(57) **CLAIM**

The ornamental design of a label dispenser and molded component therefor, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevational view of the dispenser package of the present invention including a molded component and flat paperboard member adhered thereto;

FIG. 2 is an elevational view of the molded component, shown separately for clarity of illustration;

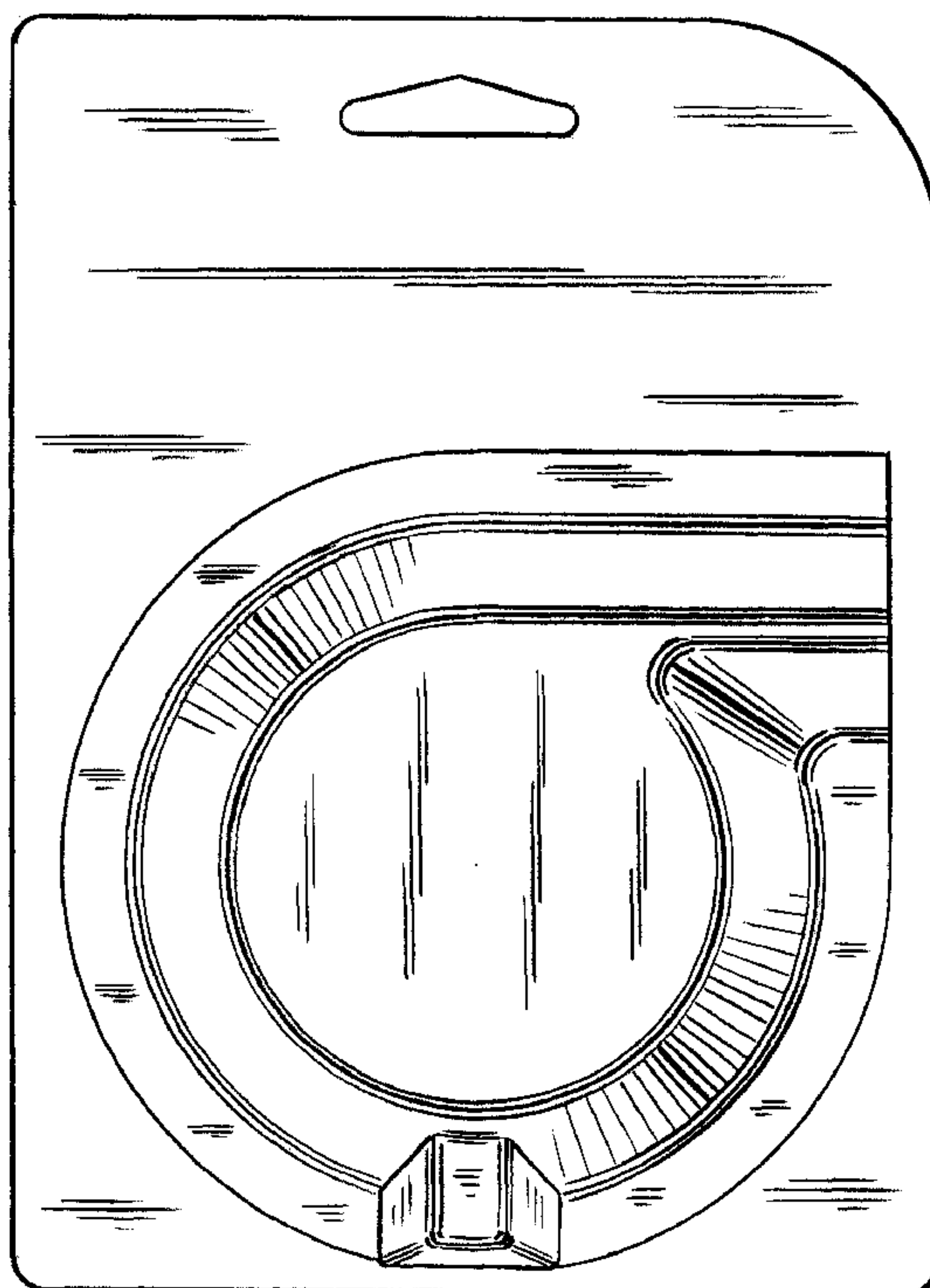
FIG. 3 is a side elevational view of the molded component as viewed from the right of FIG. 2;

FIG. 4 is a side elevational view of the molded component as viewed from the left of FIG. 2;

FIG. 5 is a top view of molded component shown in FIG. 2; and,

FIG. 6 is a bottom view of the molded component shown in FIG. 2.

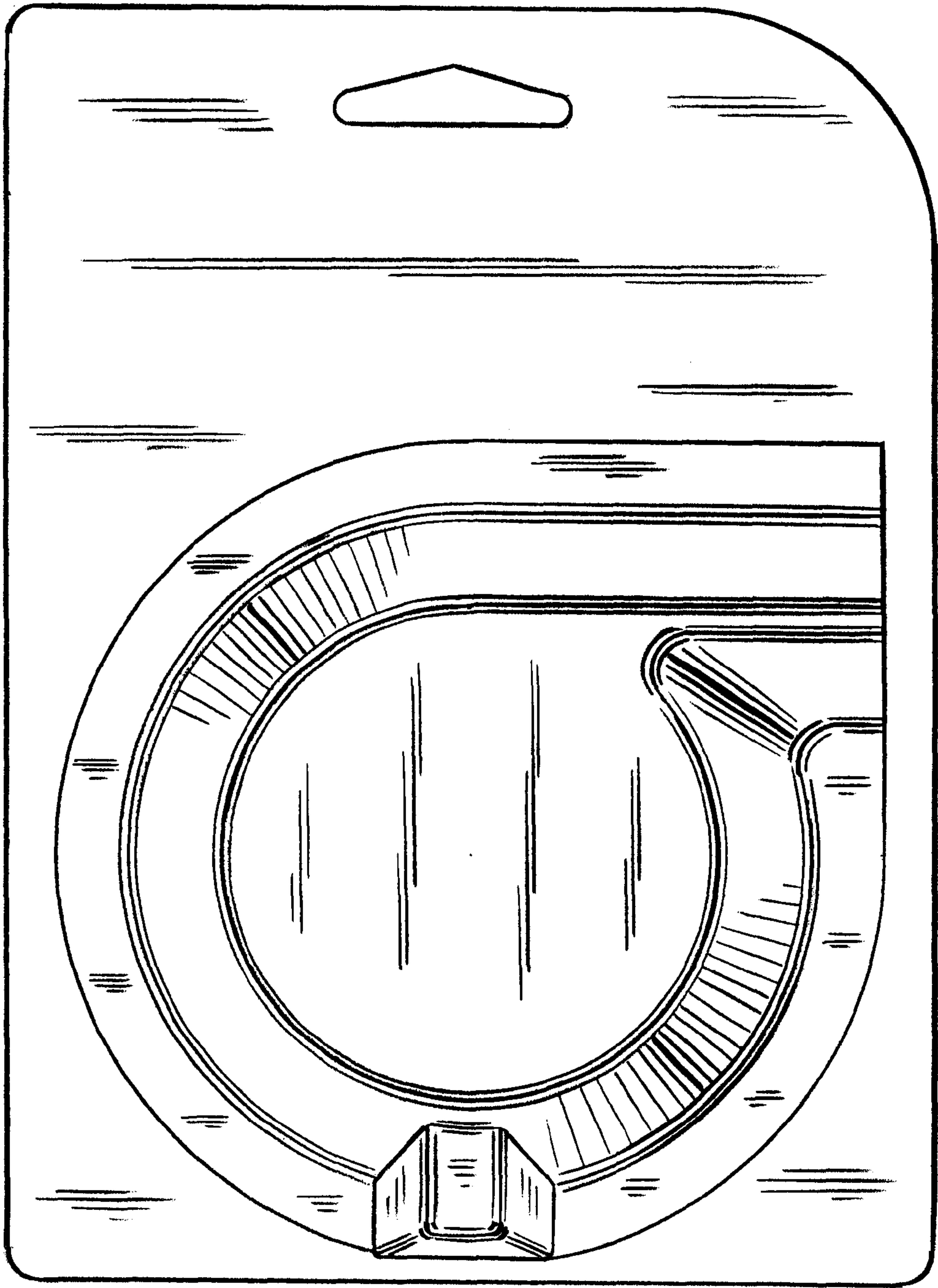

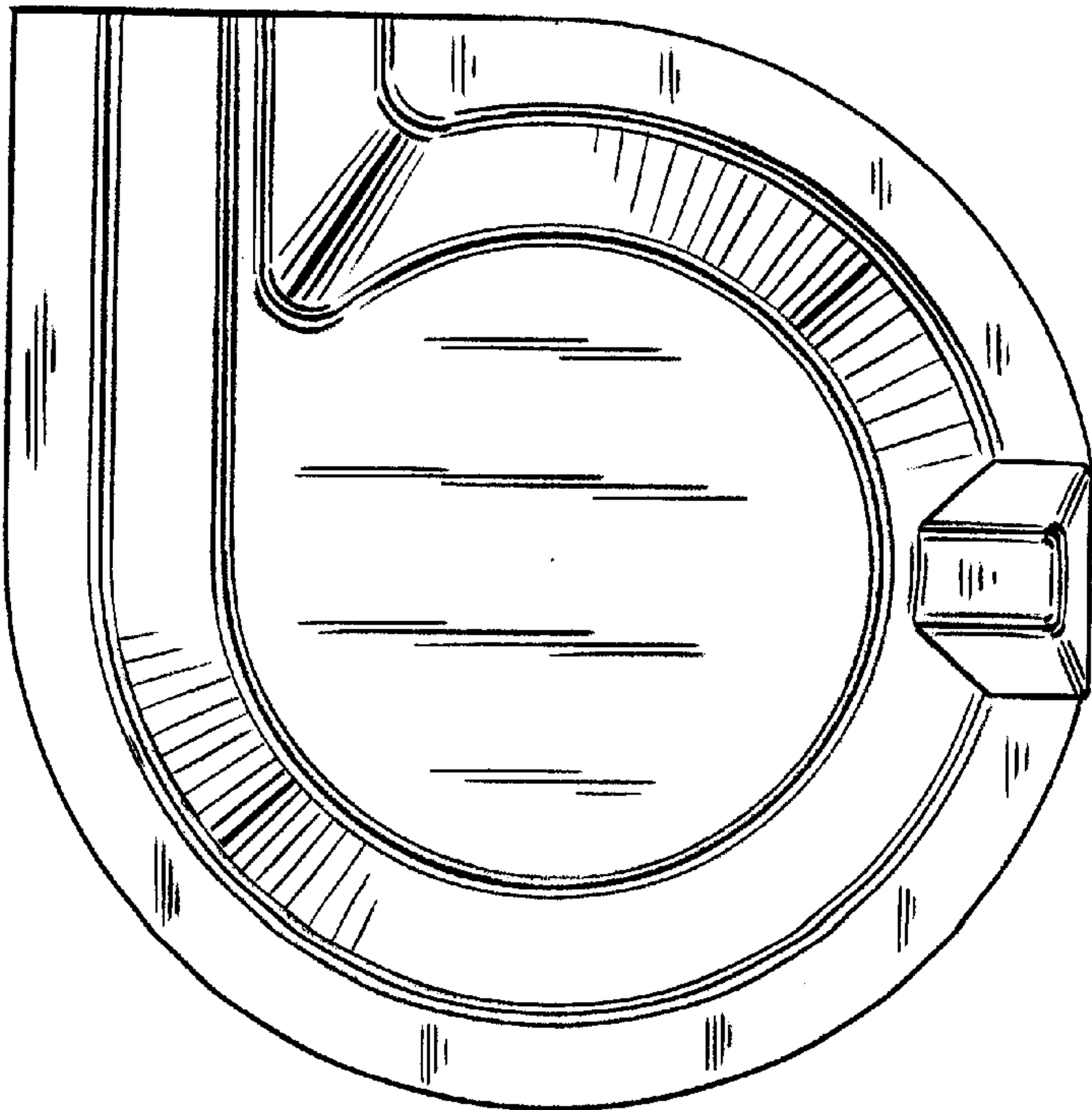

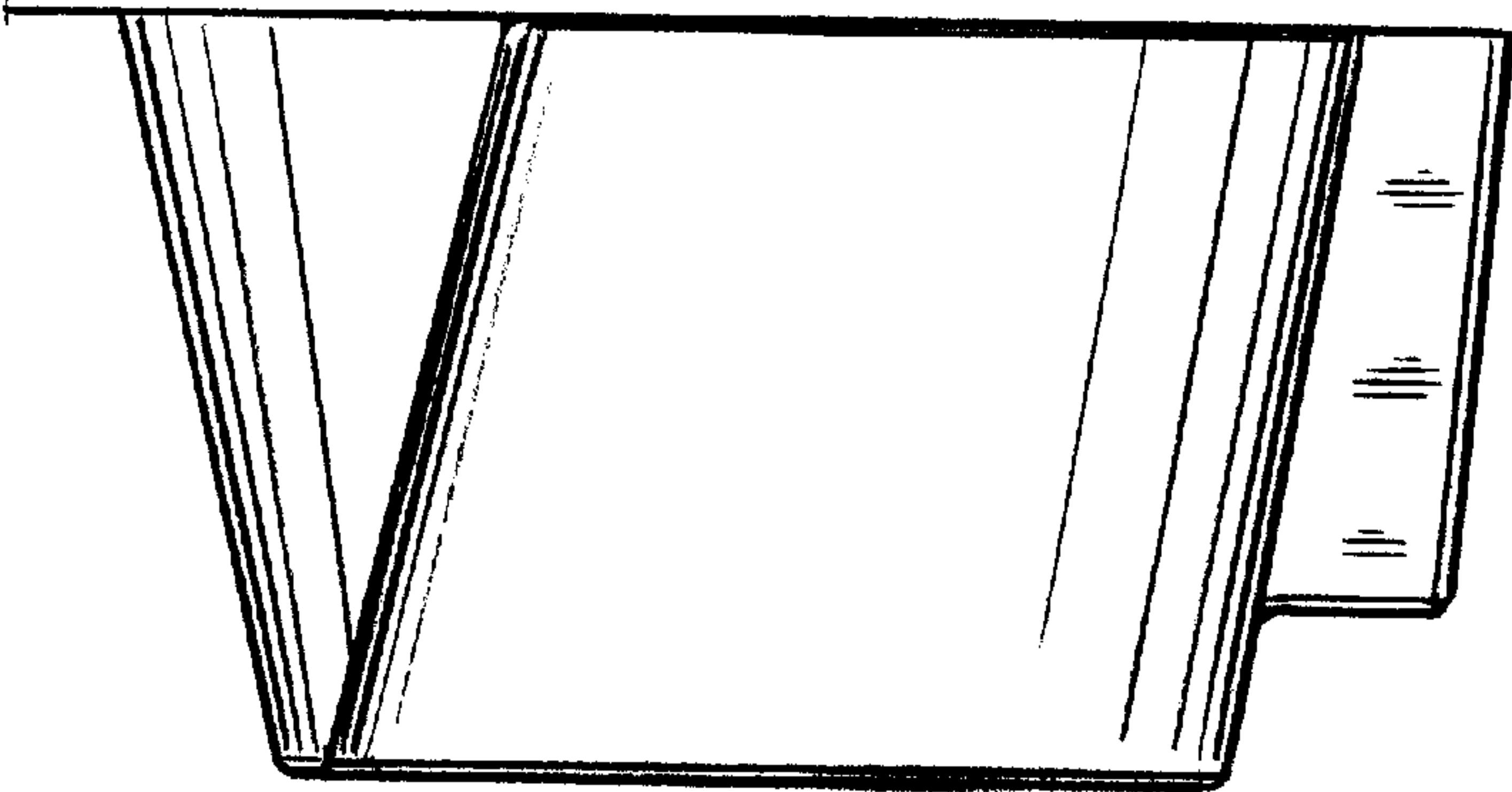

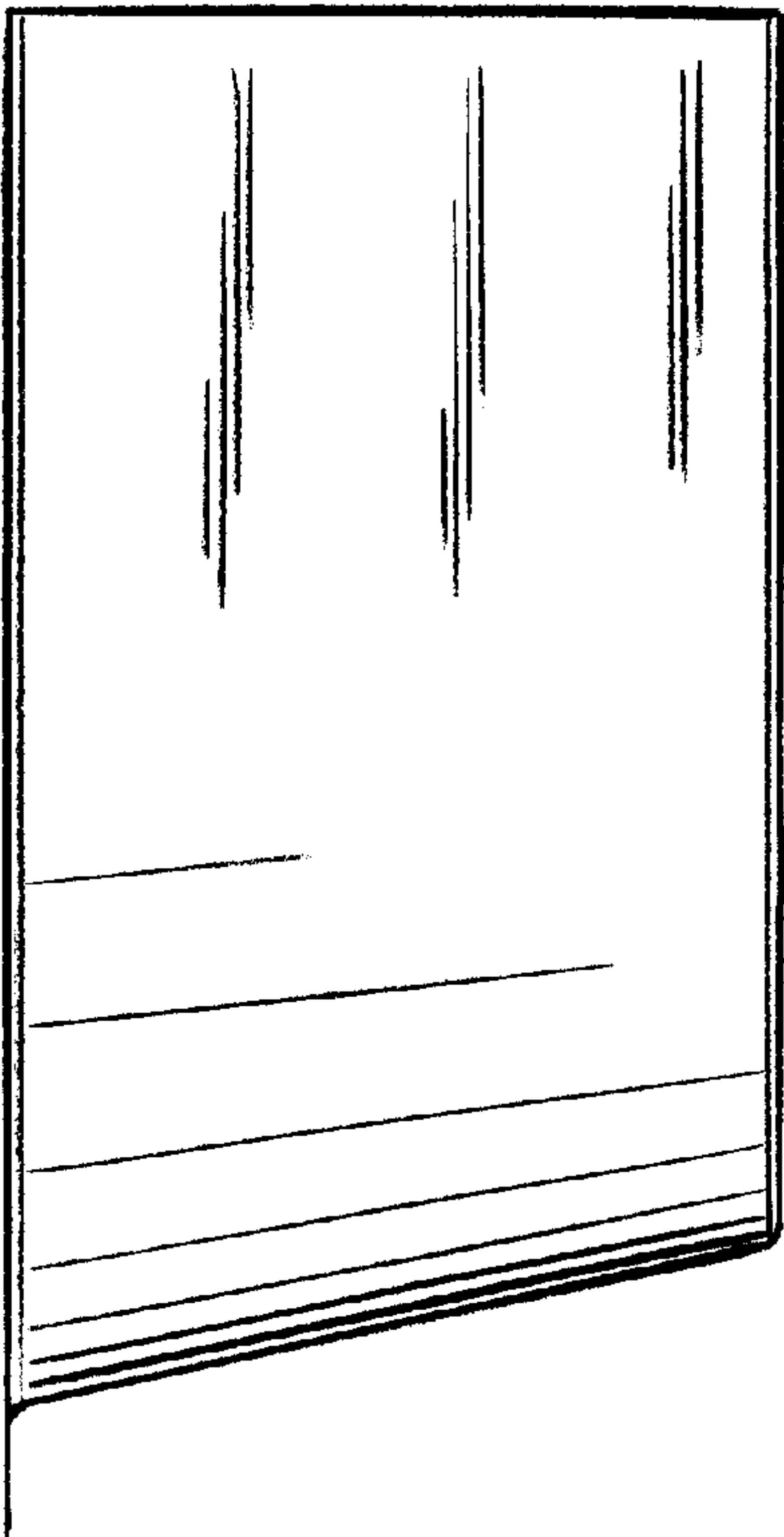

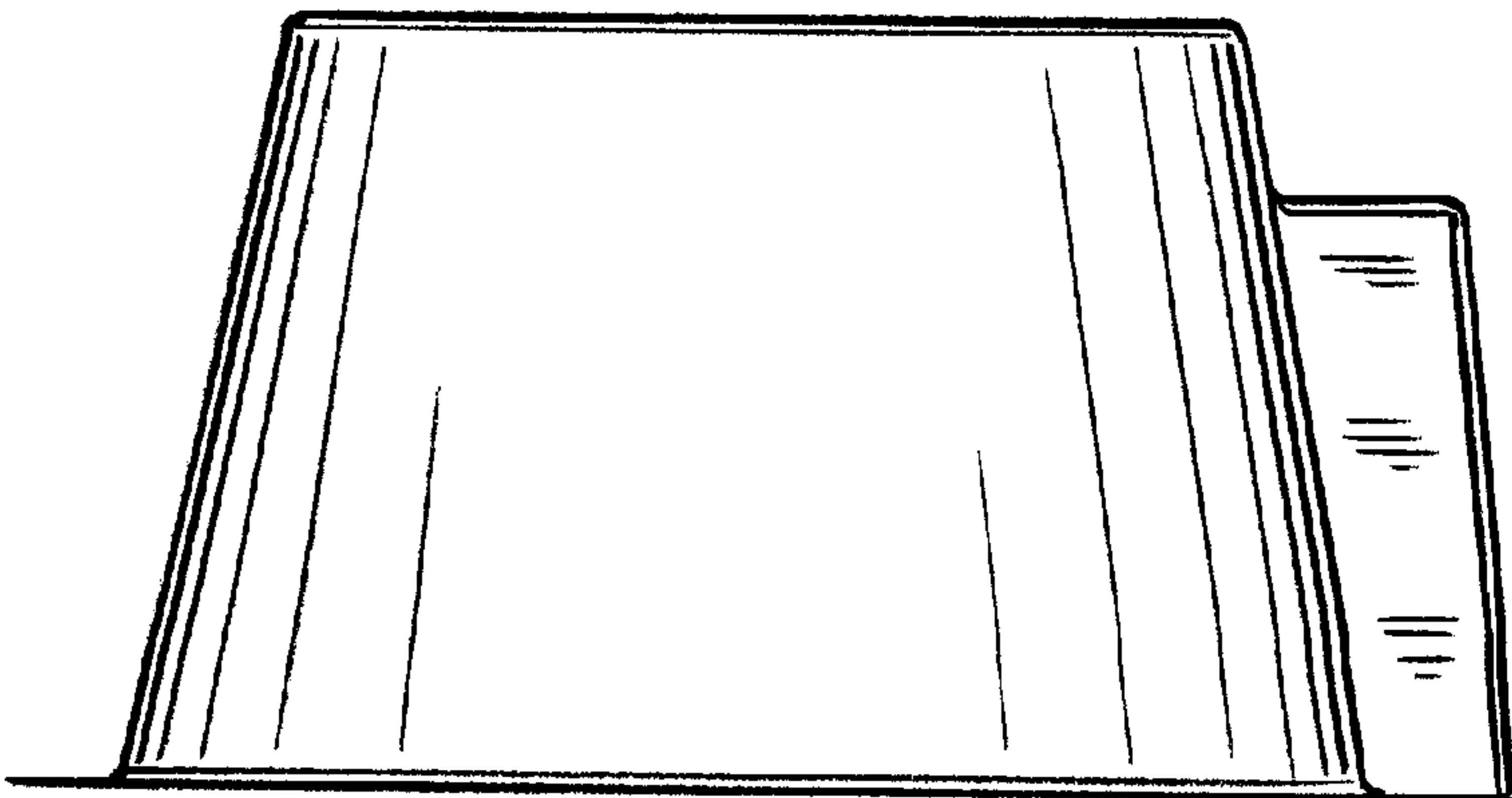

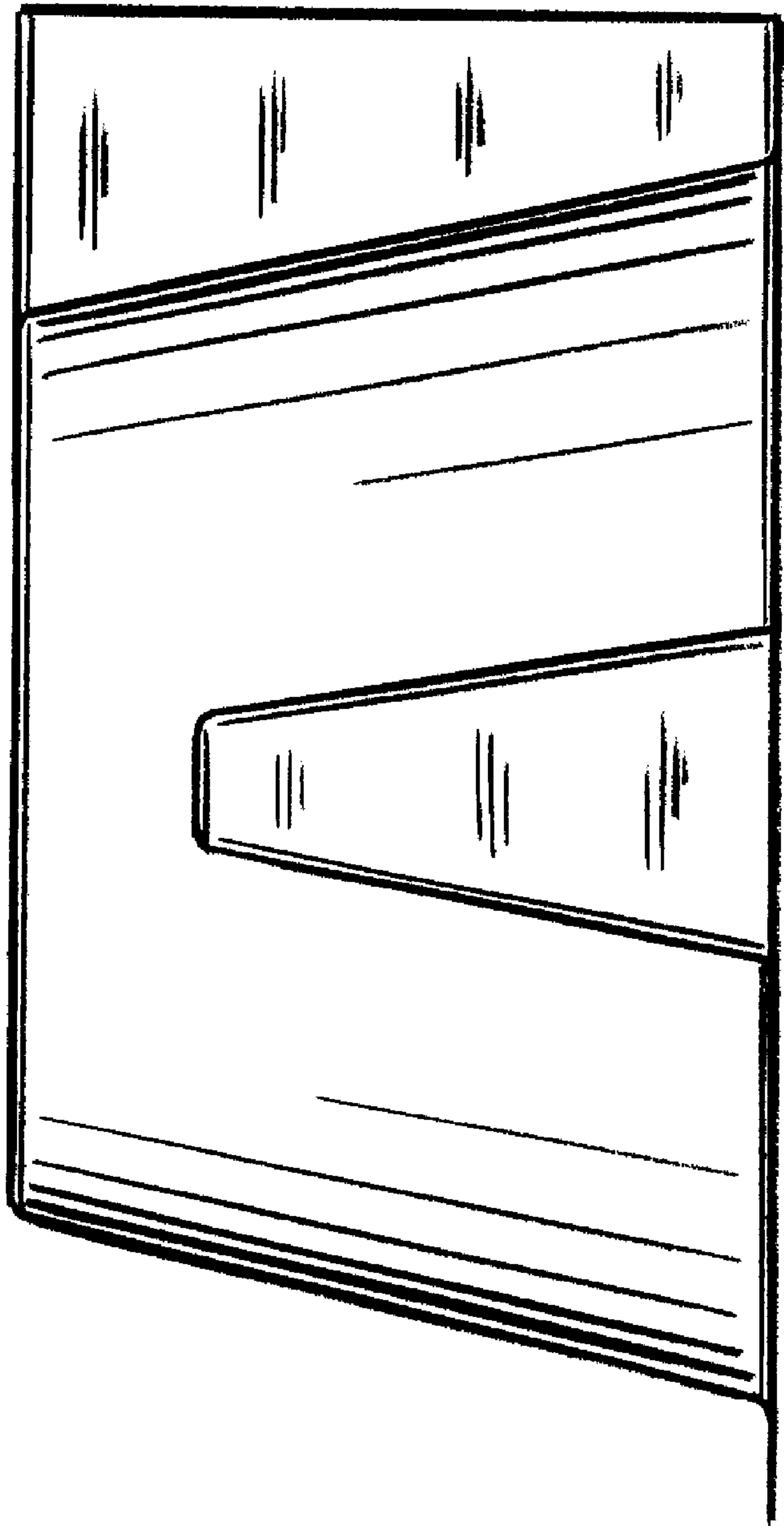
