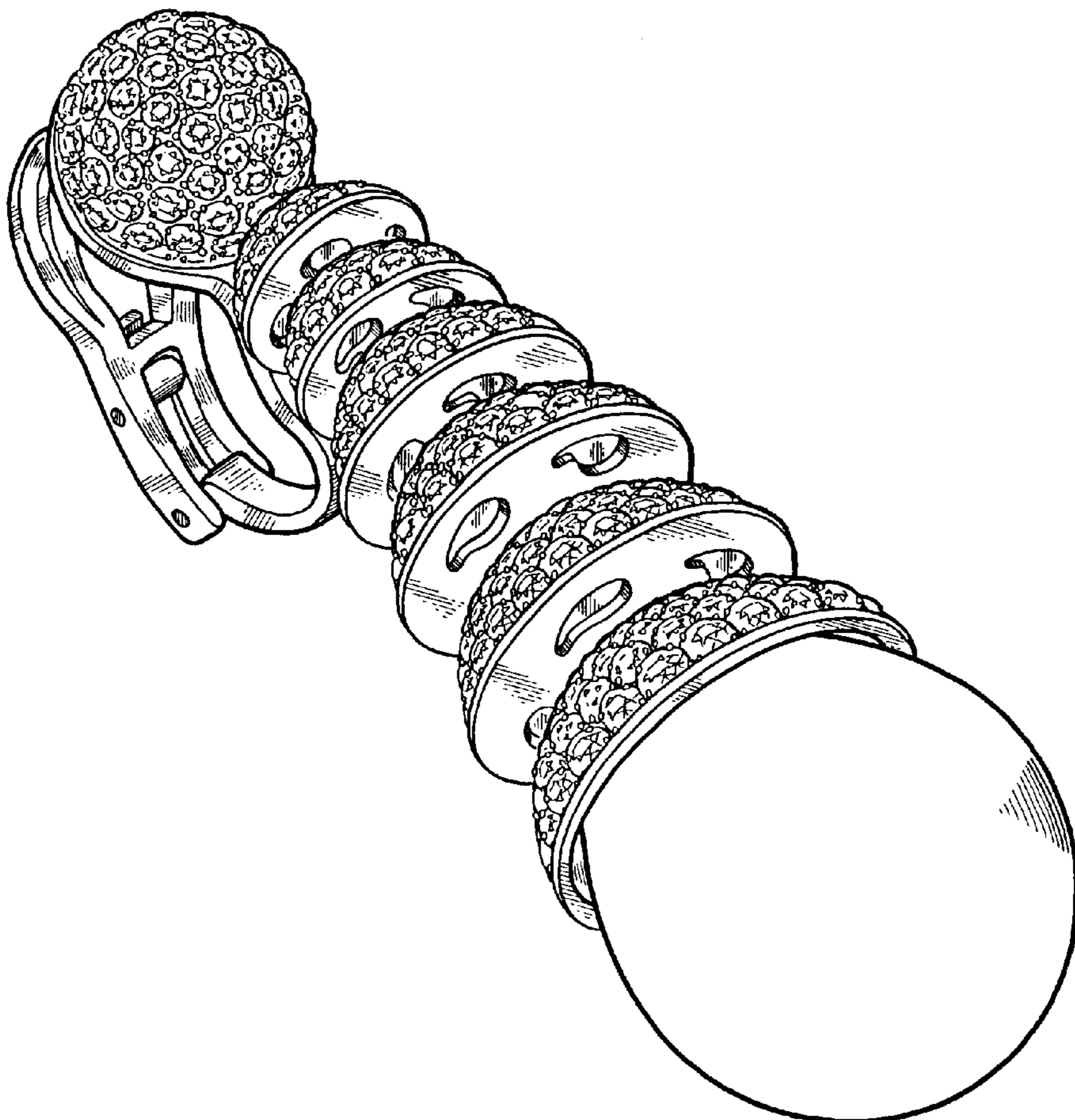

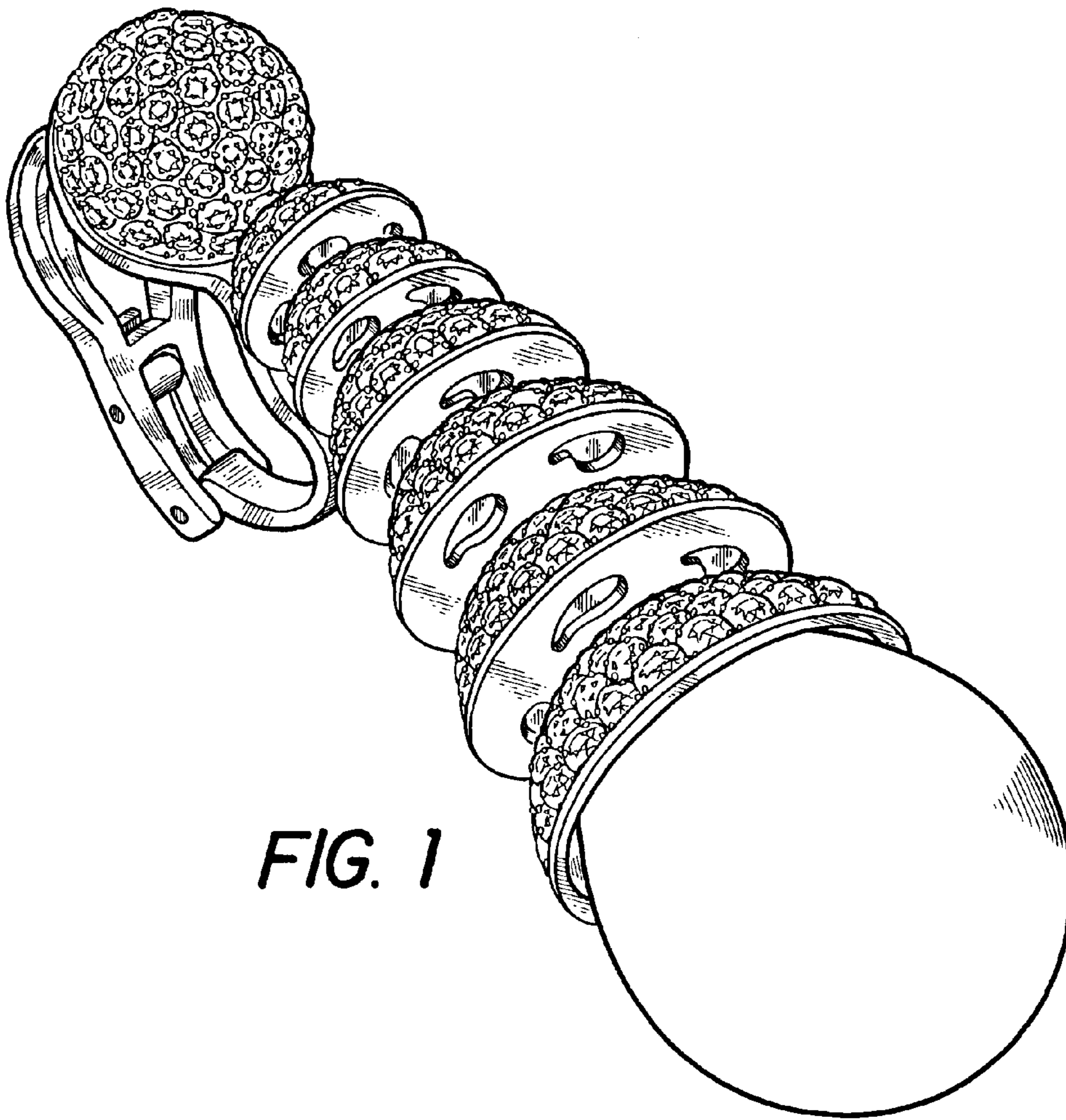
The ornamental design for the earring, as shown and described.

**DESCRIPTION**

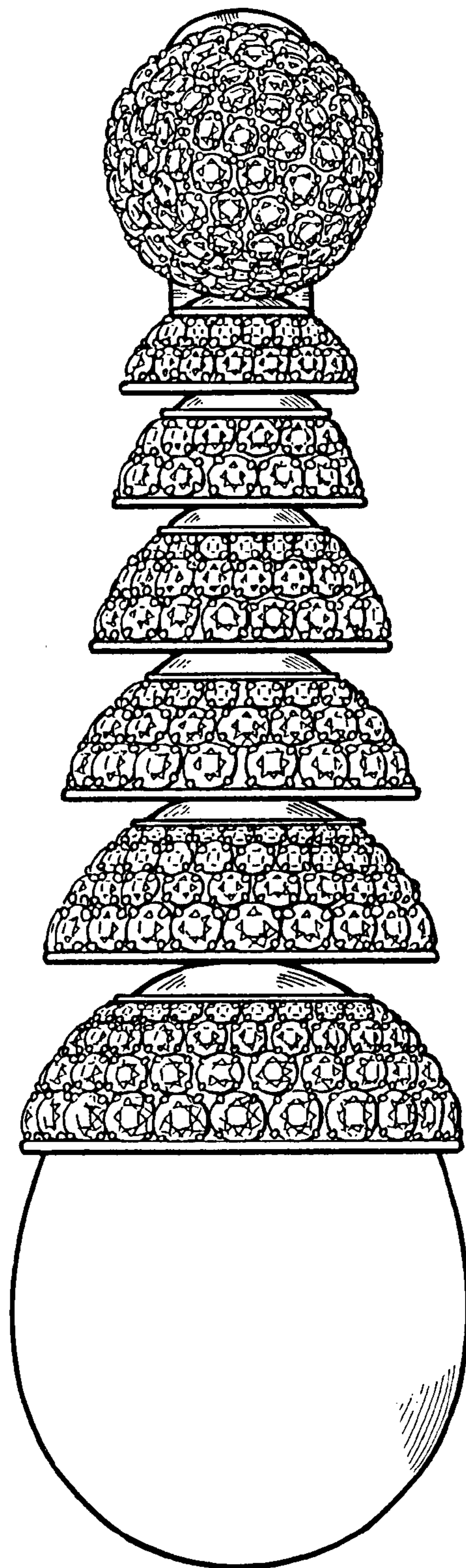
FIG. 1 is a bottom perspective view of the new ornamental earring of the present invention.

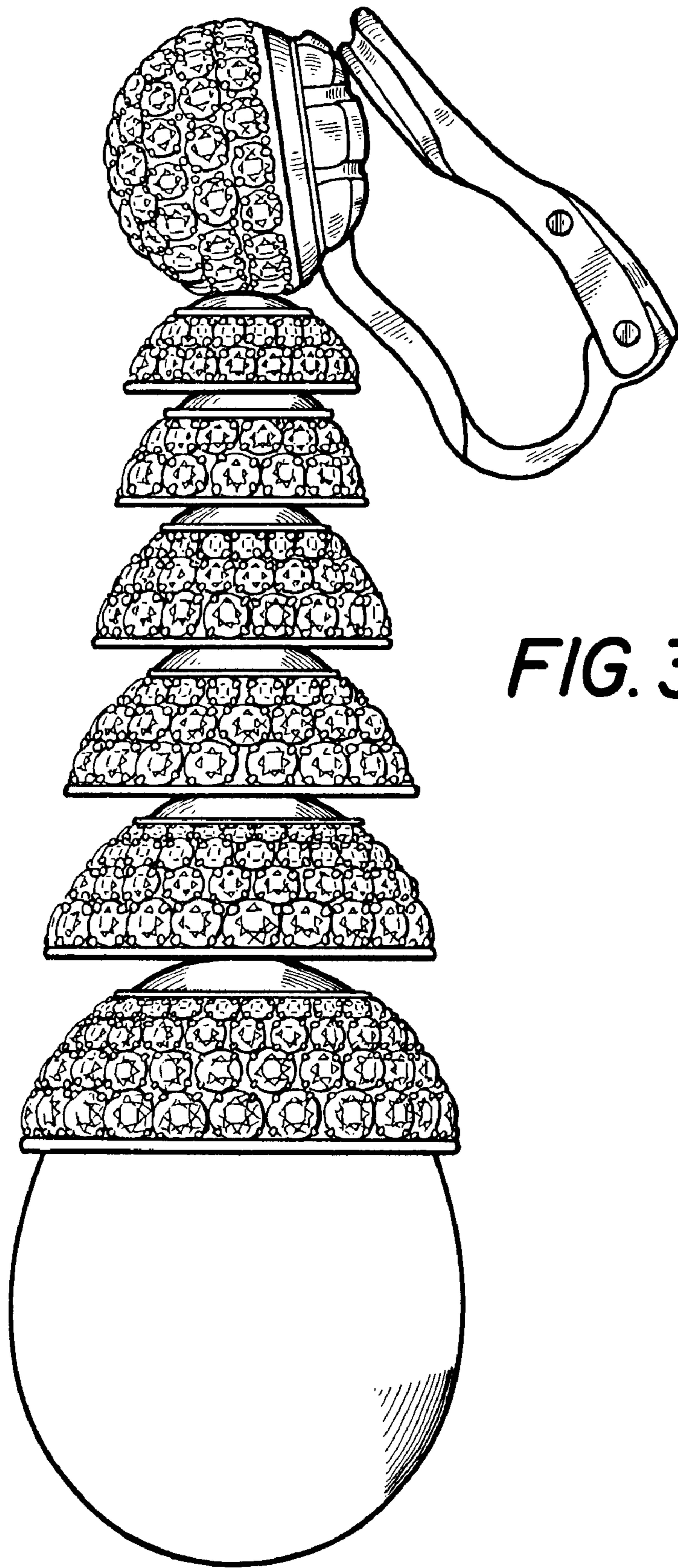

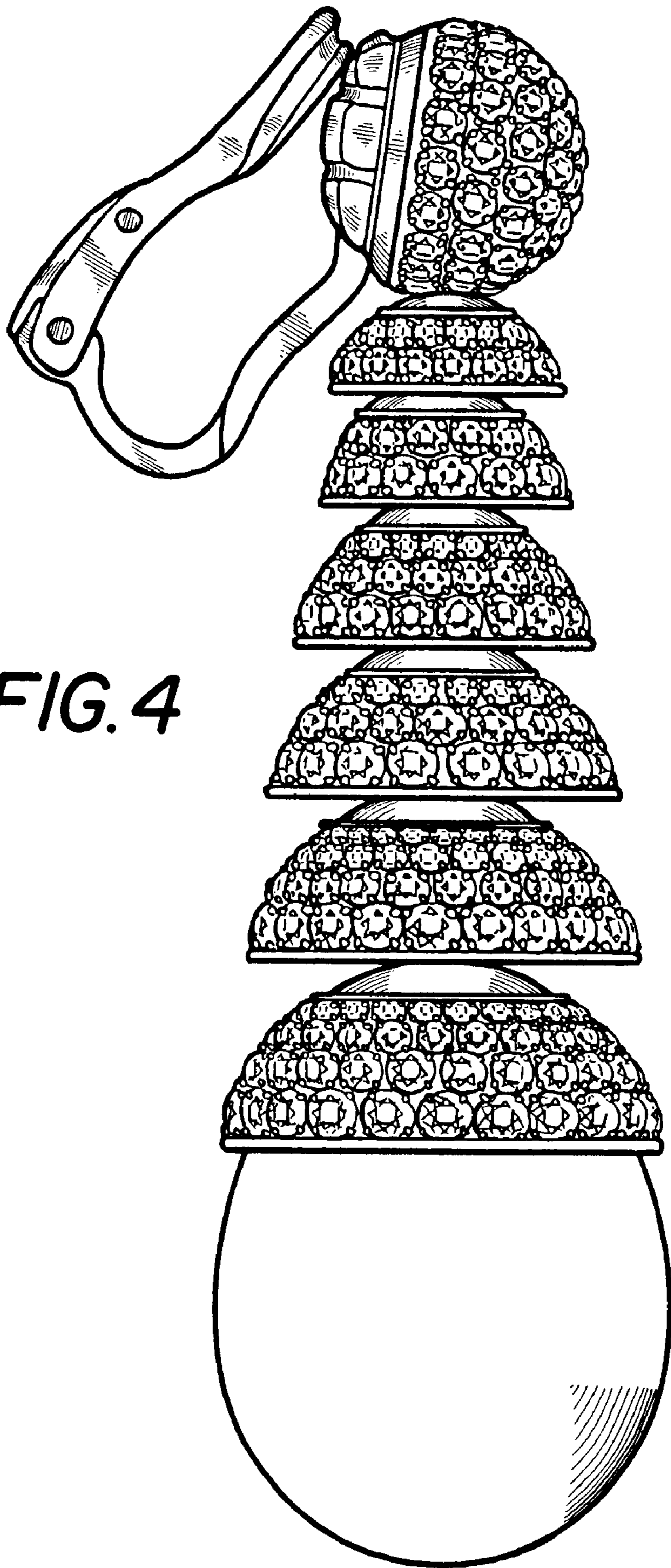

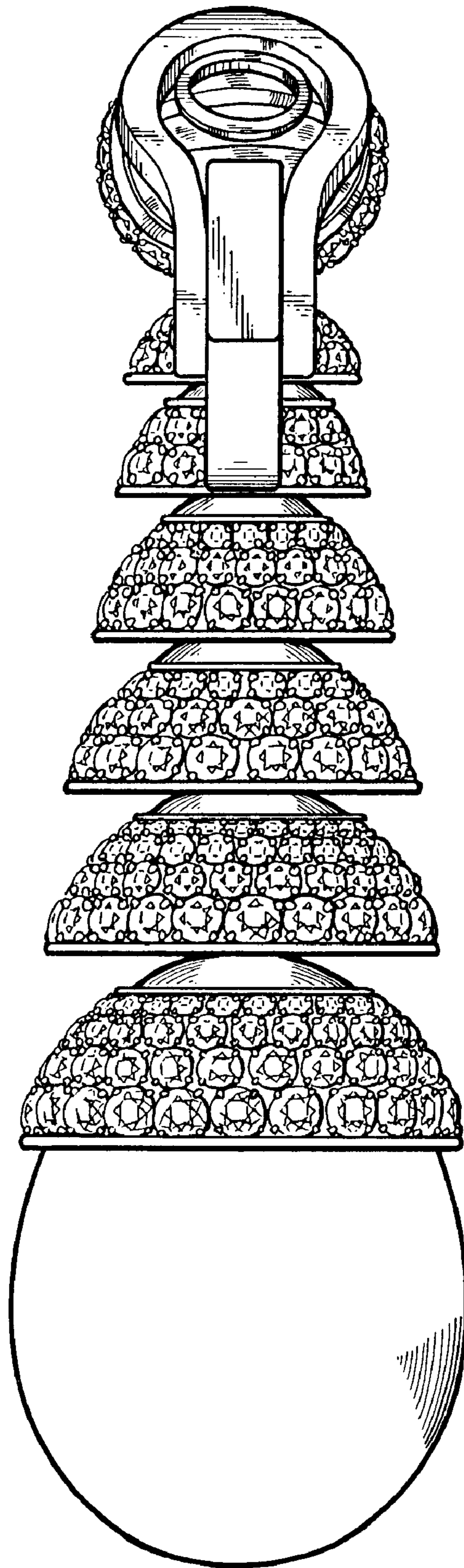

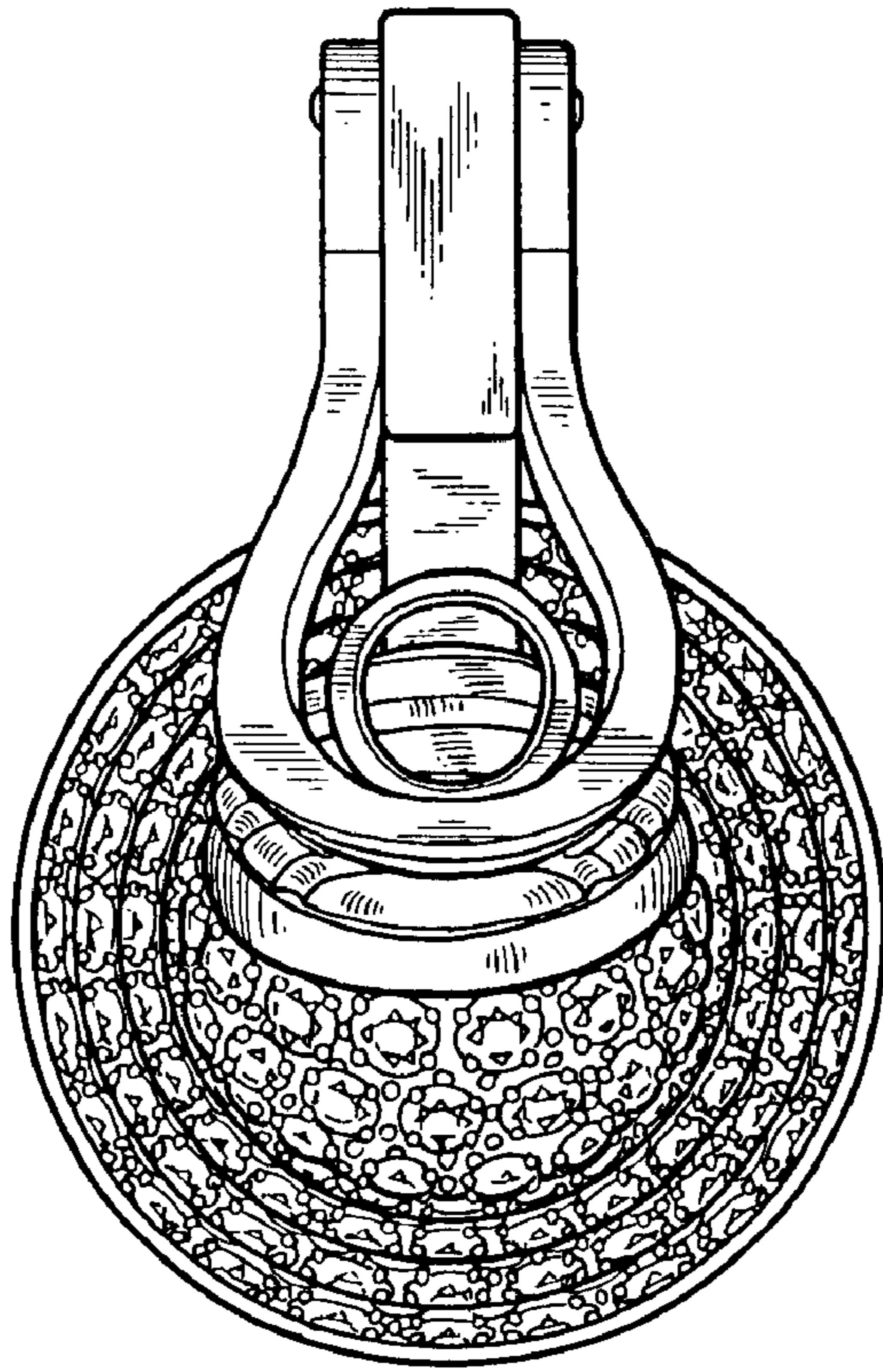

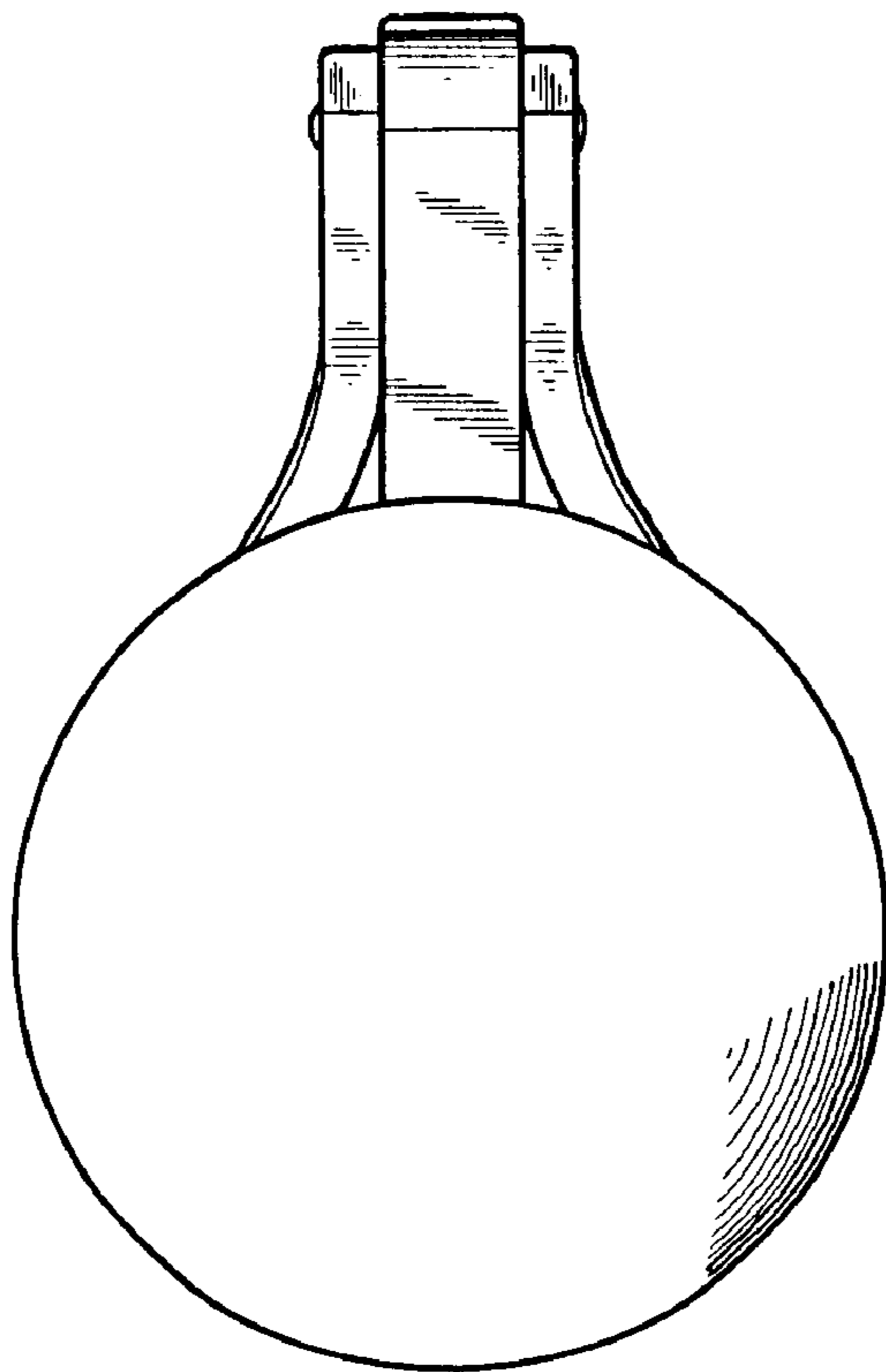
