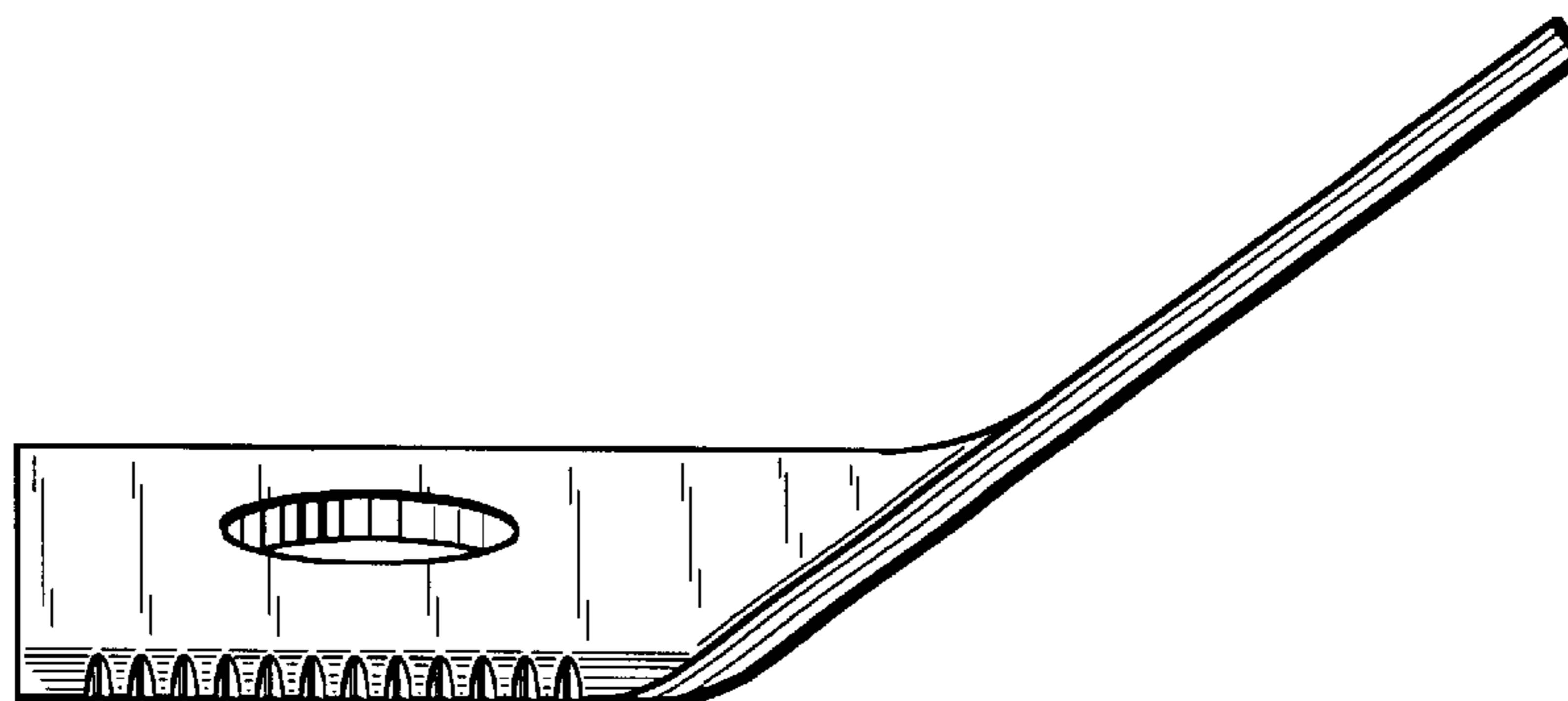
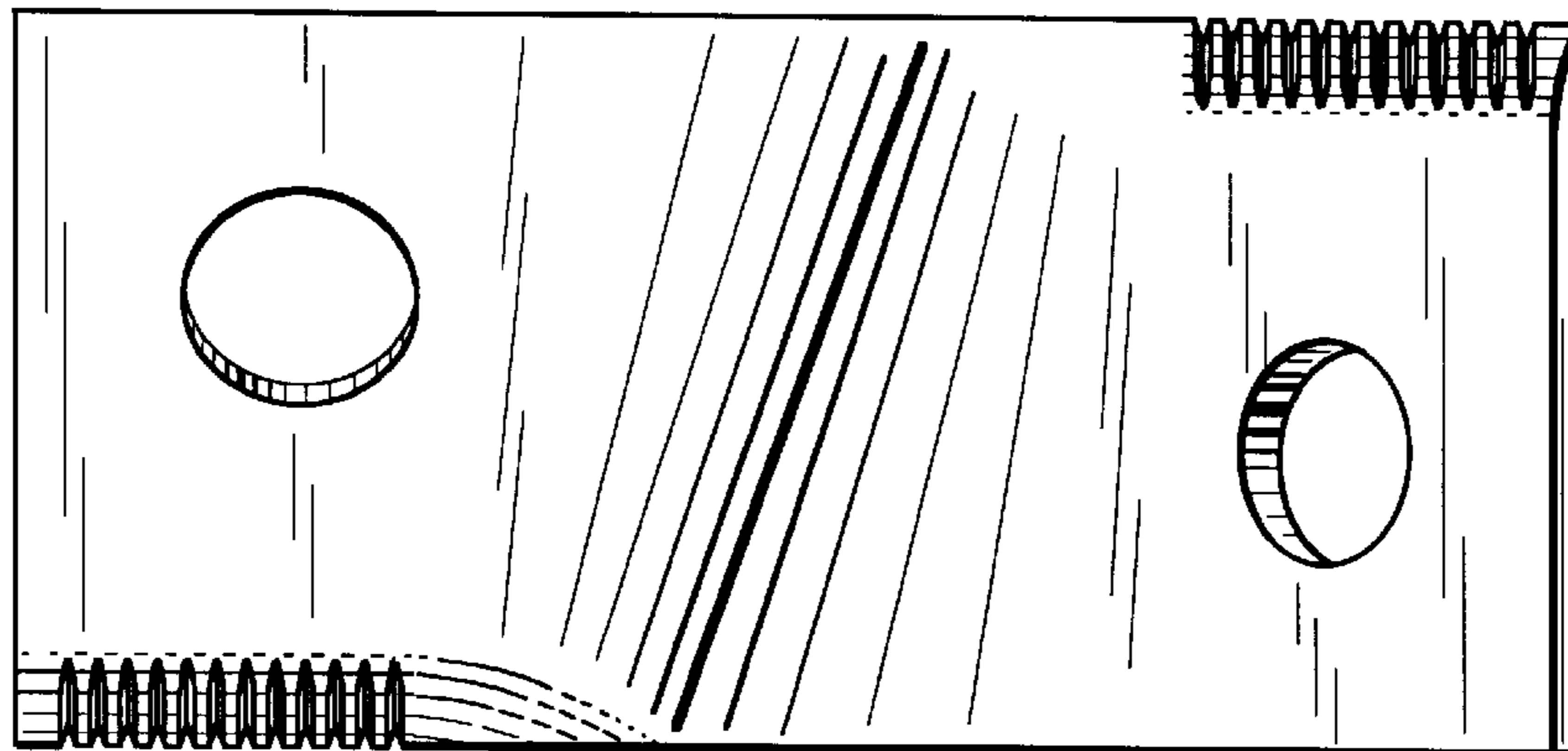
(57) **CLAIM**

We claim the ornamental design for knives for an agricul-
tural cutterhead, as shown.

DESCRIPTION

FIG. 1 is a top plan view of the knife of the instant invention;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a vertical elevation of the cutting edge thereof;
FIG. 4 is a vertical elevation of the trailing edge thereof;
FIG. 5 is an end elevation of the cutting end thereof; and,
FIG. 6 is an end elevation of the mounting end thereof.

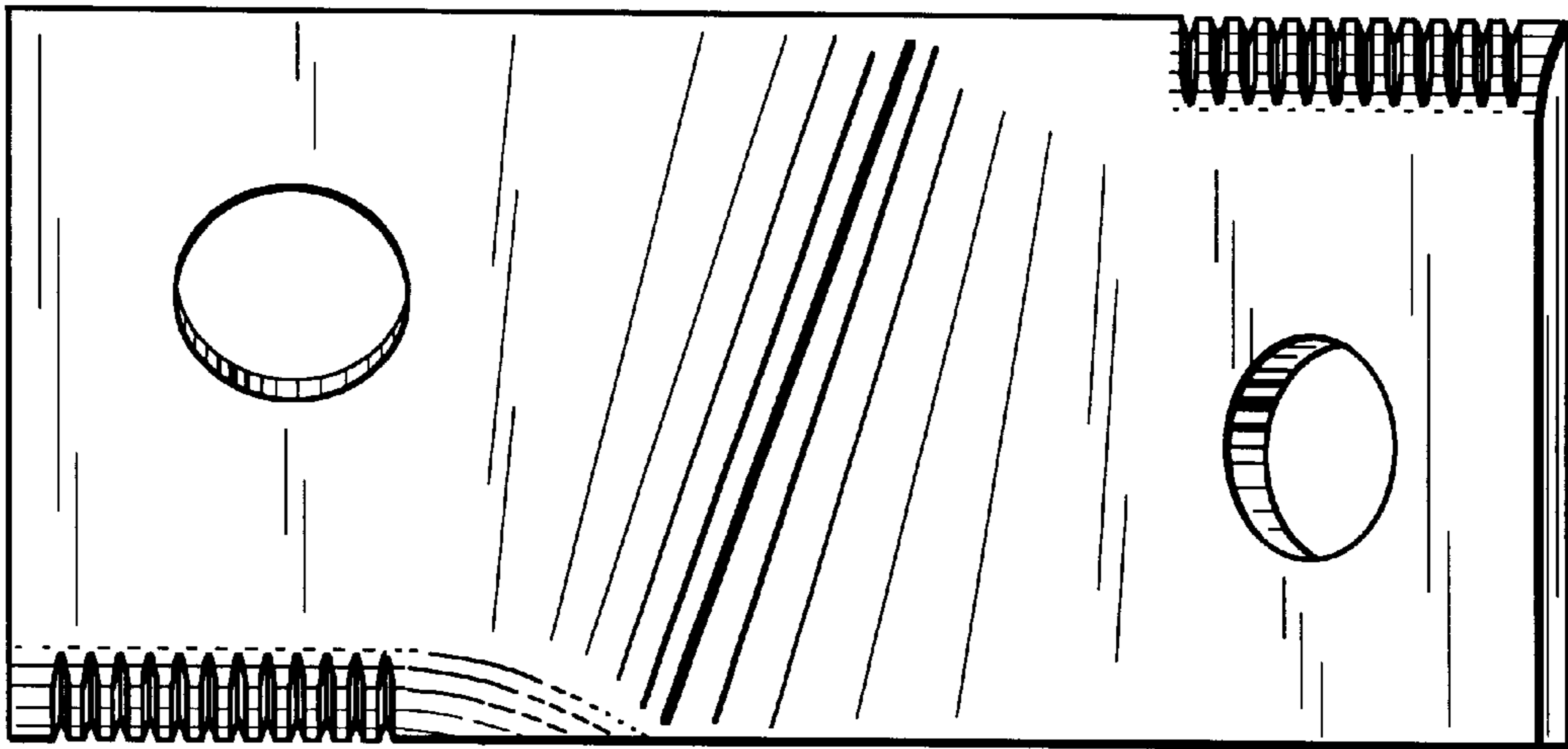

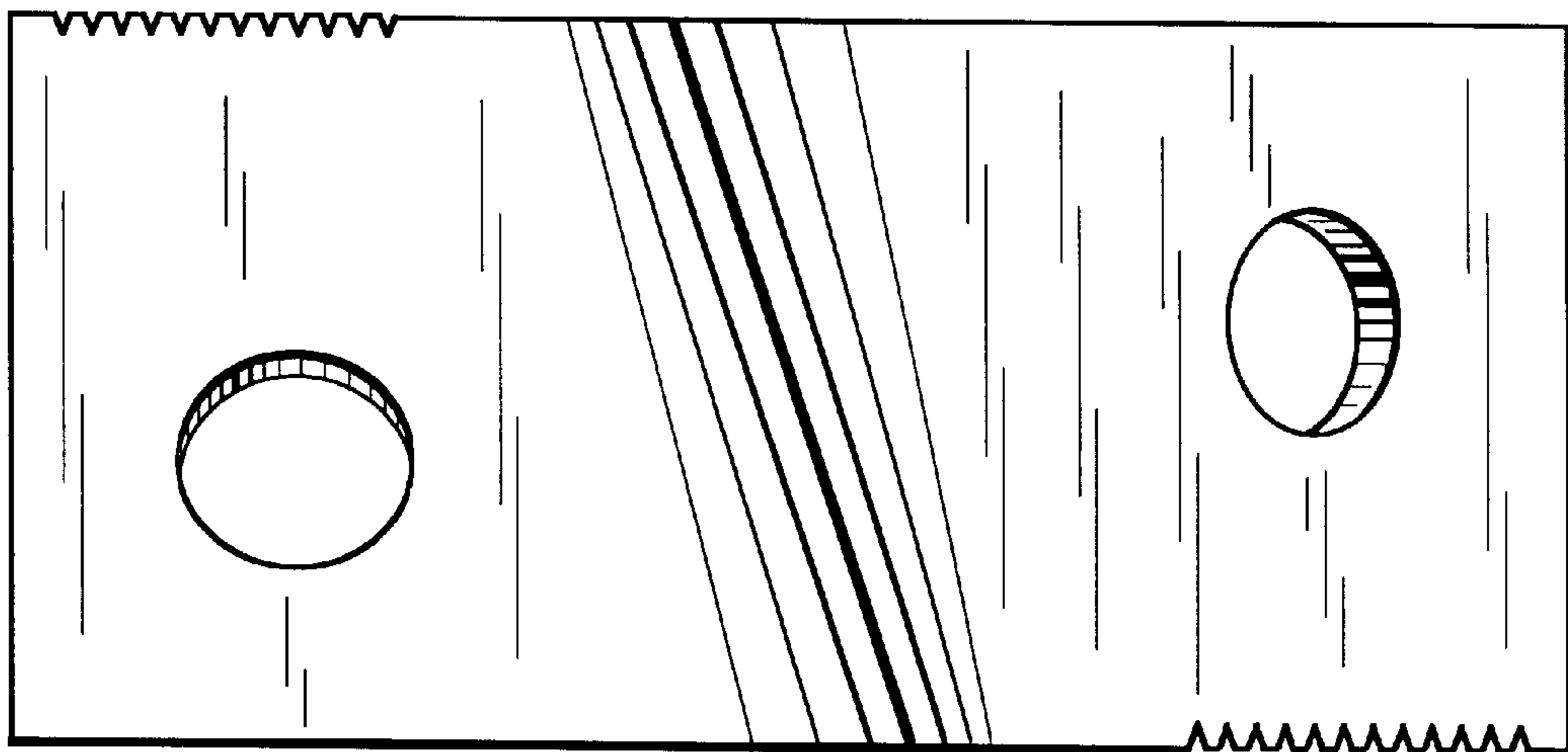

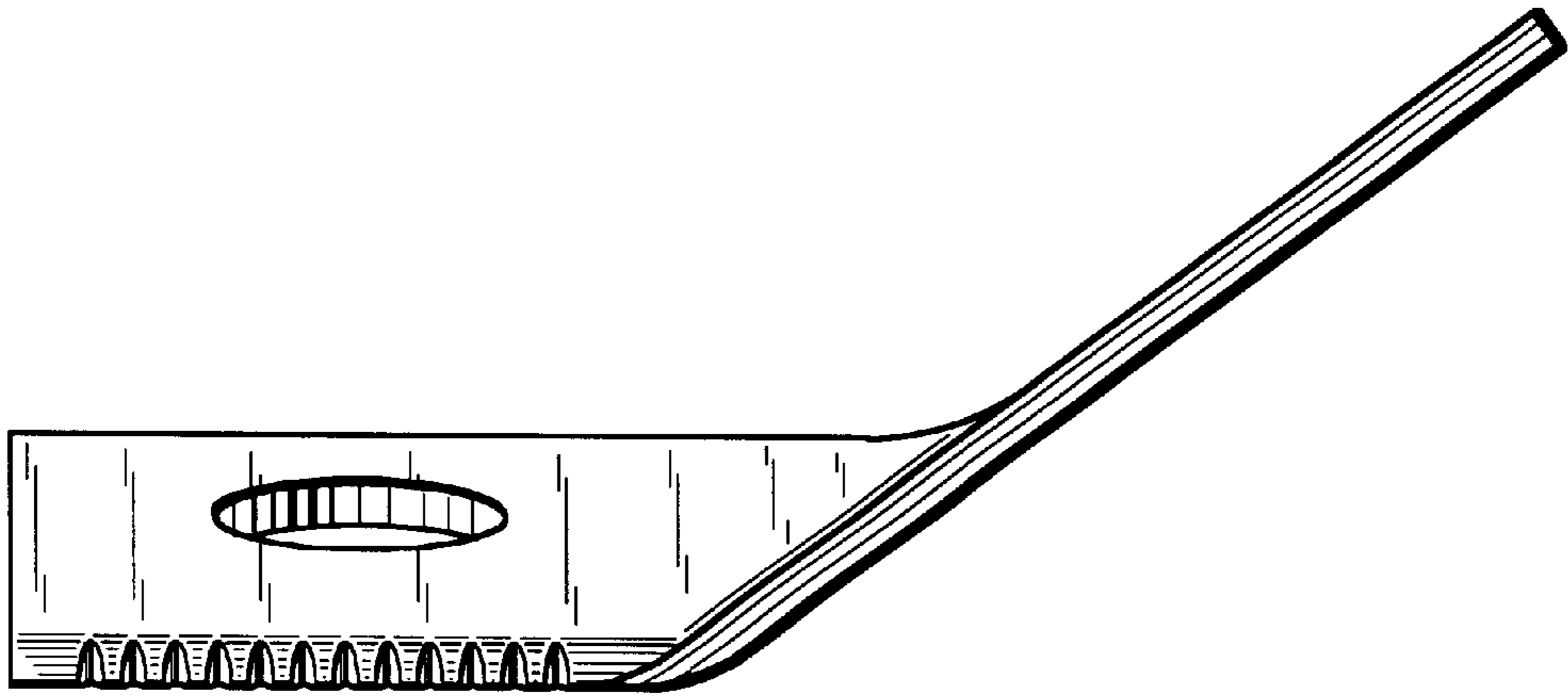

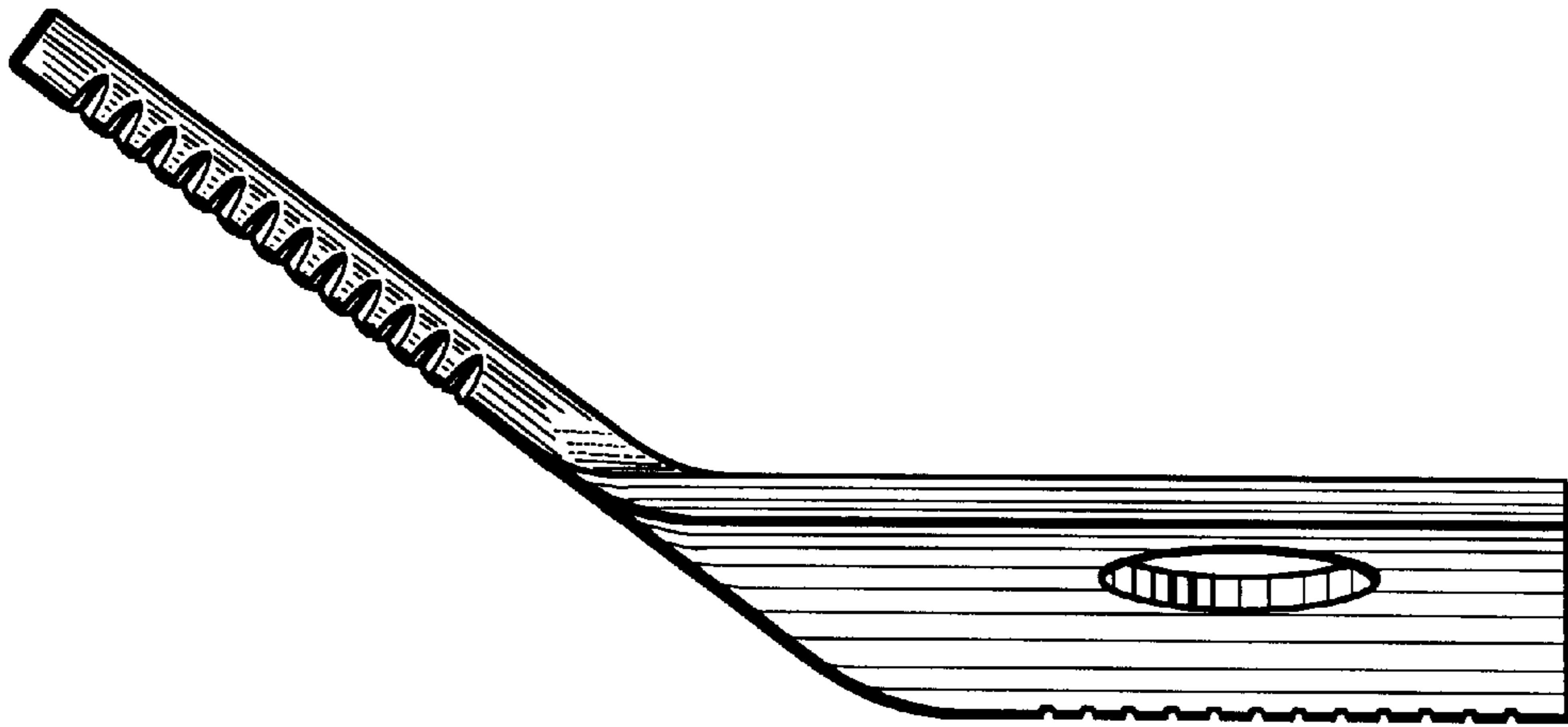

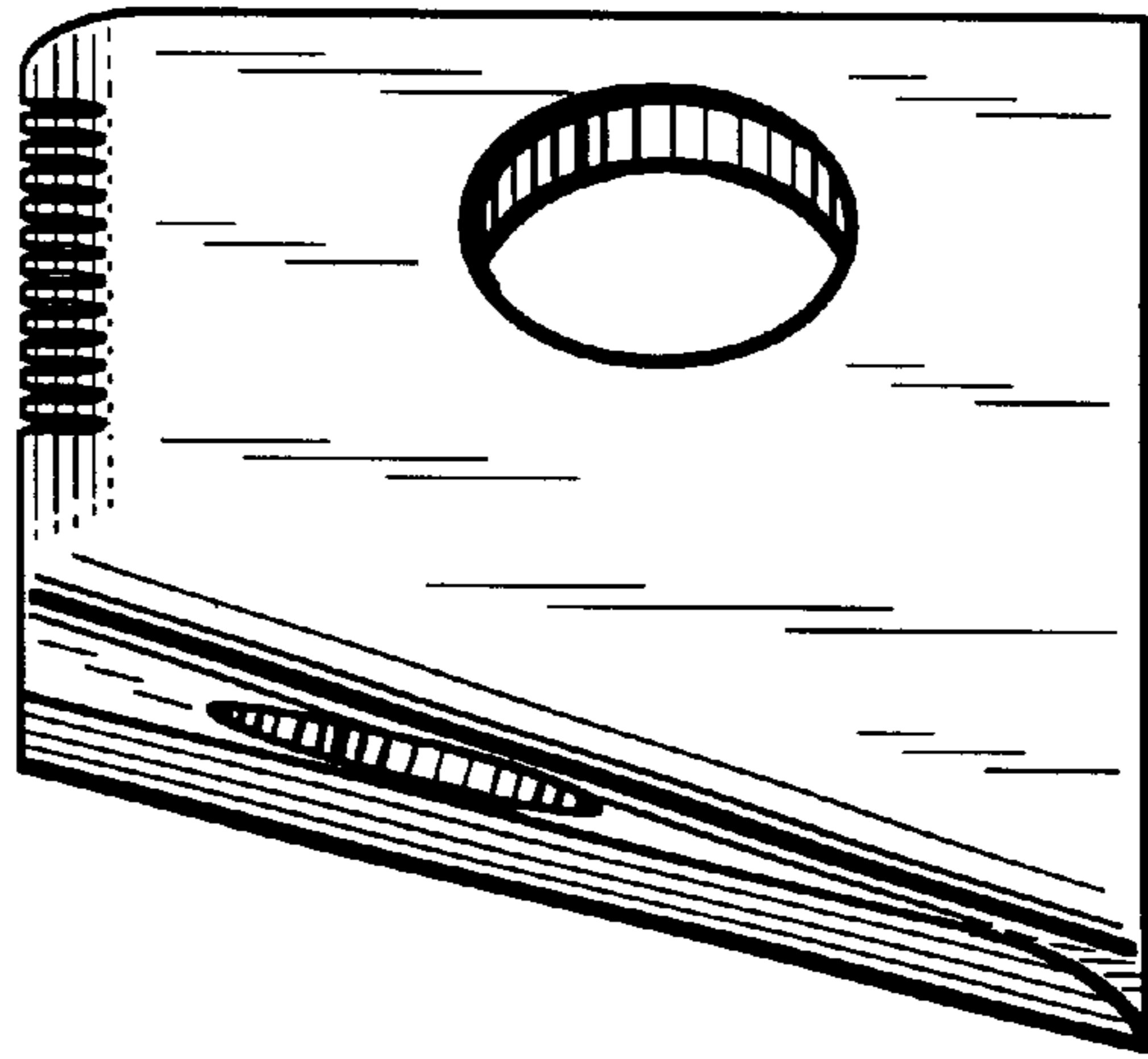

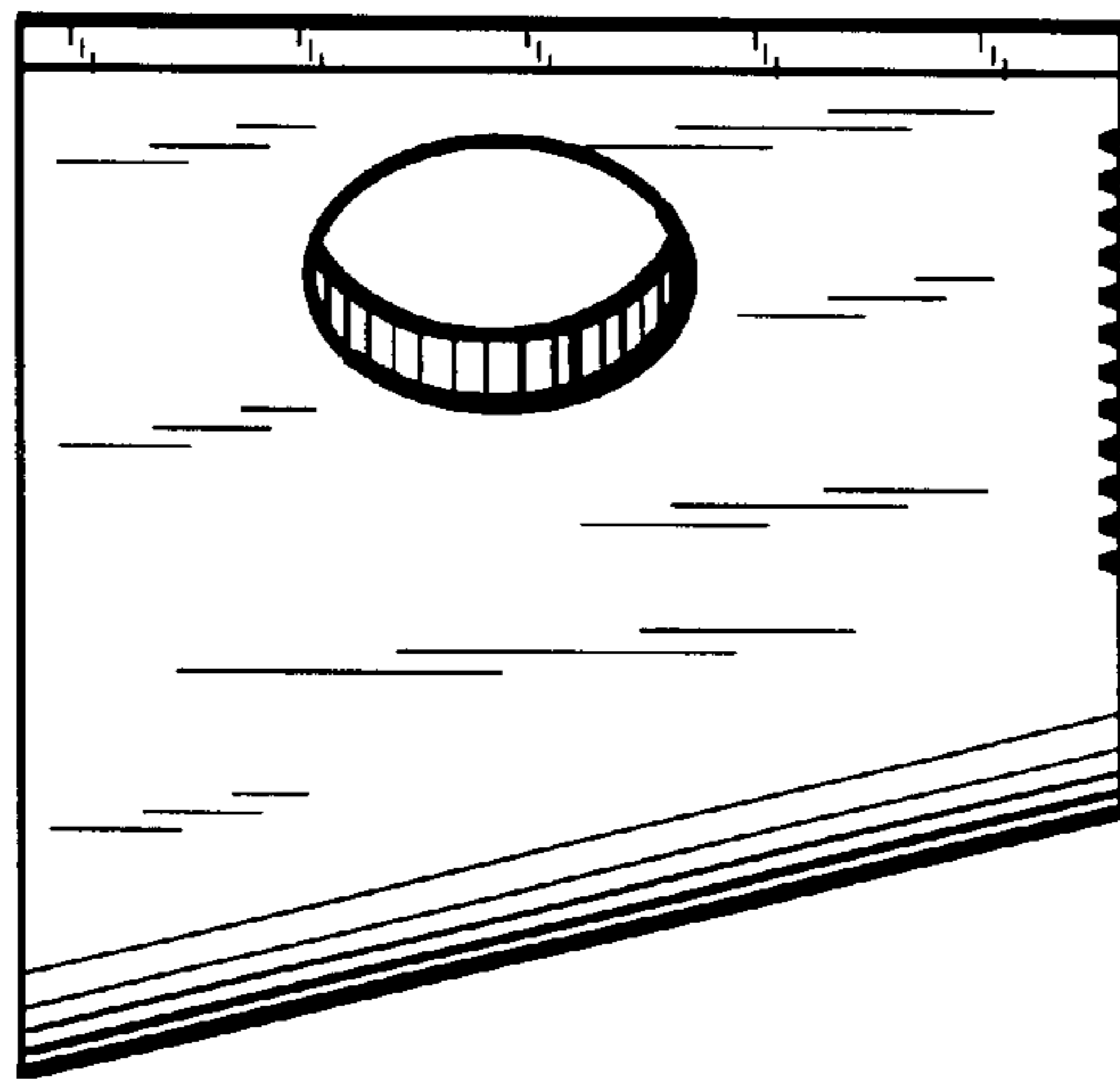
