(57) **CLAIM**

The ornamental design for a ball-point pen, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, front and one side of a ball-point pen showing our new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a side elevational view of an opposite side thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a front elevational view of the ball-point pen with the cover removed for ease of illustration;
 FIG. 8 is a side elevational view, the opposite side being a mirror image thereof;
 FIG. 9 is a rear elevational view thereof;
 FIG. 10 is a top plan view thereof;
 FIG. 11 is a bottom plan view thereof;
 FIG. 12 is a front elevational view of the cover with the ball-point pen removed for ease of illustration;
 FIG. 13 is a side elevational view thereof, the opposite side being a mirror image thereof;
 FIG. 14 is a rear elevational view thereof;
 FIG. 15 is a top plan view thereof; and,
 FIG. 16 is a bottom plan view thereof.

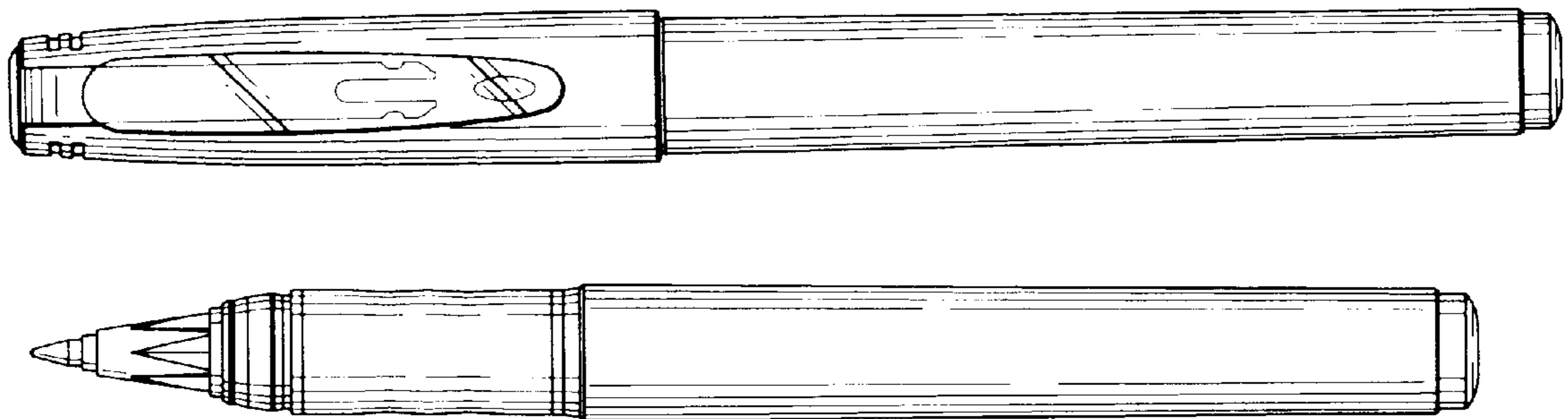

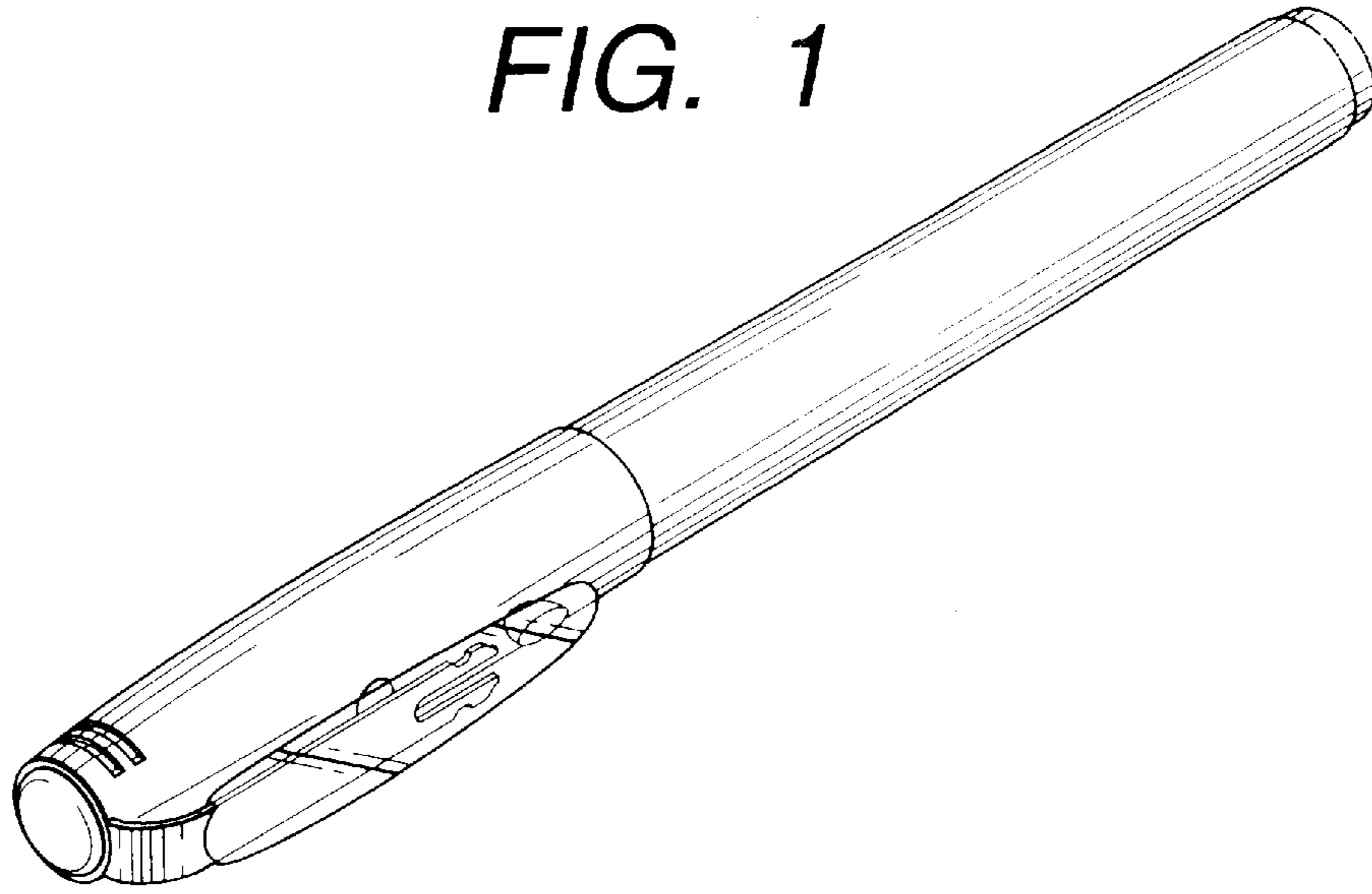

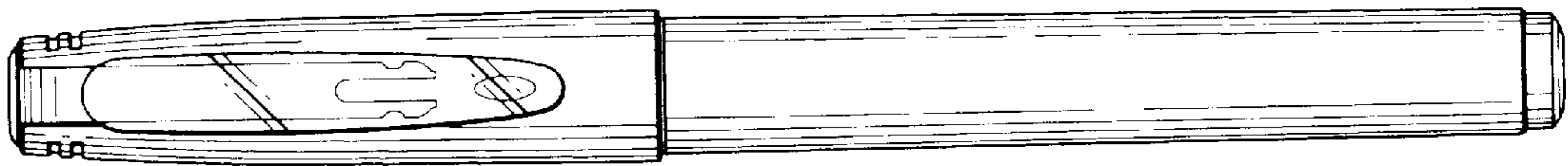

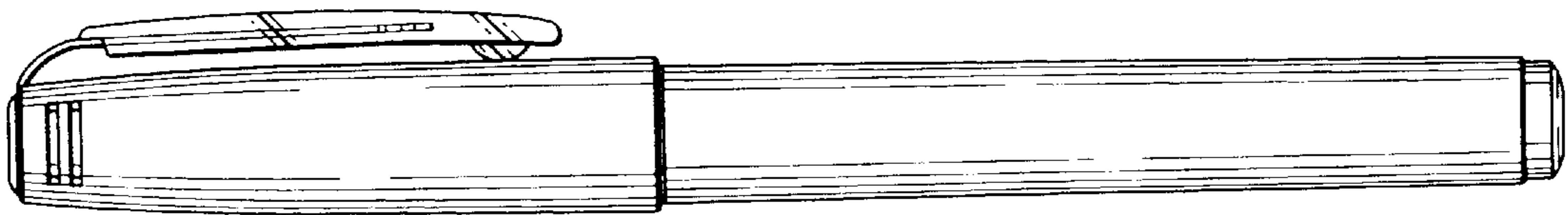

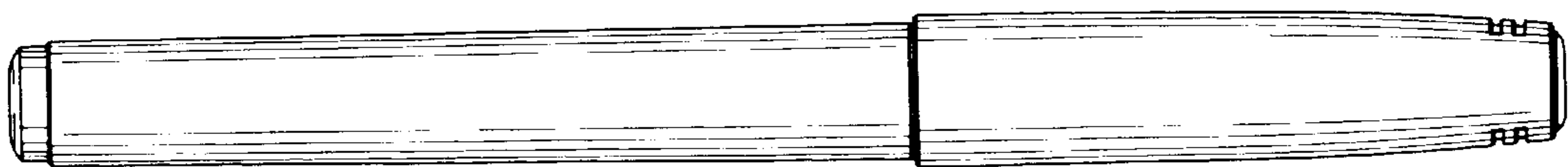

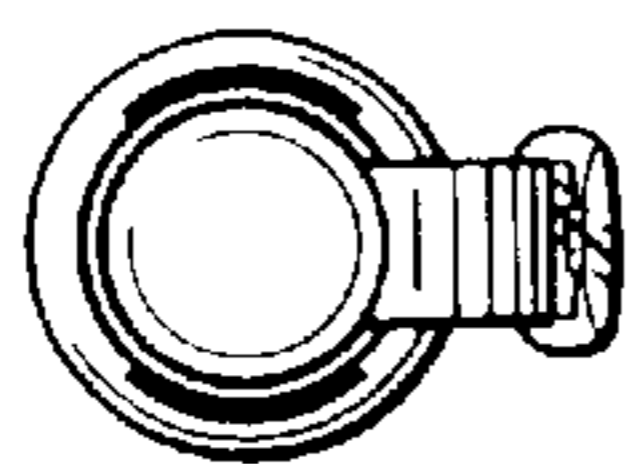

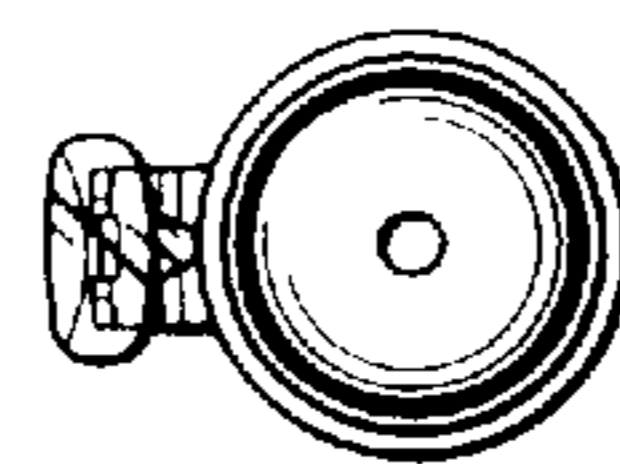

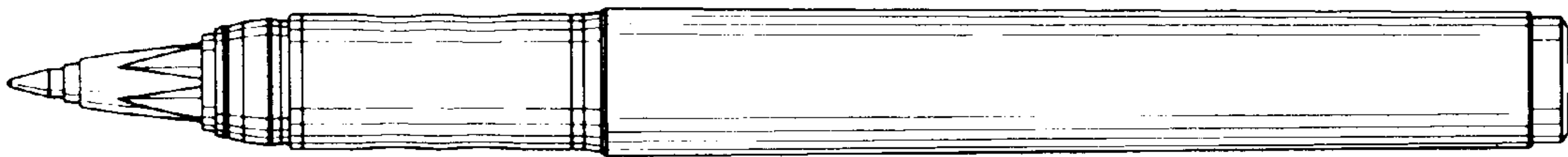

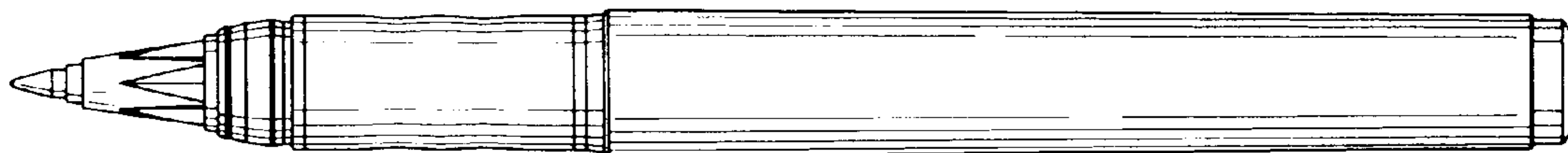

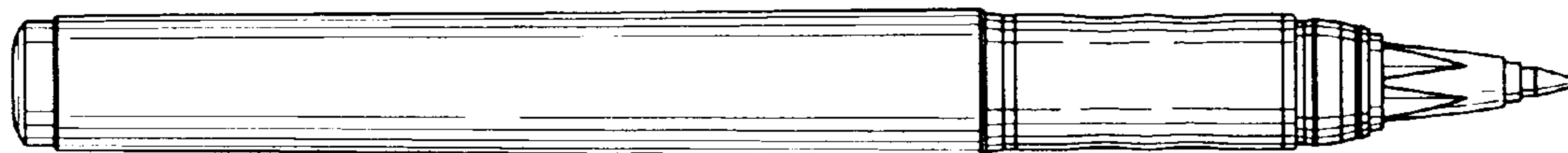

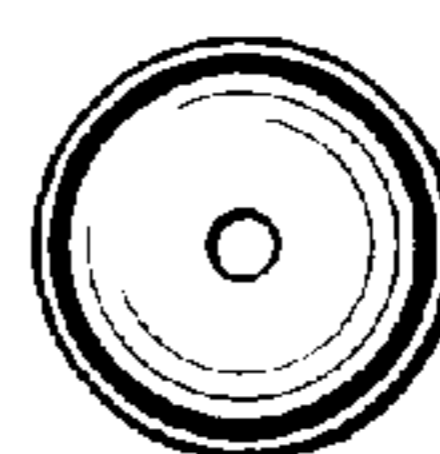

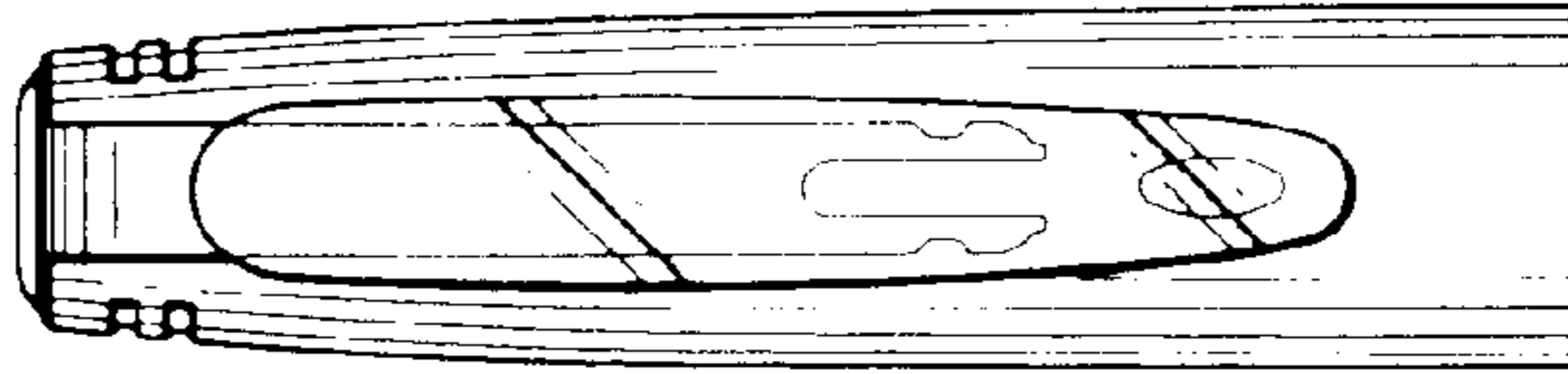

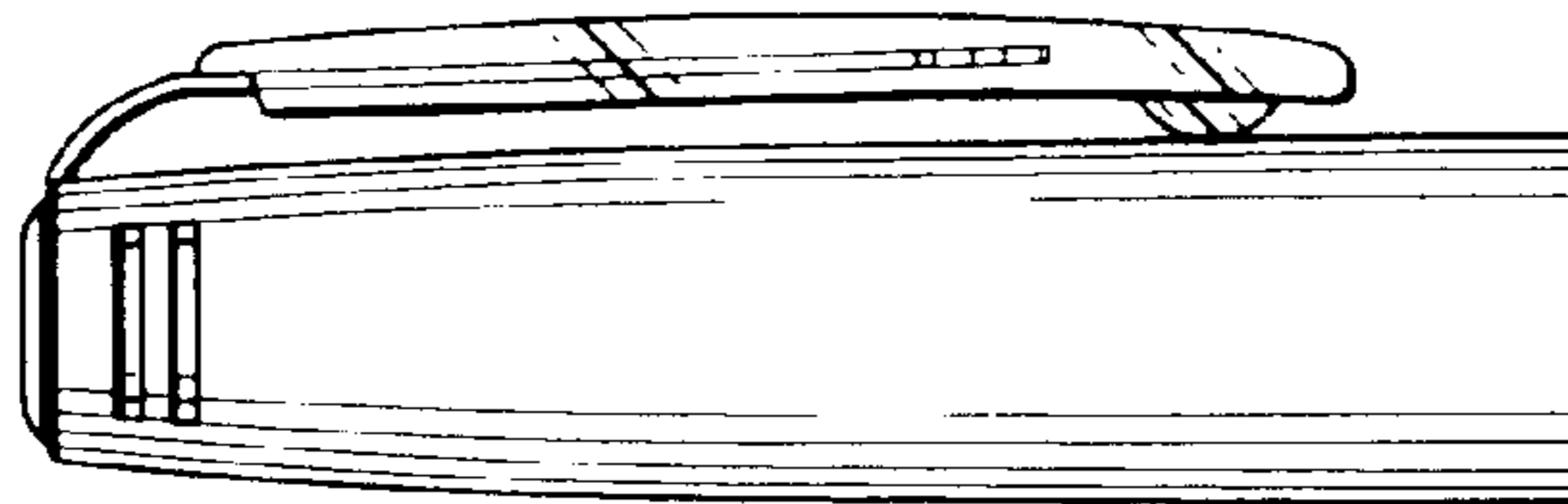

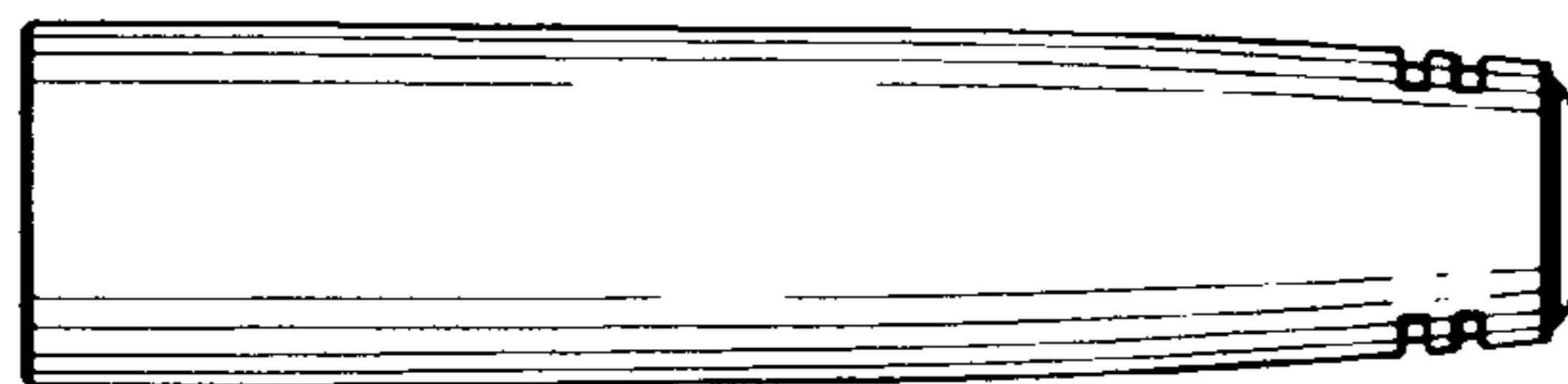

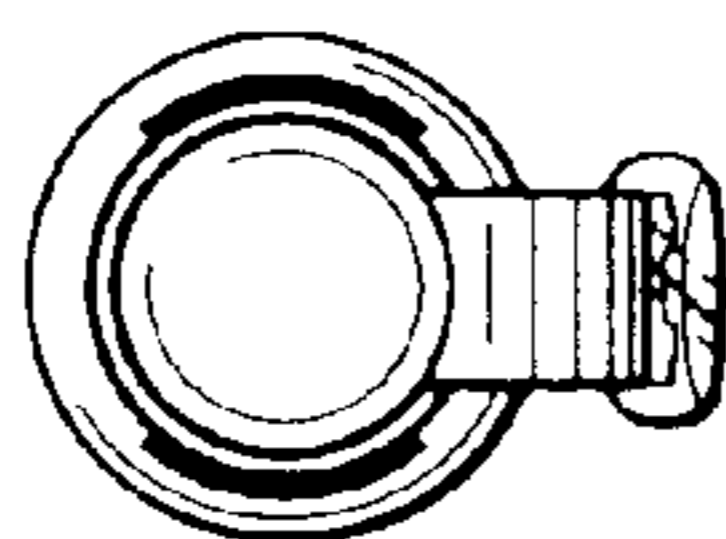
