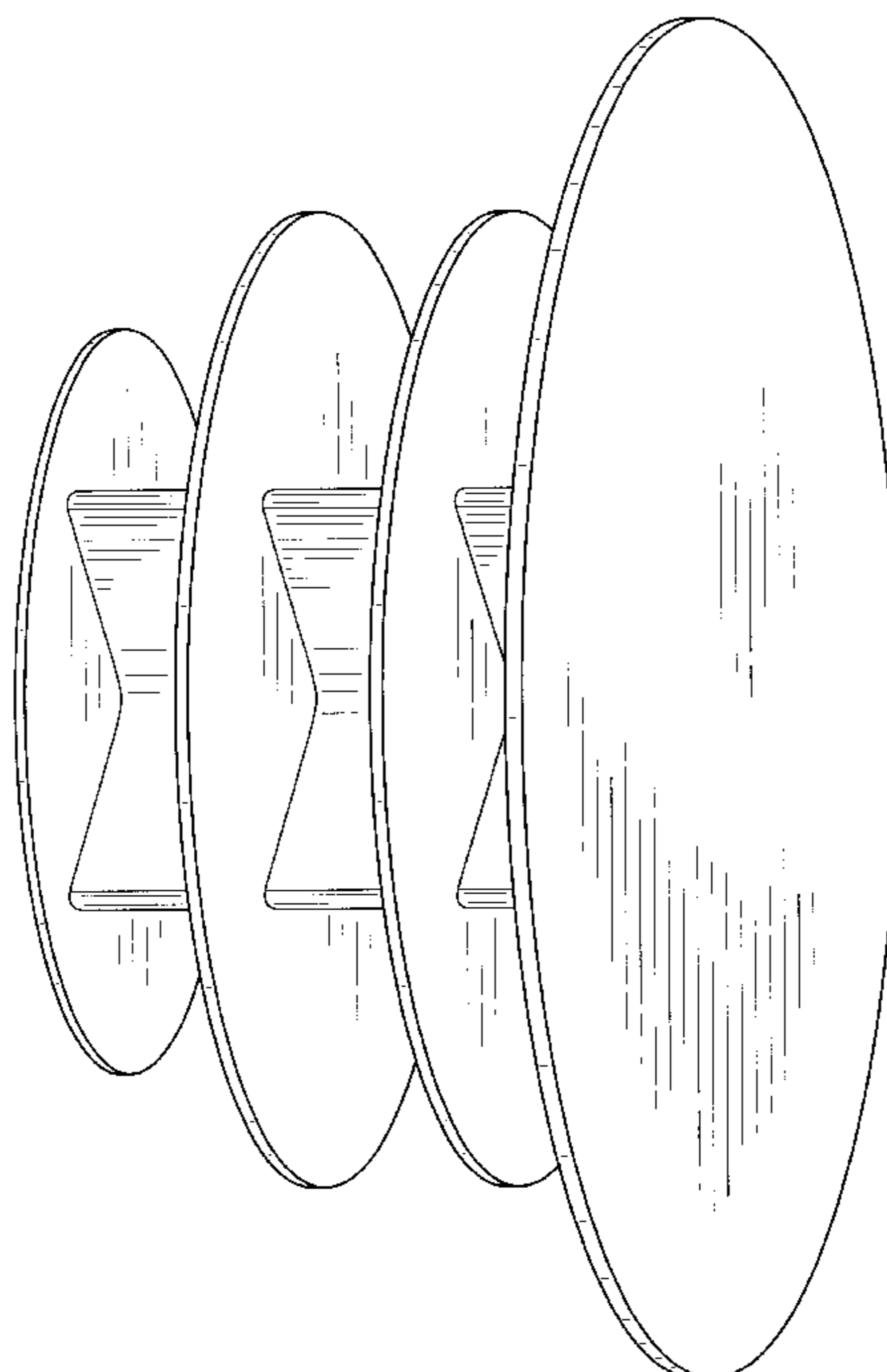
(57) **CLAIM**

The ornamental design for plug for apertures, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the plug for apertures showing our new design; FIG. 2 is a left side elevational view thereof, the right side, front and back elevational views being identical thereto; FIG. 3 is a top plan view thereof; and, FIG. 4 is a bottom plan view thereof.

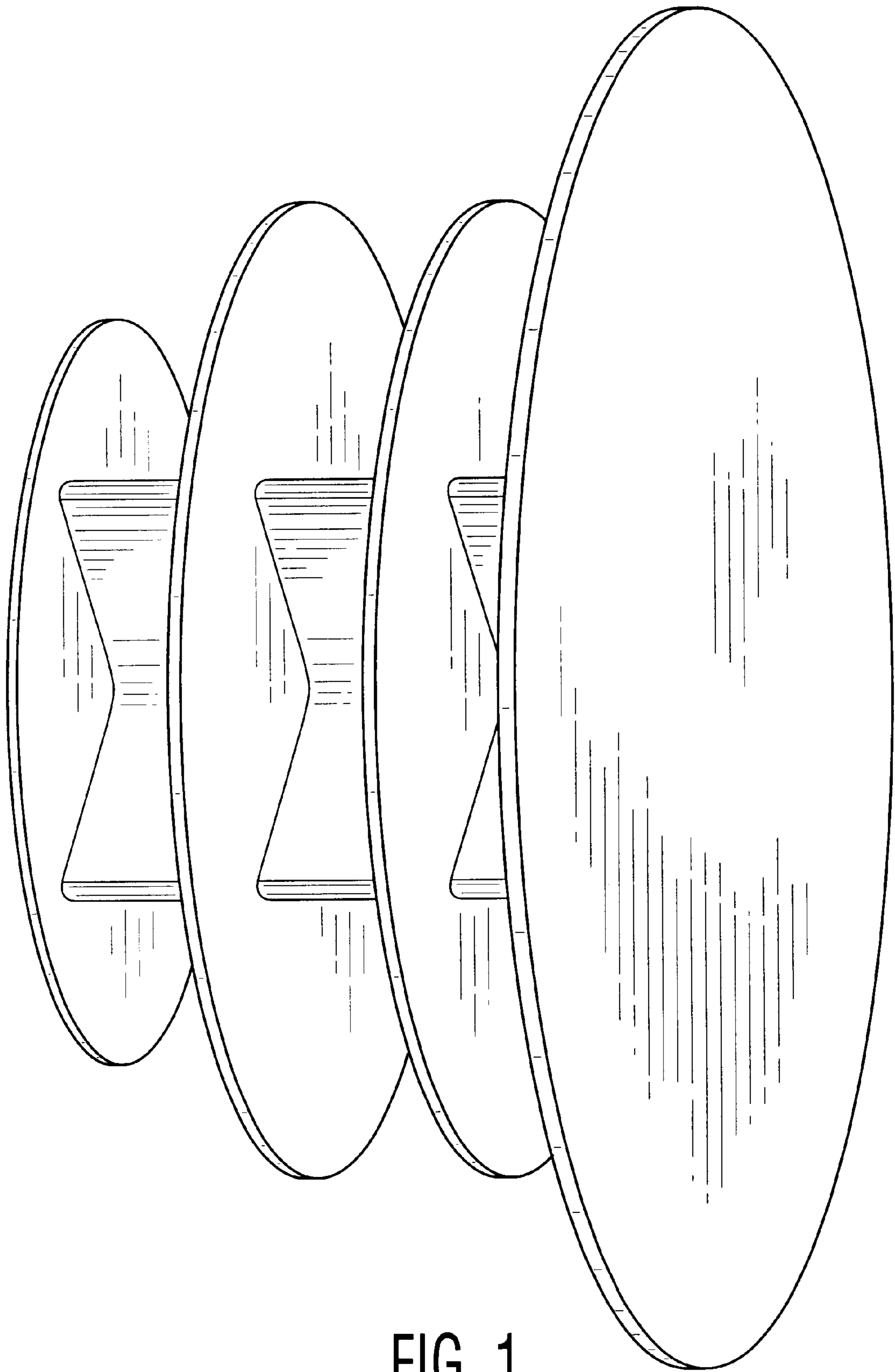

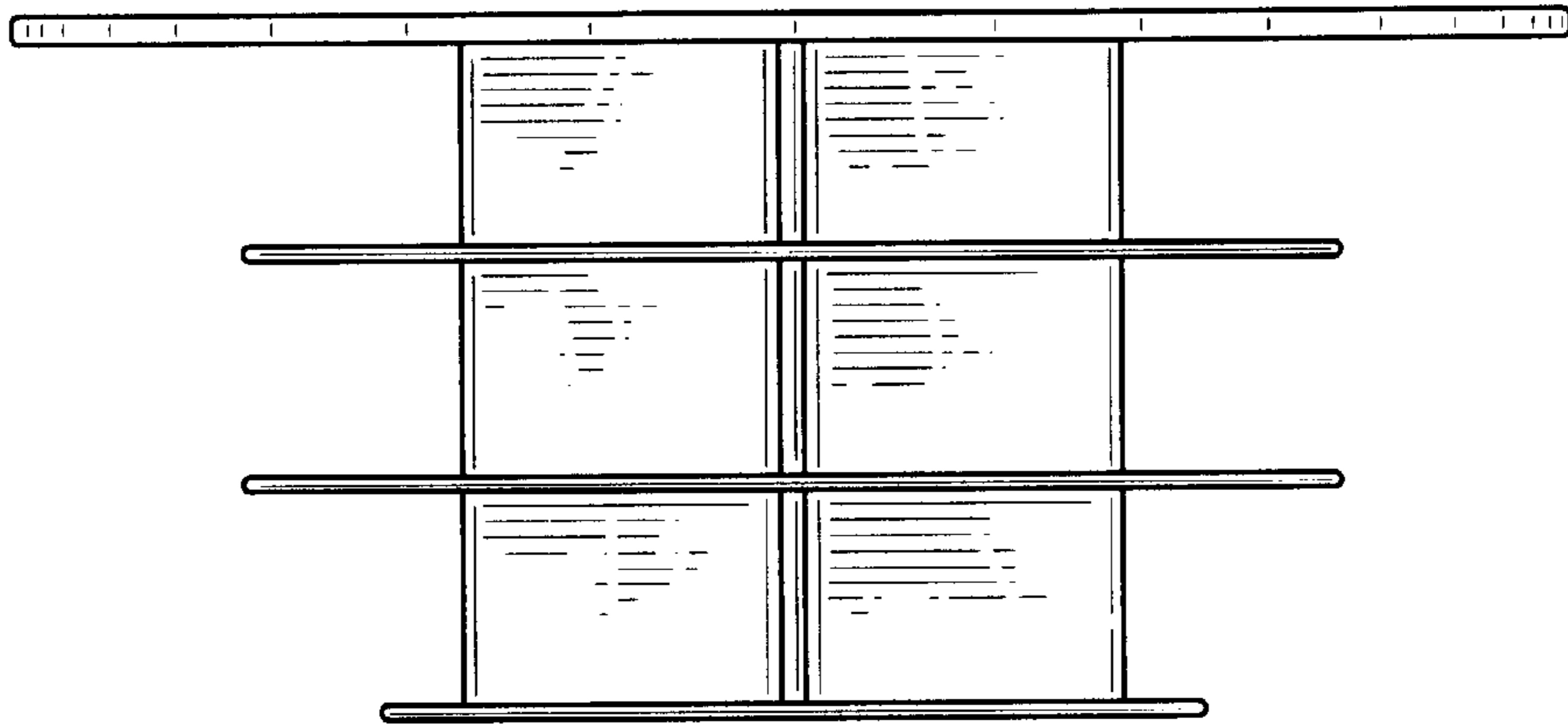

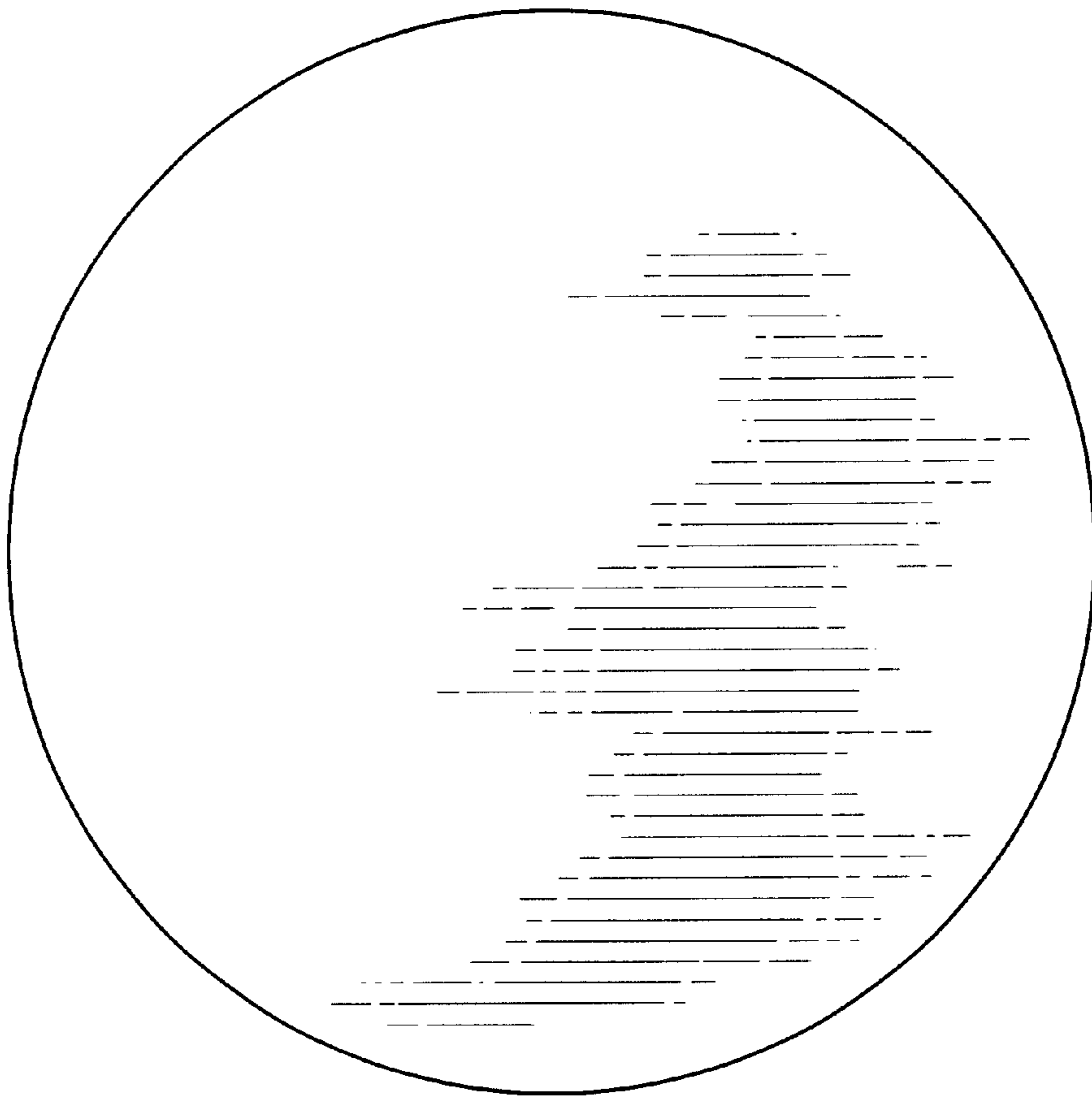

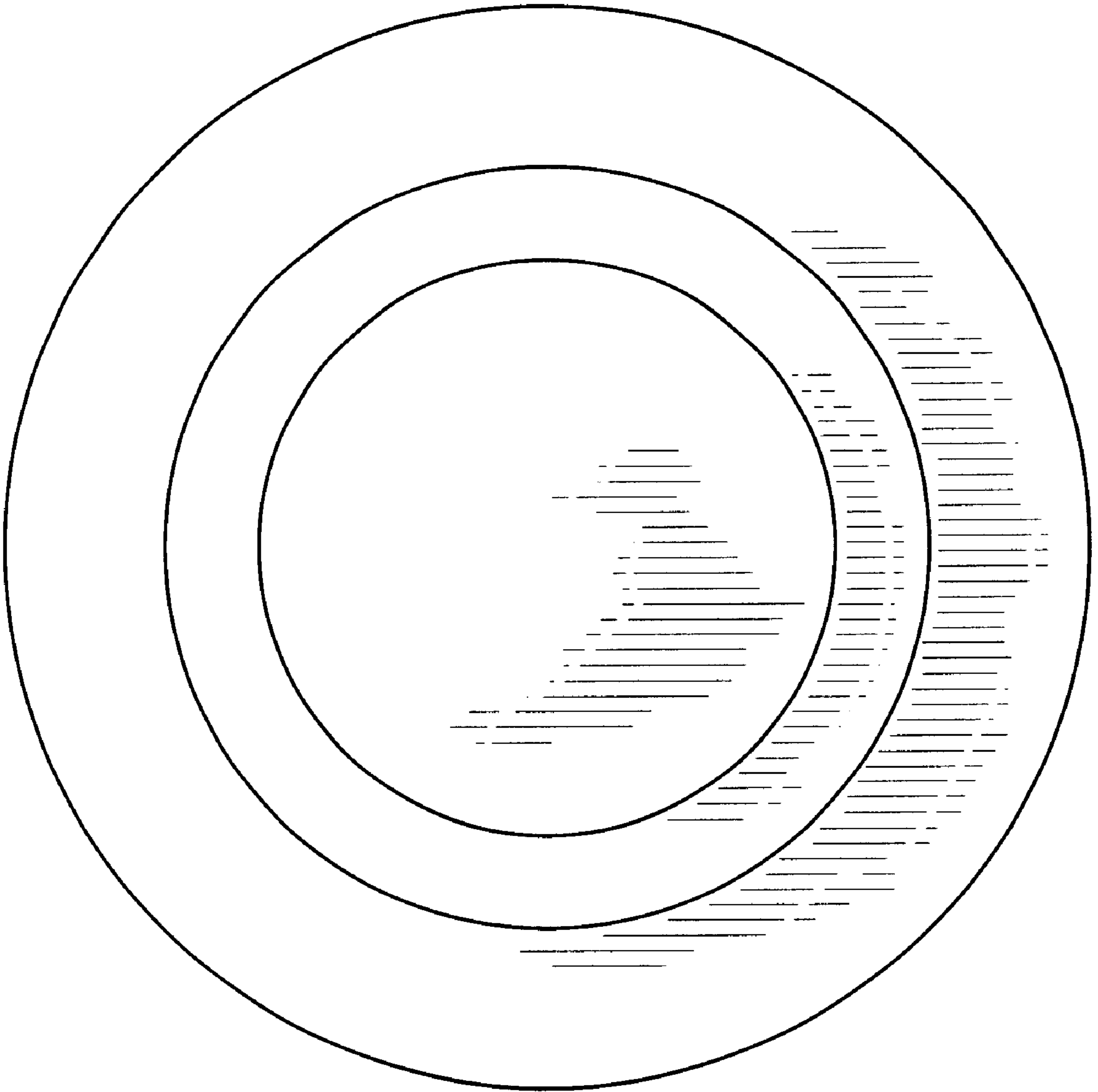
