(57) **CLAIM**

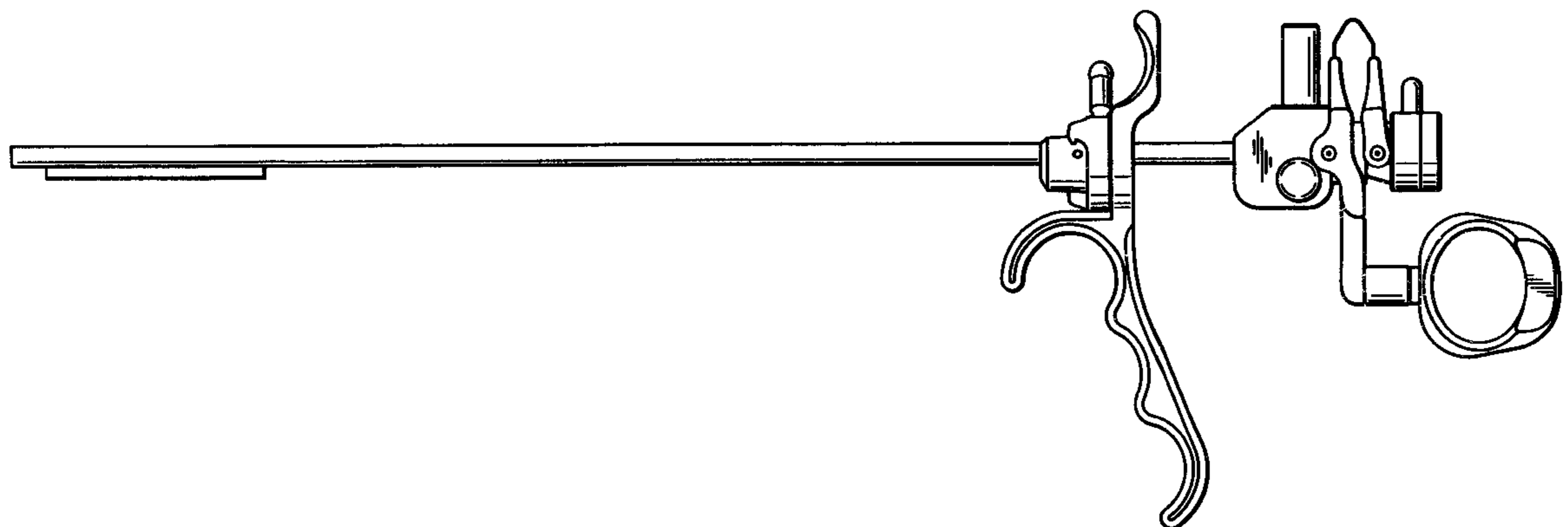
We claim the ornamental design for a tool holder, substantially as shown and described.

DESCRIPTION

FIG. 1 is a left side view of a tool holder showing my design;

FIG. 2 is a top view of the tool holder shown in FIG. 1;
 FIG. 3 is a right side view of the tool holder shown in FIG. 1;
 FIG. 4 is a bottom view of the tool holder shown in FIG. 1;
 FIG. 5 is a front view of the tool holder shown in FIG. 1;
 FIG. 6 is a rear view of the tool holder shown in FIG. 1;
 FIG. 7 is a front perspective view of the handle of the tool holder shown in FIG. 1;

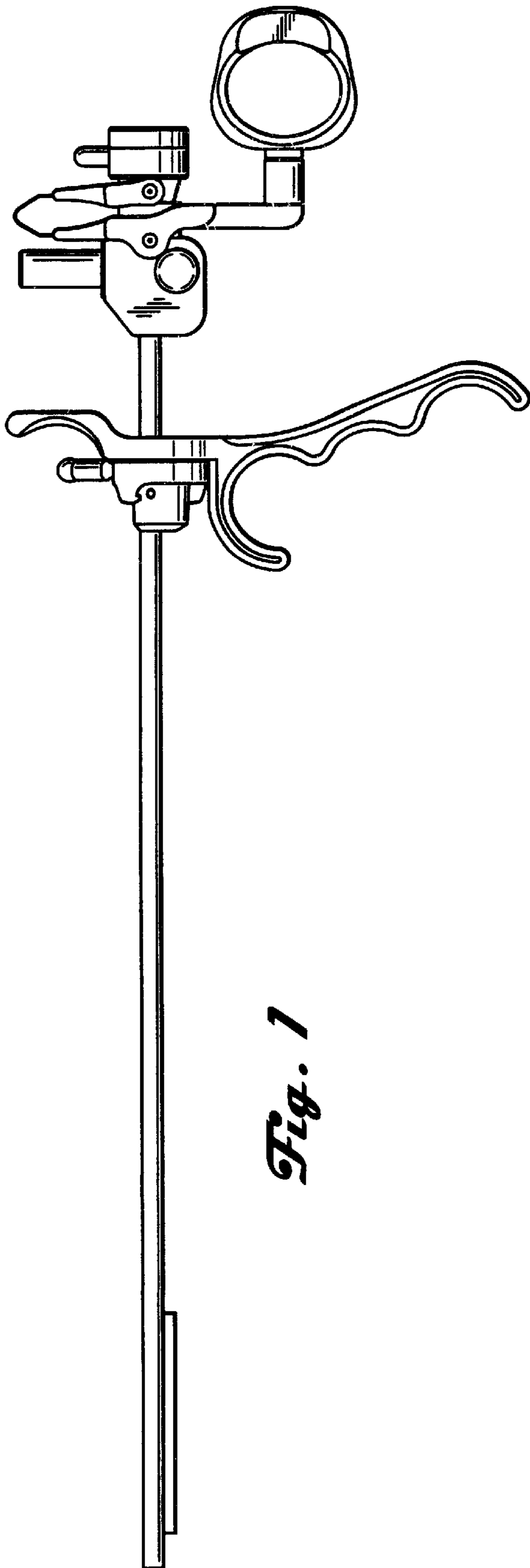

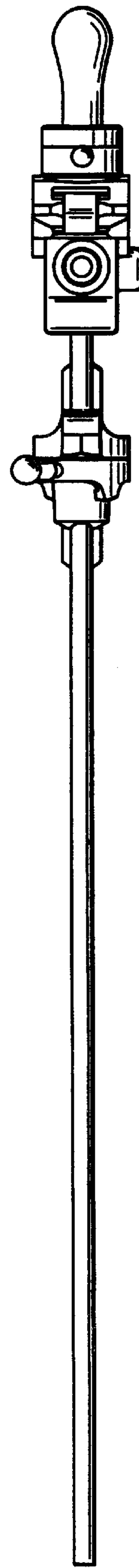
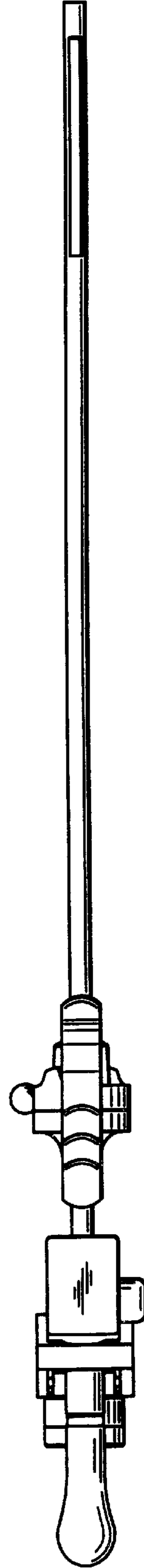
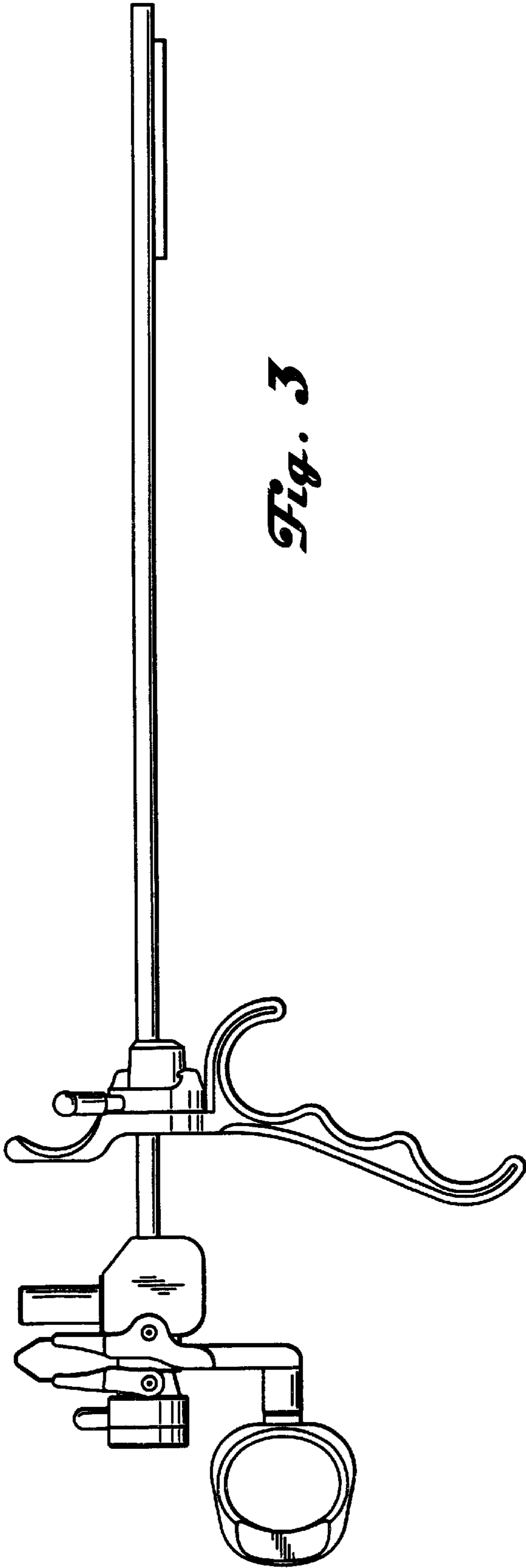

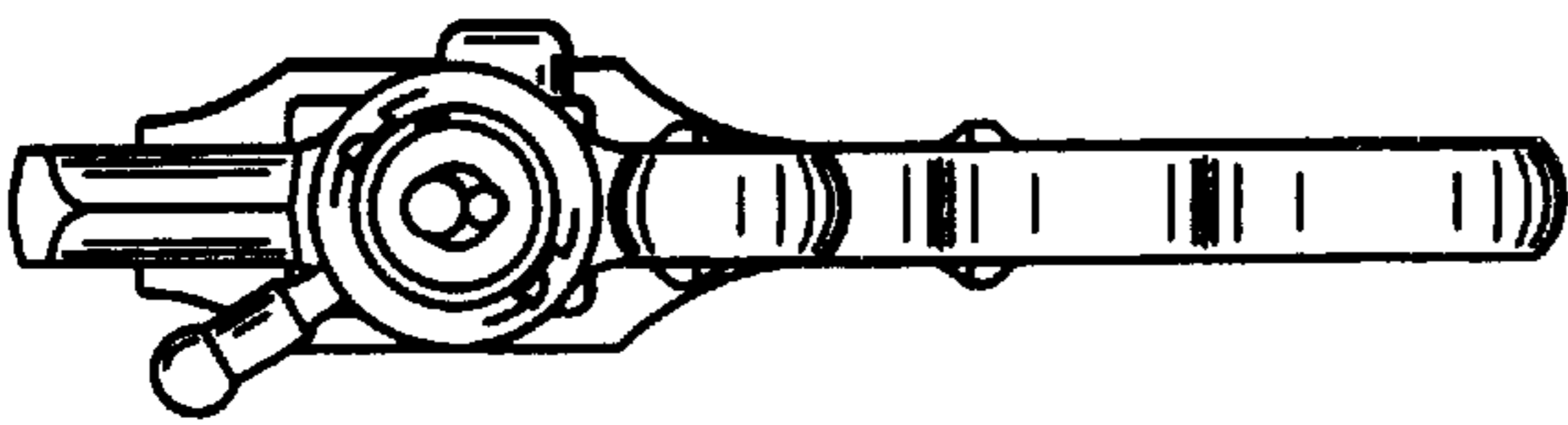

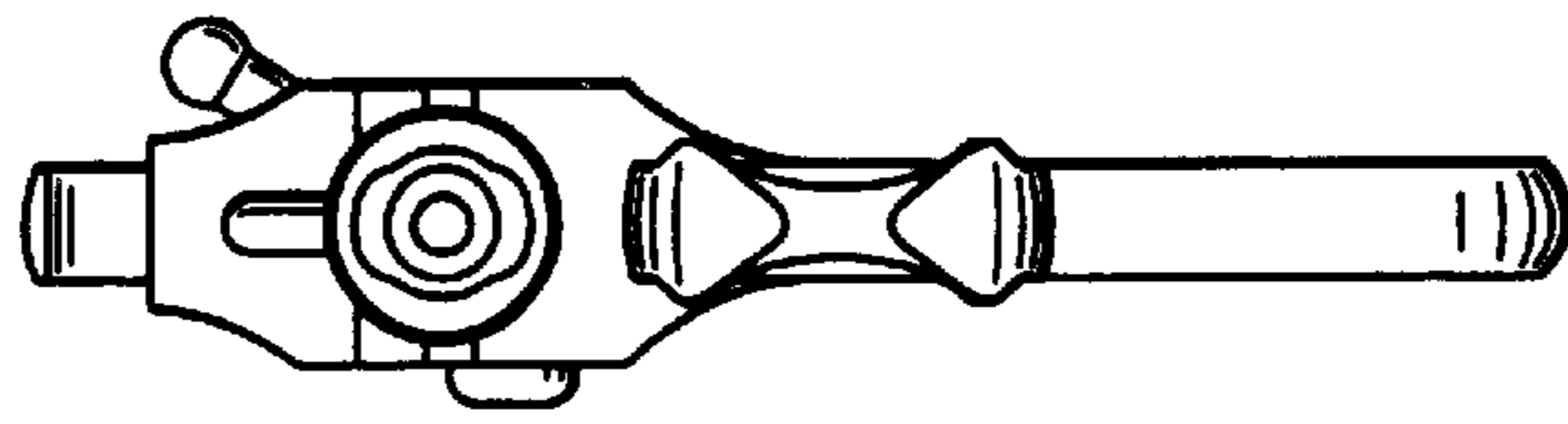

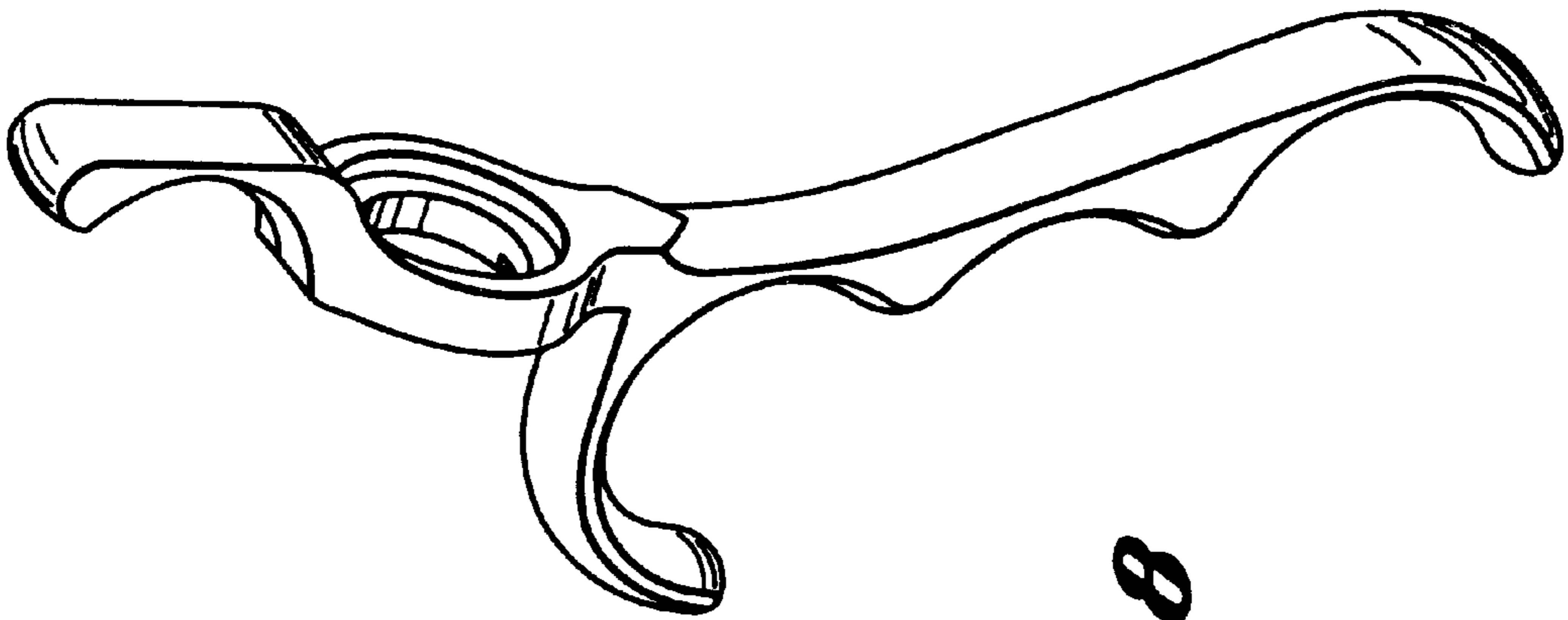

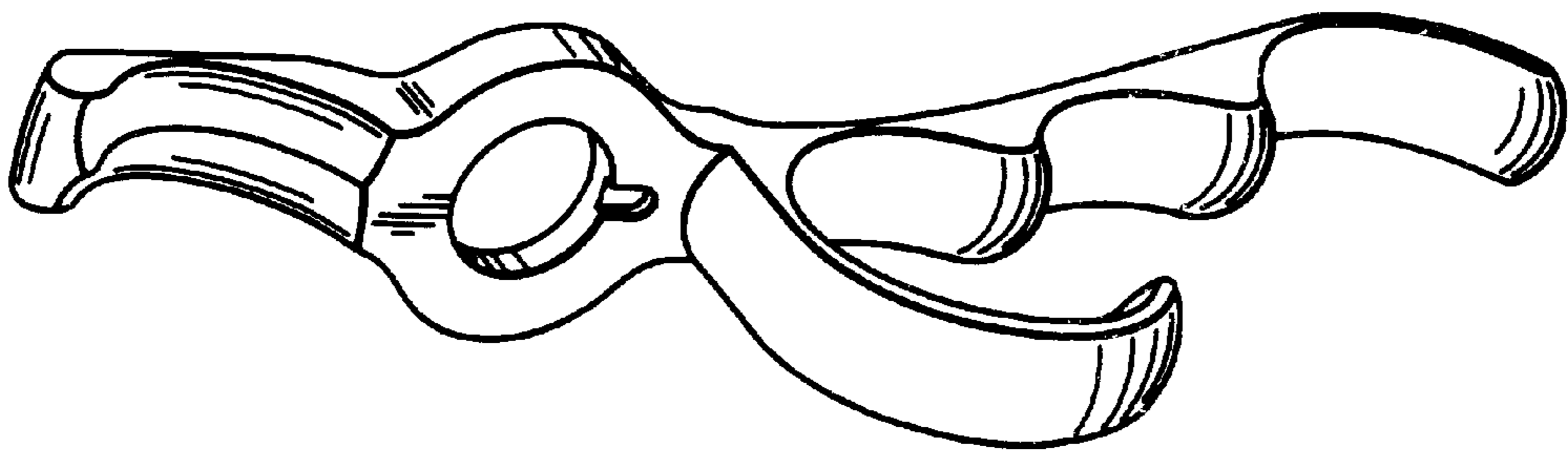

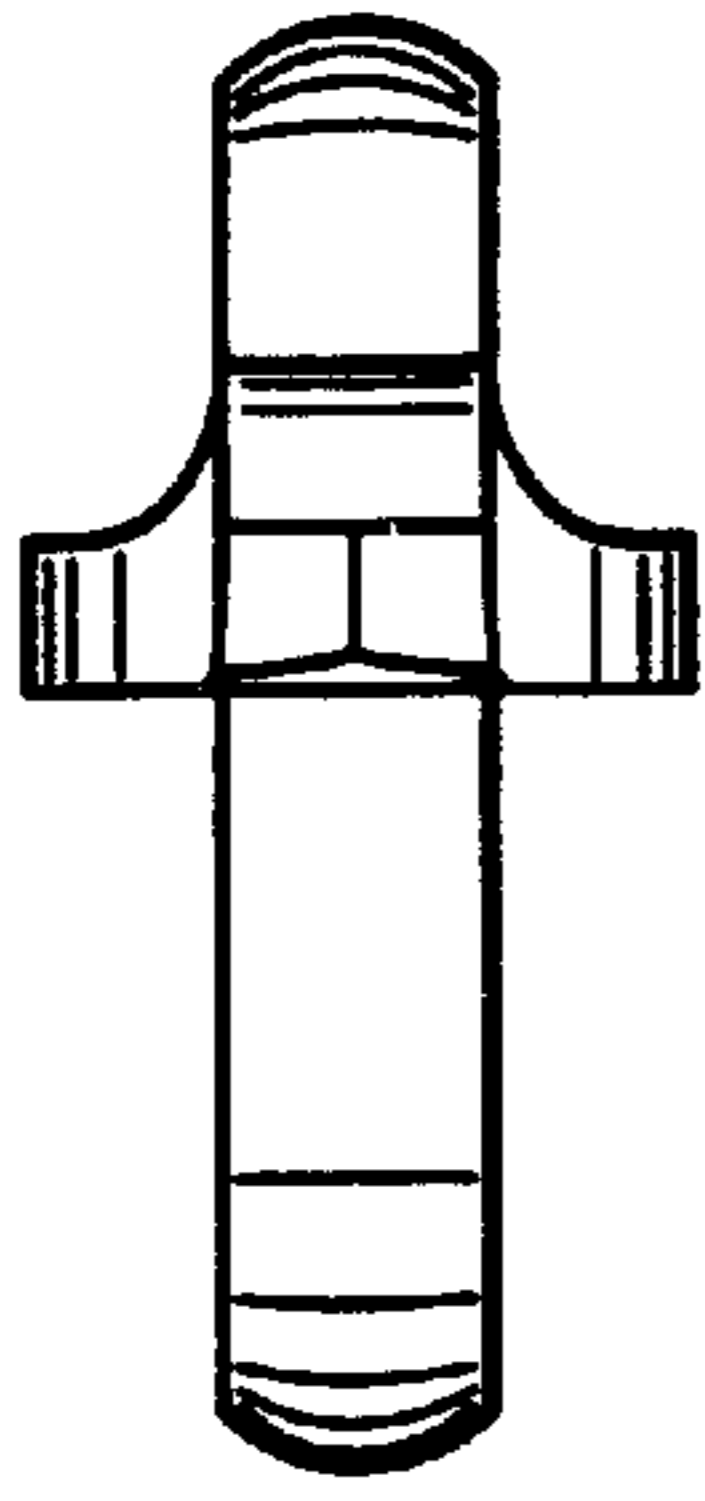

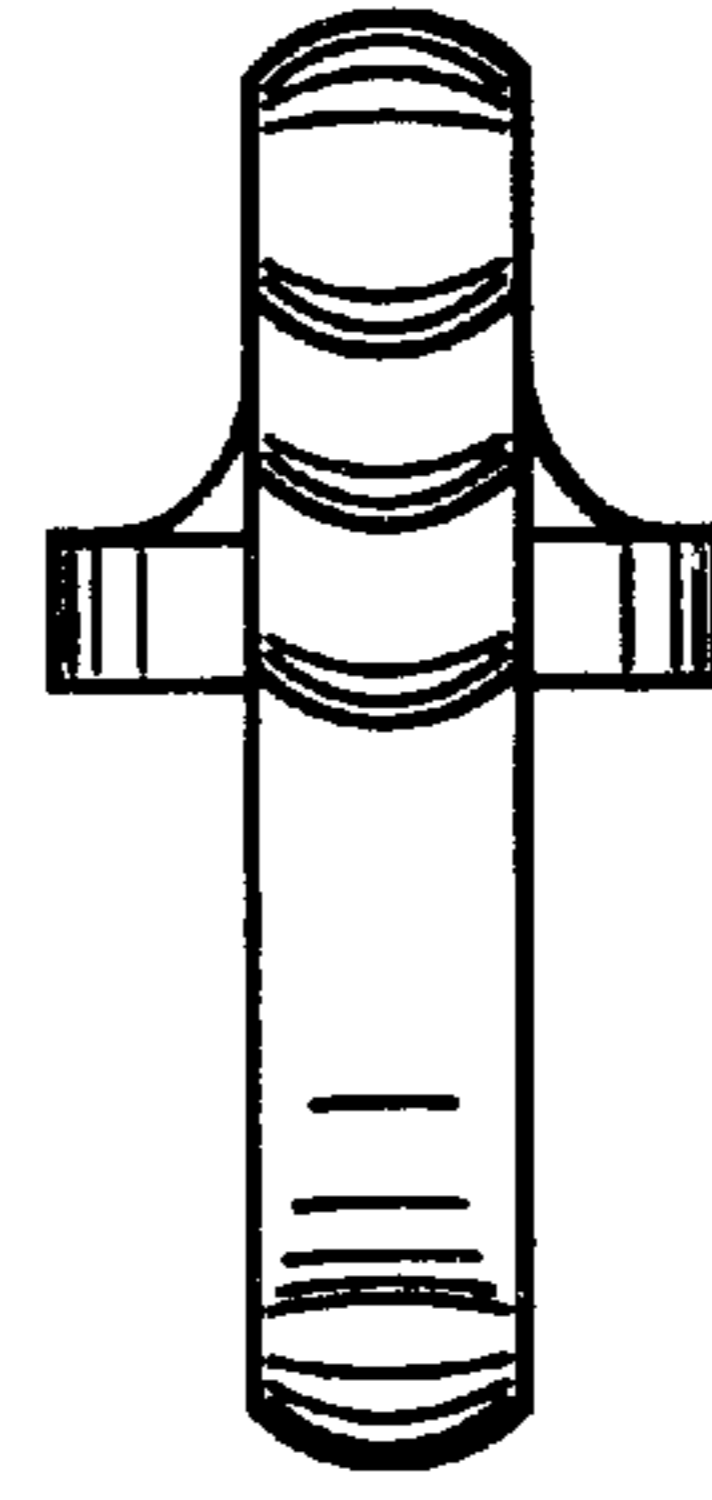

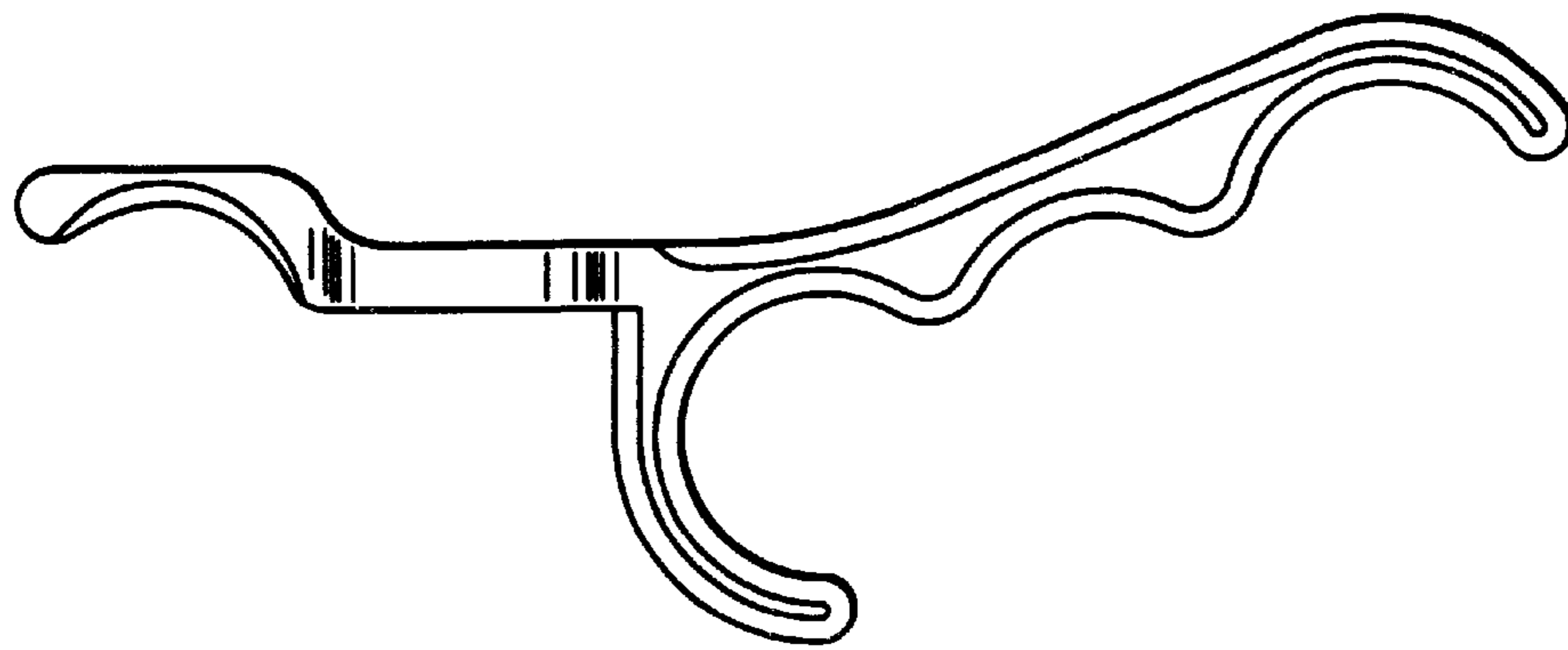

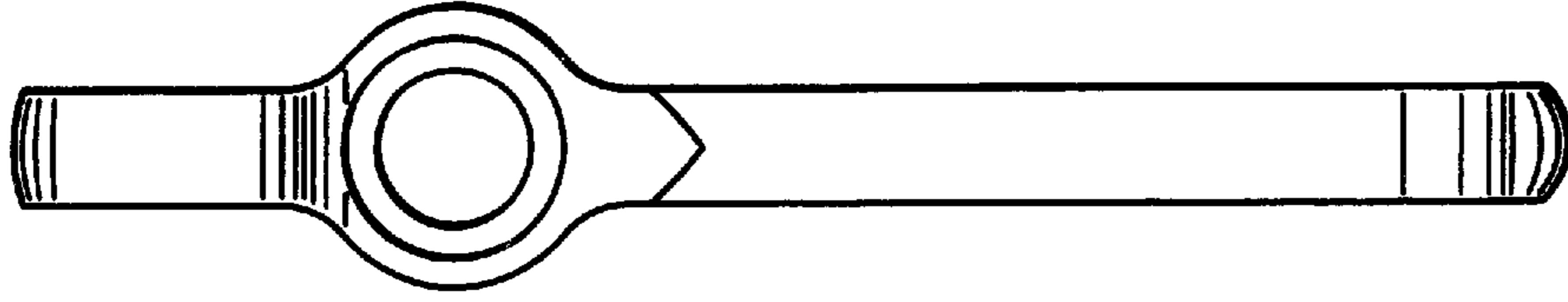

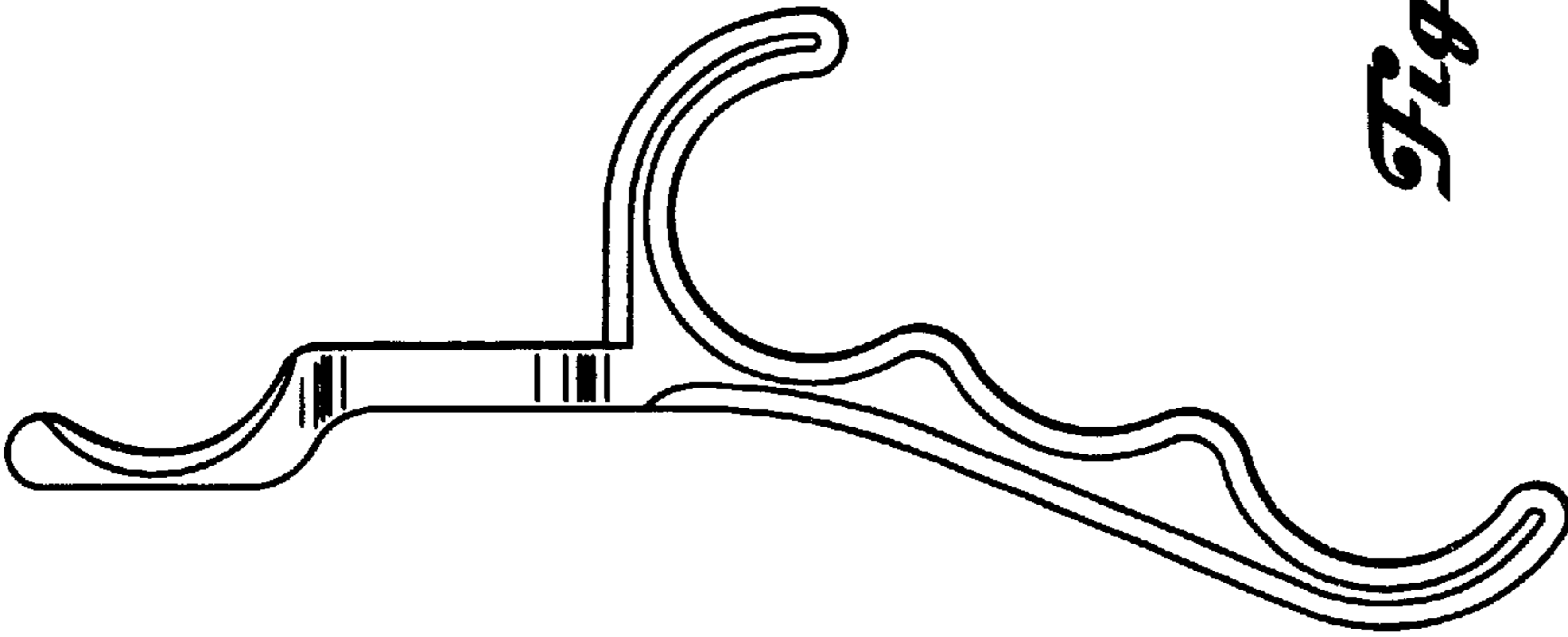

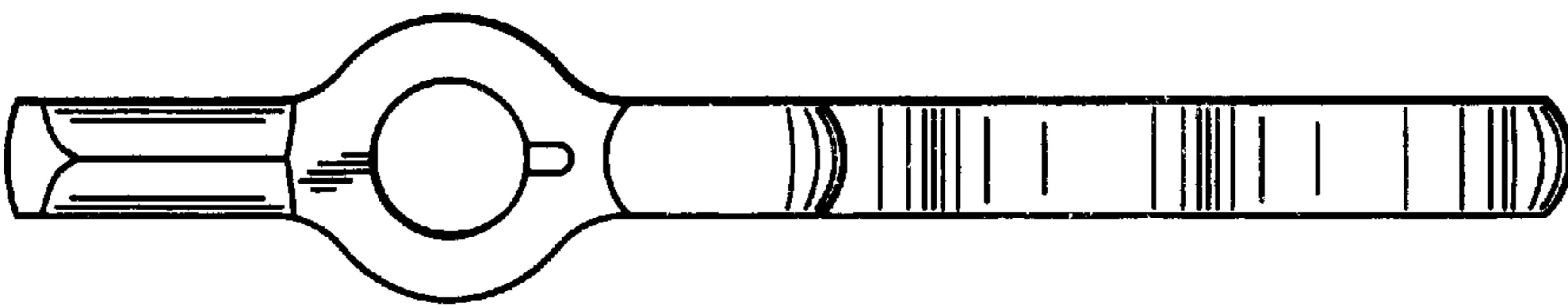

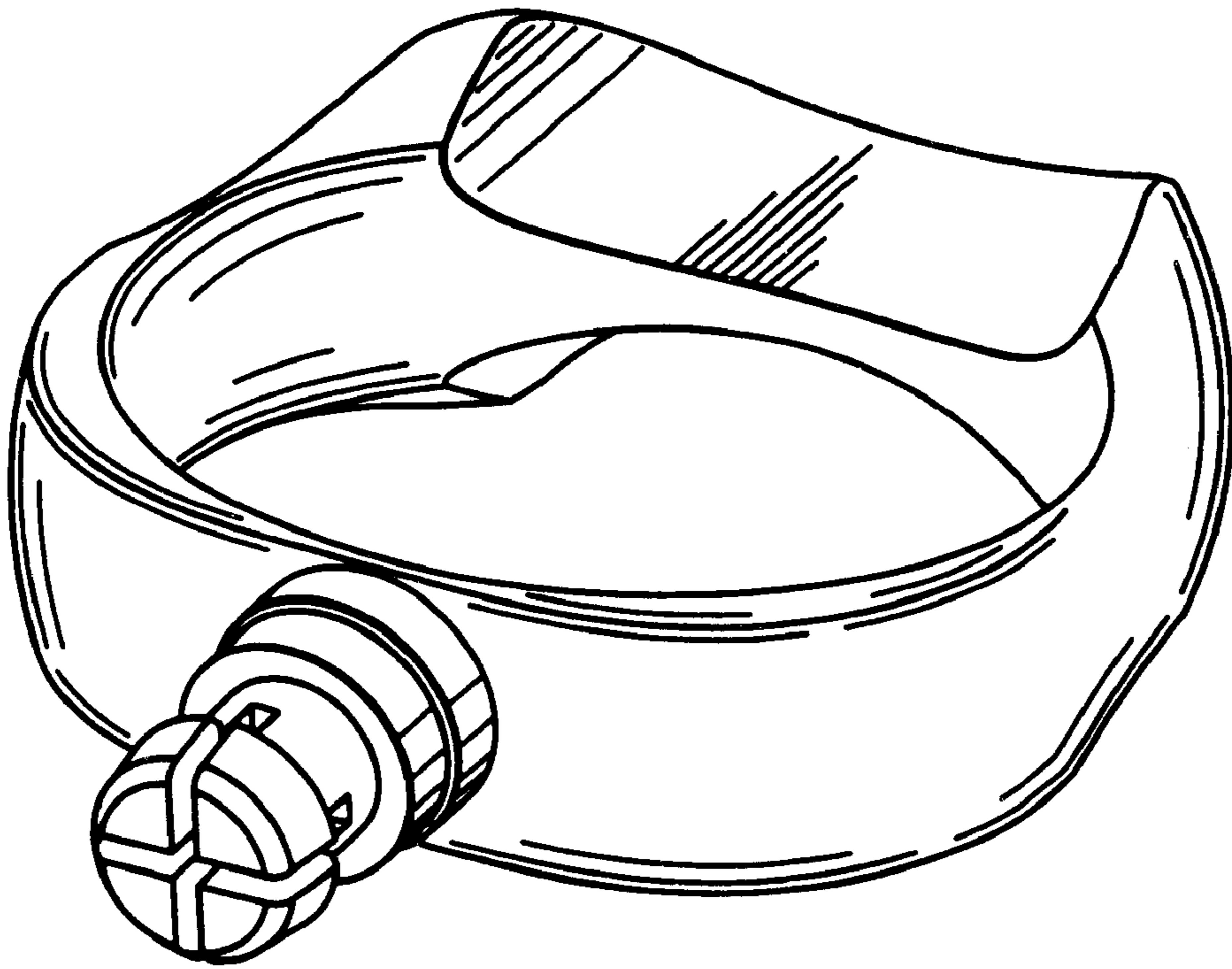

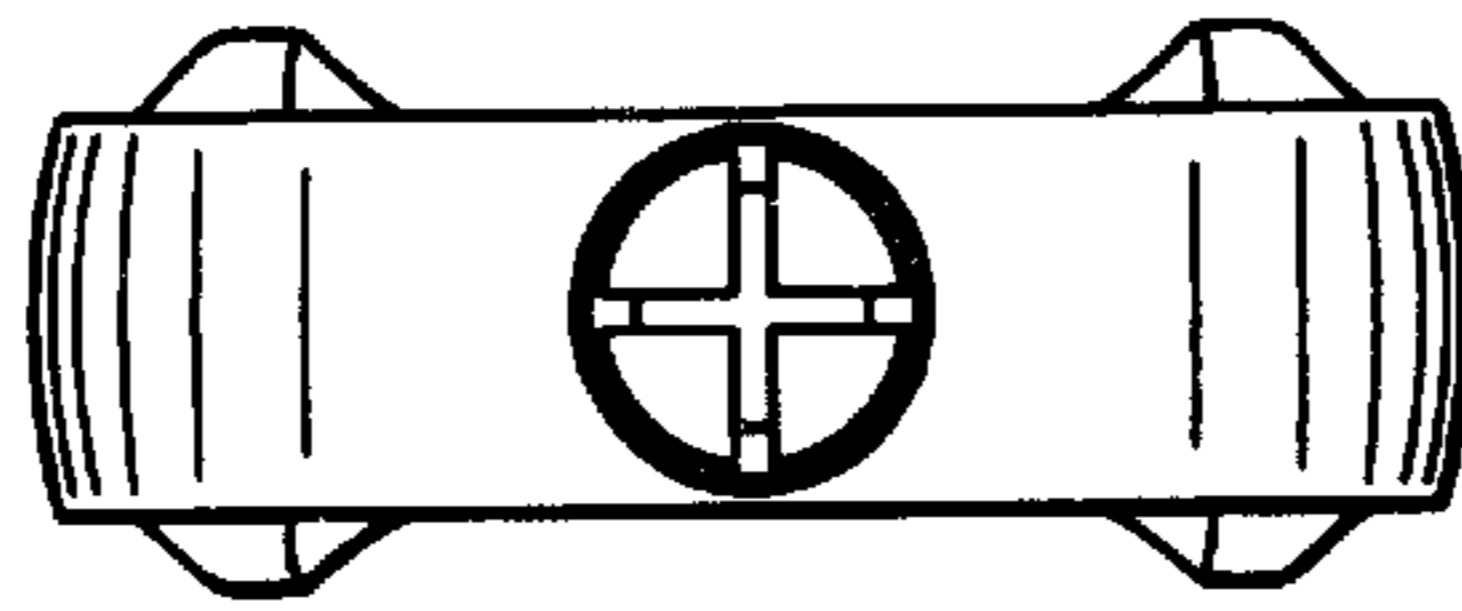

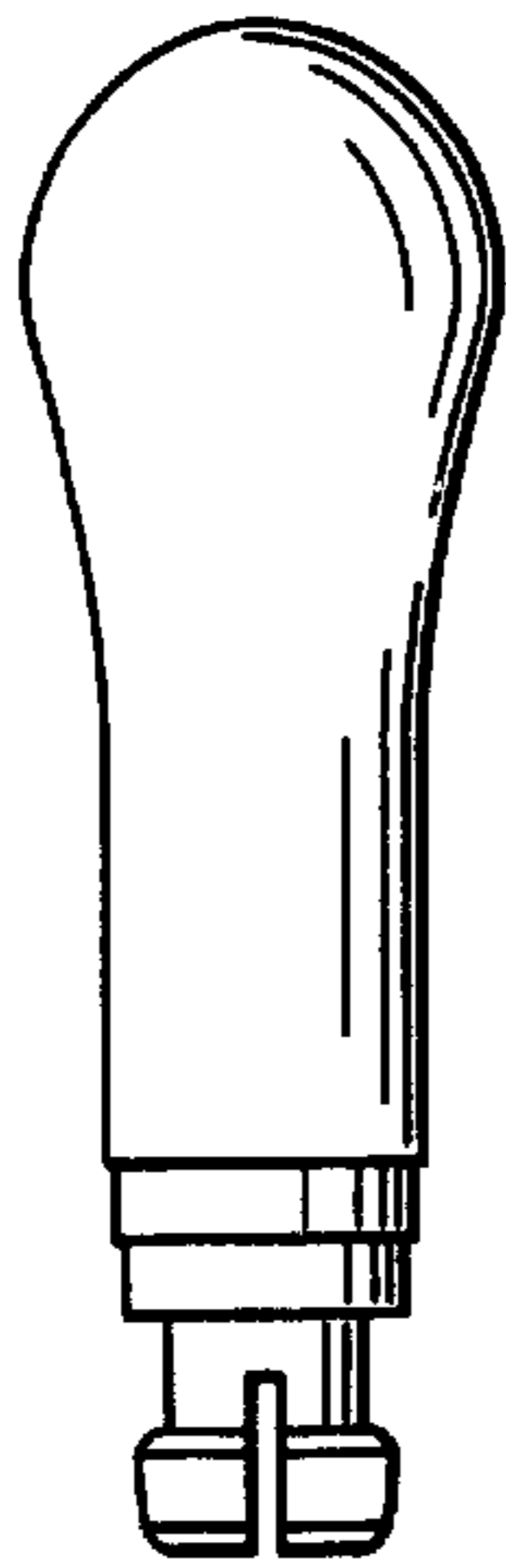

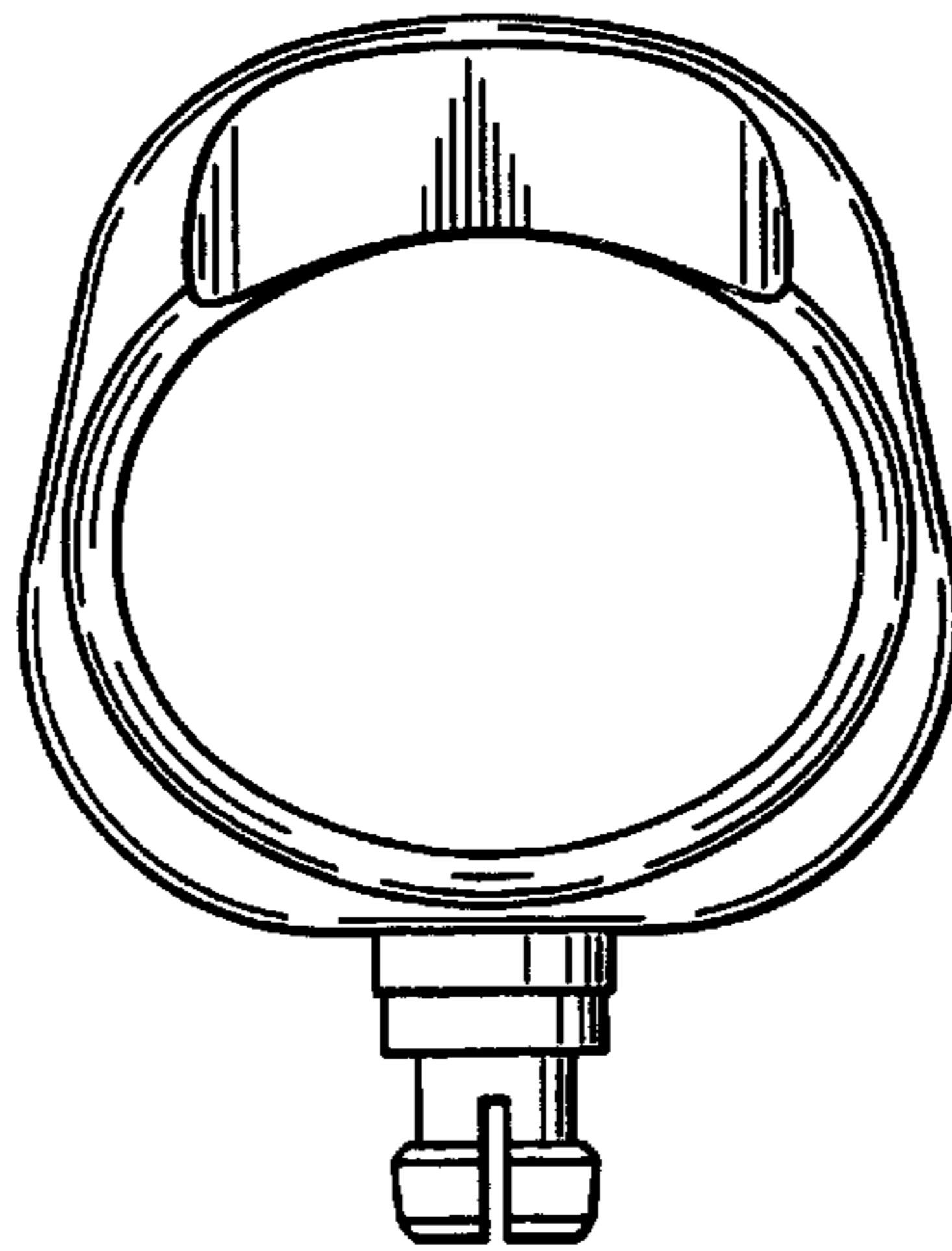

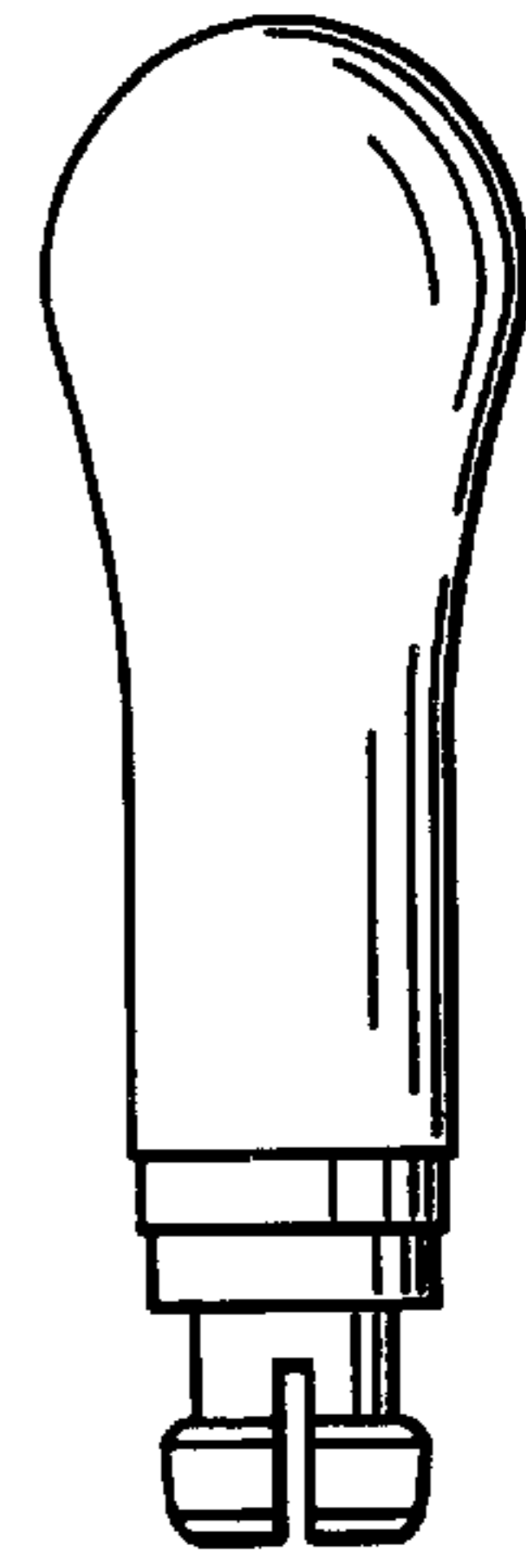

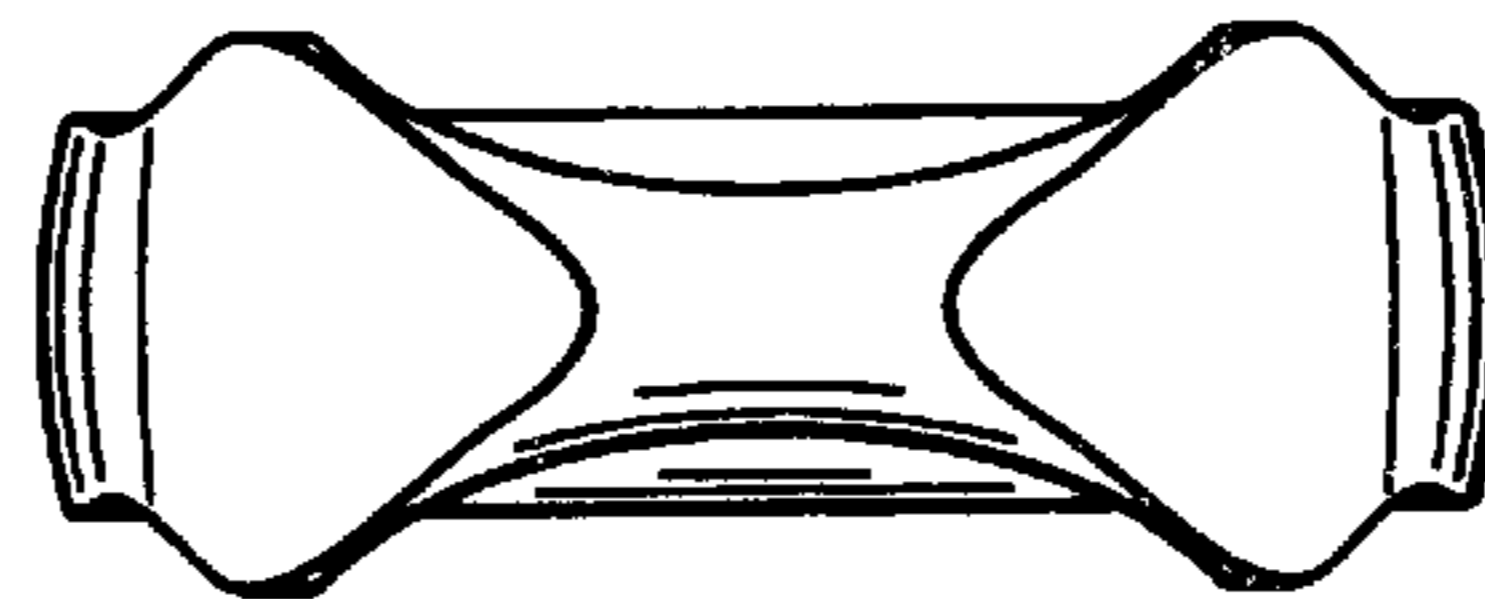
