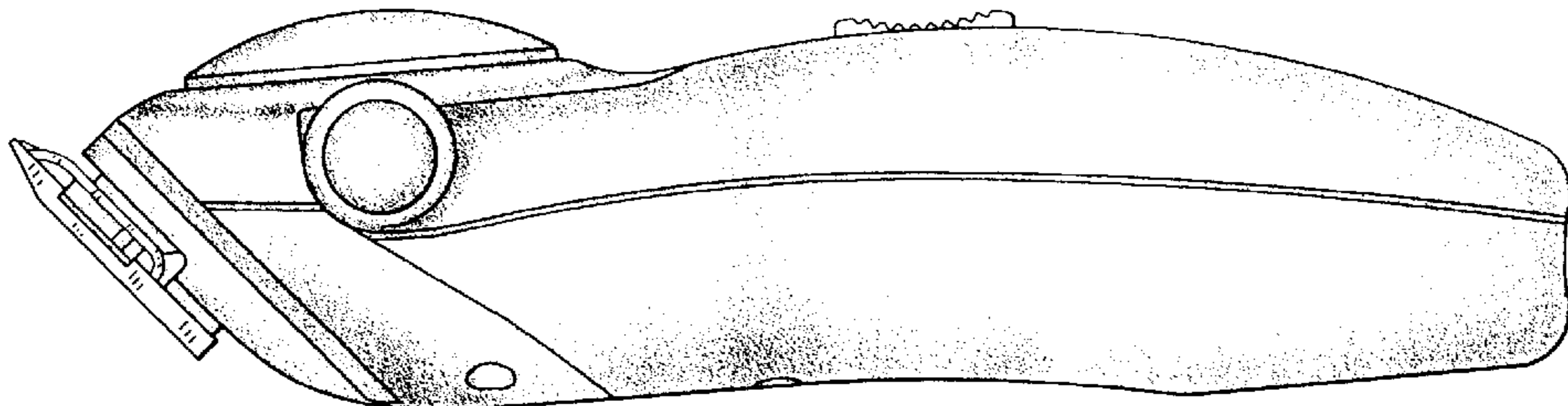
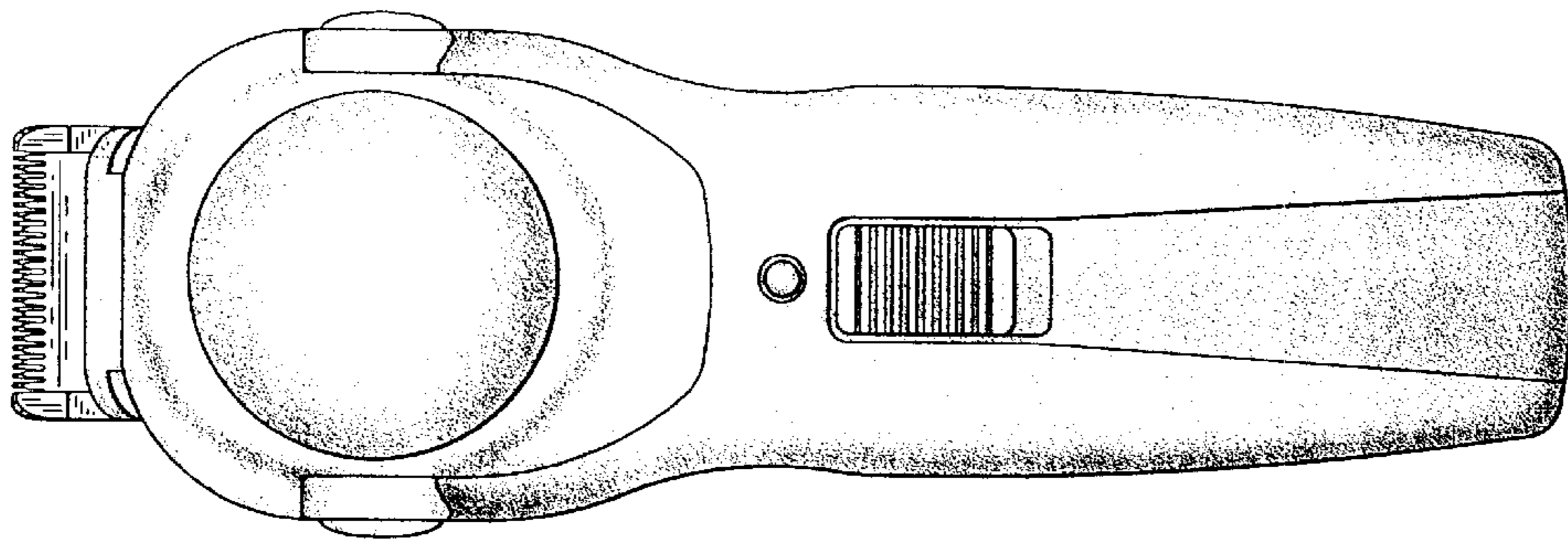
(57) **CLAIM**

The ornamental design for the hair clipper, as shown and described in the accompanying figures.

DESCRIPTION

FIG. 1 is a top view of the hair clipper according to the present invention;
FIG. 2 is a bottom view of the hair clipper of FIG. 1;
FIG. 3 is a right side view of the hair clipper of FIG. 1, the side opposite being a mirror image thereof;
FIG. 4 is a front end view of the hair clipper of FIG. 1; and,
FIG. 5 is a rear end view of the hair clipper of FIG. 1.

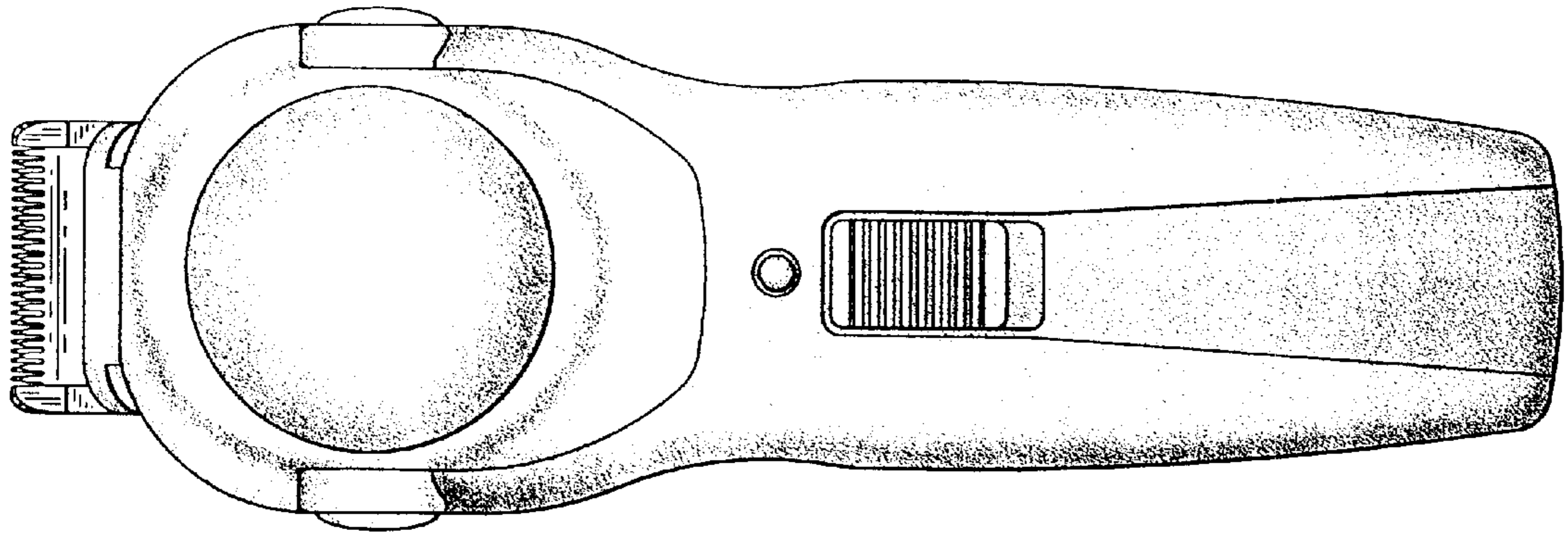

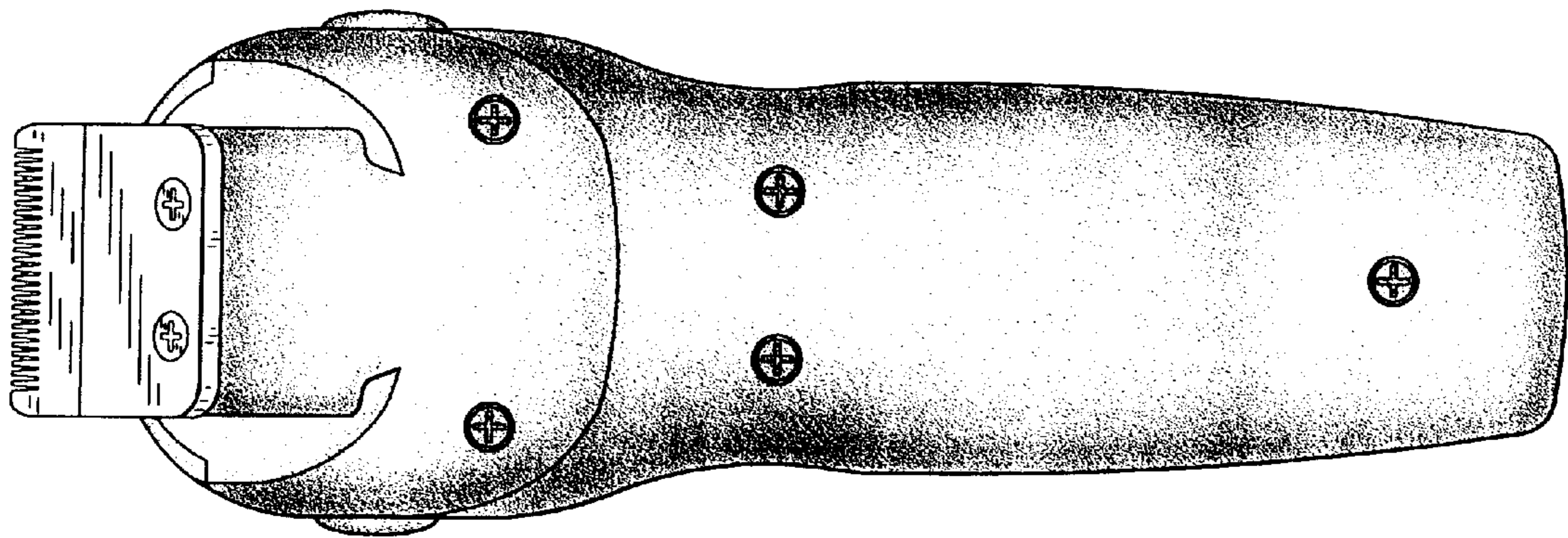

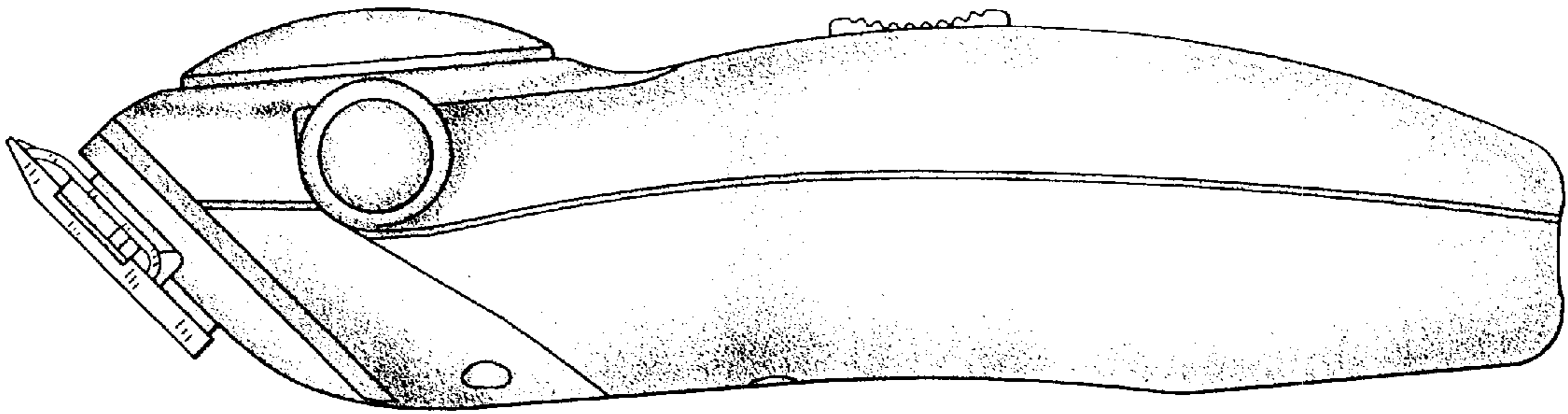

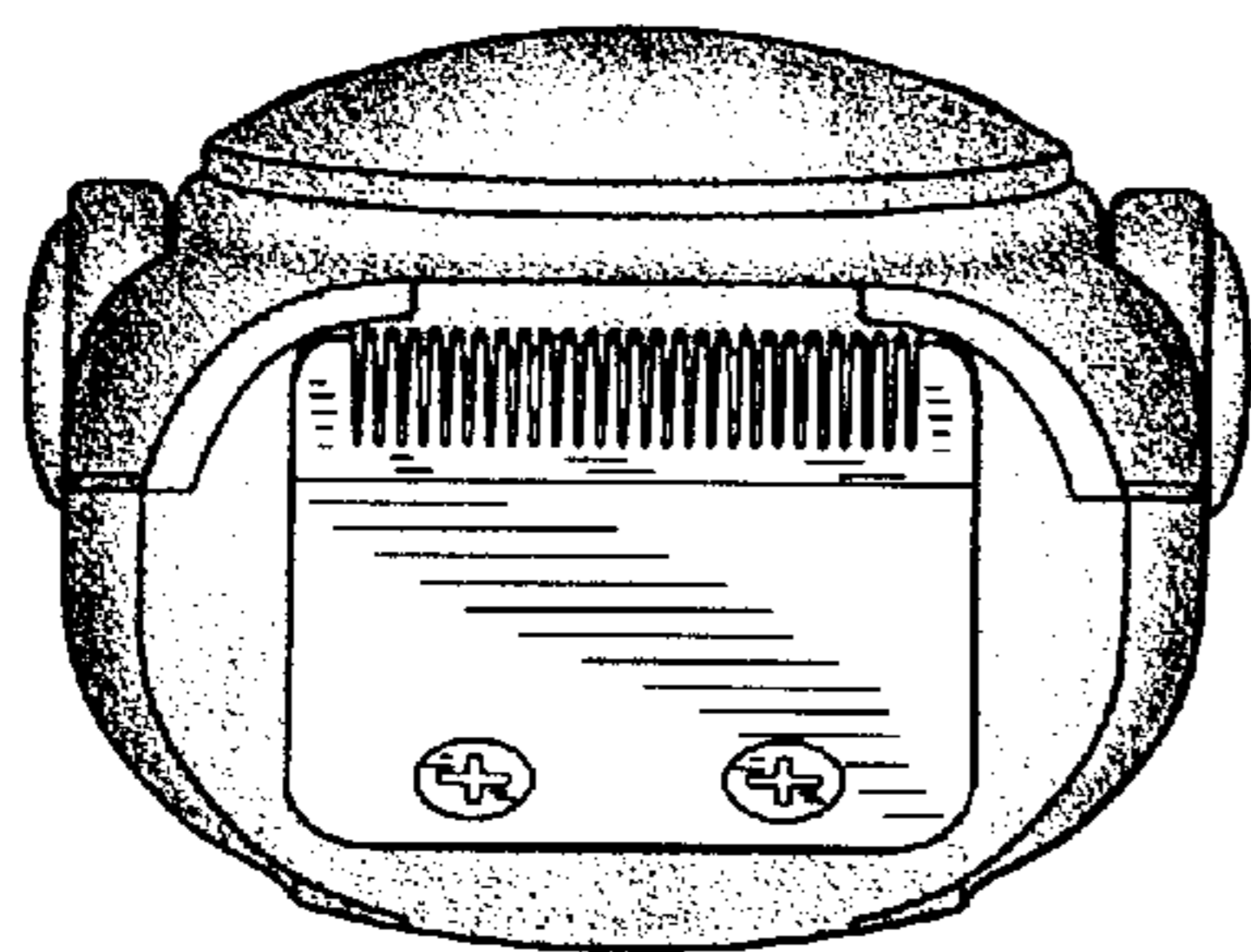

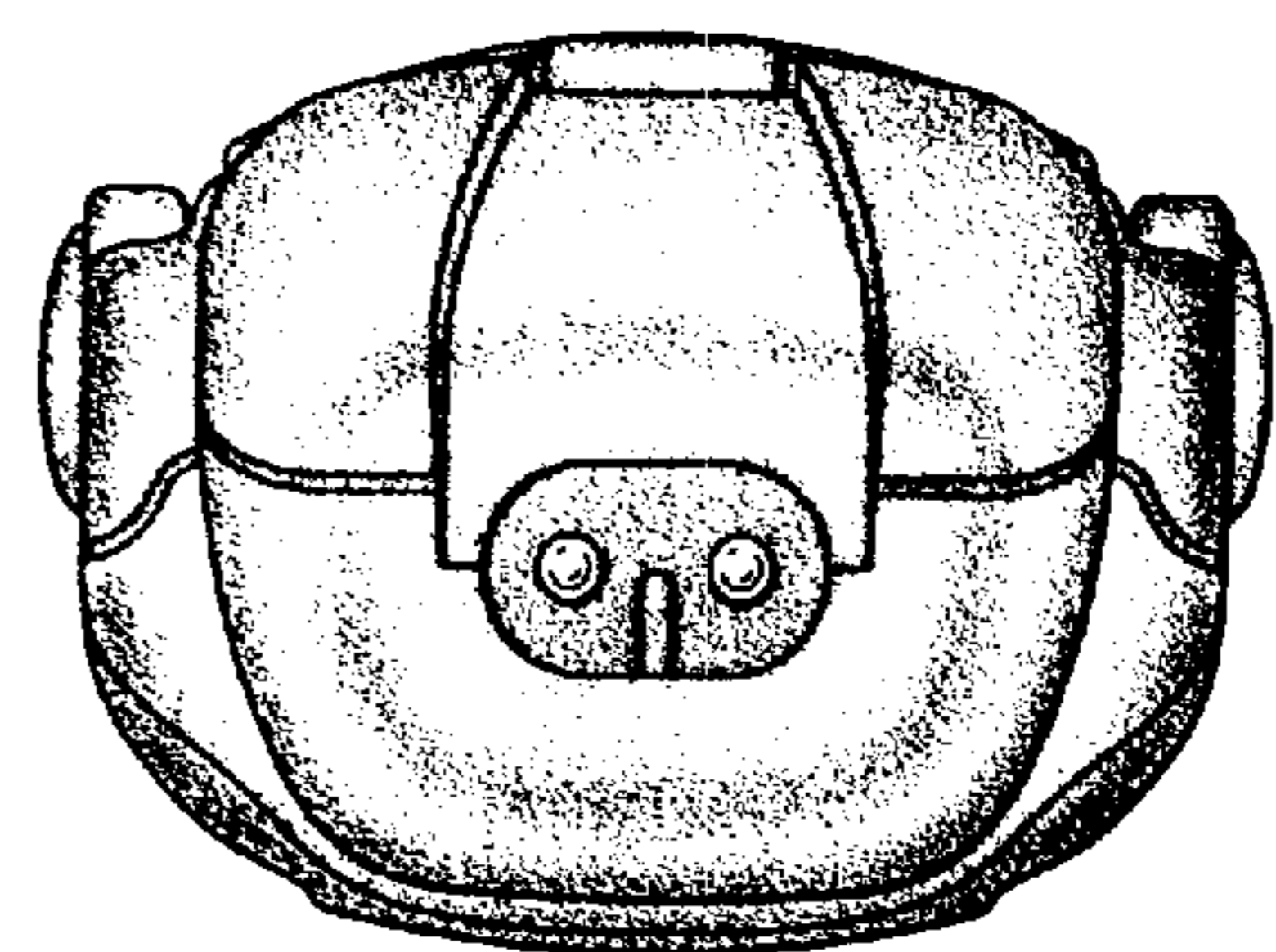
