(57) **CLAIM**

The ornamental design for a curly-shaped puffed extrudate snack food, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the curly-shaped puffed extrudate snack food of the present invention;

FIG. 2 is a rear perspective view of the curly-shaped puffed extrudate snack food of the present invention;

FIG. 3 is a top elevation view of the curly-shaped puffed extrudate snack food of the present invention;

FIG. 4 is a bottom elevation view of the curly-shaped puffed extrudate snack food of the present invention;

FIG. 5 is a front elevation view of the curly-shaped puffed extrudate snack food of the present invention;

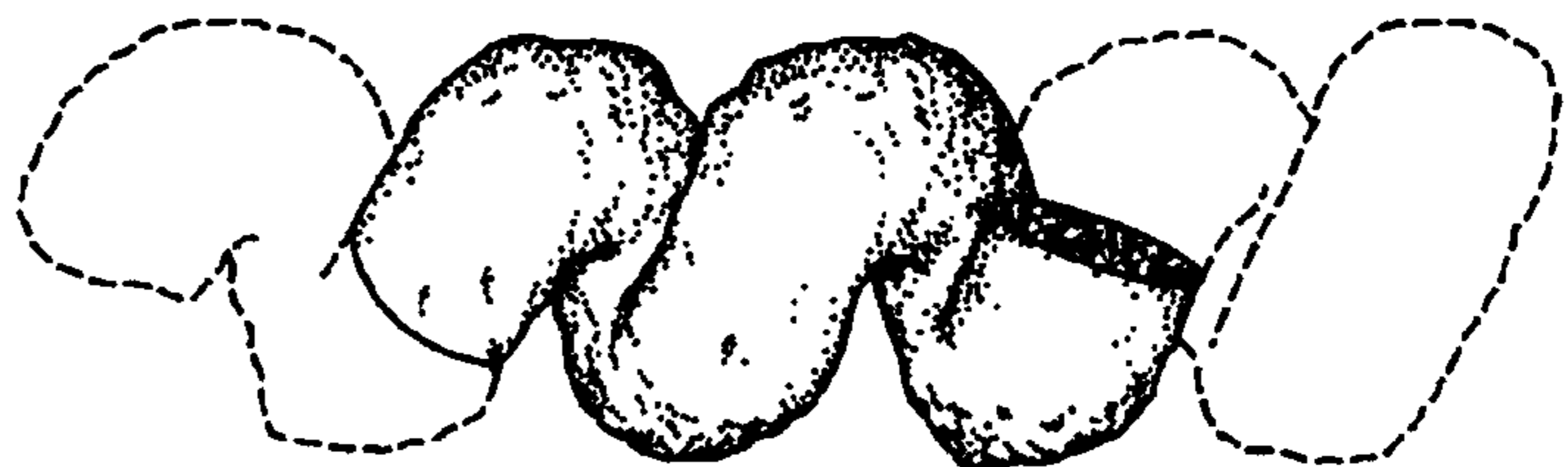
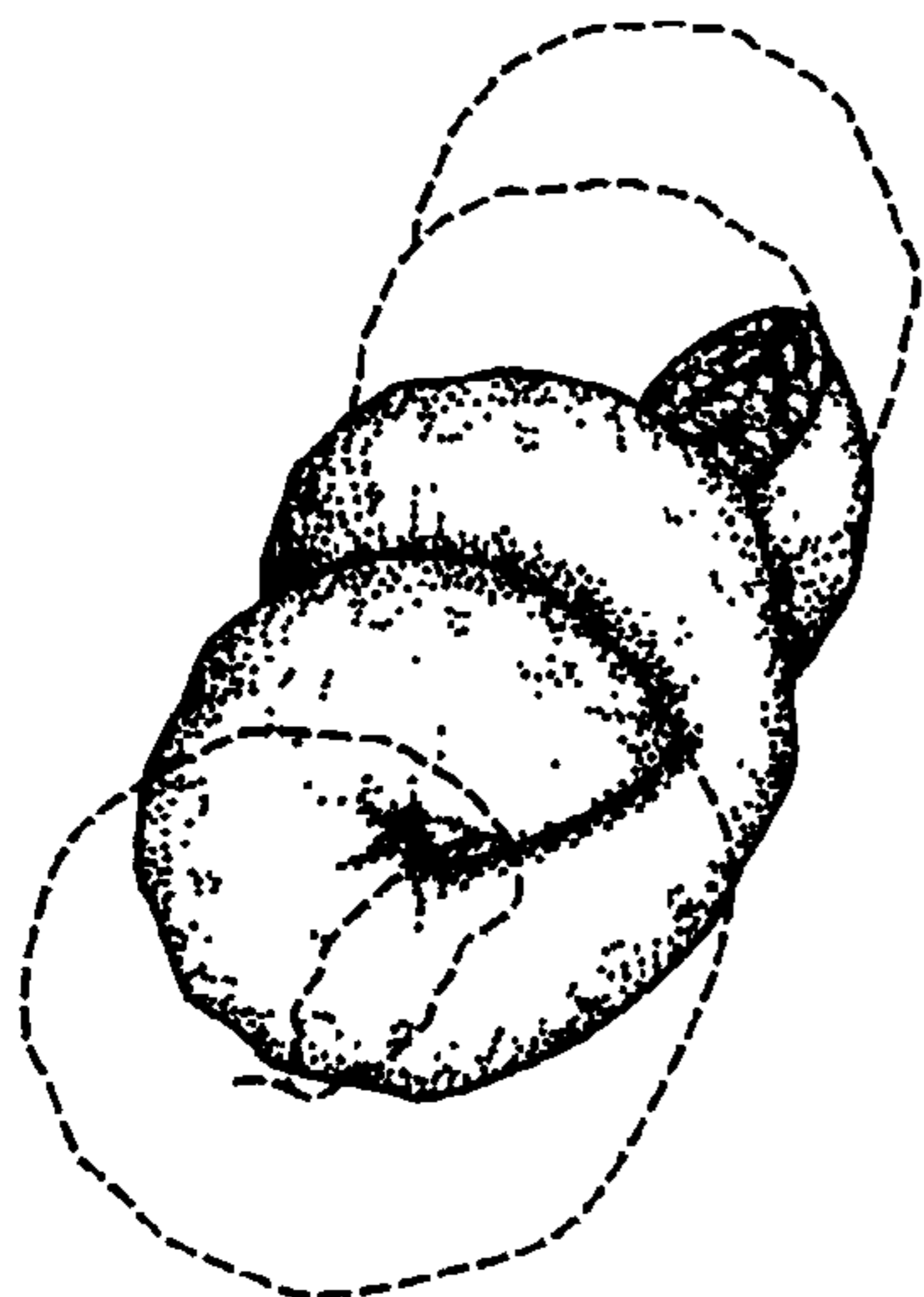
FIG. 6 is a rear elevation view of the curly-shaped puffed extrudate snack food of the present invention;

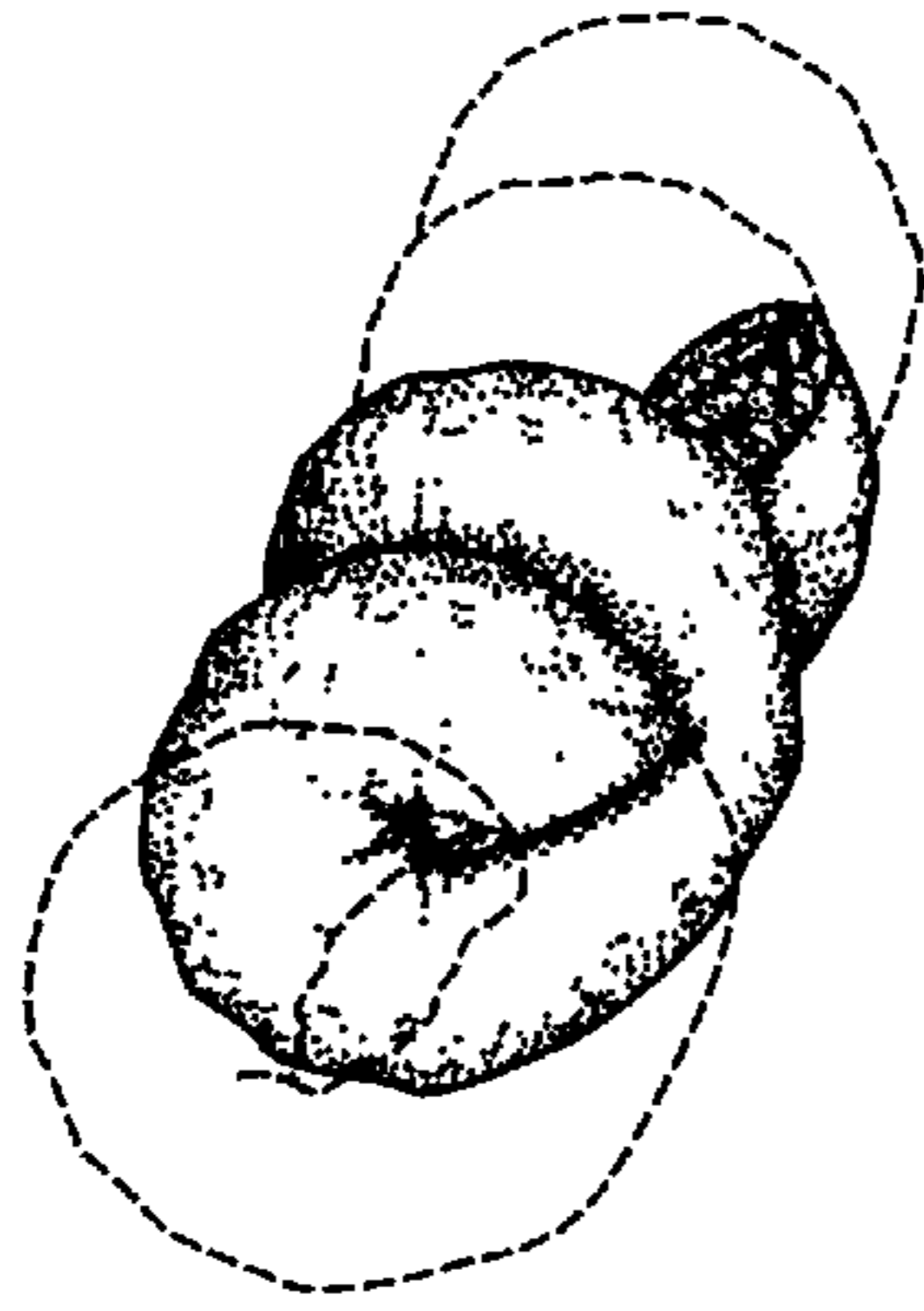

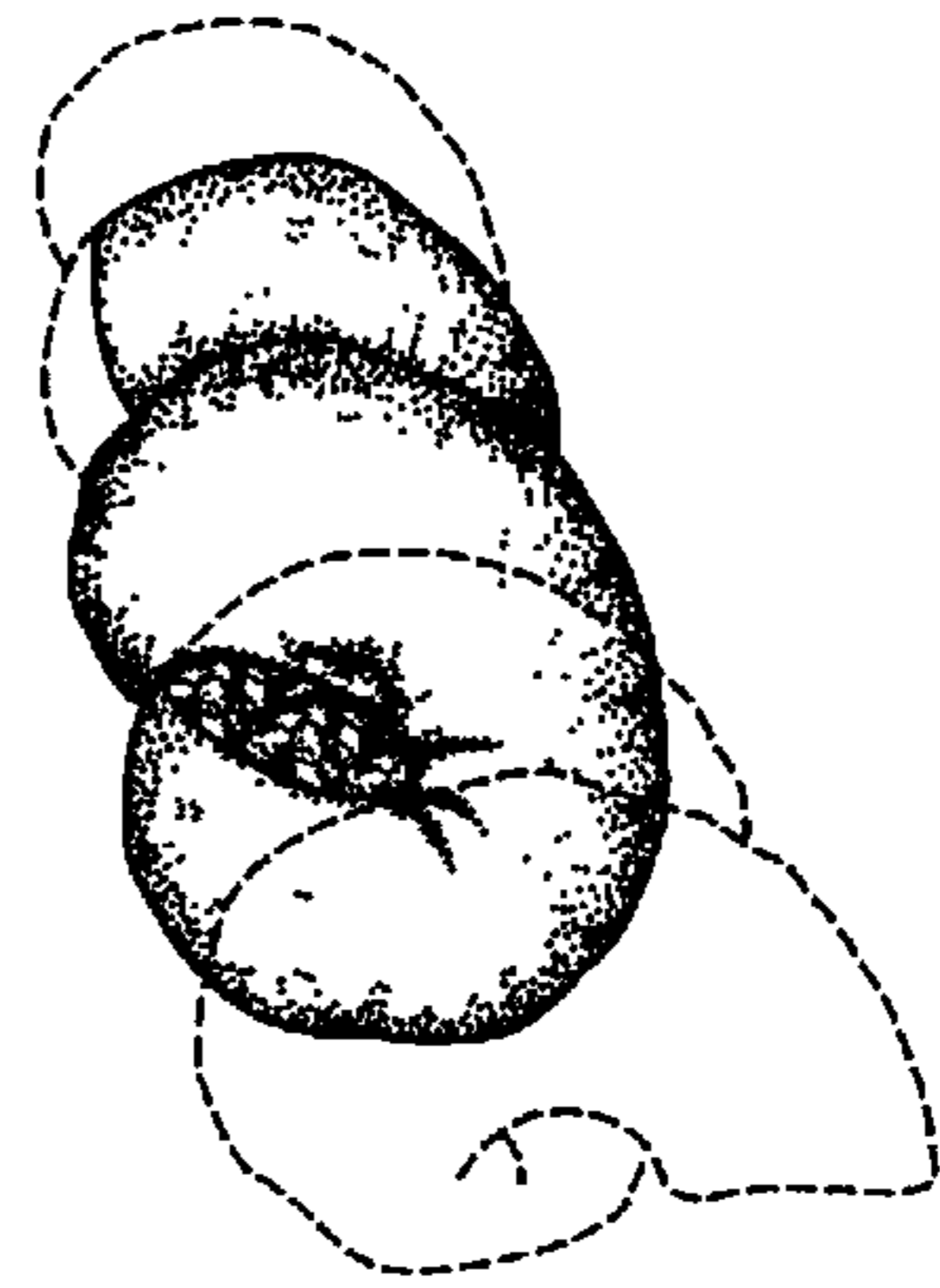

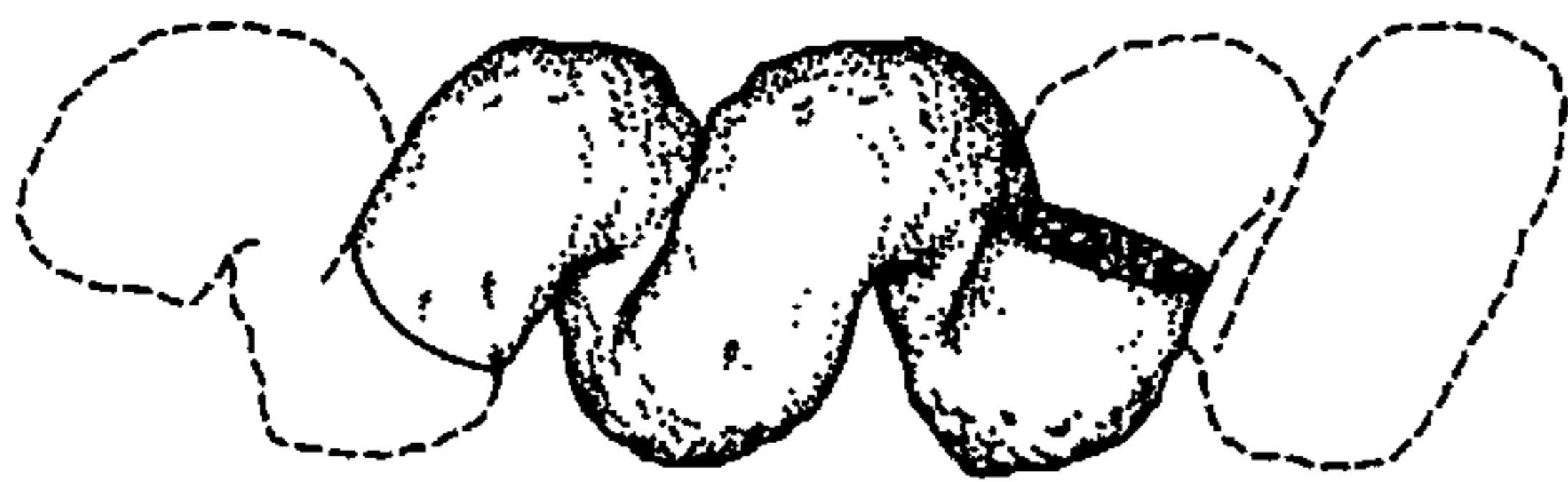

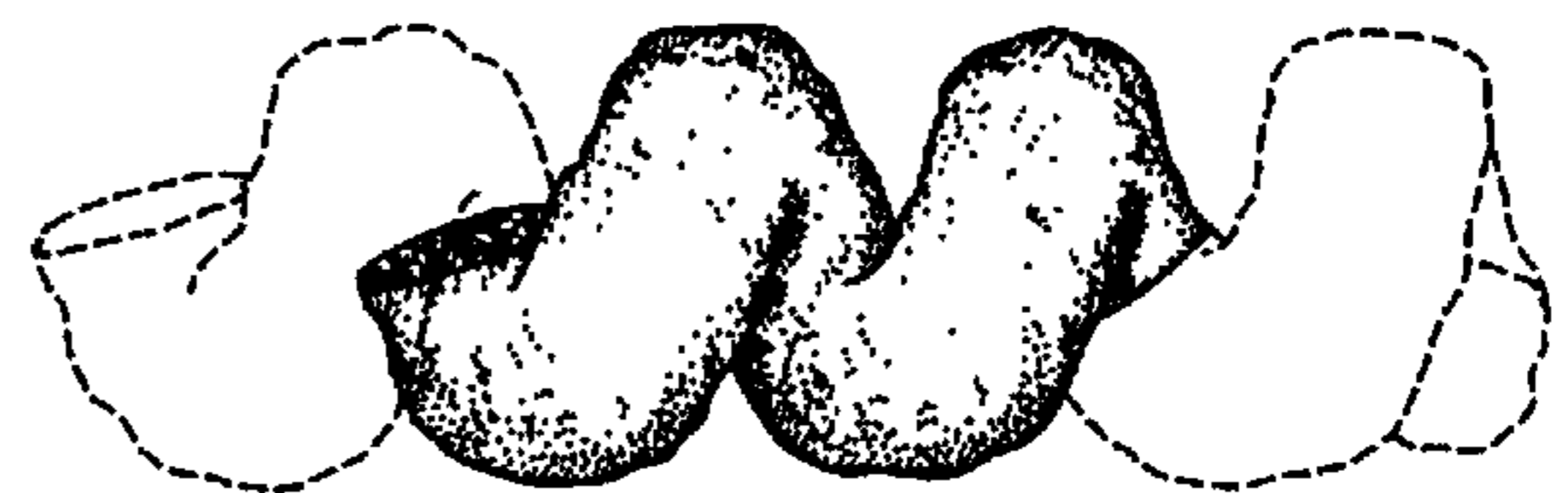
