(57) **CLAIM**

The ornamental design for a backpack, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of a backpack showing our new
design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a perspective view showing the rear pouch open
and the flap raised;
FIG. 4 is a bottom plan view of FIG. 3, showing the inner
strip for holding a stuffed toy in the pouch;
FIG. 5 is a rear elevational view of FIG. 1;
FIG. 6 is a left side elevational view of FIG. 1;
FIG. 7 is a top plan view of FIG. 1;
FIG. 8 is a right side elevational view of FIG. 1; and,
FIG. 9 is a bottom plan view of FIG. 1.

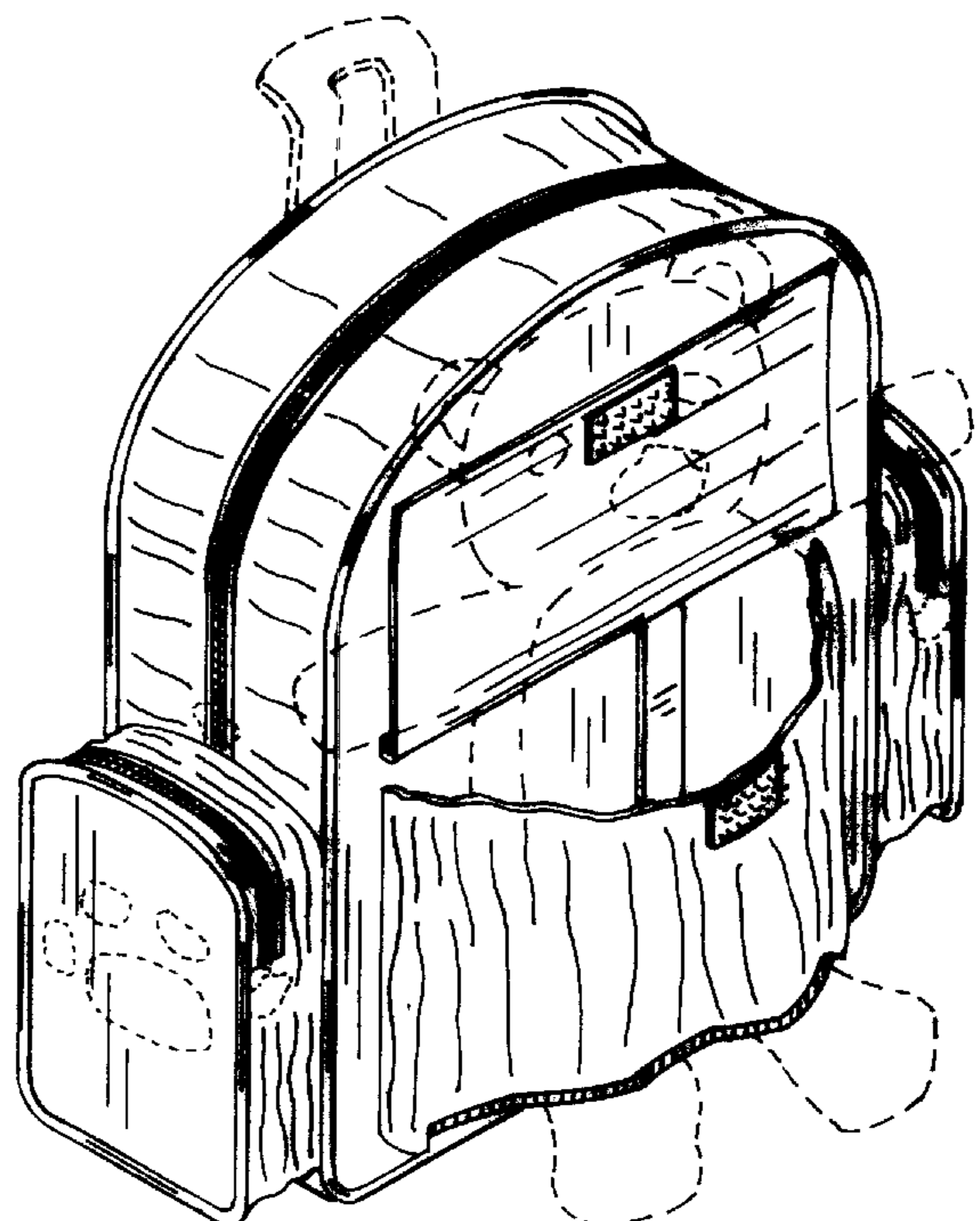
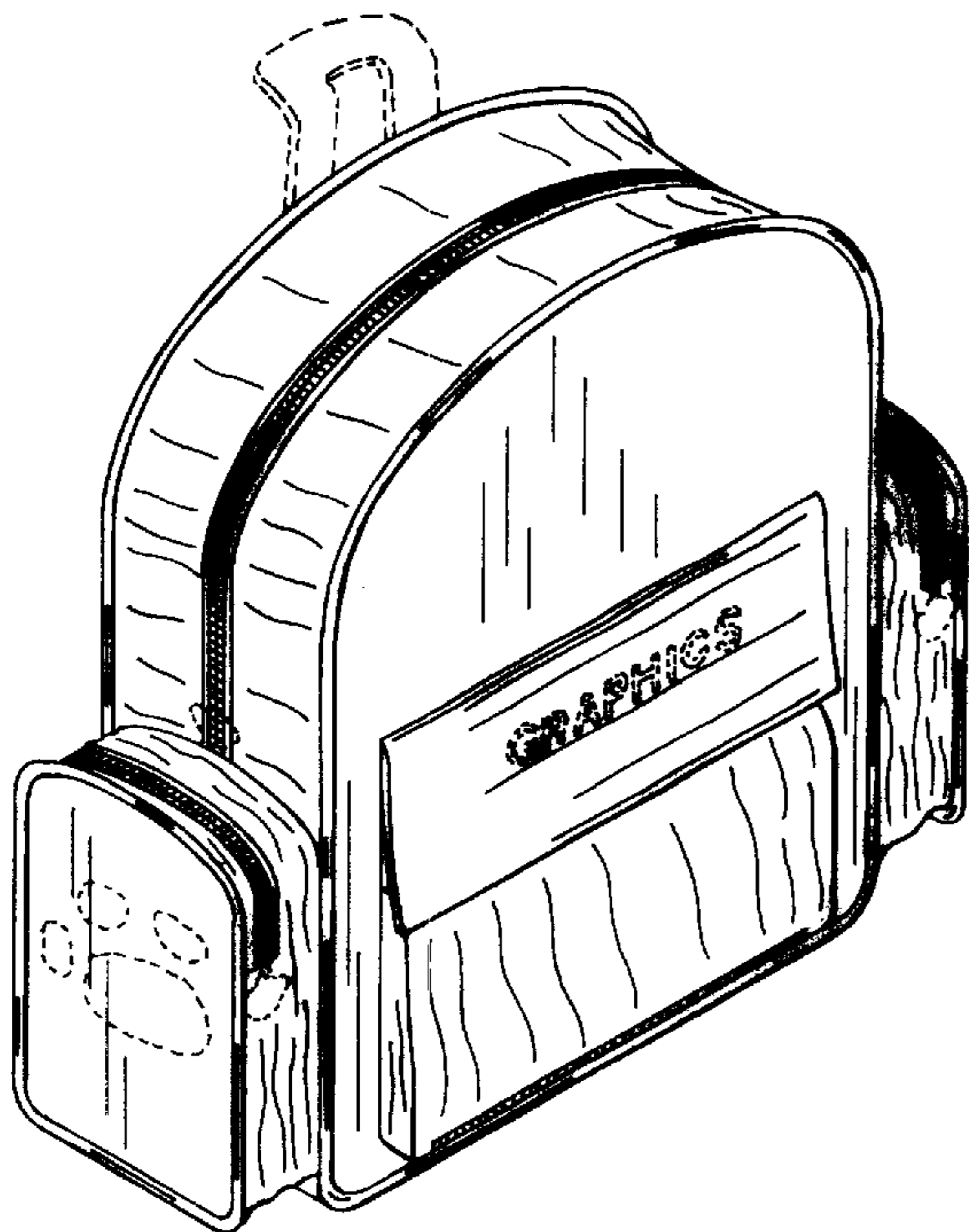

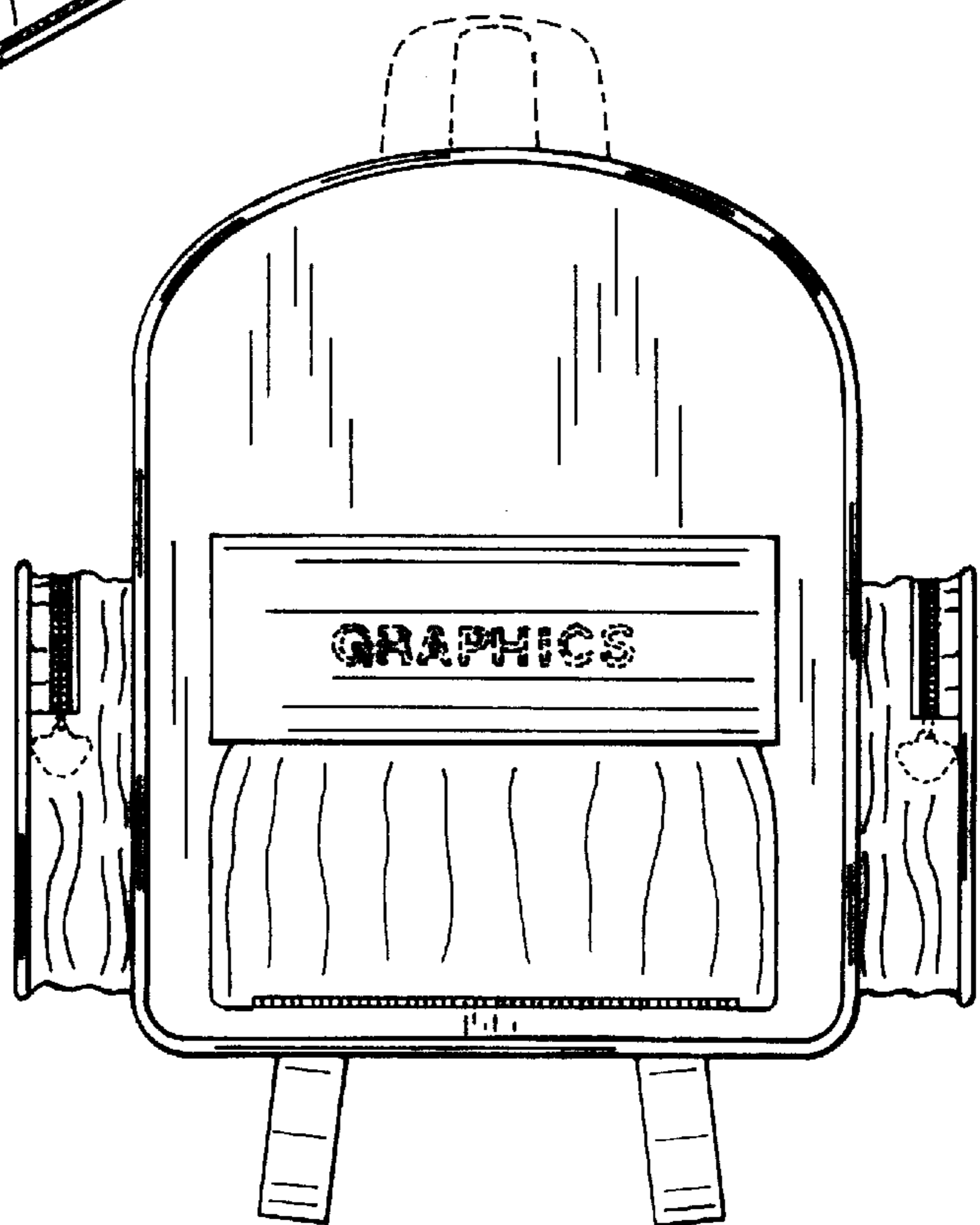

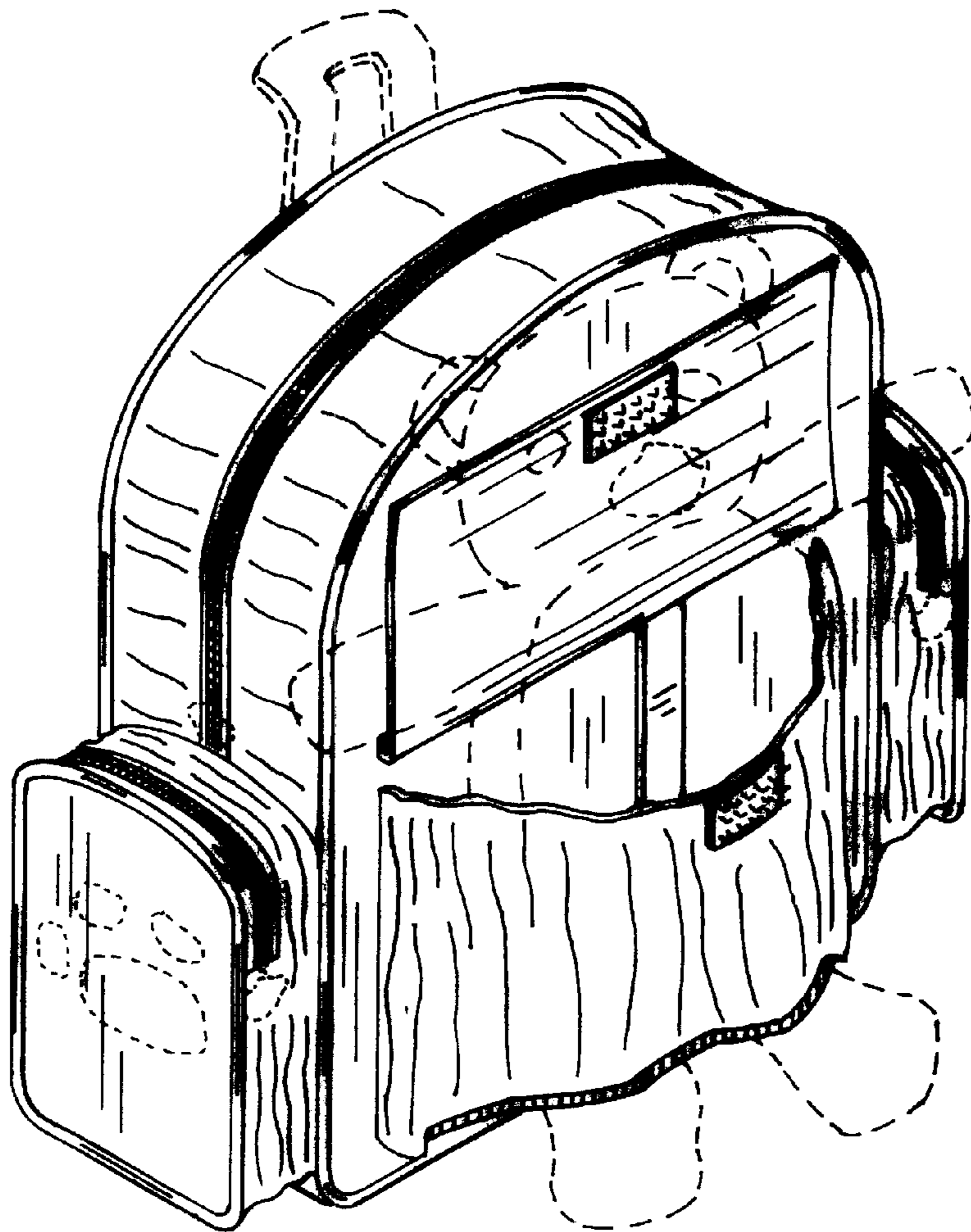

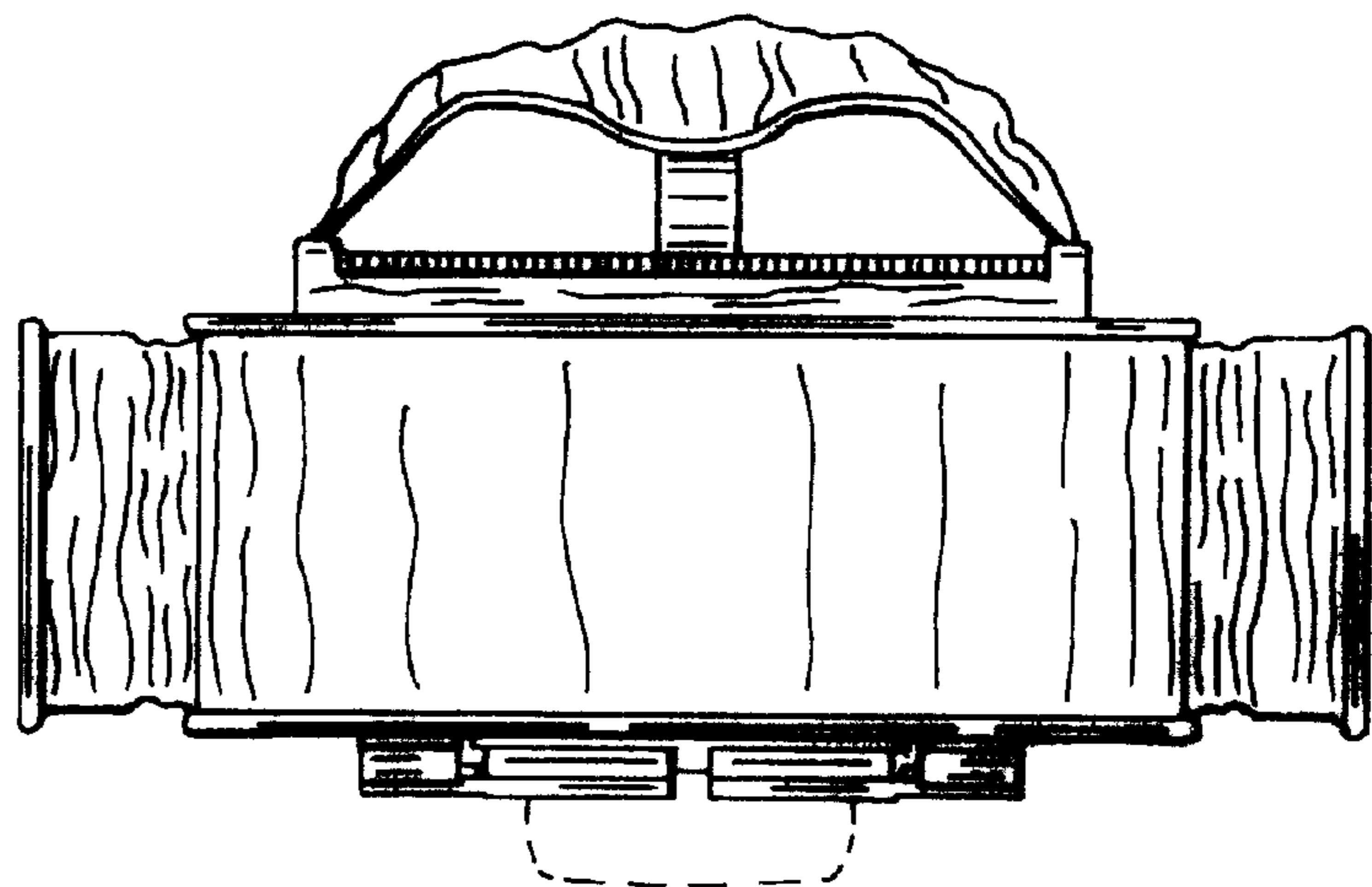

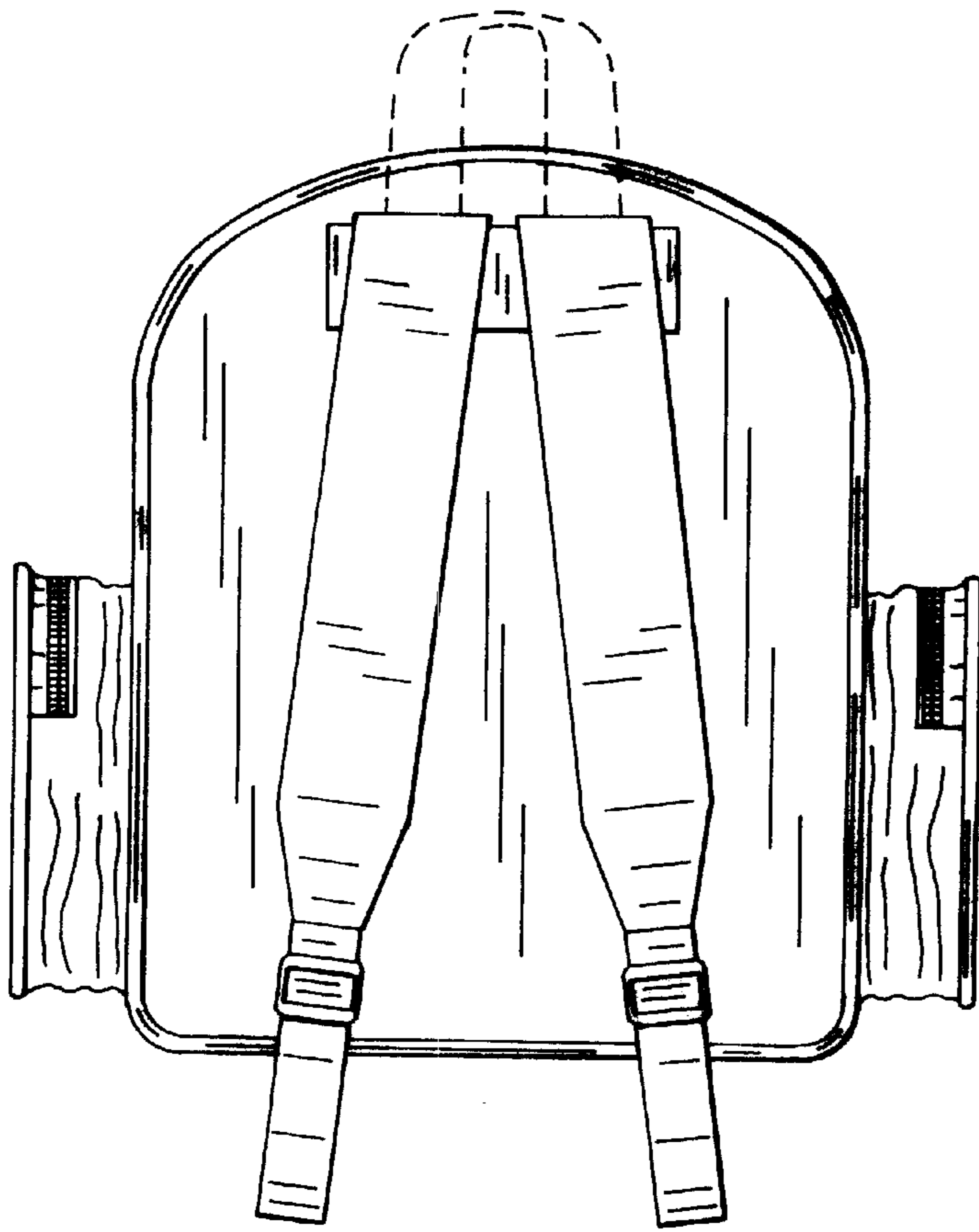

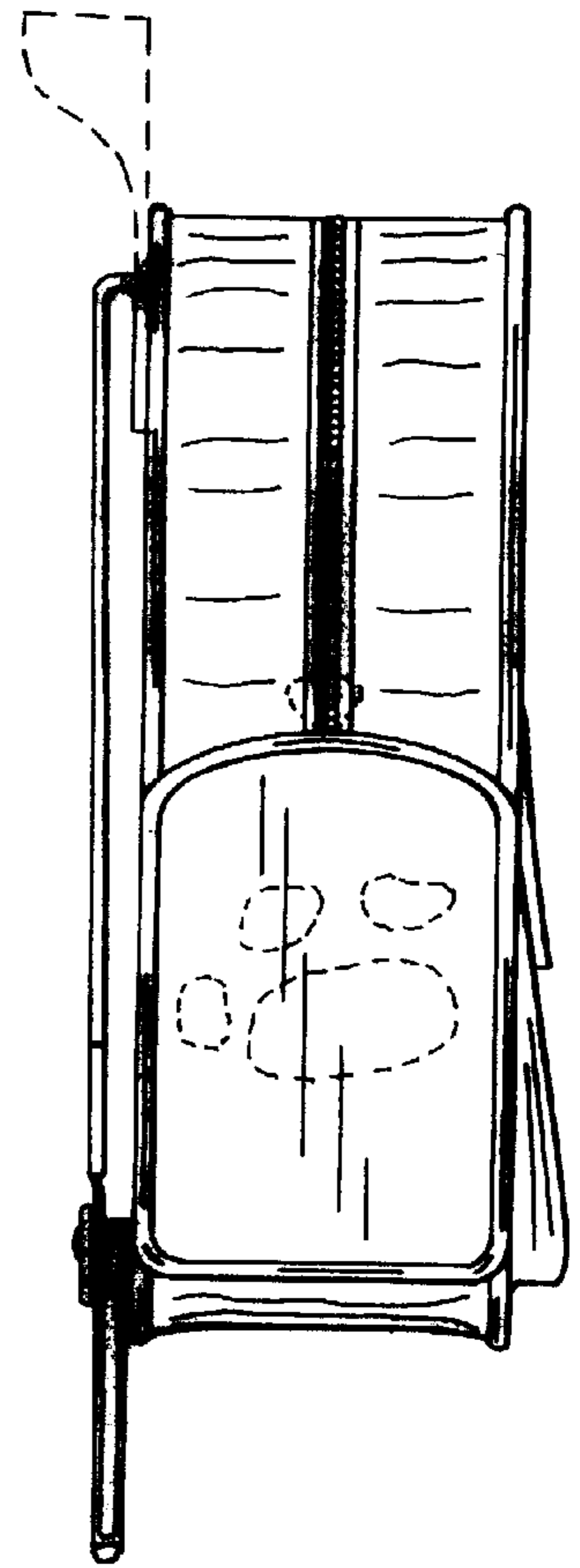

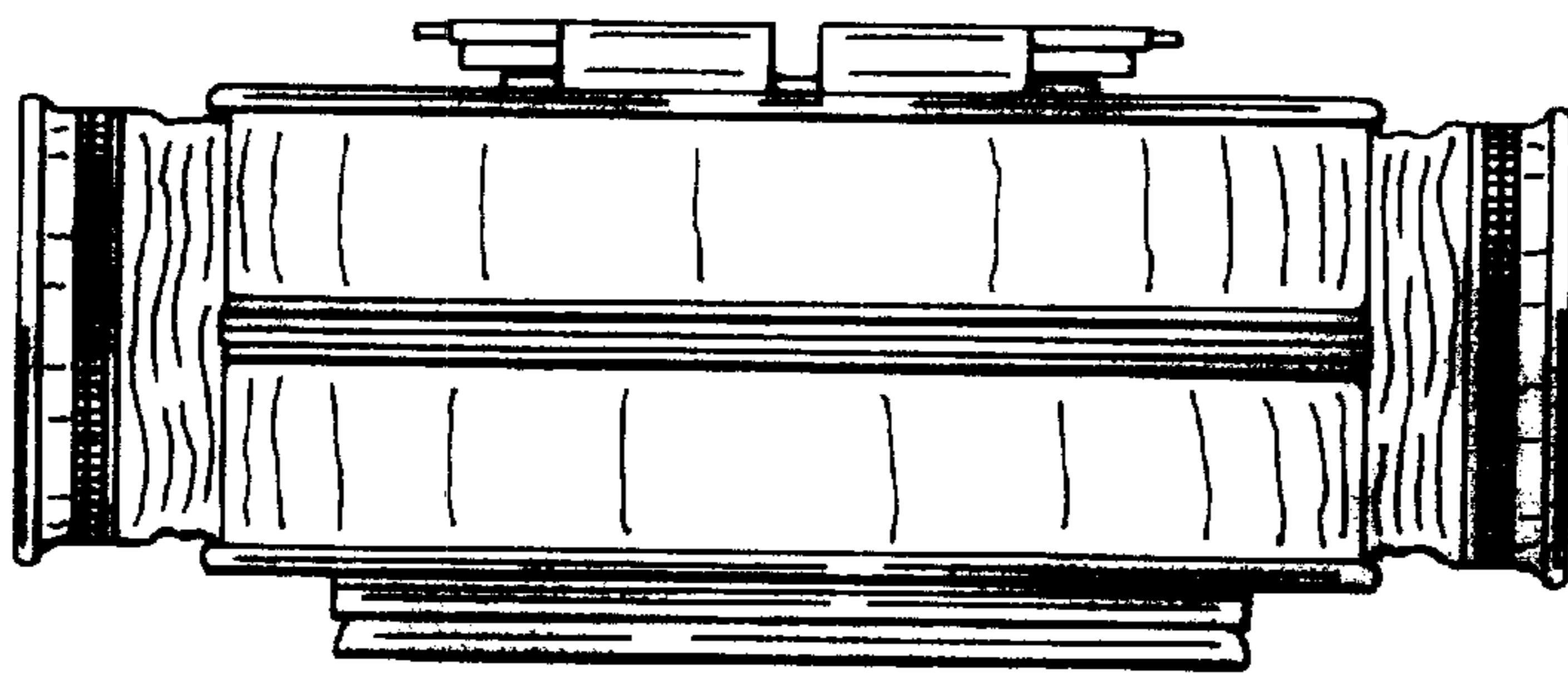

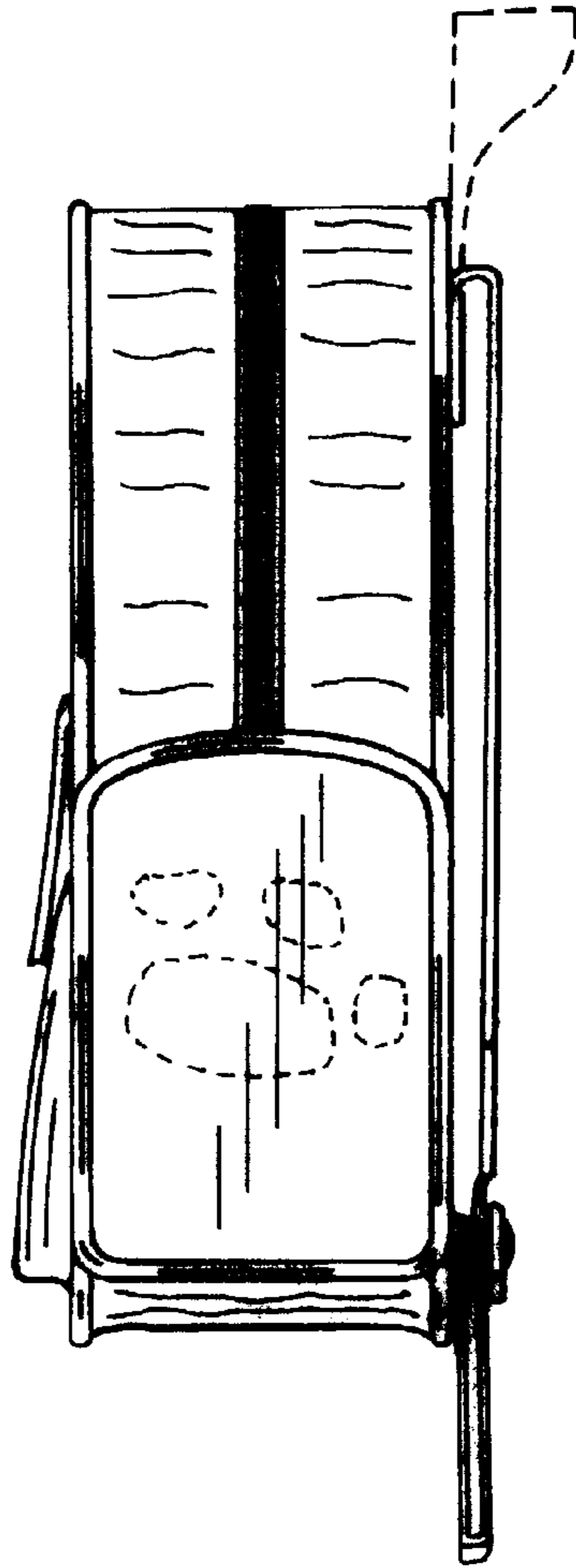

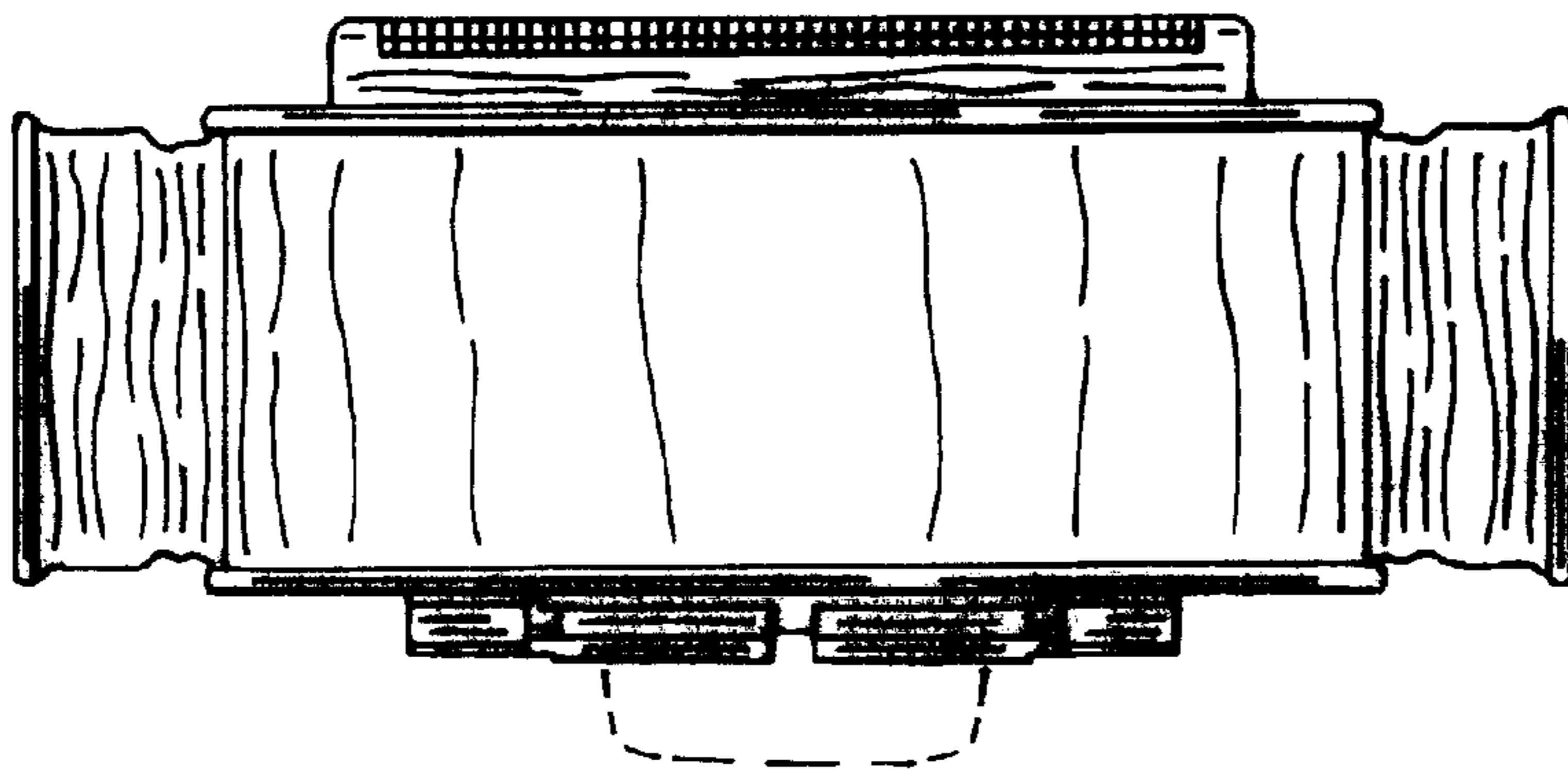
