(57) **CLAIM**

The ornamental design for an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the automobile tire, showing the new design, the top plan view and the bottom plan view appearing the same as the front view;

FIG. 2 is a rear view of the automobile tire;

FIG. 3 is a right side view of the automobile tire;

FIG. 4 is a left side view of the automobile tire;

FIG. 5 is a perspective view of the automobile tire;

FIG. 6 is a fragmentary front view, showing in enlargement the portion of 6—6 in FIG. 1; and,

FIG. 7 is a sectional view taken on line 7—7 in FIG. 6.

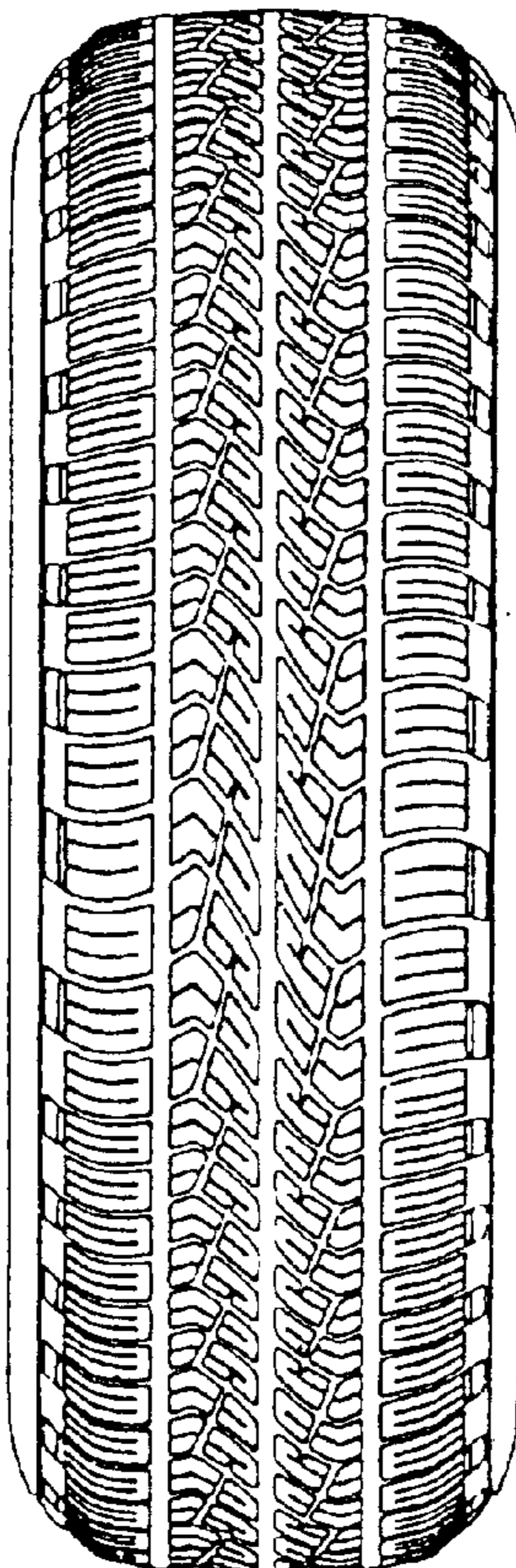

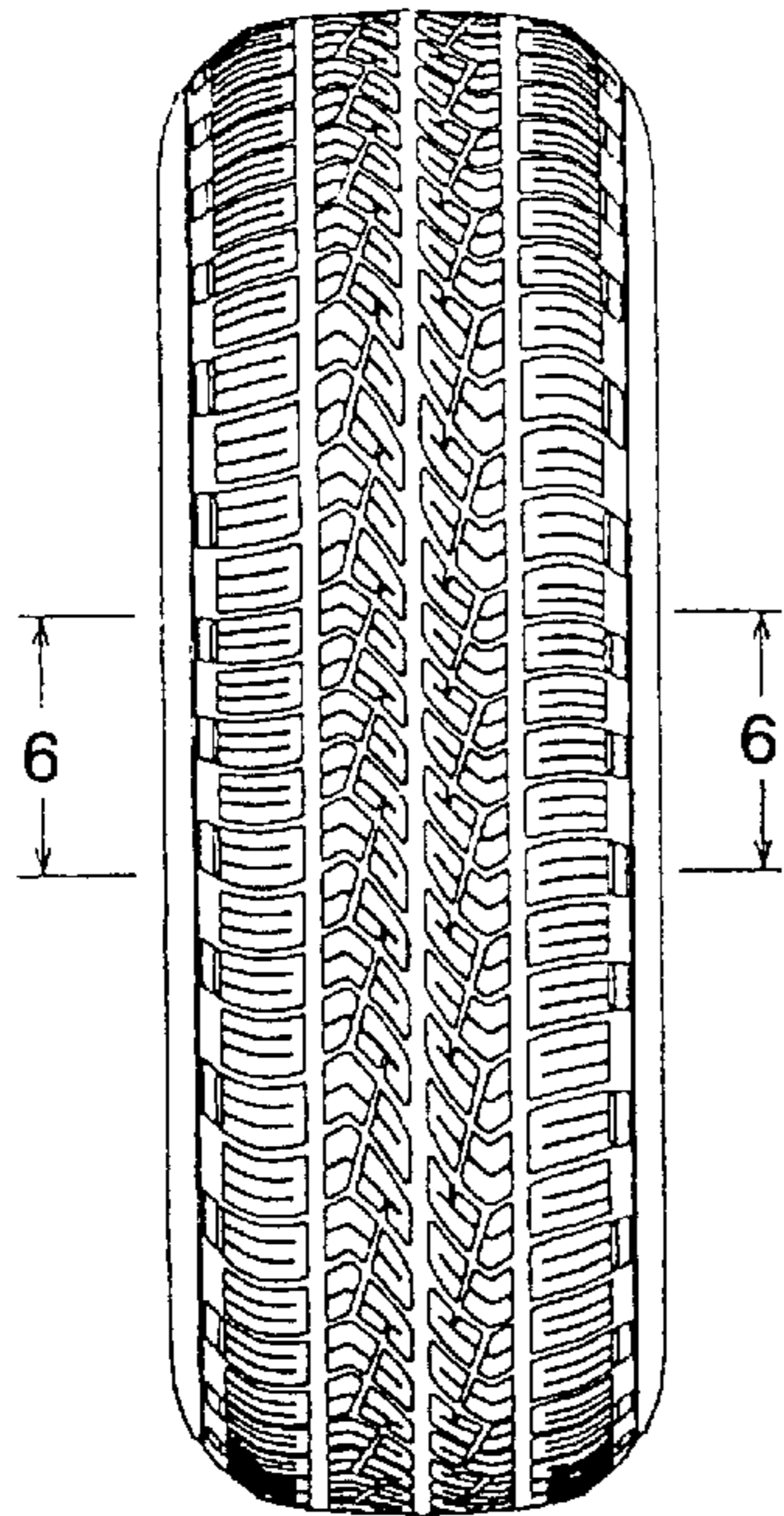

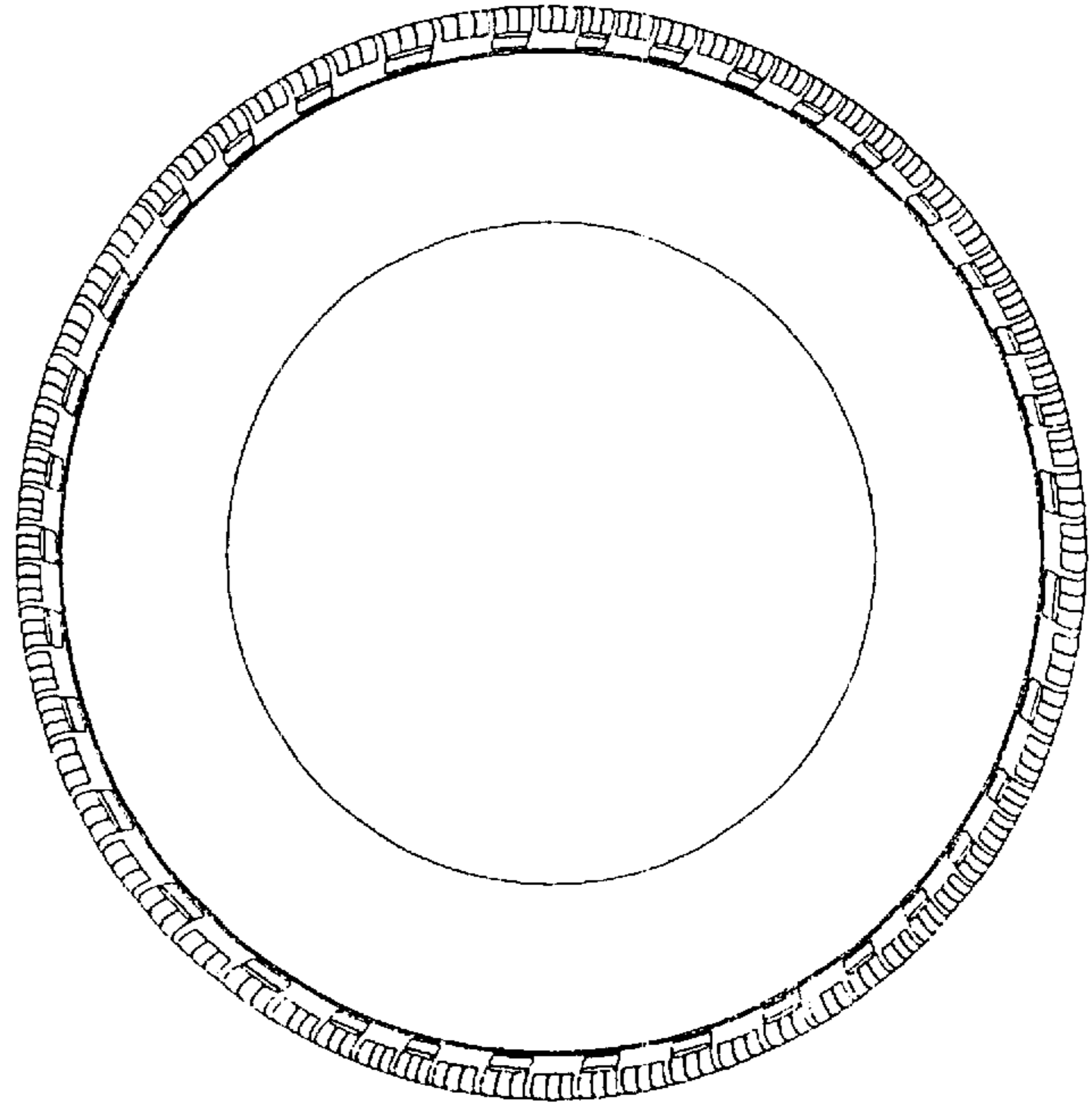

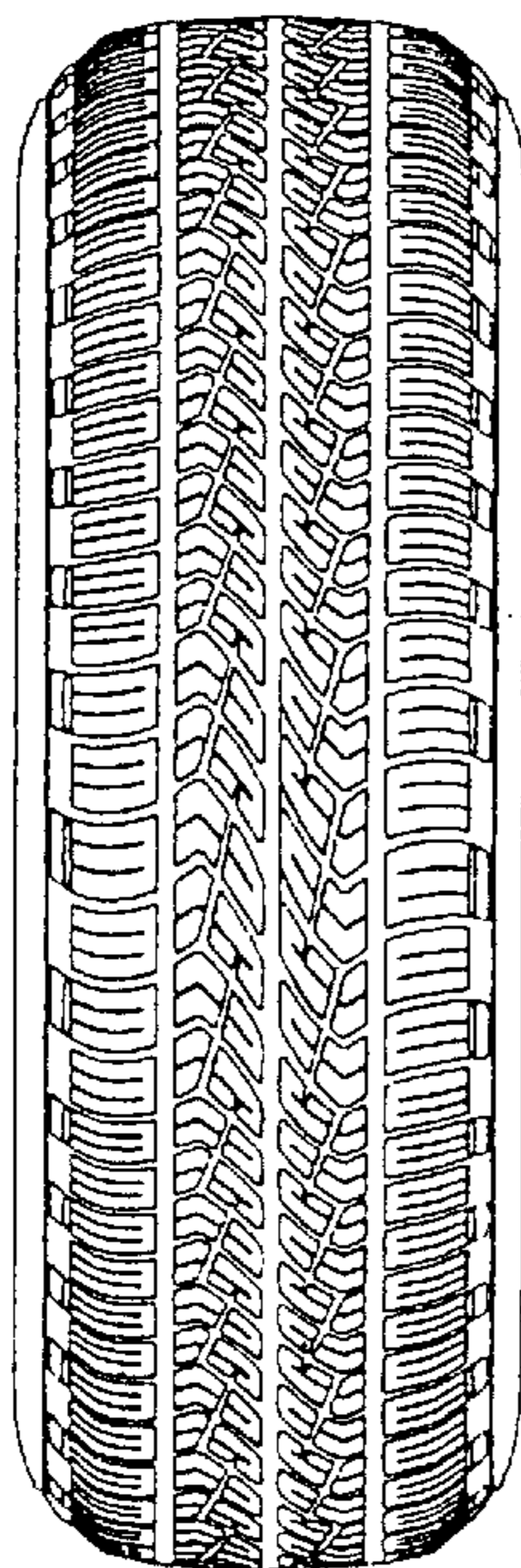

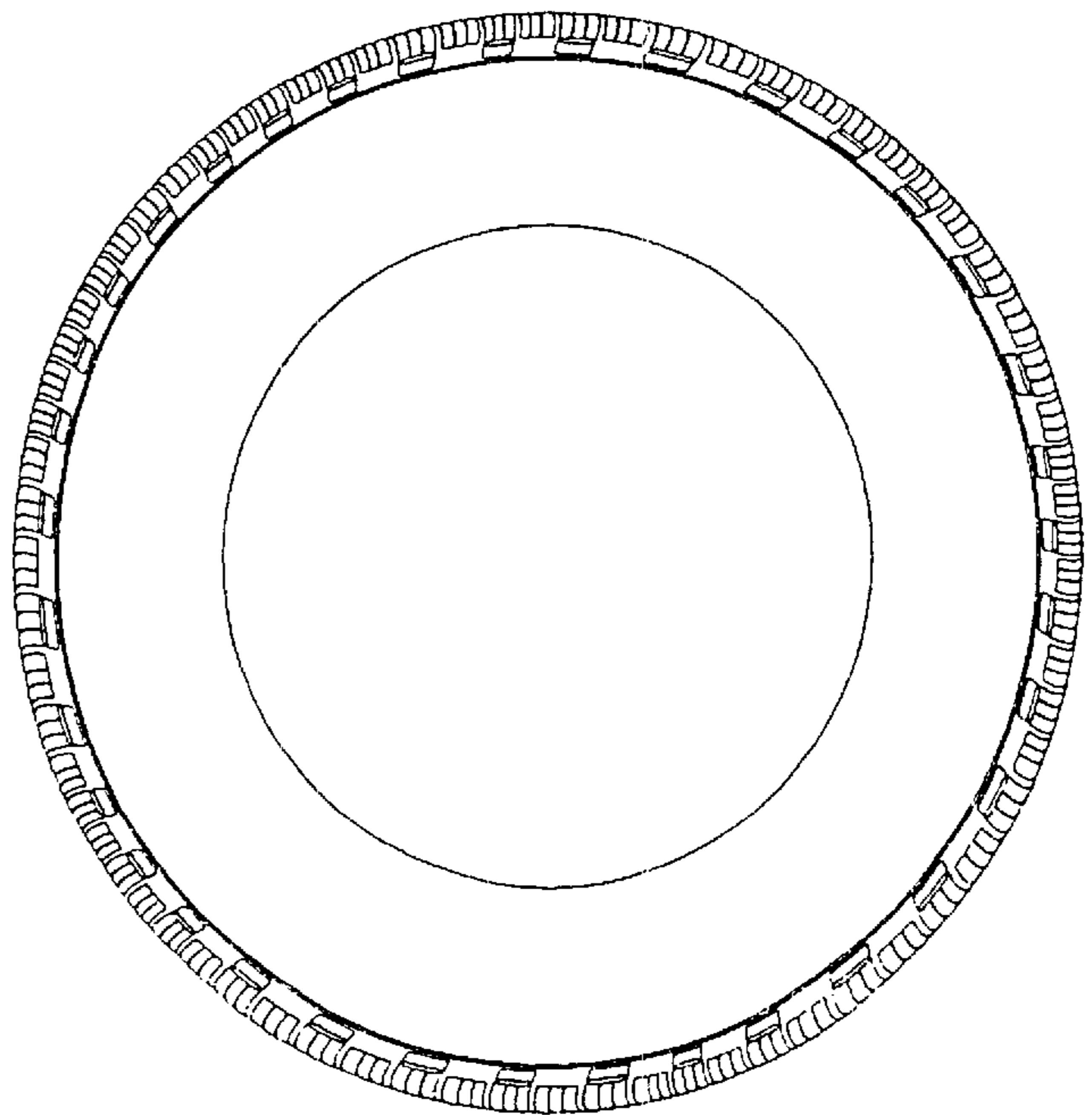

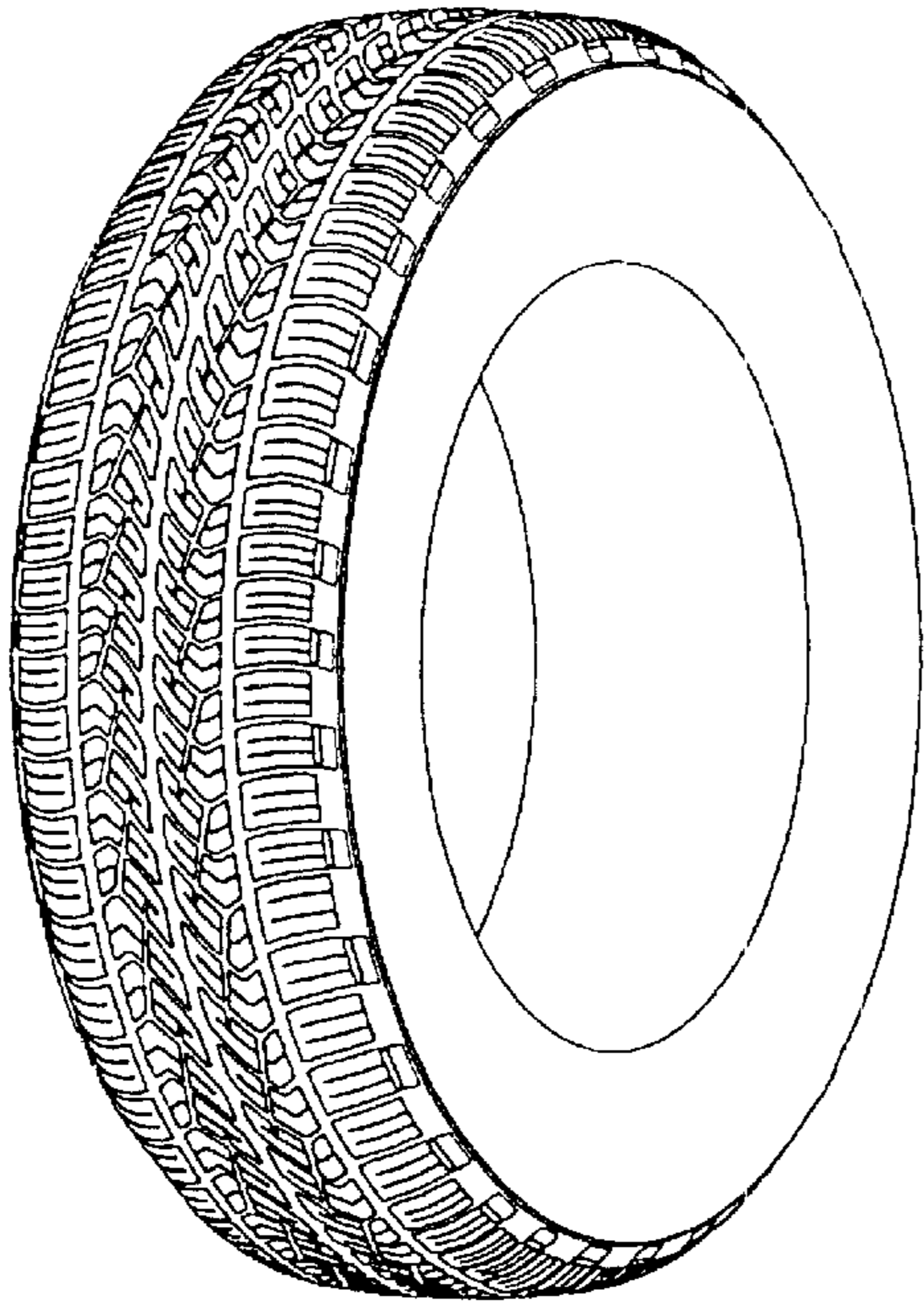

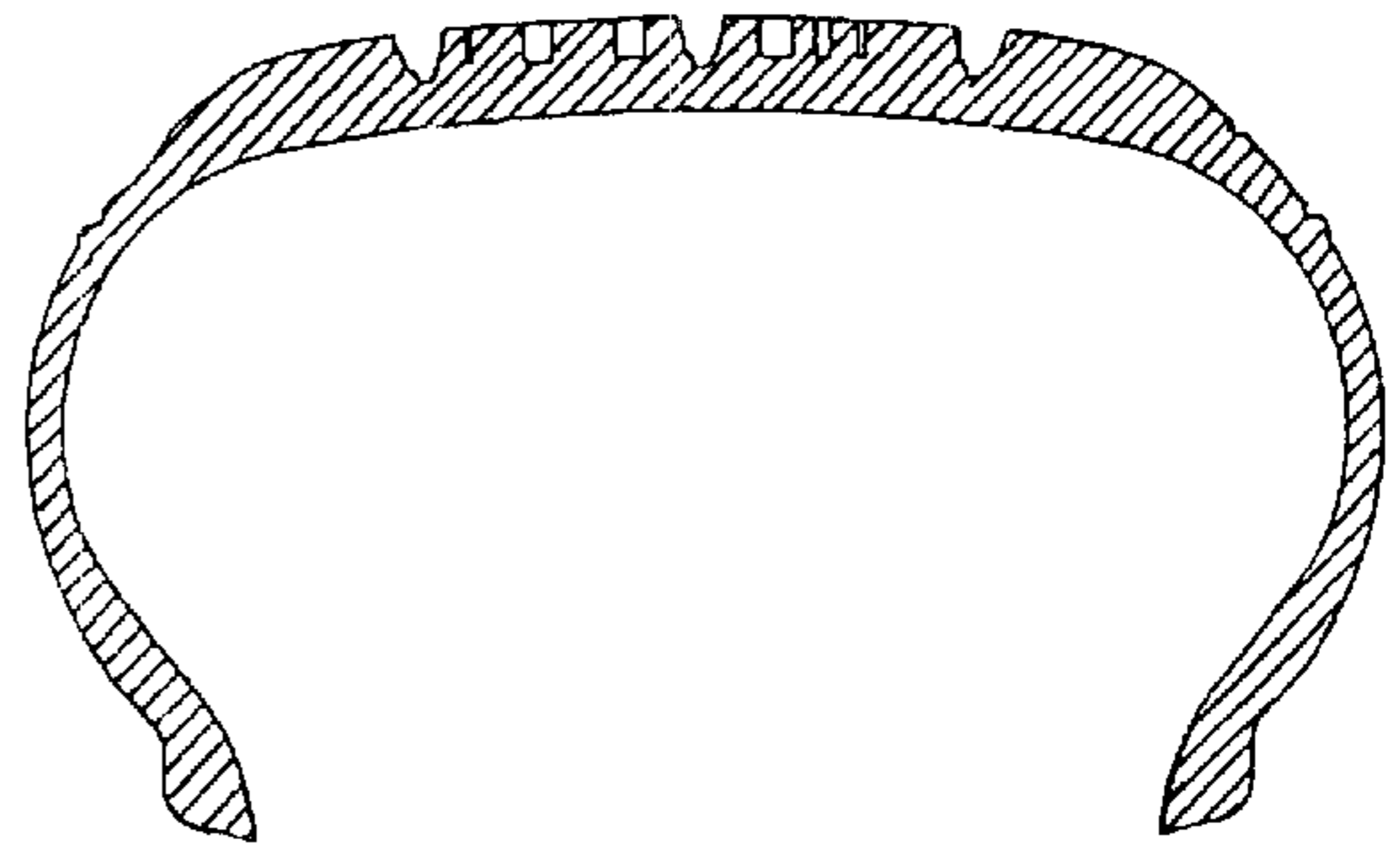
