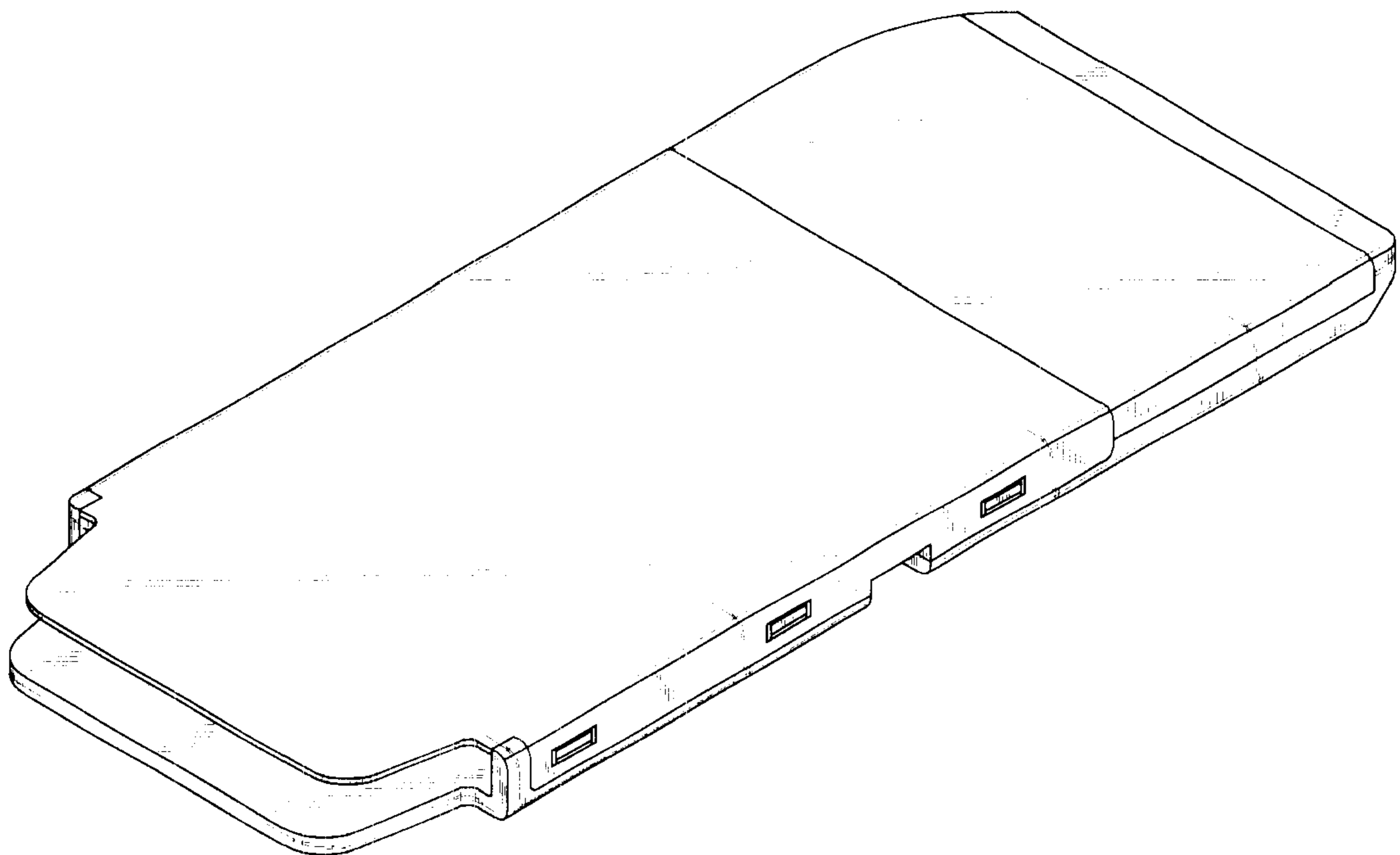
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a cartridge for recording media showing my new design;

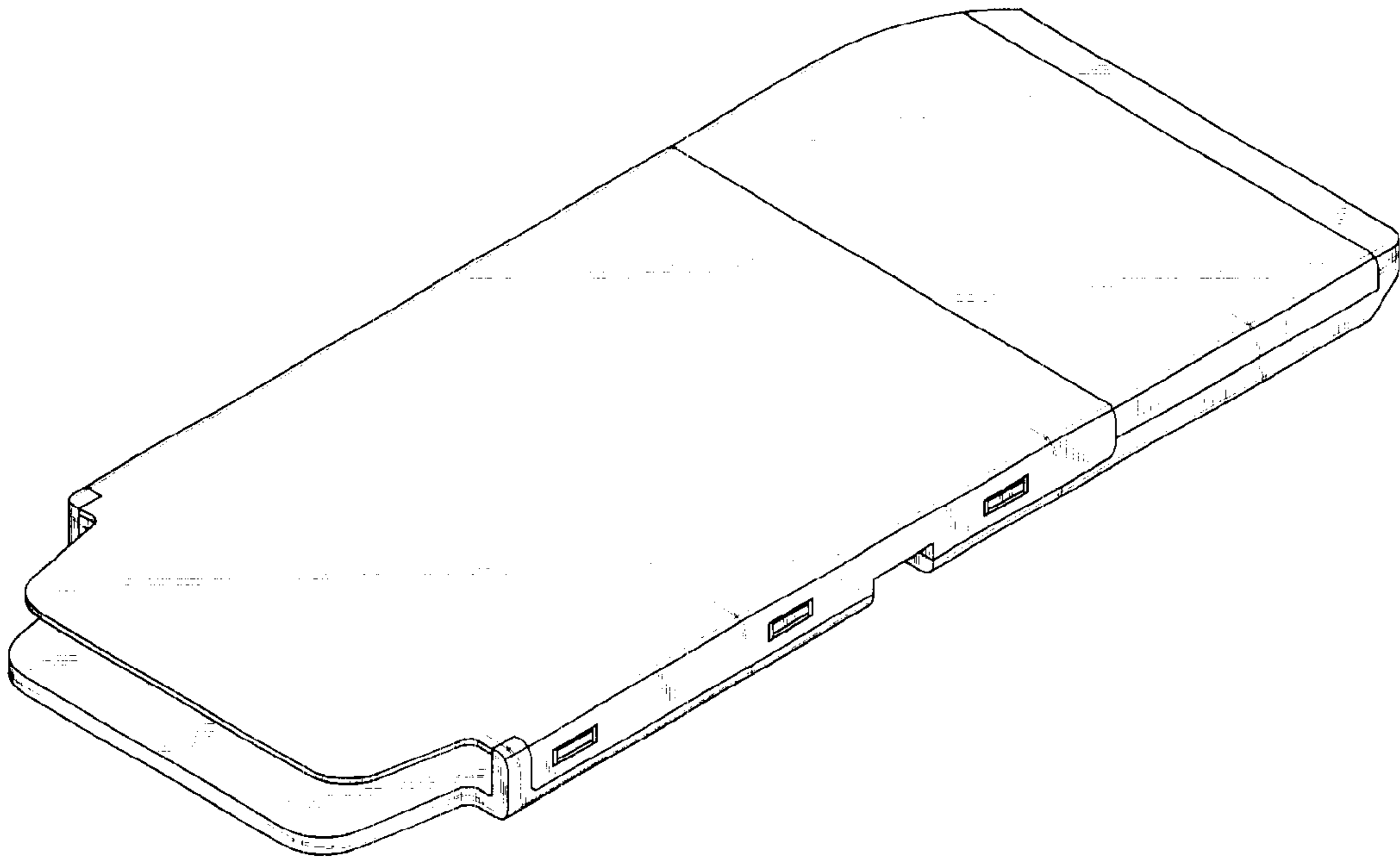

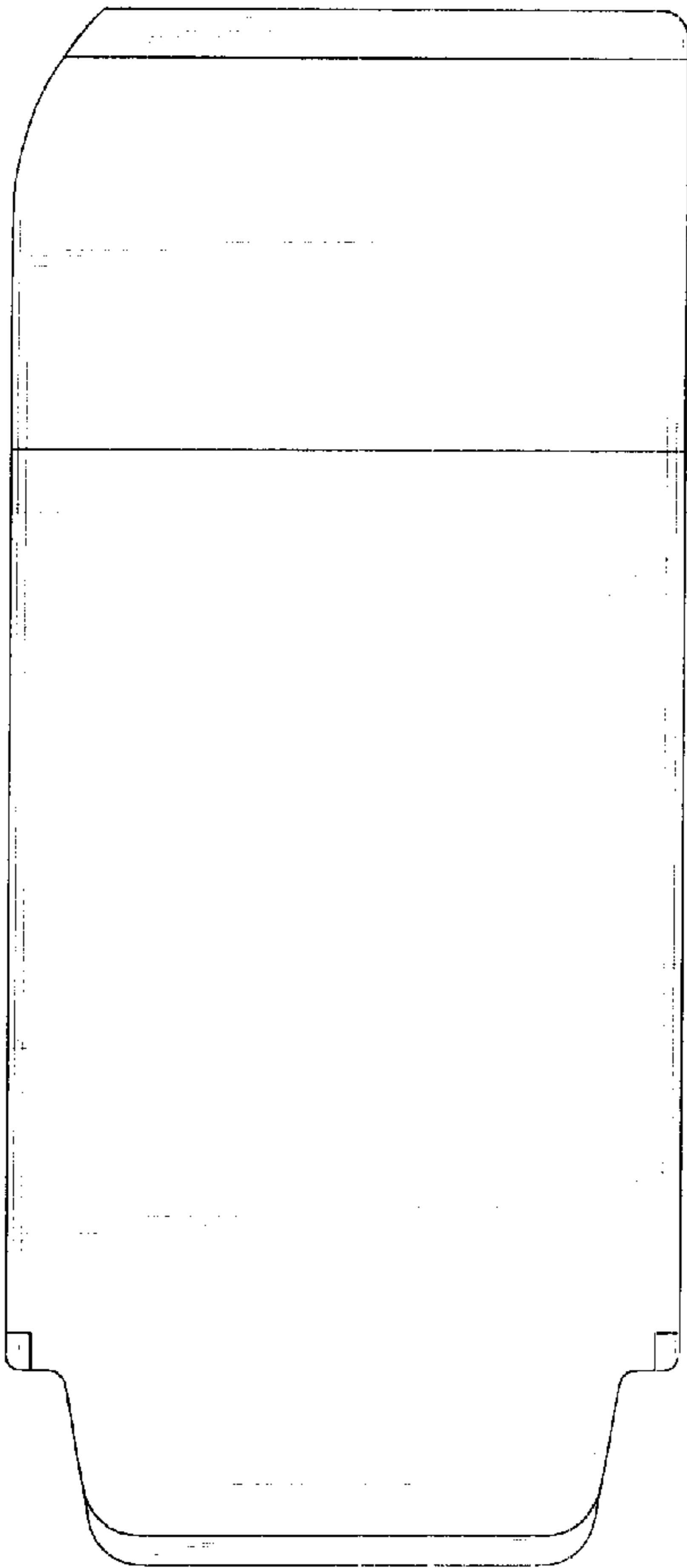

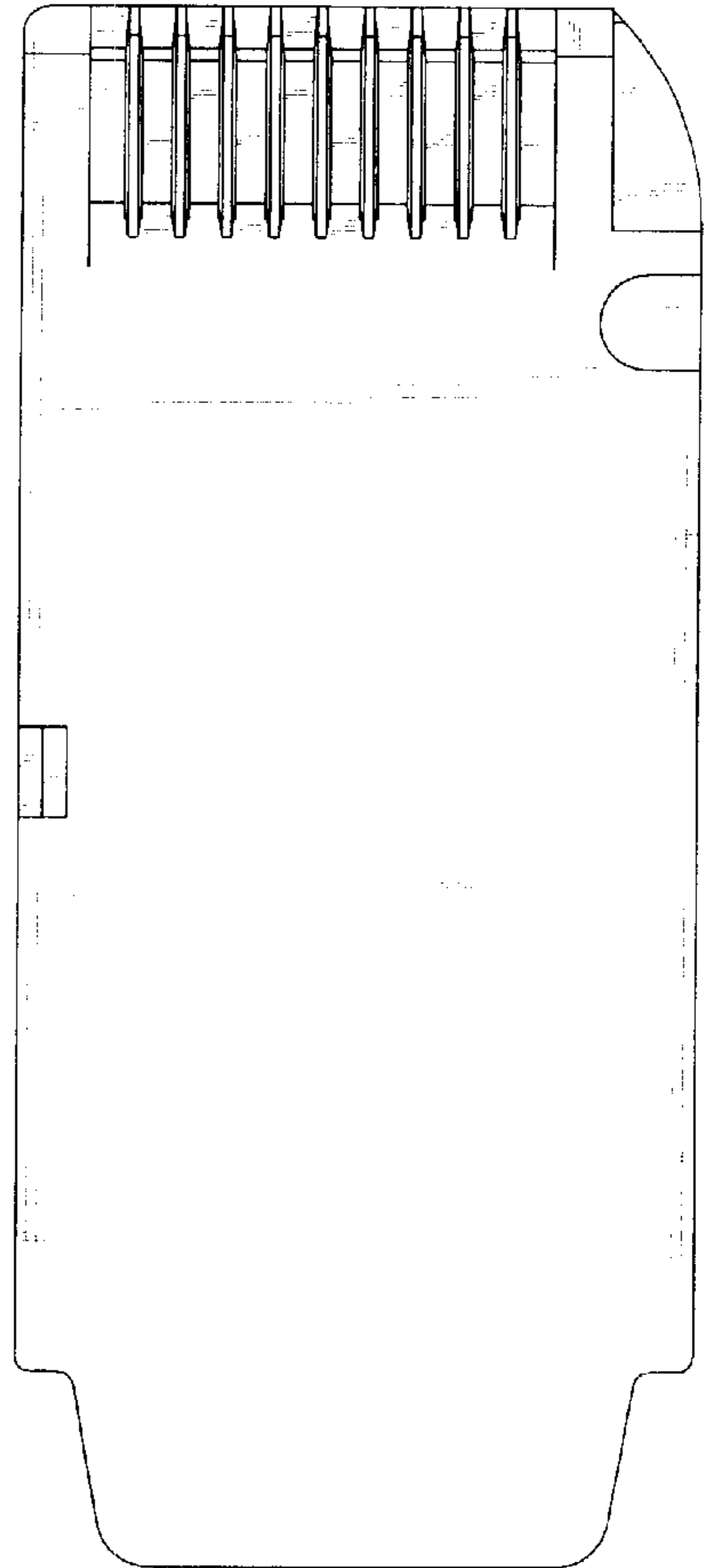

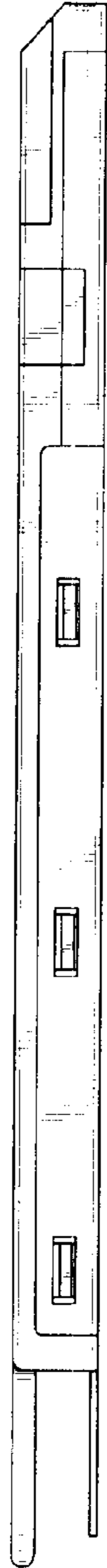

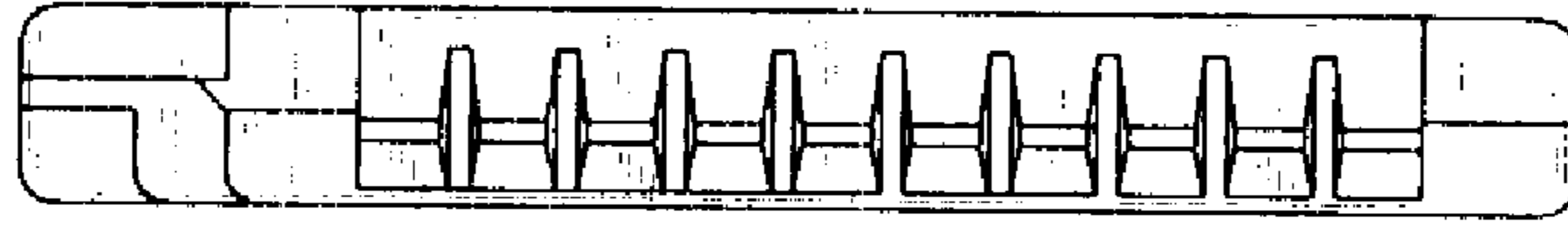

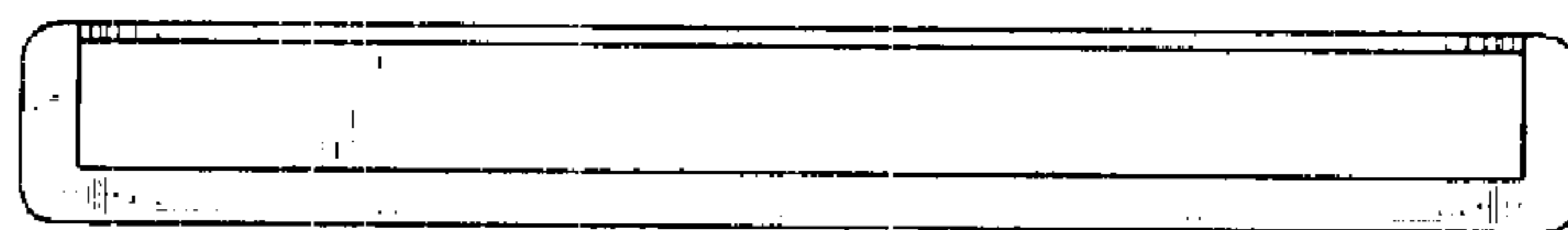
