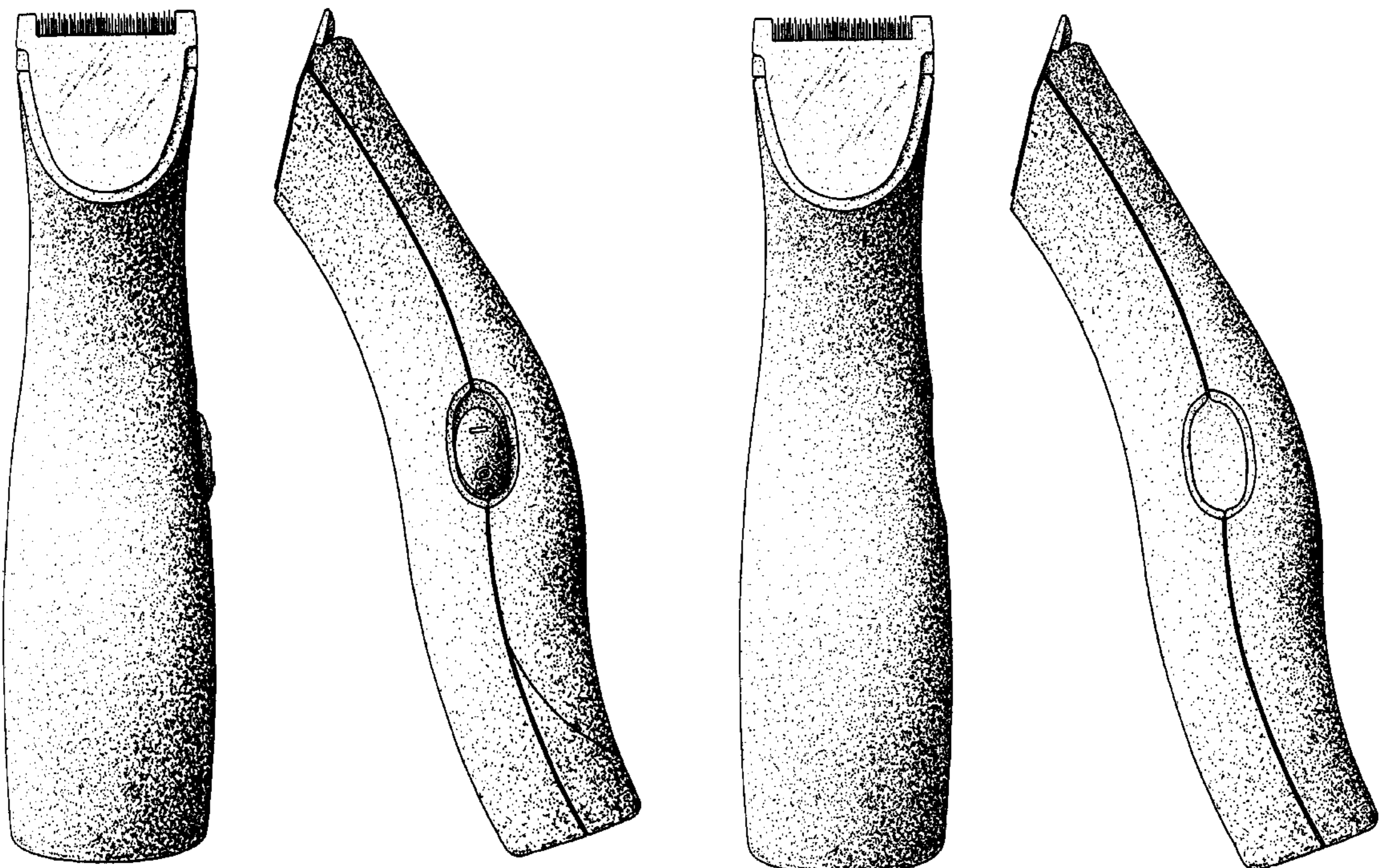
FIG. 1 is a perspective view of our design for a trimmer;

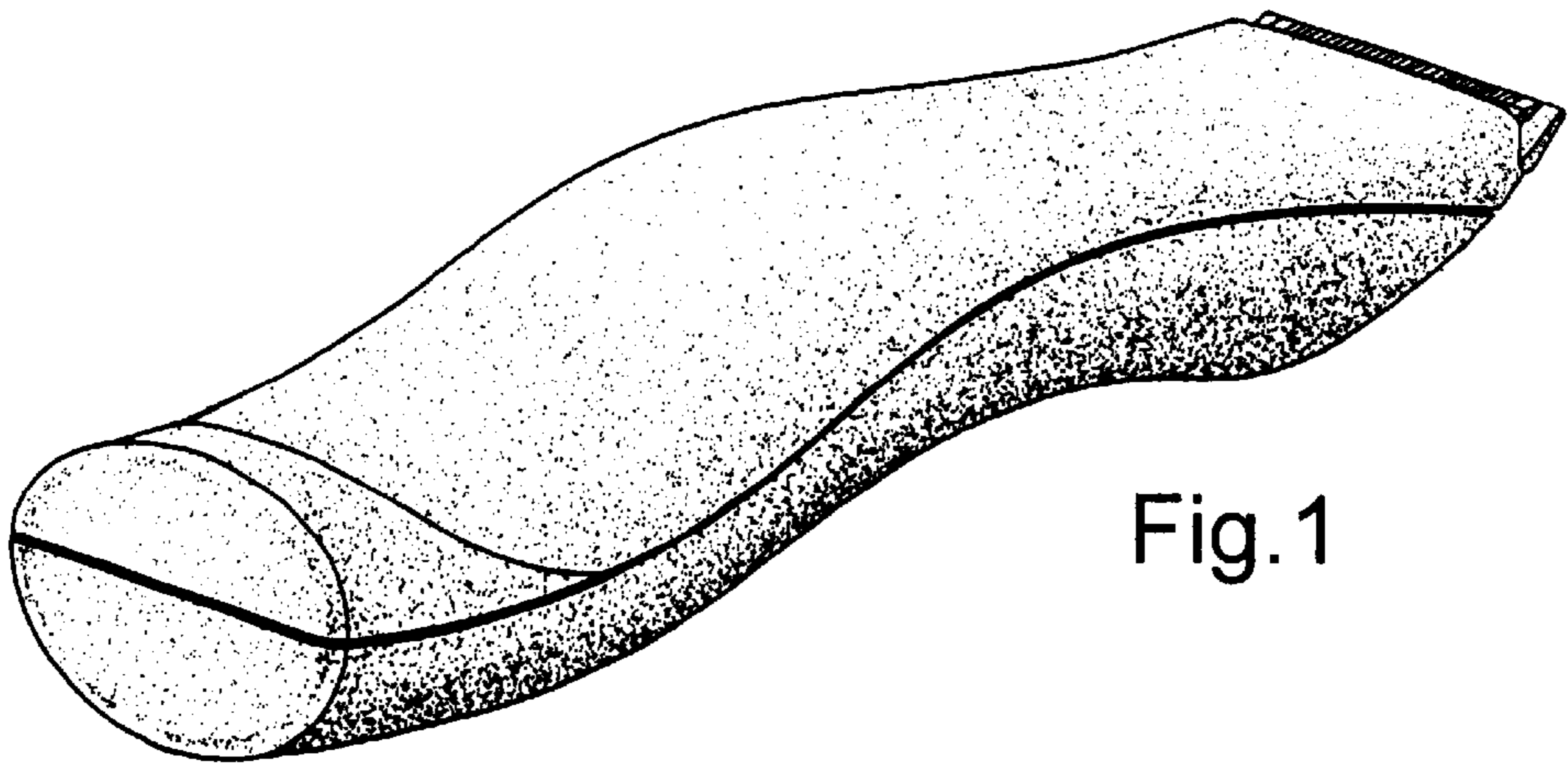

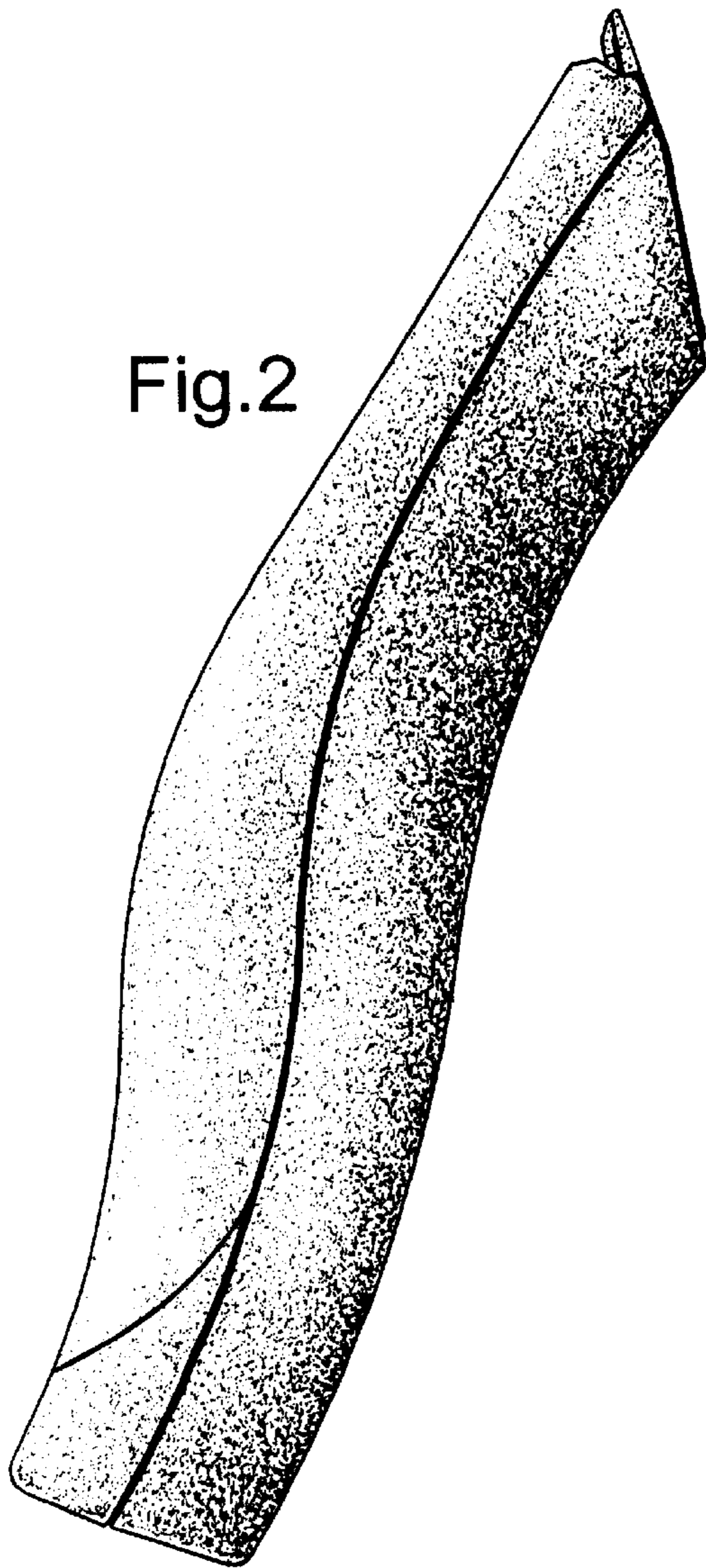

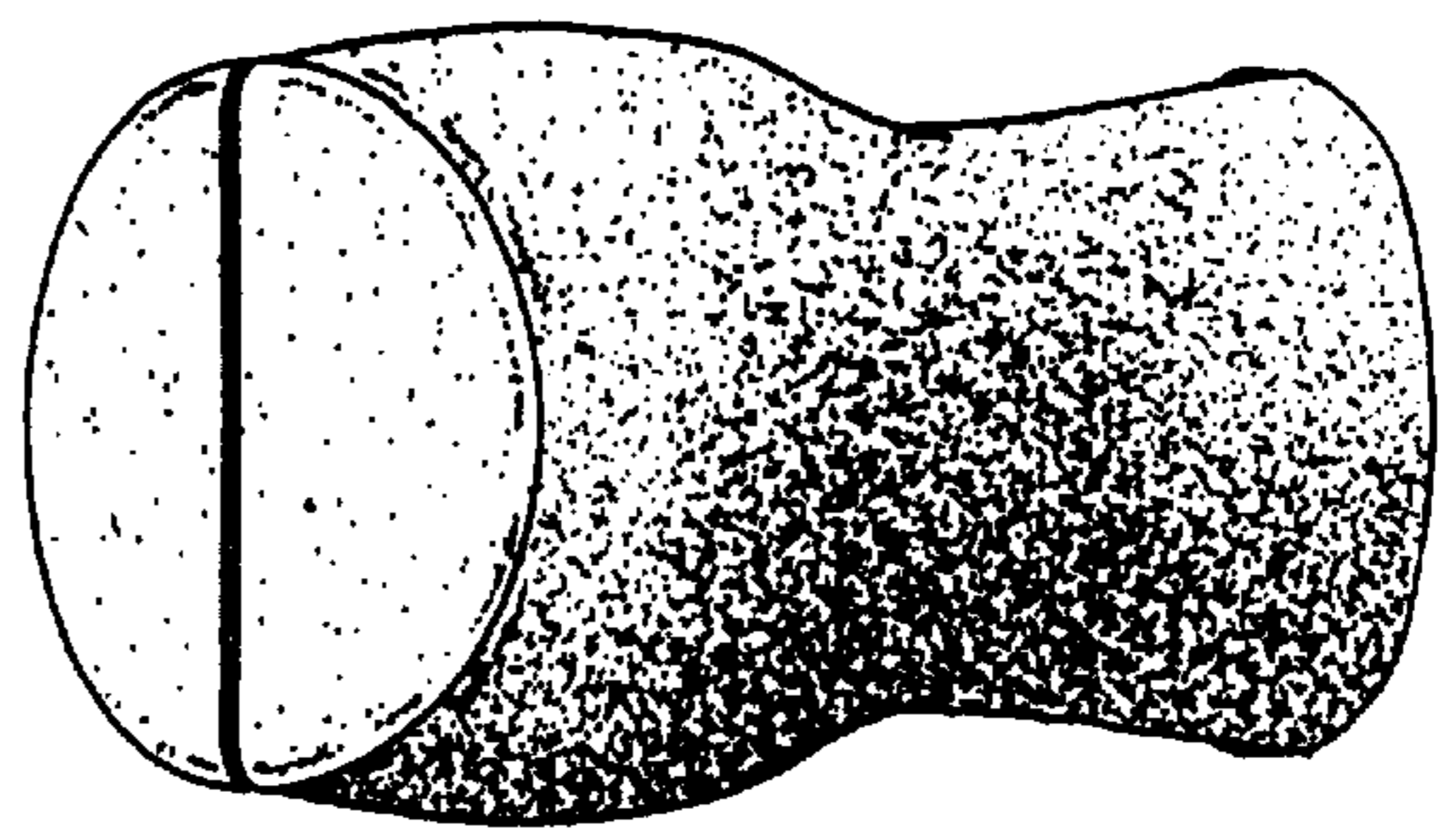

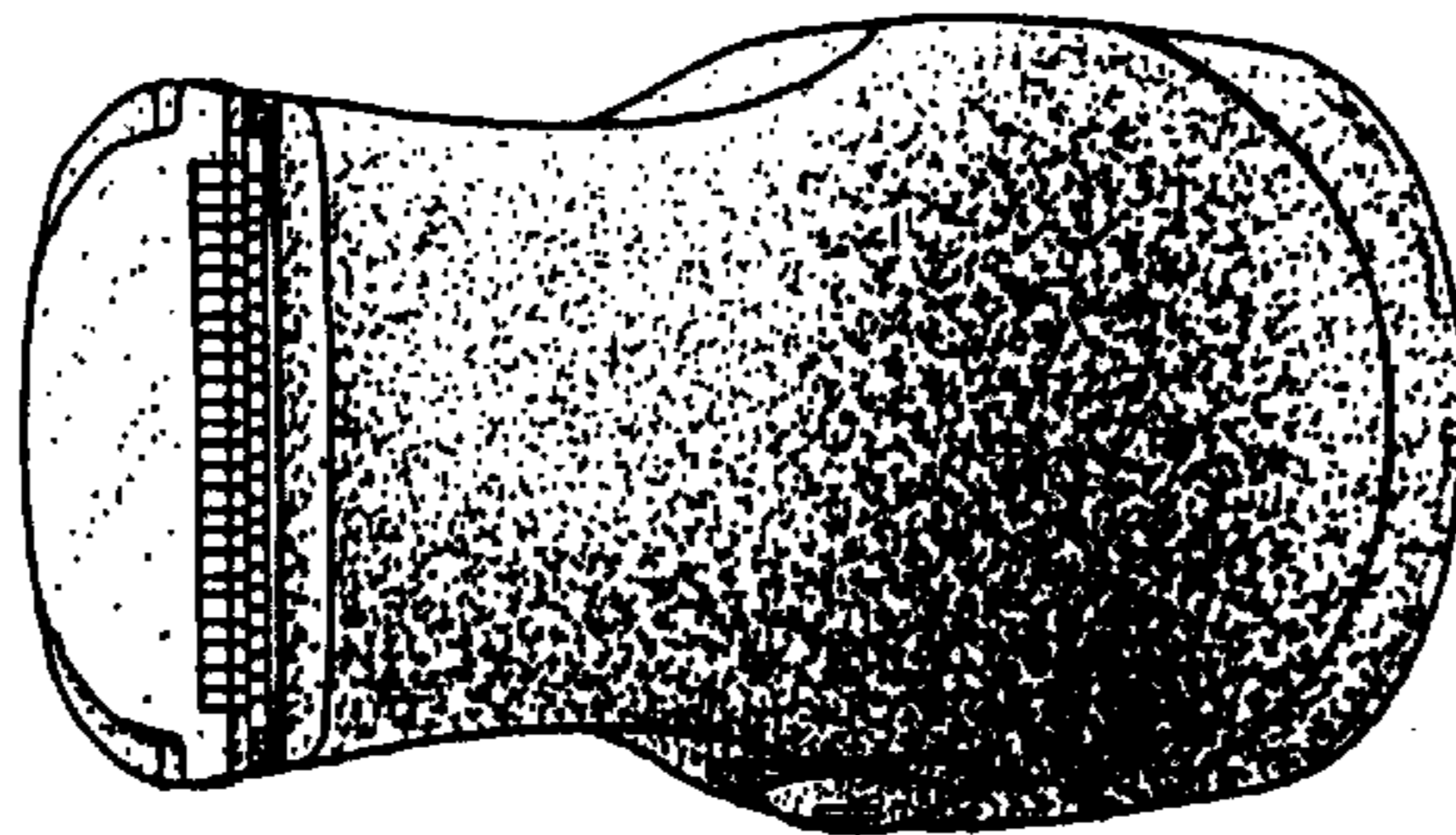

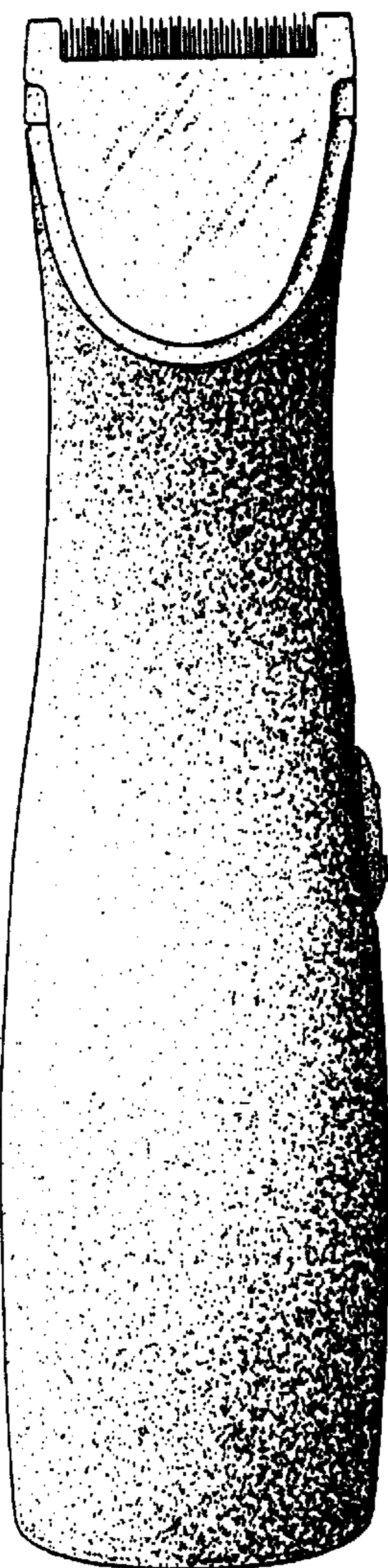

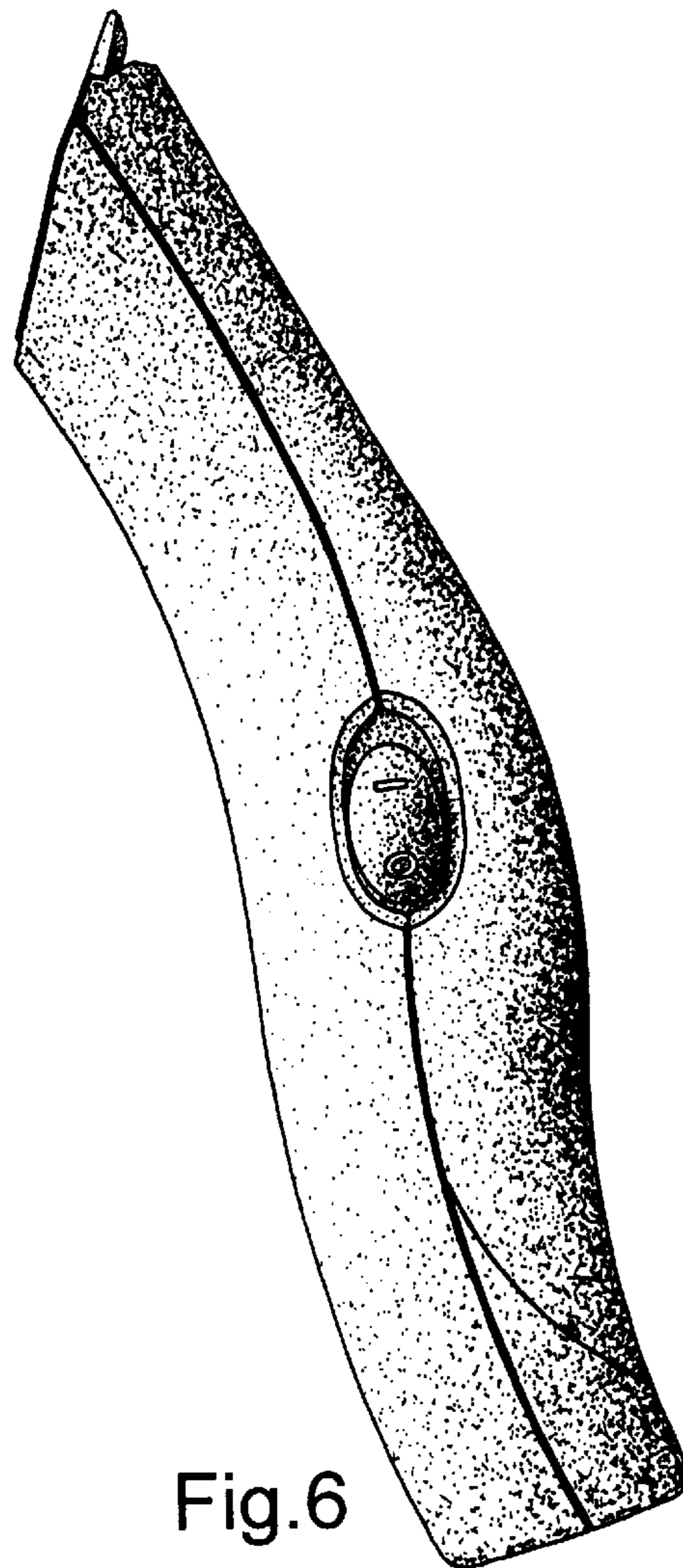

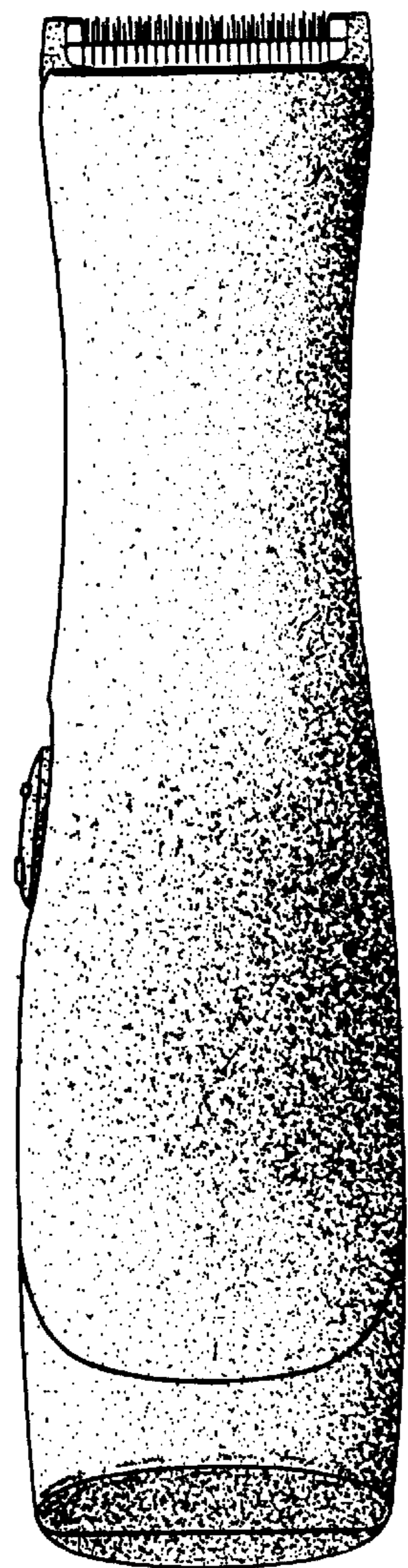

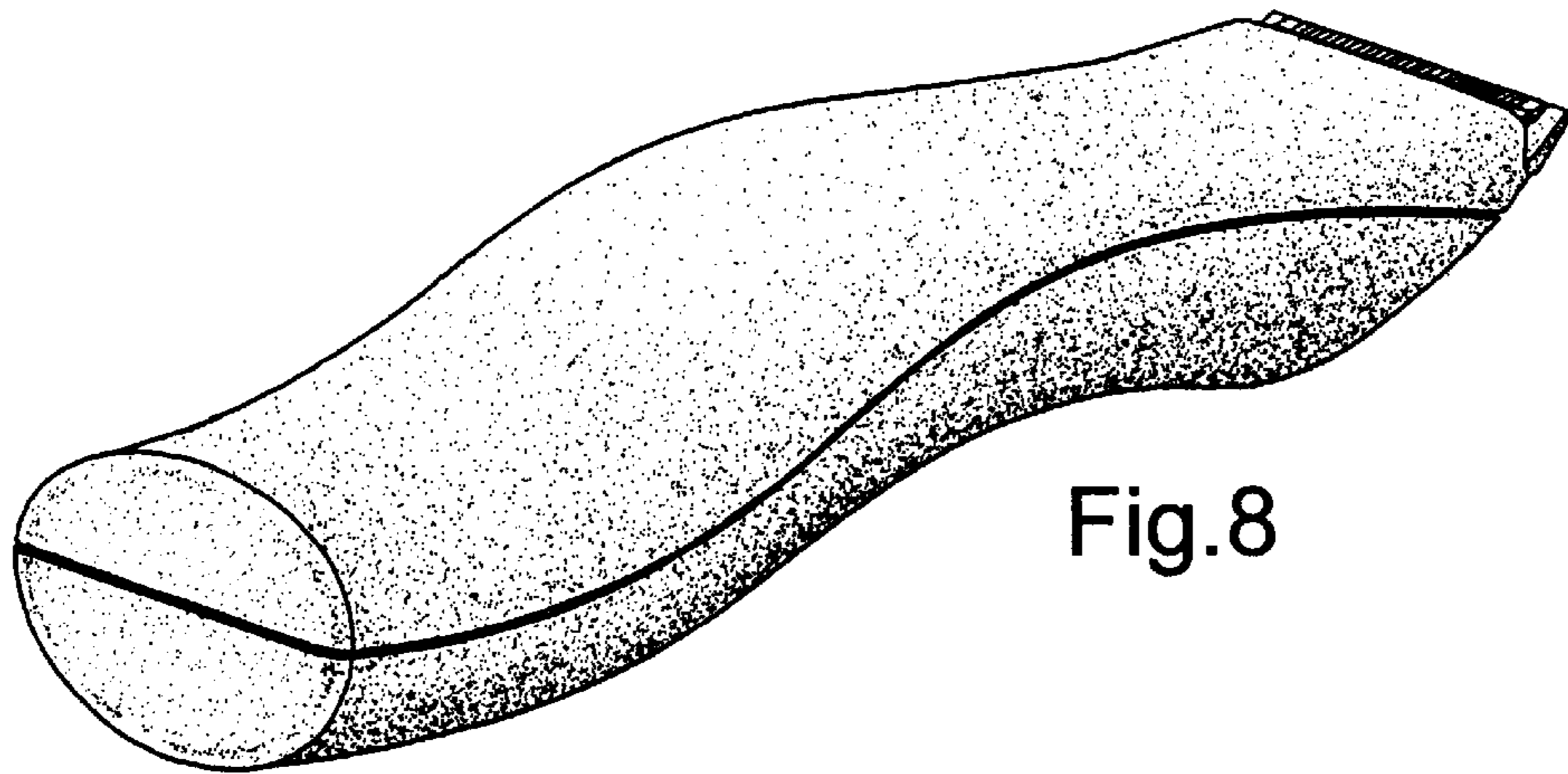

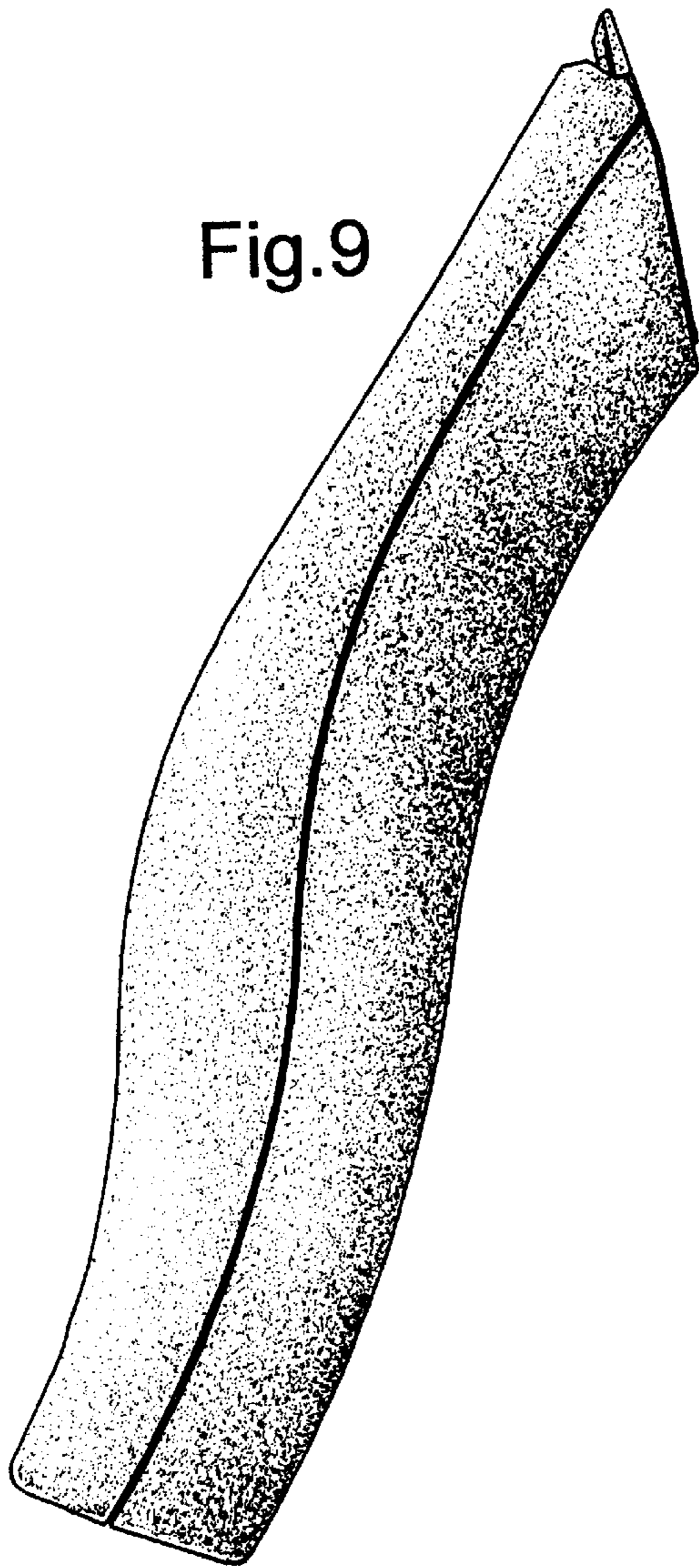

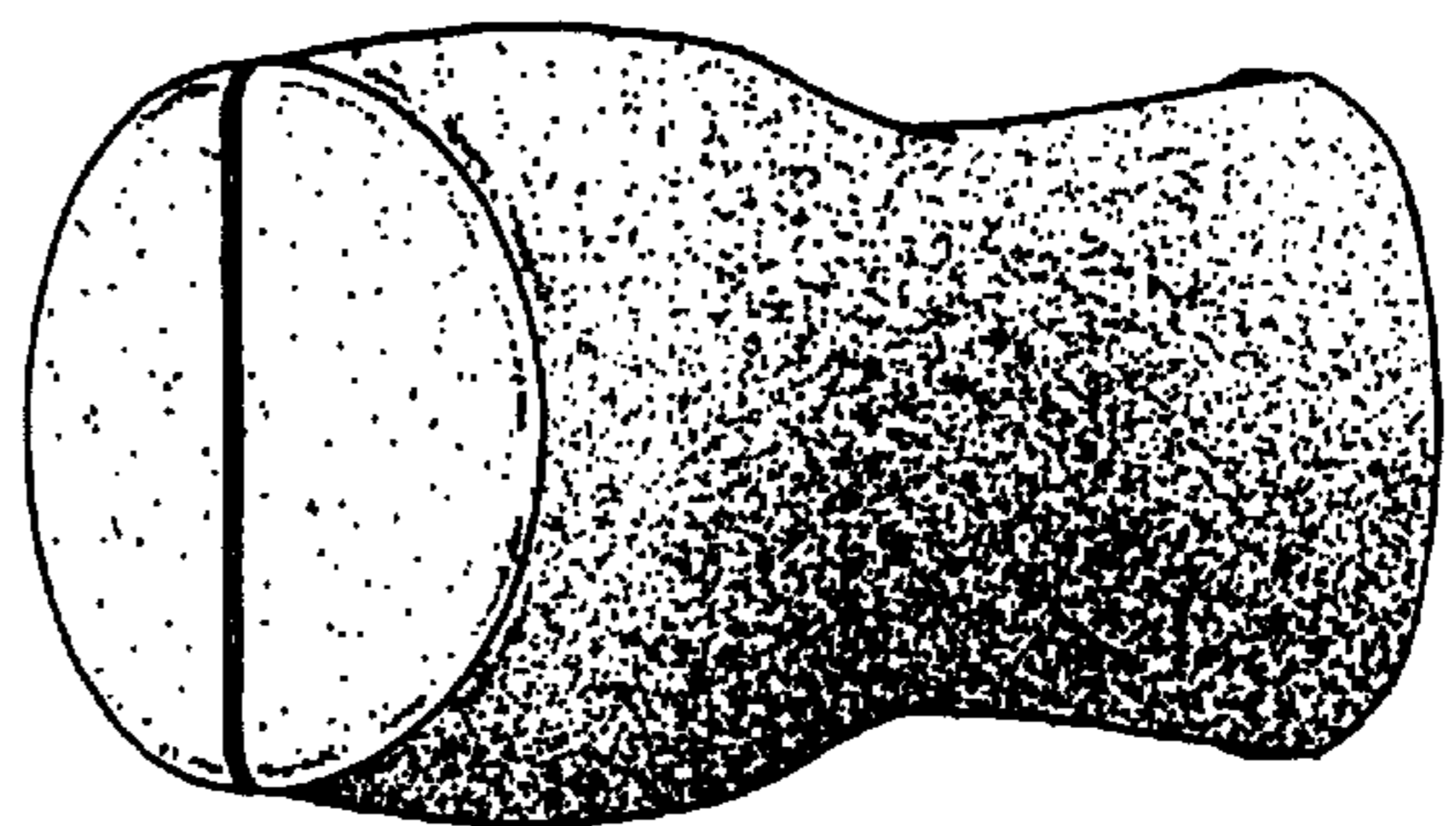

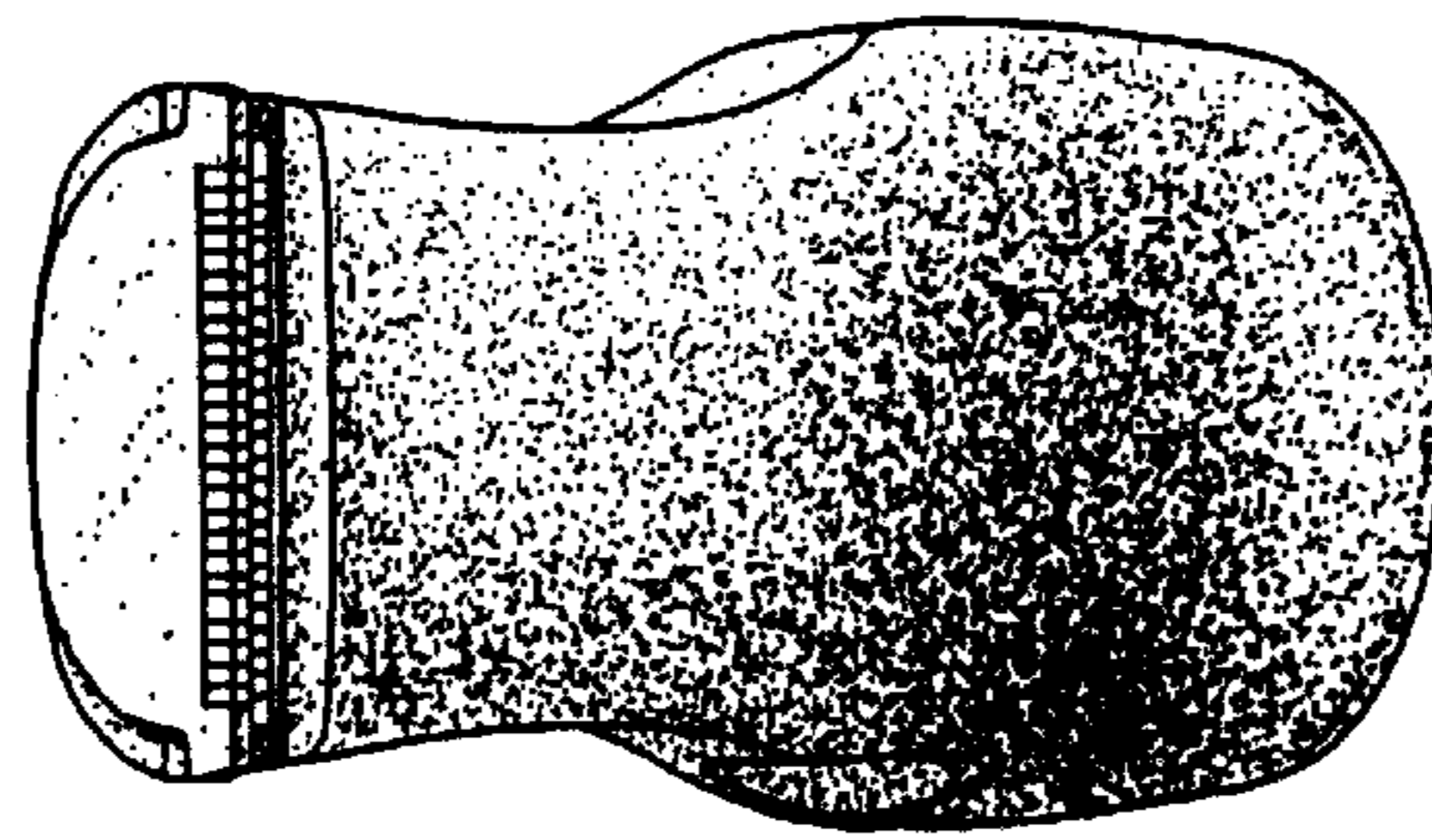

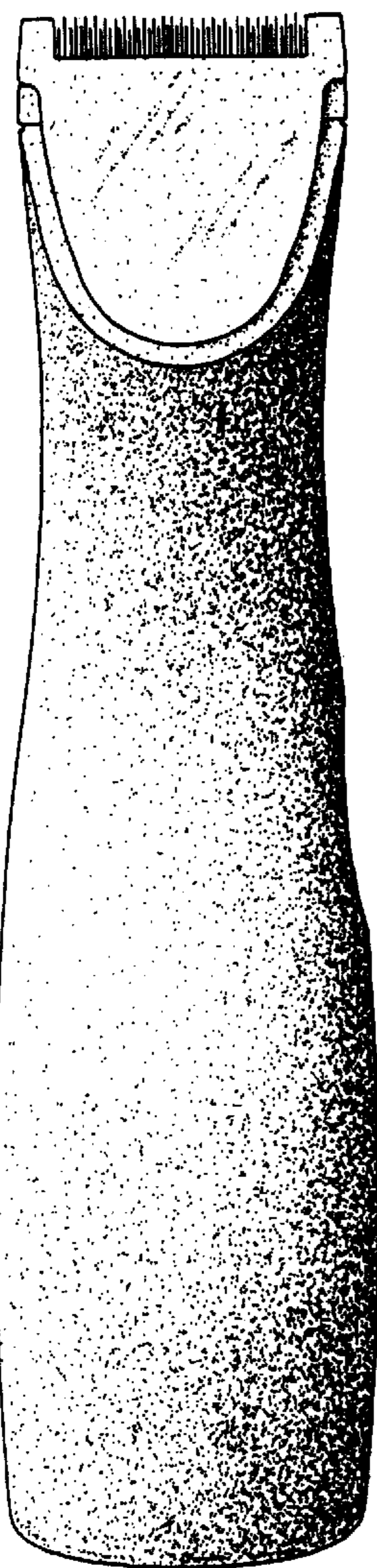

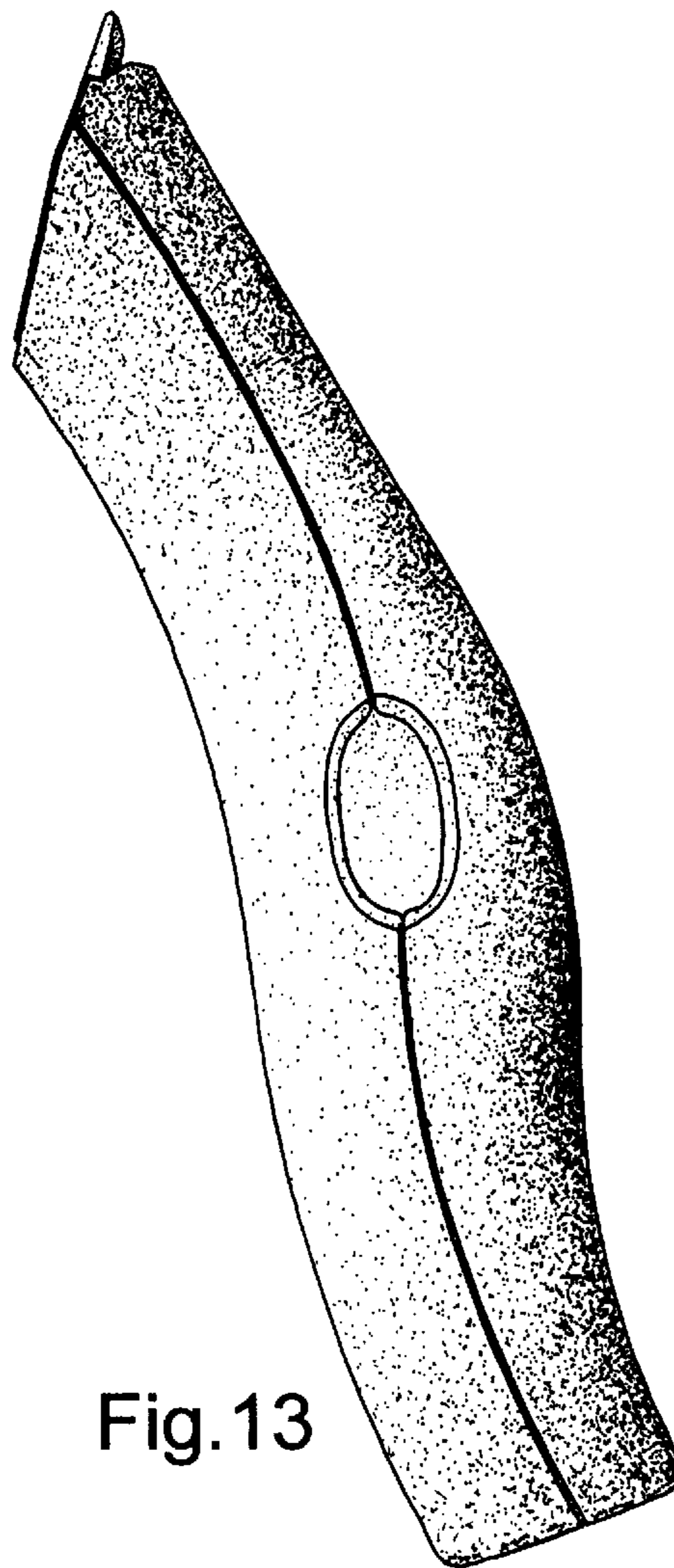

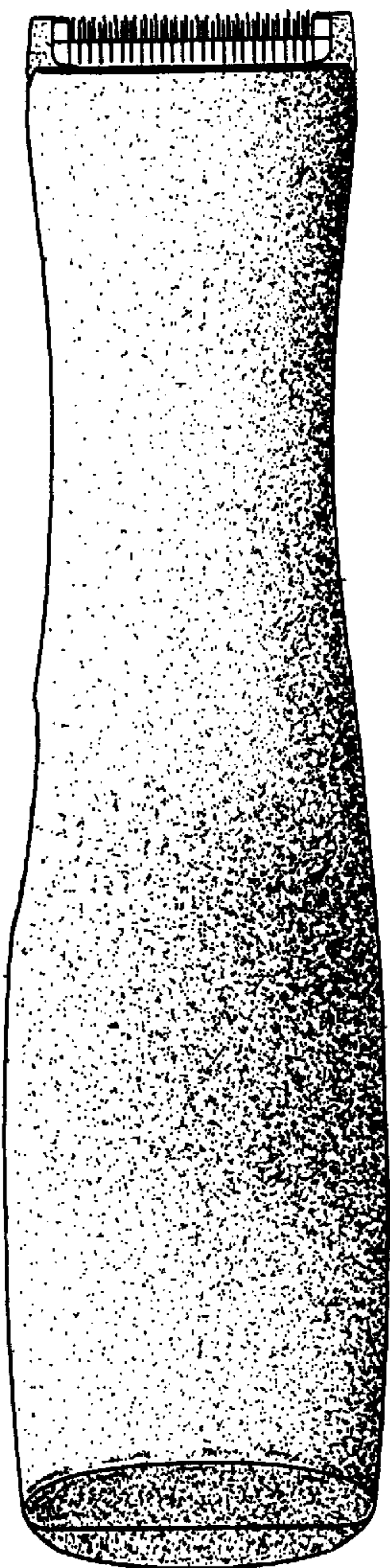
