(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 illustrates a perspective view of the shoe sole design of the invention;

FIG. 2 illustrates a left view of the shoe sole design of FIG. 1;

FIG. 3 illustrates a right side view of the shoe design of FIG. 1;

FIG. 4 illustrates a front side view of the shoe sole design of FIG. 1;

FIG. 5 illustrates a back side view of the shoe sole design of FIG. 1;

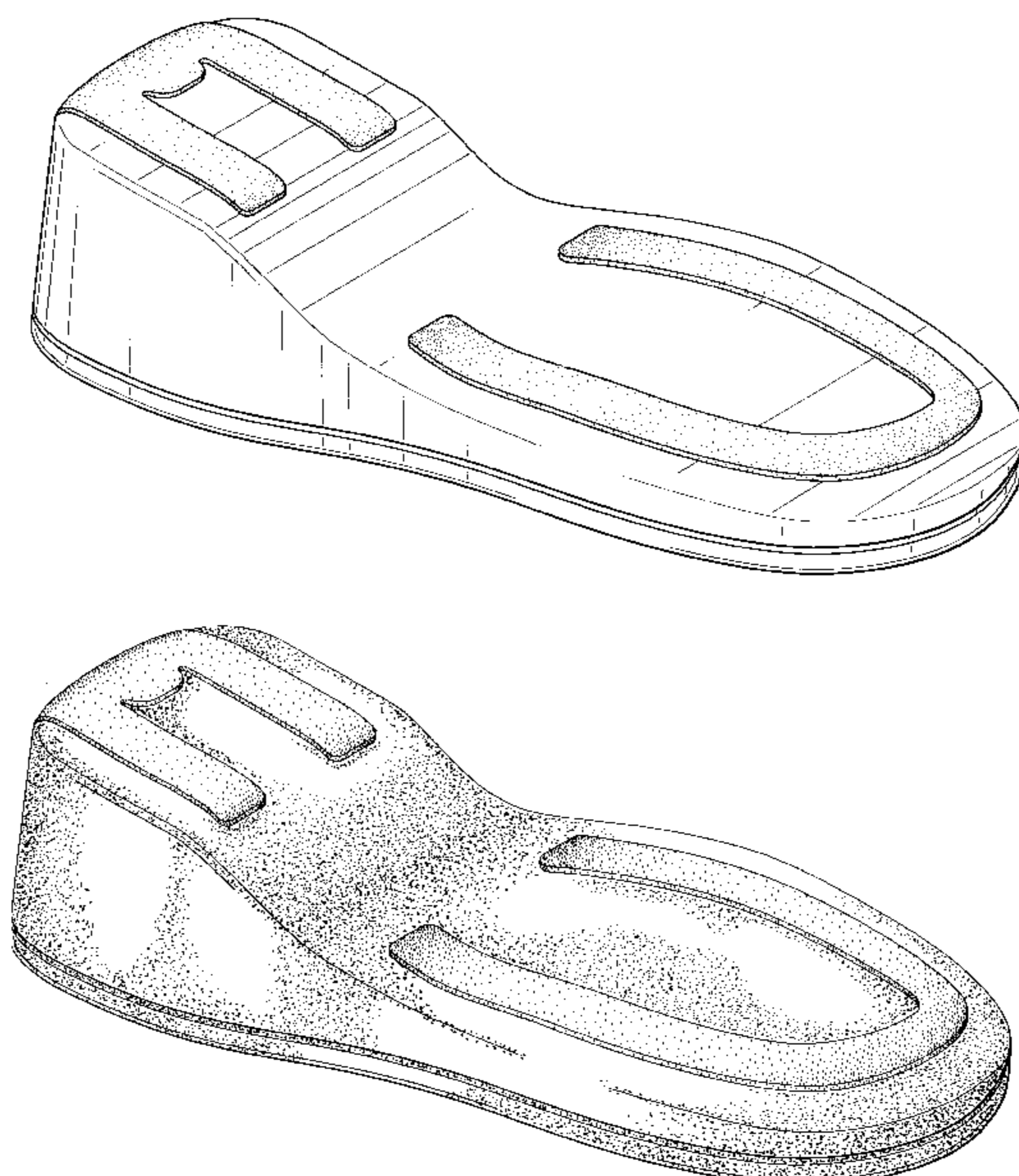
FIG. 6 illustrates a top view of the shoe sole design of FIG. 1;

FIG. 7 illustrates a bottom view of the shoe sole design of FIG. 1; and,

FIG. 8 is a perspective view of an alternate embodiment of the design shown in FIGS. 1-7.

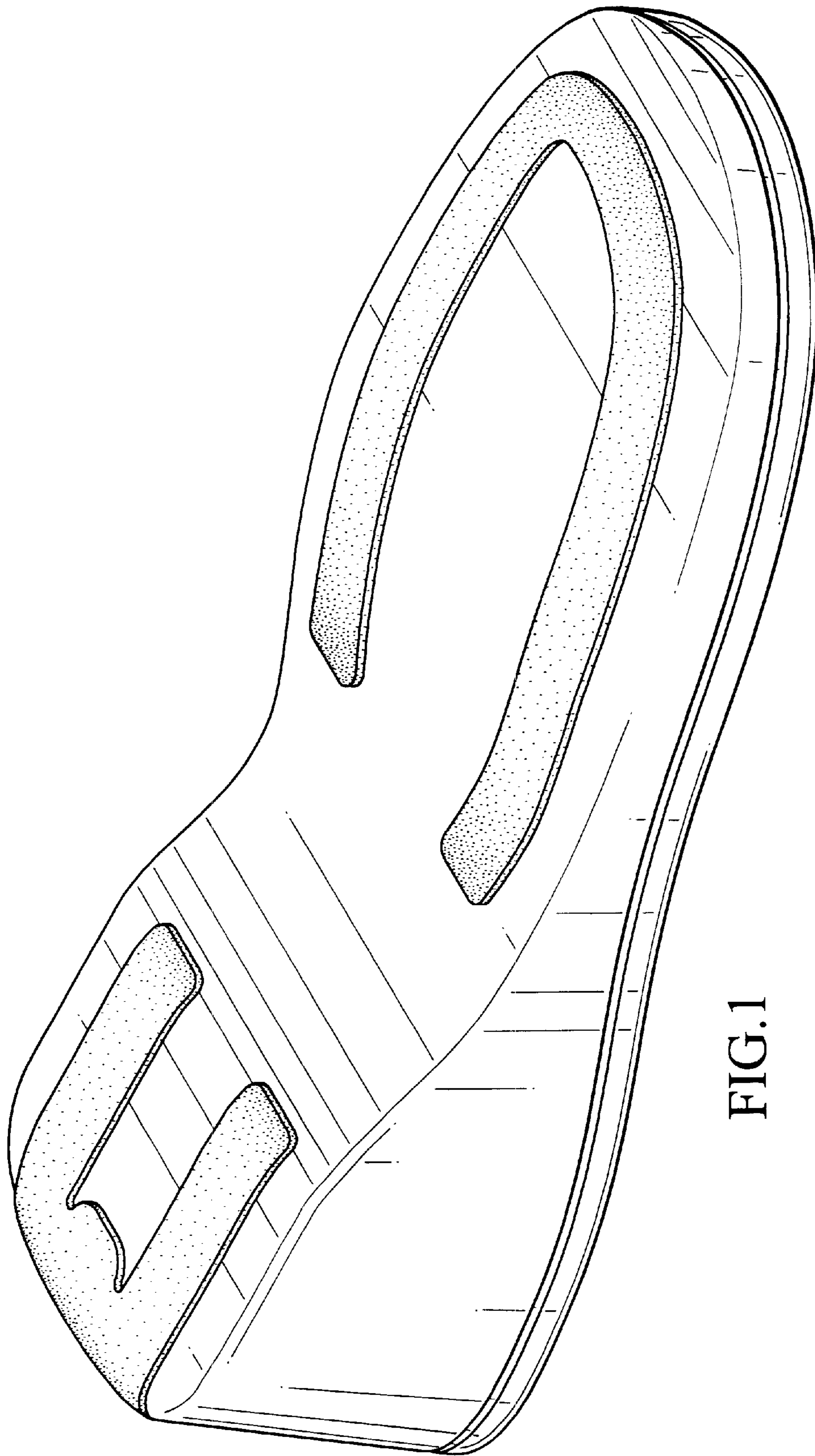

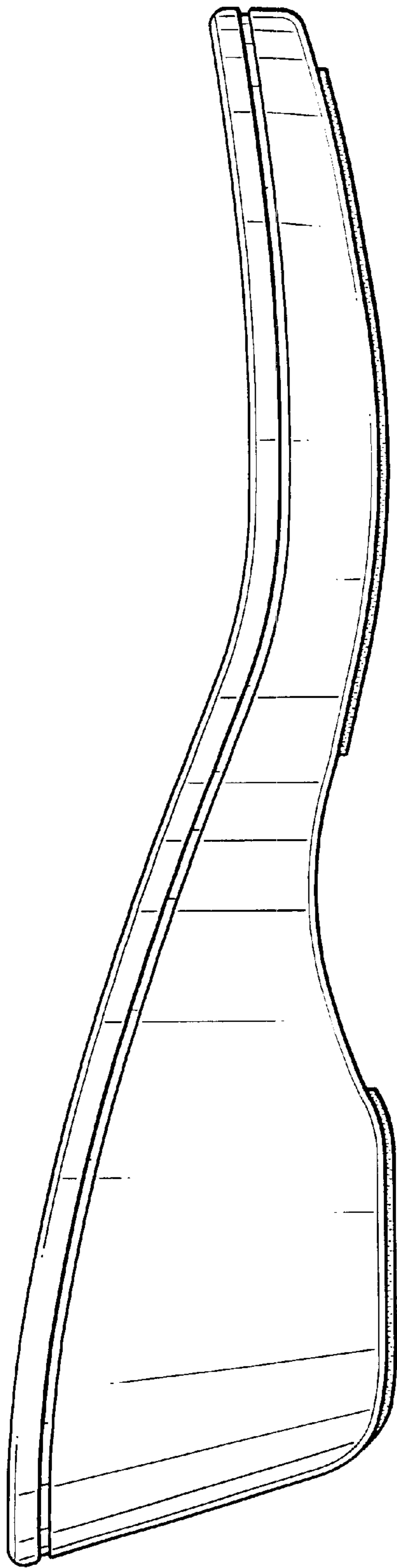

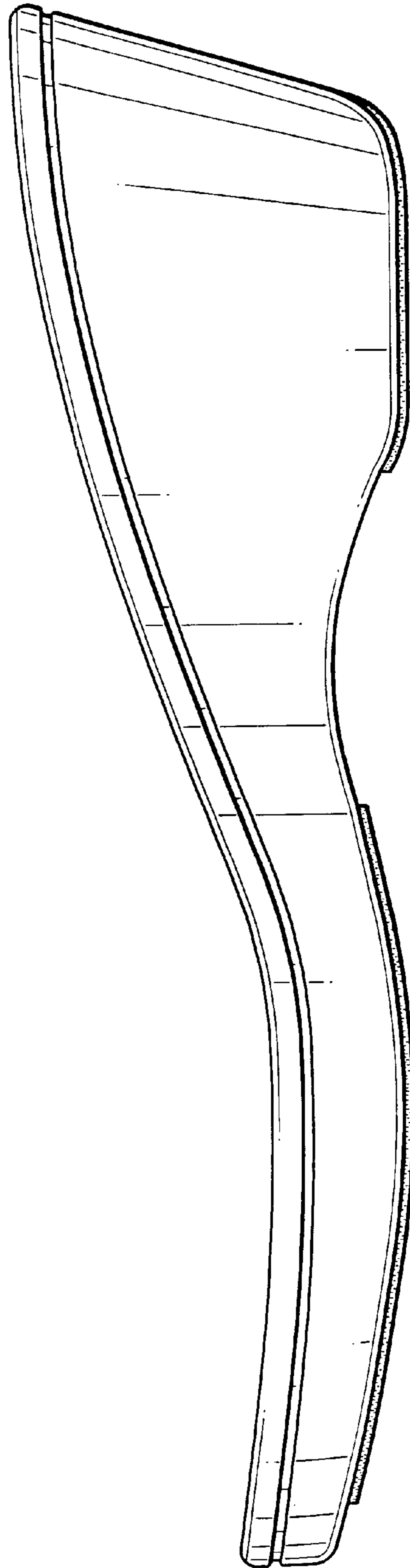

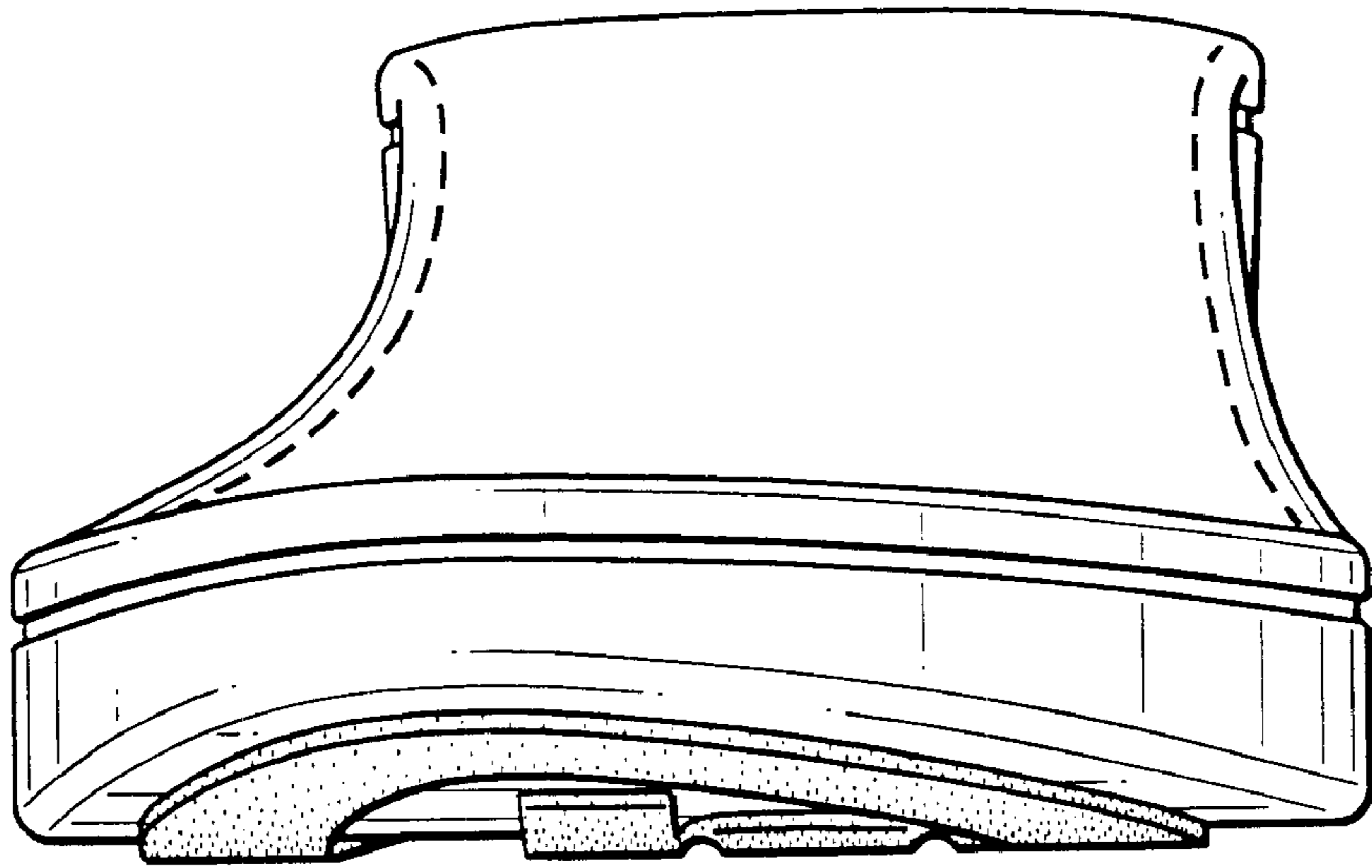

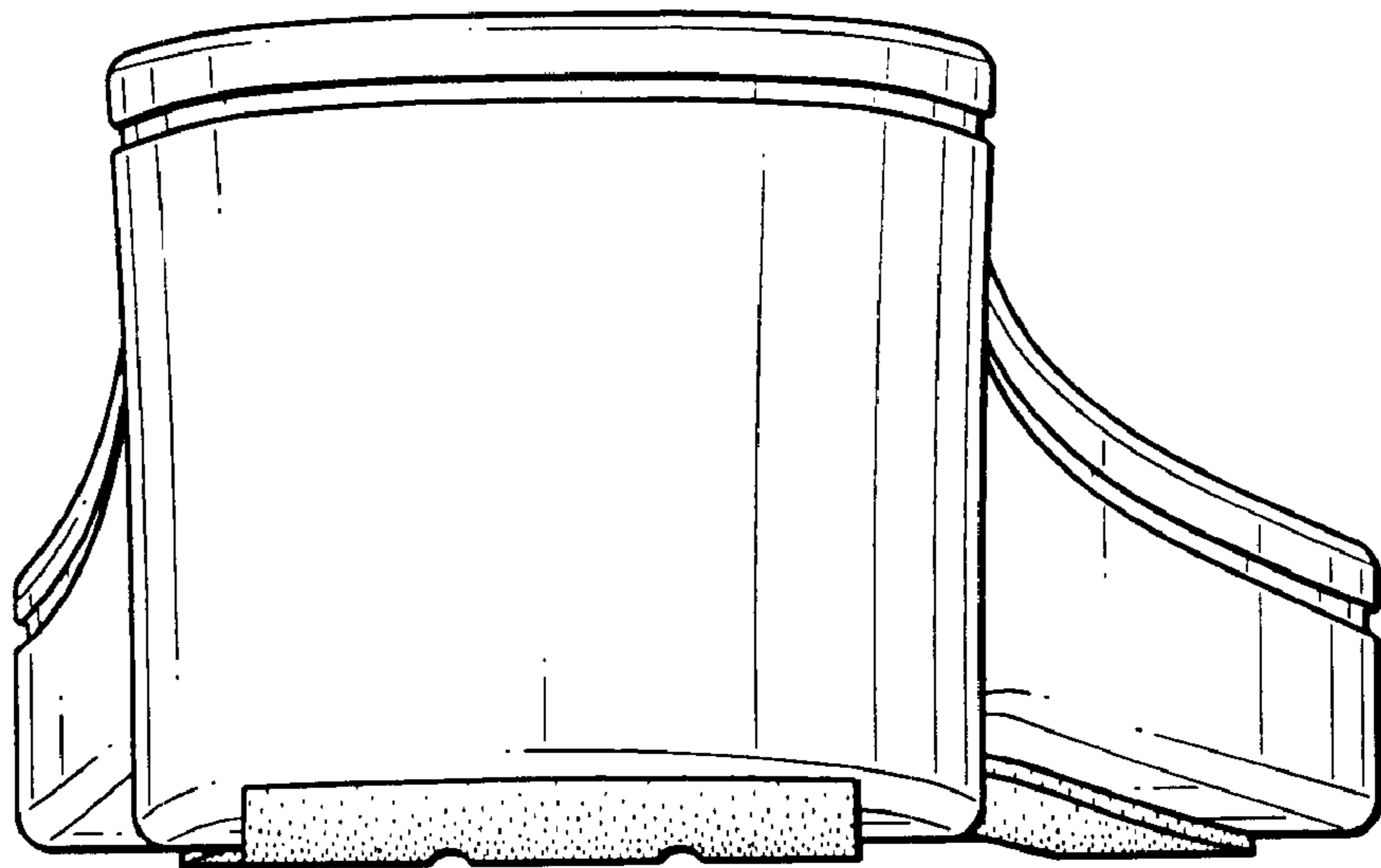

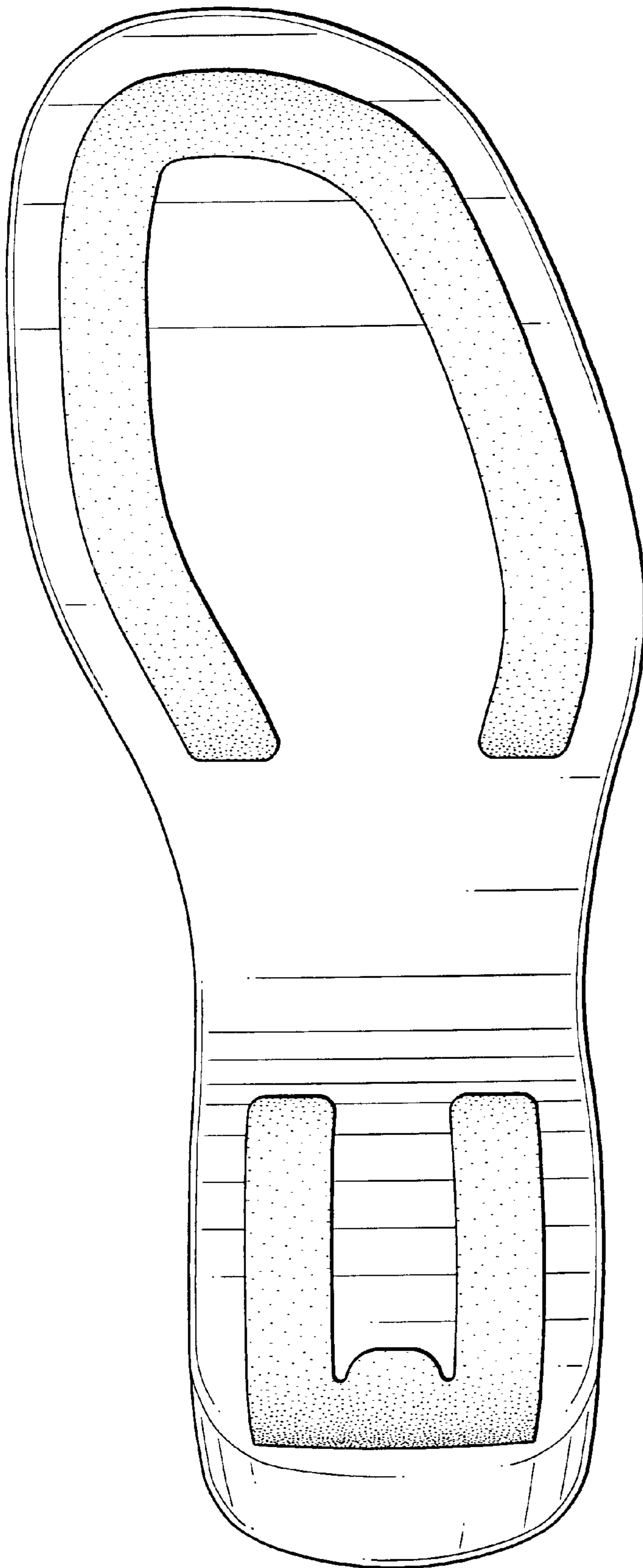

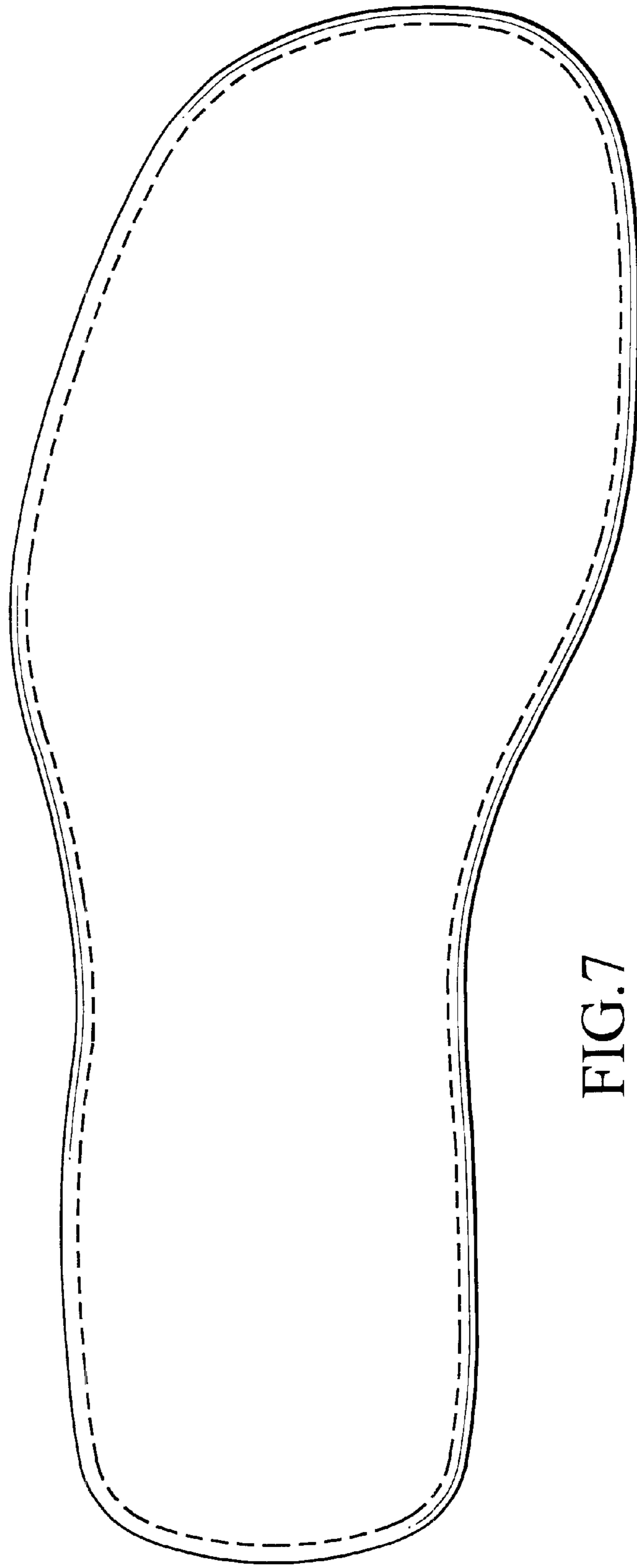

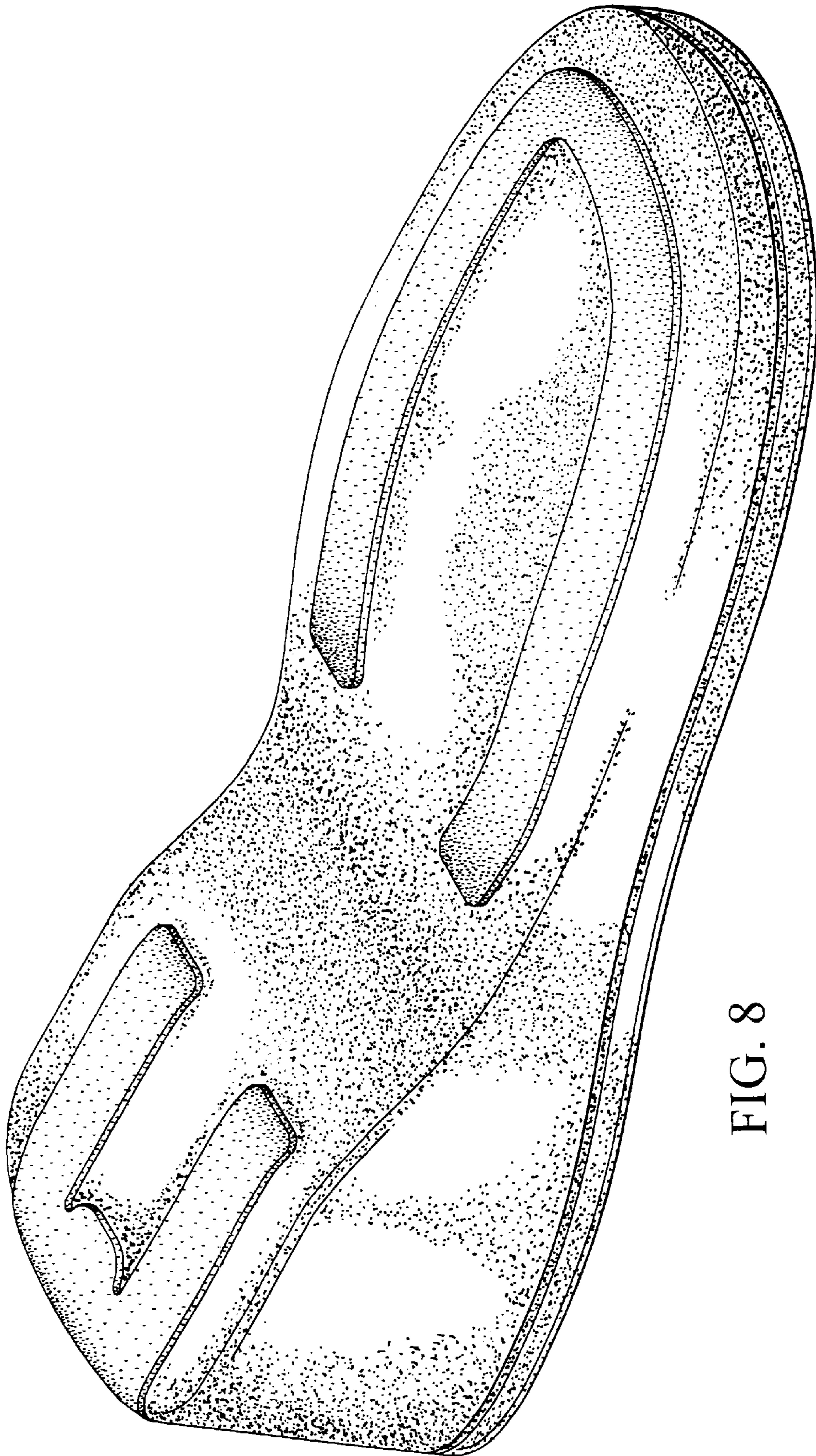
