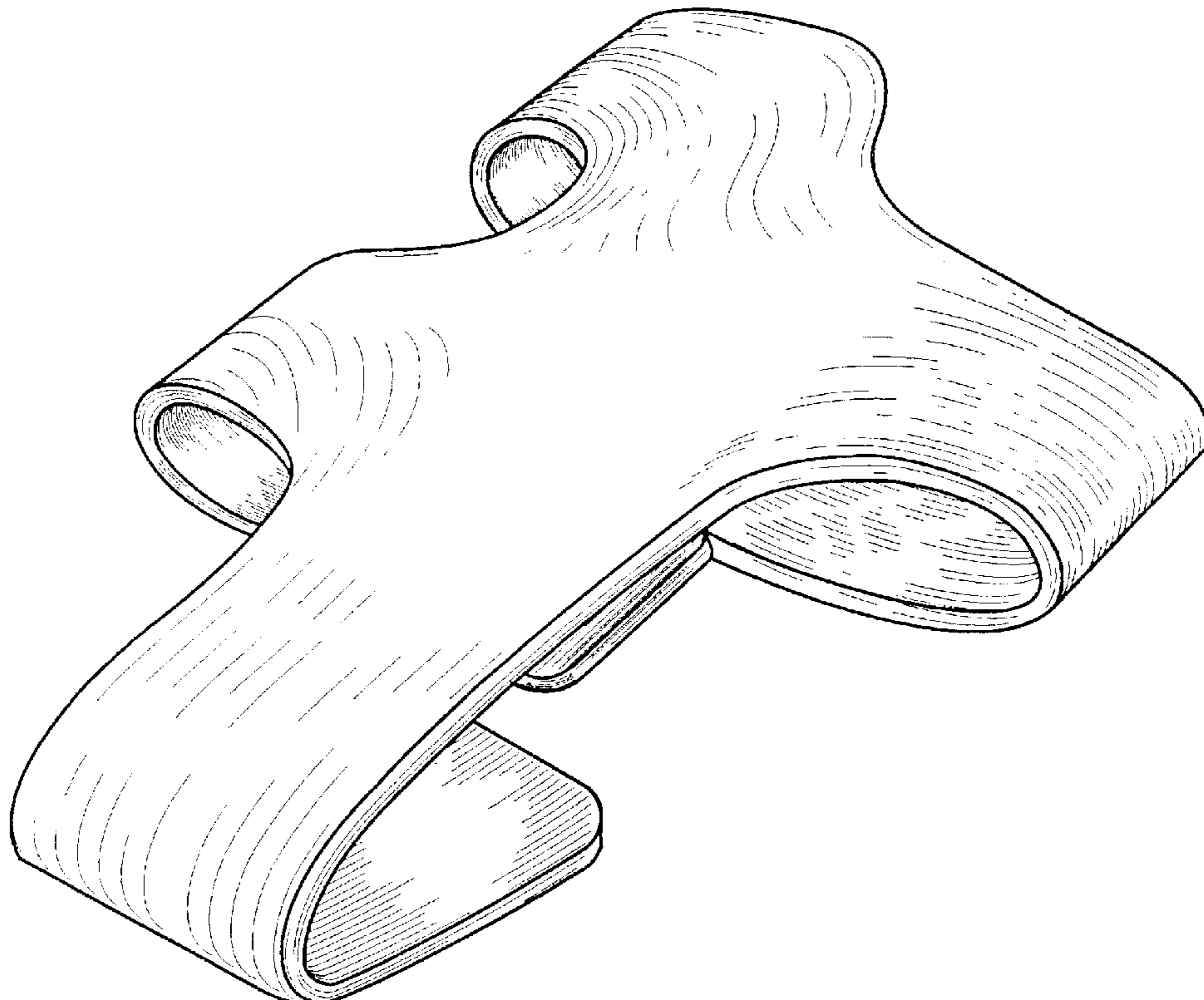

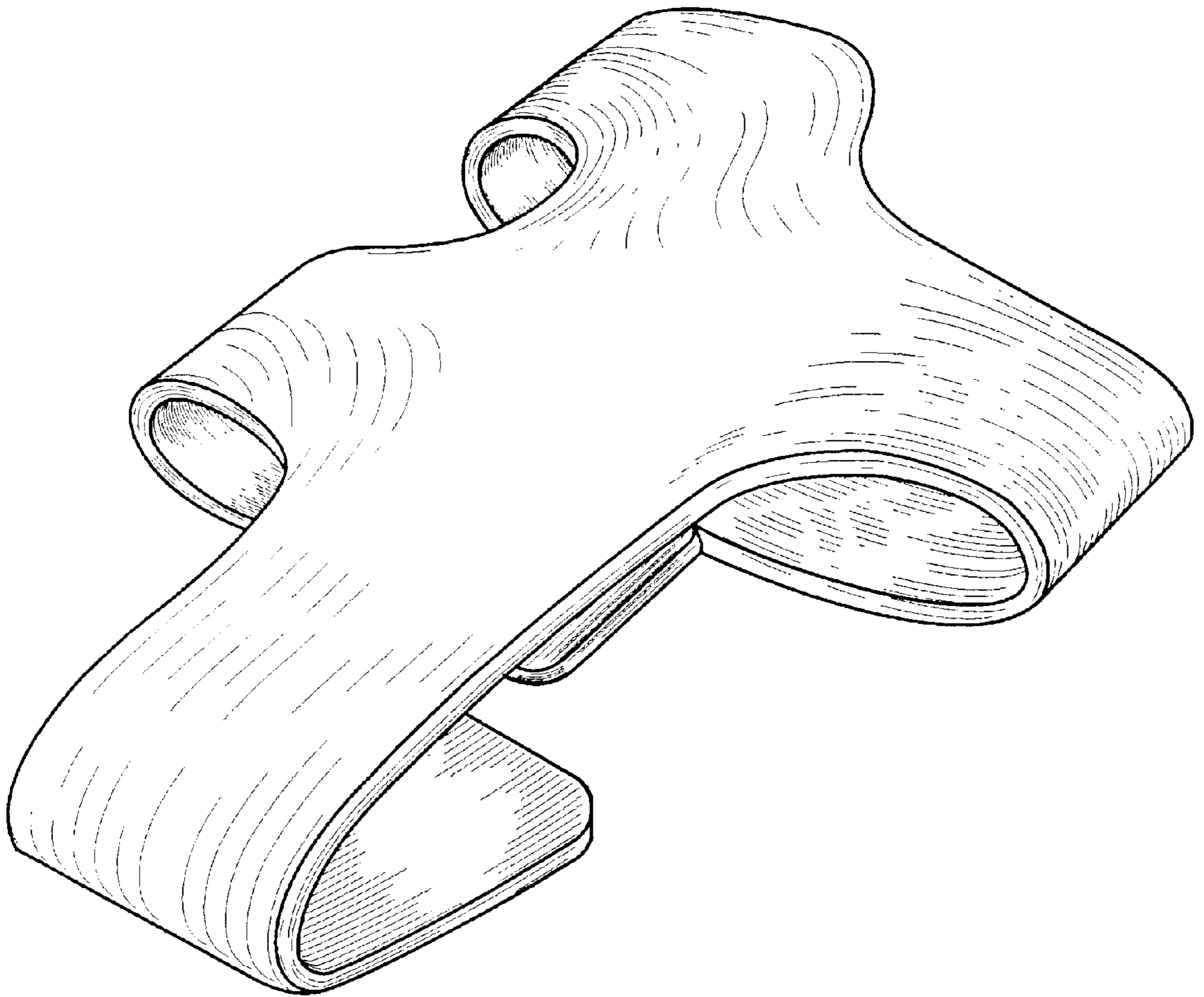
The ornamental design for an adjustable holster, as shown.

**DESCRIPTION**

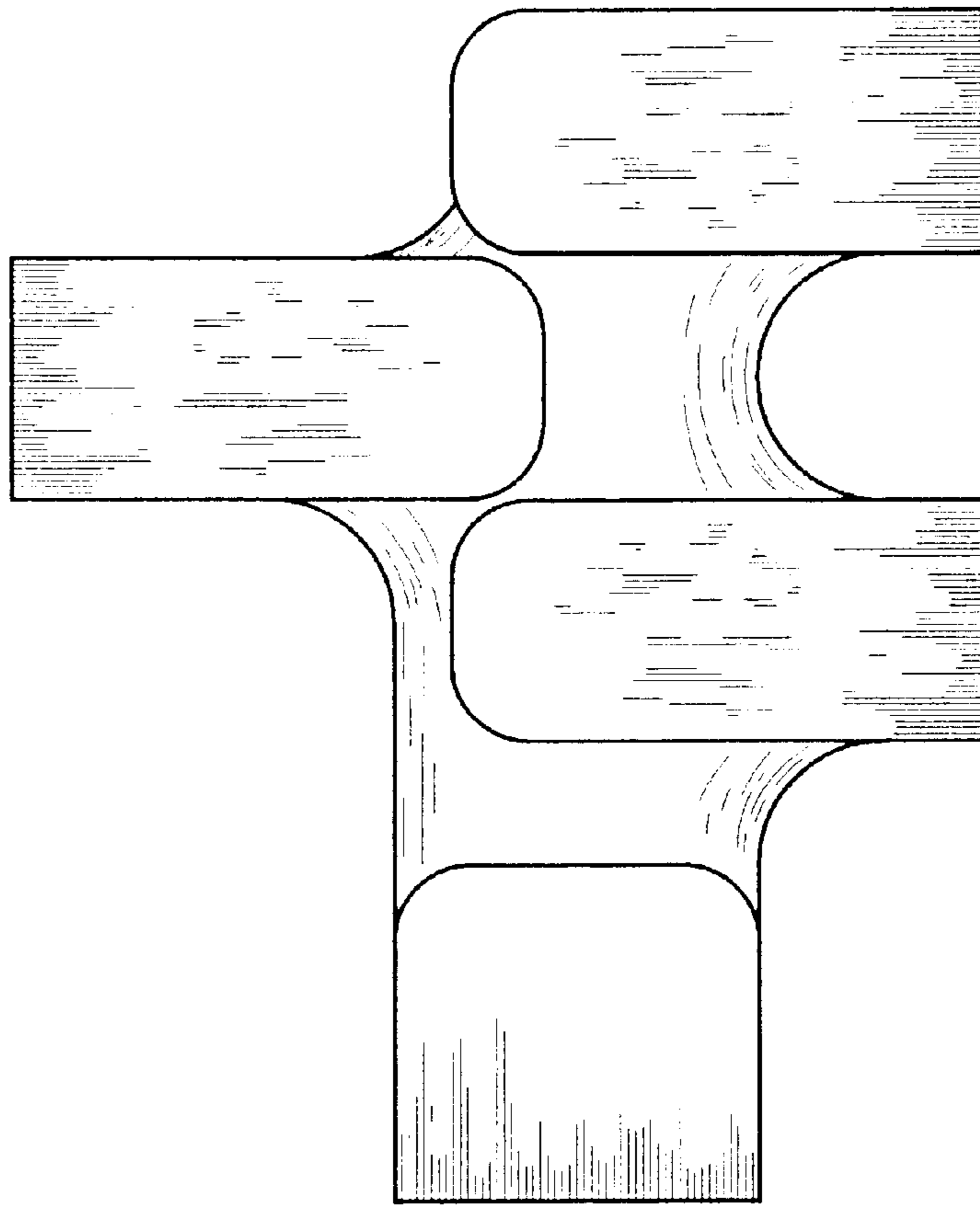
FIG. 1 is a perspective view of an adjustable holster showing our new design;

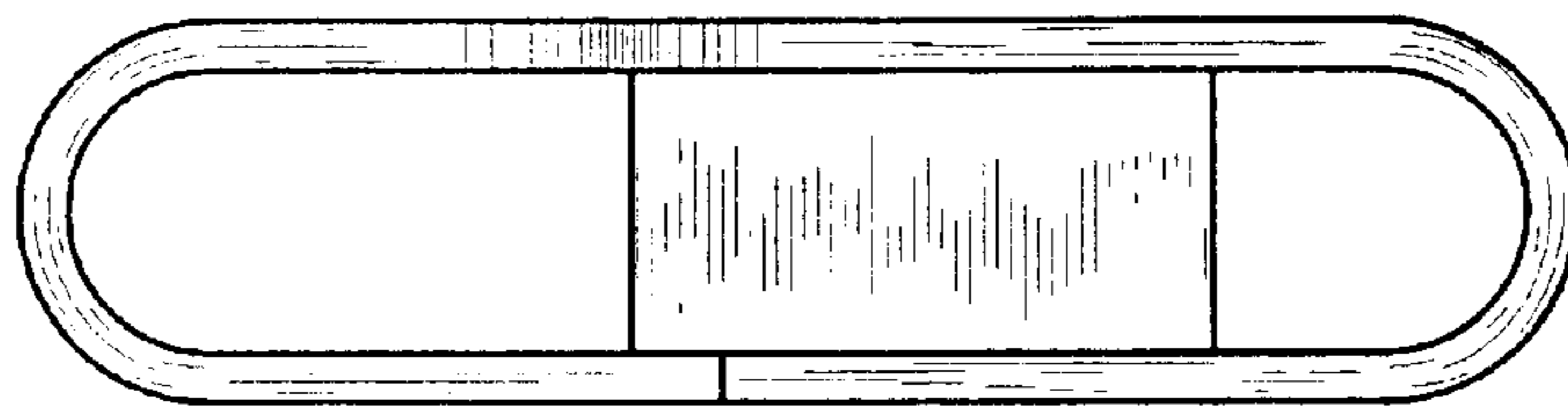

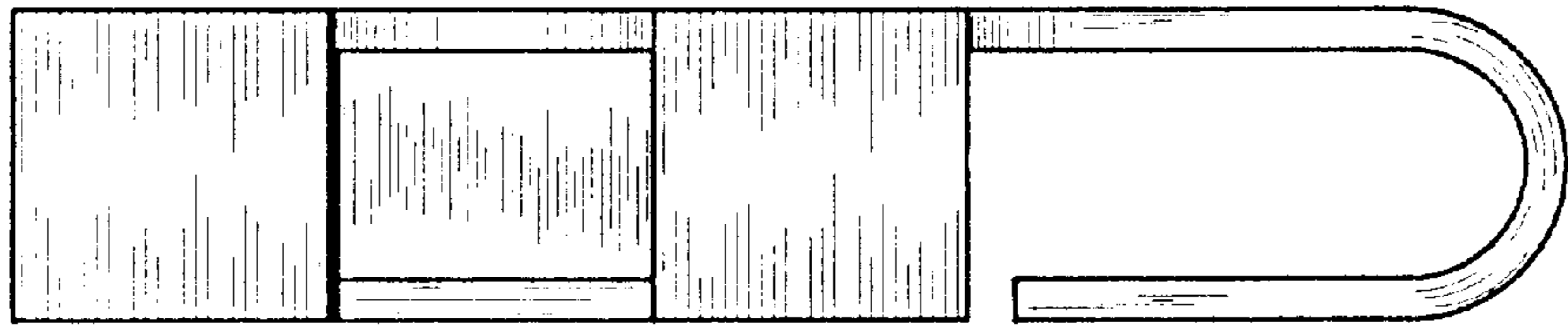

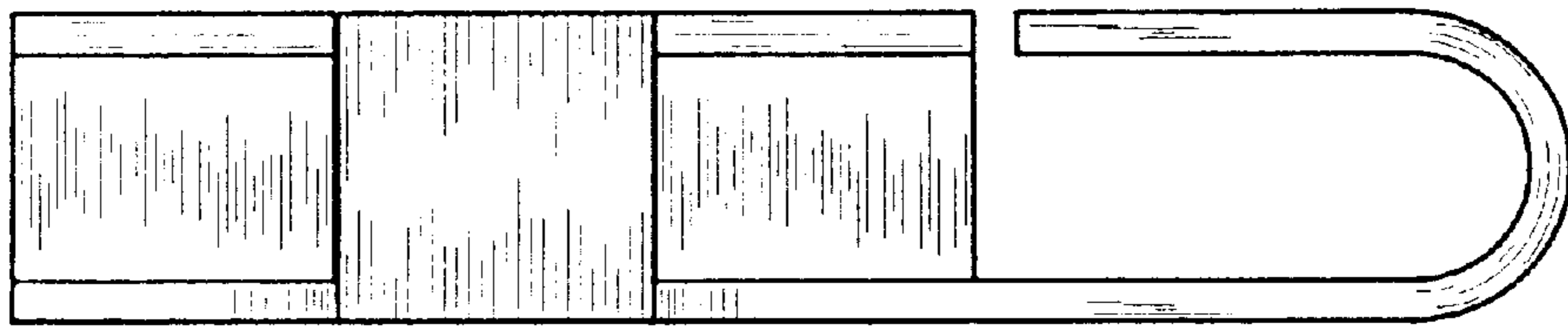

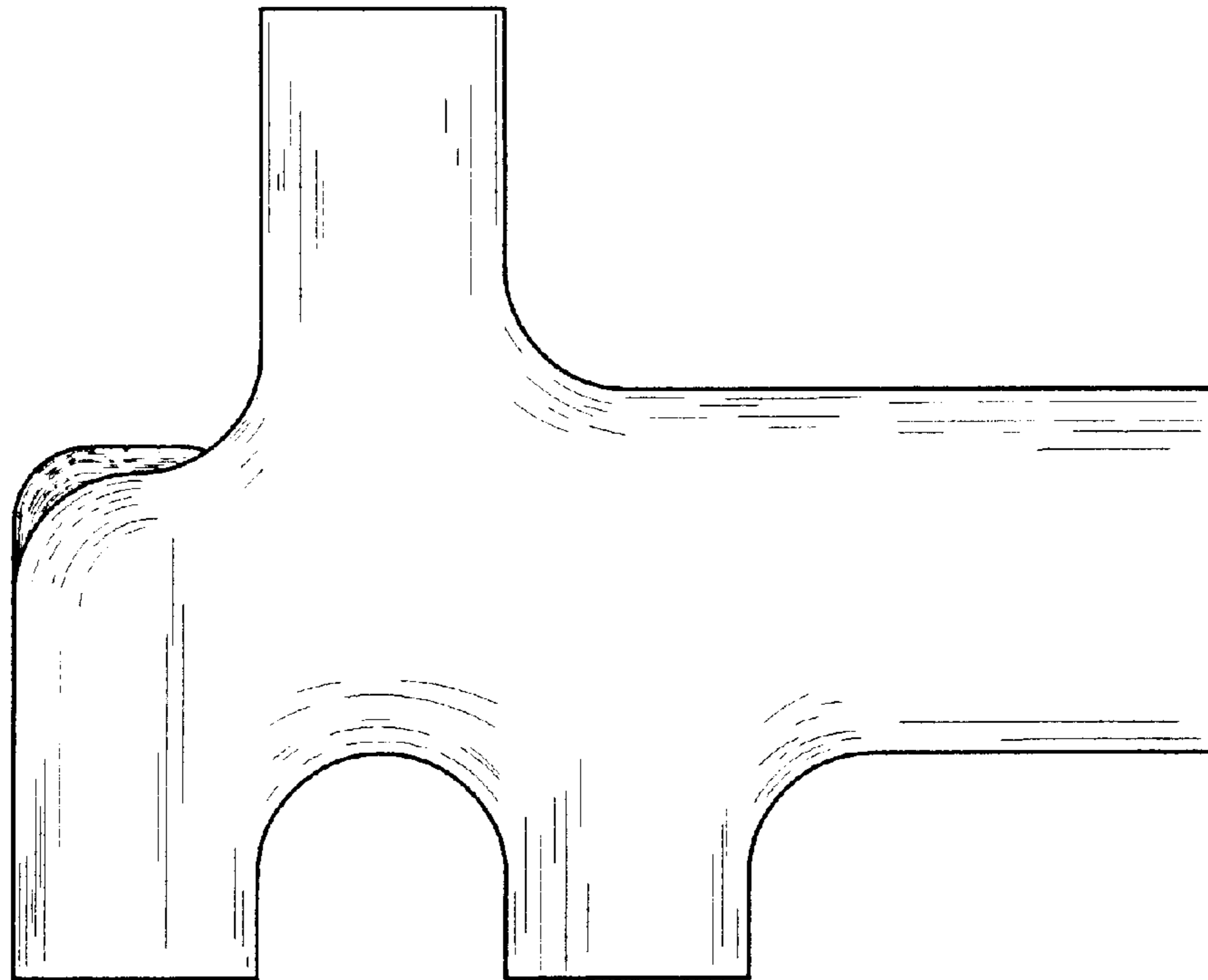
