FIG. 3 is a top plan view thereof.

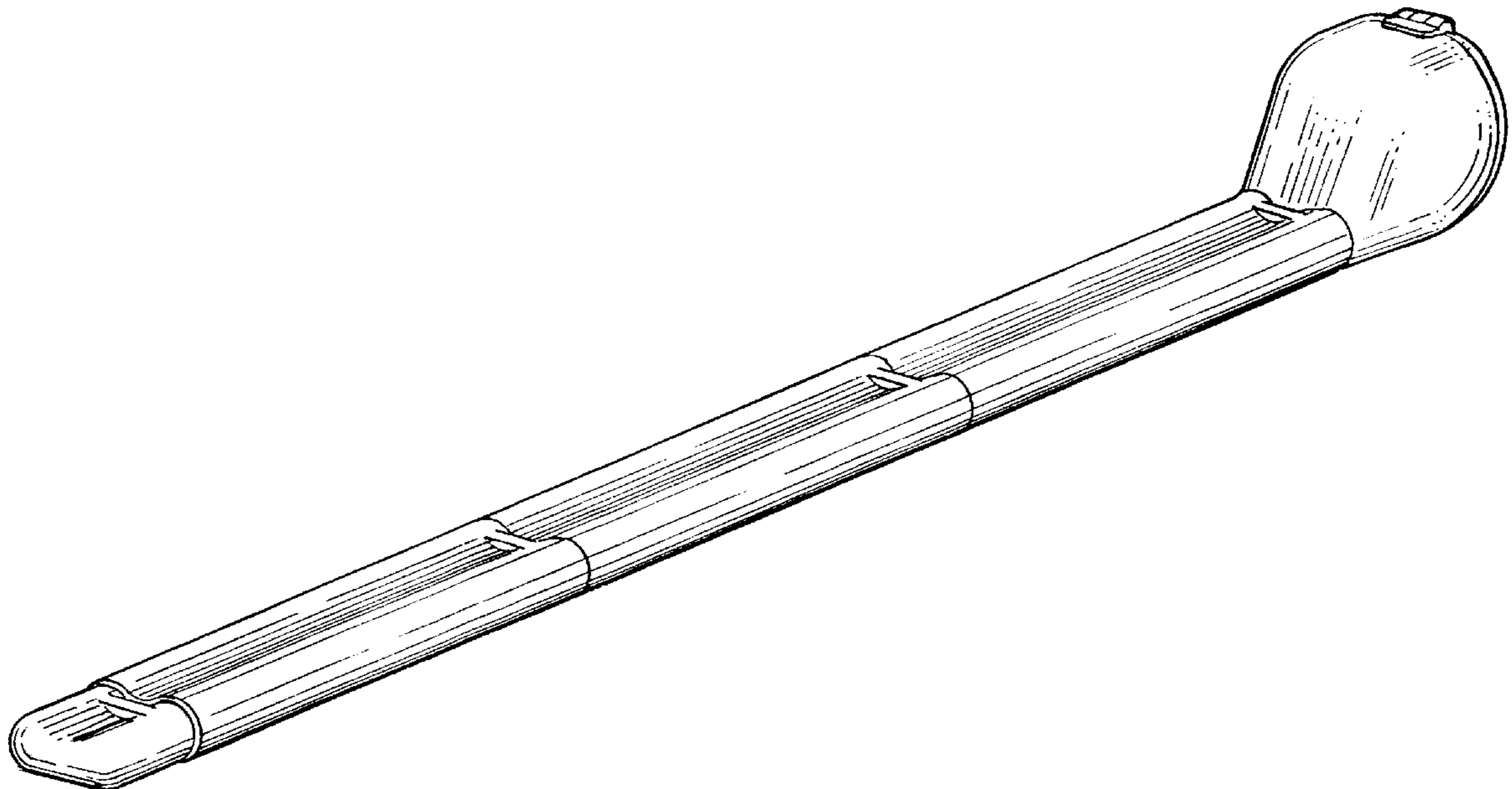
FIG. 4 is a right side elevational view thereof, with the left side elevational view being a mirror image of FIG. 4.

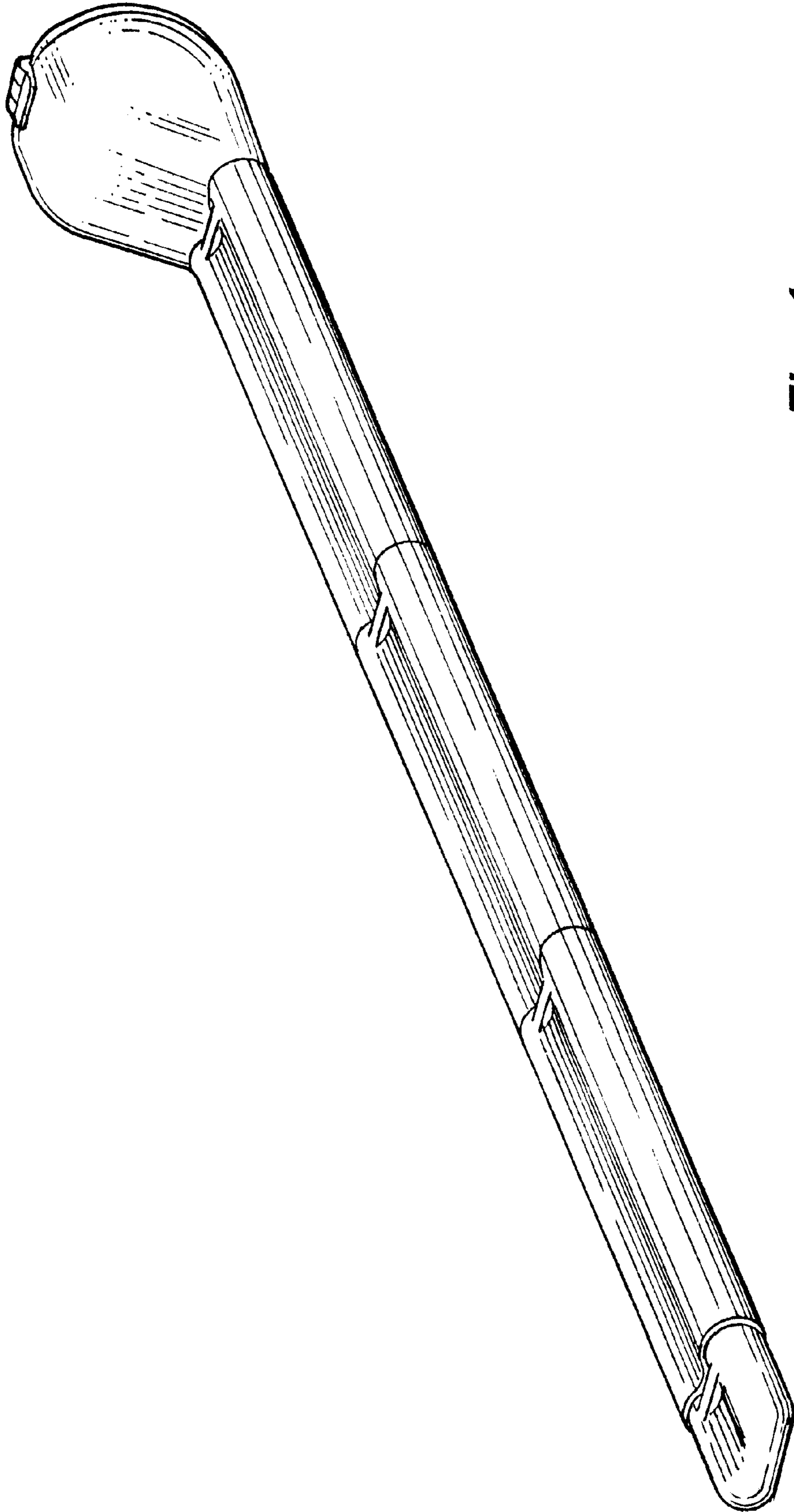

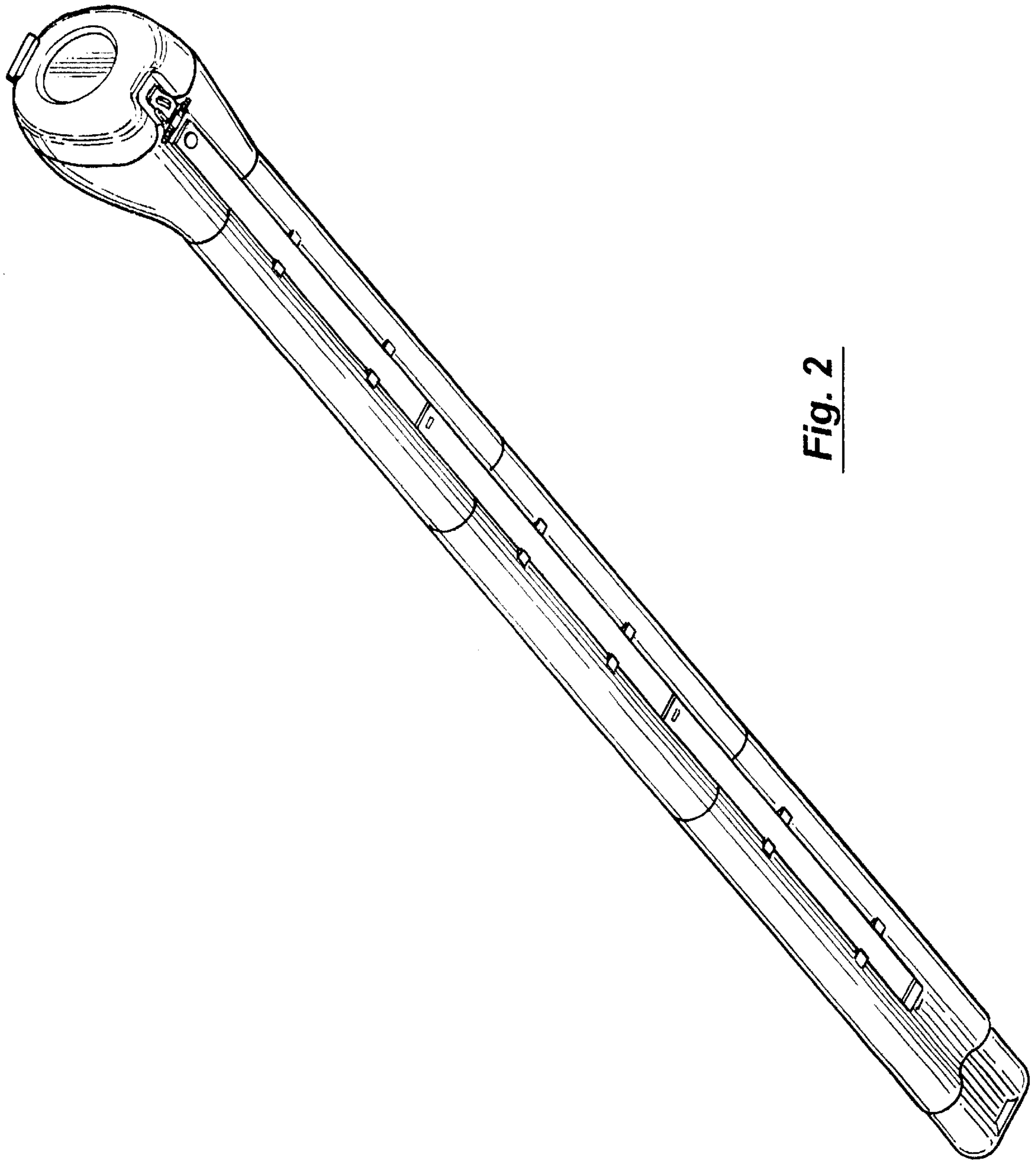

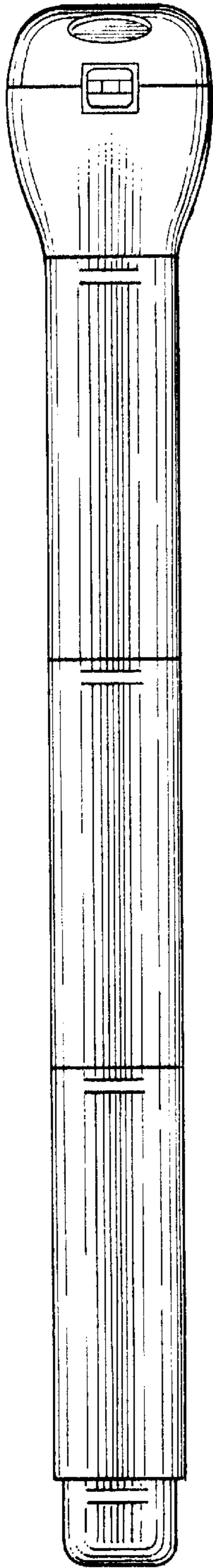

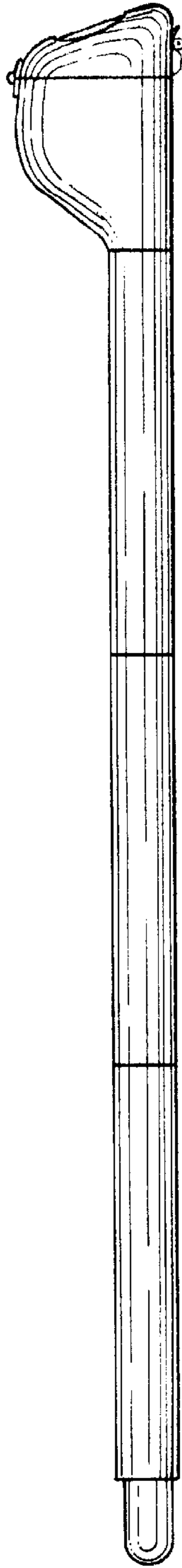

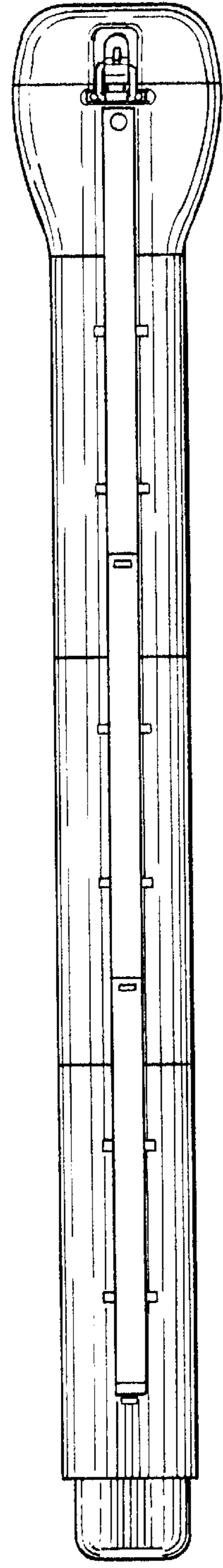

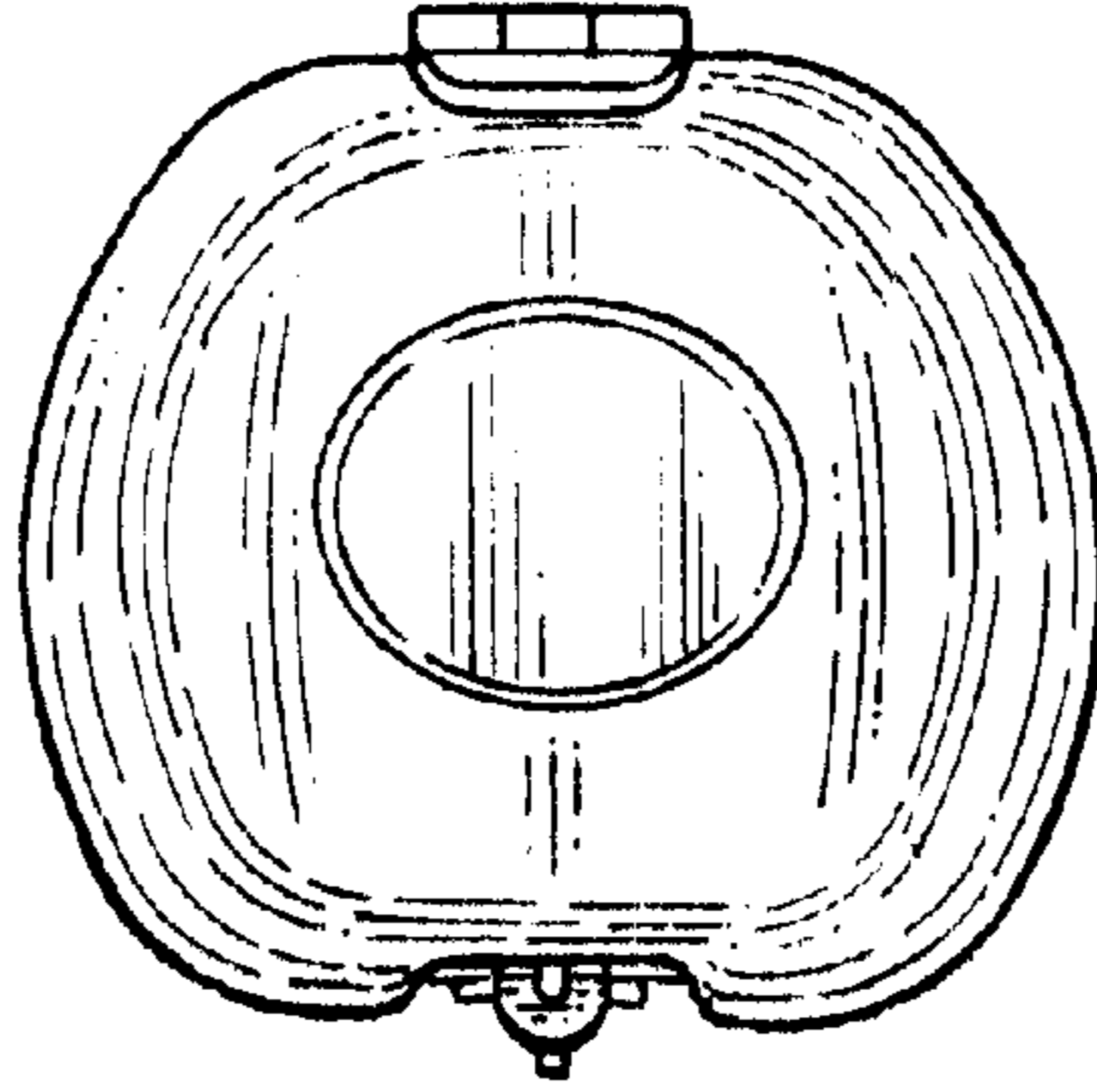

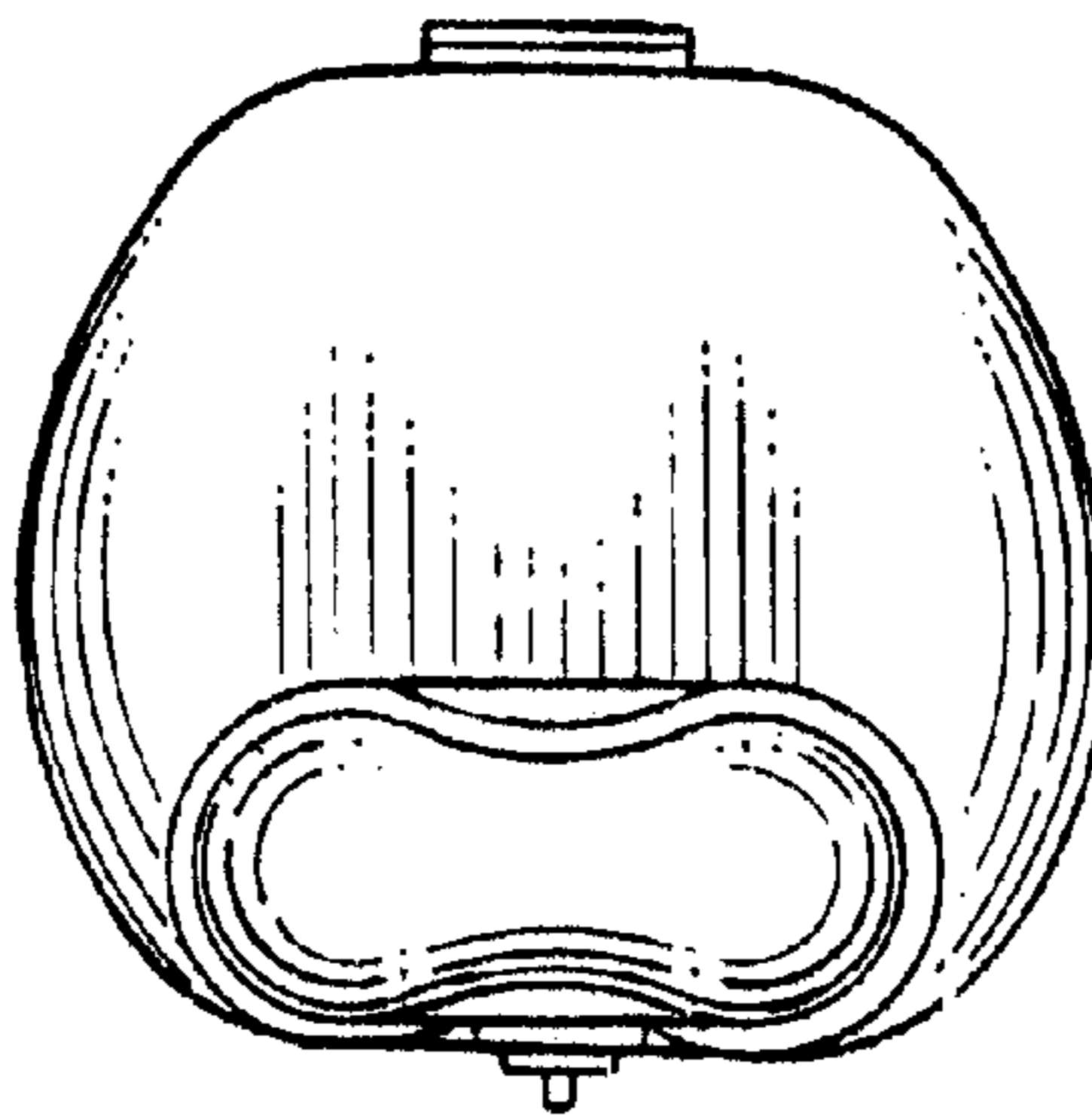
