DESCRIPTION

FIG. 1 is a perspective view of the wooden basket showing our new design;

FIG. 2 is a rear view thereof;

FIG. 5 is a front view thereof;

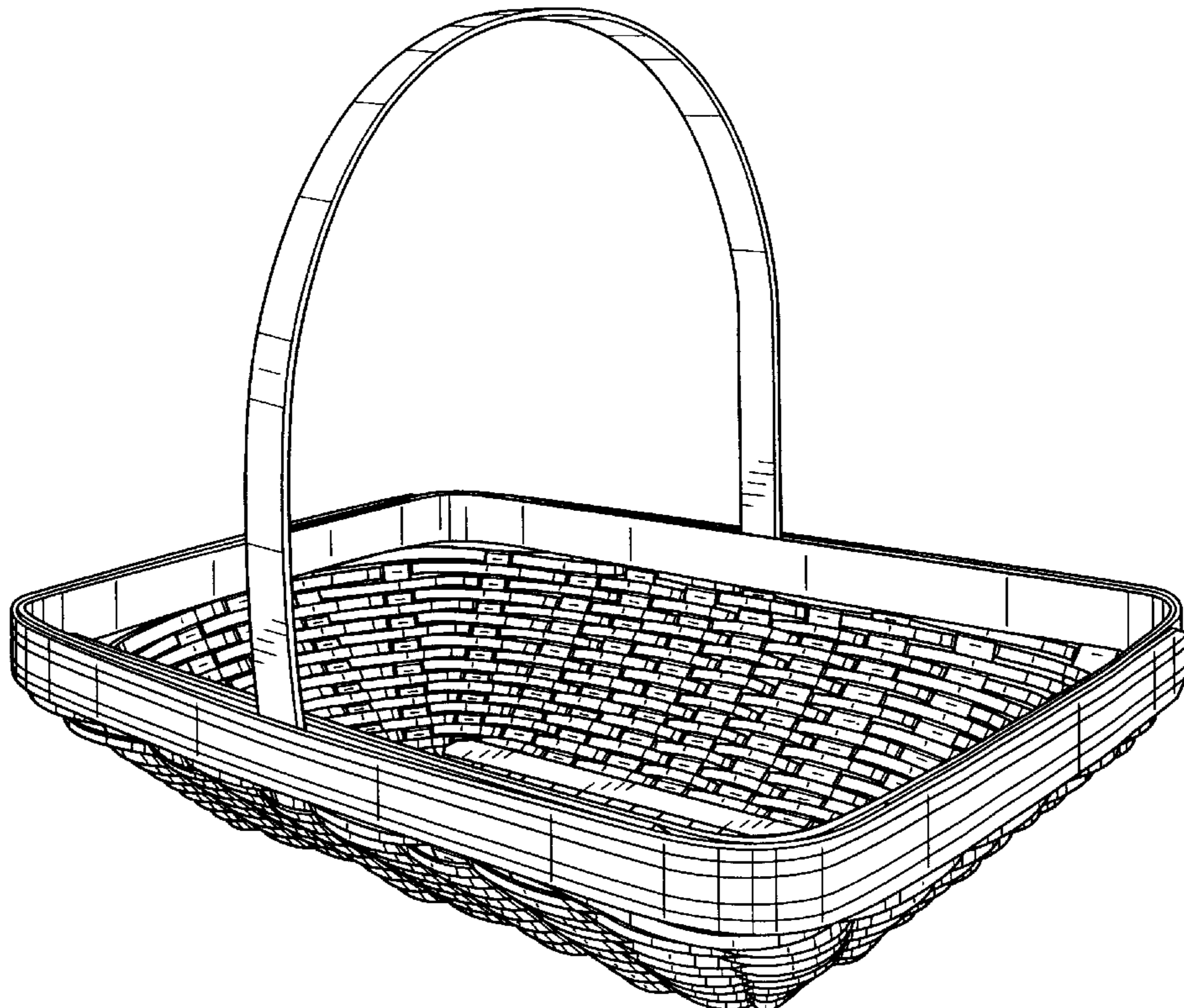
FIG. 6 is a top view thereof;

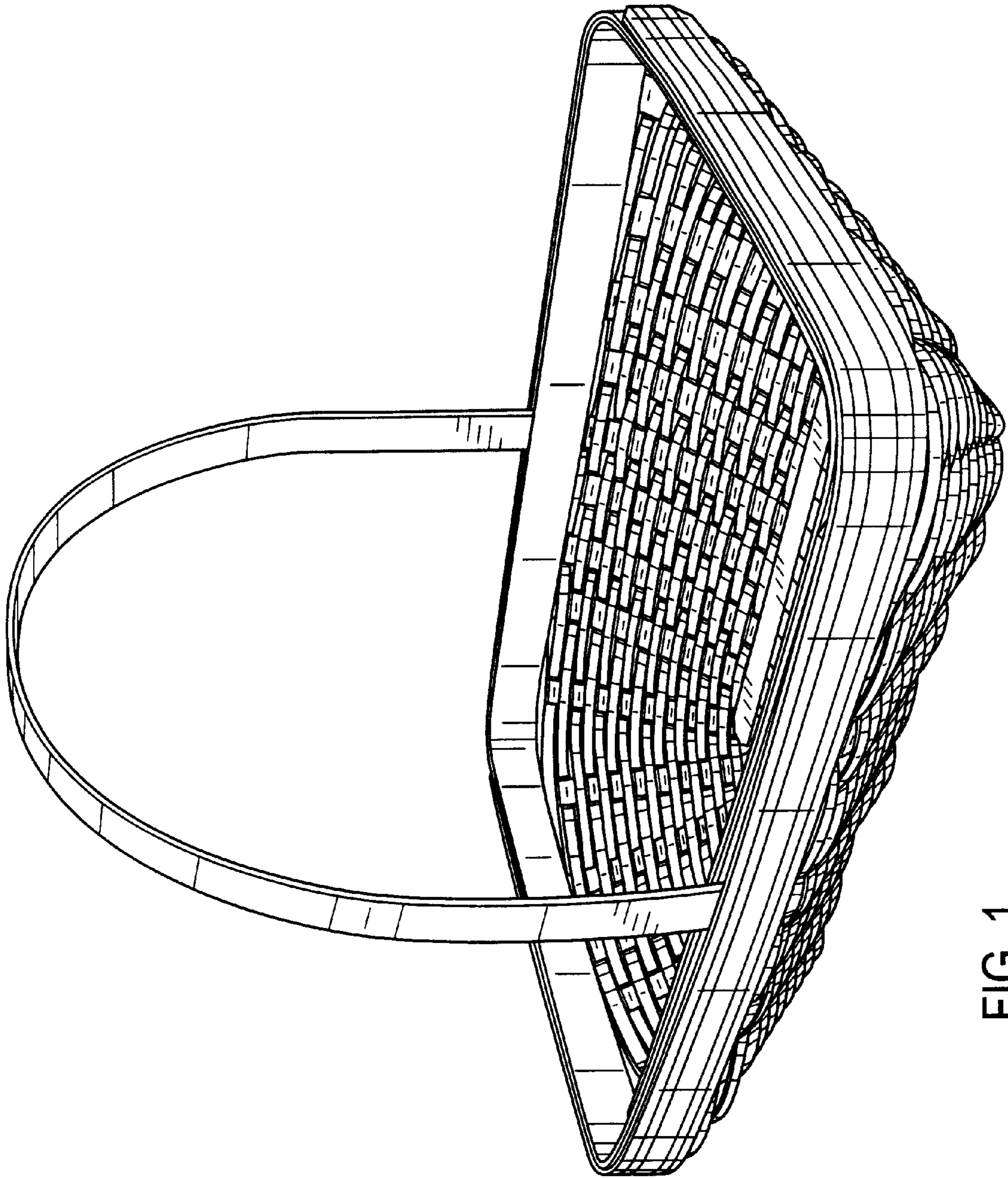

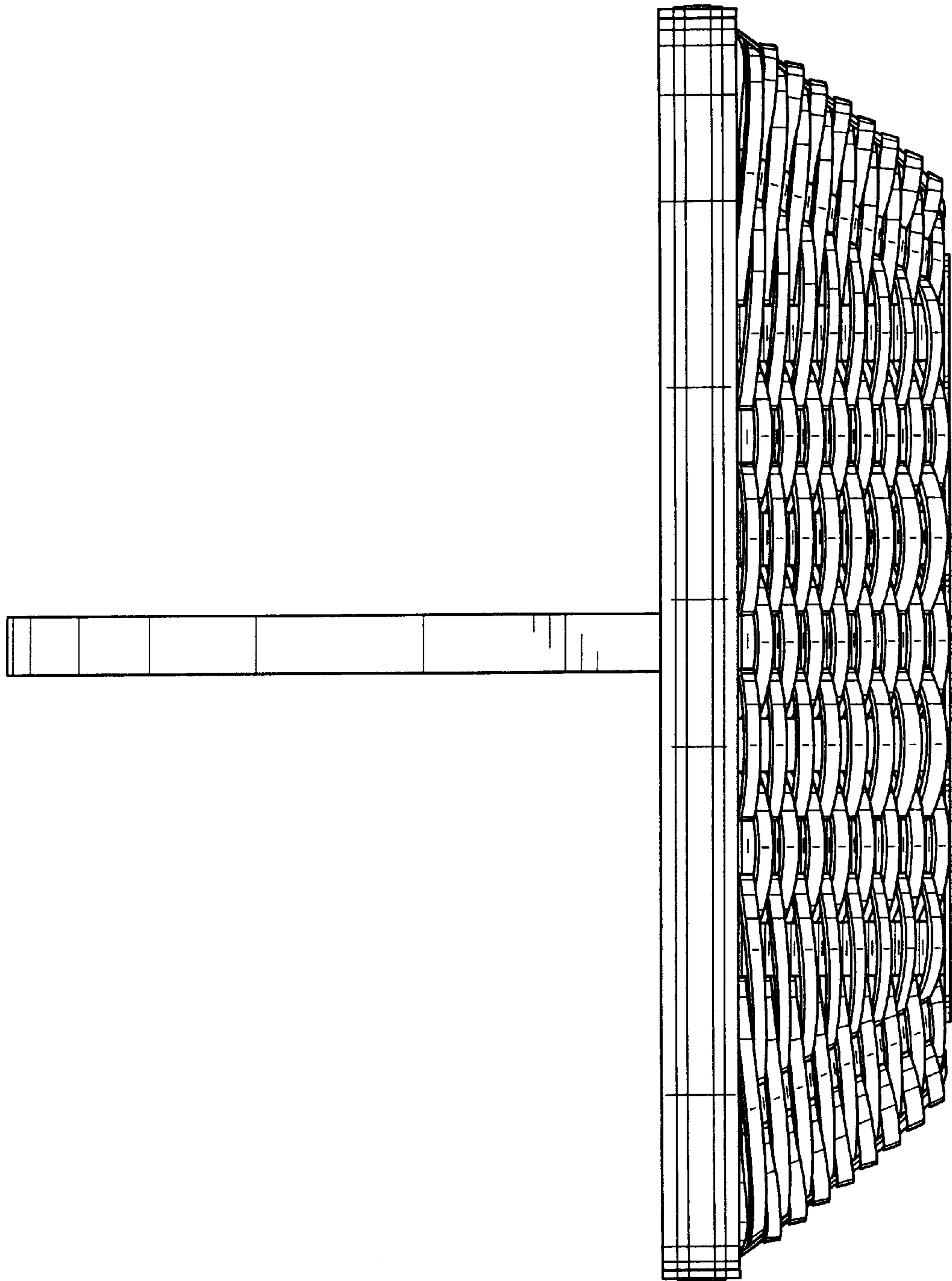

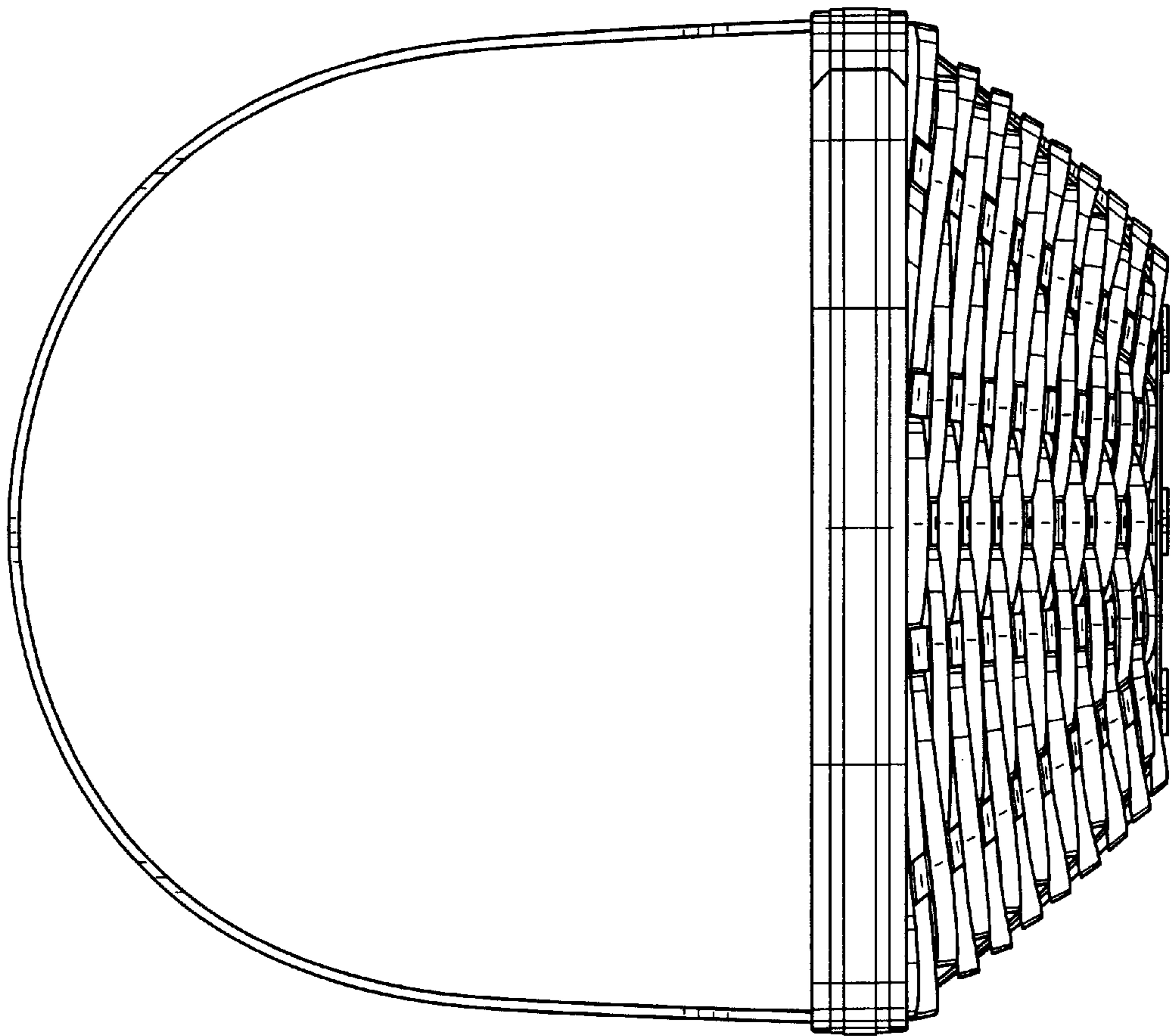

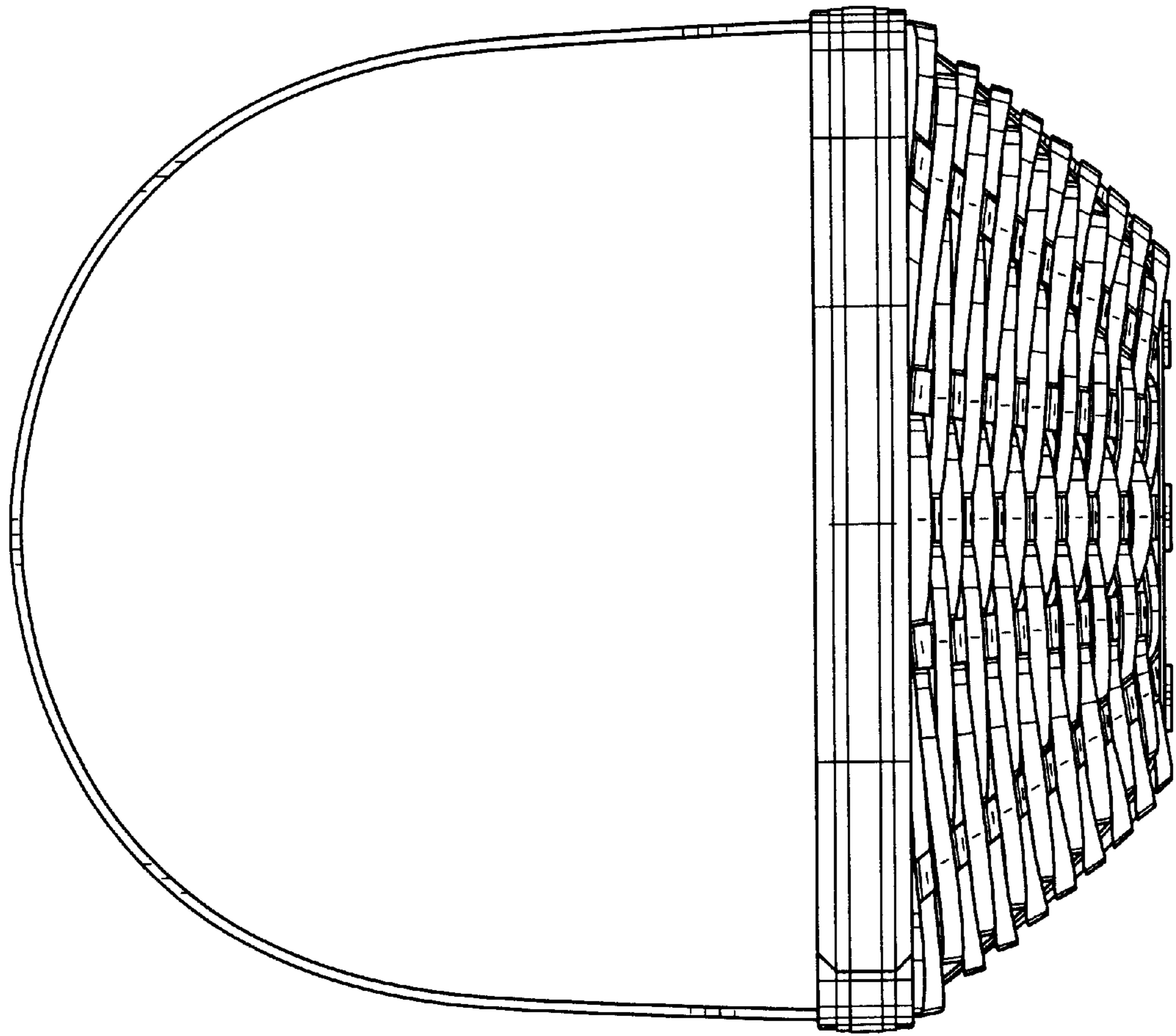

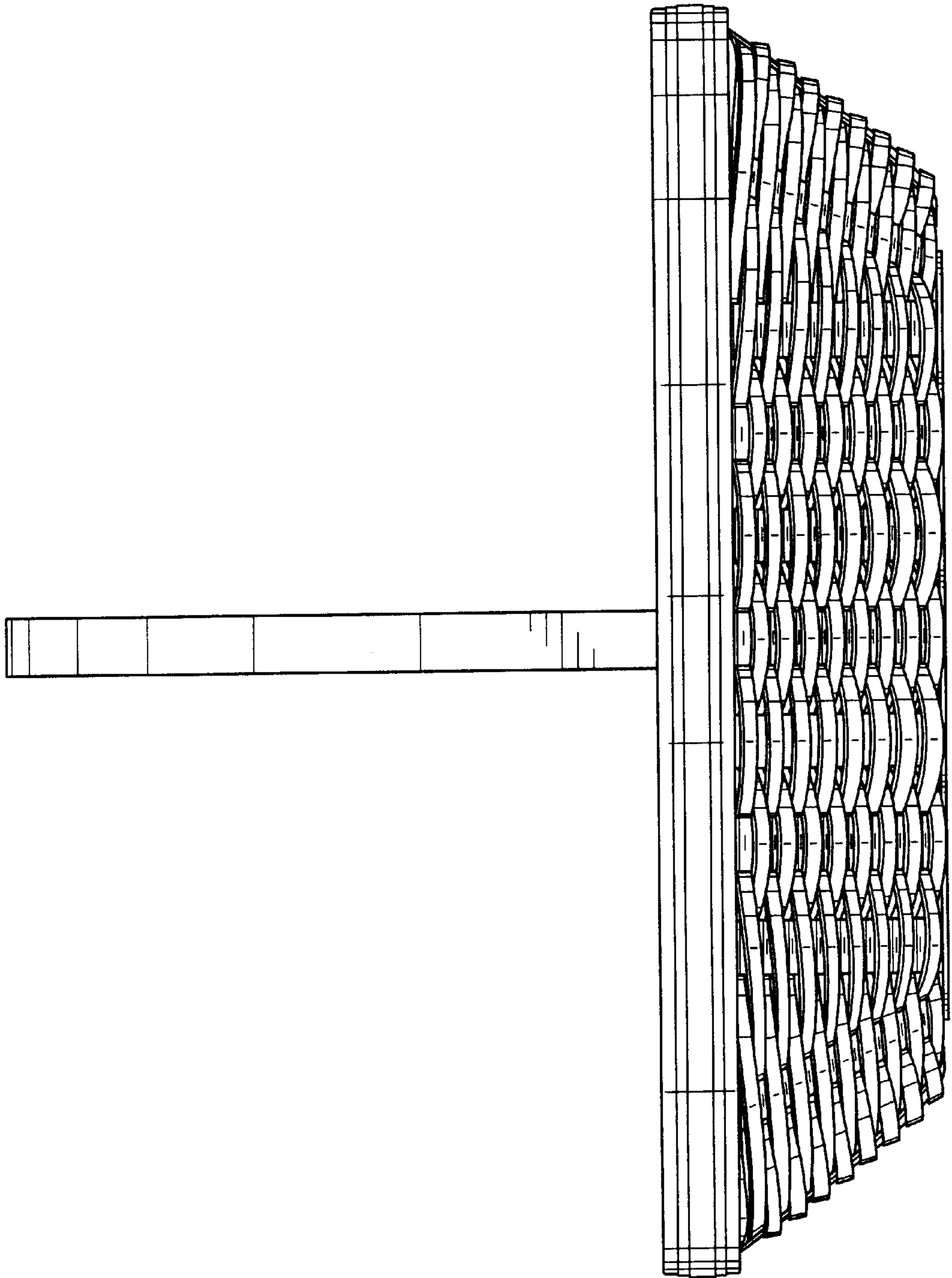

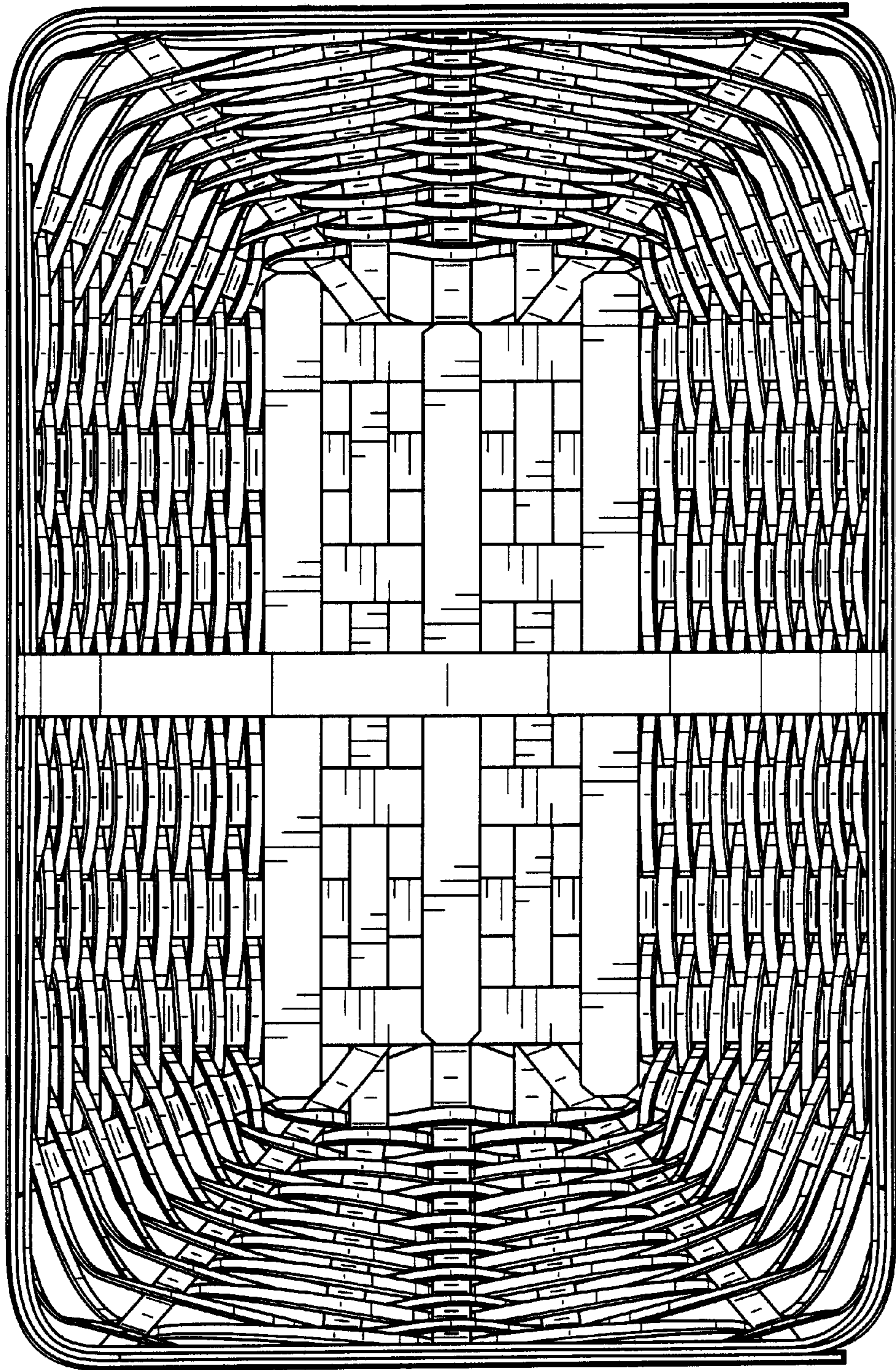

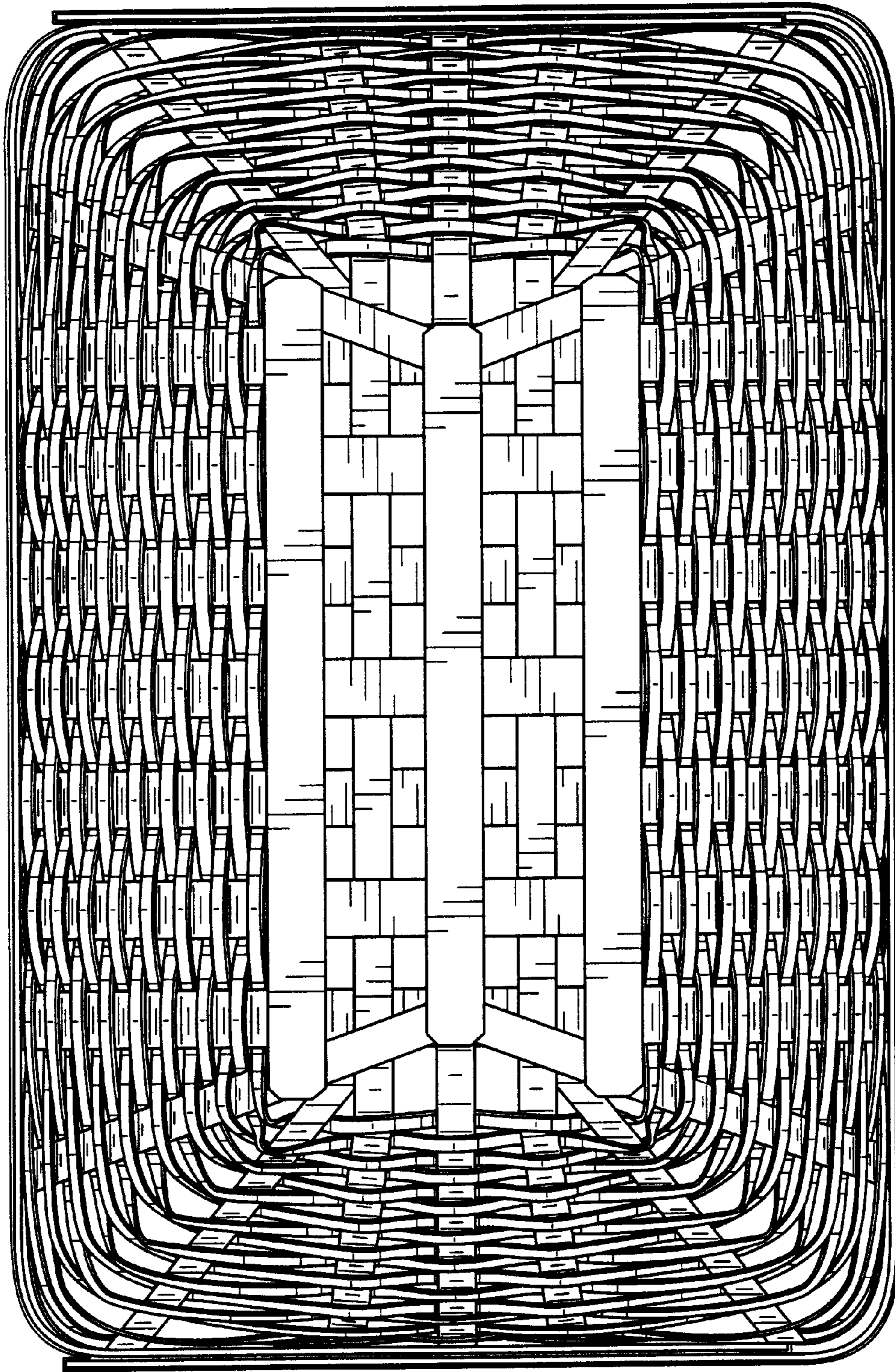

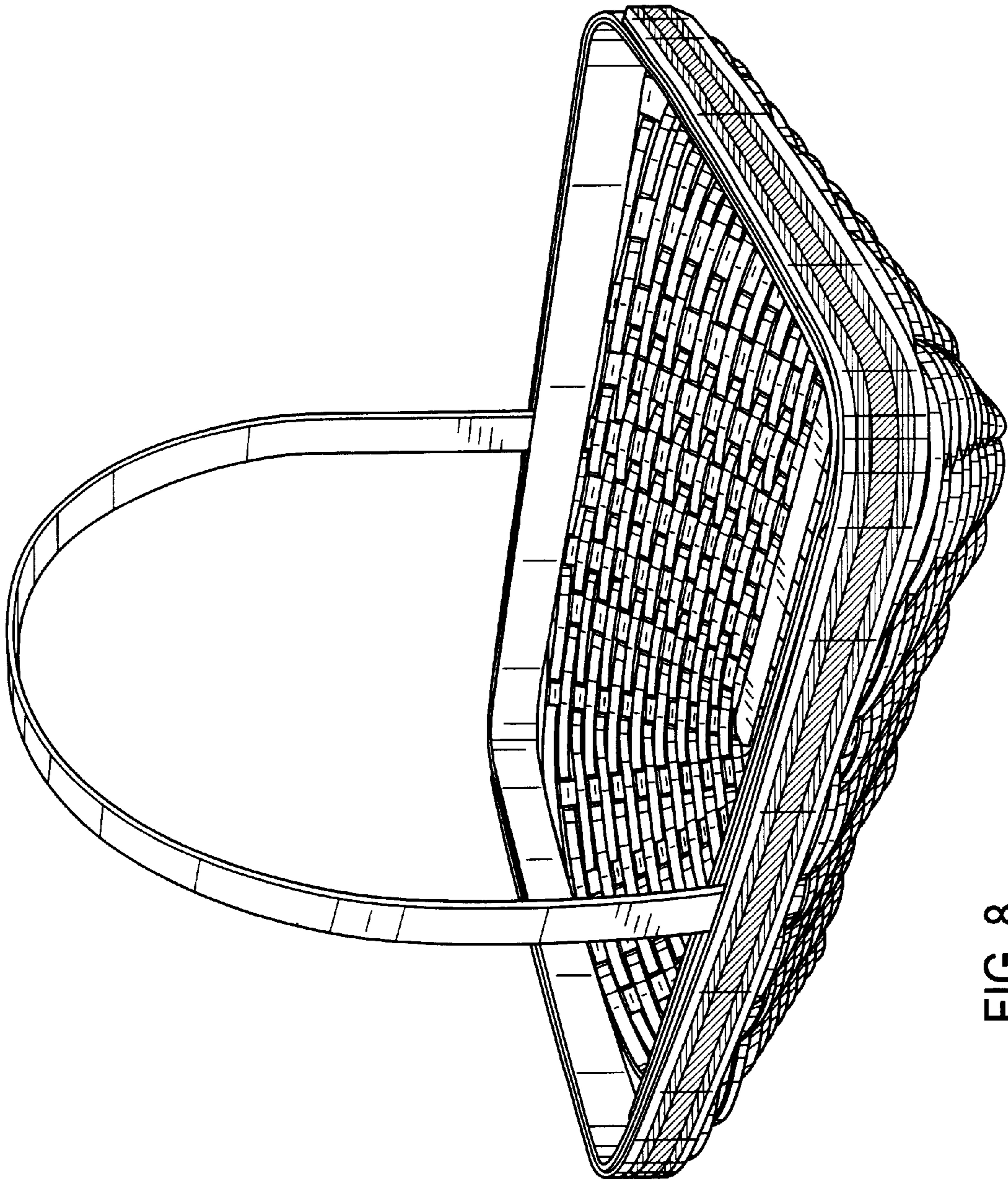

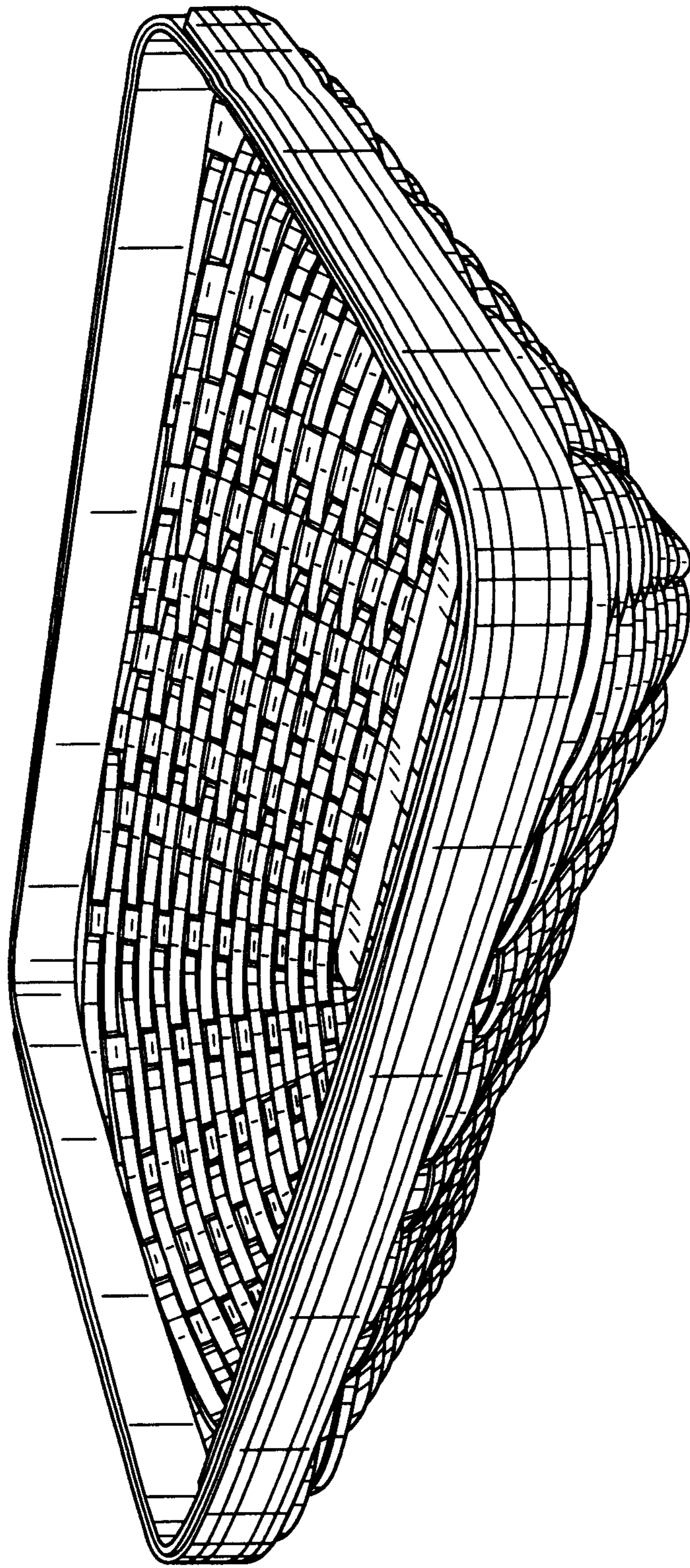
