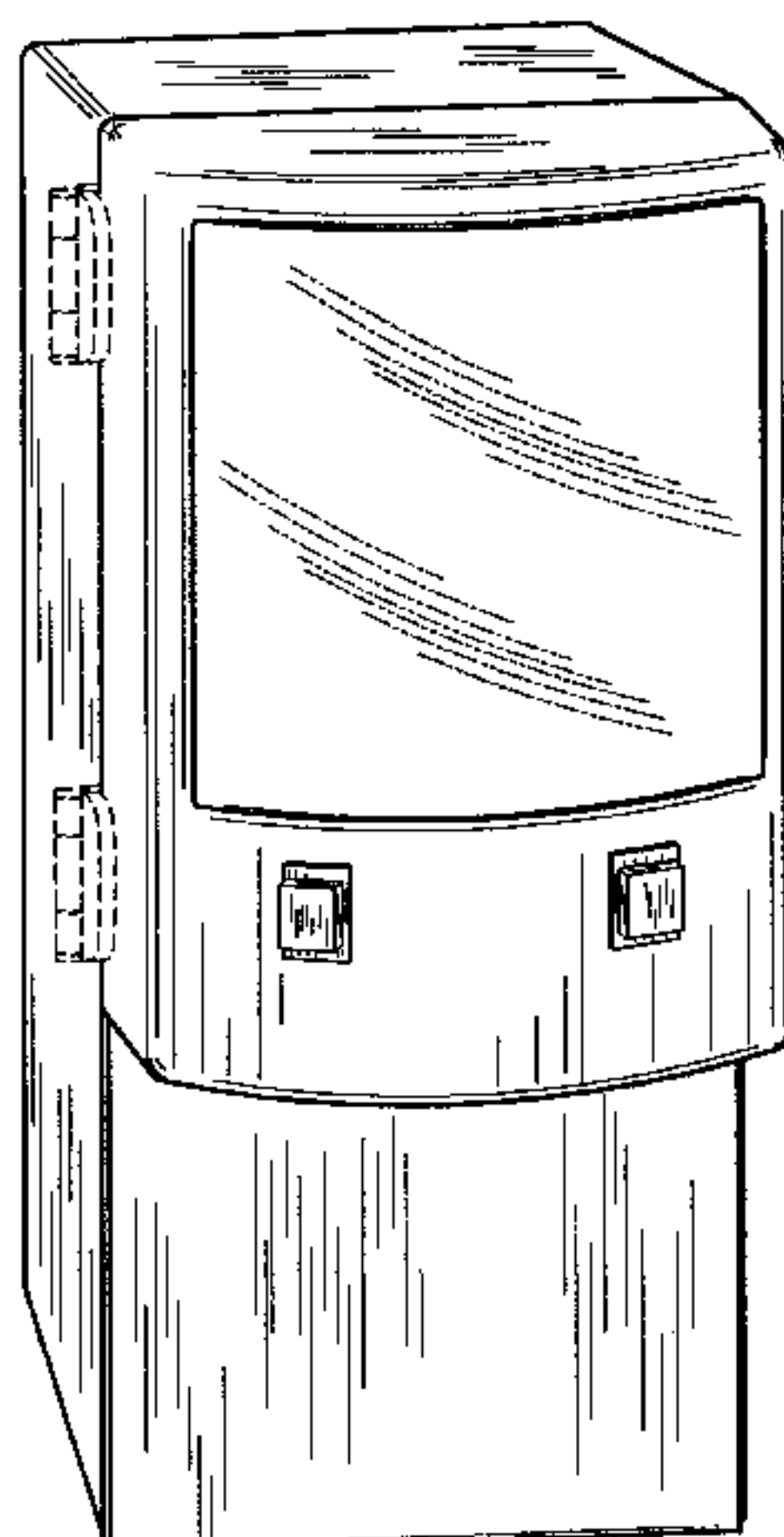
(57) **CLAIM**

I claim the ornamental design for powder dispenser, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the powder dispenser of my new design;

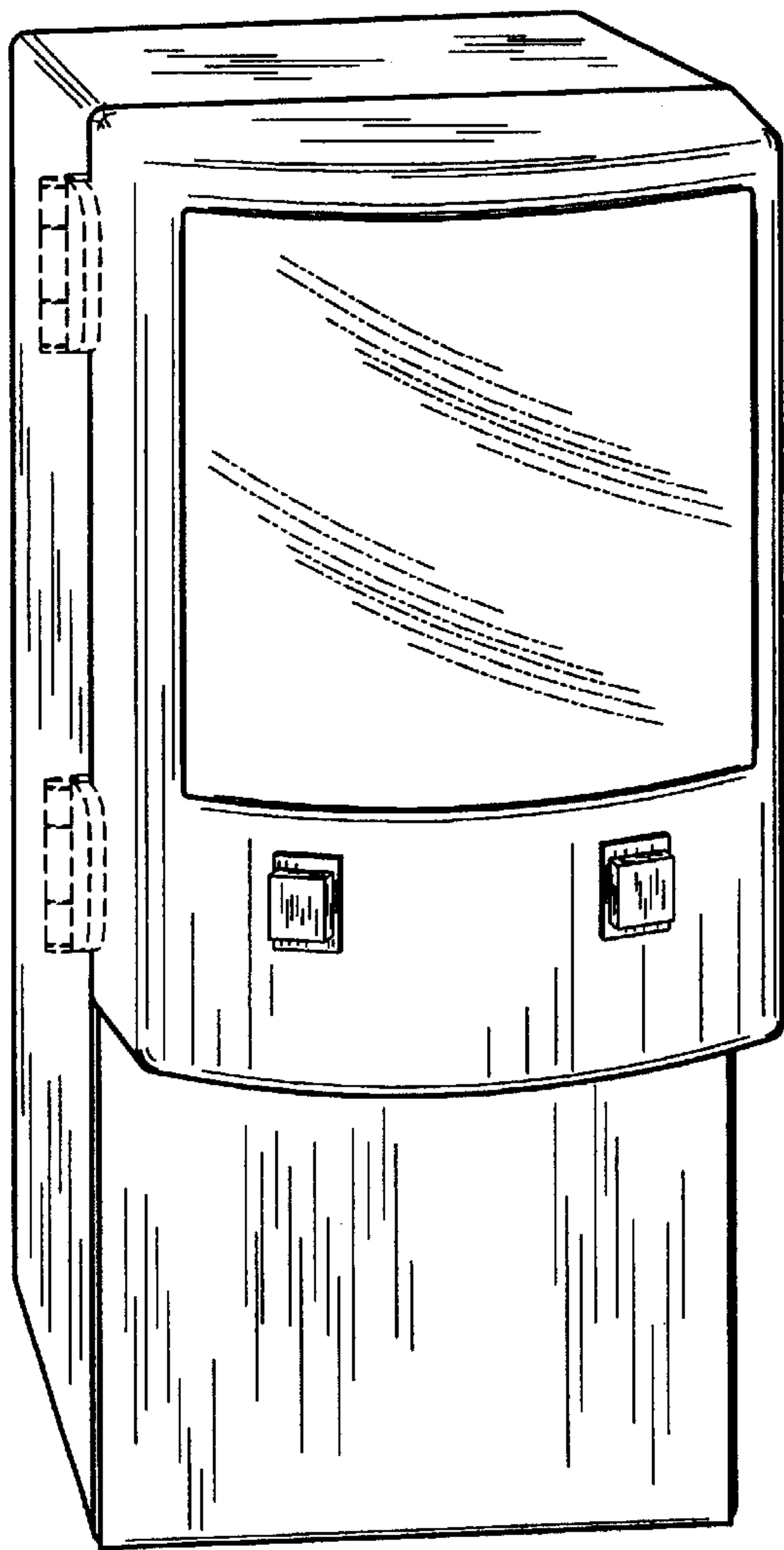

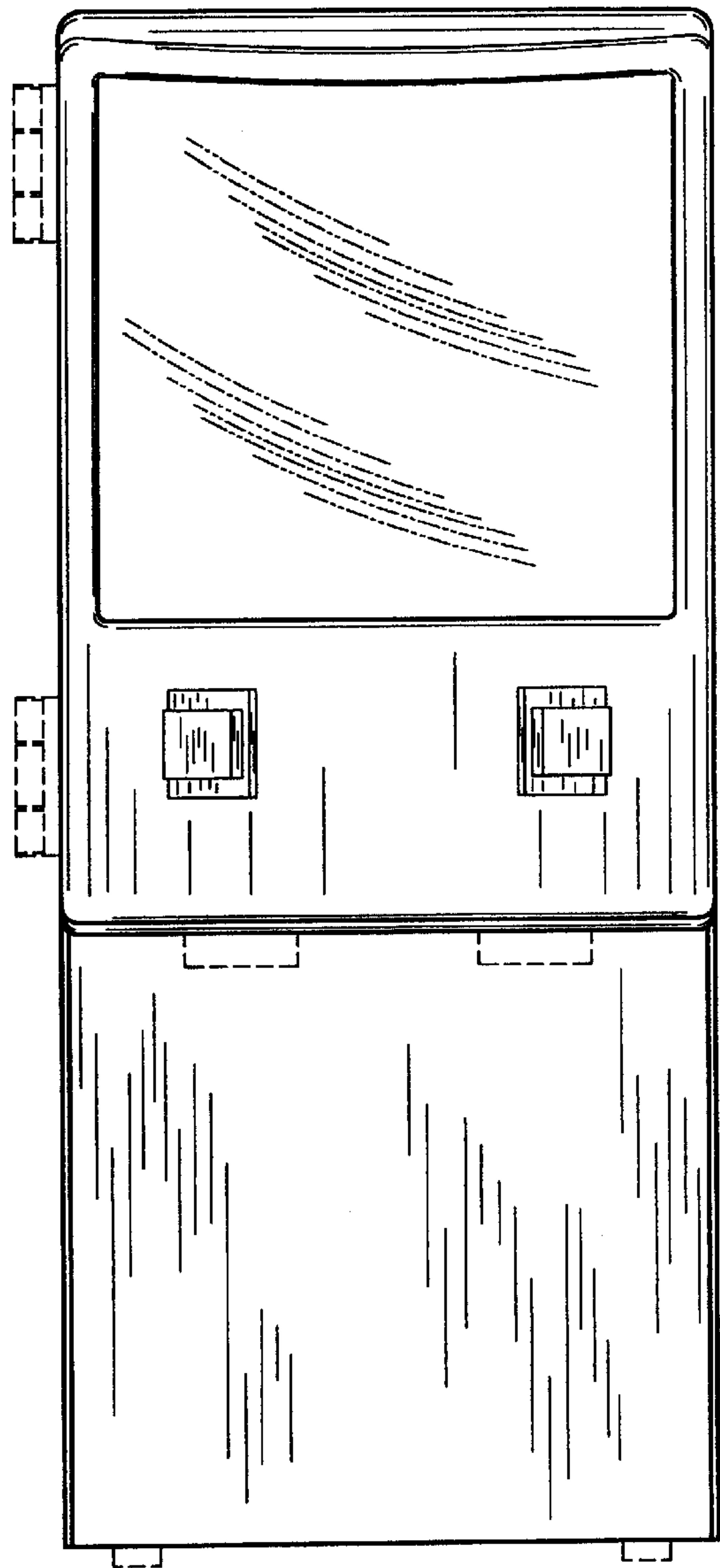

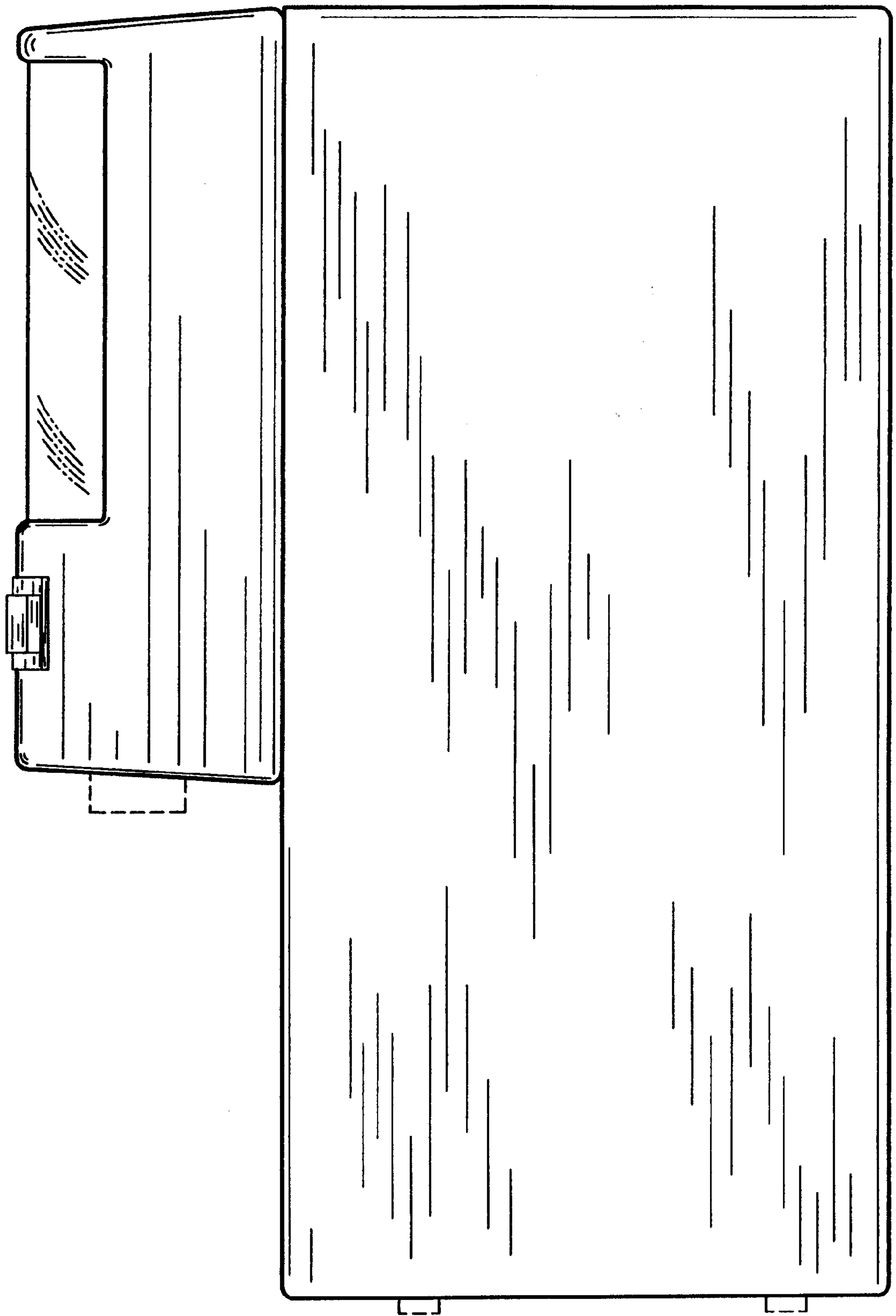

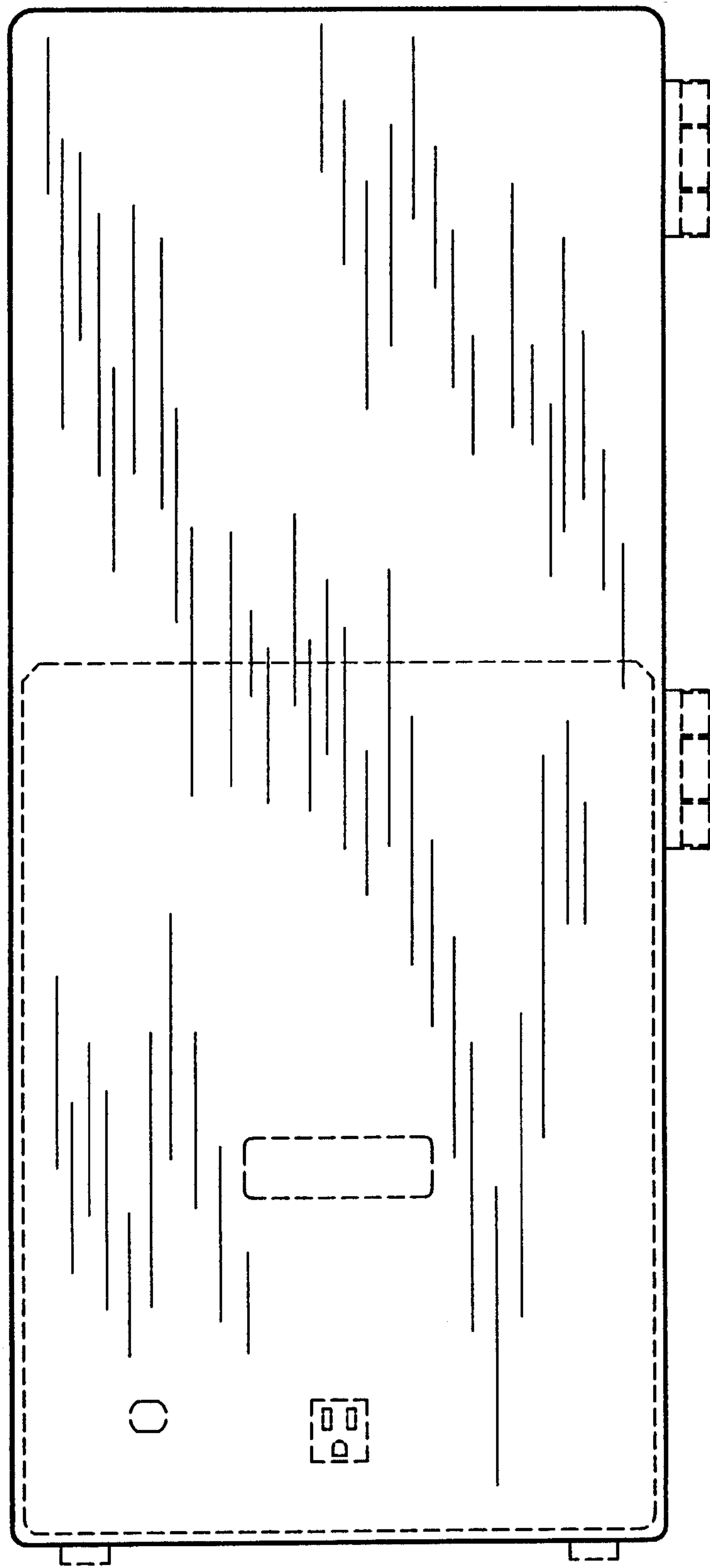

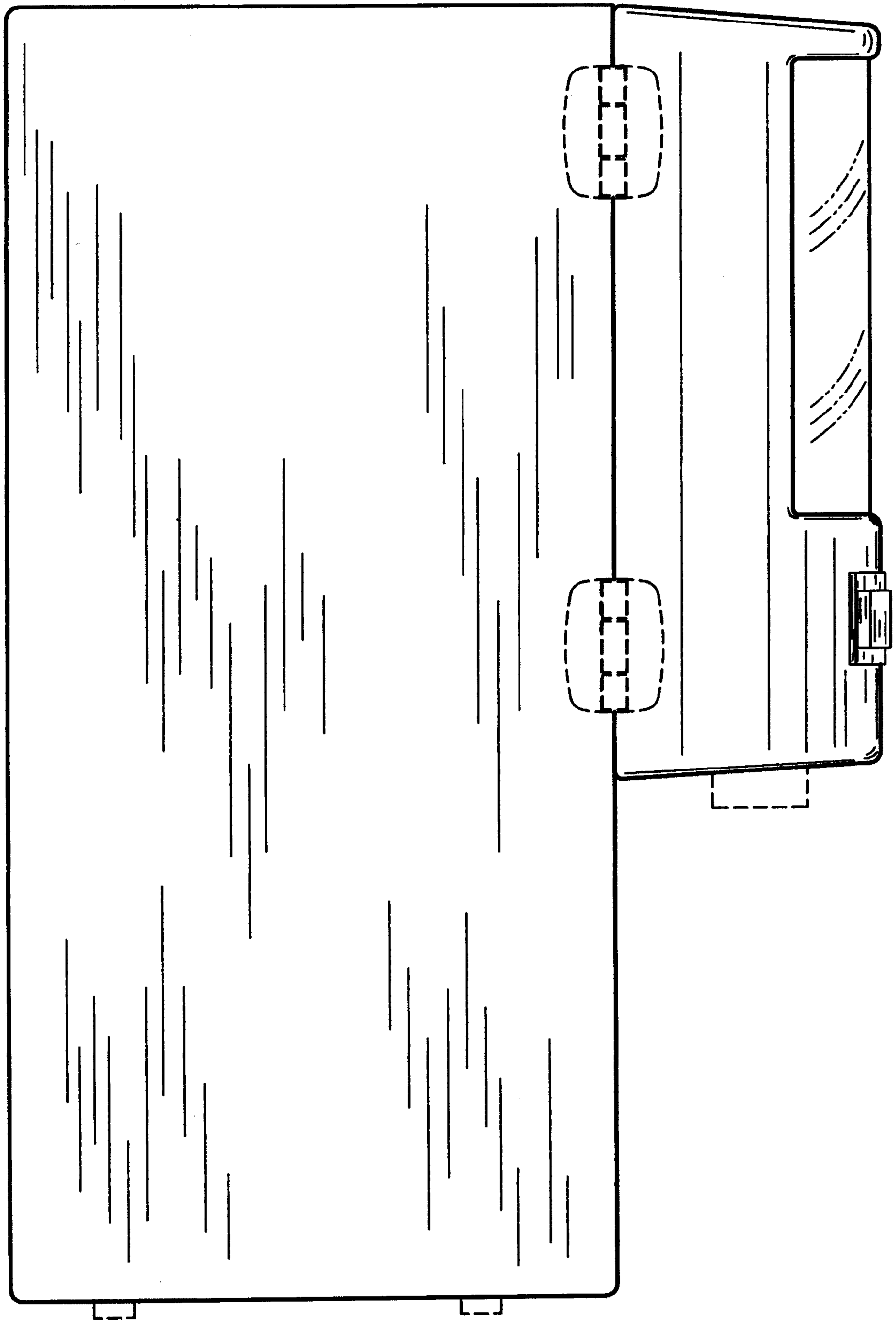

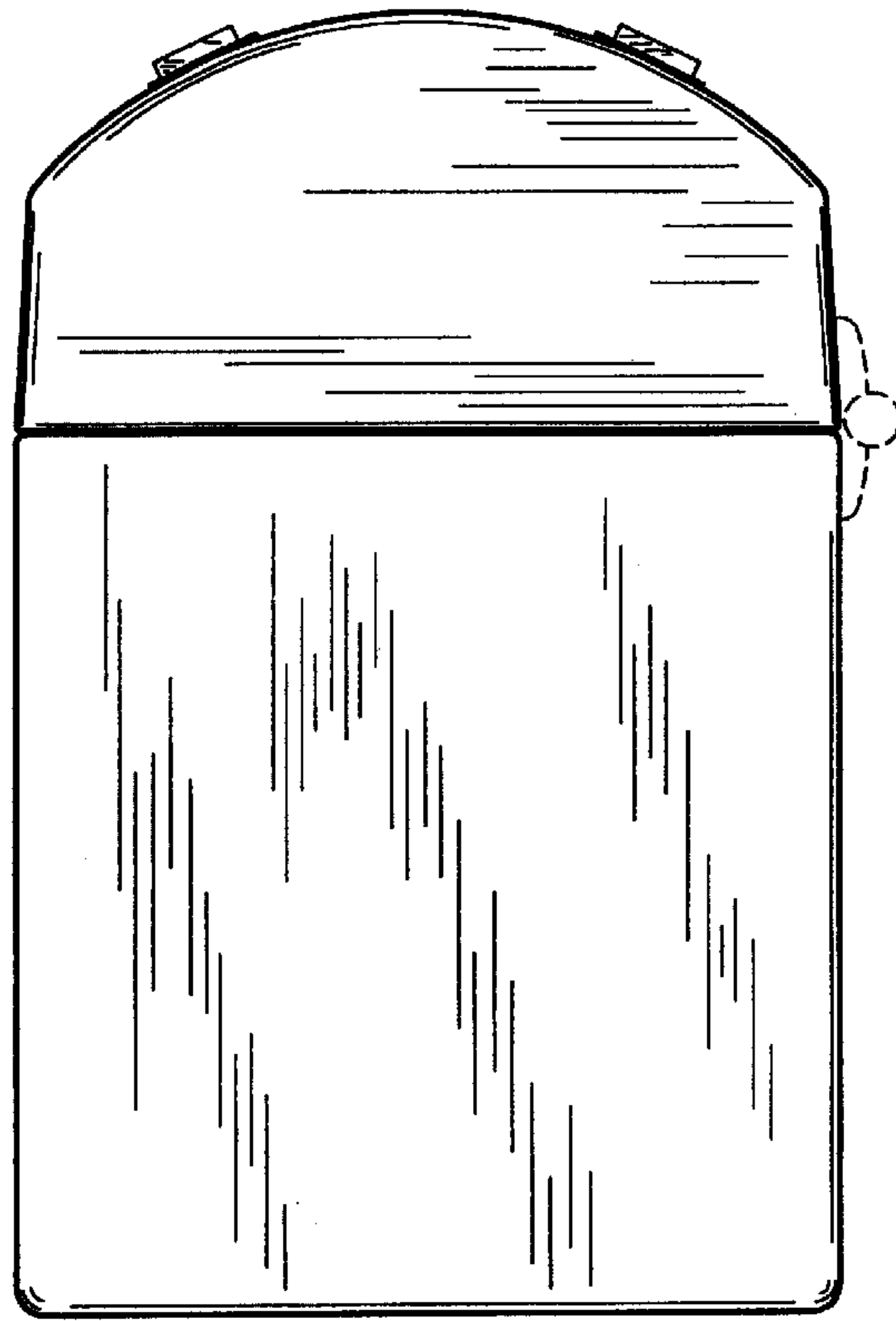

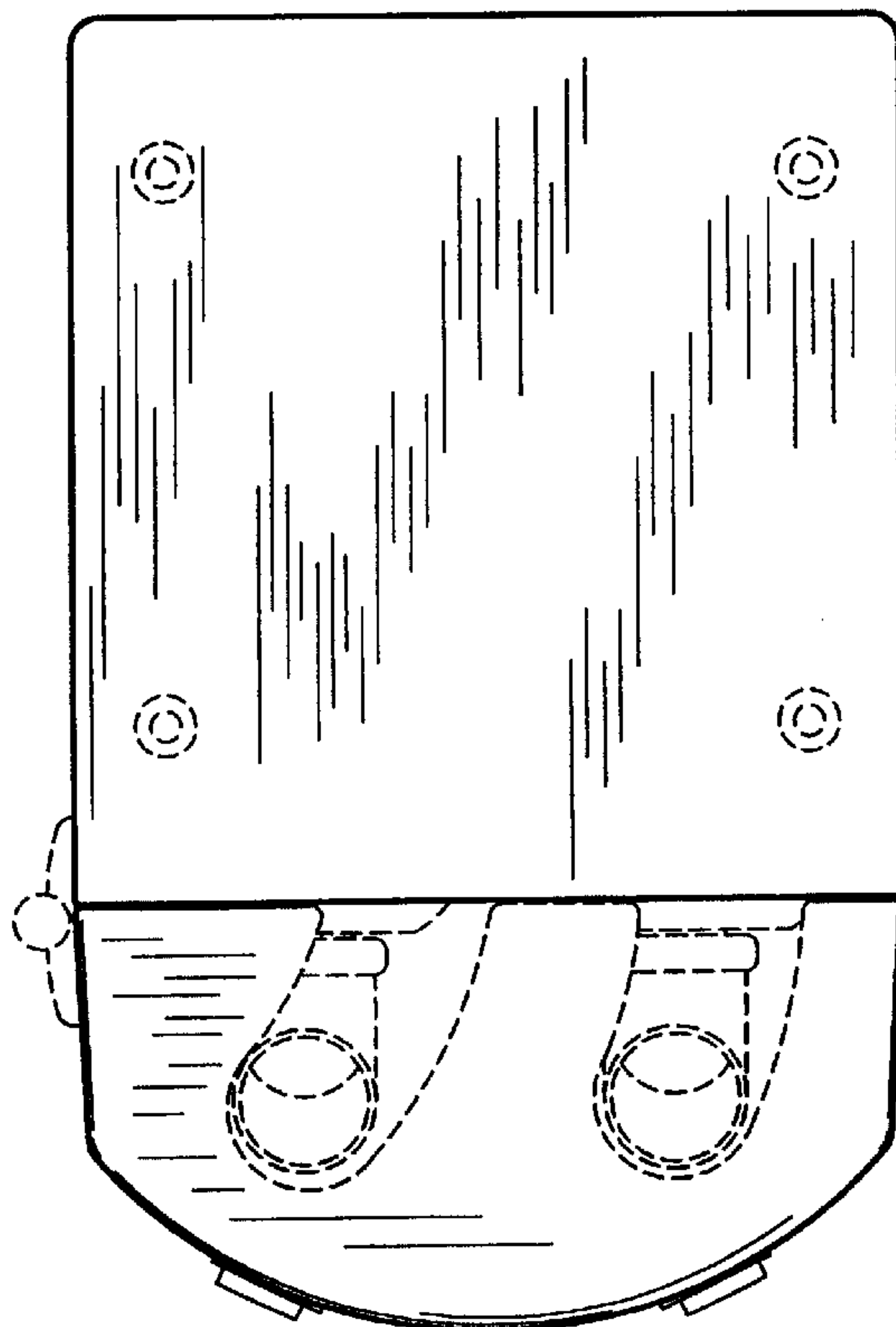
