This Design Patent Application is related to concurrently filed U.S. Design patent application No. 29/148,142, entitled "Mat with Pillow Portion and Body Portion."

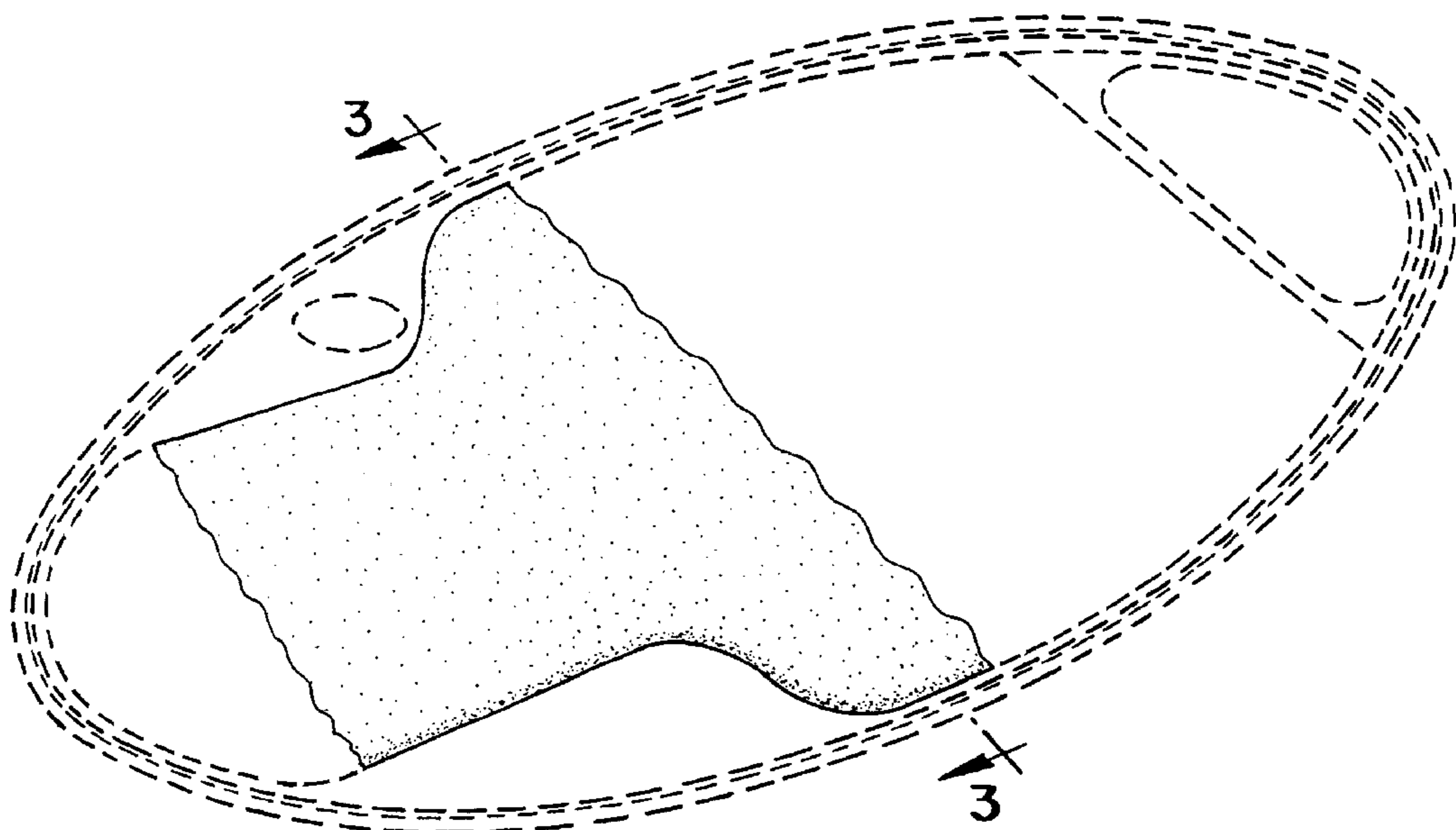

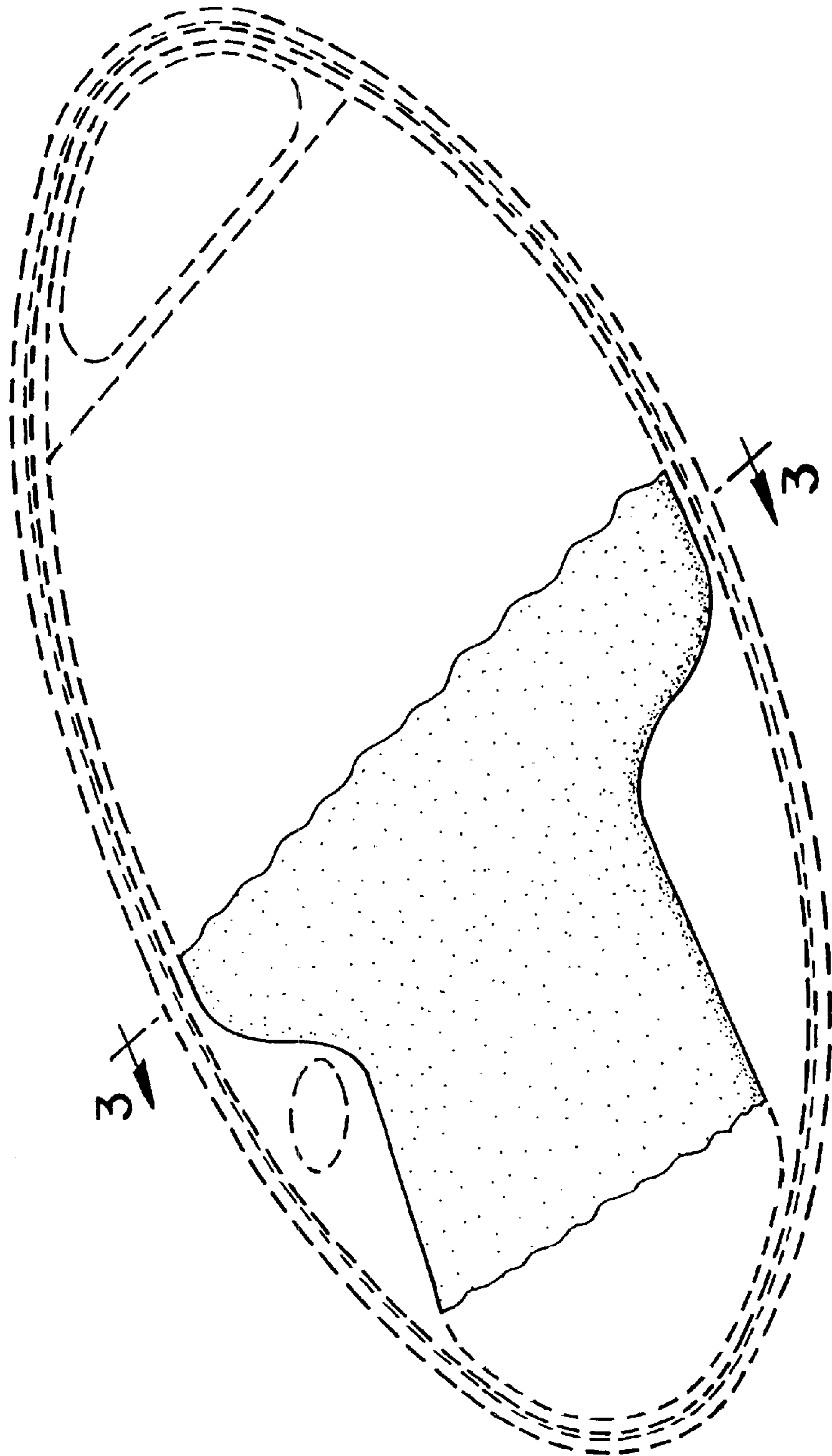

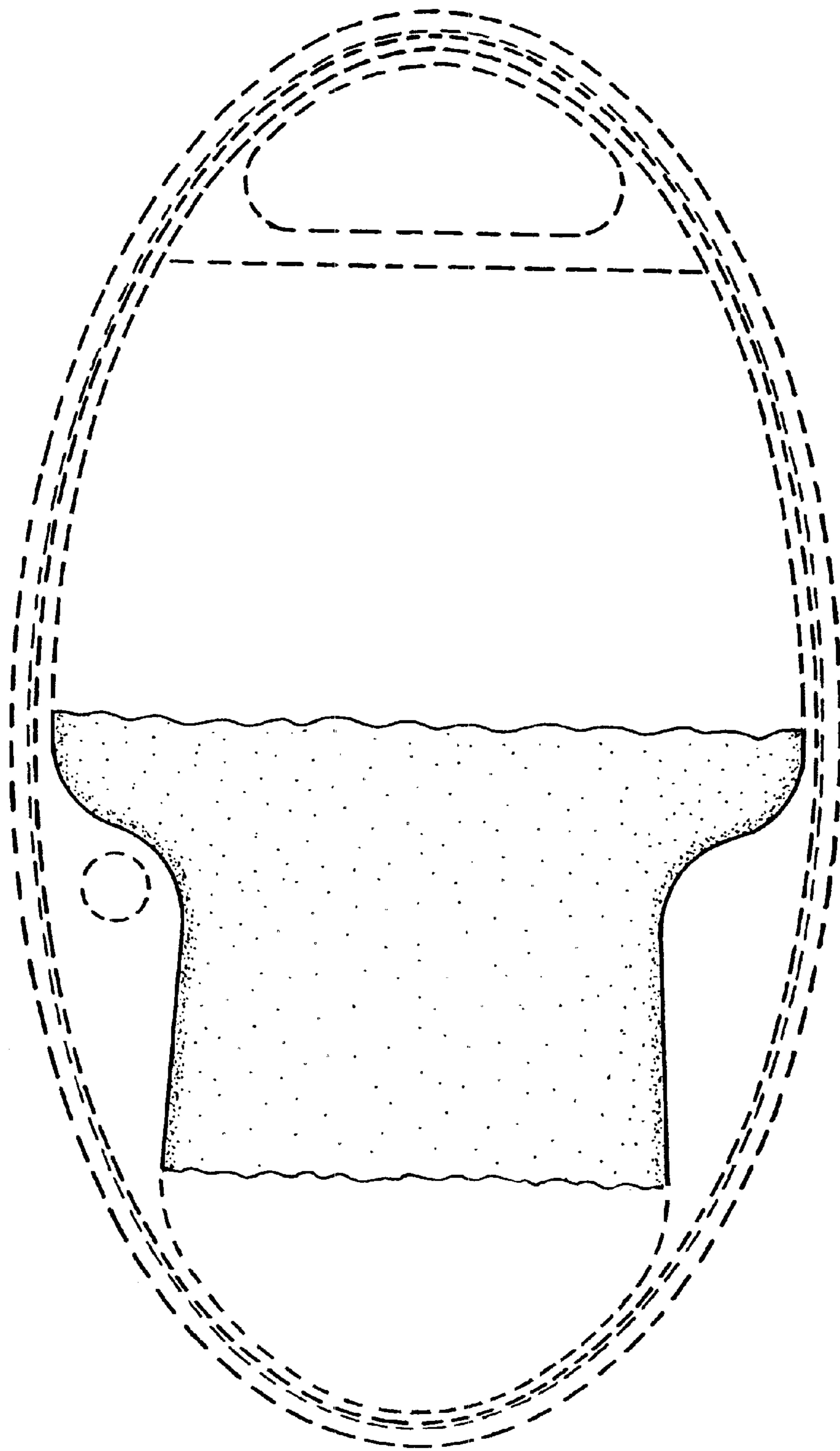
