(57) **CLAIM**

The ornamental design for a cooking utensil accessory, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a cooking utensil accessory;  
FIG. 2 is a top plan view of the cooking utensil accessory shown in FIG. 1;  
FIG. 3 is a front elevational view of the cooking utensil accessory of FIG. 1, the rear, left side and right side elevational views being identical to FIG. 3;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a sectional view taken at arrows 5—5 of FIG. 2 and looking in the direction of the arrows.

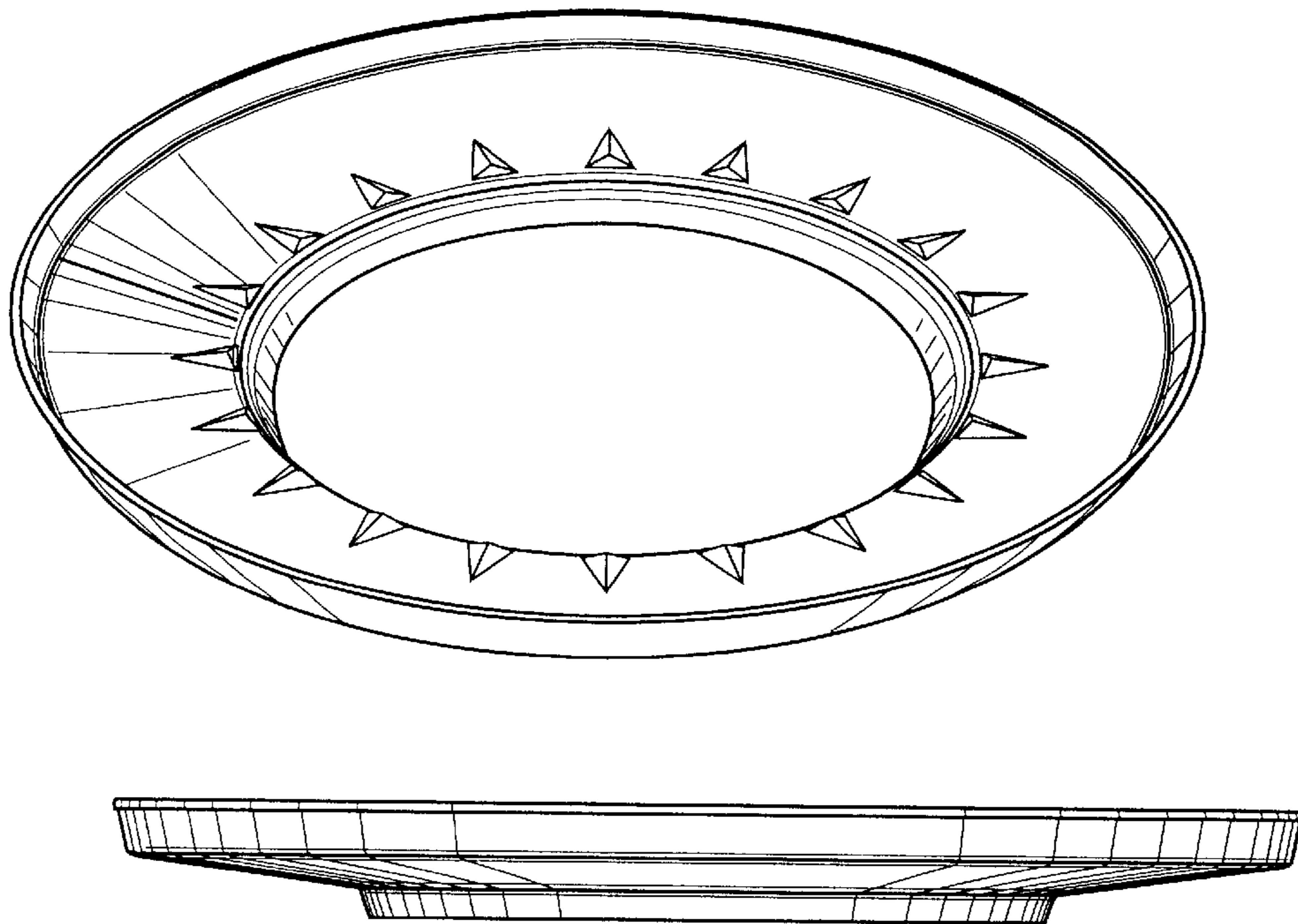

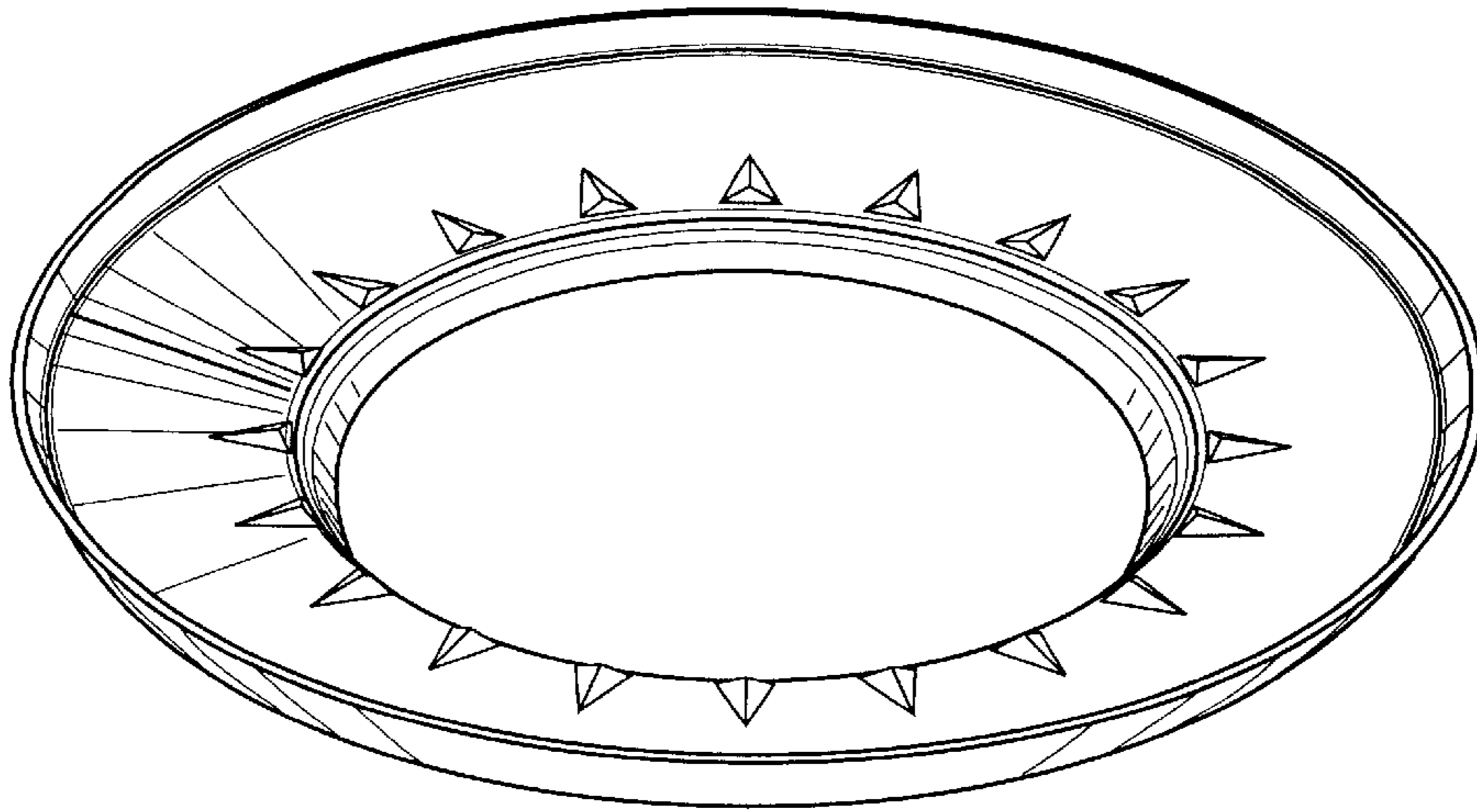

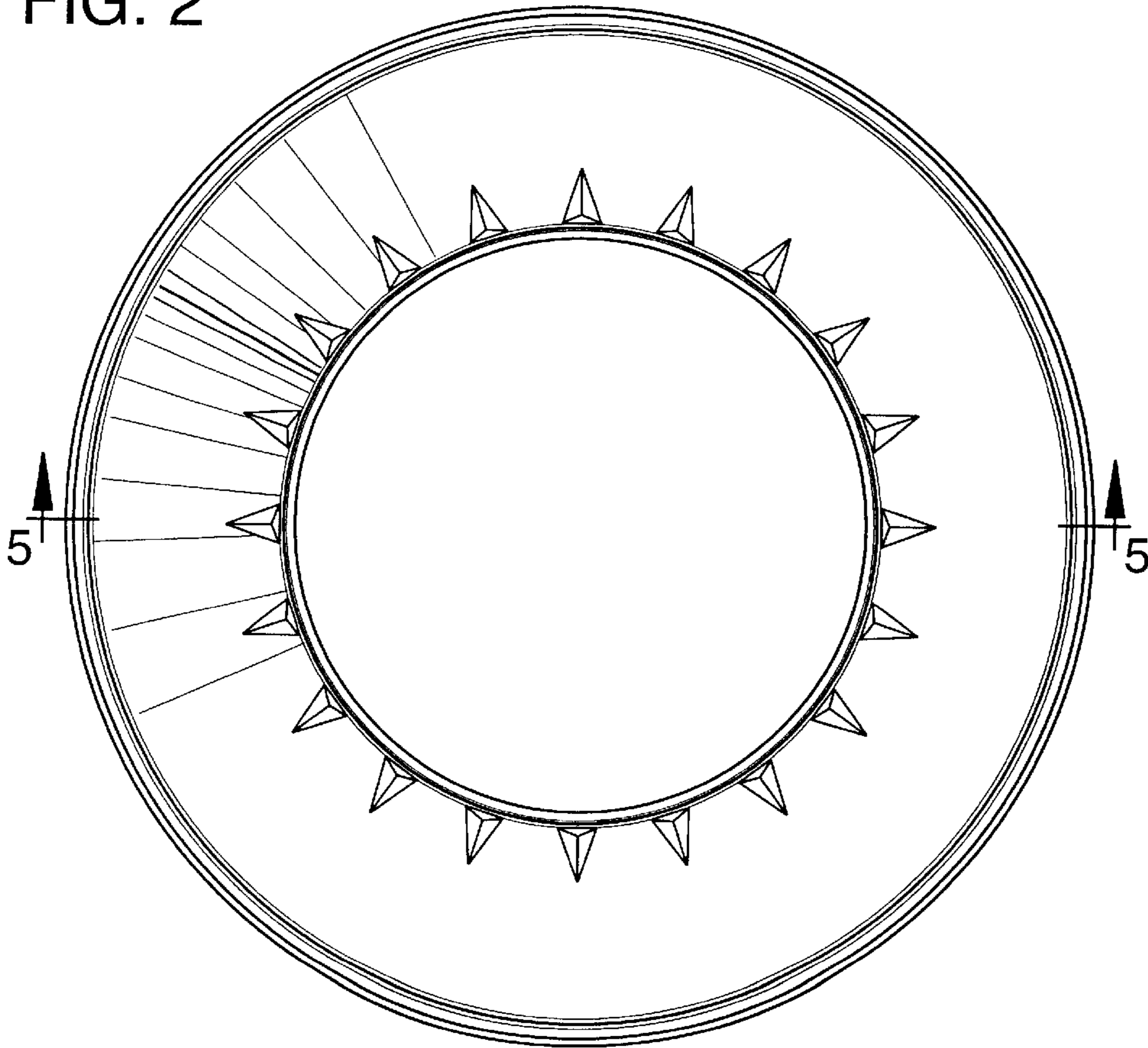

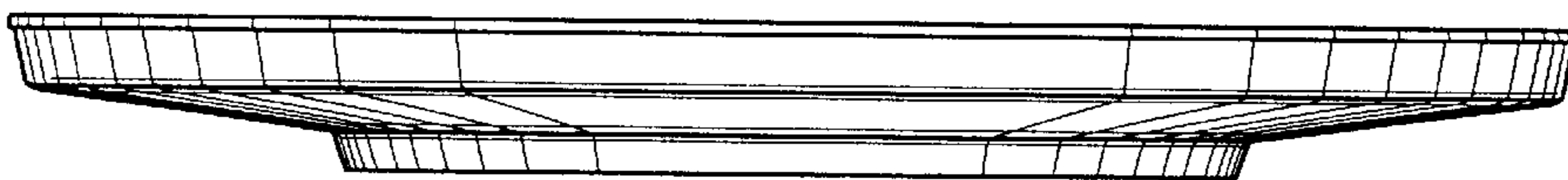

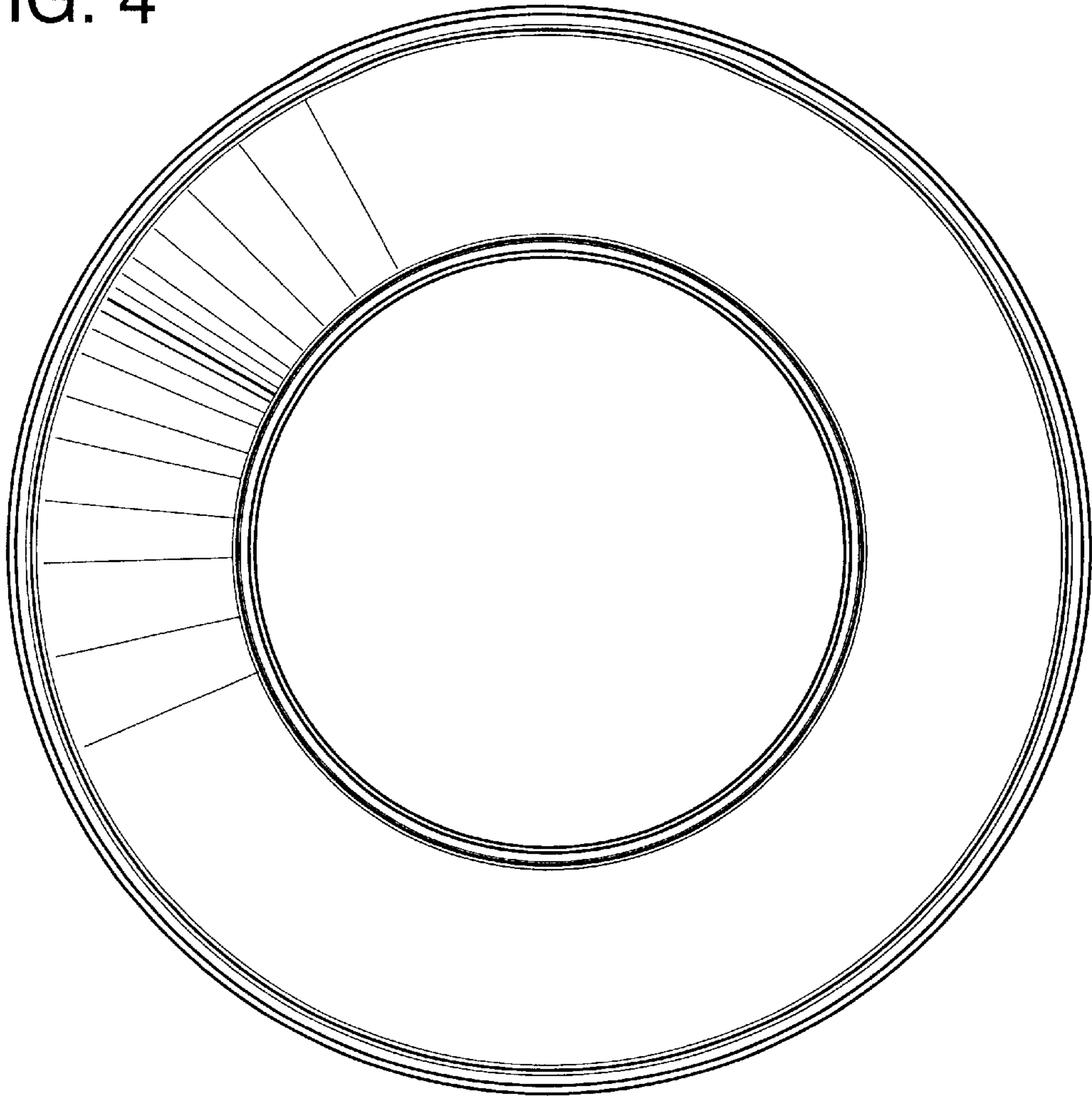
