FIG. 10 is a bottom plan view of the present invention of FIG. 8.

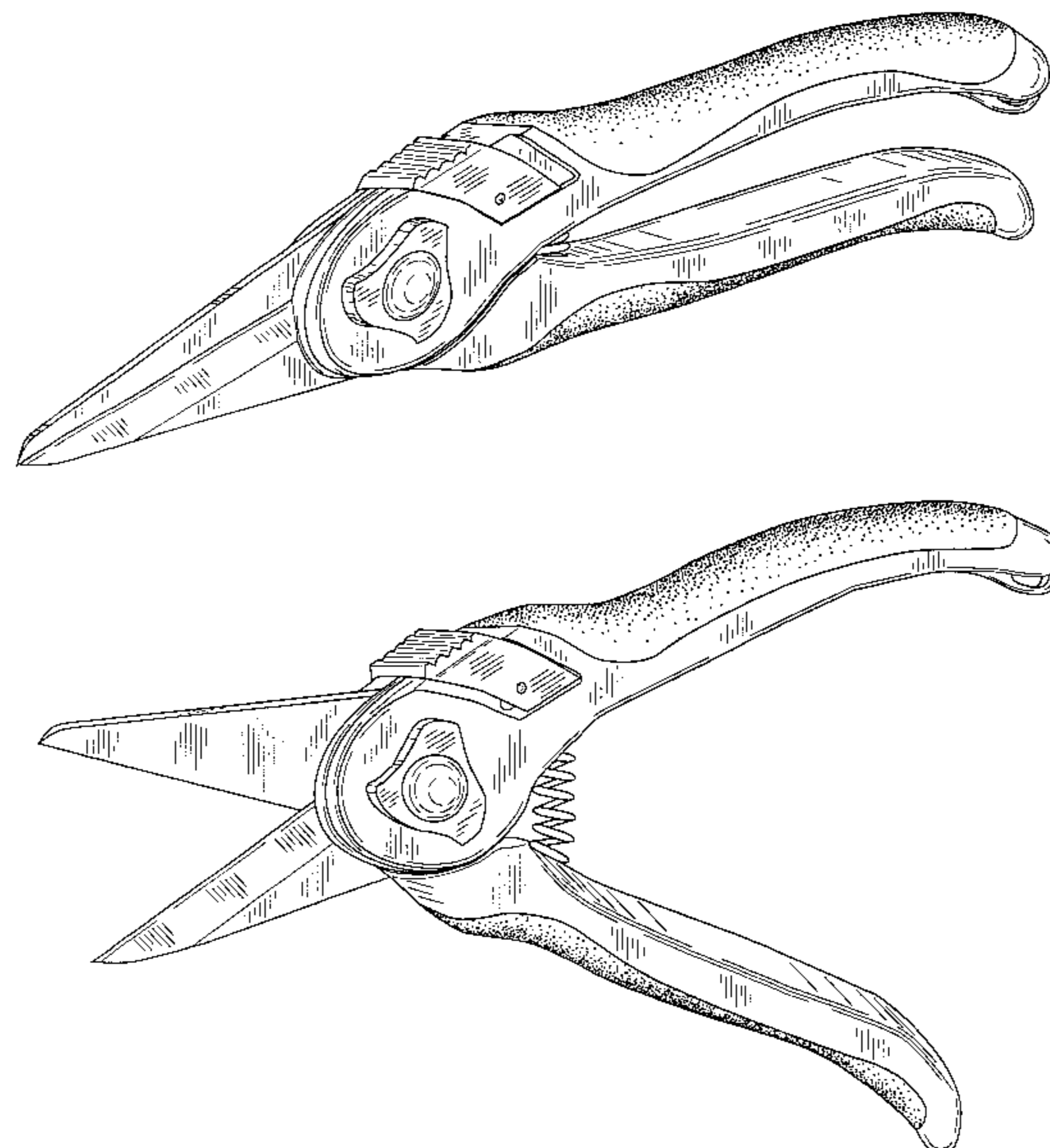
FIG. 11 is a front elevational view of the present invention of FIG. 8.

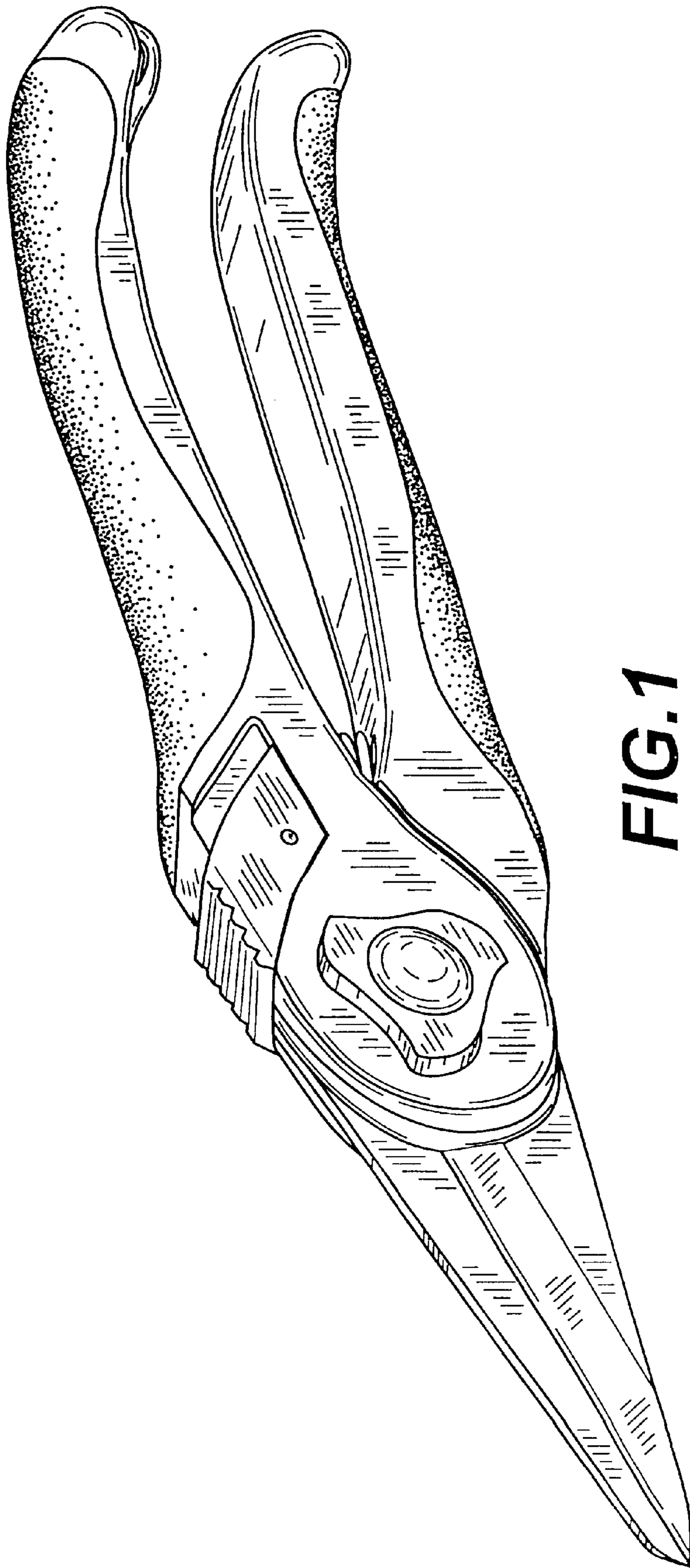

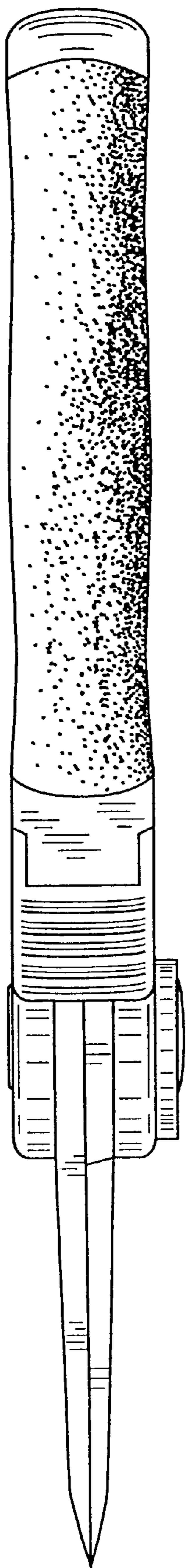

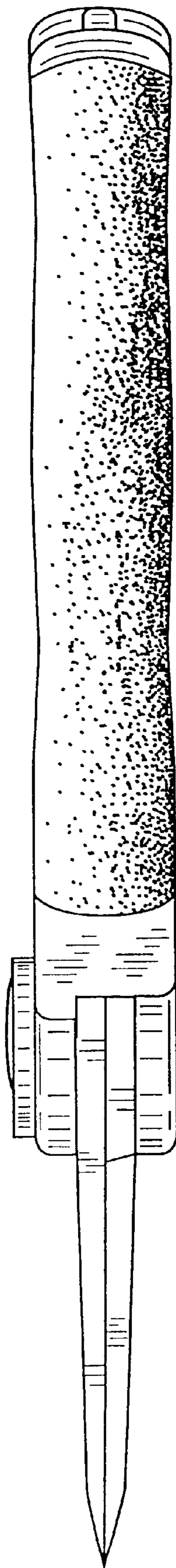

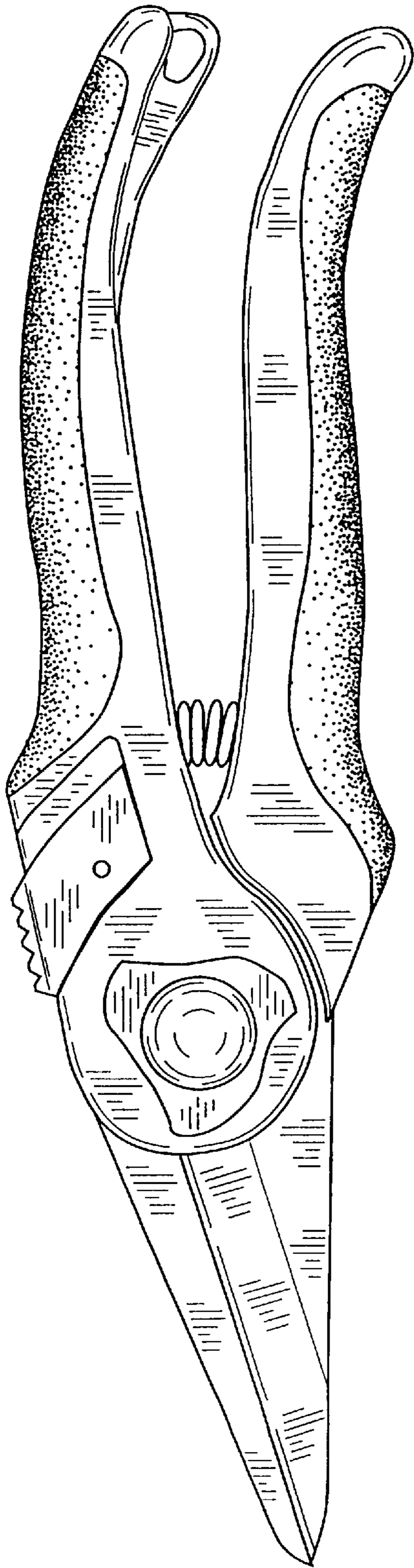

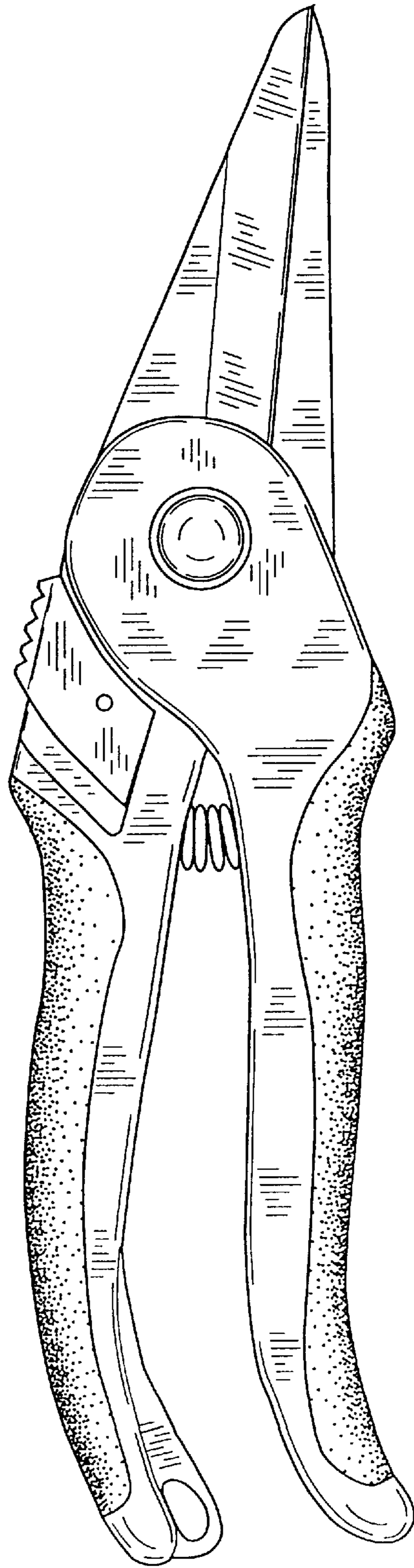

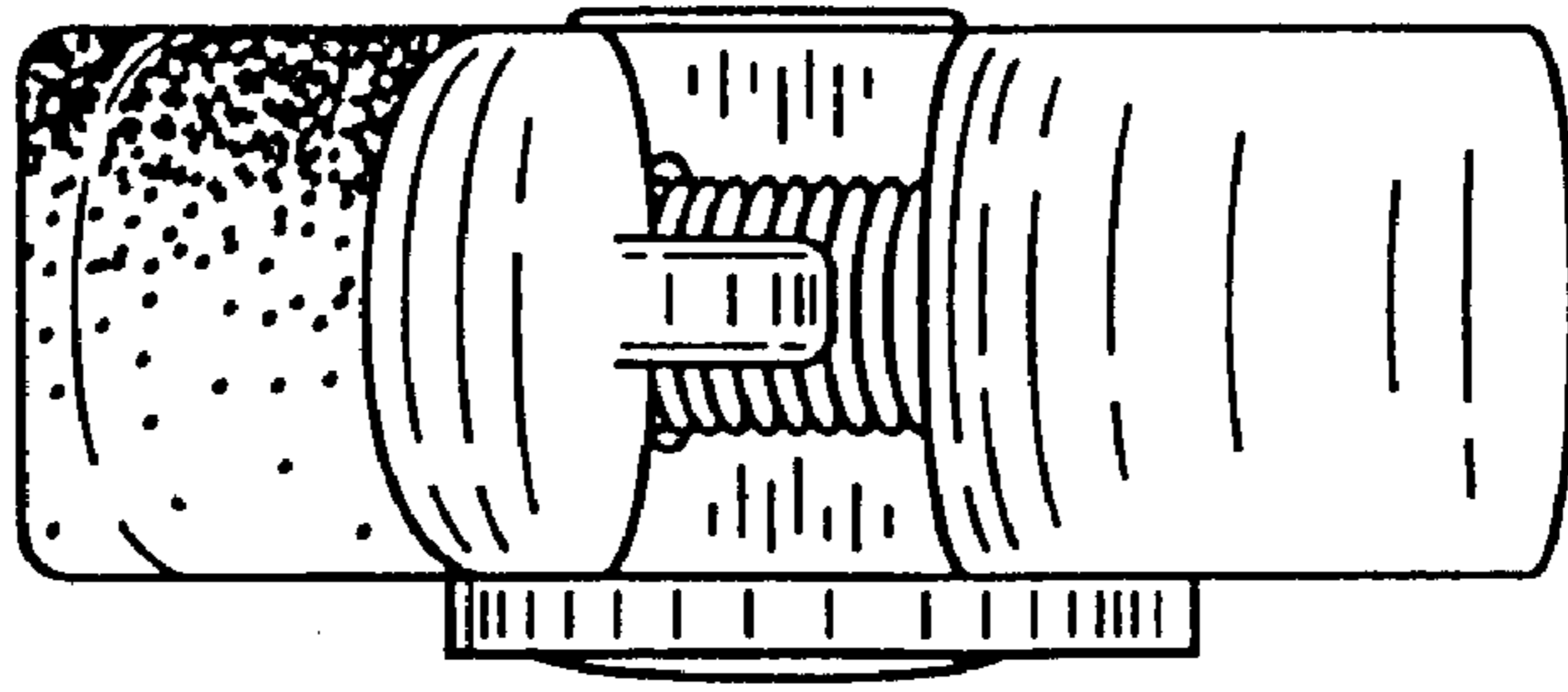

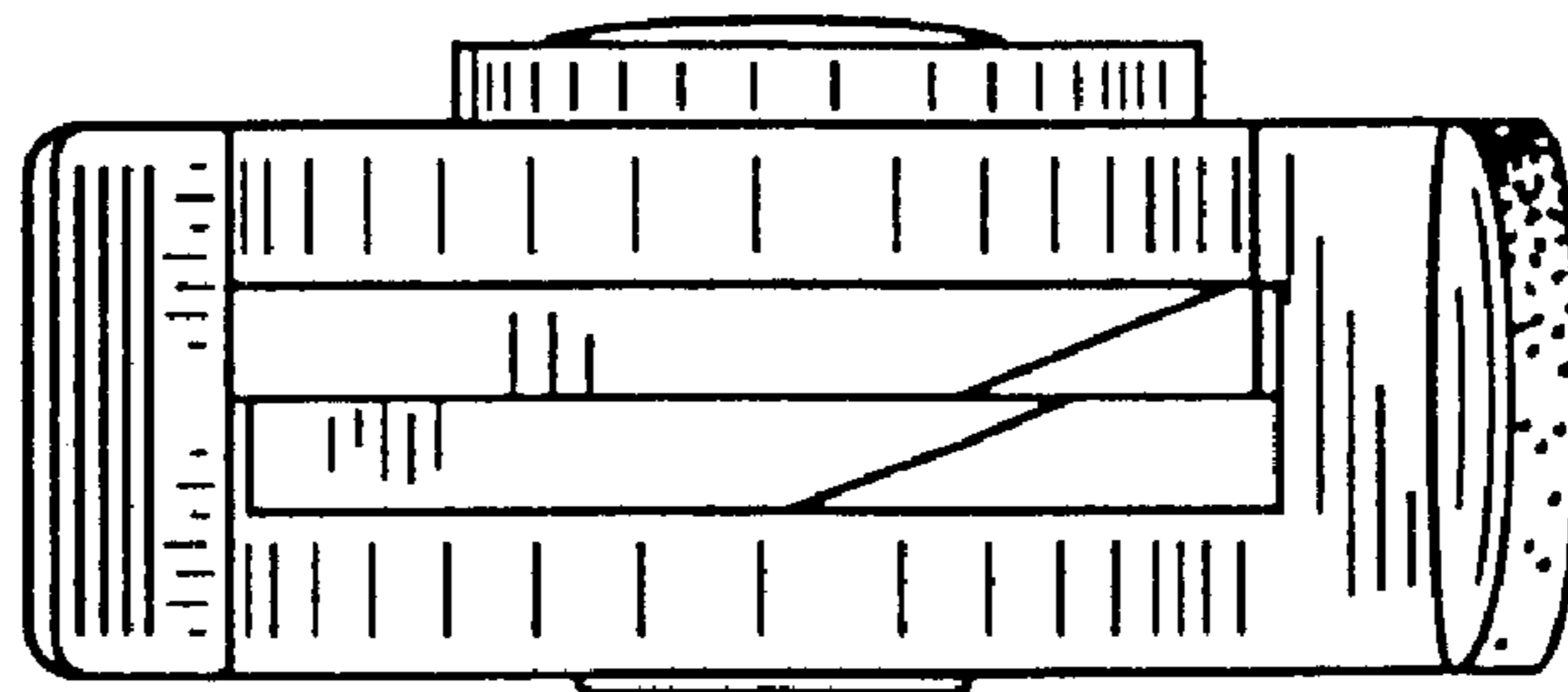

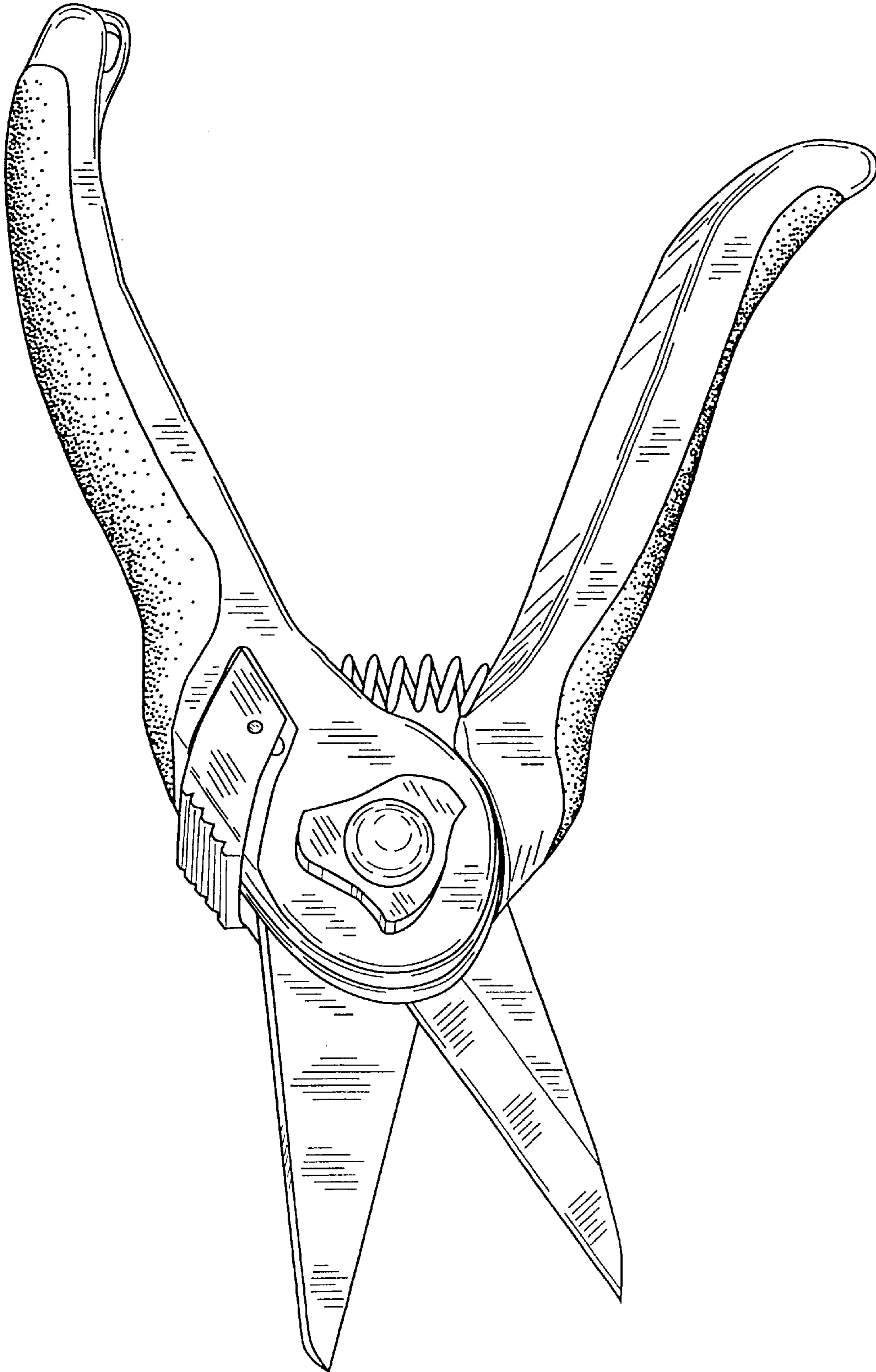

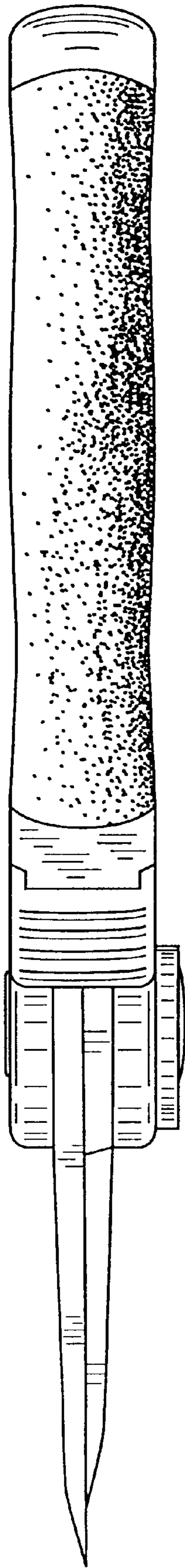

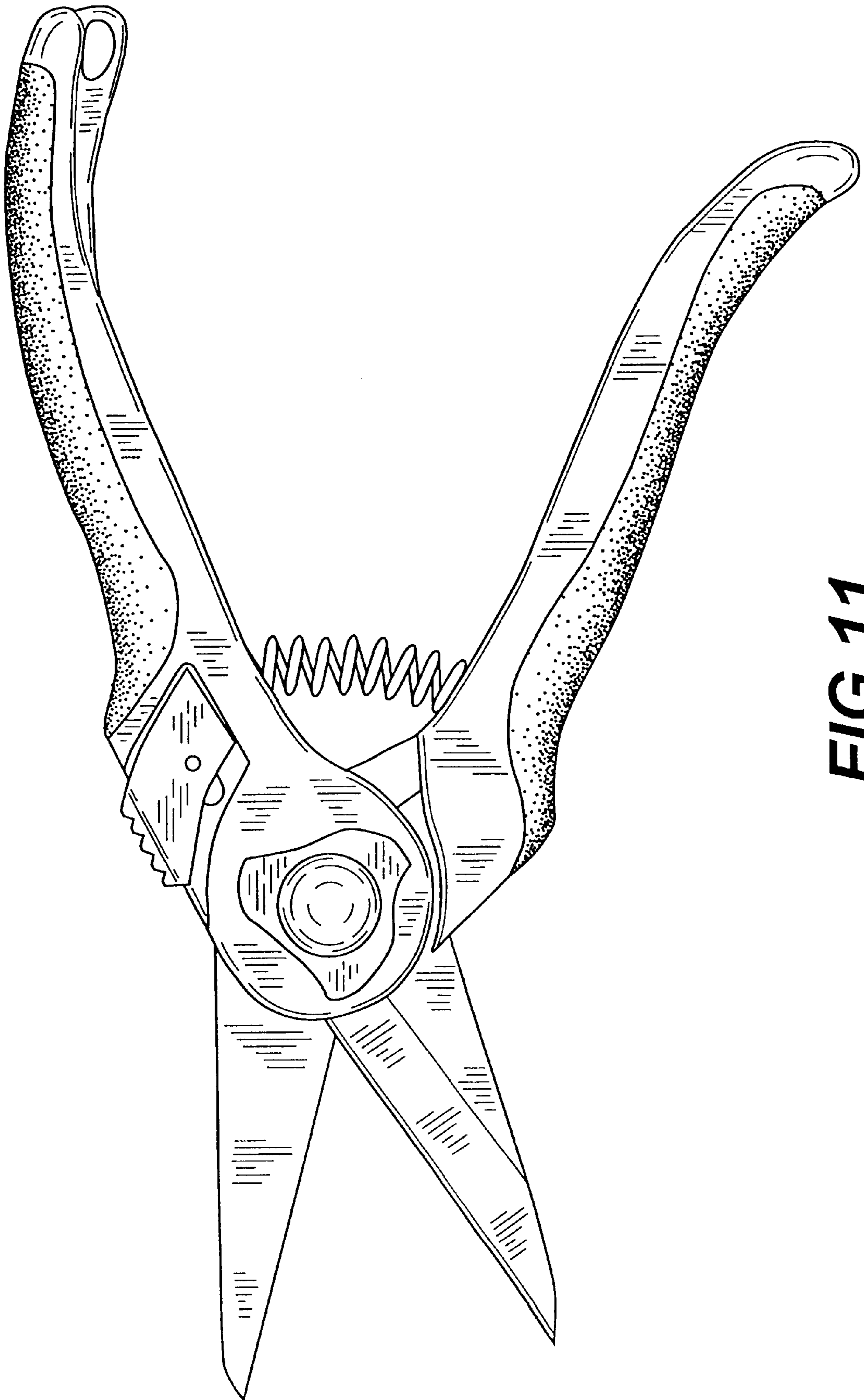

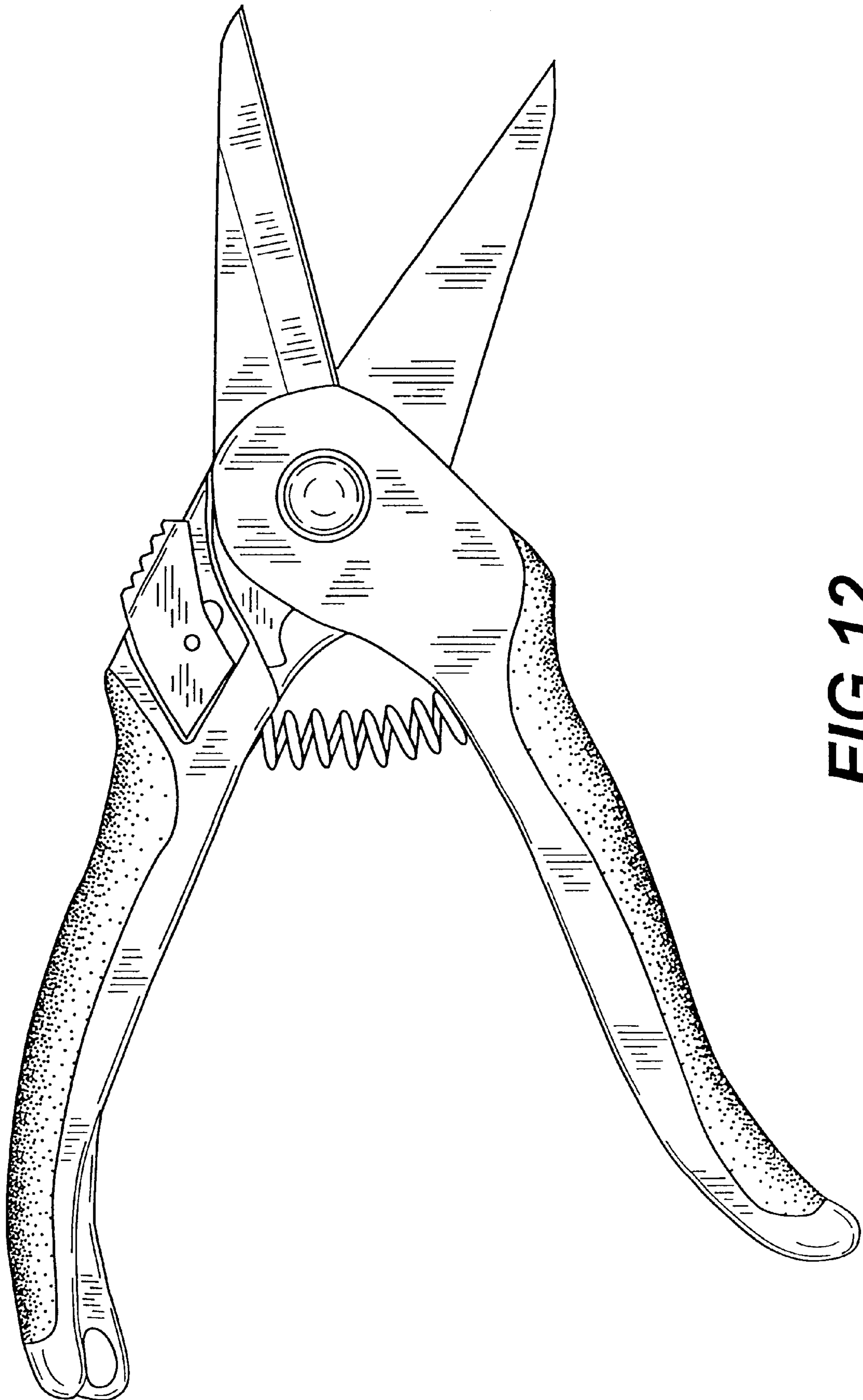

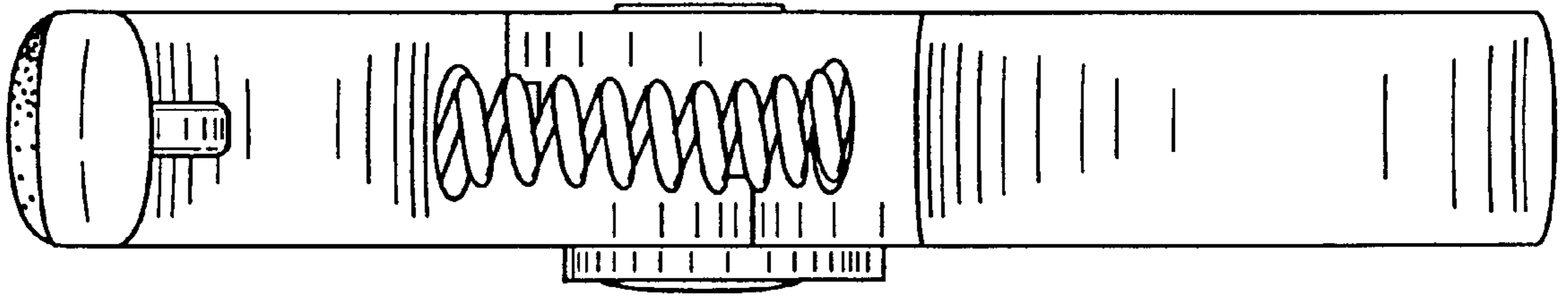

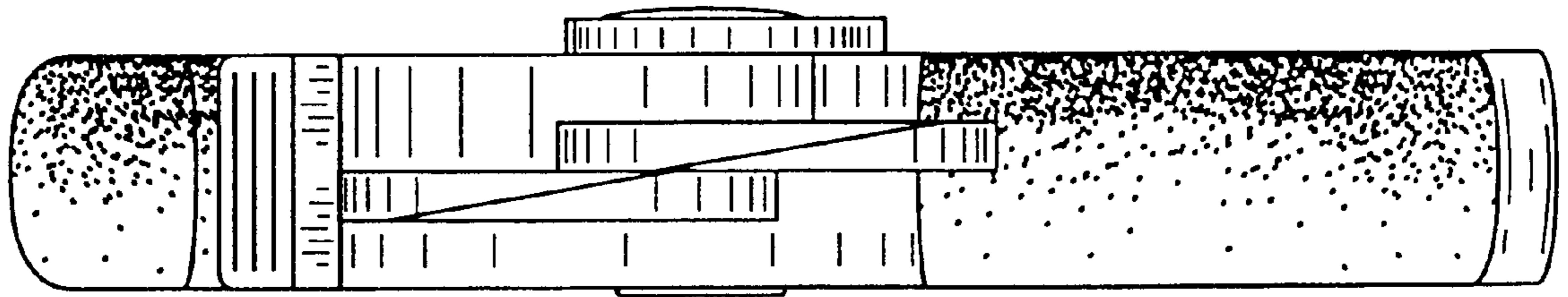
