(57) **CLAIM**

The ornamental design for a deodorant roll-on, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the deodorant roll-on, looking toward the front right portion thereof, with a swivel cap in an open position exposing a roller ball for one embodiment of the invention;

FIG. 2 is a perspective view of the embodiment of FIG. 1, with the swivel cap in a closed position covering the roller ball;

FIG. 3 is a front elevational view thereof, with the swivel cap in a closed position;

FIG. 4 is a front elevational view of the embodiment of FIG. 3, with the swivel cap in an open position;

FIG. 5 is a rear elevational view thereof, with the swivel cap in an open position;

FIG. 6 is a rear elevational view thereof, with the swivel cap in a closed position;

FIG. 7 is a left side elevational view thereof, with the swivel cap in a closed position;

FIG. 8 is a left side elevational view thereof, with the swivel cap in an open position;

FIG. 9 is a right side elevational view thereof, with the swivel cap in a closed position;

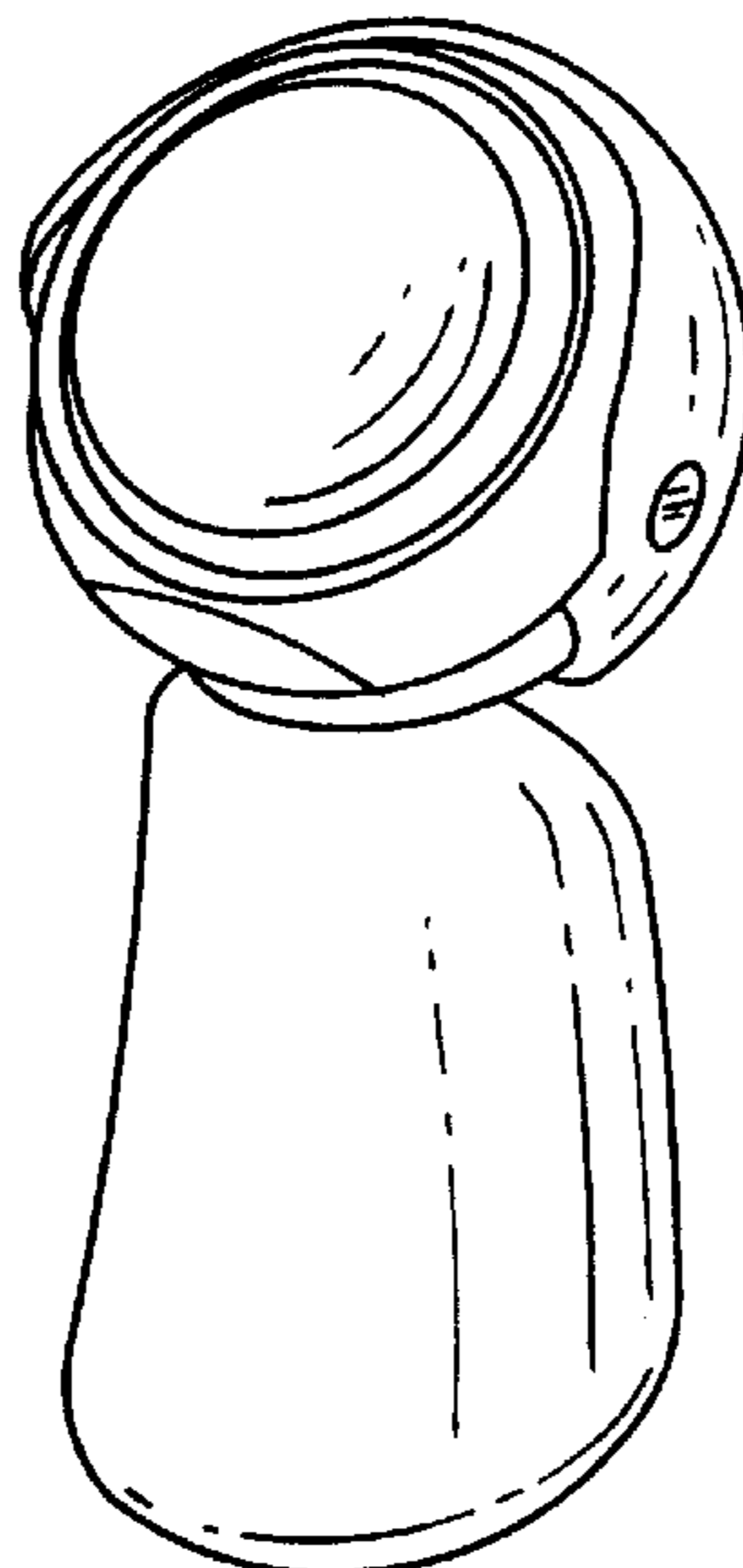
FIG. 10 is a right side elevational view thereof, with the swivel cap in an open position;

FIG. 11 is a top plan view thereof, with the swivel cap in a closed position;

FIG. 12 is a top plan view thereof, with the swivel cap in an open position; and,

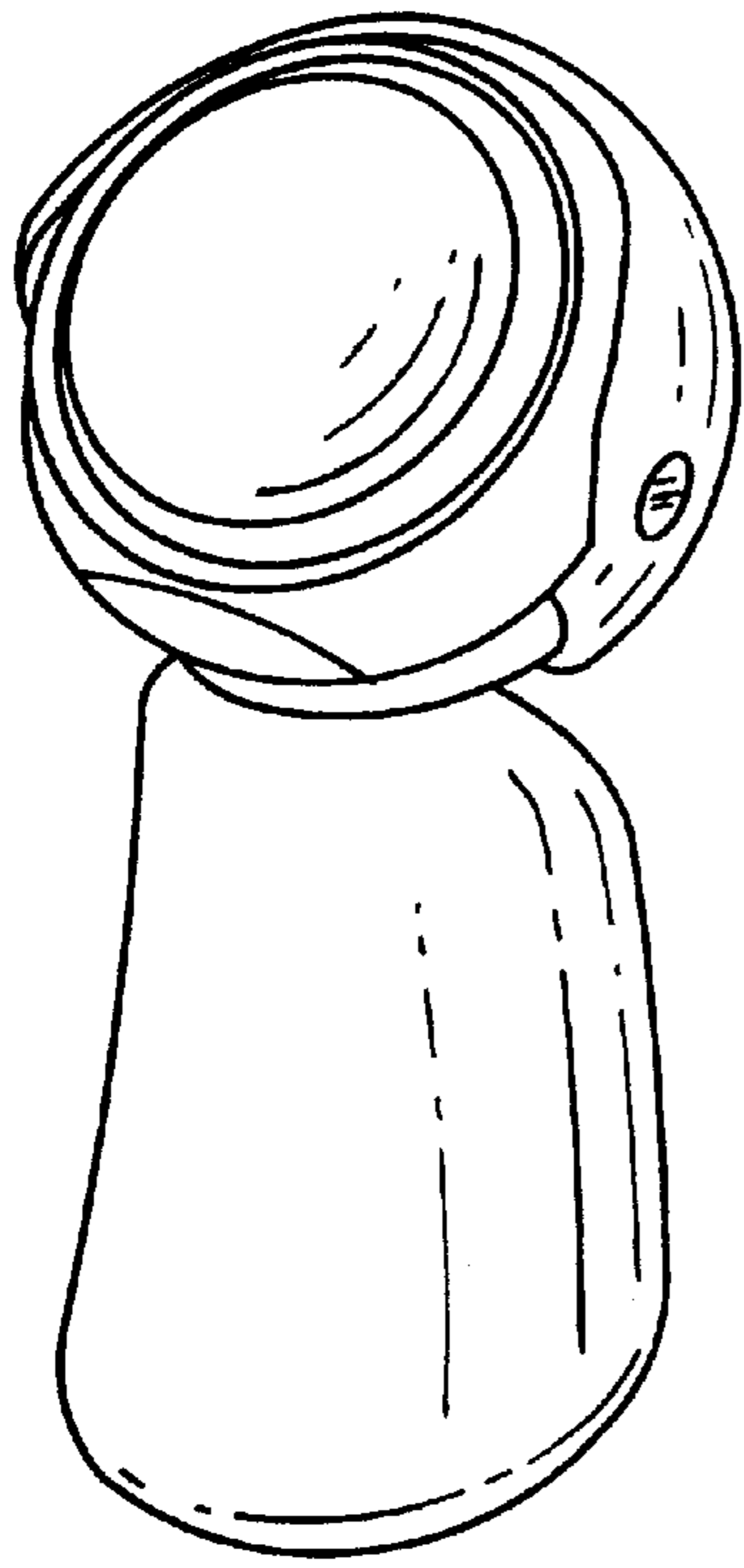

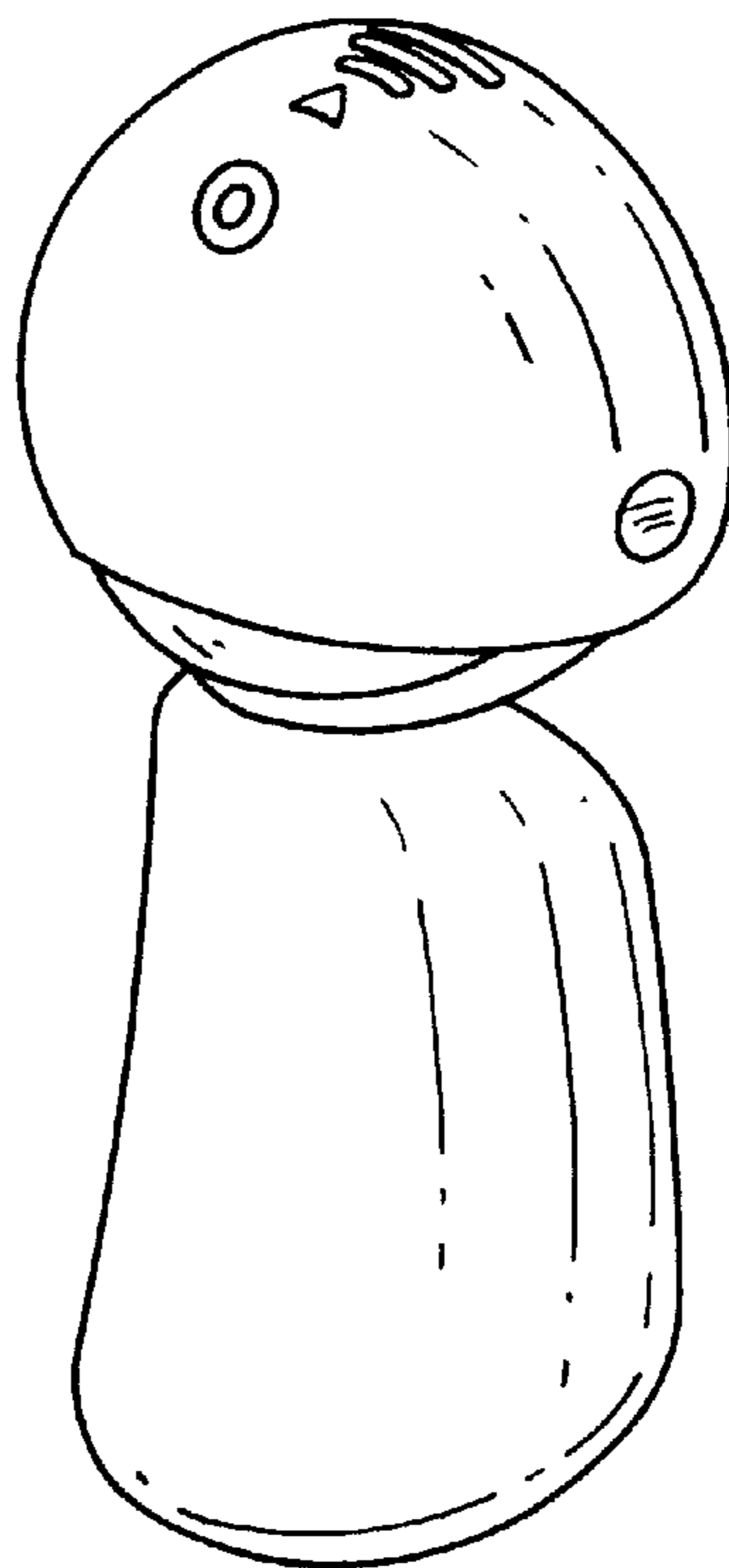

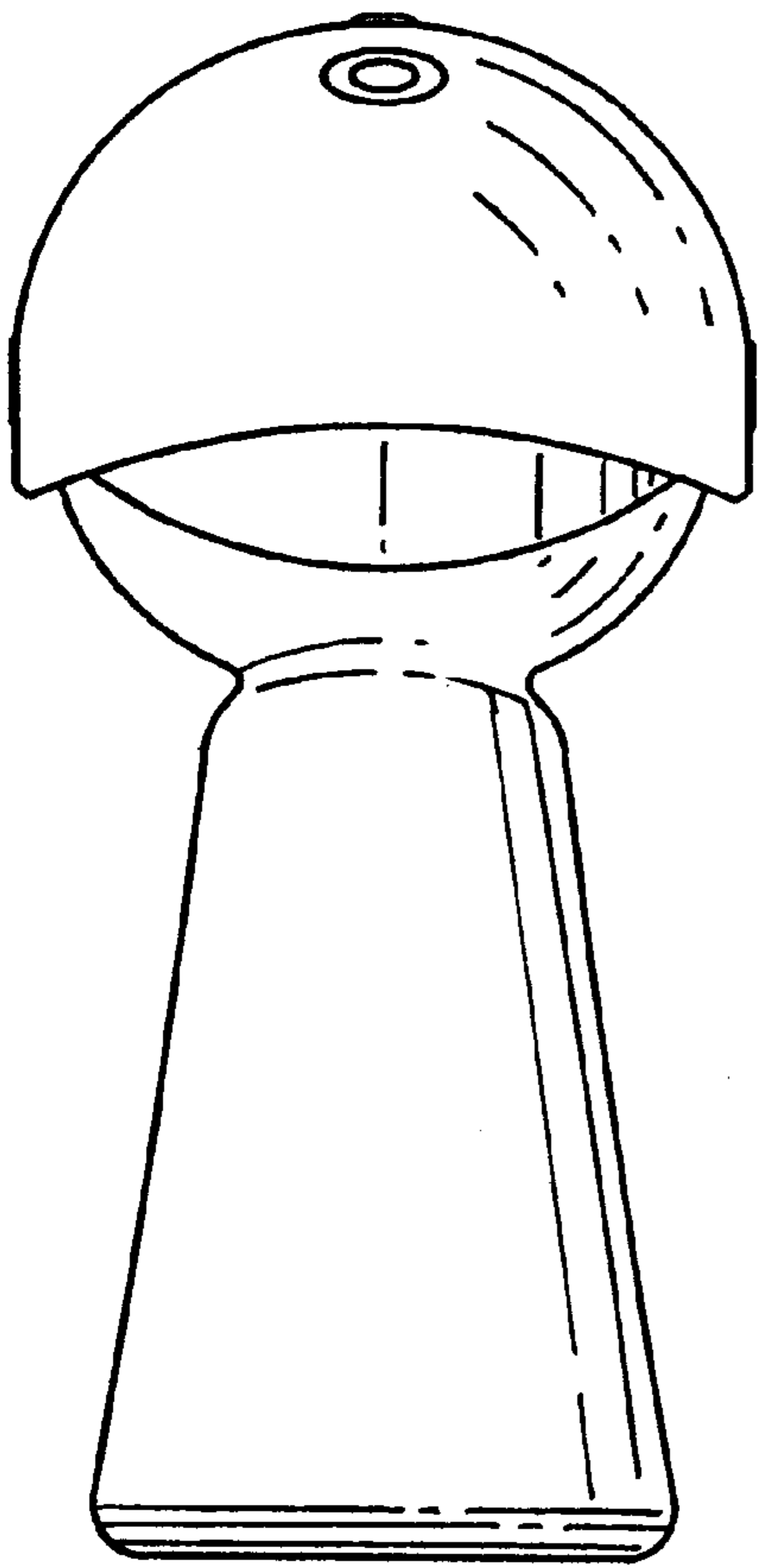

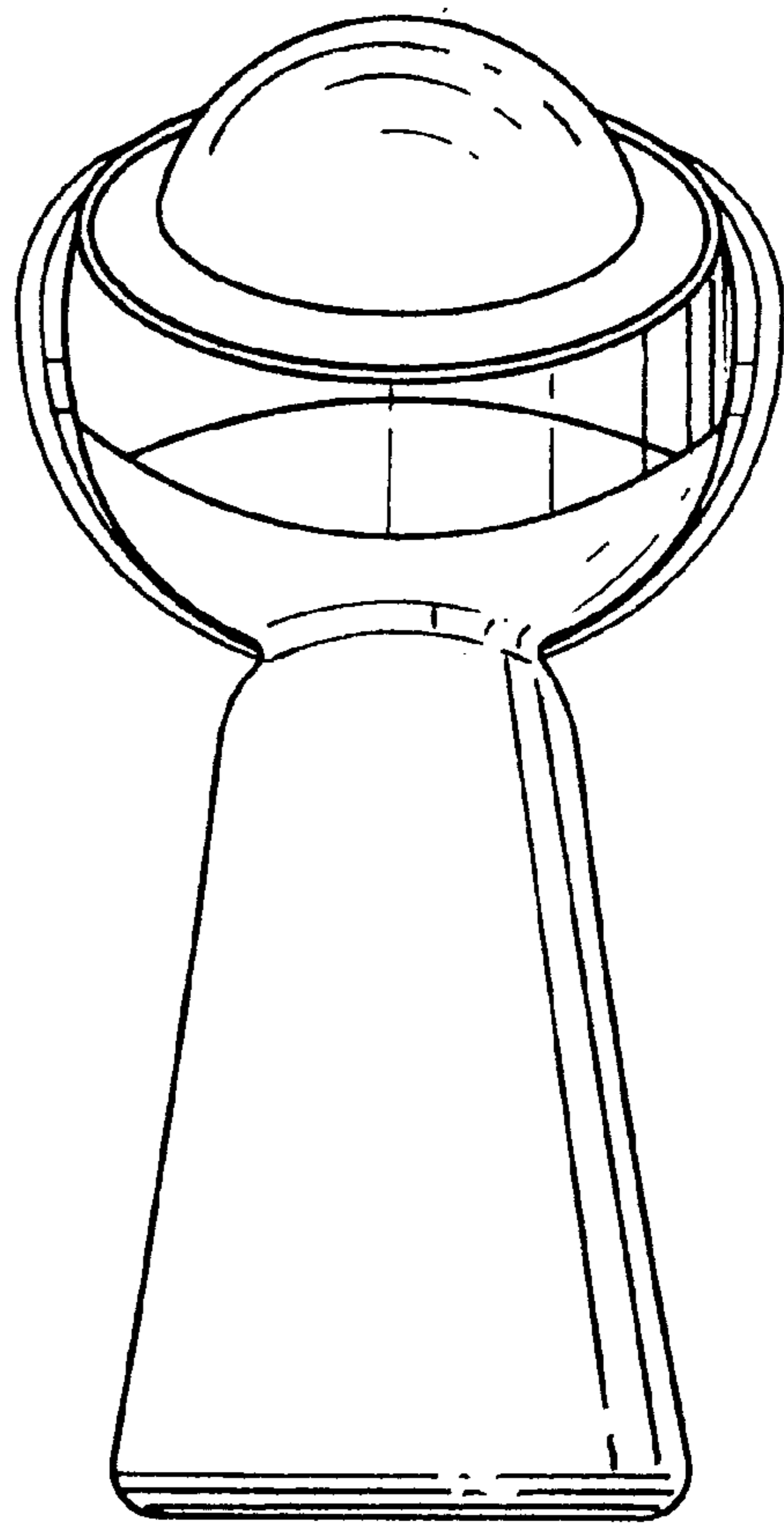

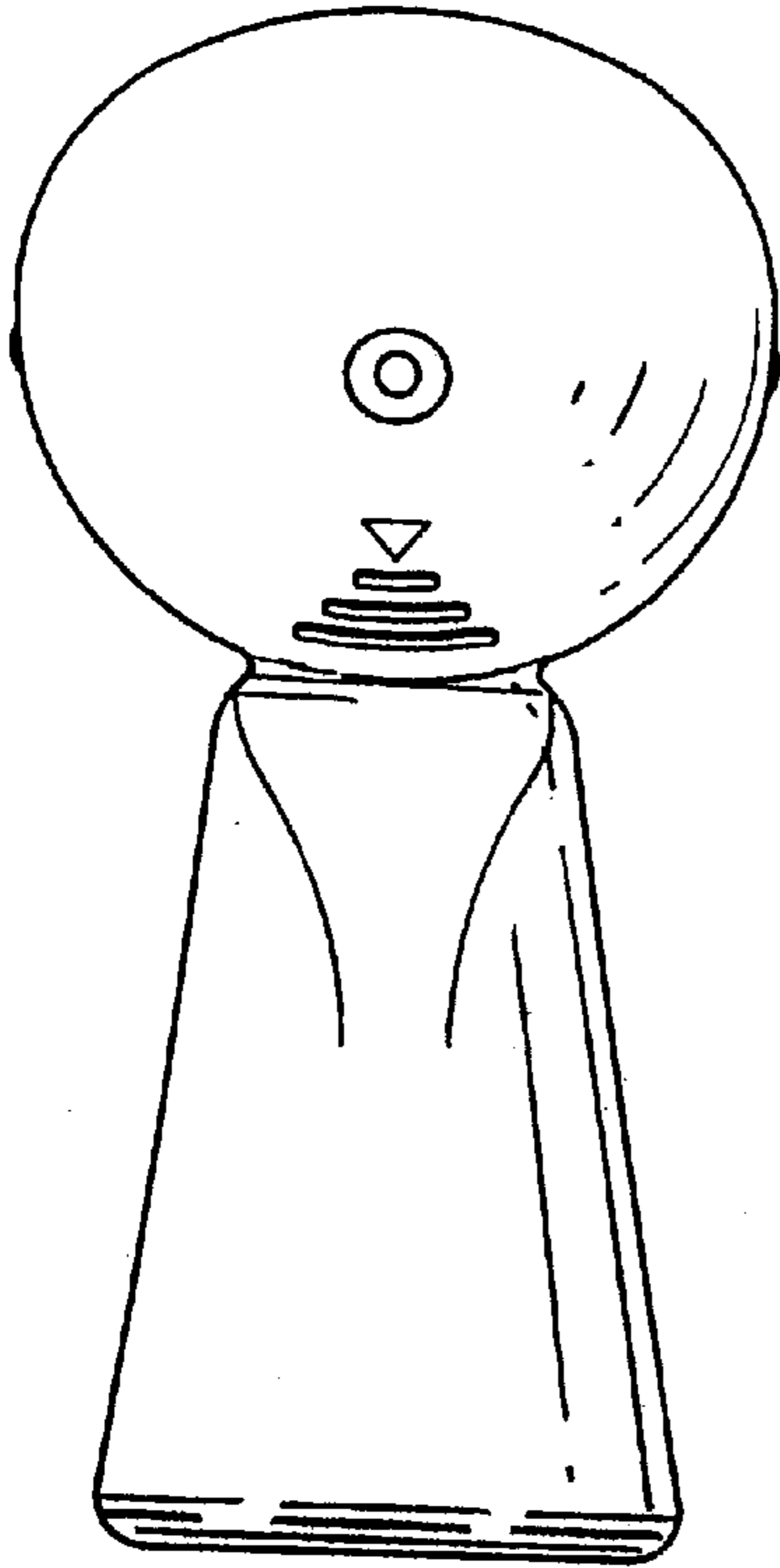

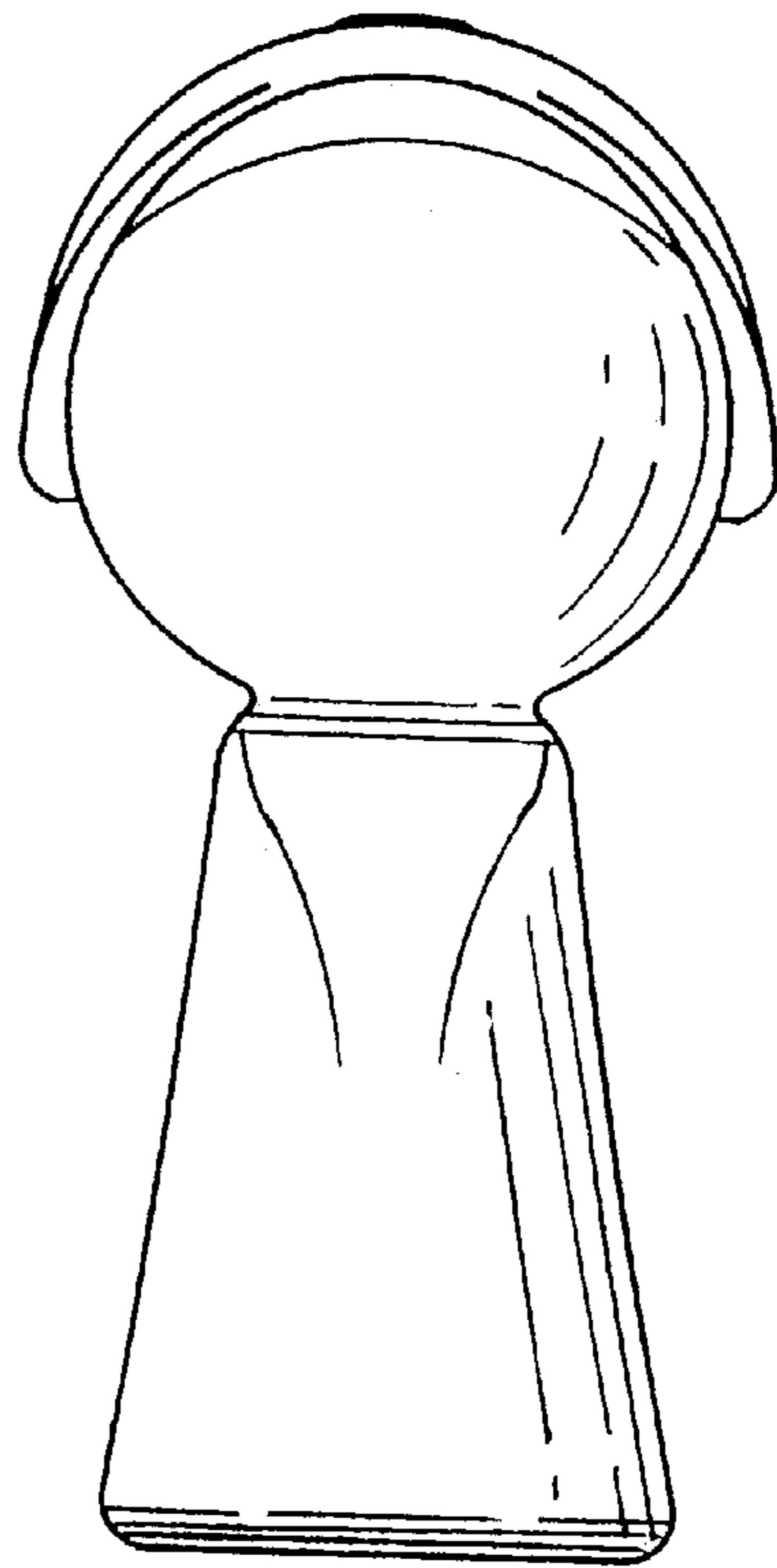

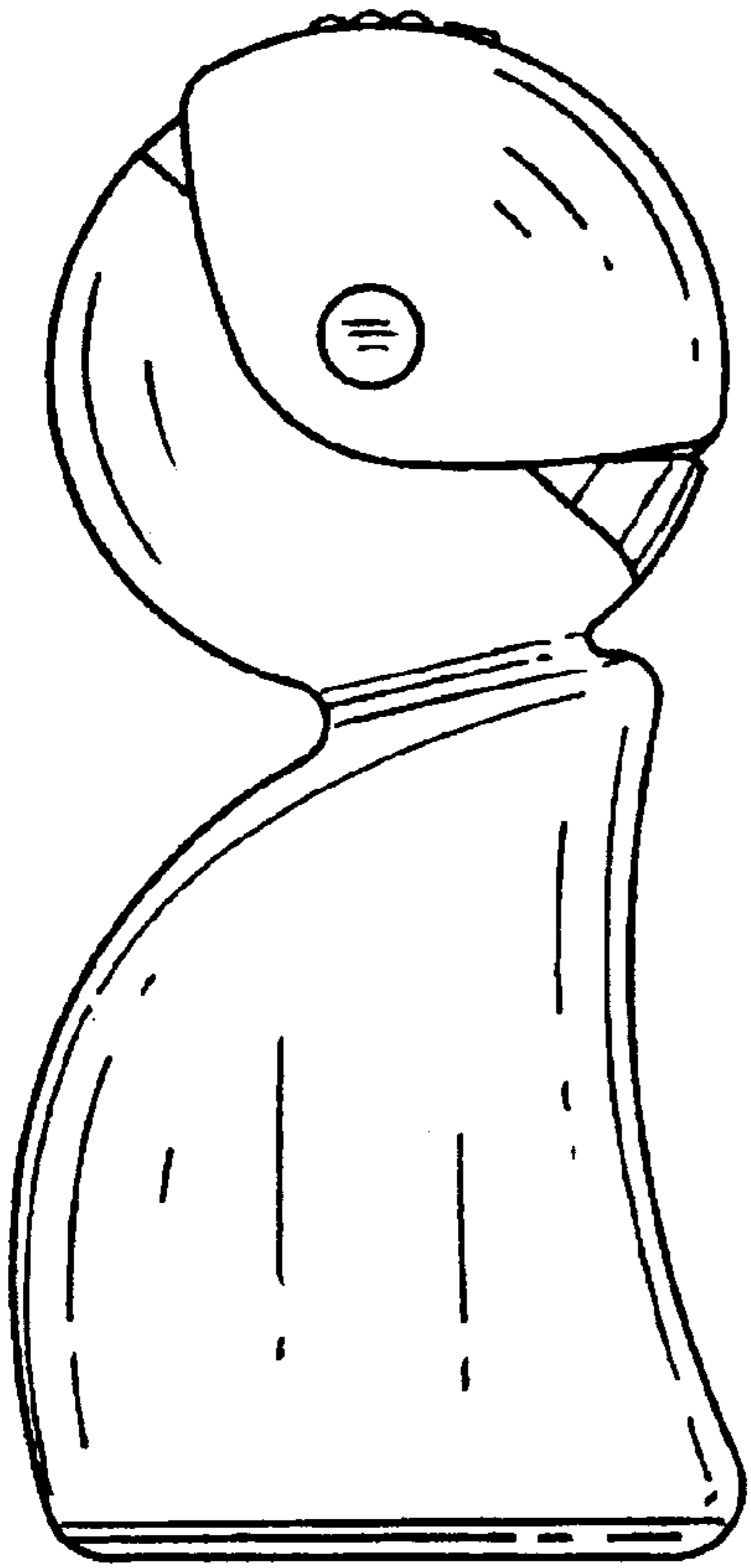

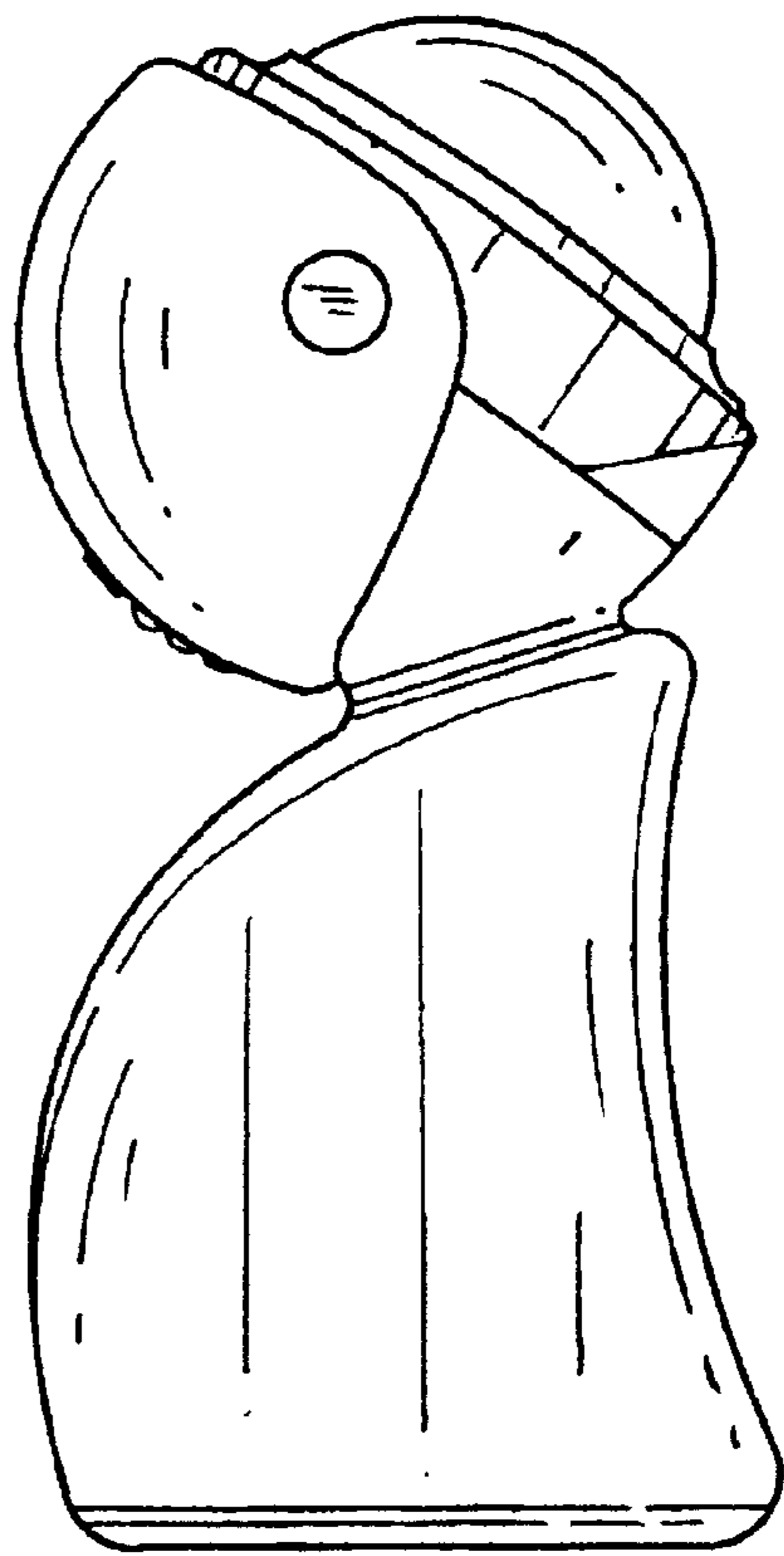

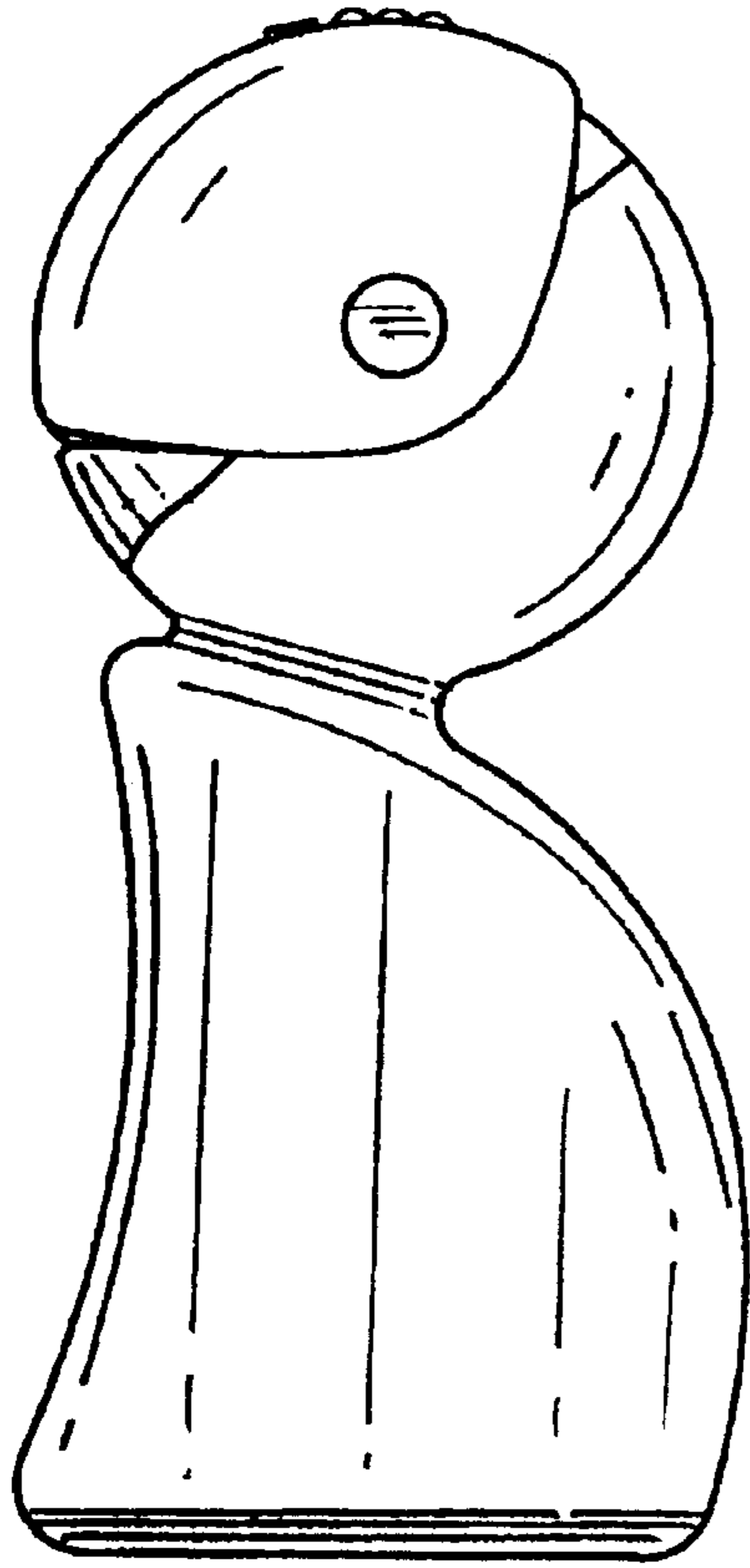

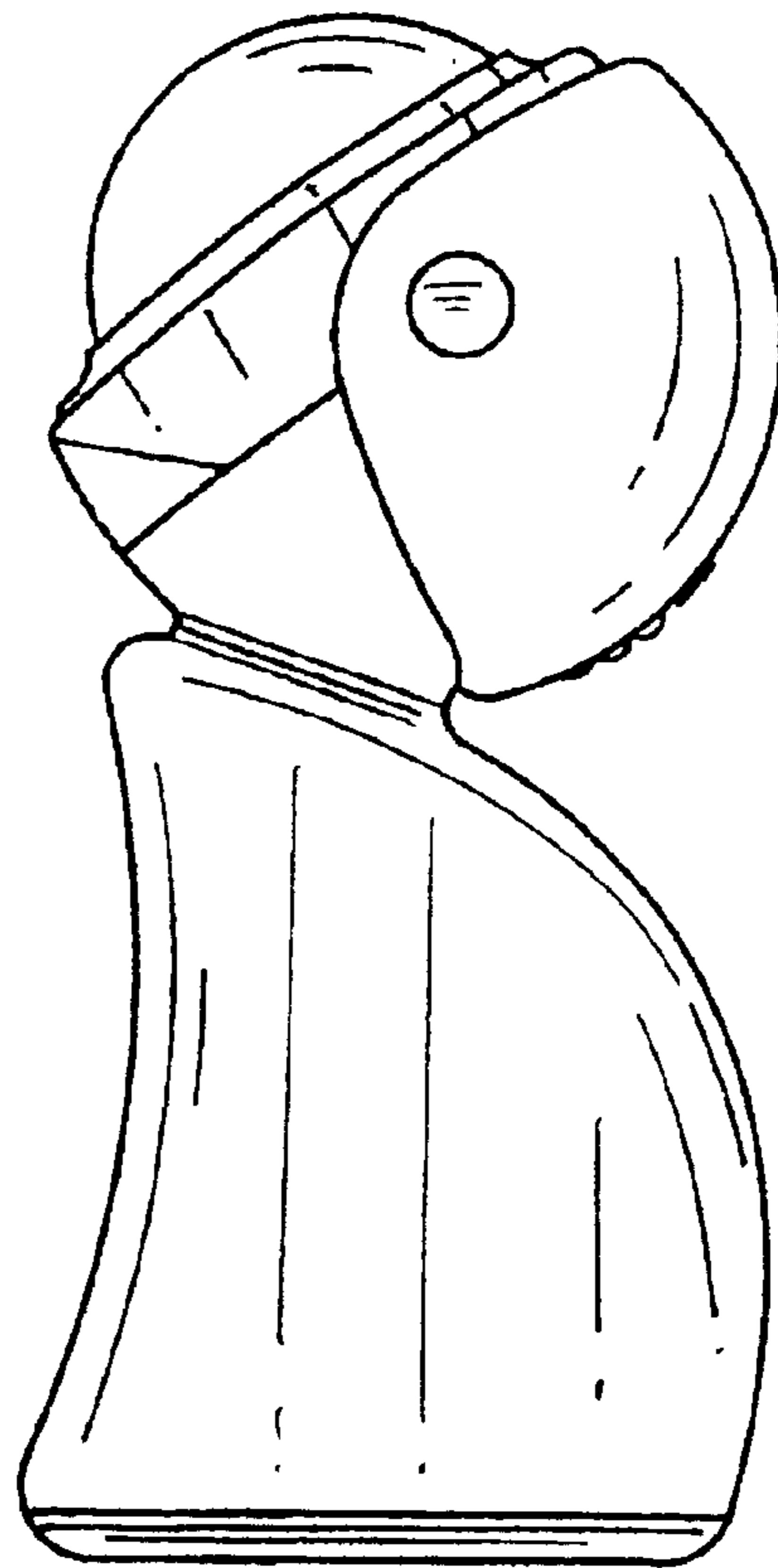

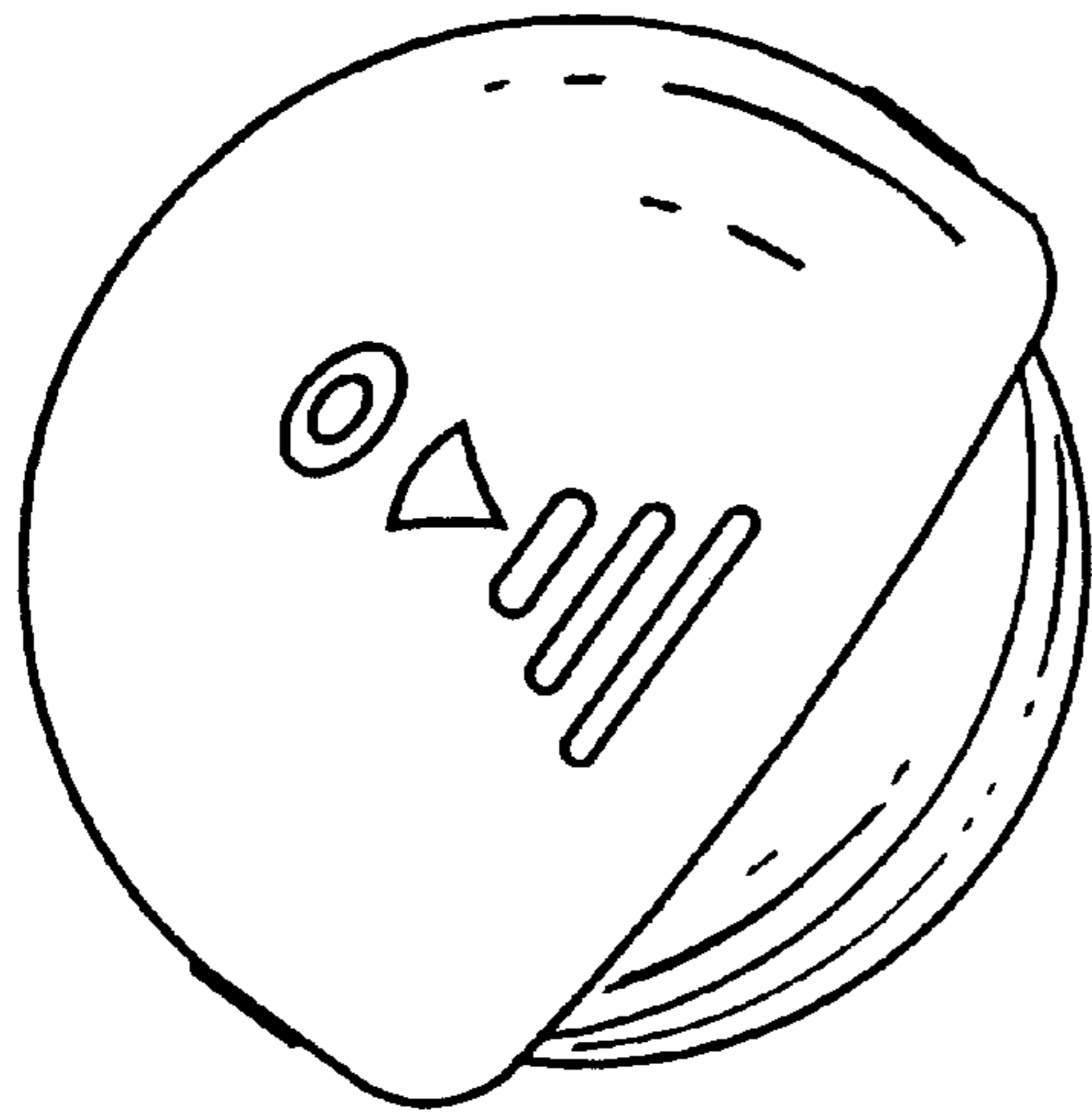

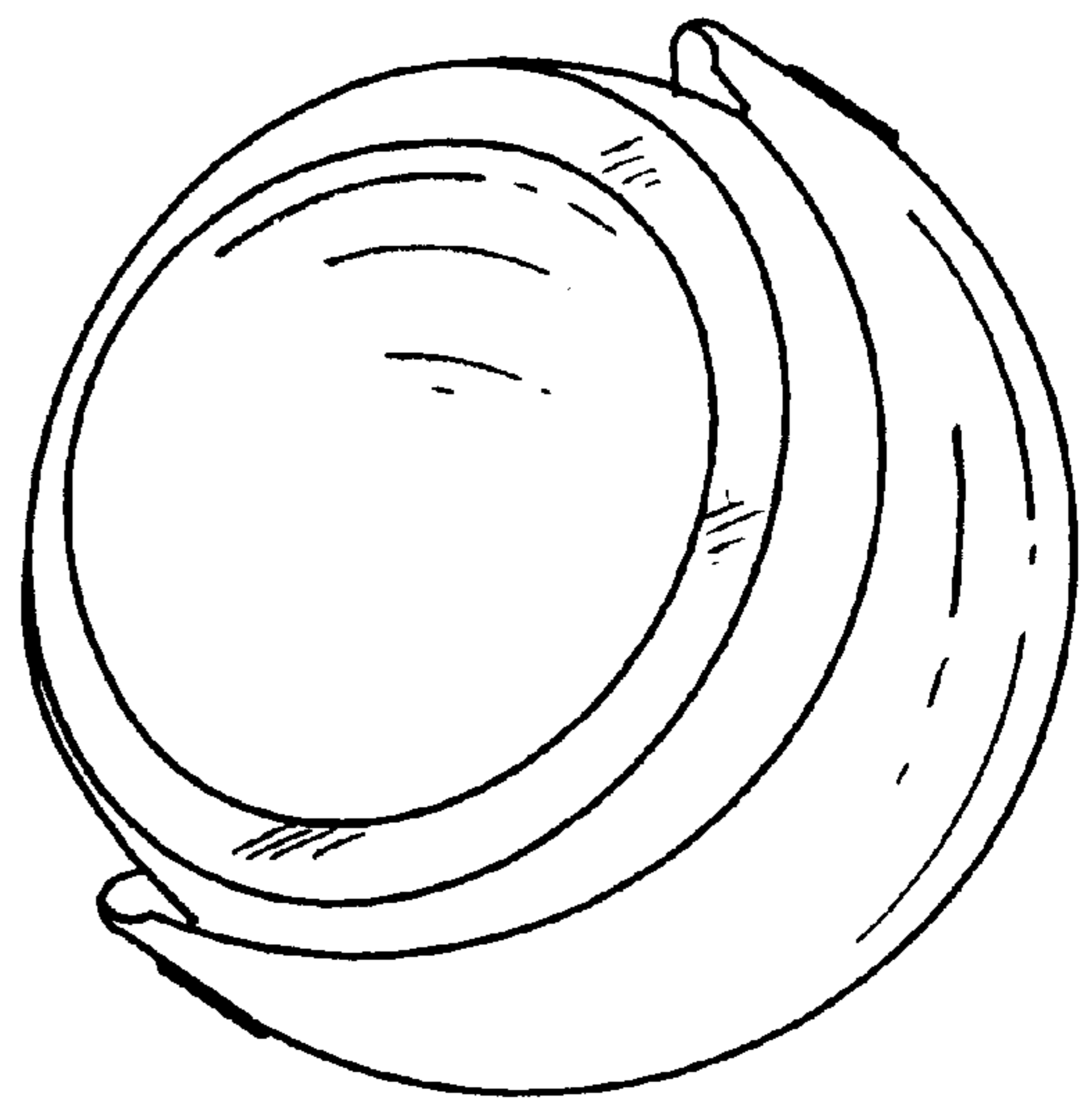

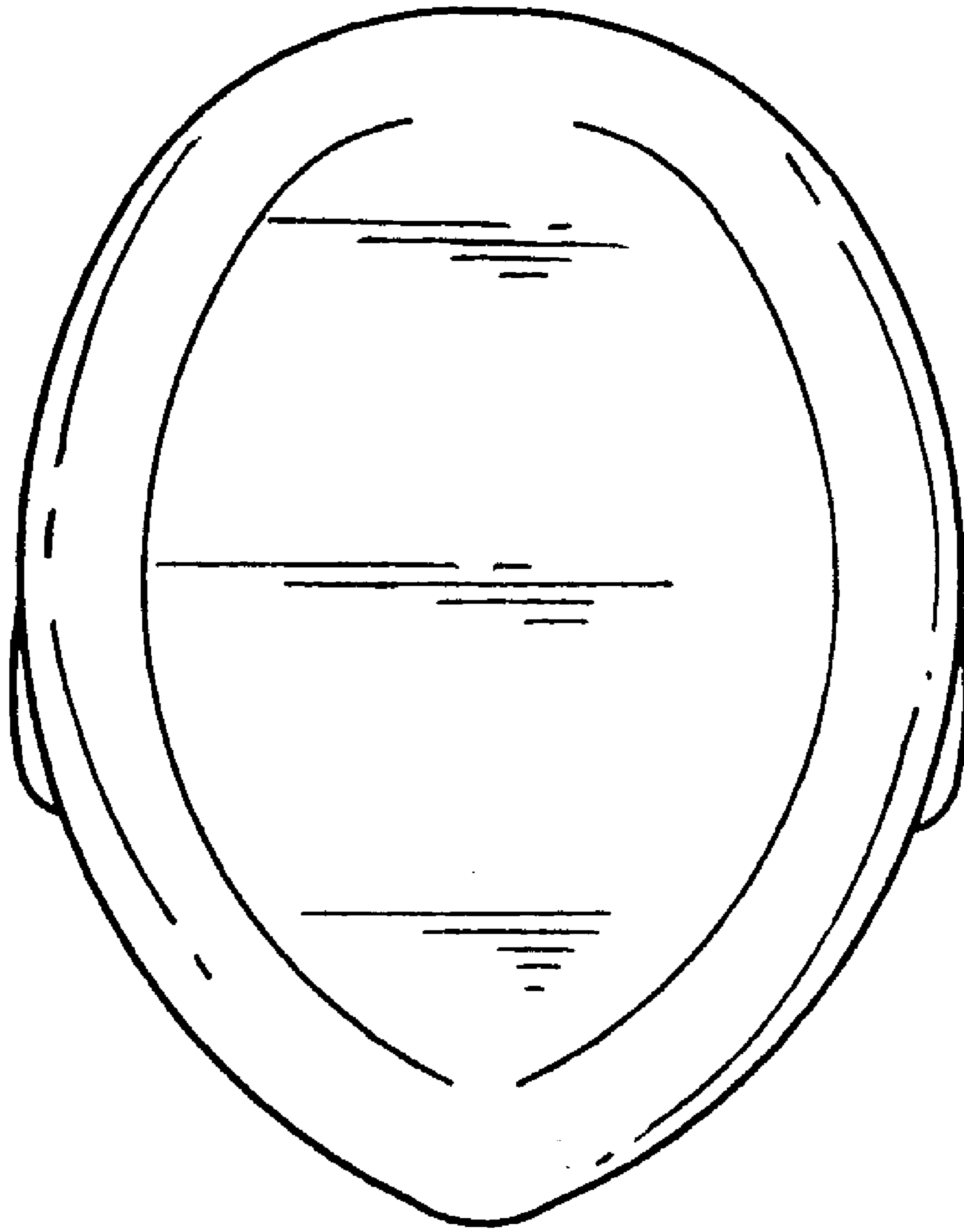
