(57) **CLAIM**

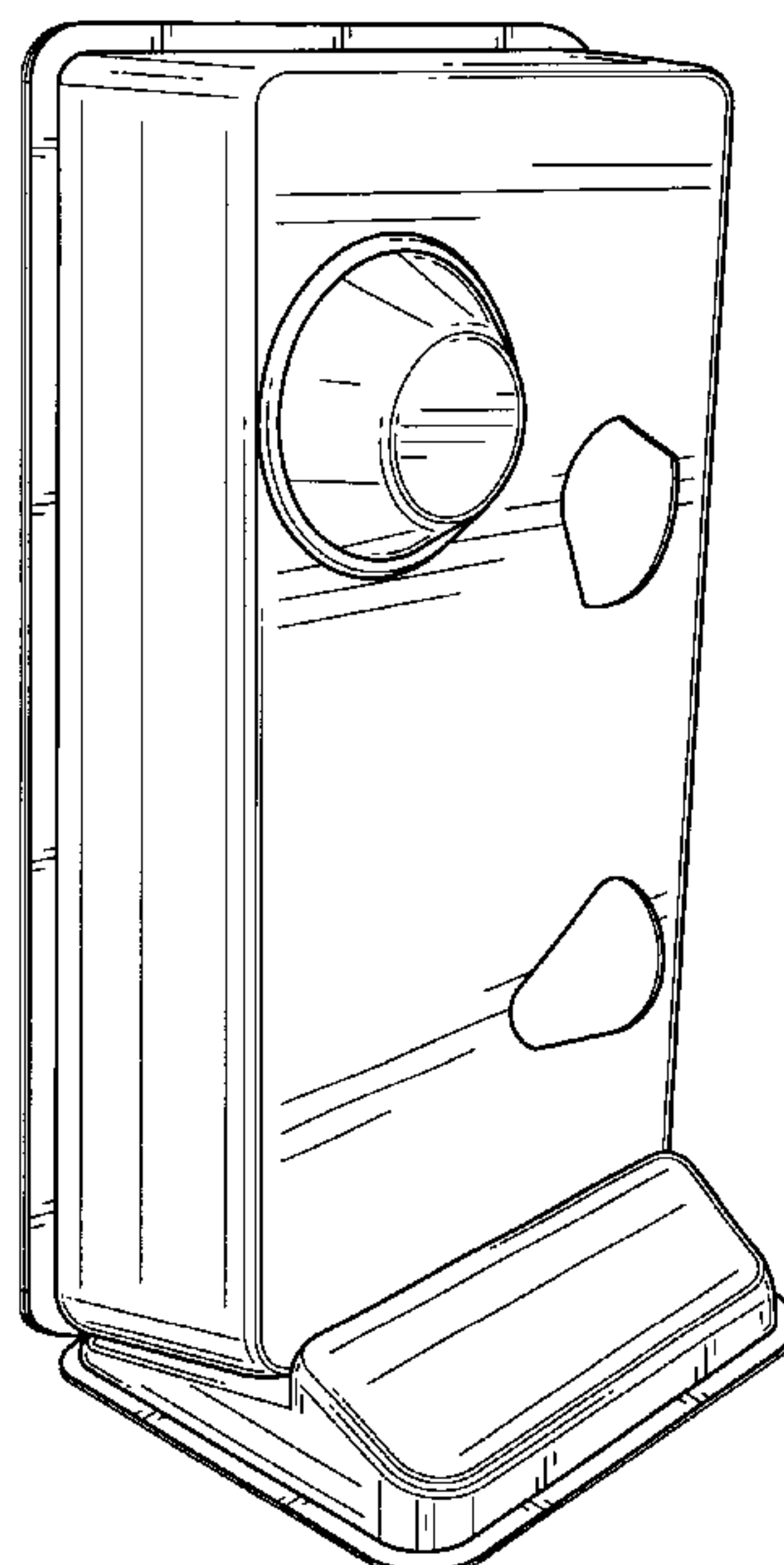
The ornamental design of a handset packaging, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handset packaging in accordance with the present invention.

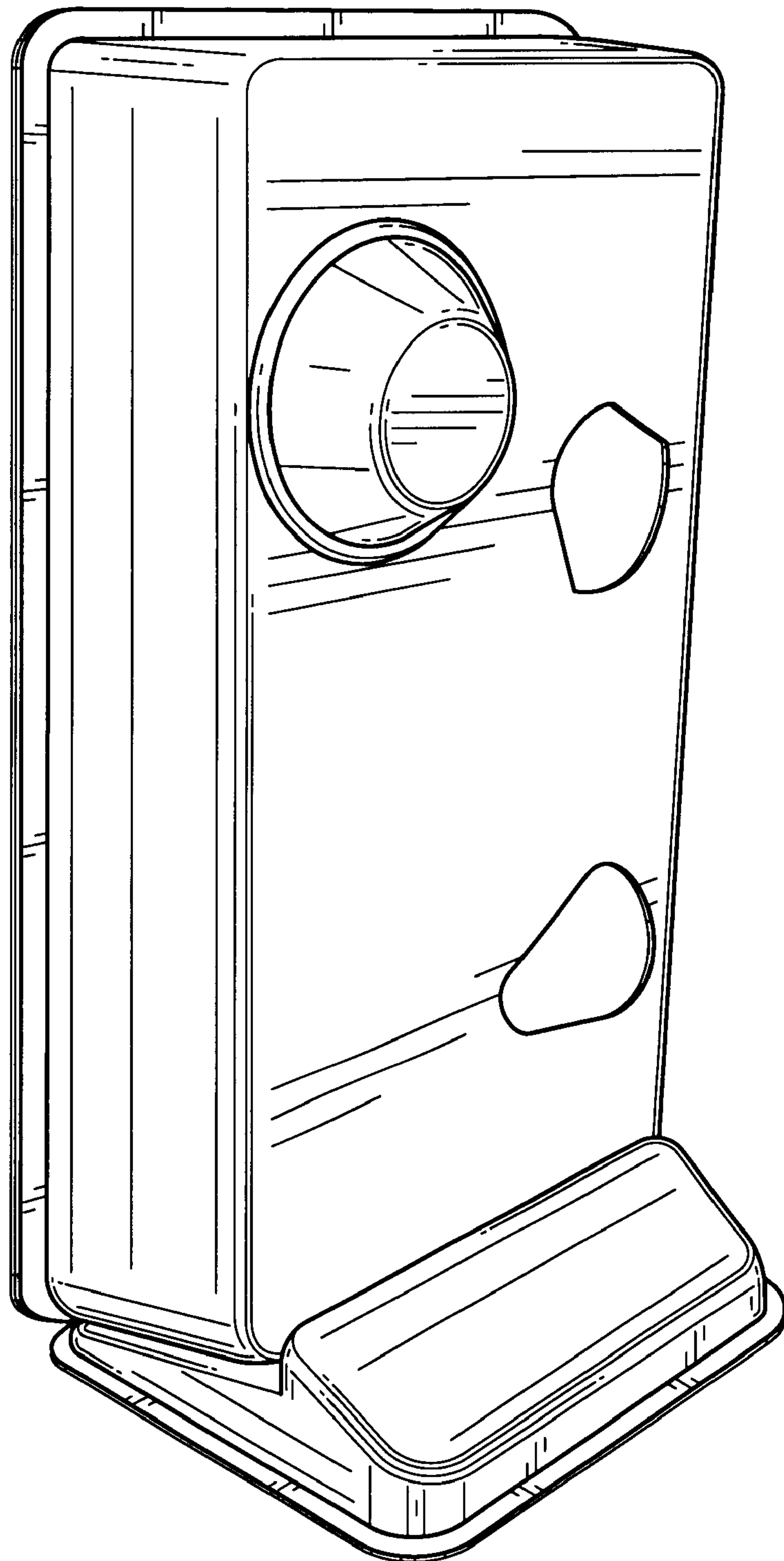

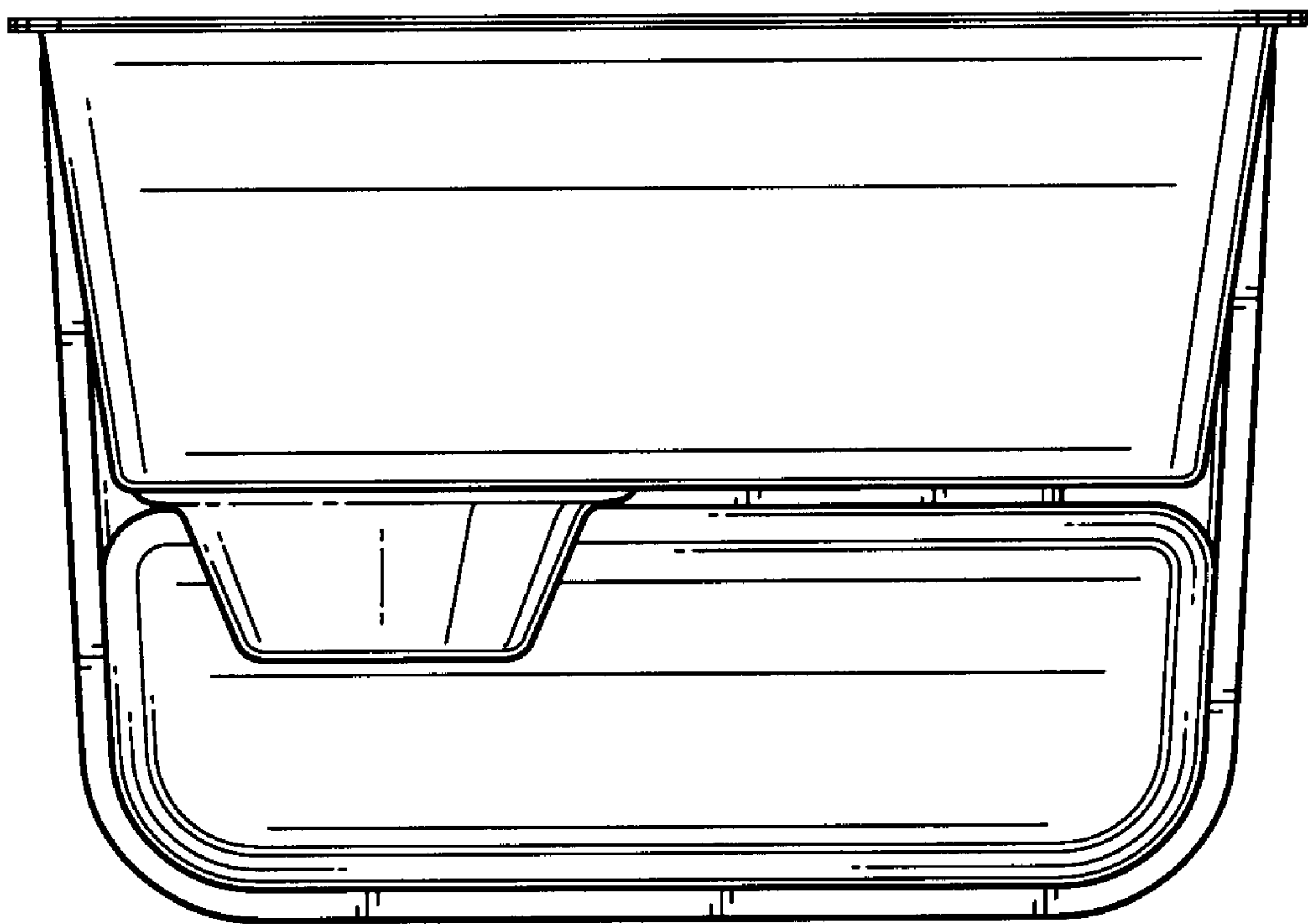

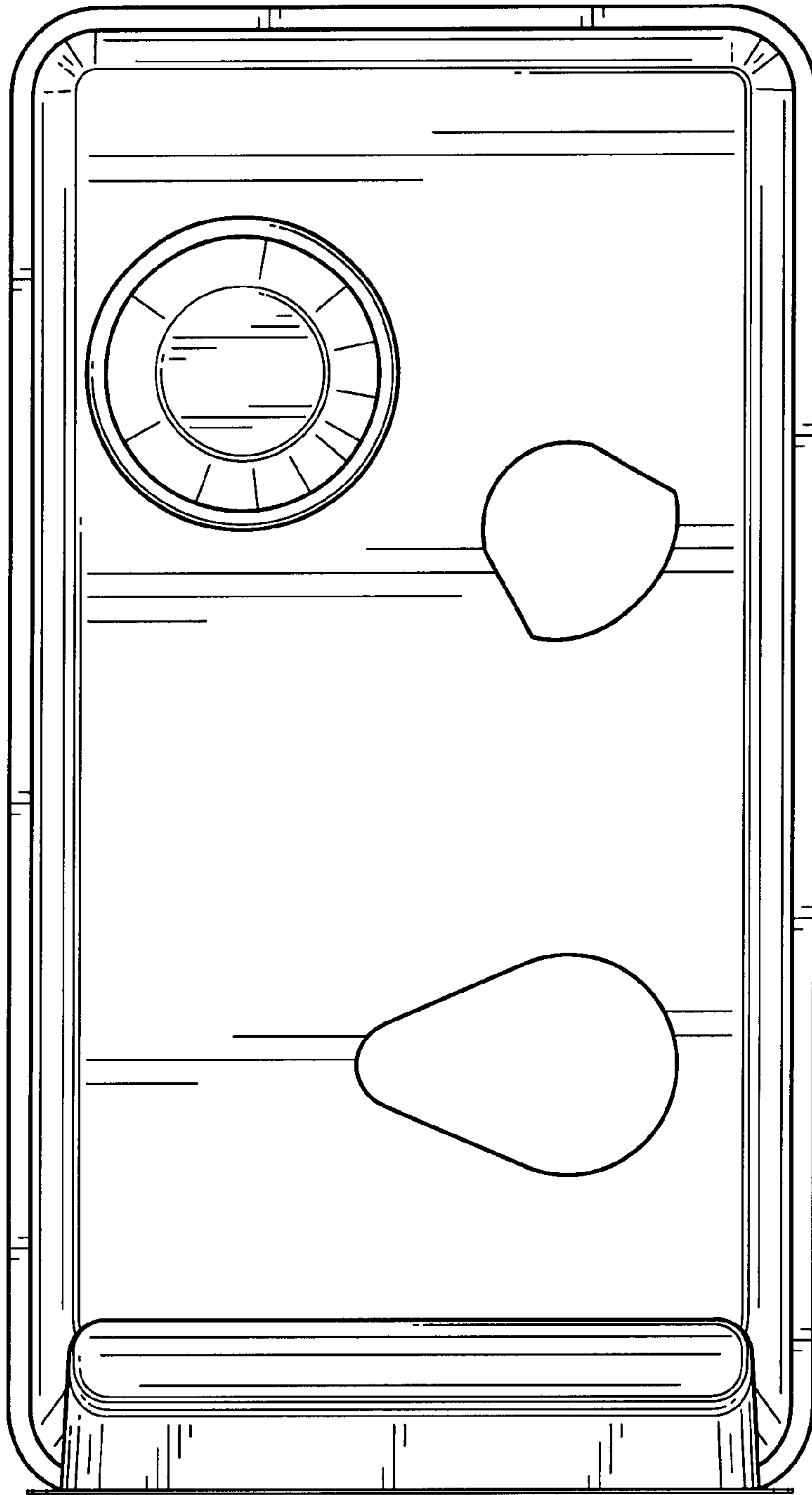

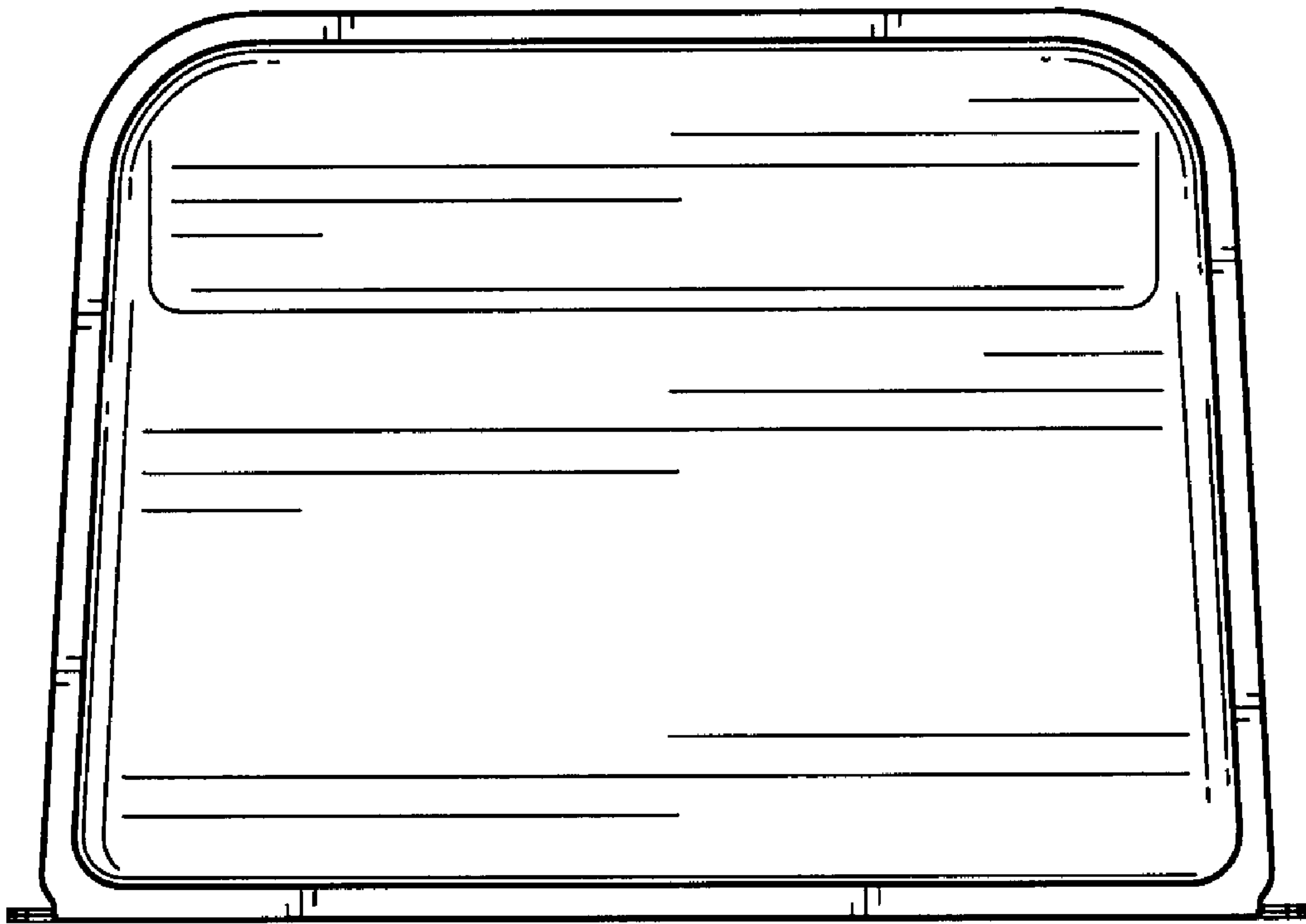

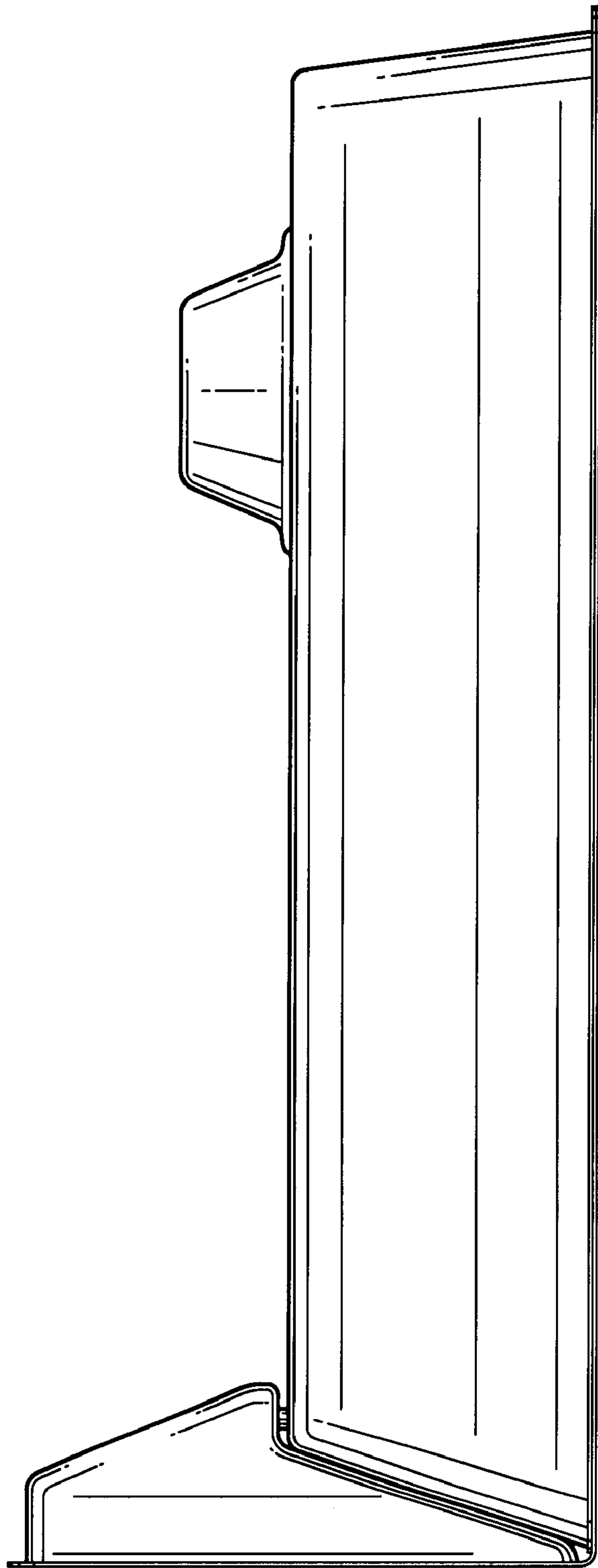

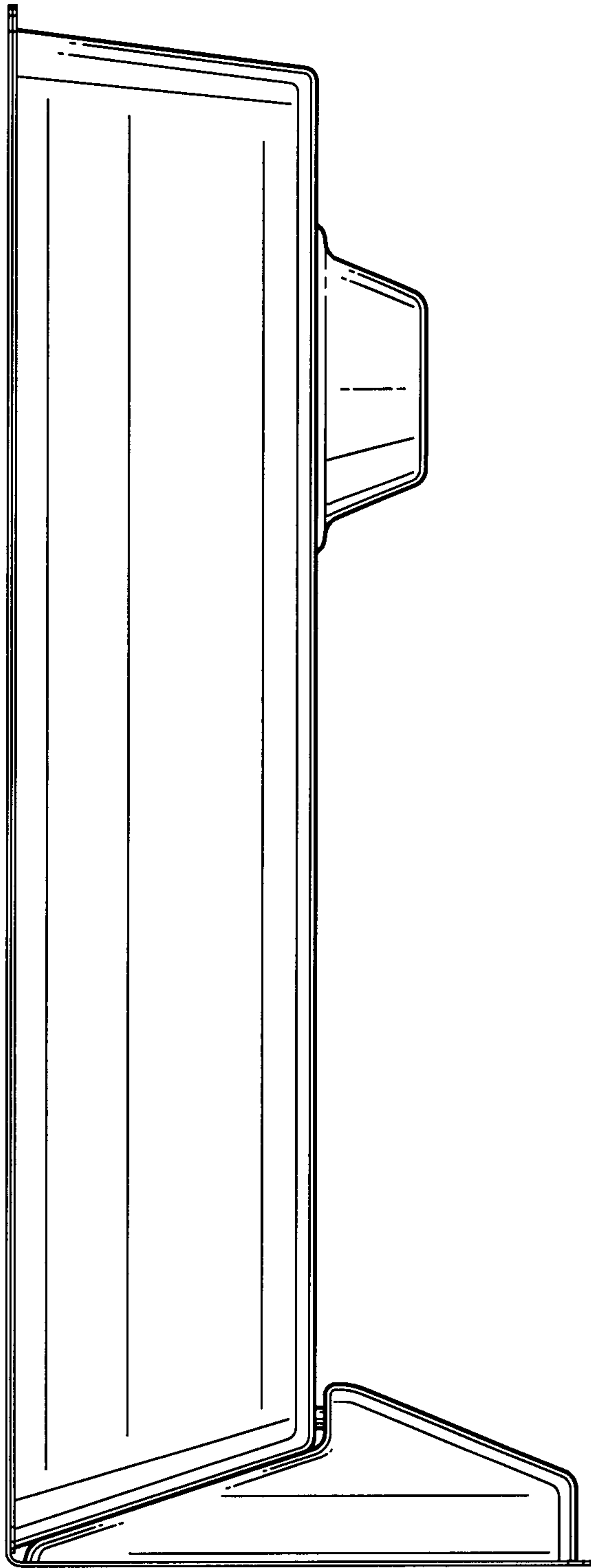

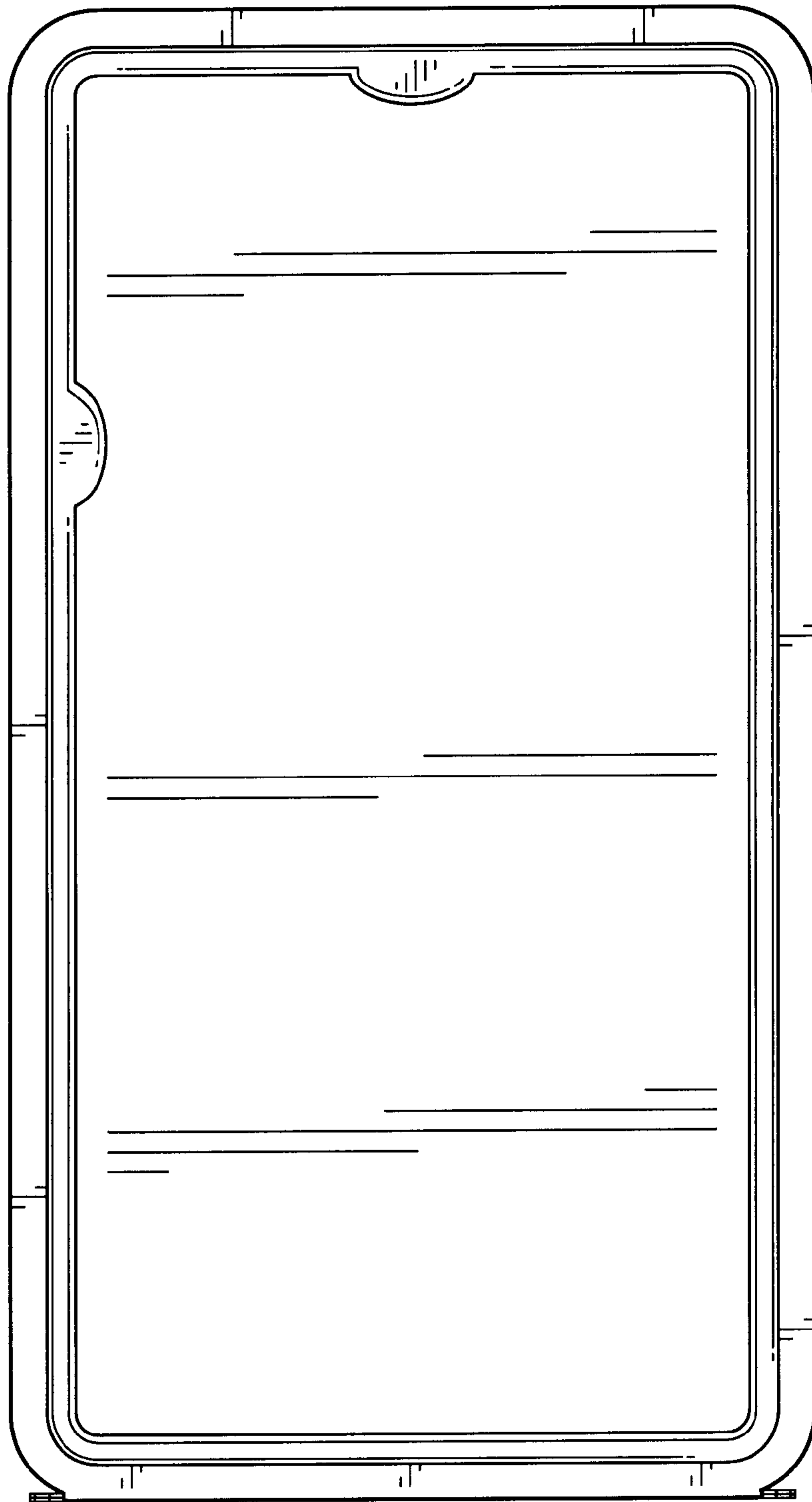
