The ornamental design for a combined bottle and cap, as shown and described.

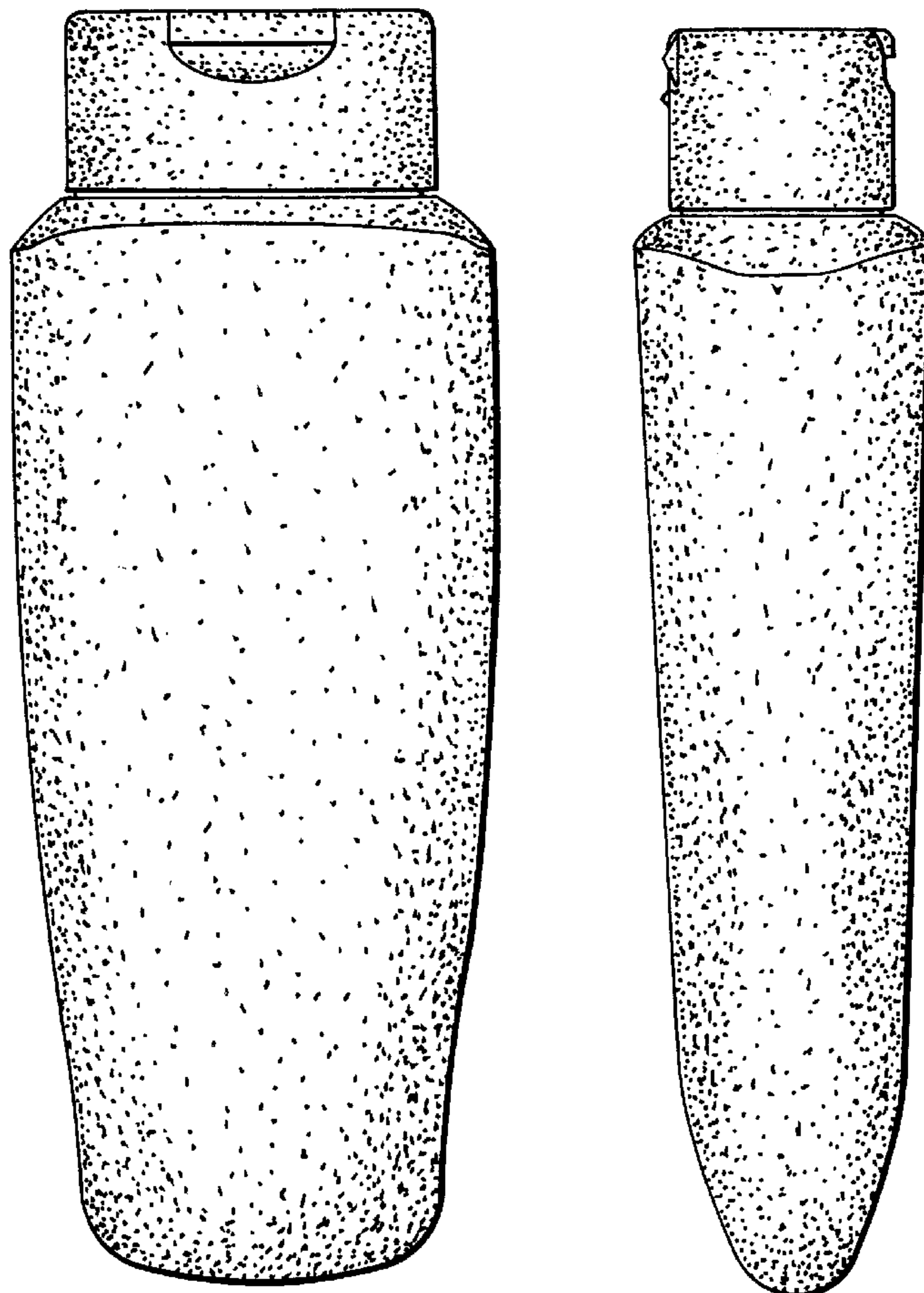
**DESCRIPTION**

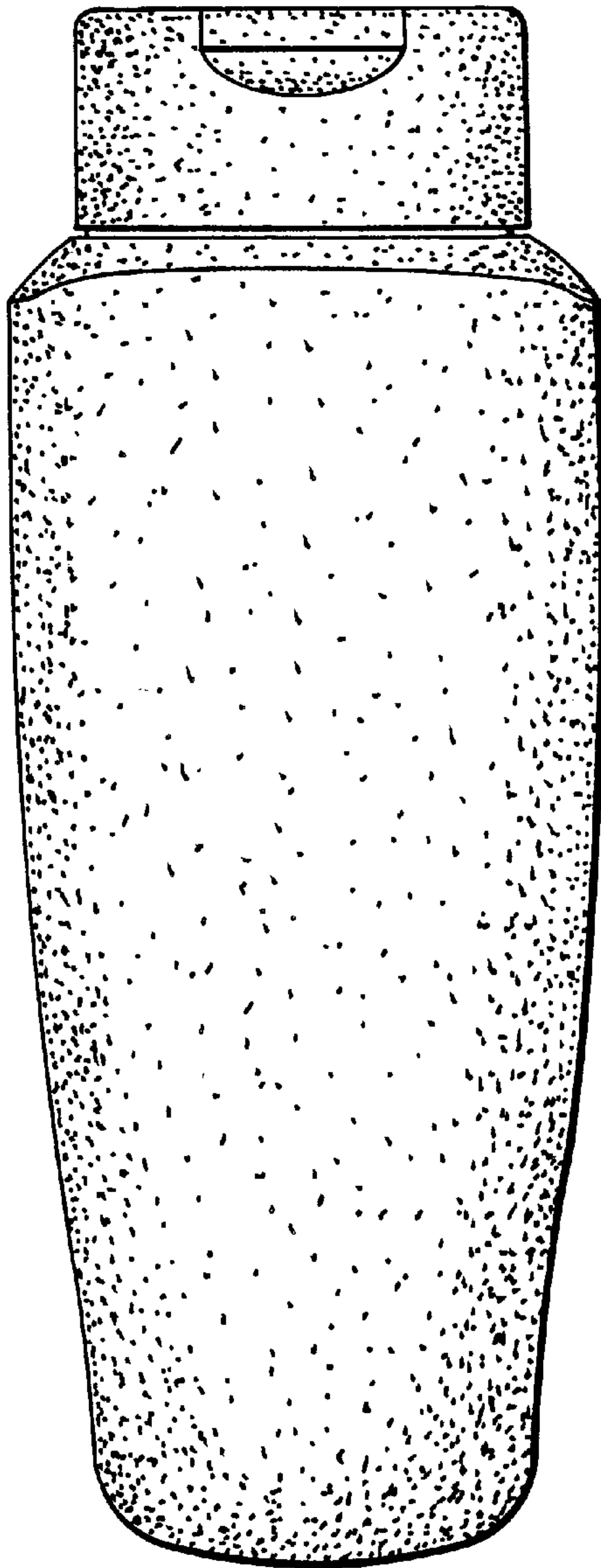
FIG. 1 is a front elevation of a combined bottle and cap showing our new design;

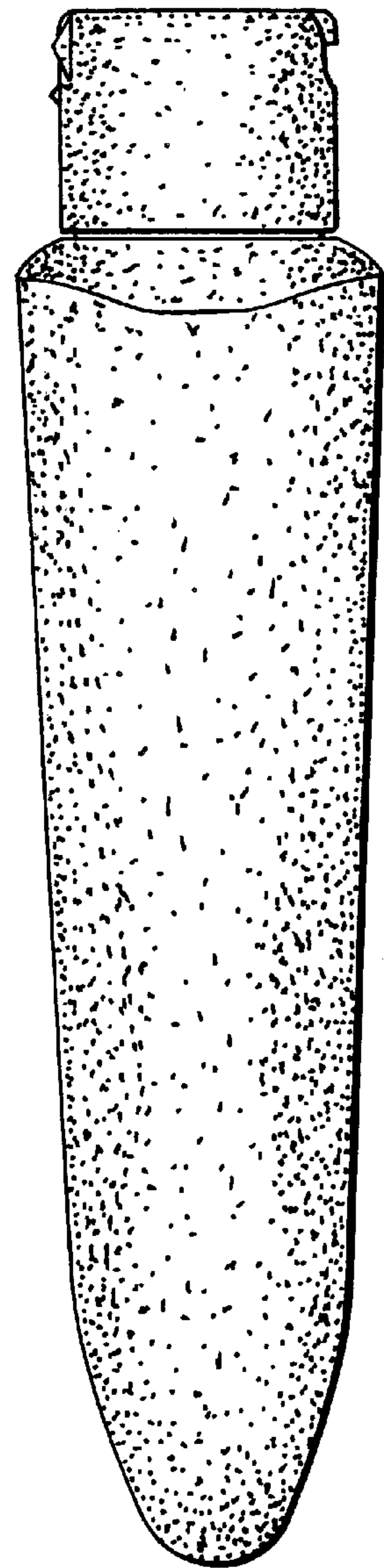

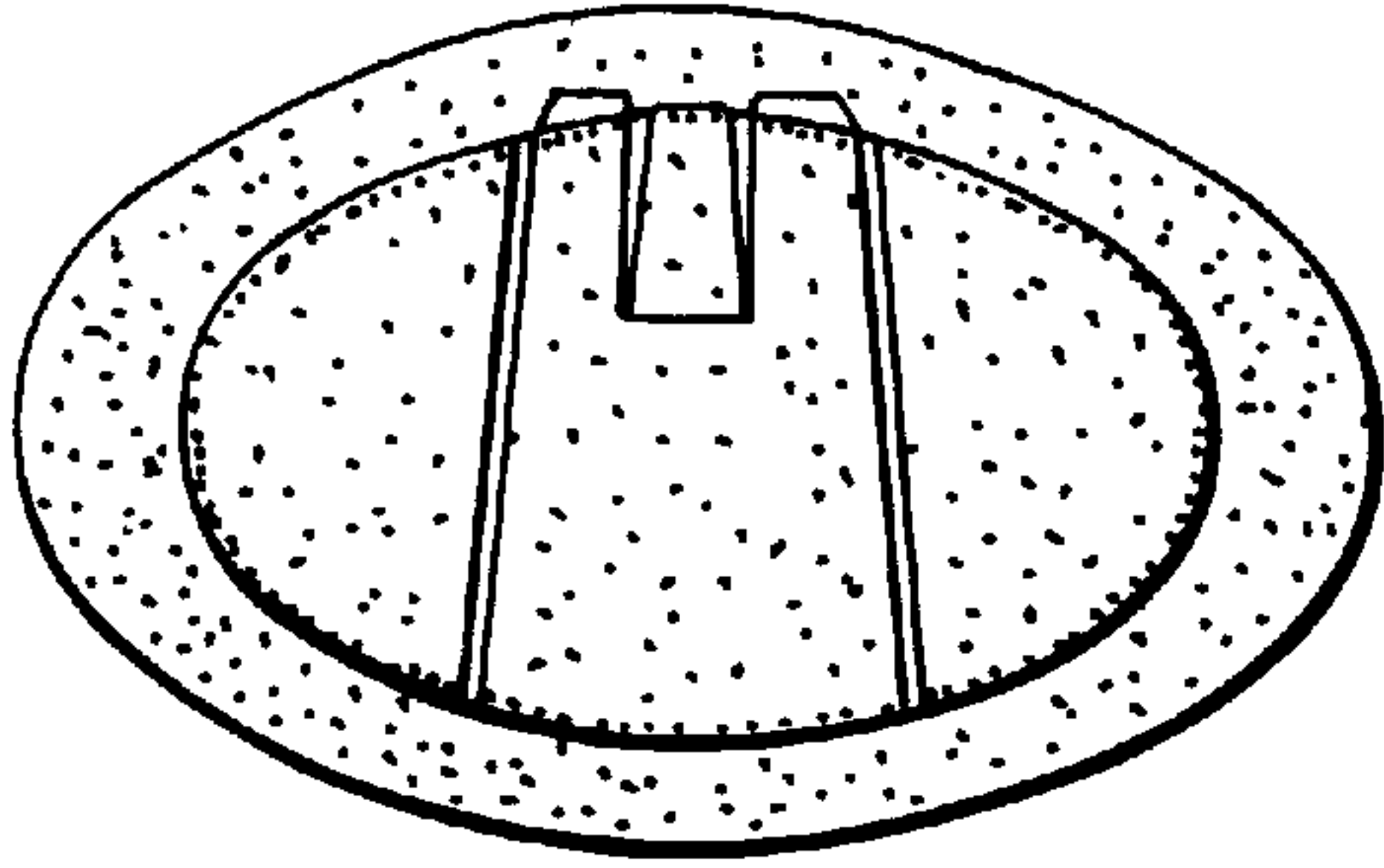




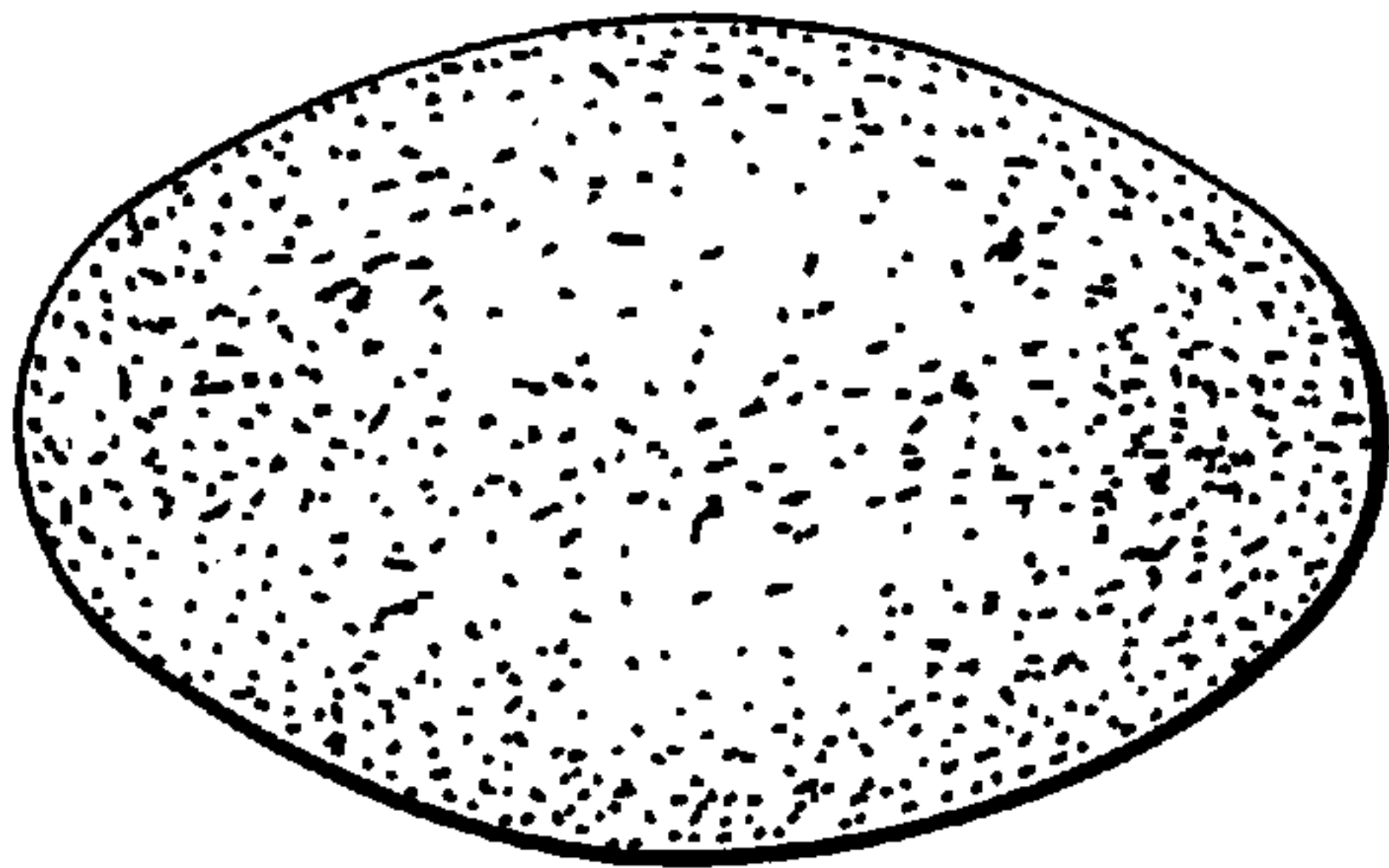

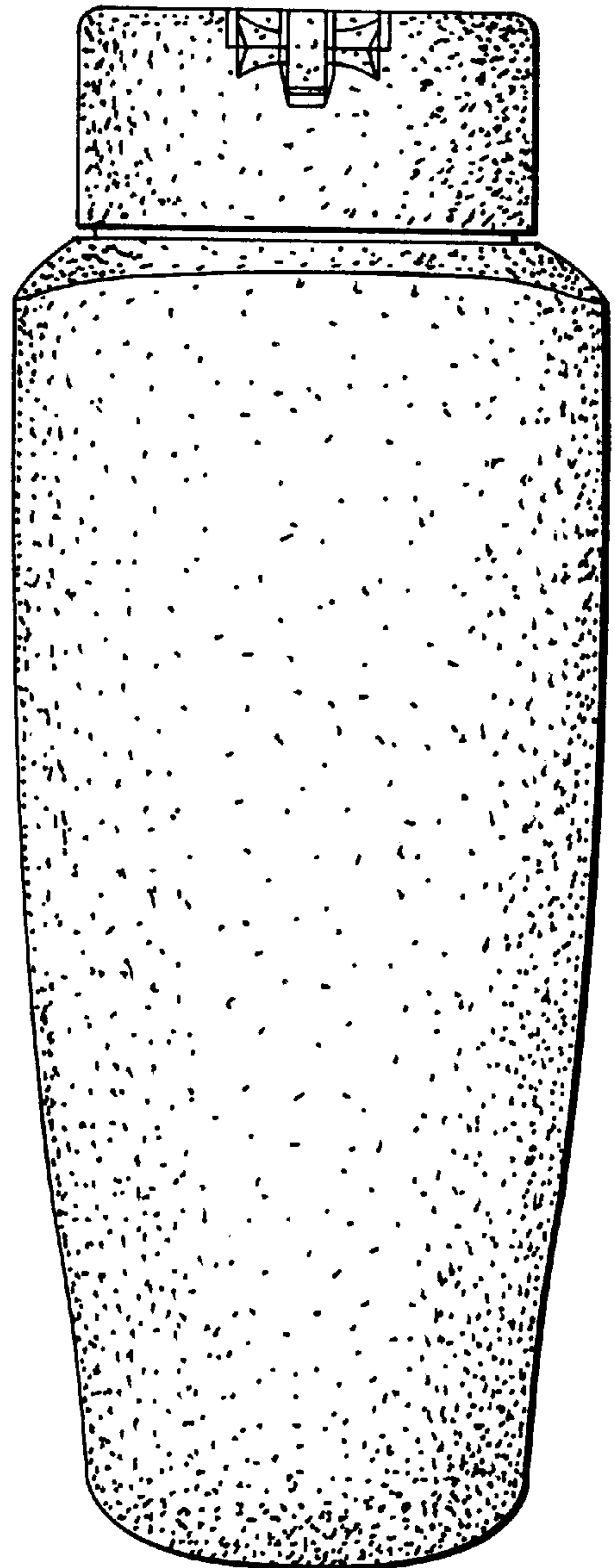
