(57) **CLAIM**

I claim the ornamental design for a water sprinkling head for a car, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of the water sprinkling head for a car showing my design. The broken away disclosure shows a water line of indeterminate lengths.

FIG. 2 is a front view thereof.

FIG. 3 is a back view thereof. The broken away disclosure shows the water line of indeterminate length.

FIG. 4 is a side view thereof. The broken away disclosure shows the water line of indeterminate length.

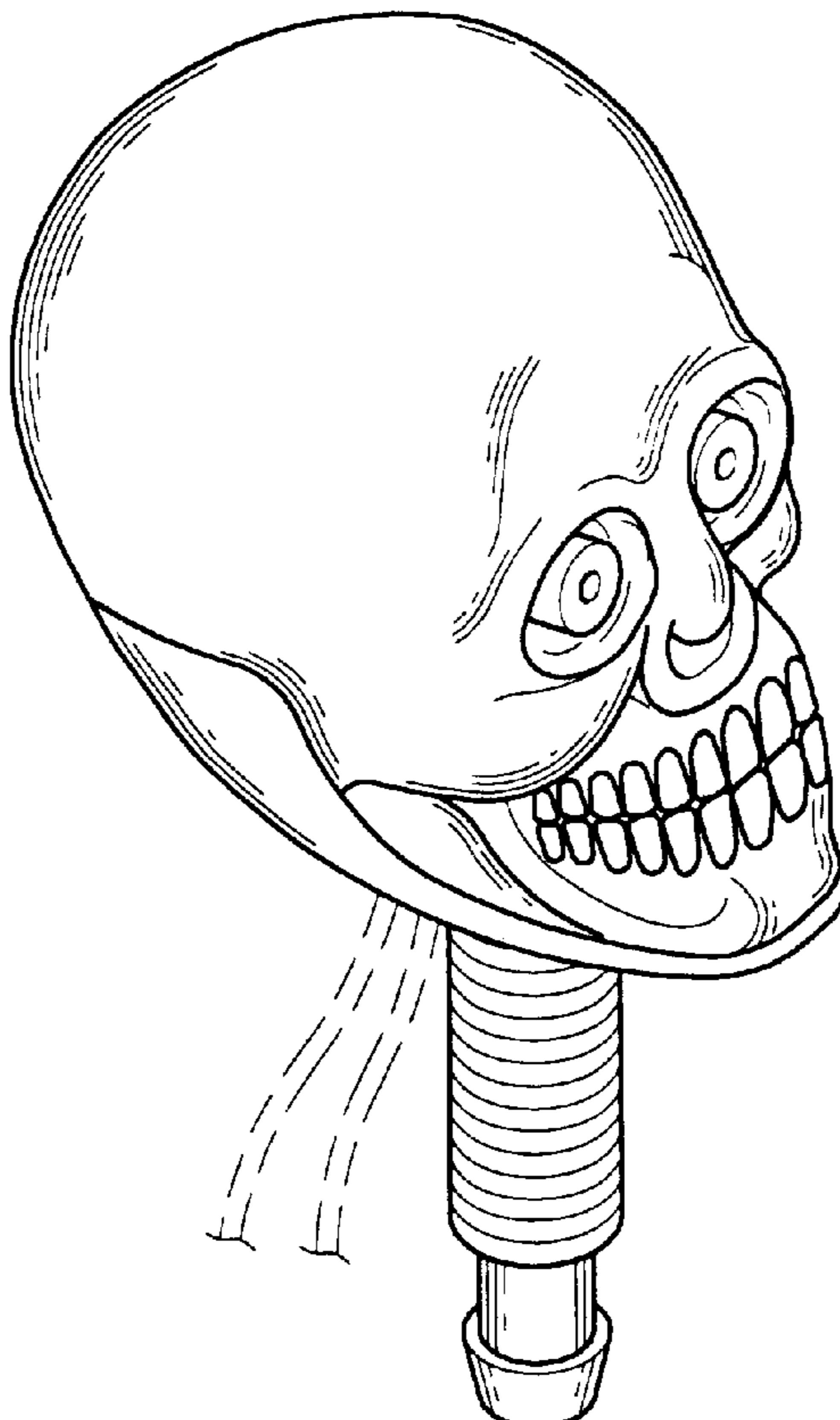
FIG. 5 is an opposite side view thereof. The broken away disclosure shows the water line of indeterminate length.

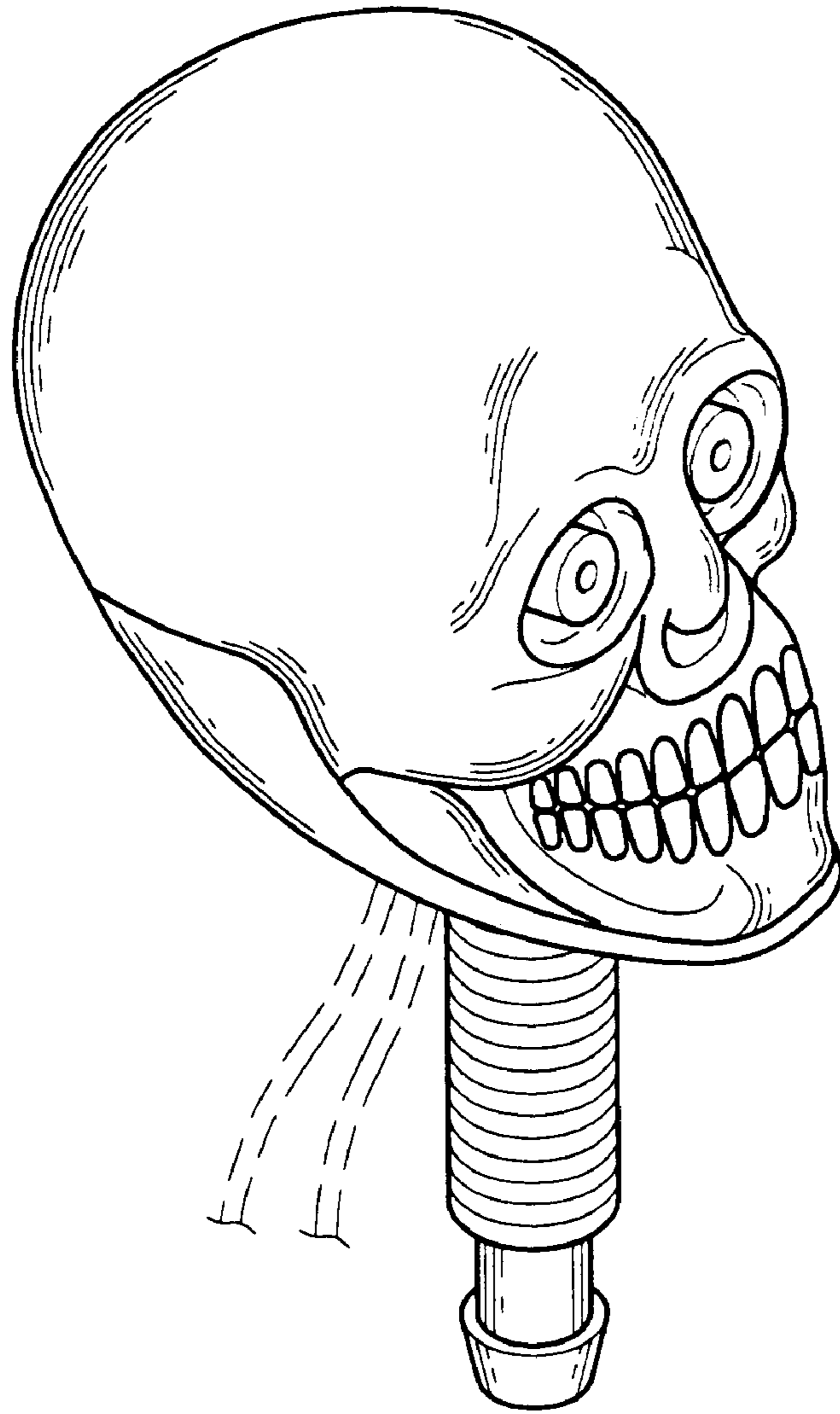

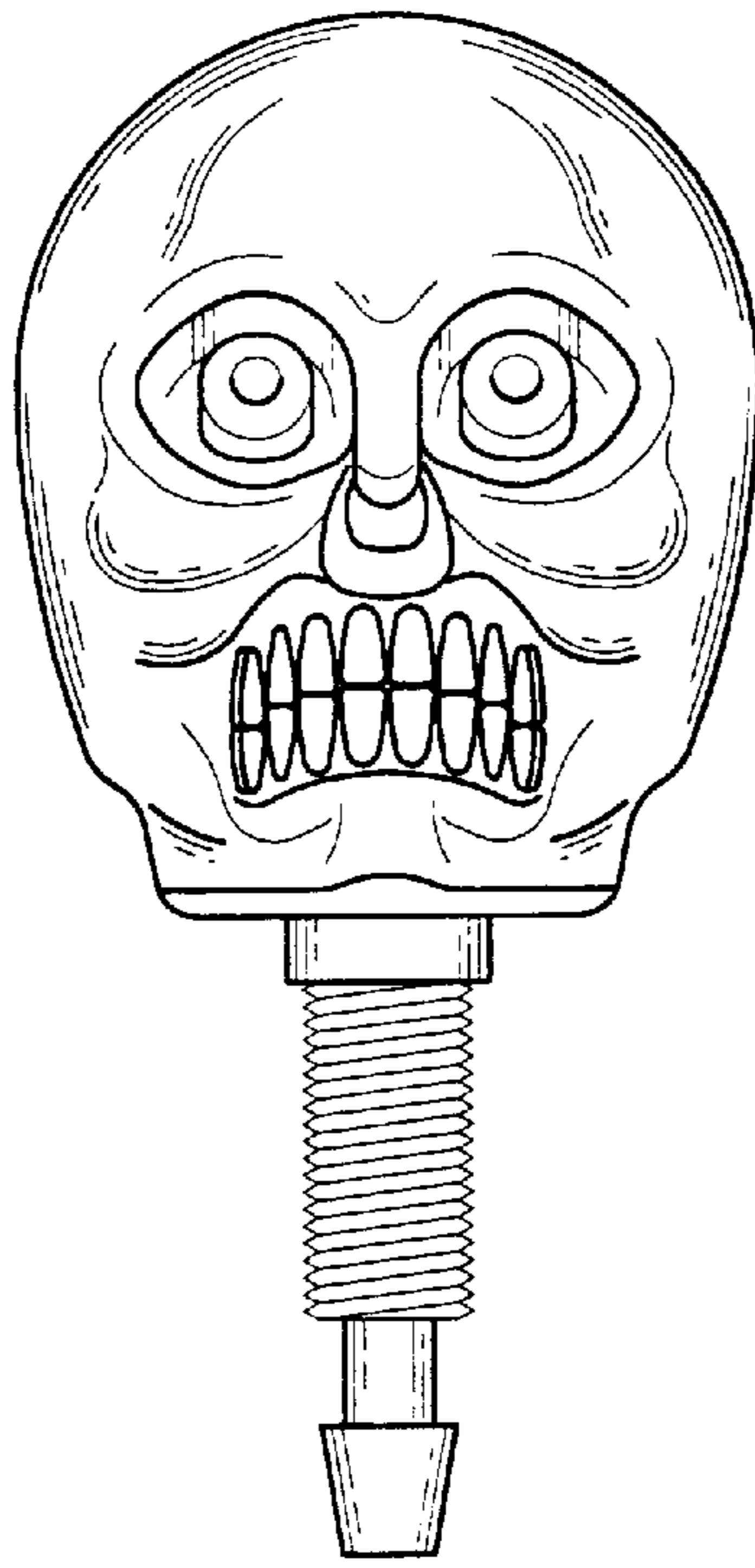

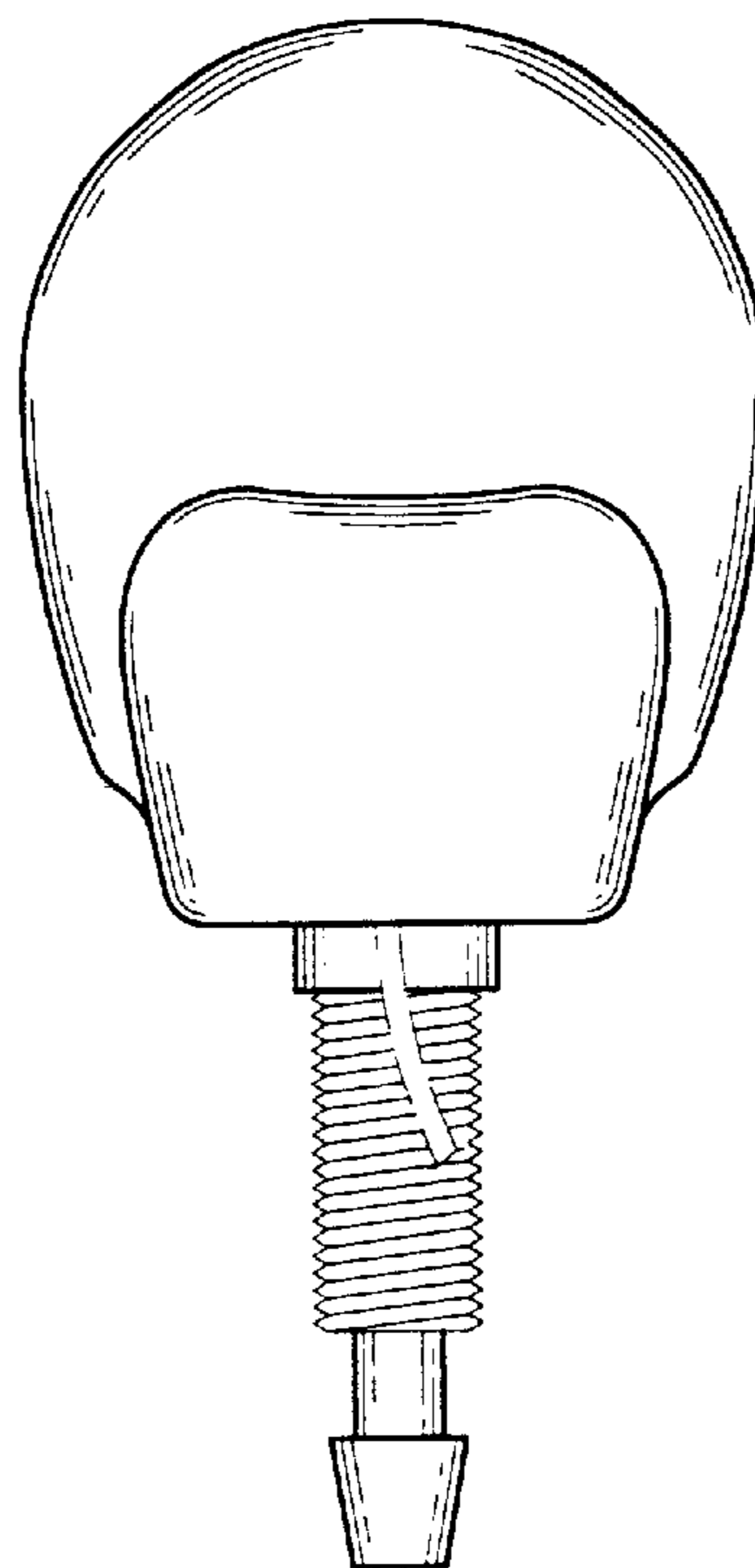

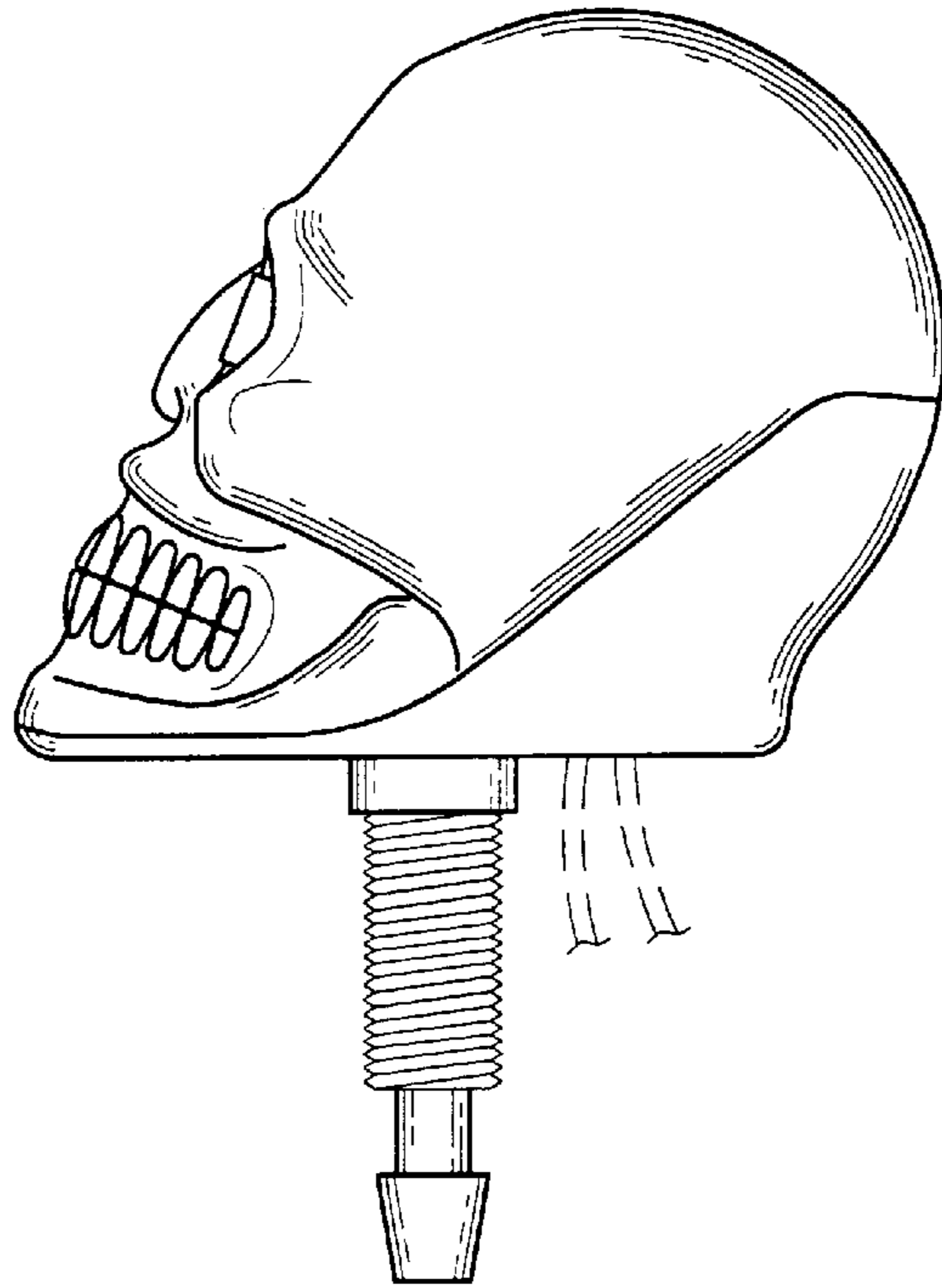

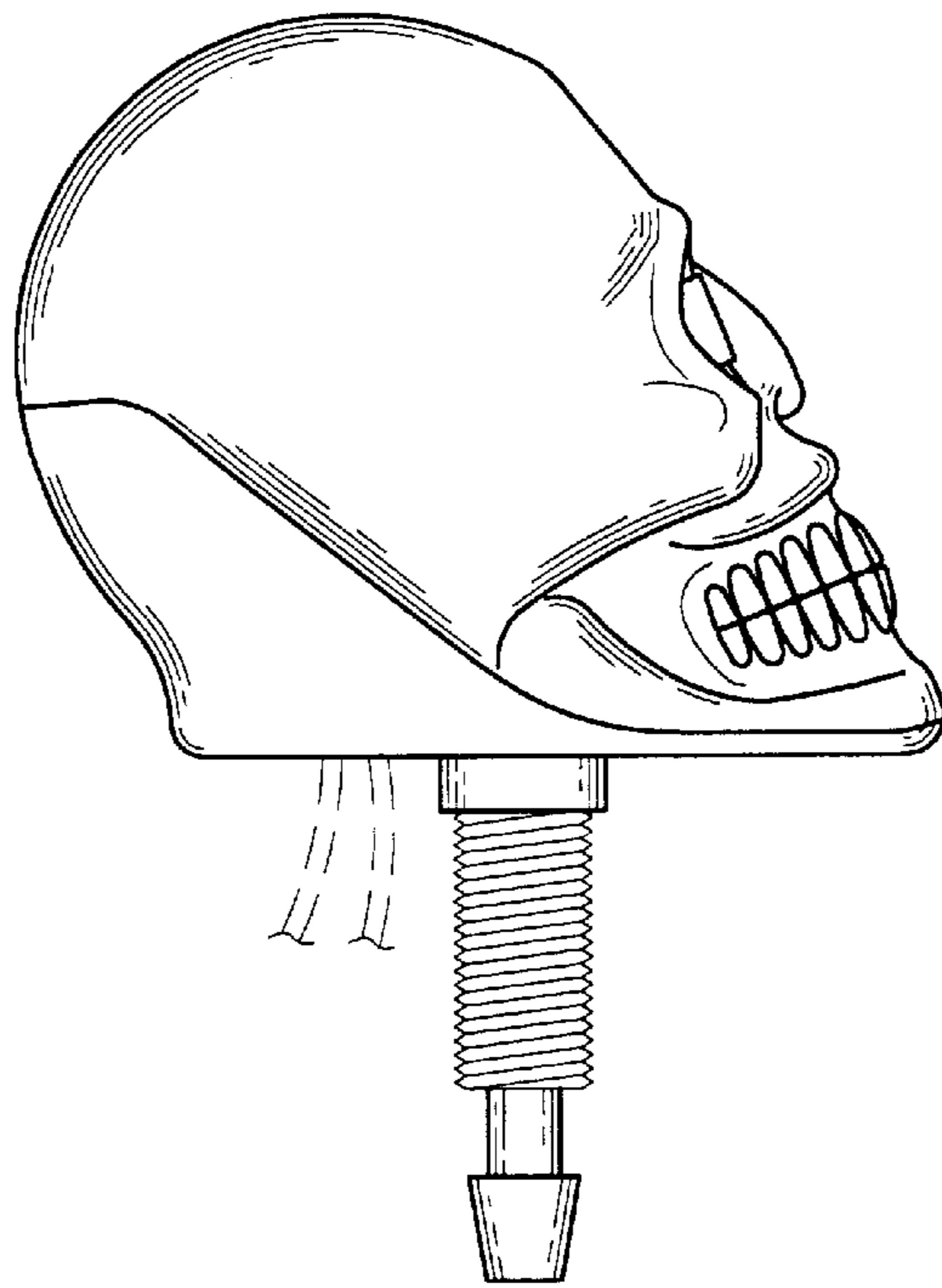

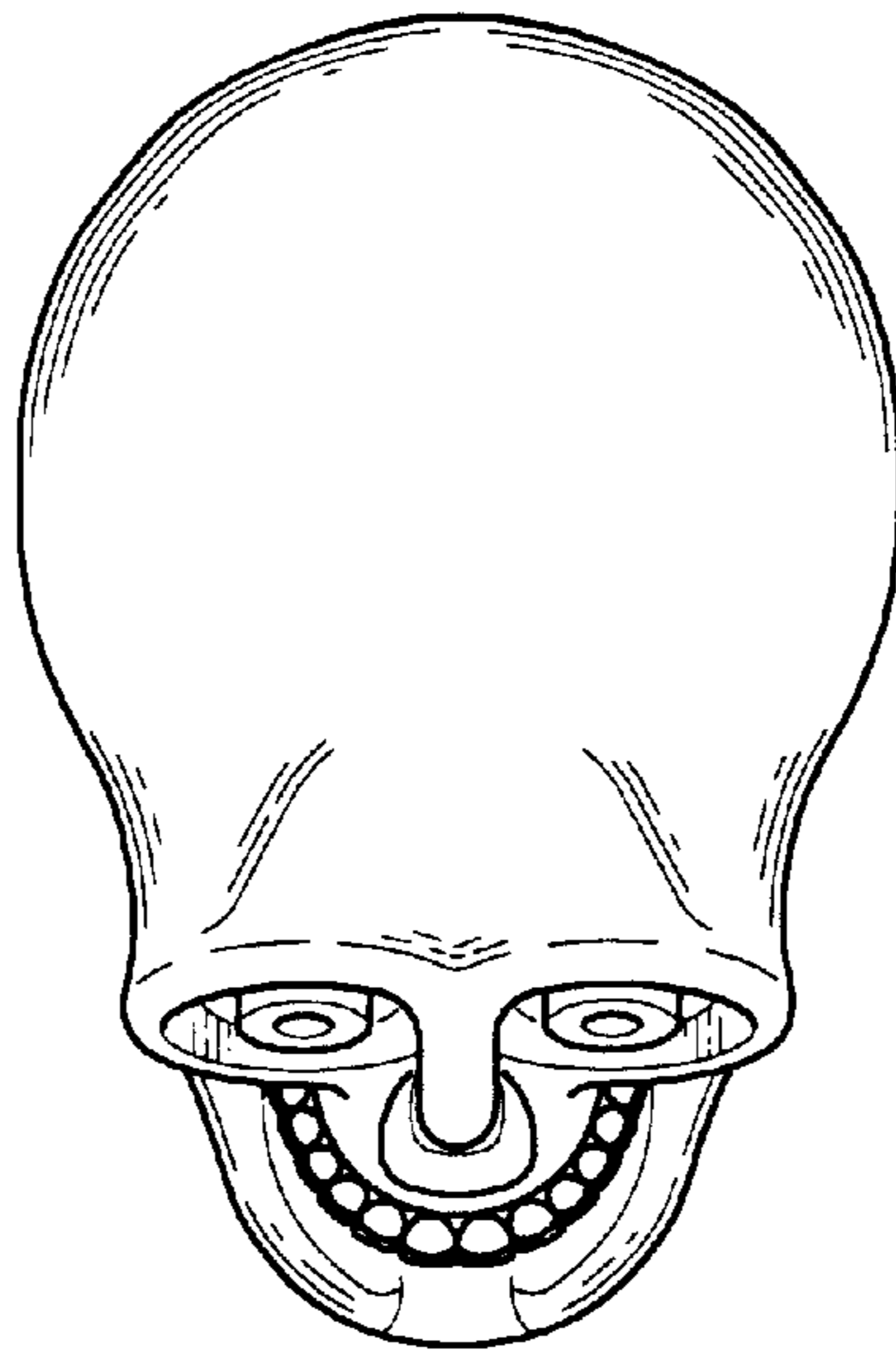

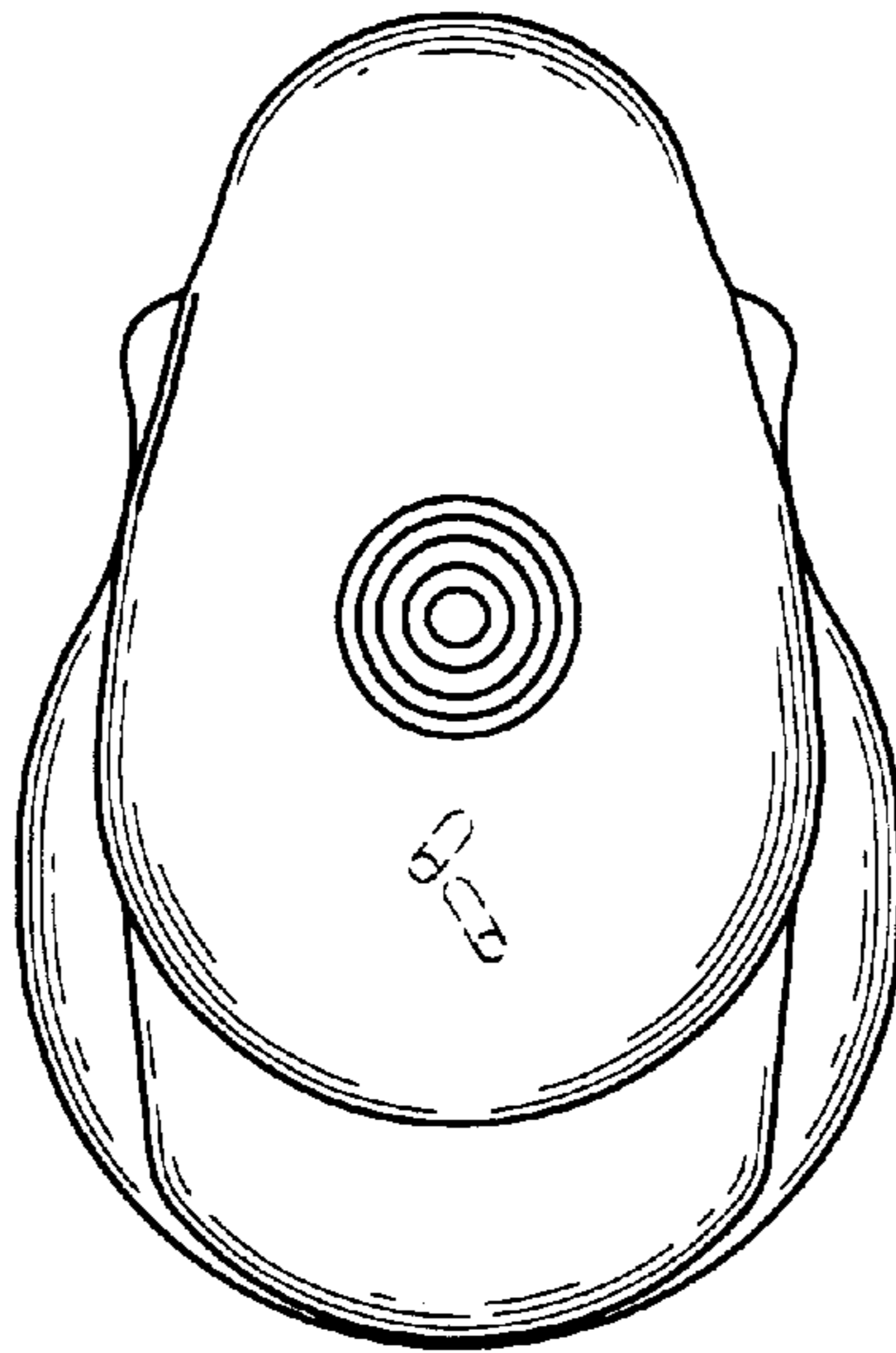

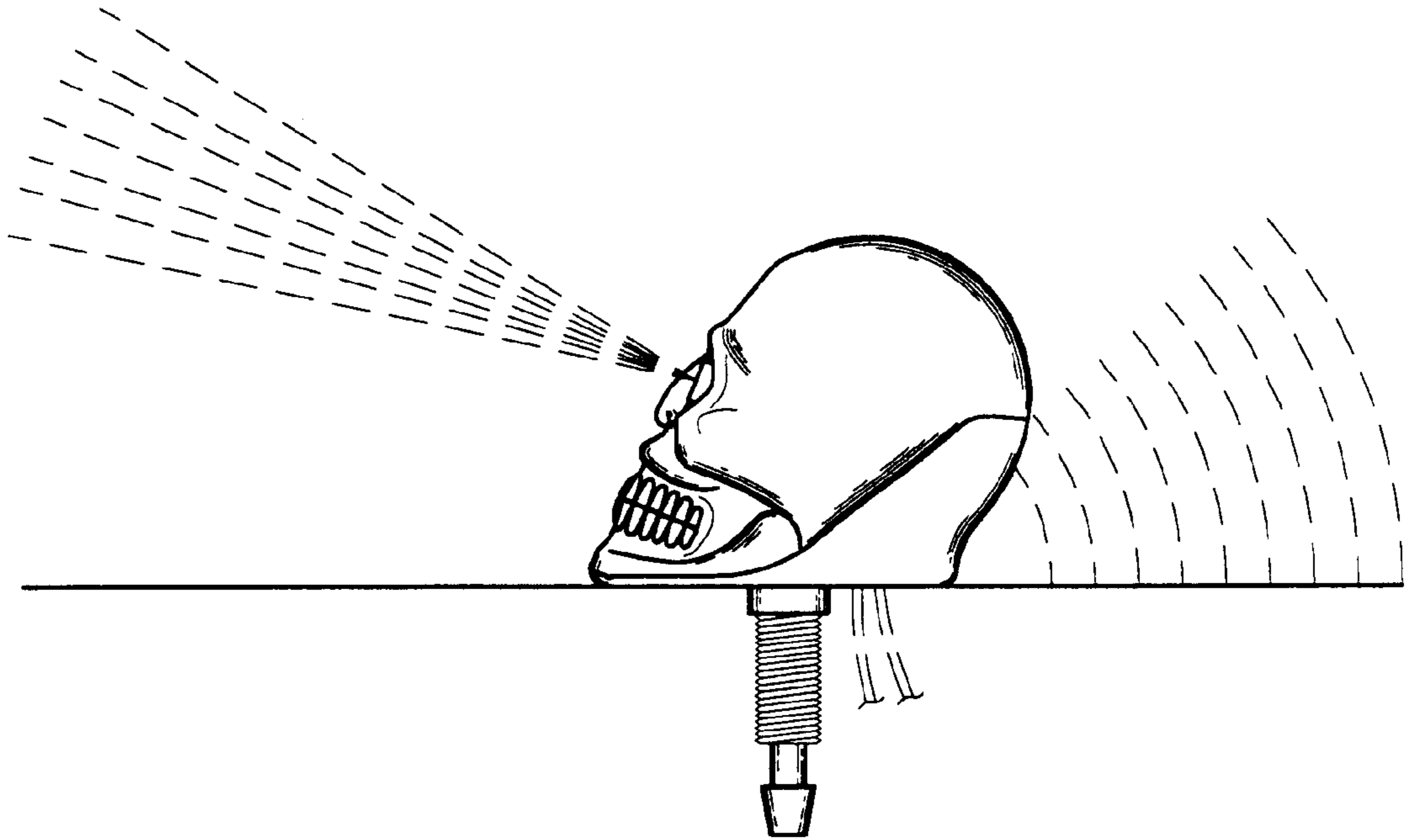
