(57) **CLAIM**

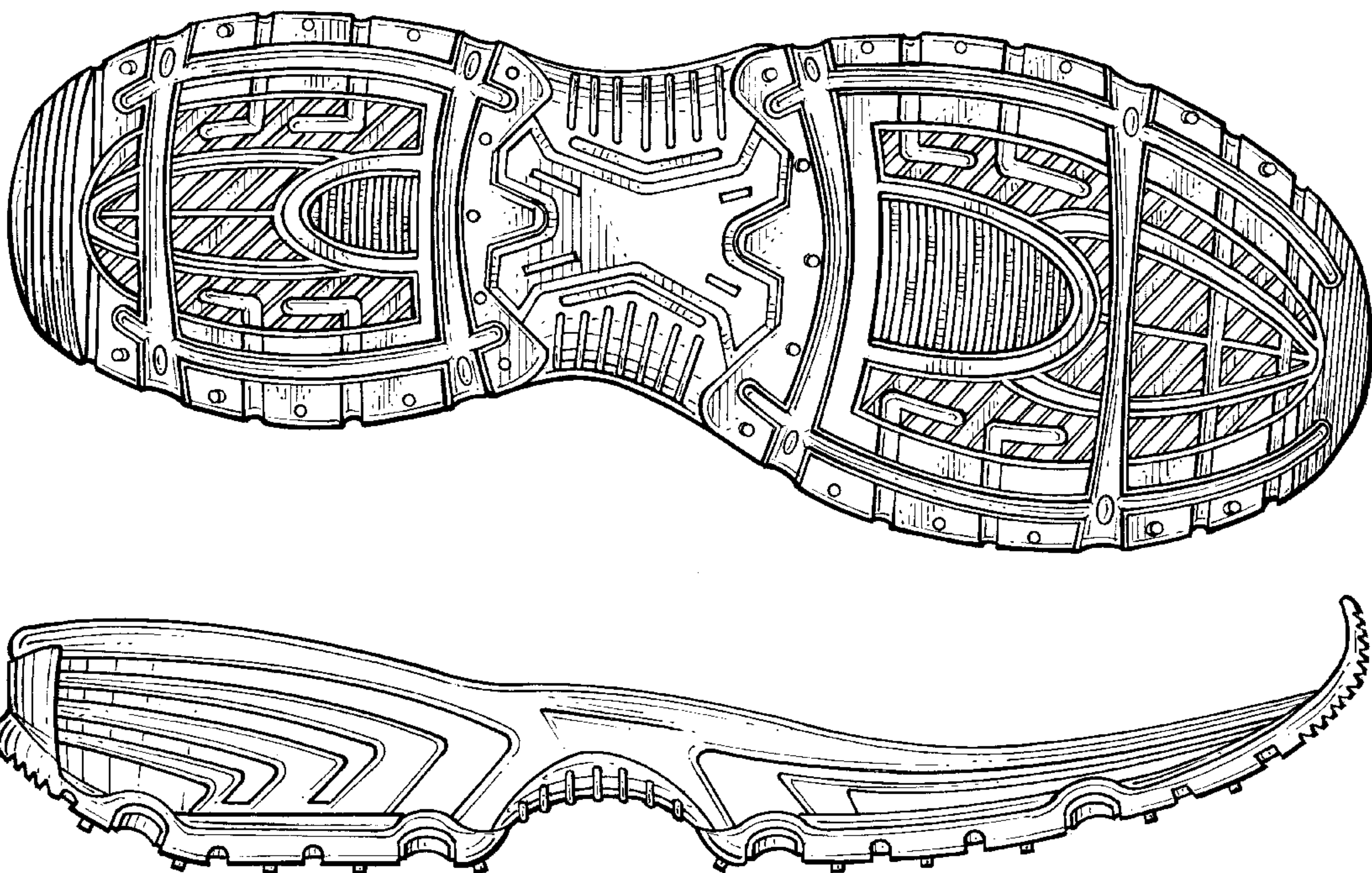
The ornamental design for a shoe bottom, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the shoe bottom showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a left elevational view thereof;
FIG. 4 is a right elevational view thereof;
FIG. 5 is a front elevational view thereof; and,
FIG. 6 is a rear elevational view.

The broken line showing the shoe upper in the figures are for illustrative purposes only and form no part of the claimed design.

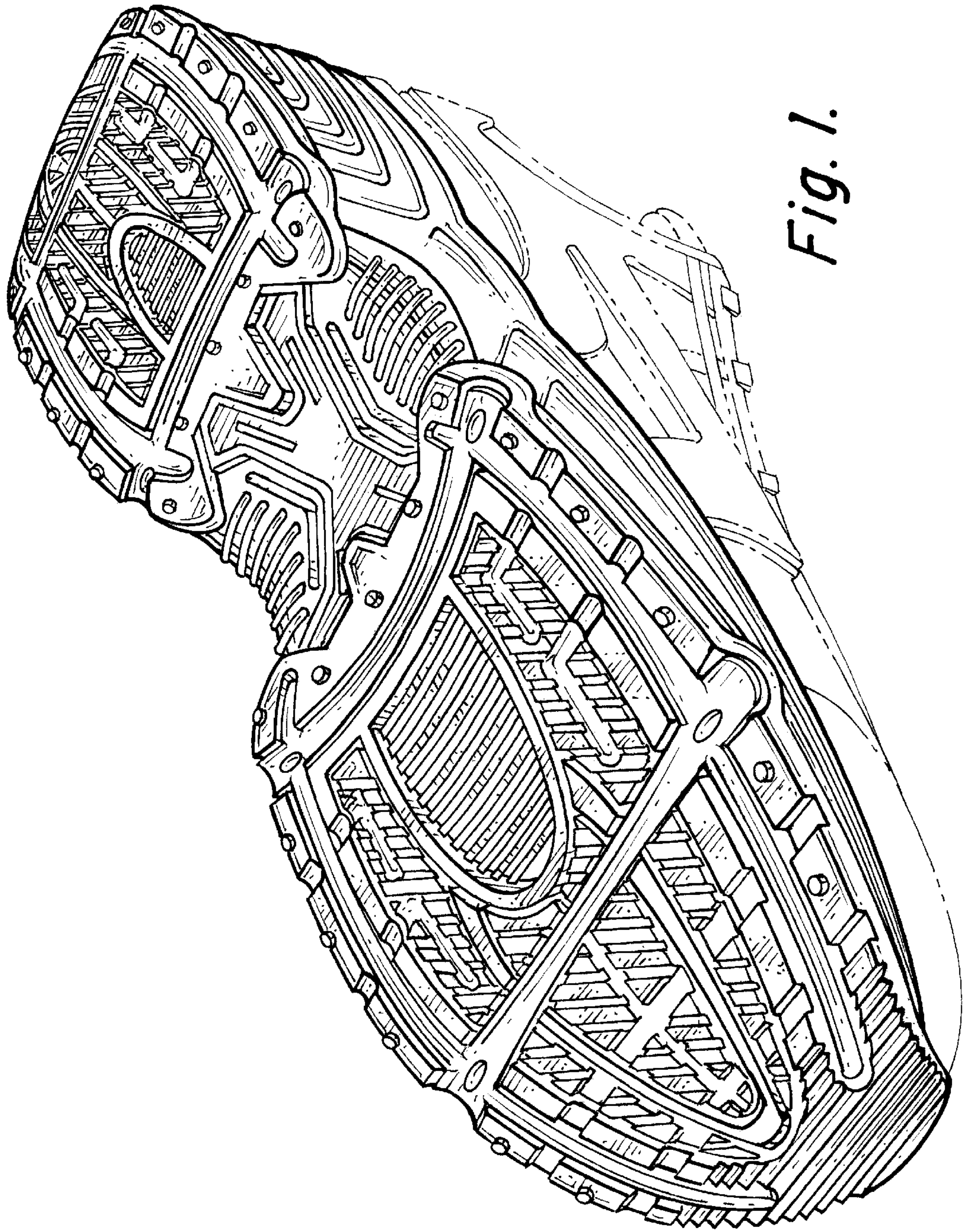

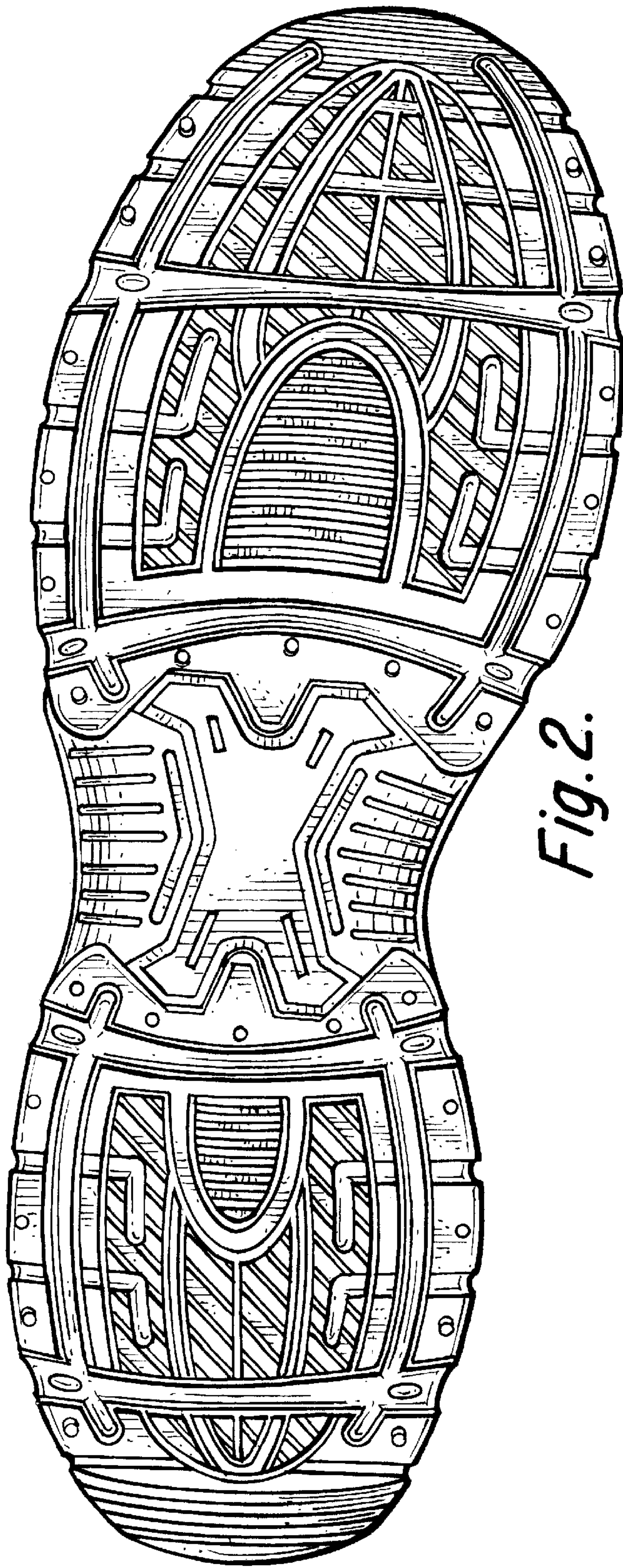

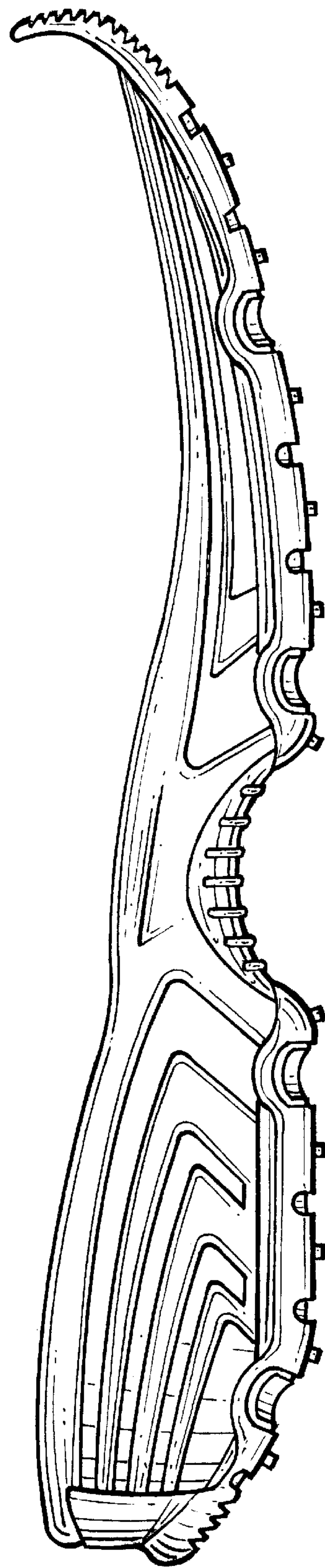

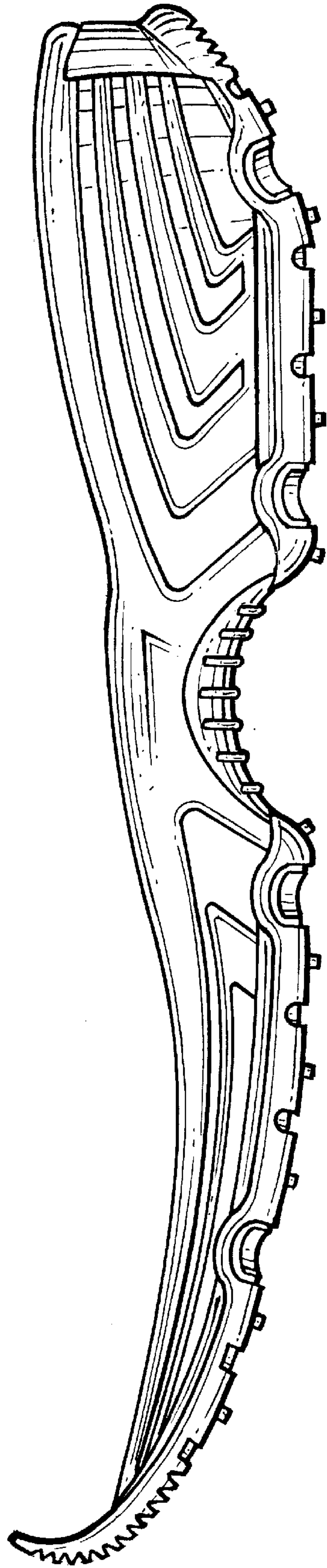

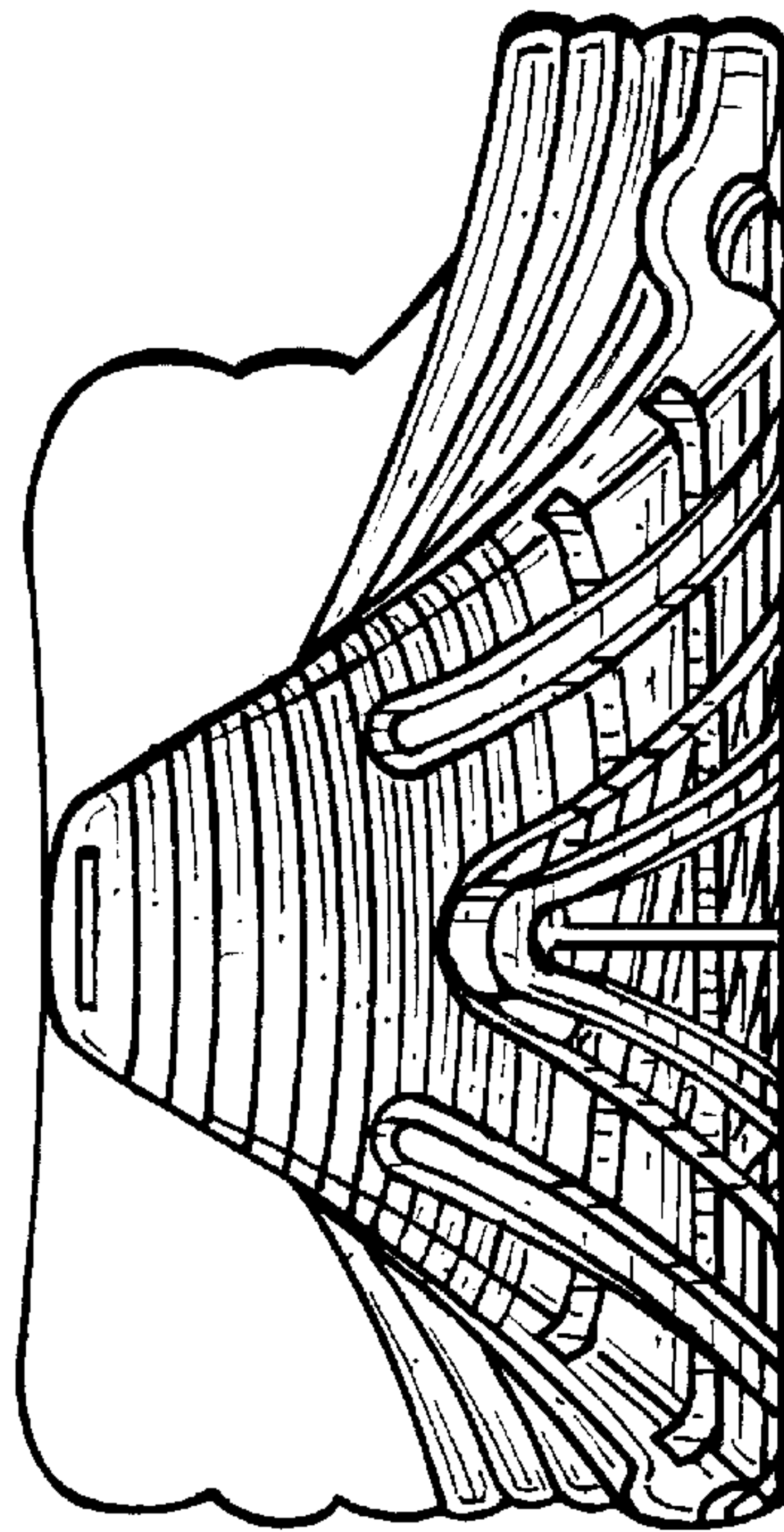

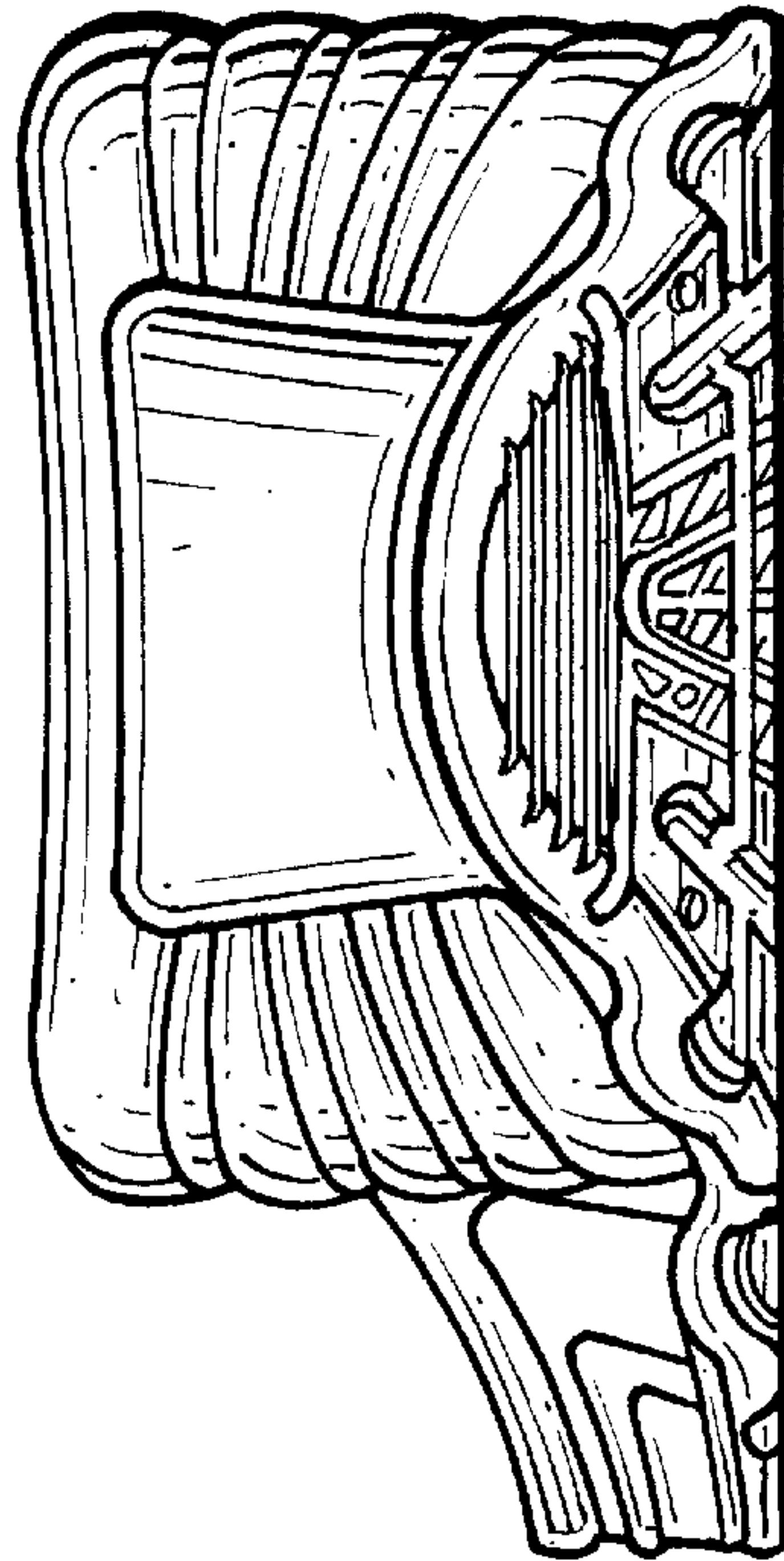
