FIG. 1 is a side front perspective view of a roll-up pencil case in its rolled up form showing my new design;

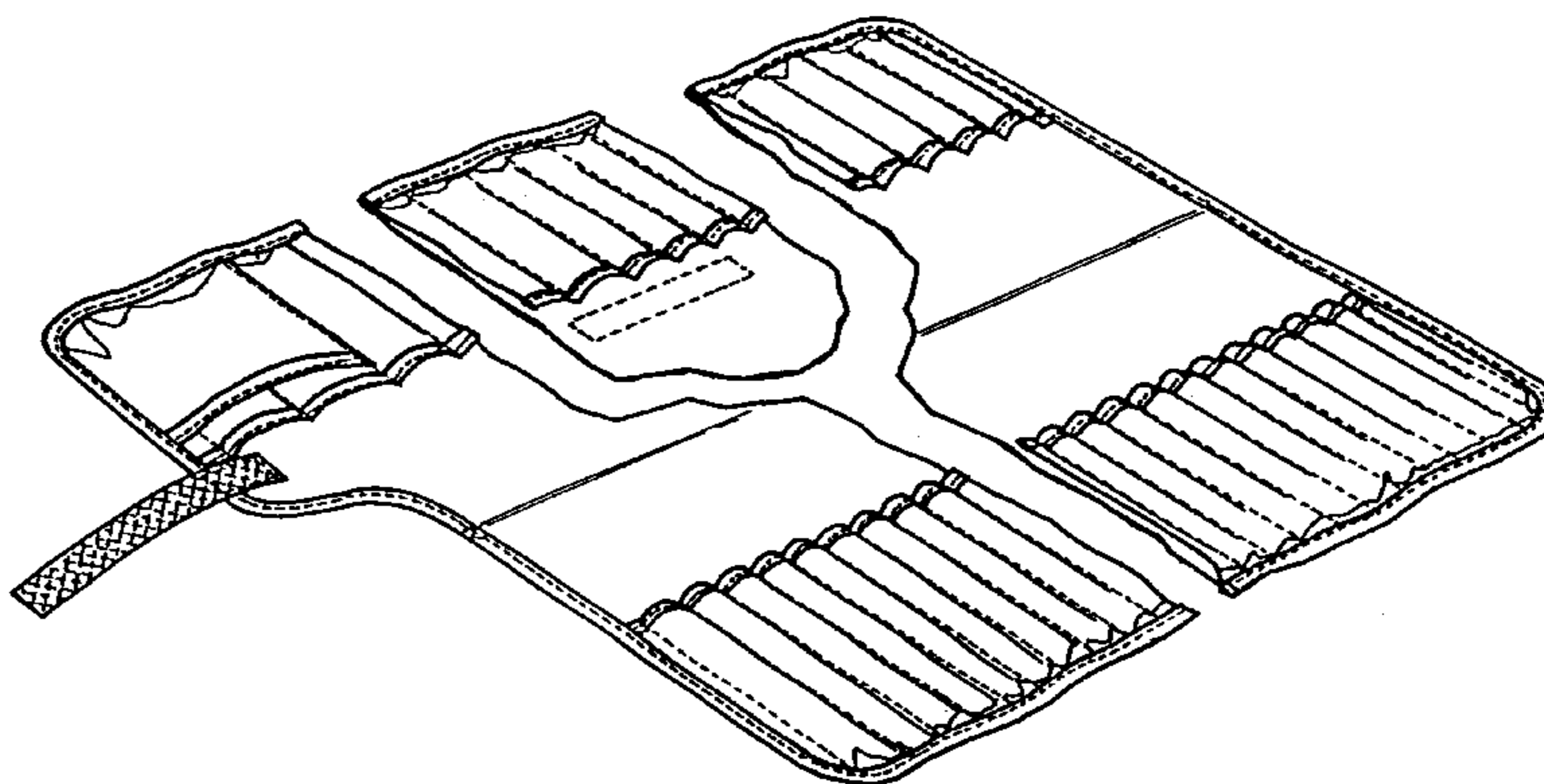
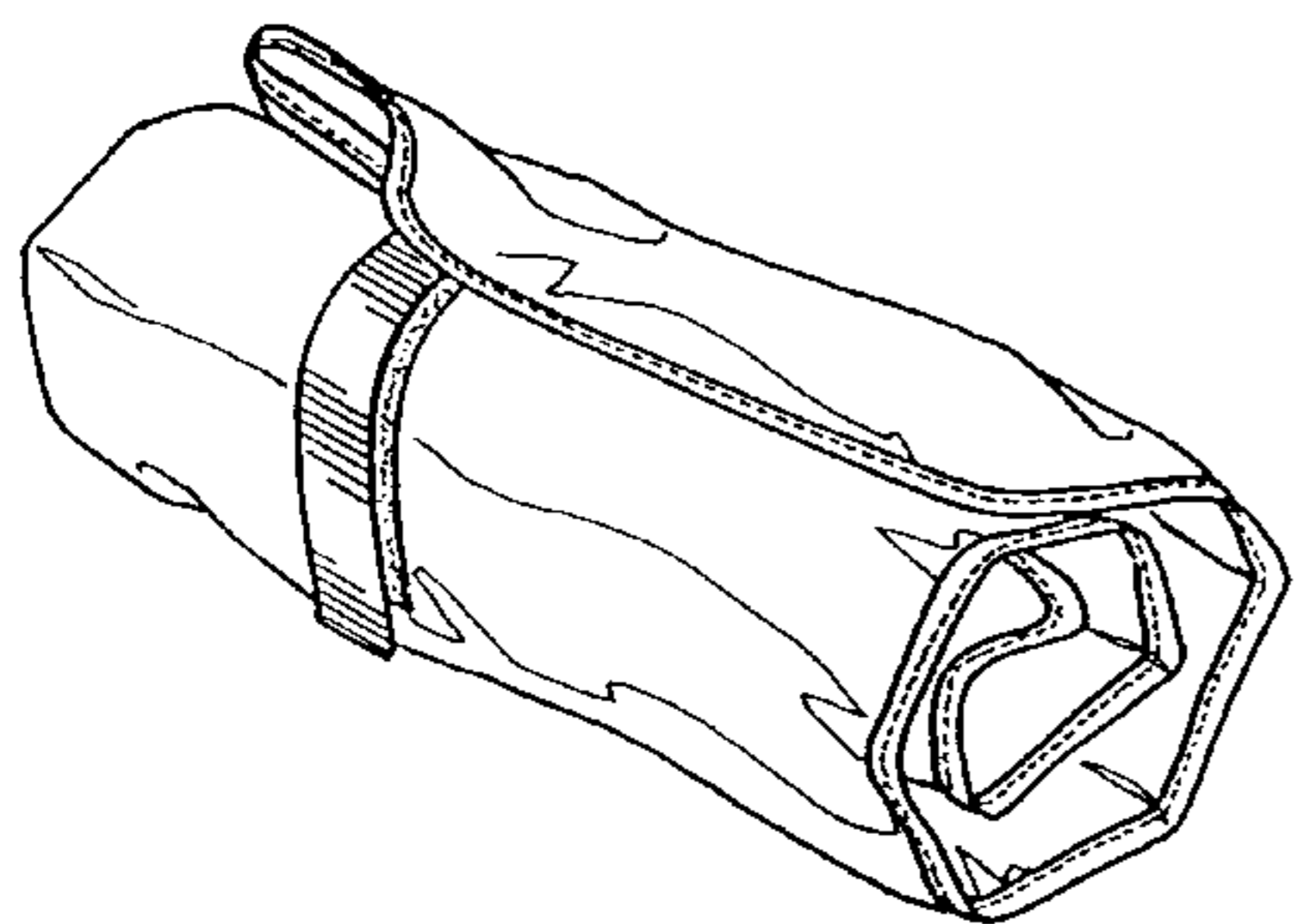
FIG. 2 is a perspective top view in its unrolled form thereof;

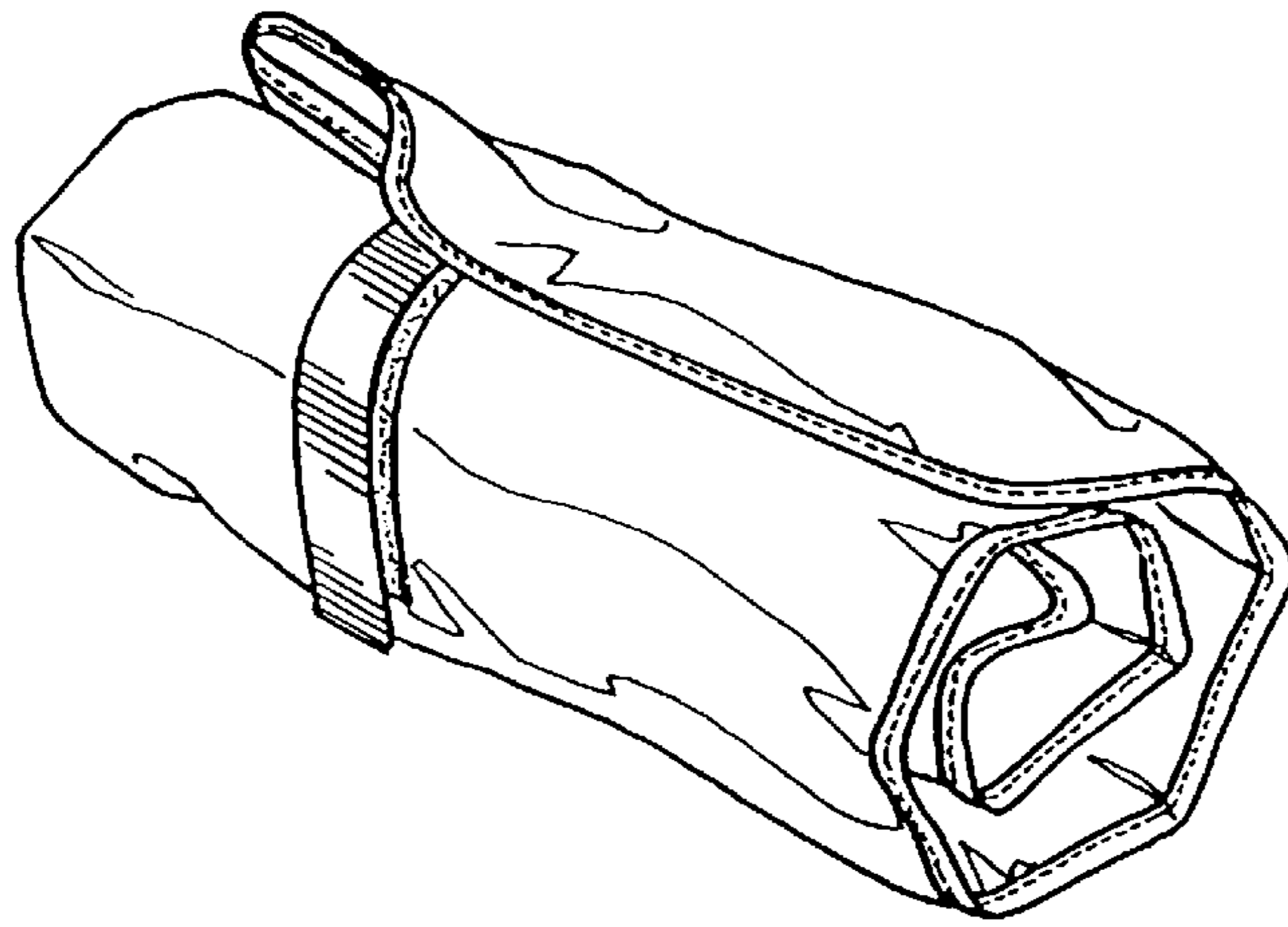

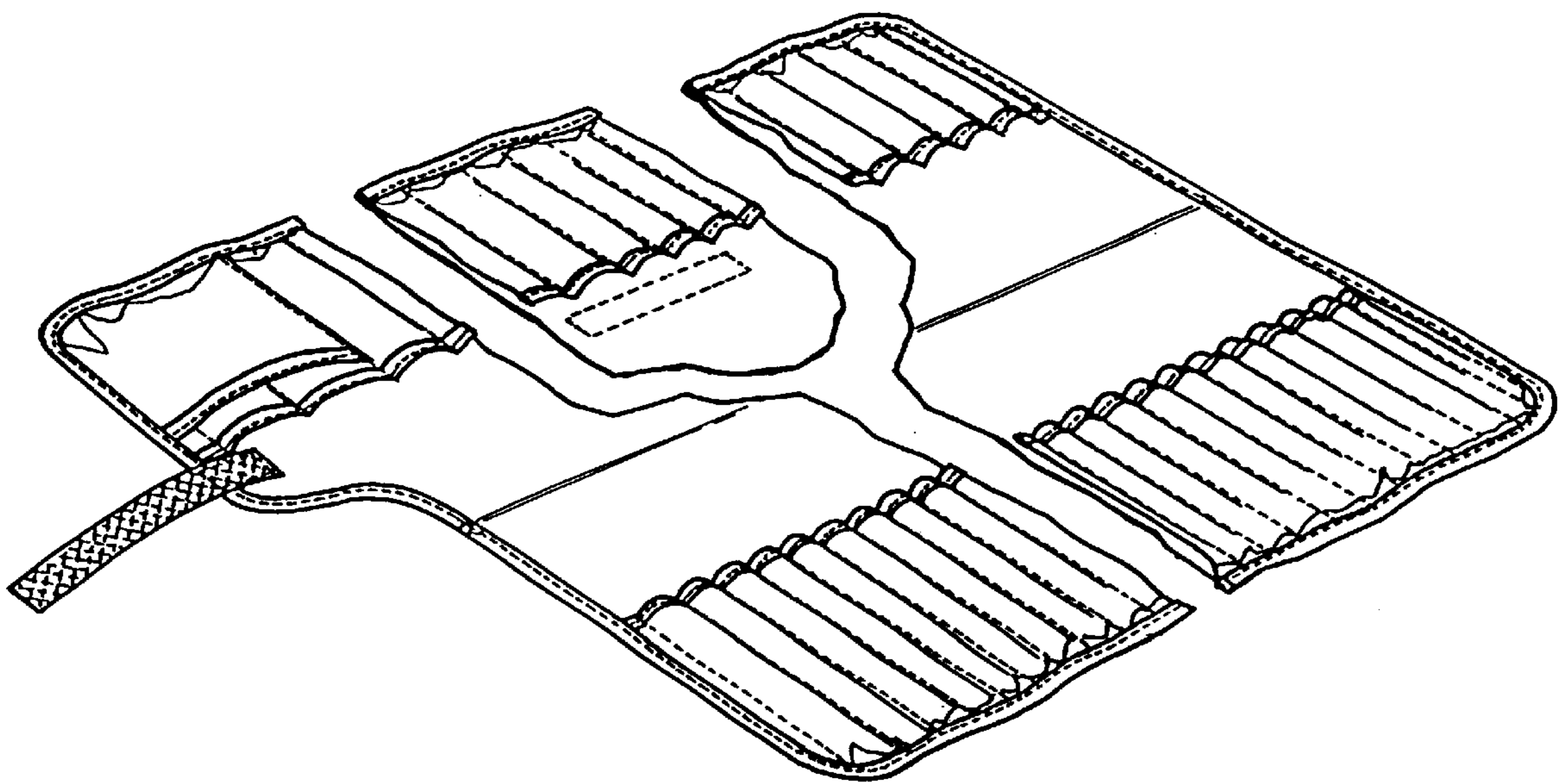
