(57) **CLAIM**

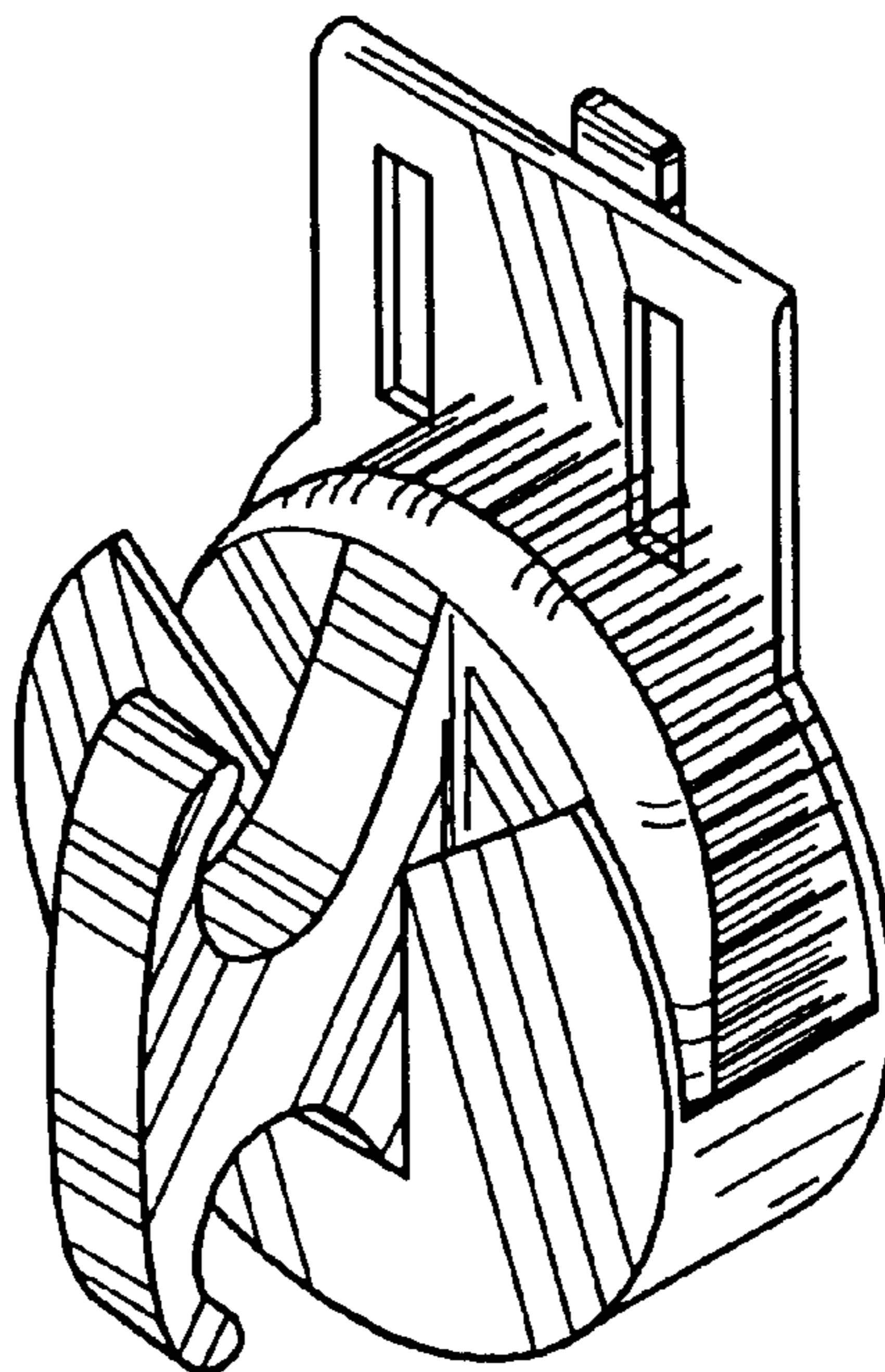
The ornamental design for a hair brush with carrying case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the hair brush portion of the hair brush with carrying case showing my new design; FIG. 2 is top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevational view thereof, the opposite side being a mirror image thereof; FIG. 5 is a left side elevational view thereof, the opposite side being a mirror image thereof; FIG. 6 is a perspective view of the carrying case portion of the hair brush with carrying case showing my new design; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom view thereof; FIG. 9 is a front elevational view thereof; FIG. 10 is a rear elevational view thereof; FIG. 11 is a left side elevational view thereof, the opposite side being a mirror image thereof; and, FIG. 12 is a perspective view of the hair brush with carrying case thereof.

The hair brush and the carrying case are shown separately in some of the views for clarity of illustration only.

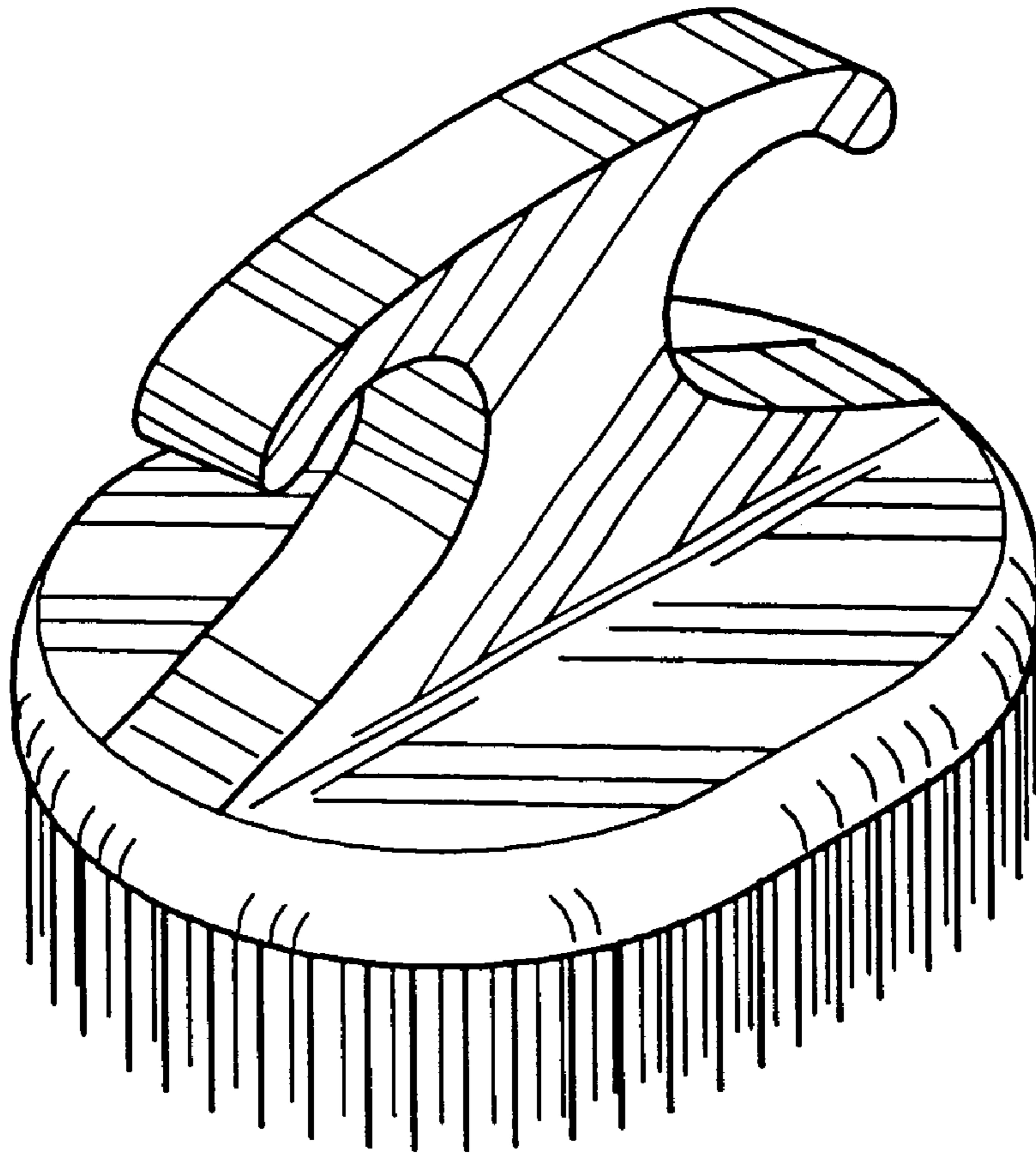

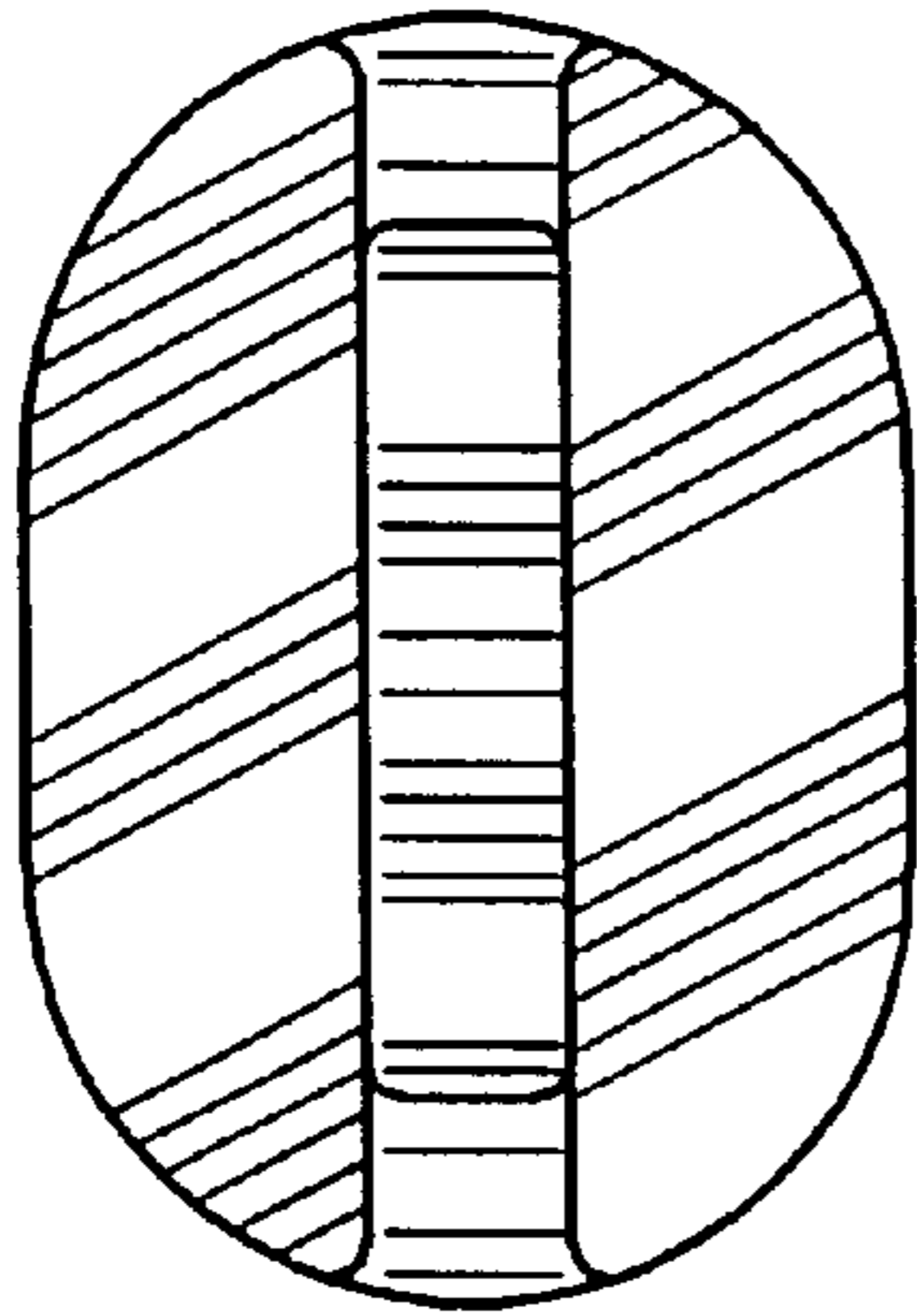

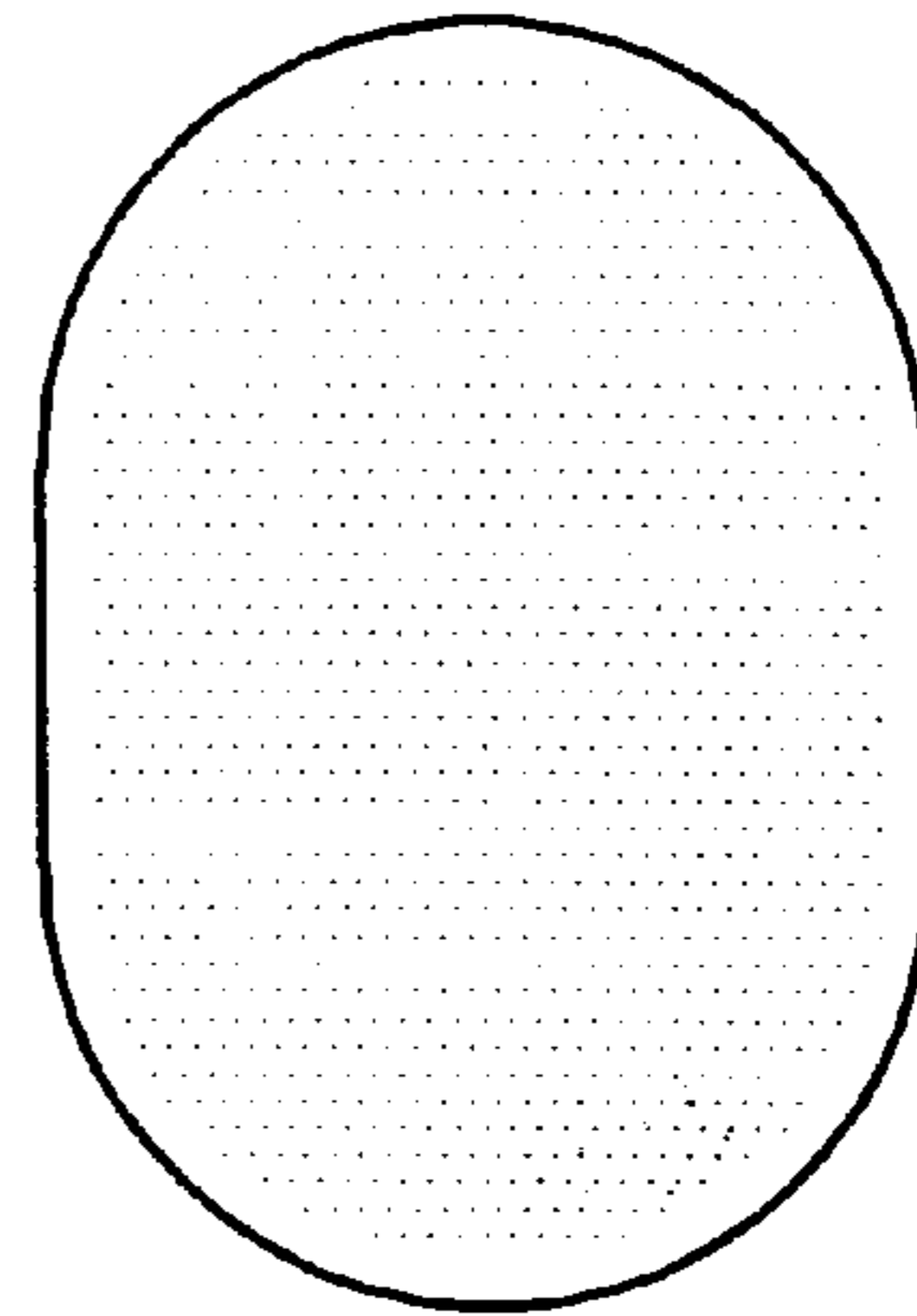

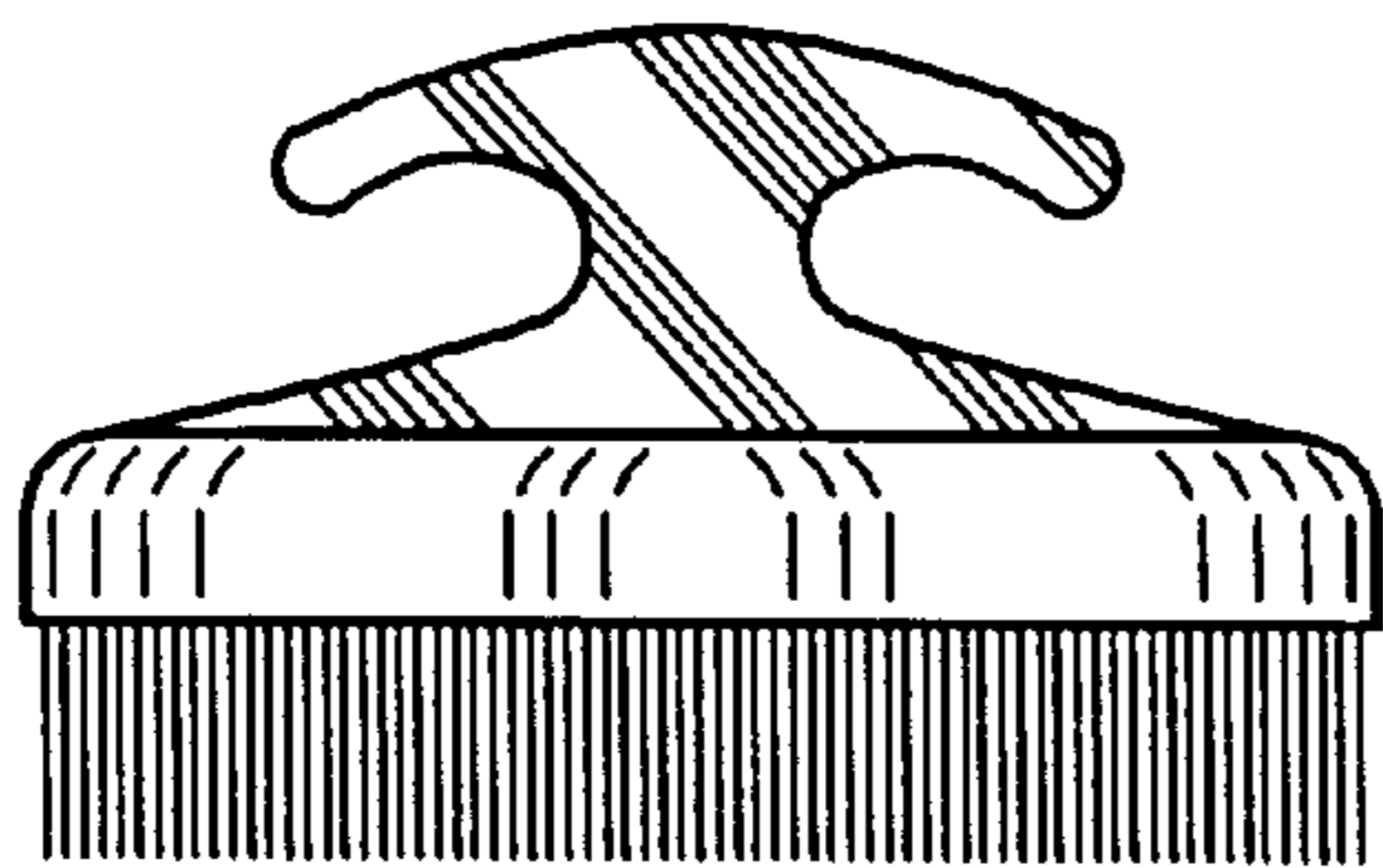

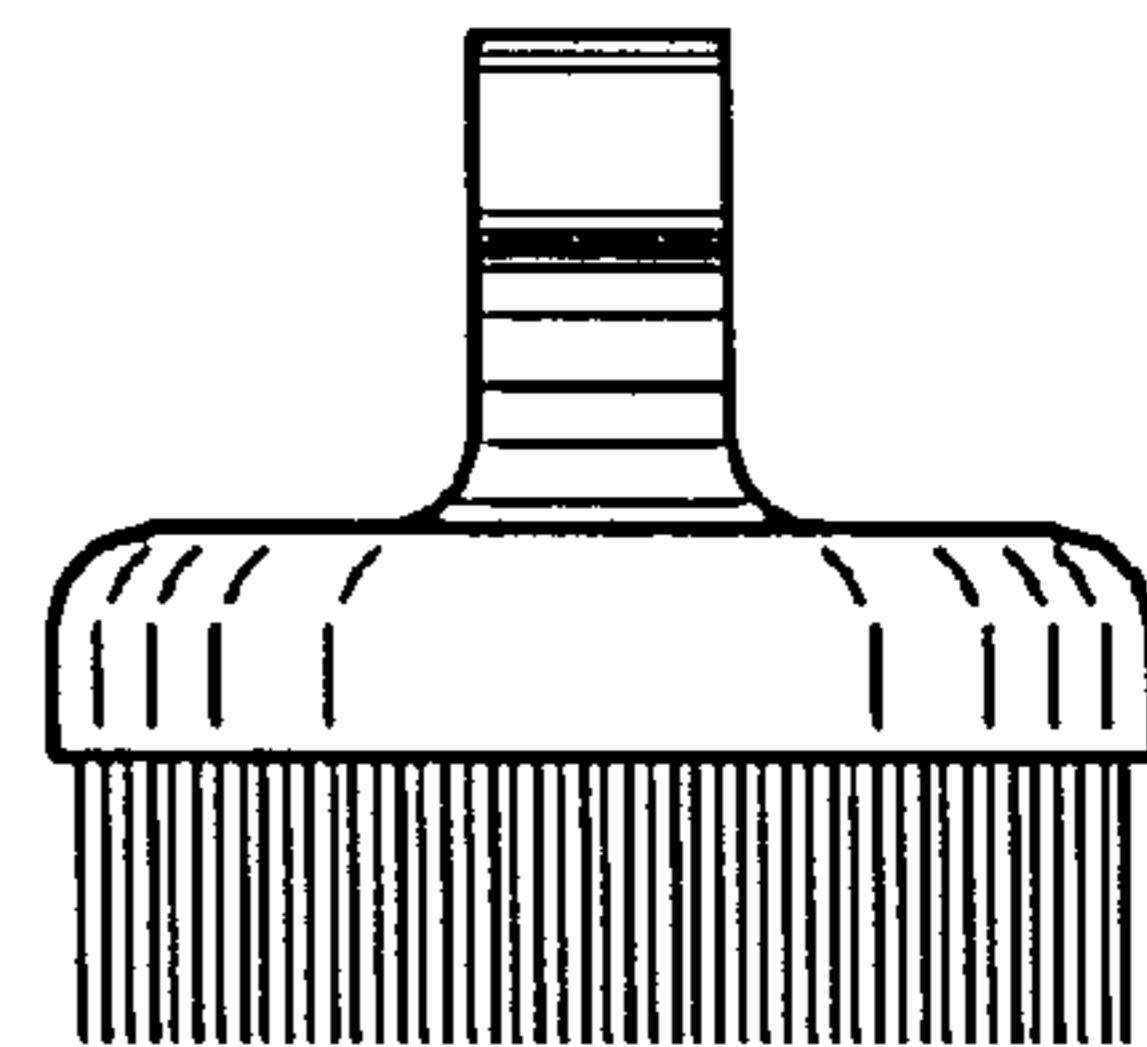

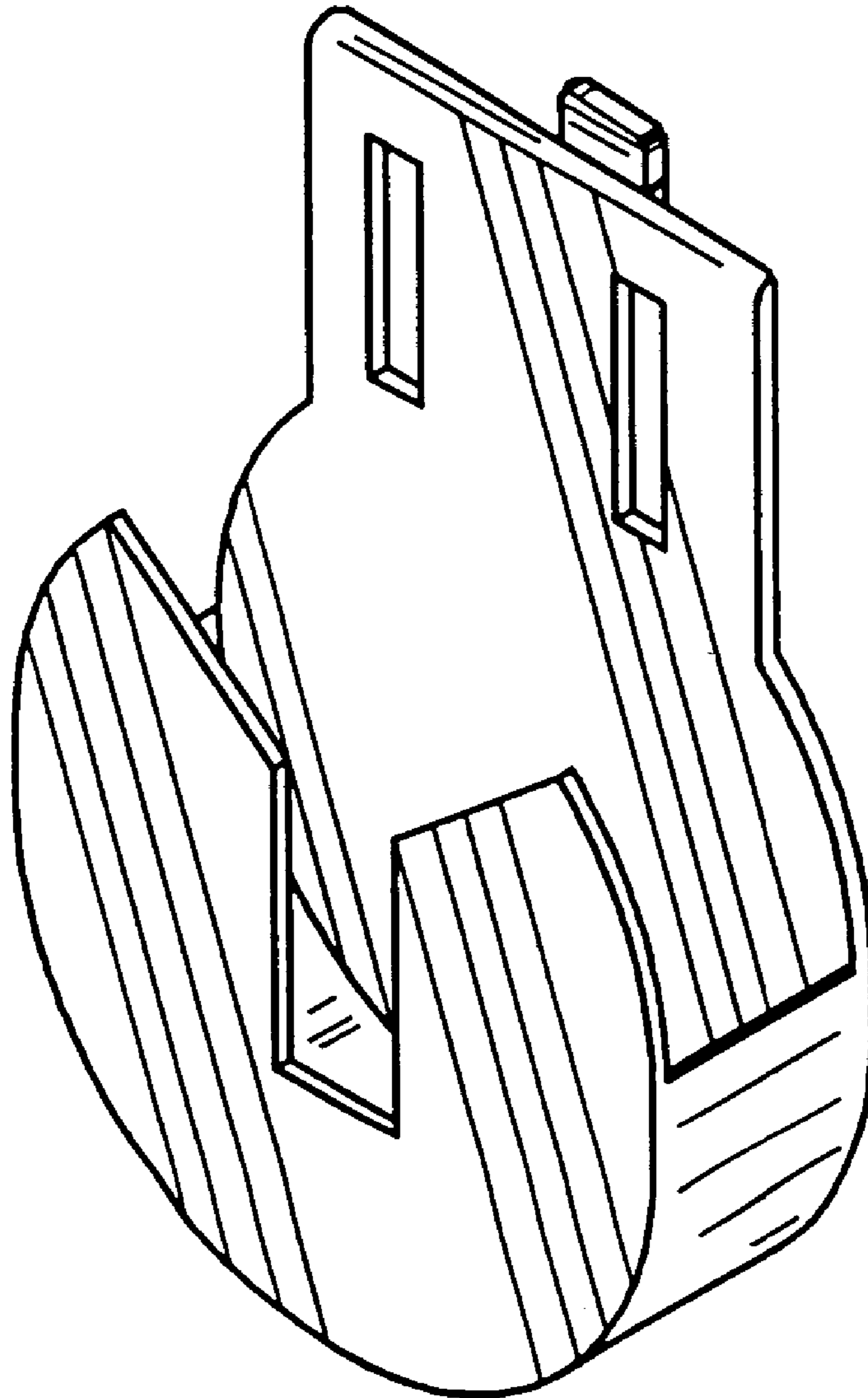

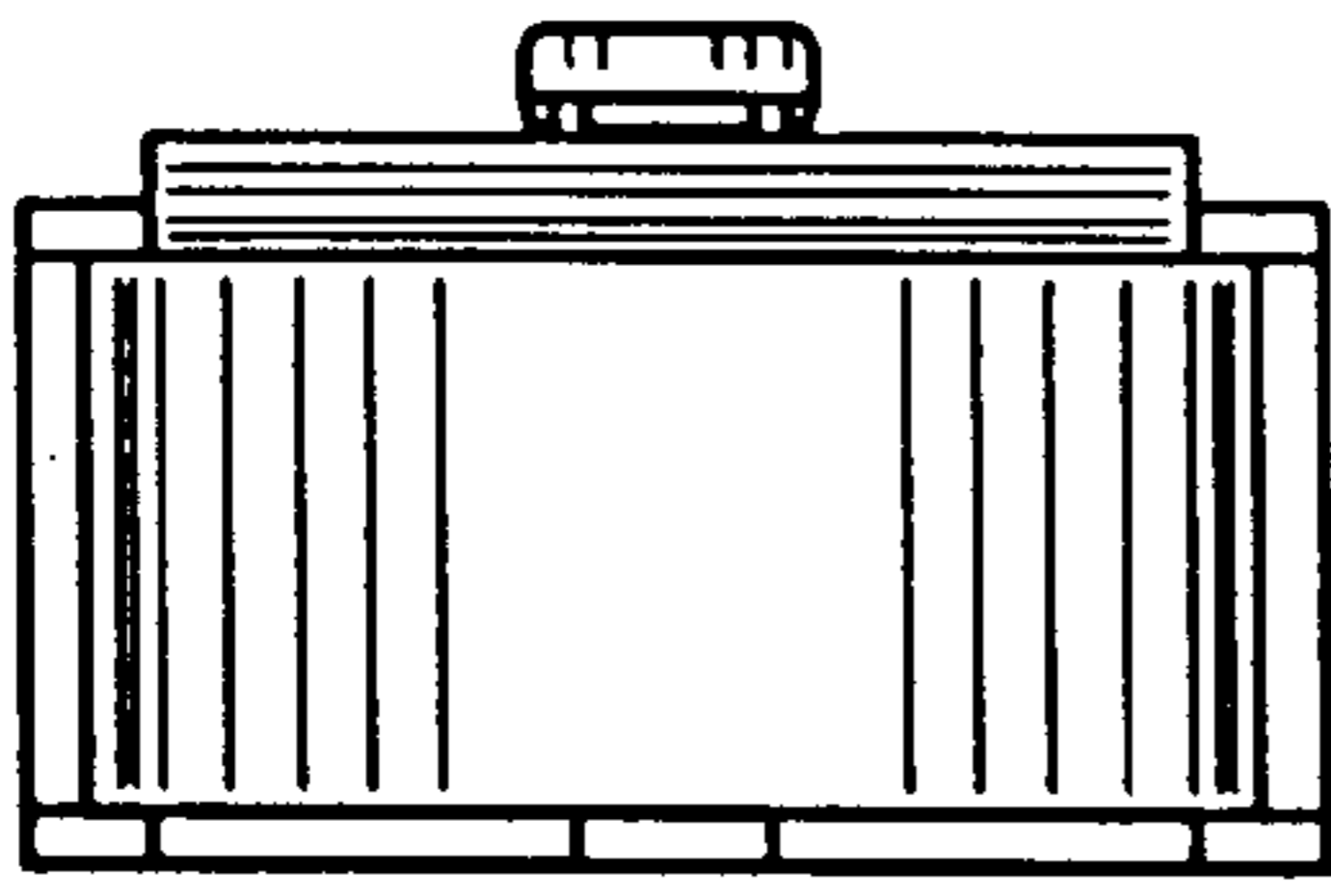

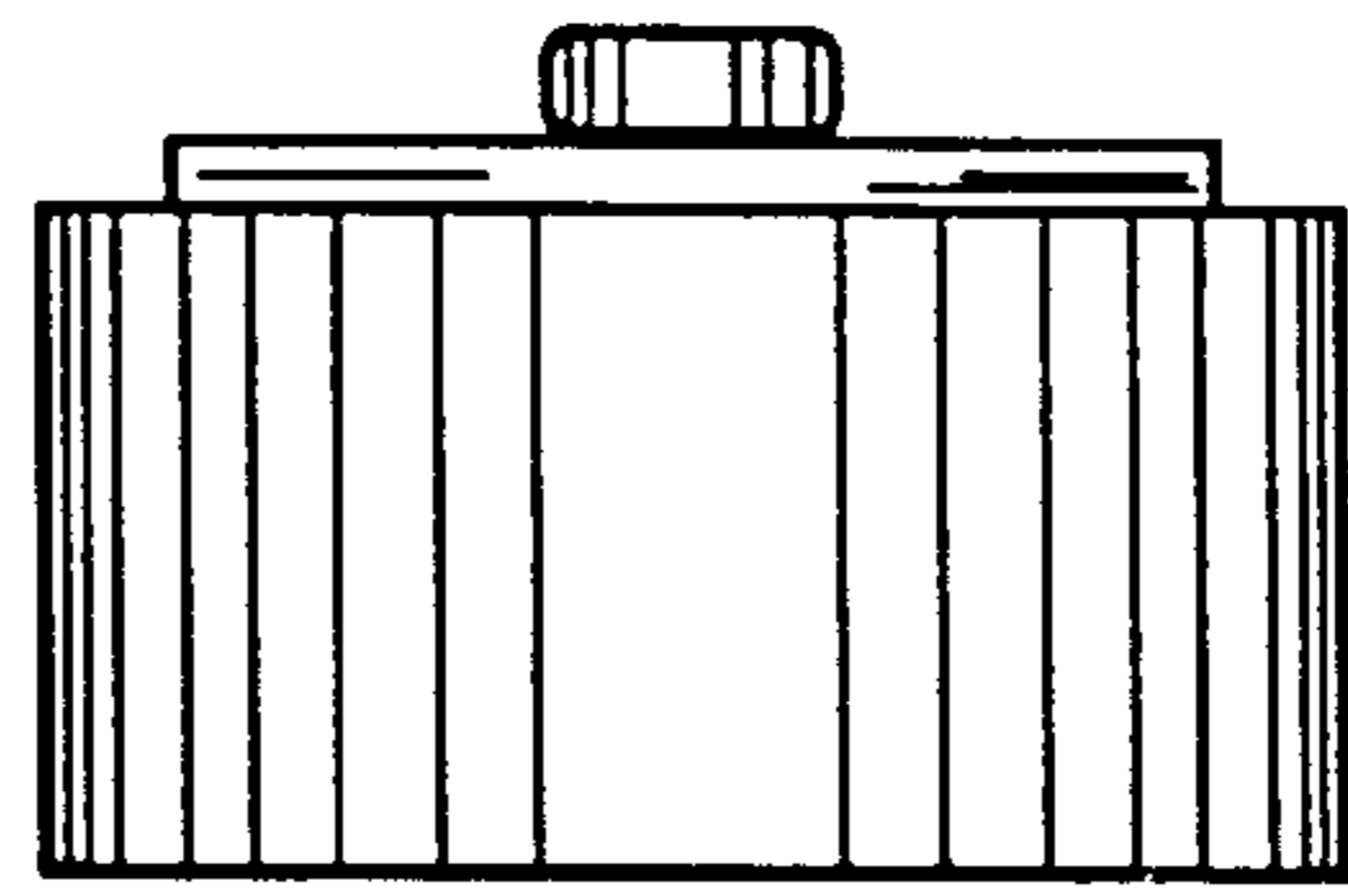

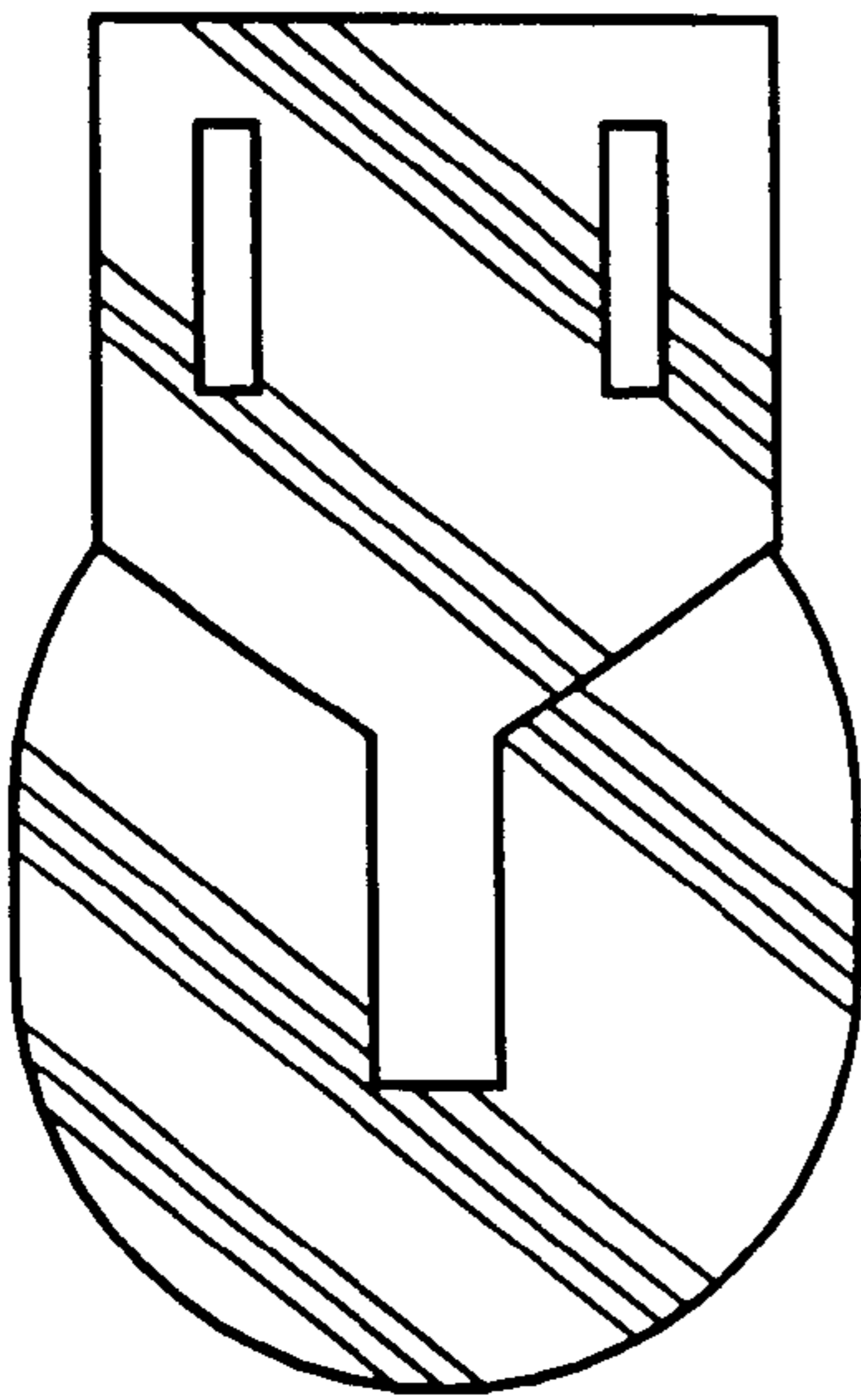

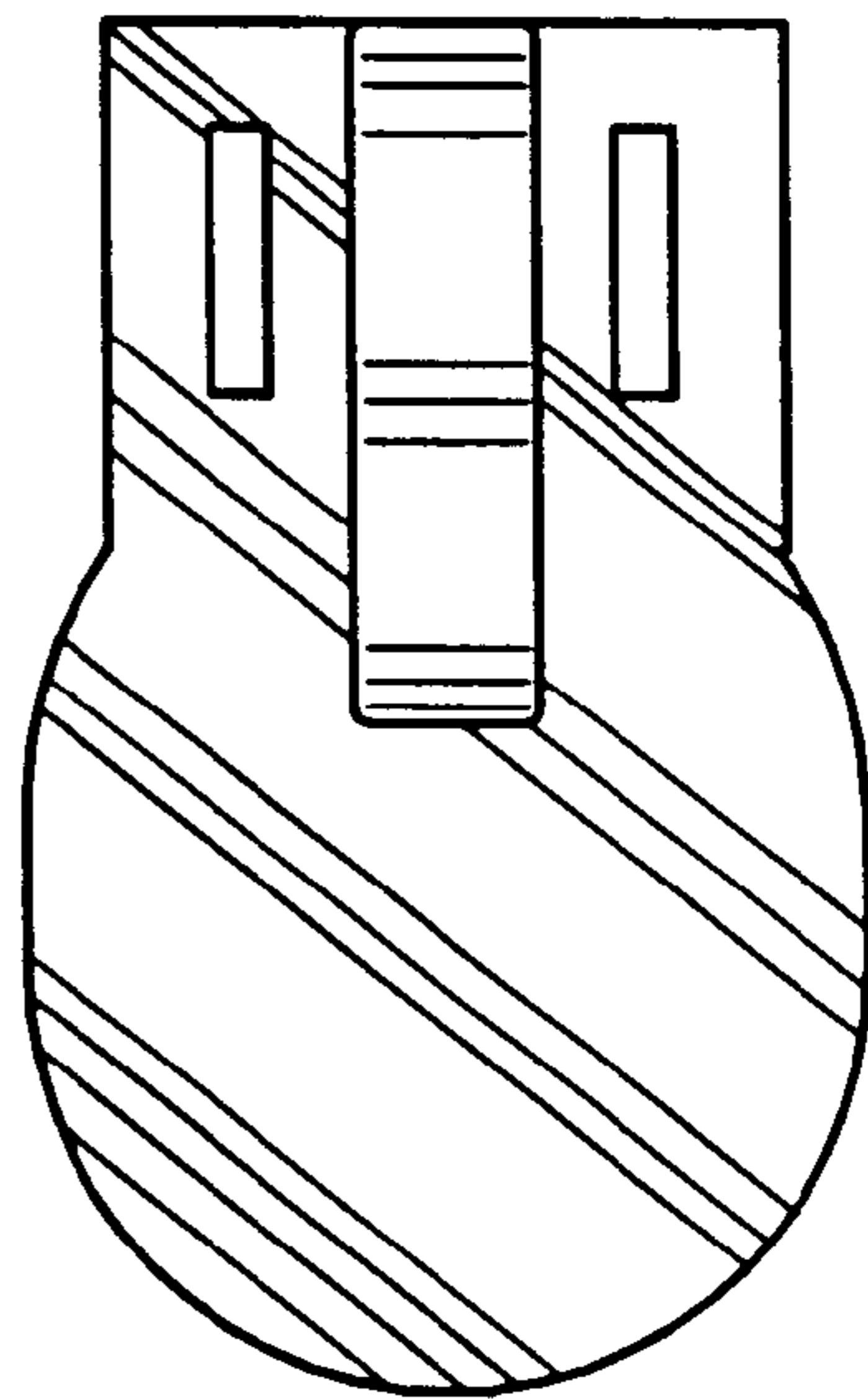

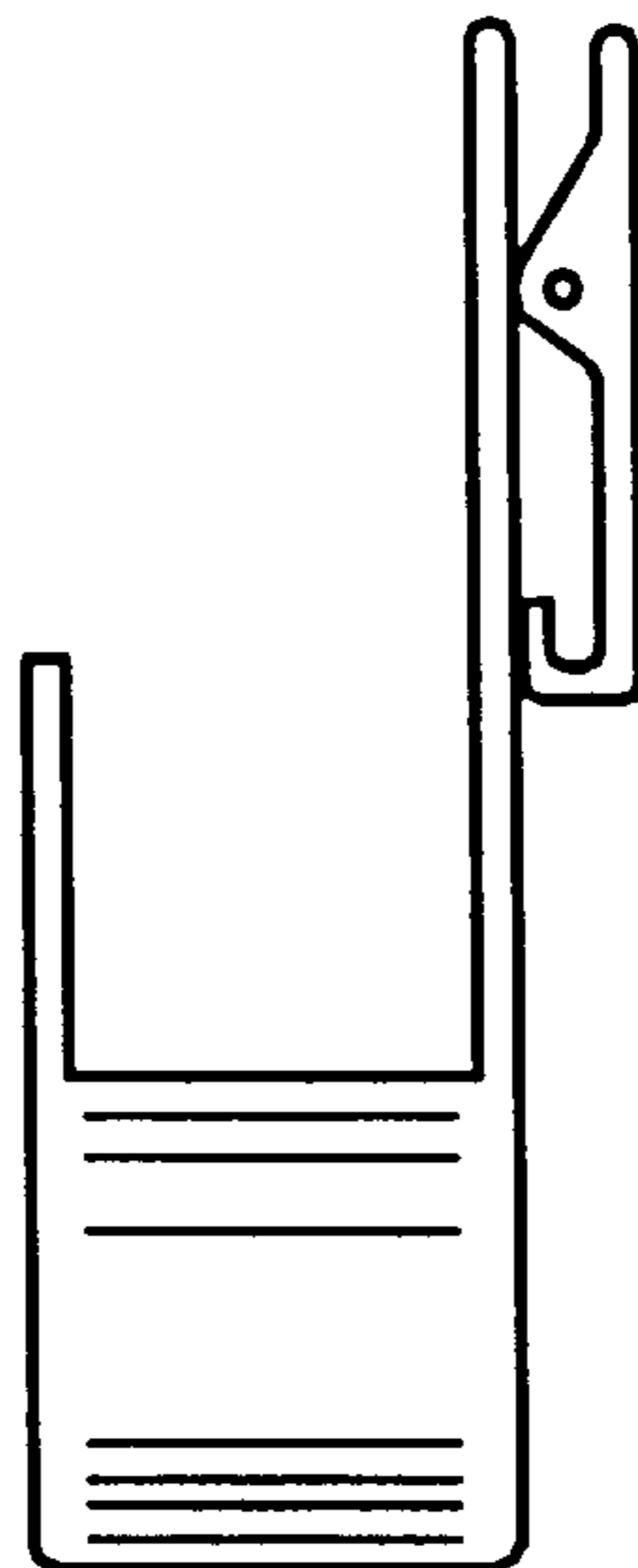

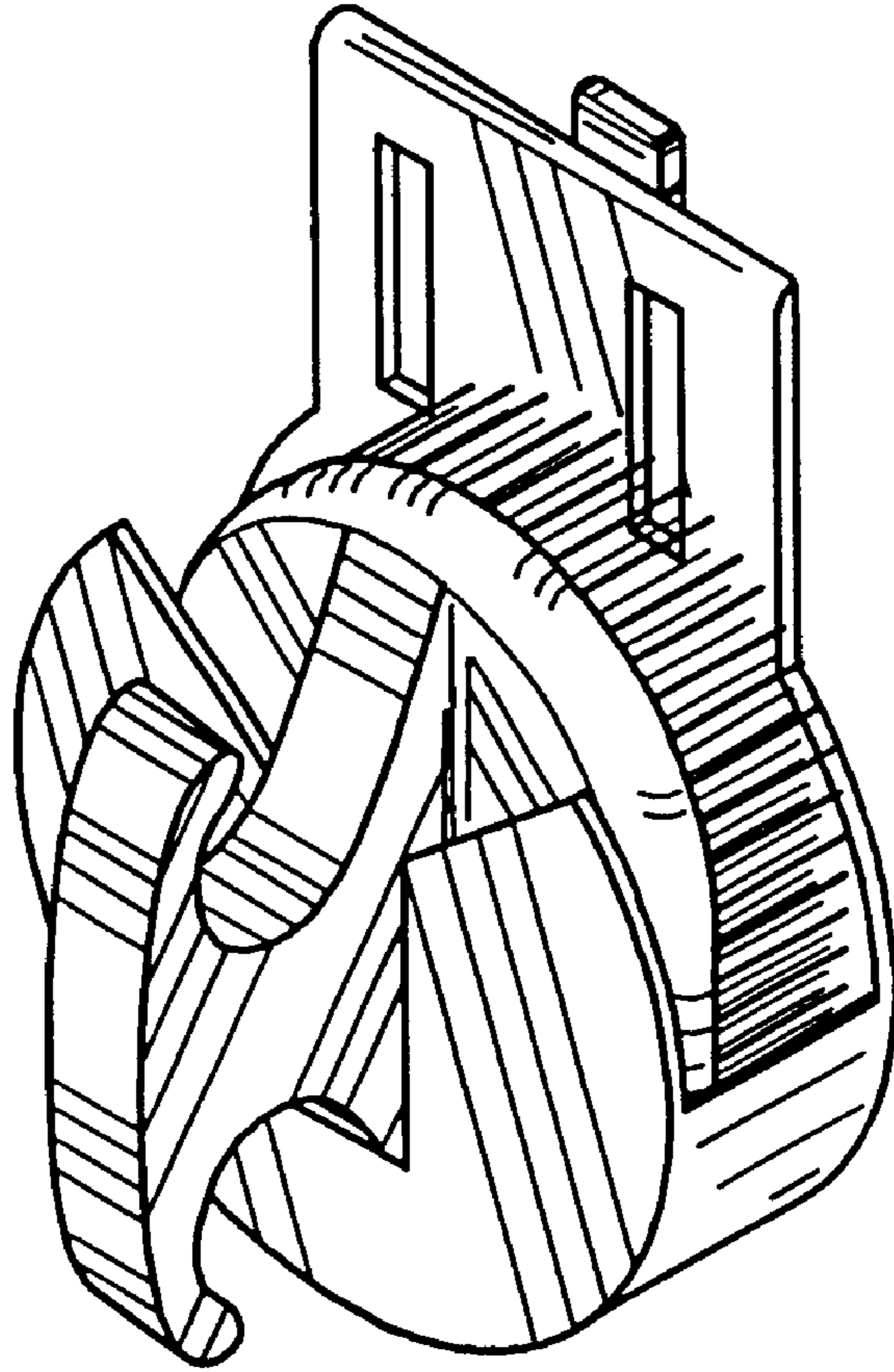
