DESCRIPTION

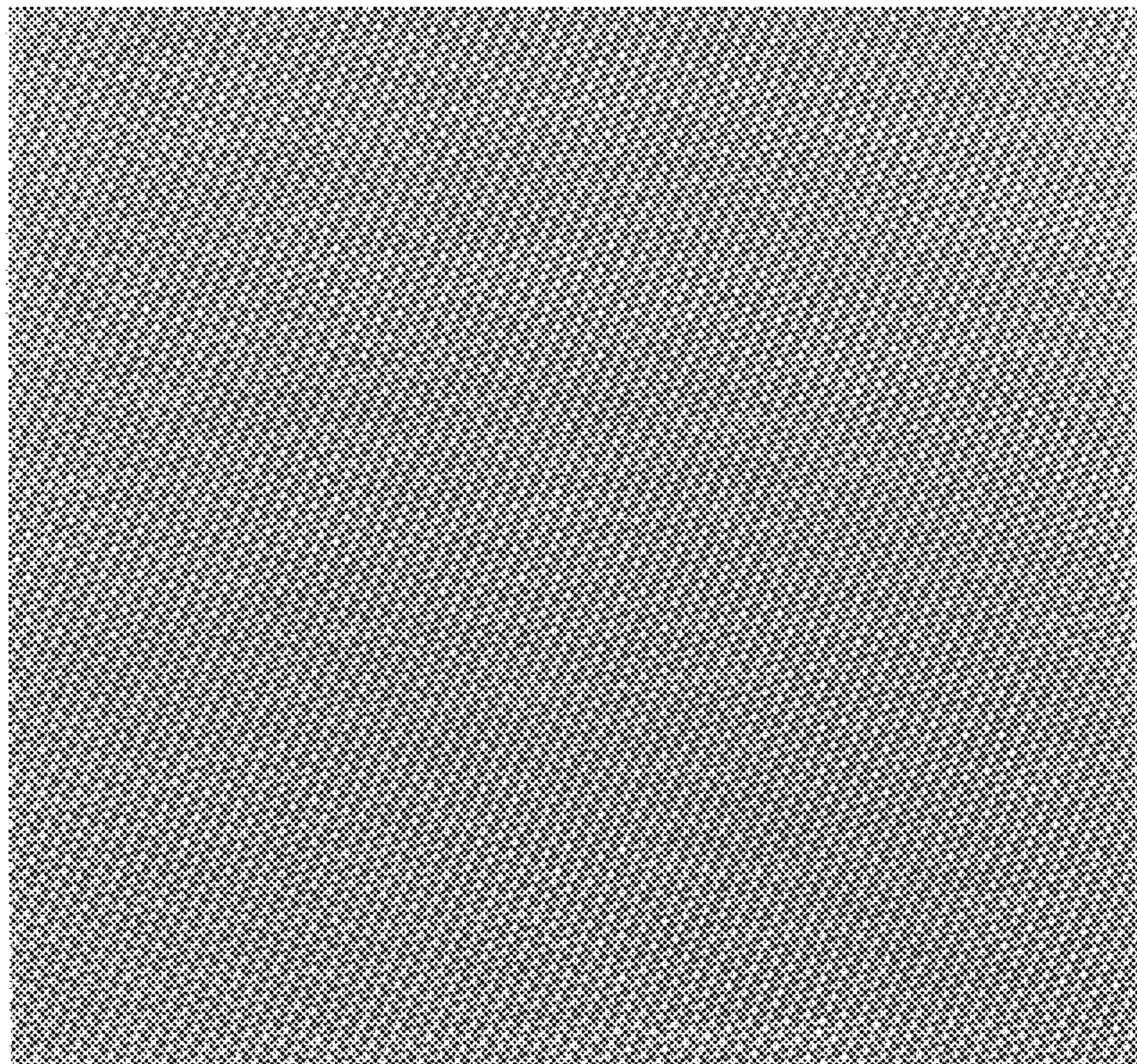
FIG. 1 is a top plan view of a fabric embodying my new design;

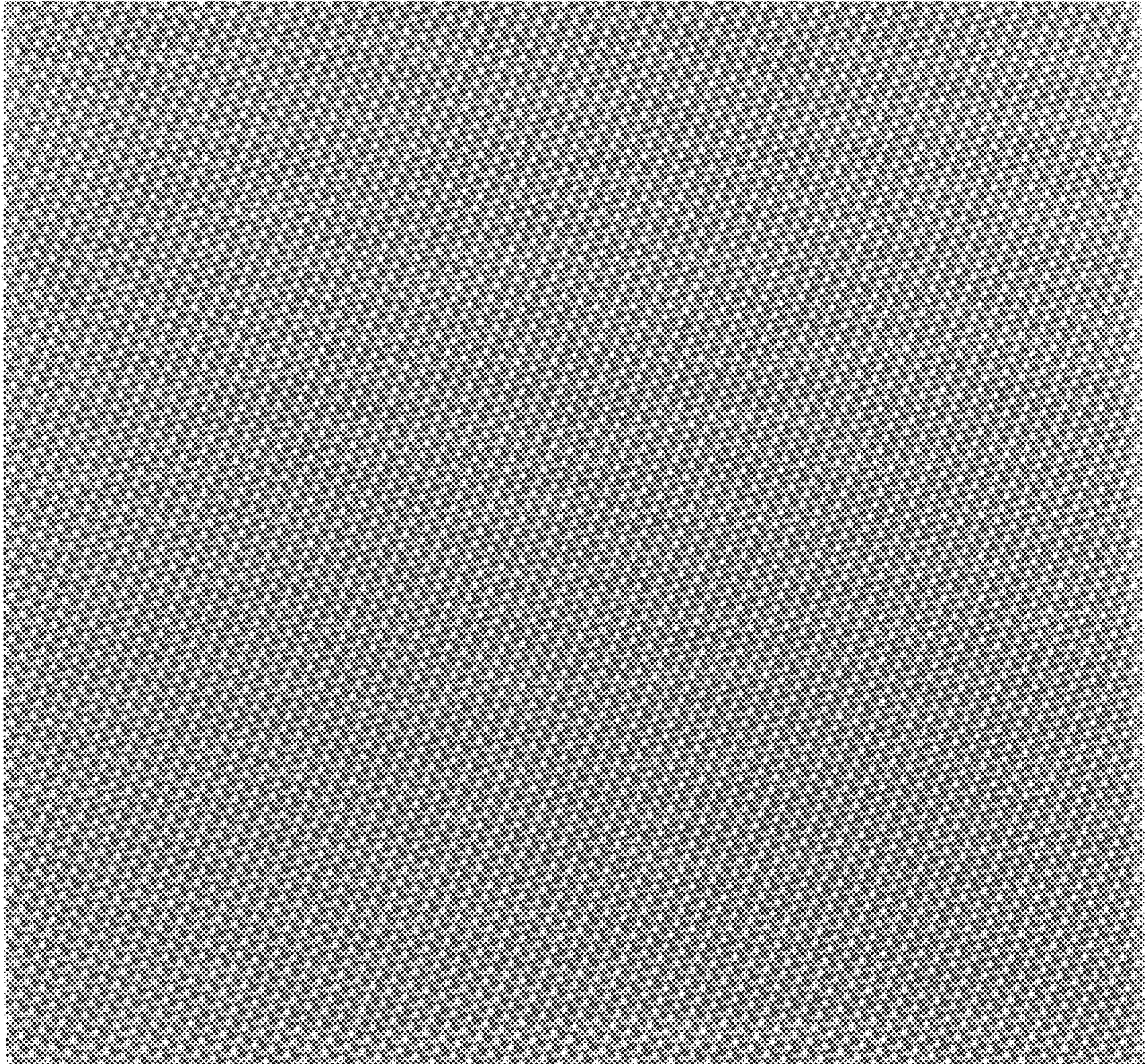

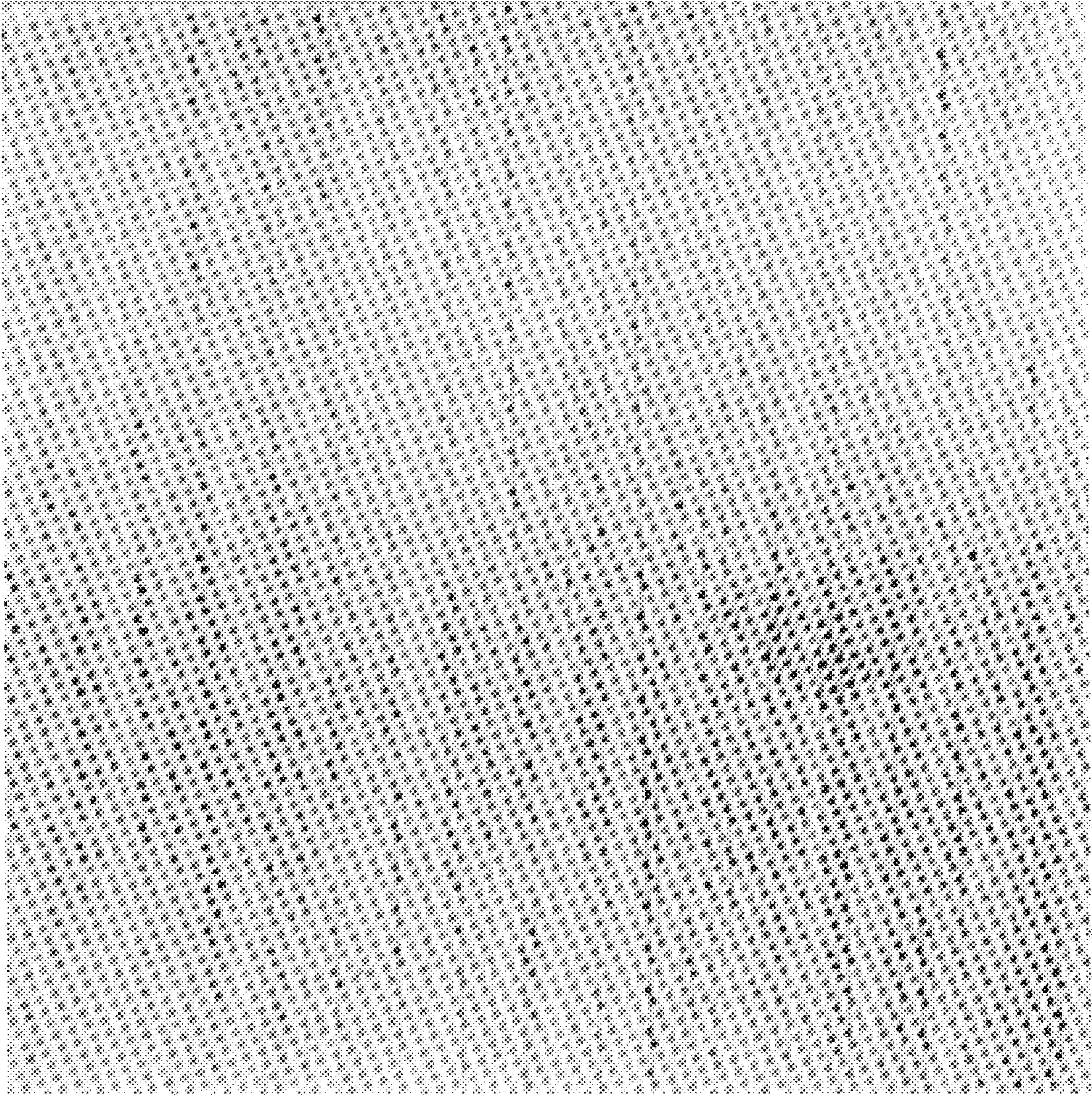

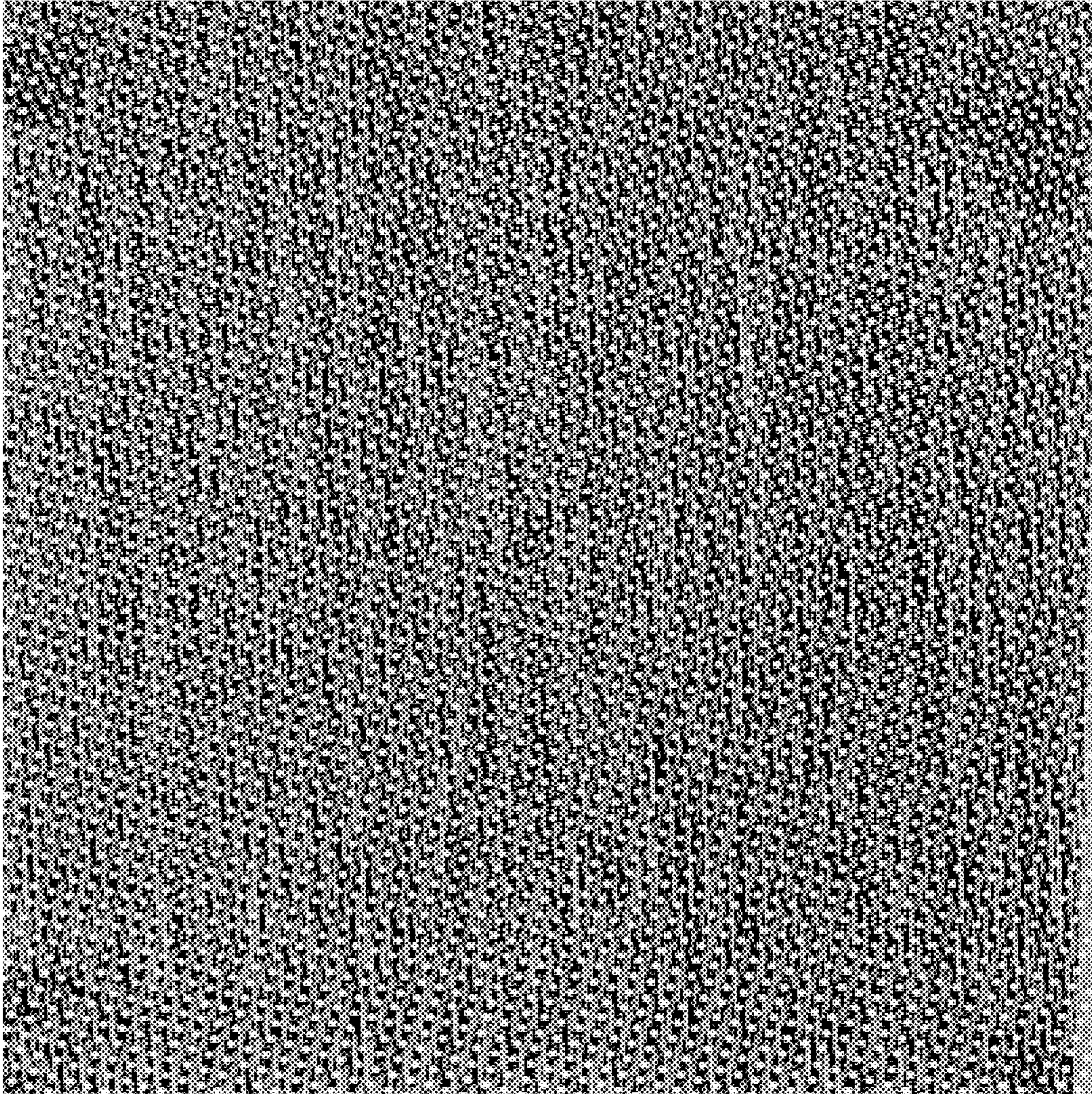

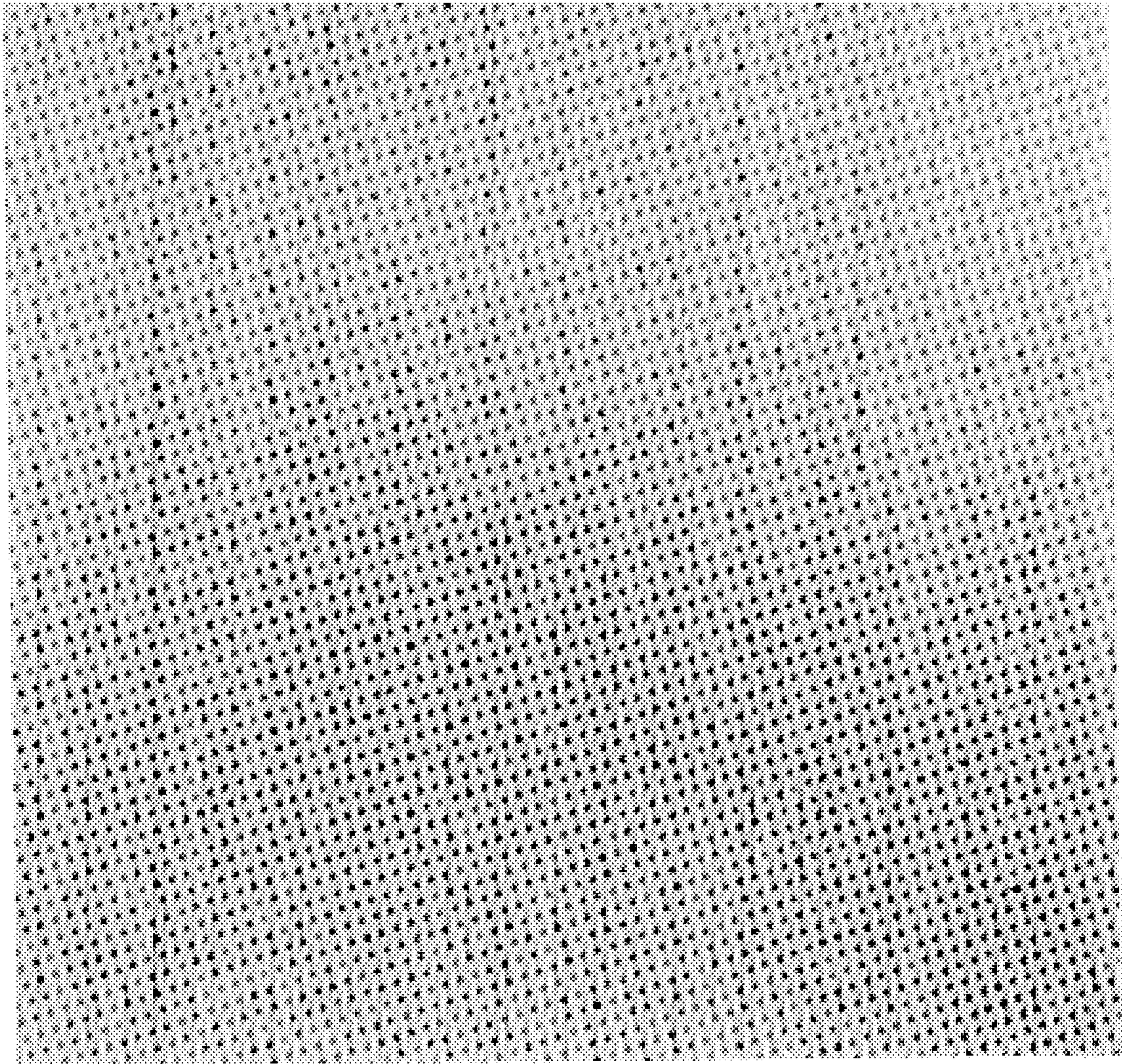
