DESCRIPTION

FIG. 10 is rear elevational view thereof.

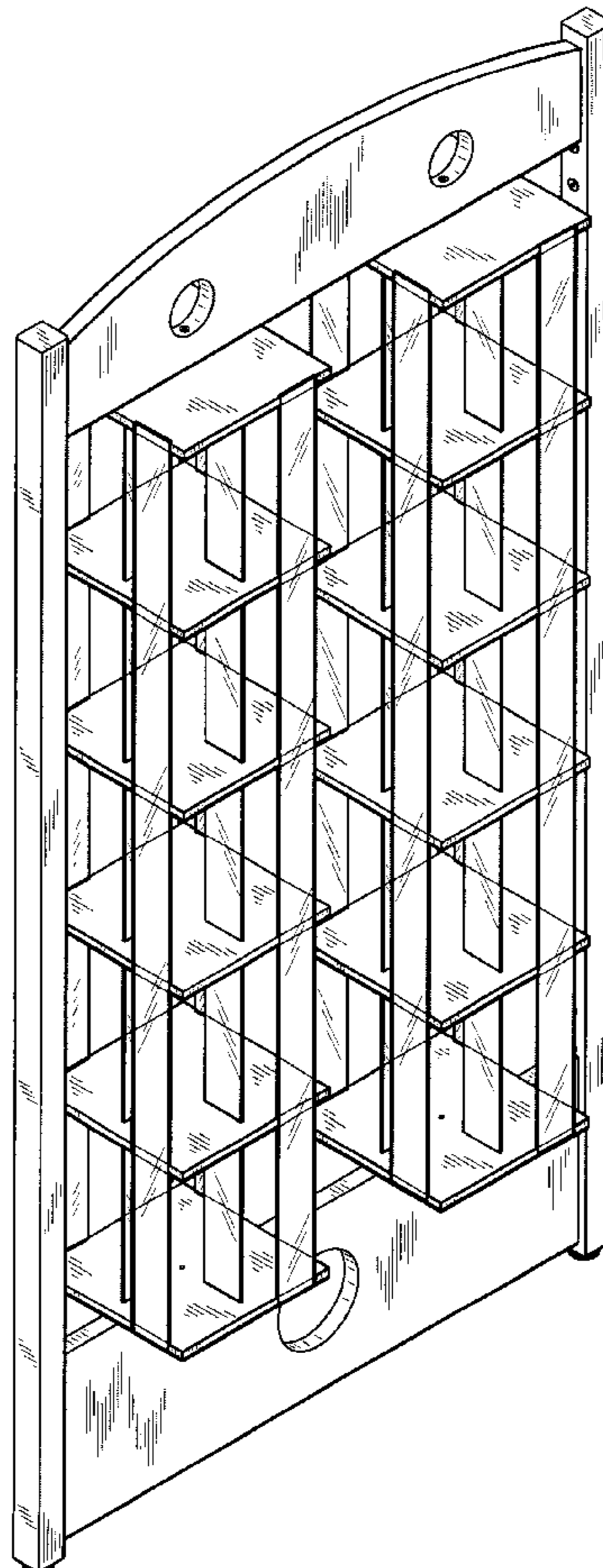
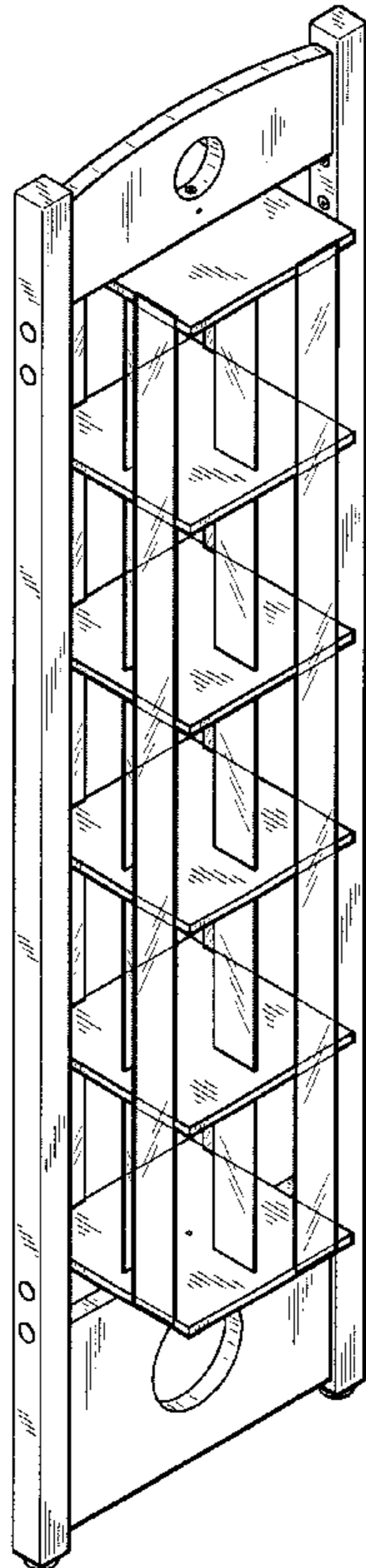
FIG. 11 is right side elevational view thereof.

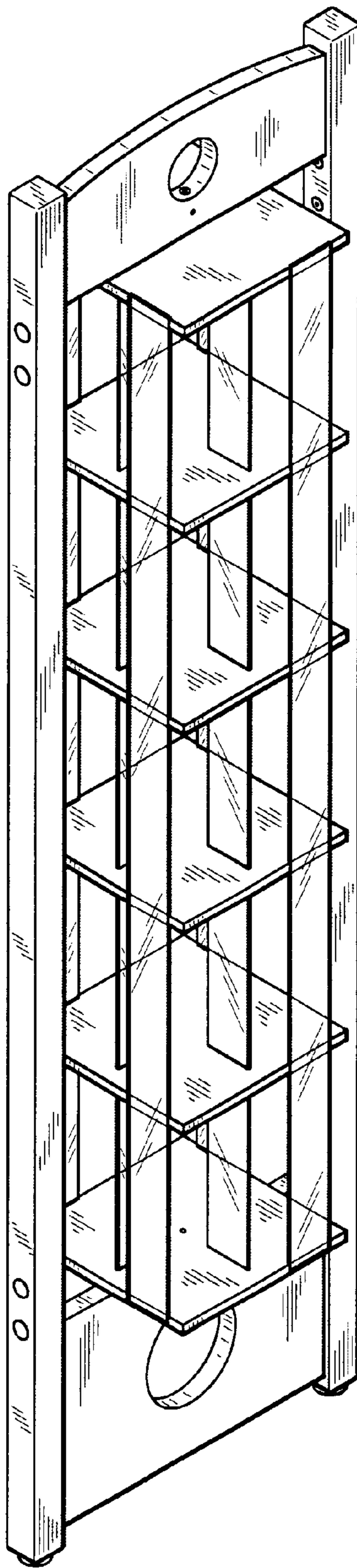

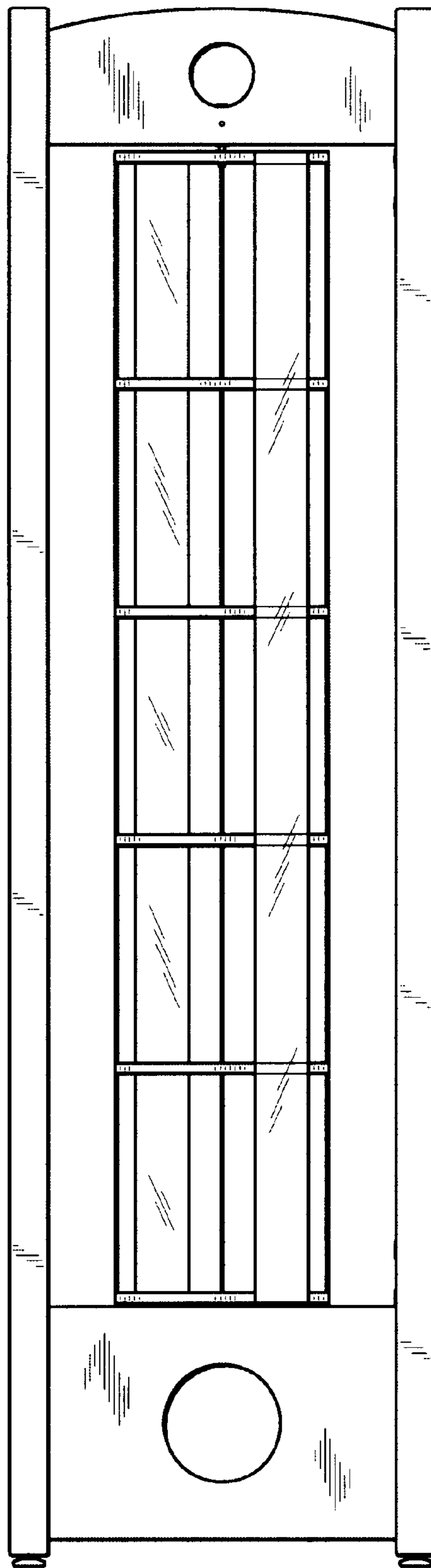

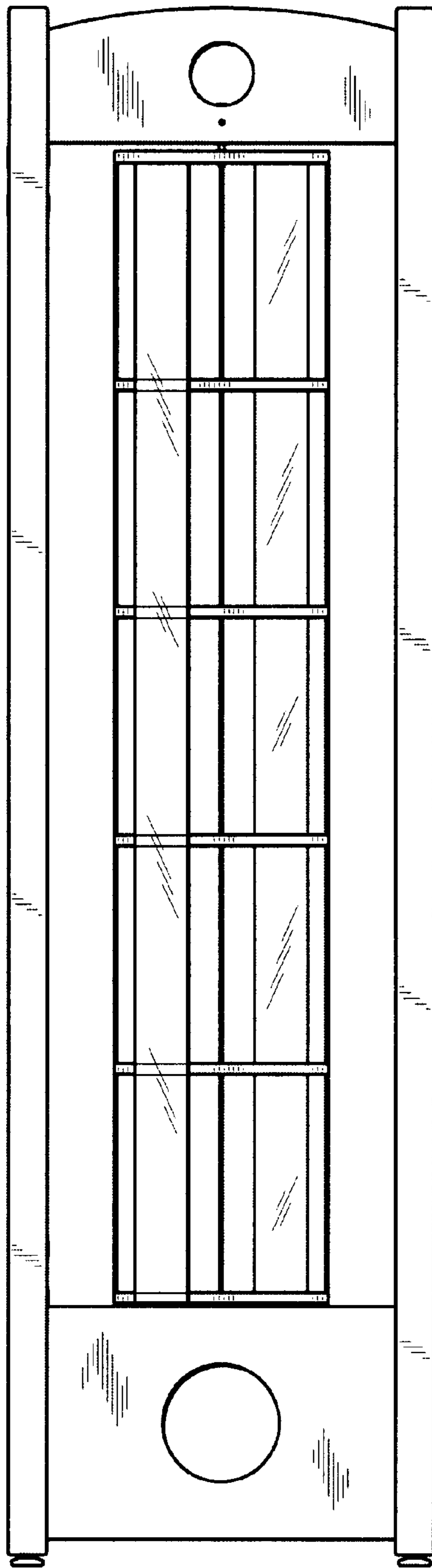

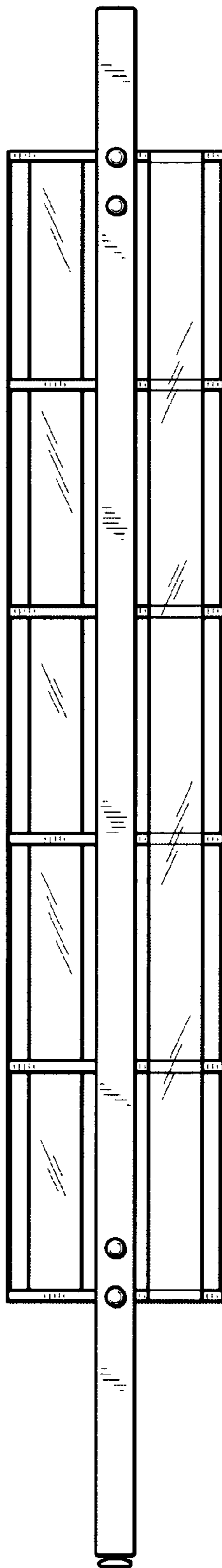

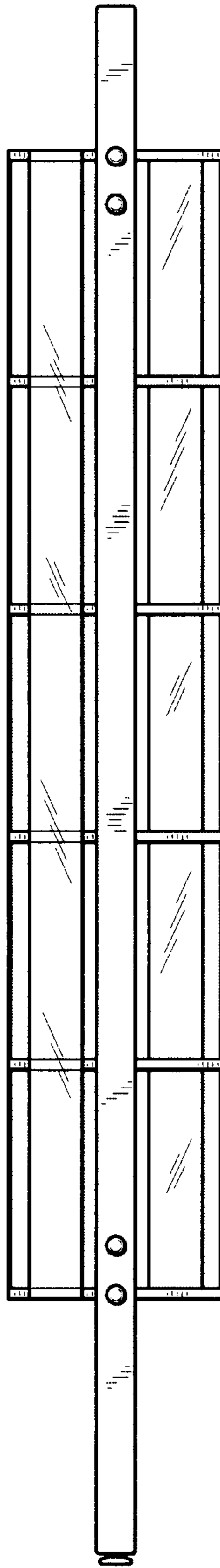

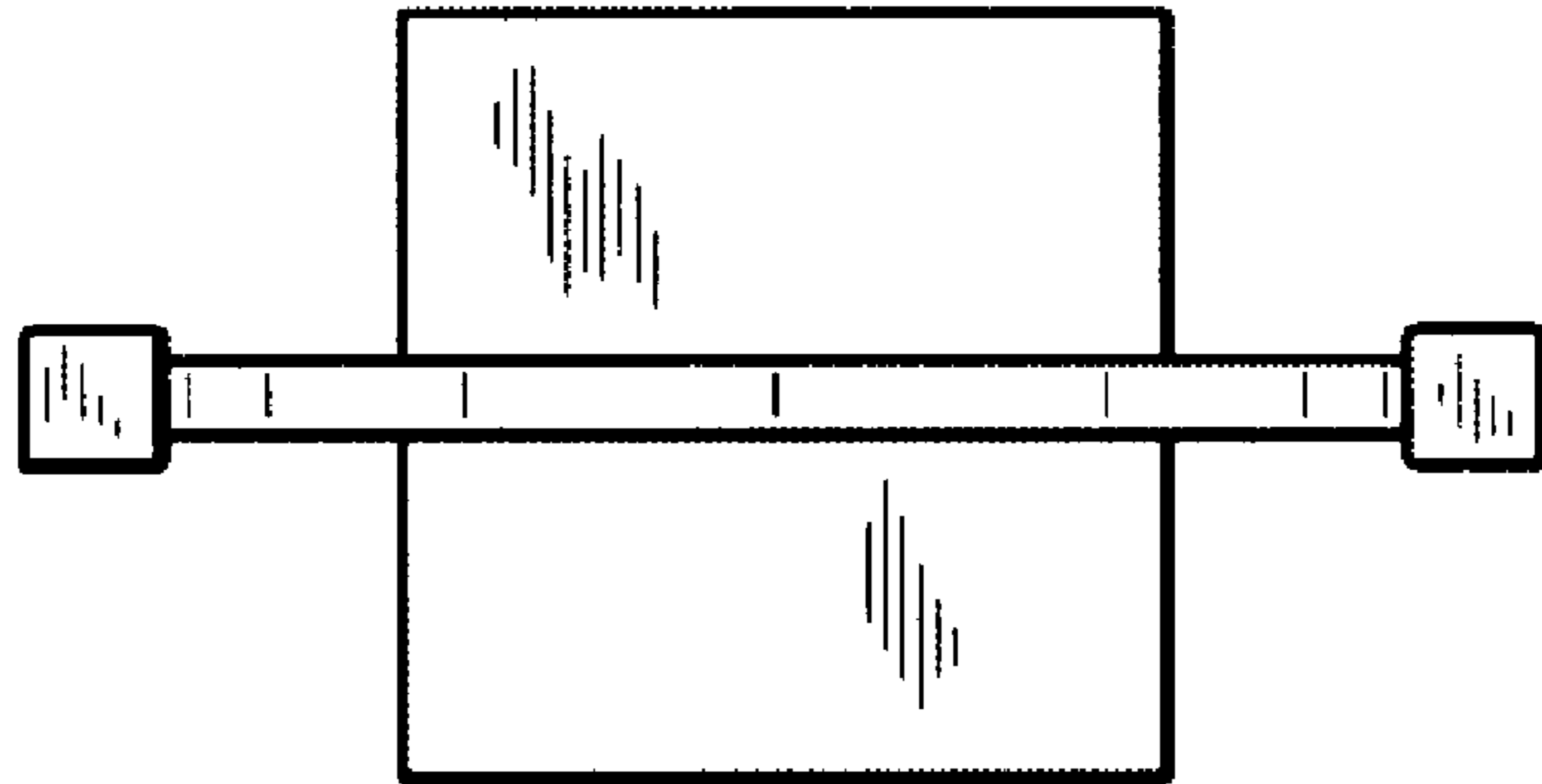

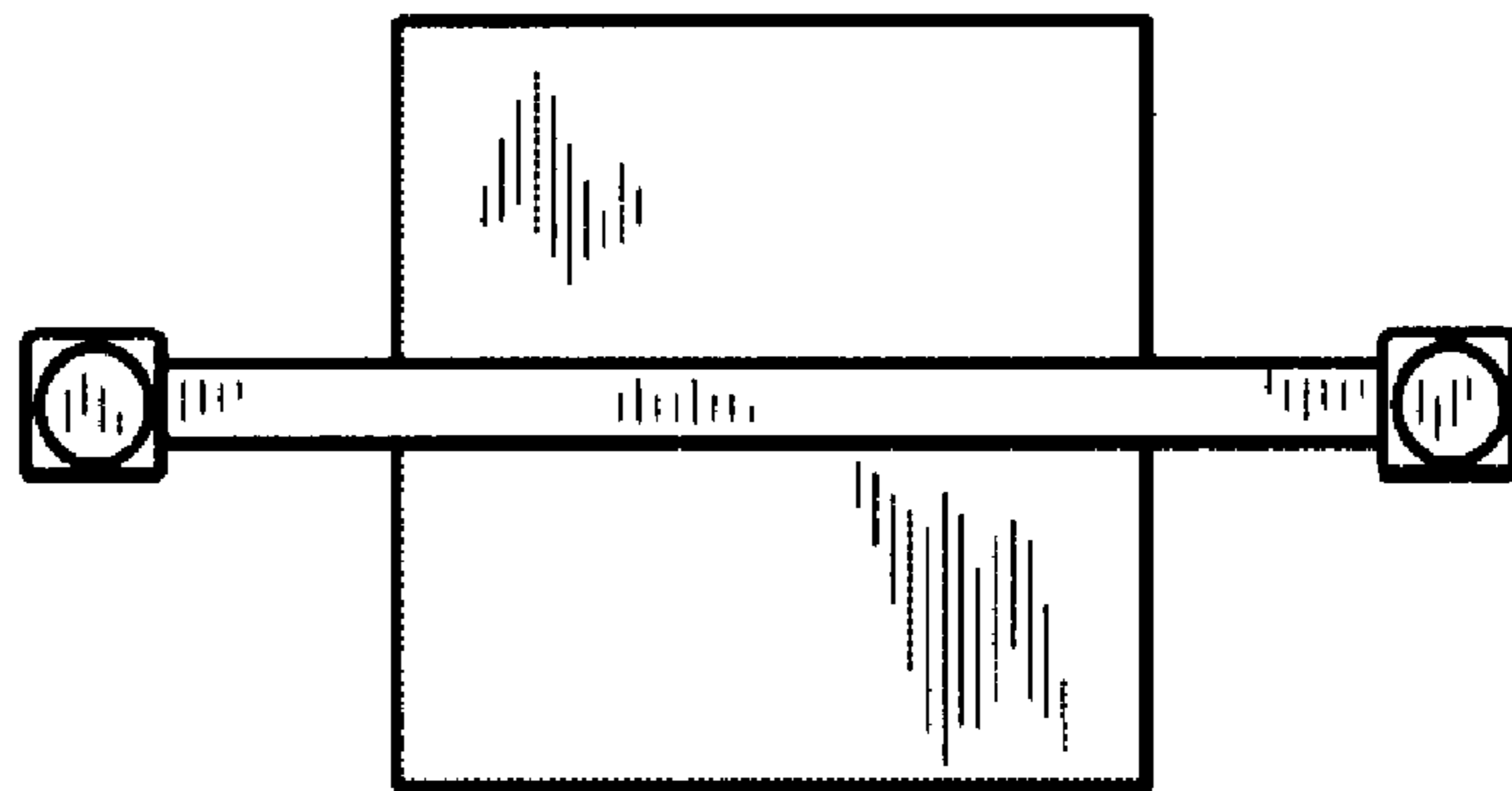

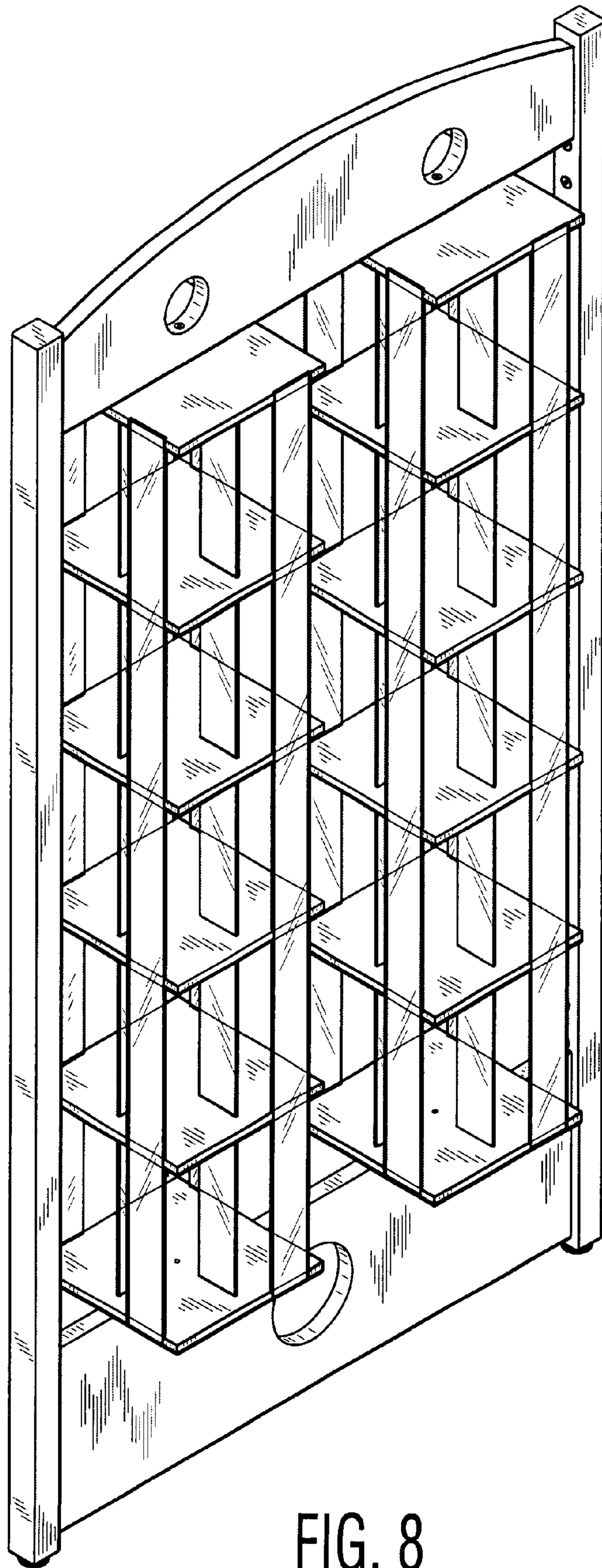

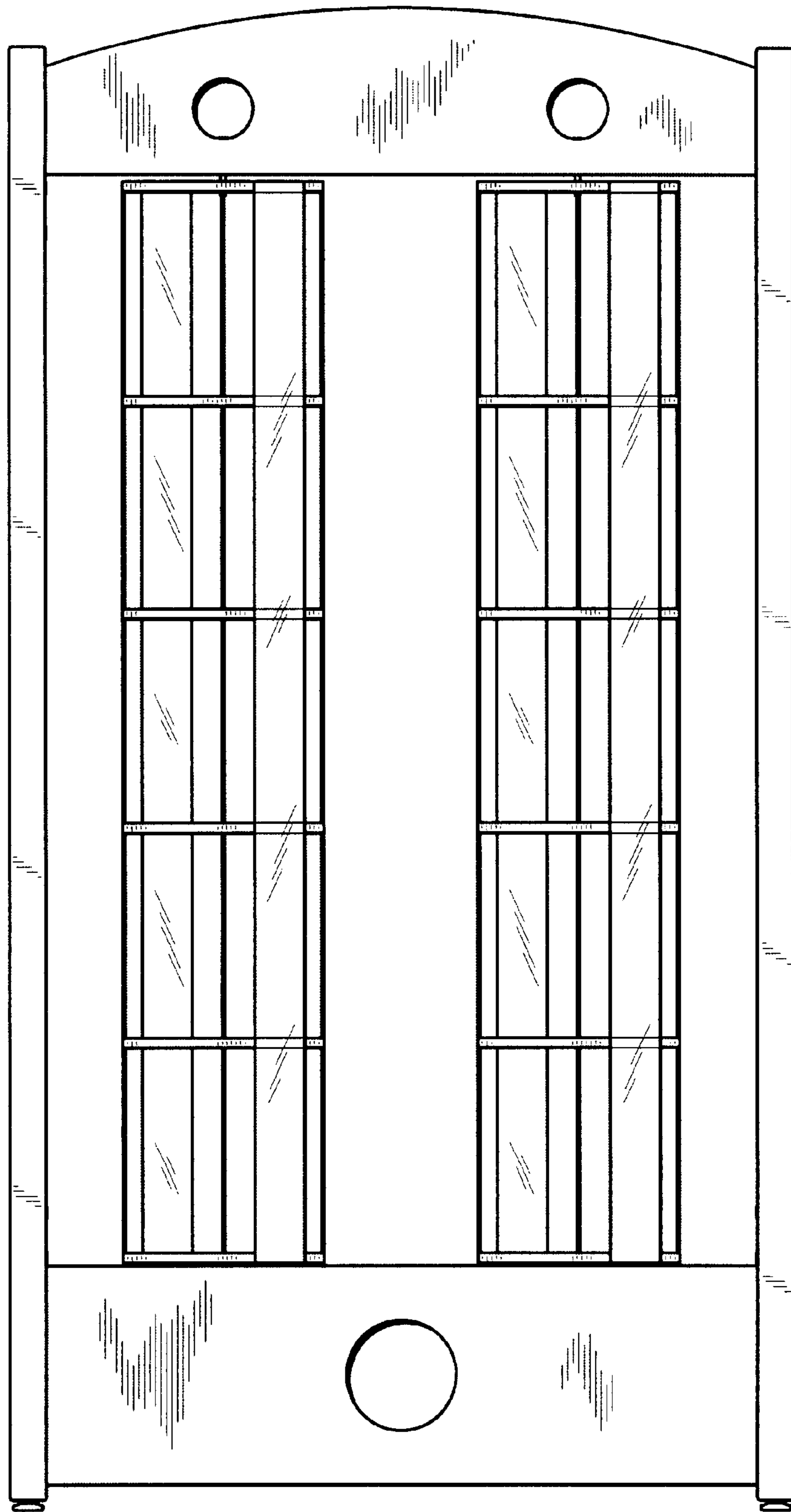

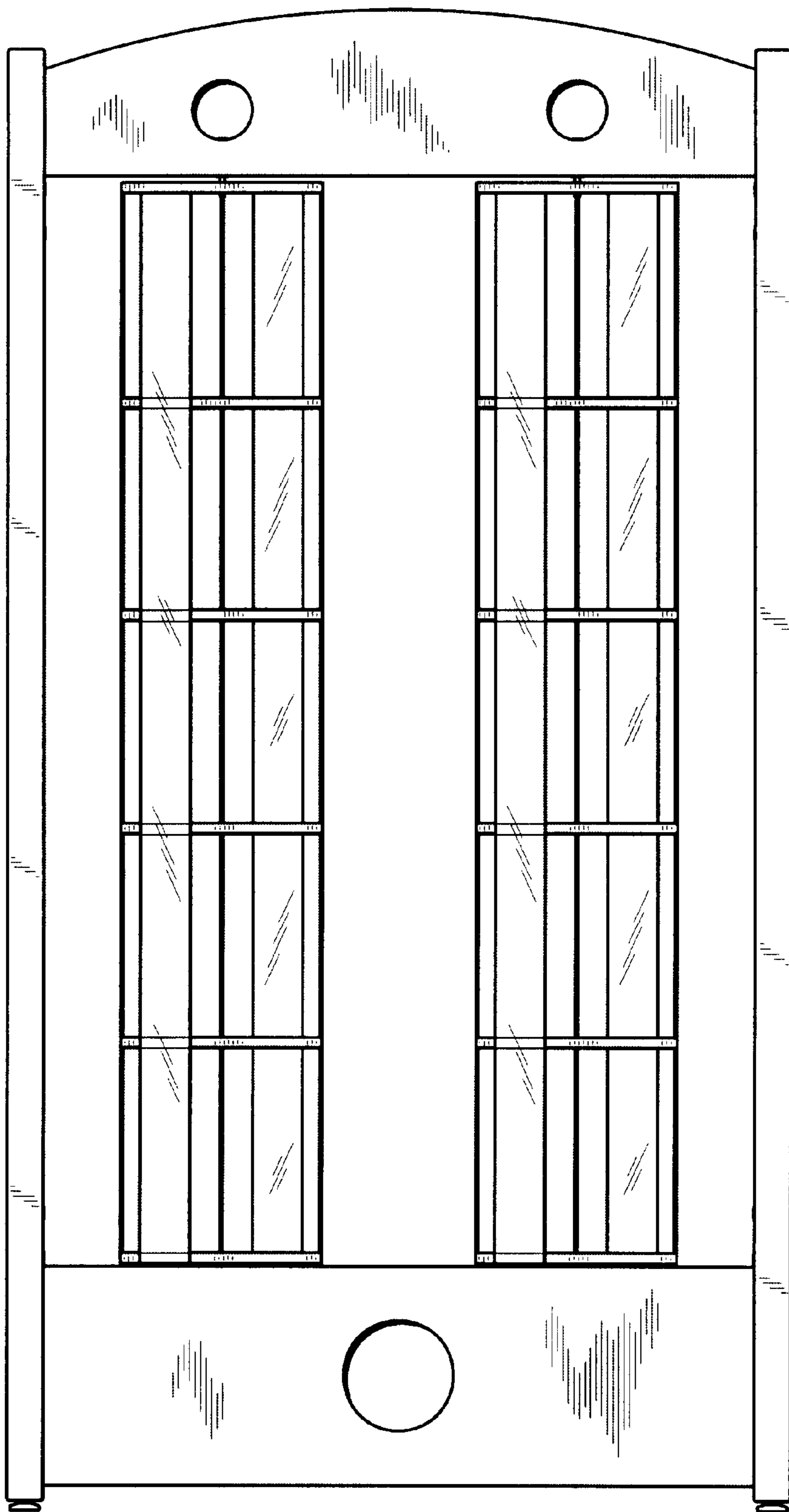

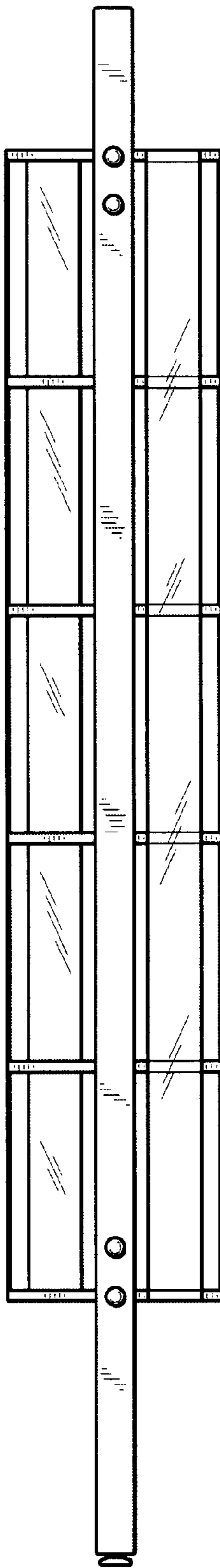

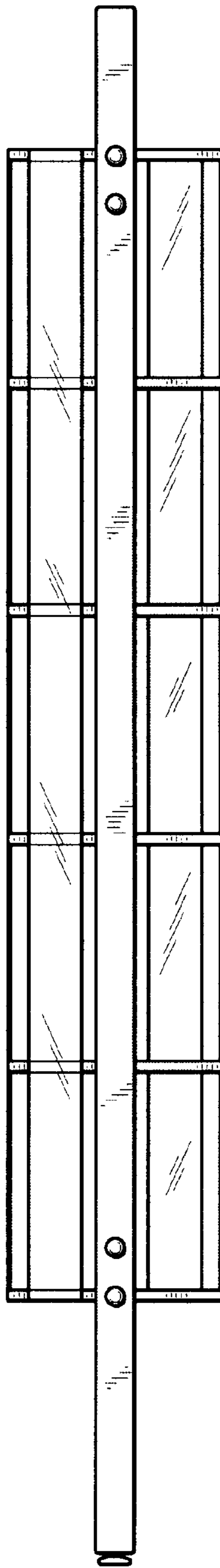

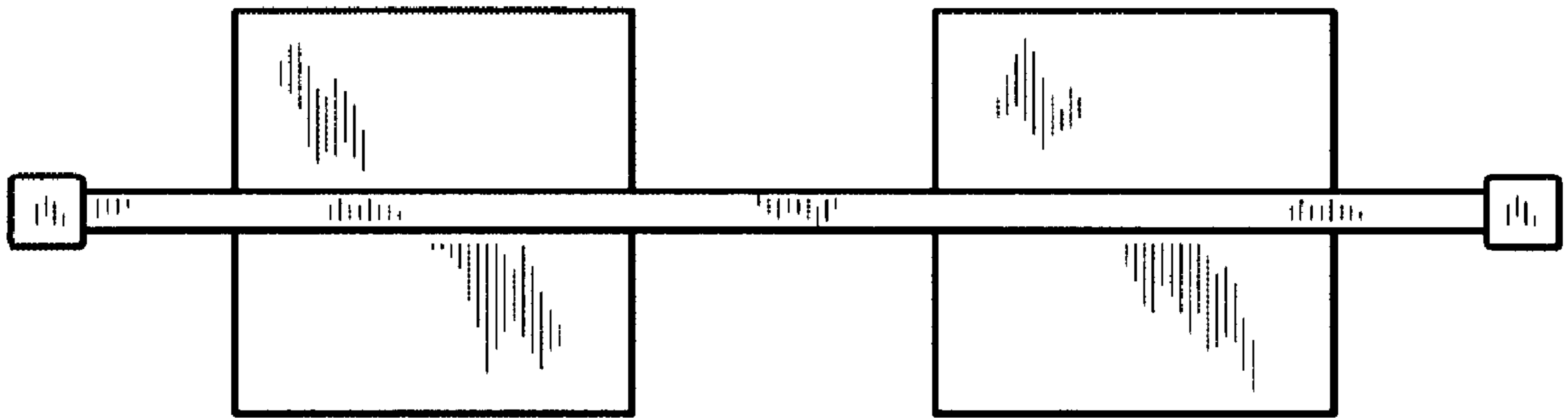

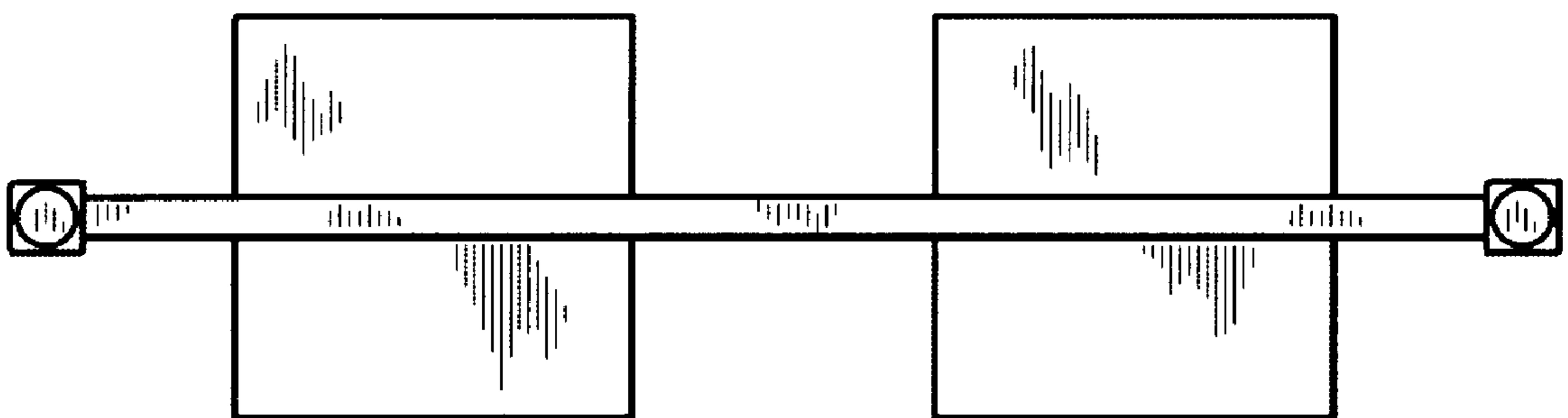
