The ornamental design for beer cask with tap, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the beer cask with tap, with the tap down;

FIG. 4 is a top view with the tap down;

FIG. 5 is an elevated front view; and,

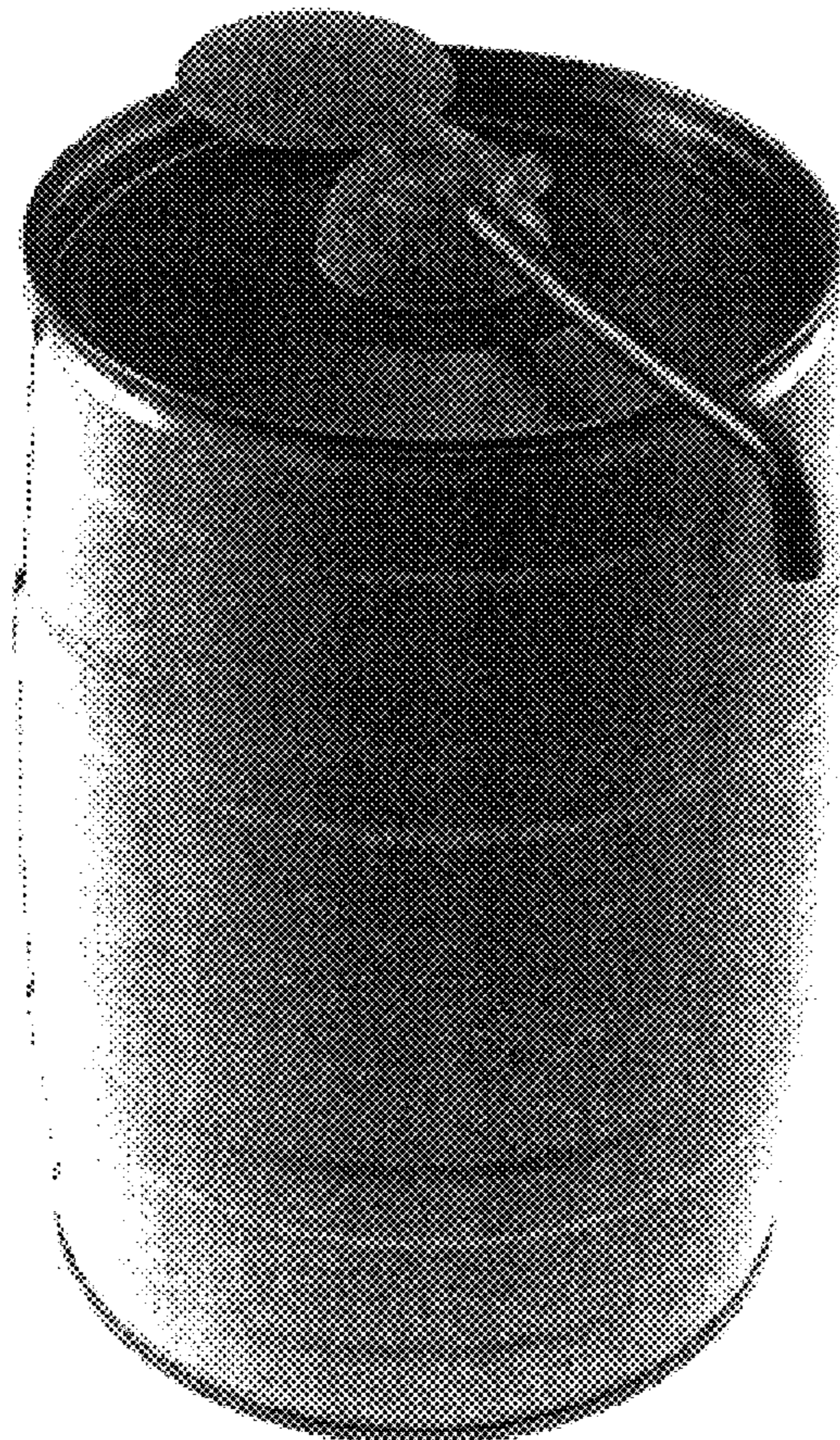

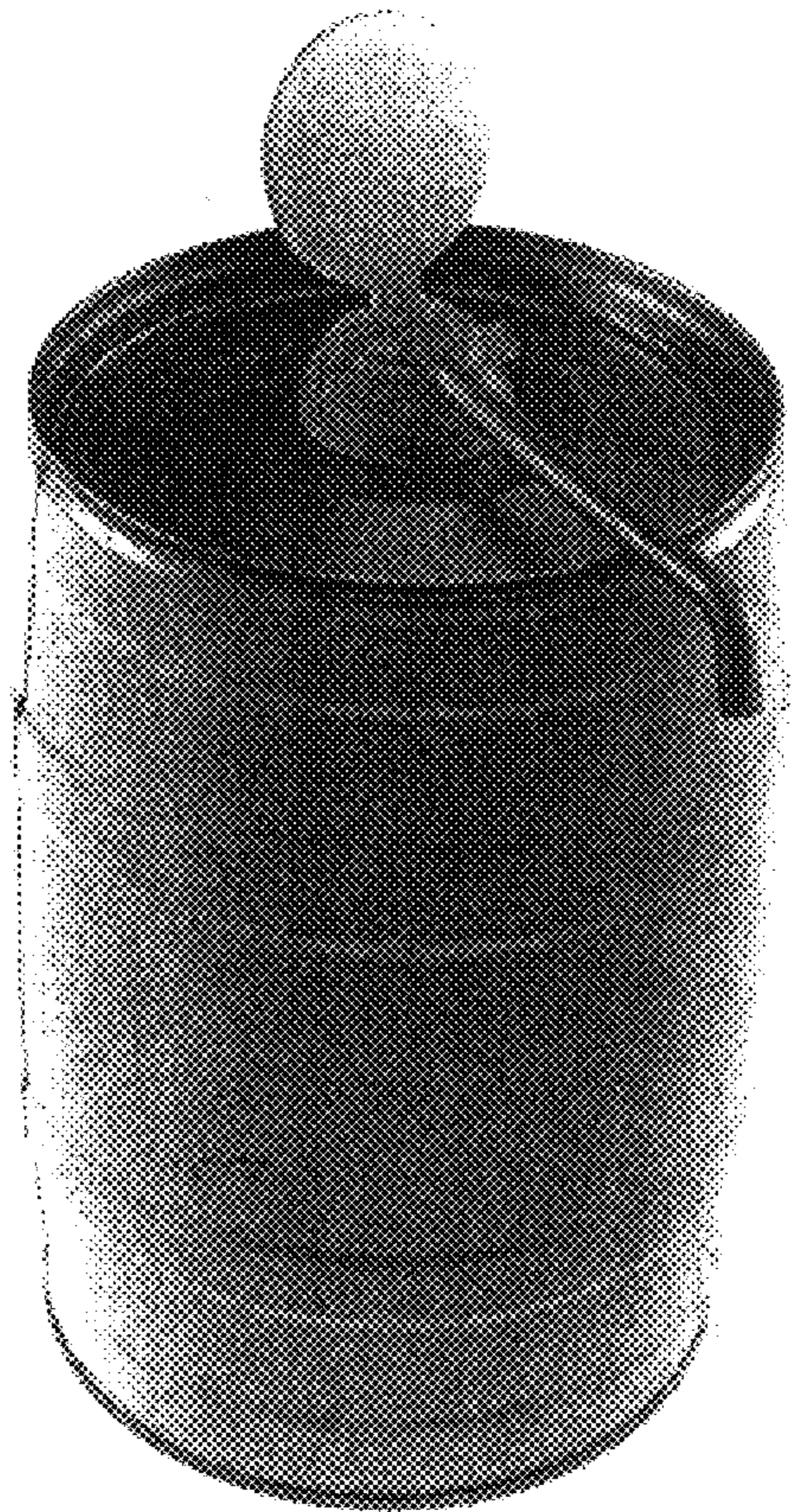

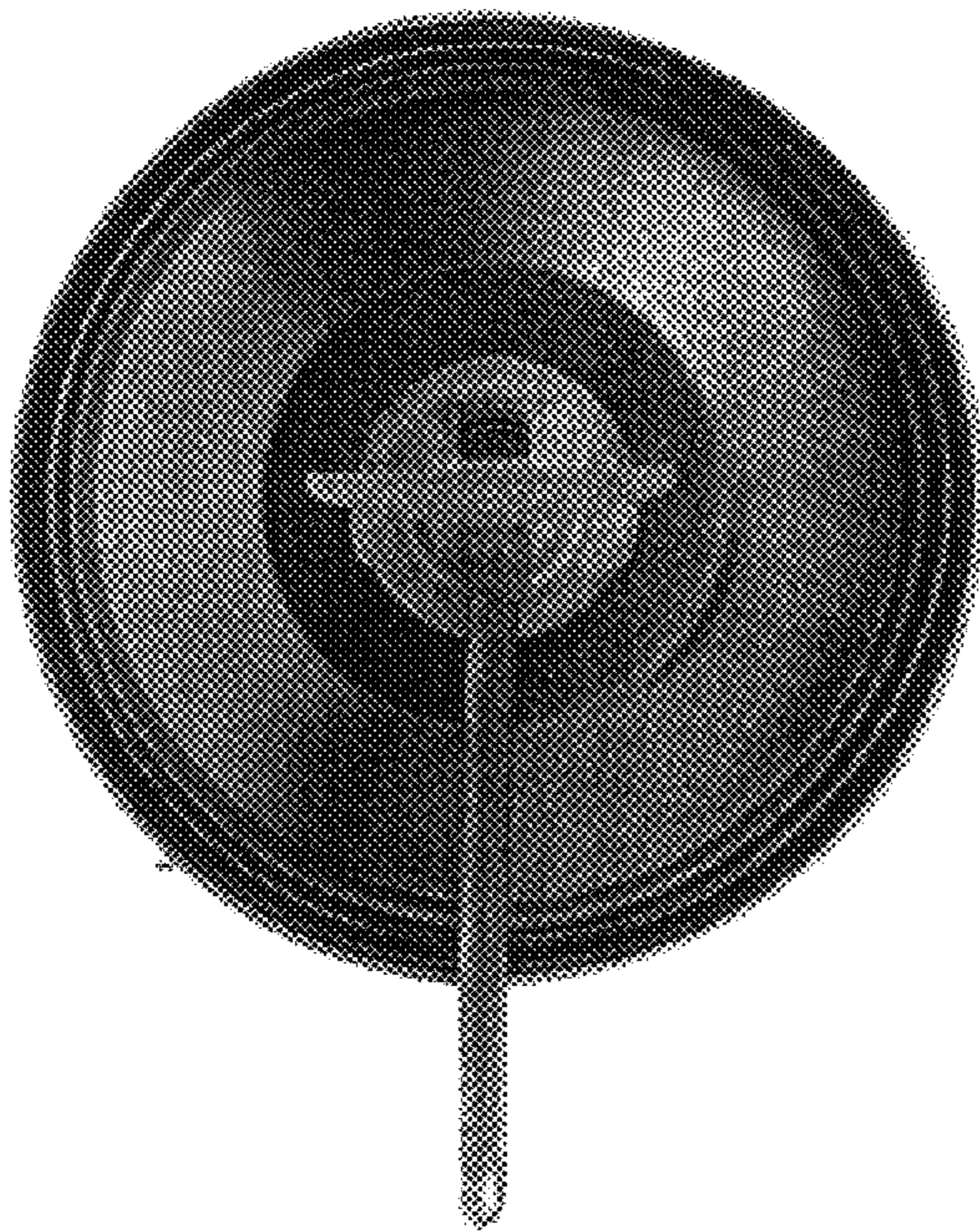

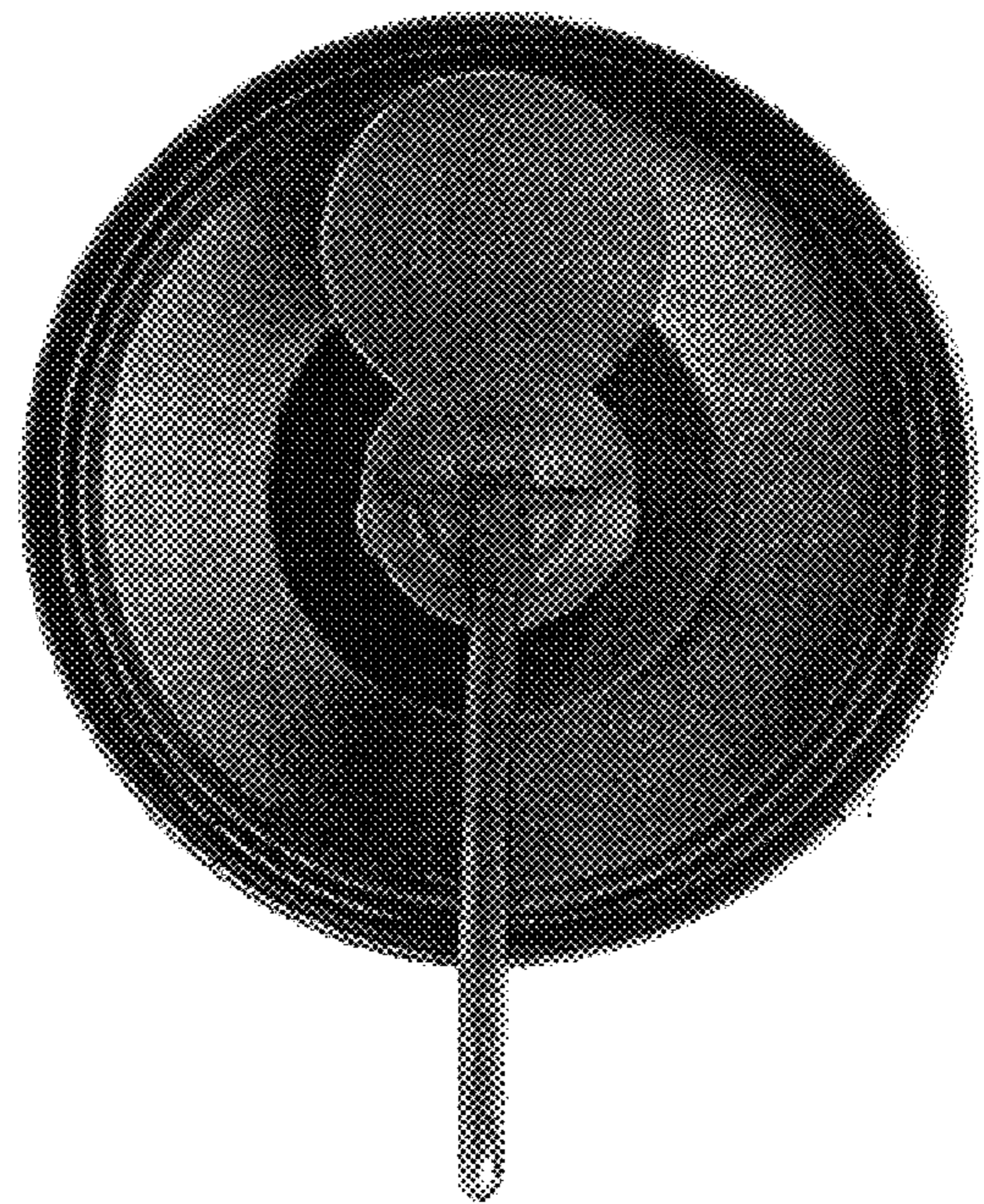

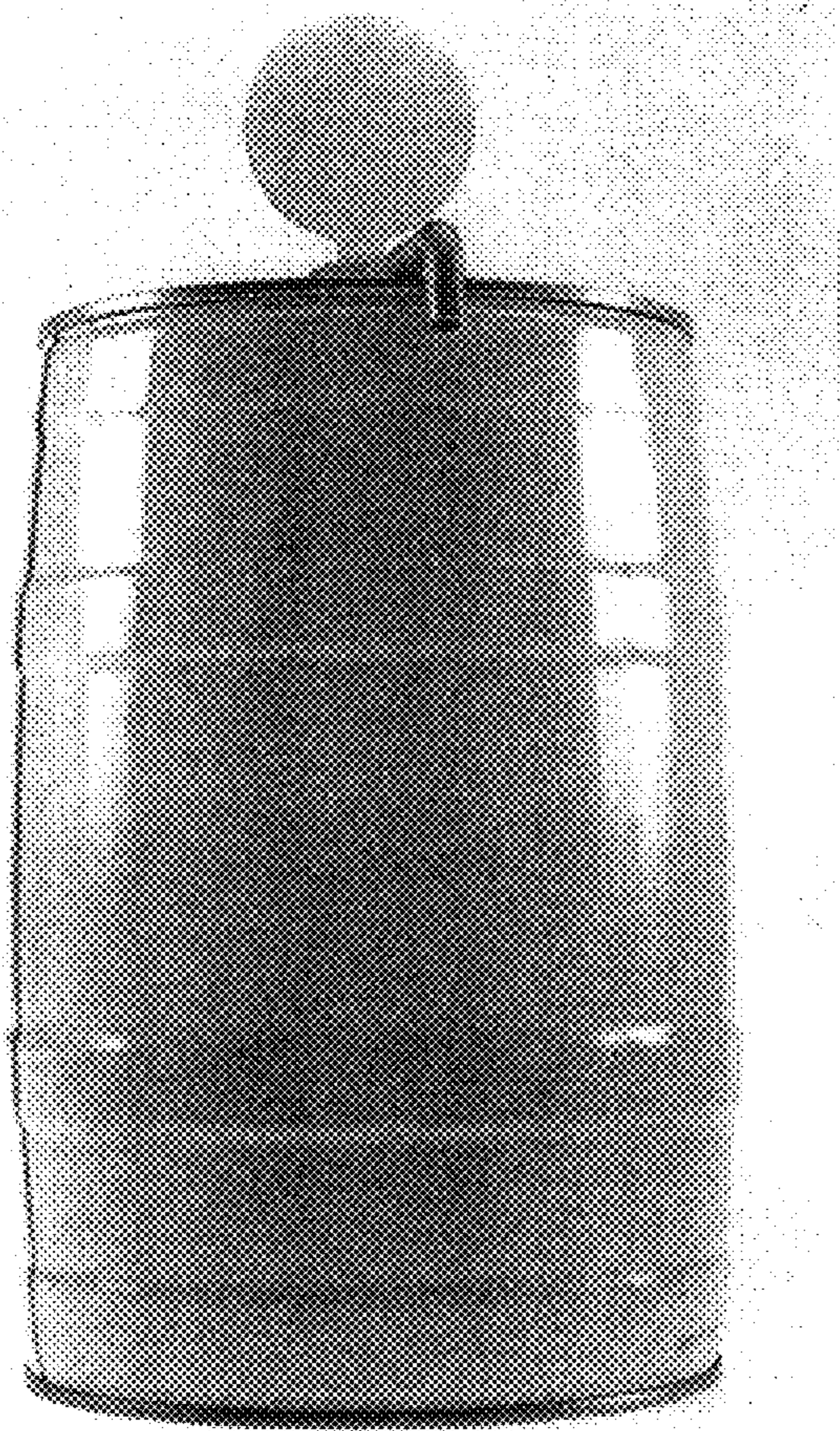

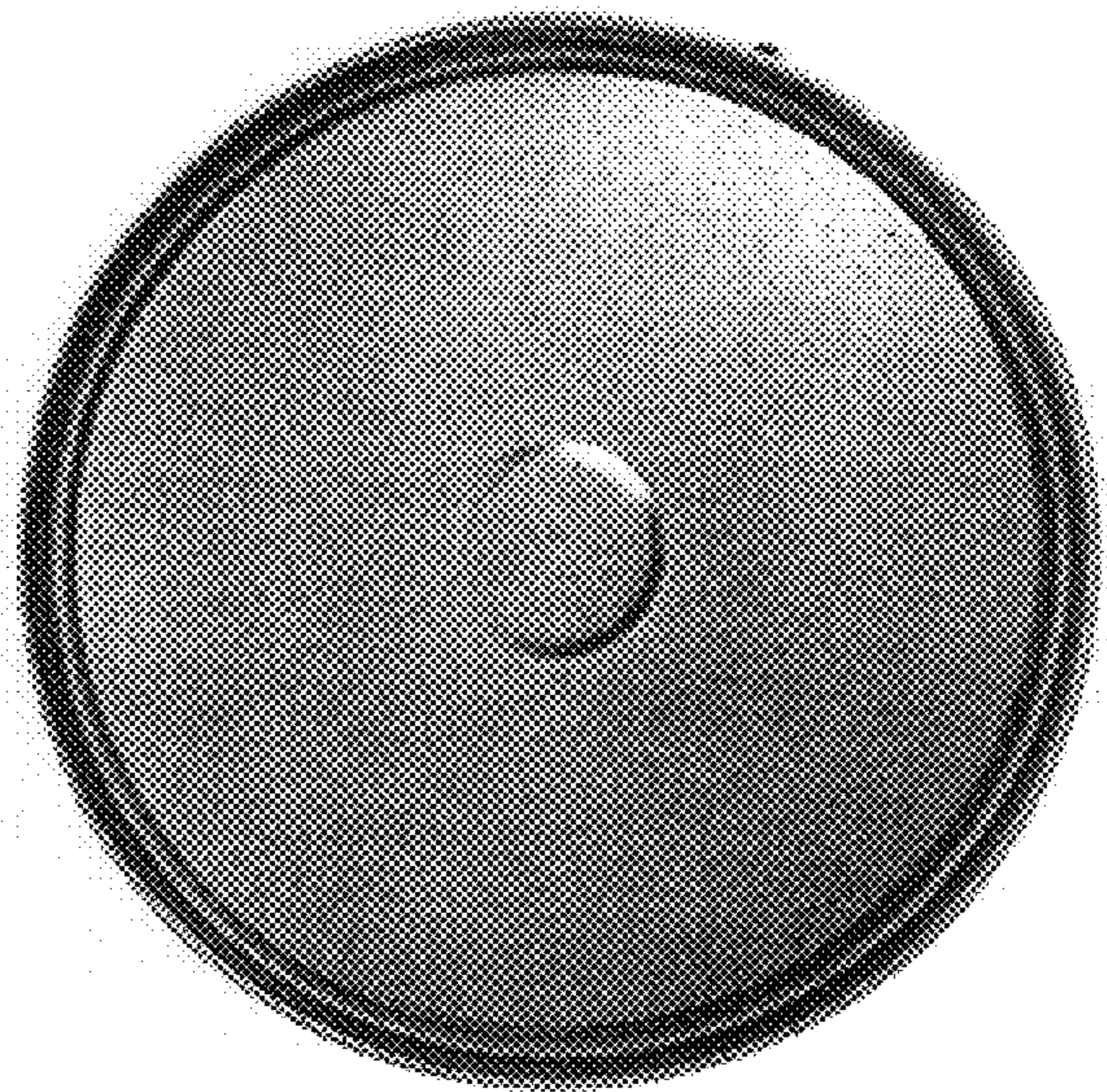
