(57) **CLAIM**

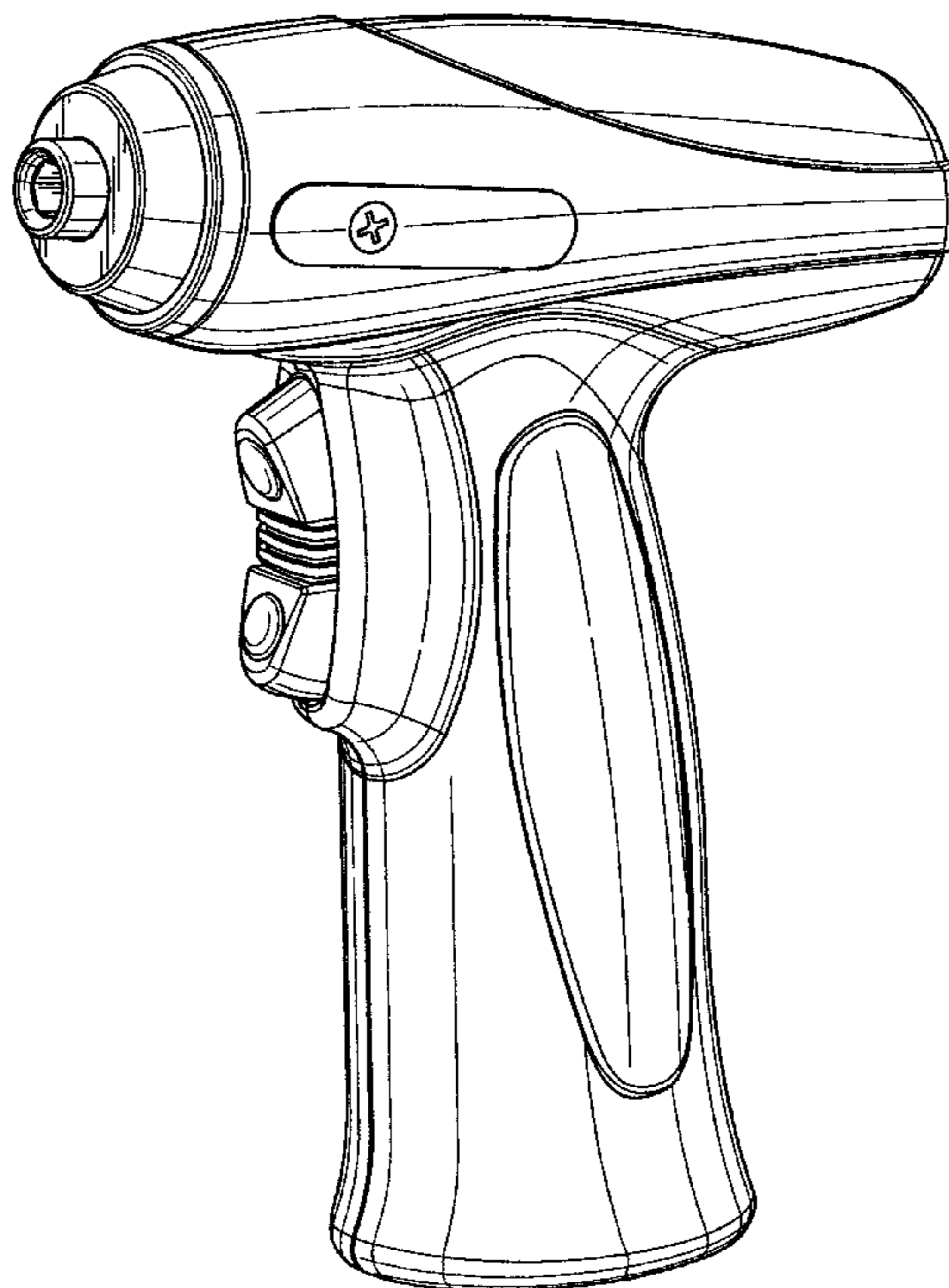
The ornamental design for a rotary driving tool, as shown and described.

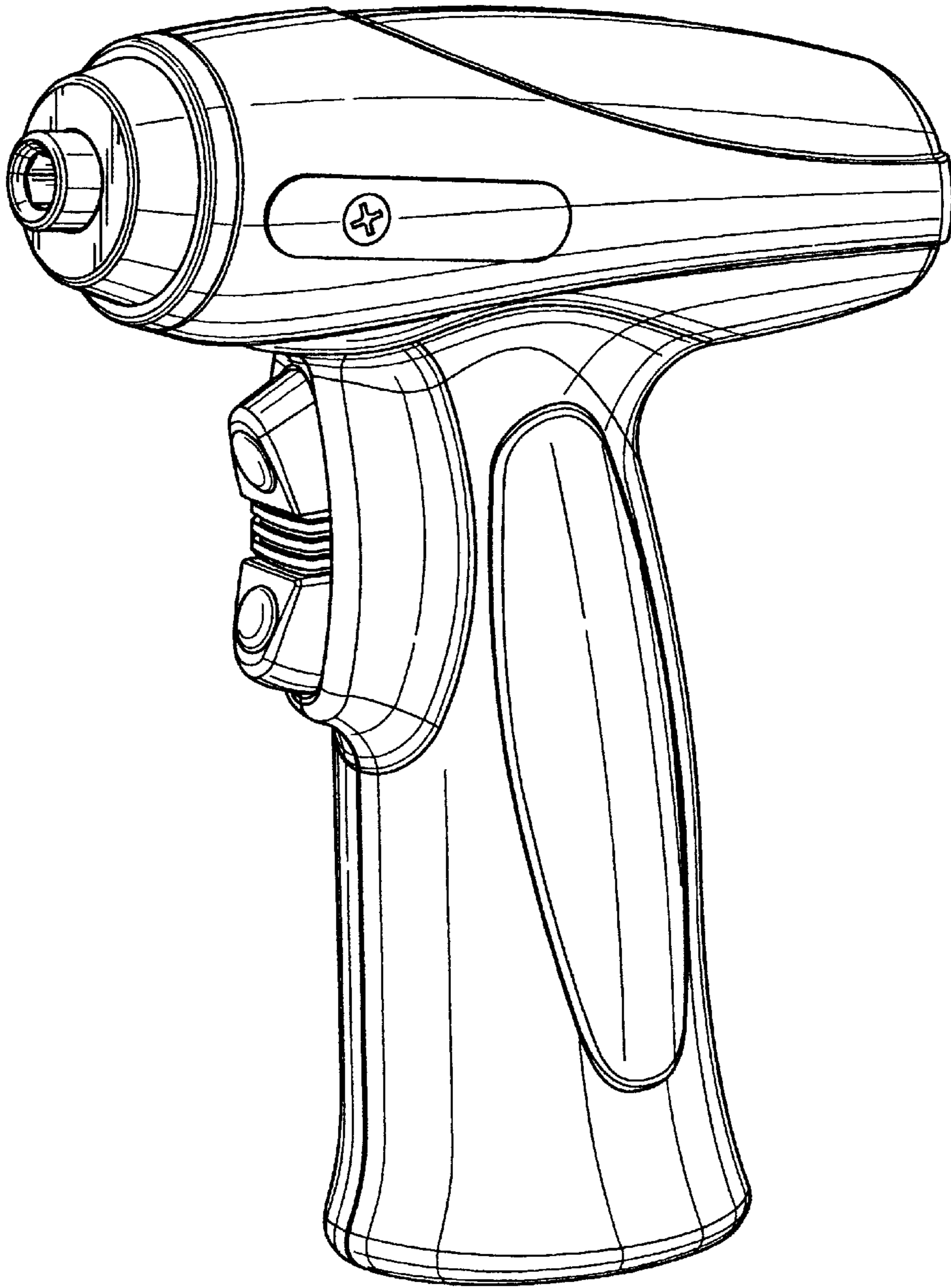

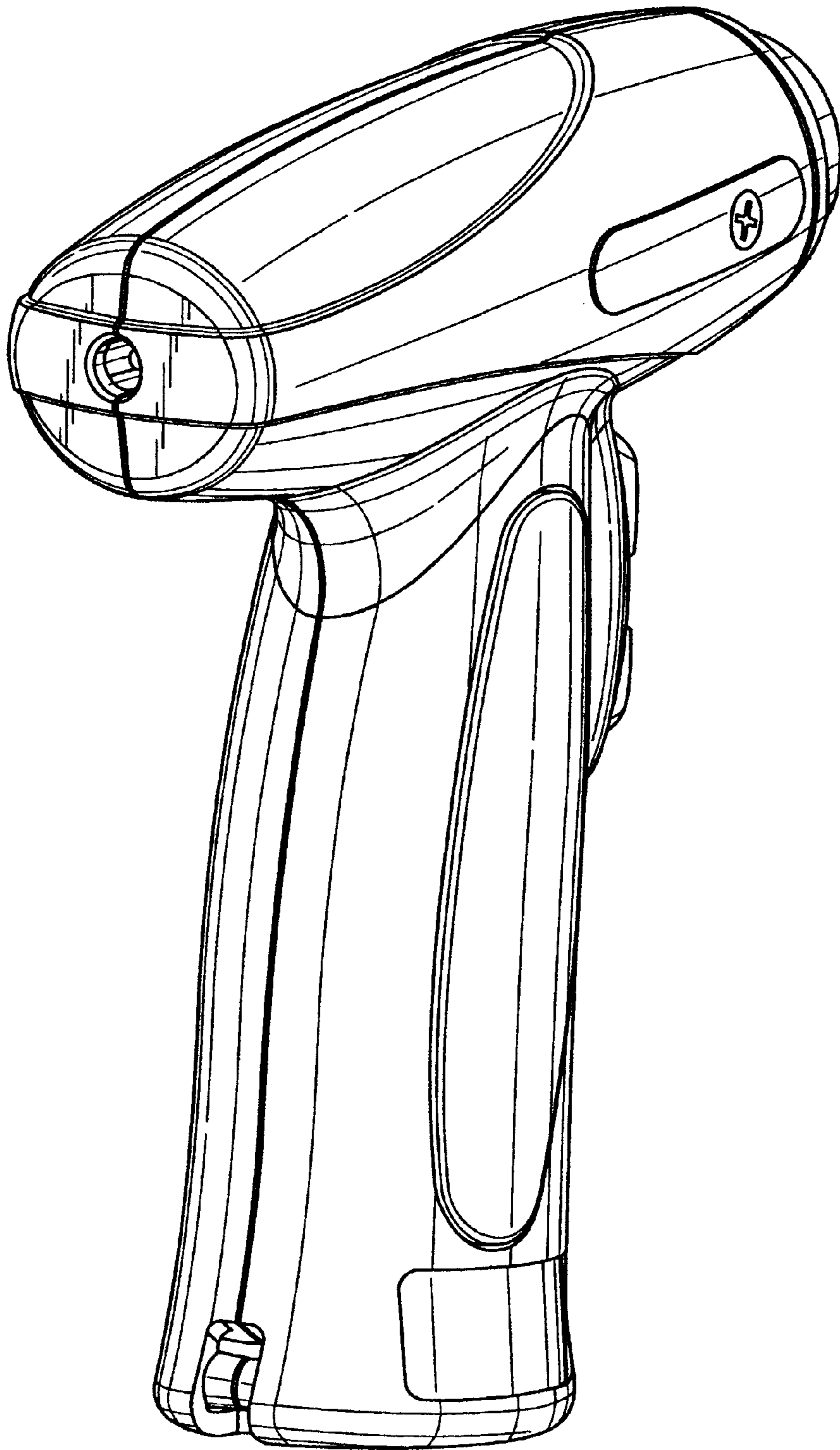

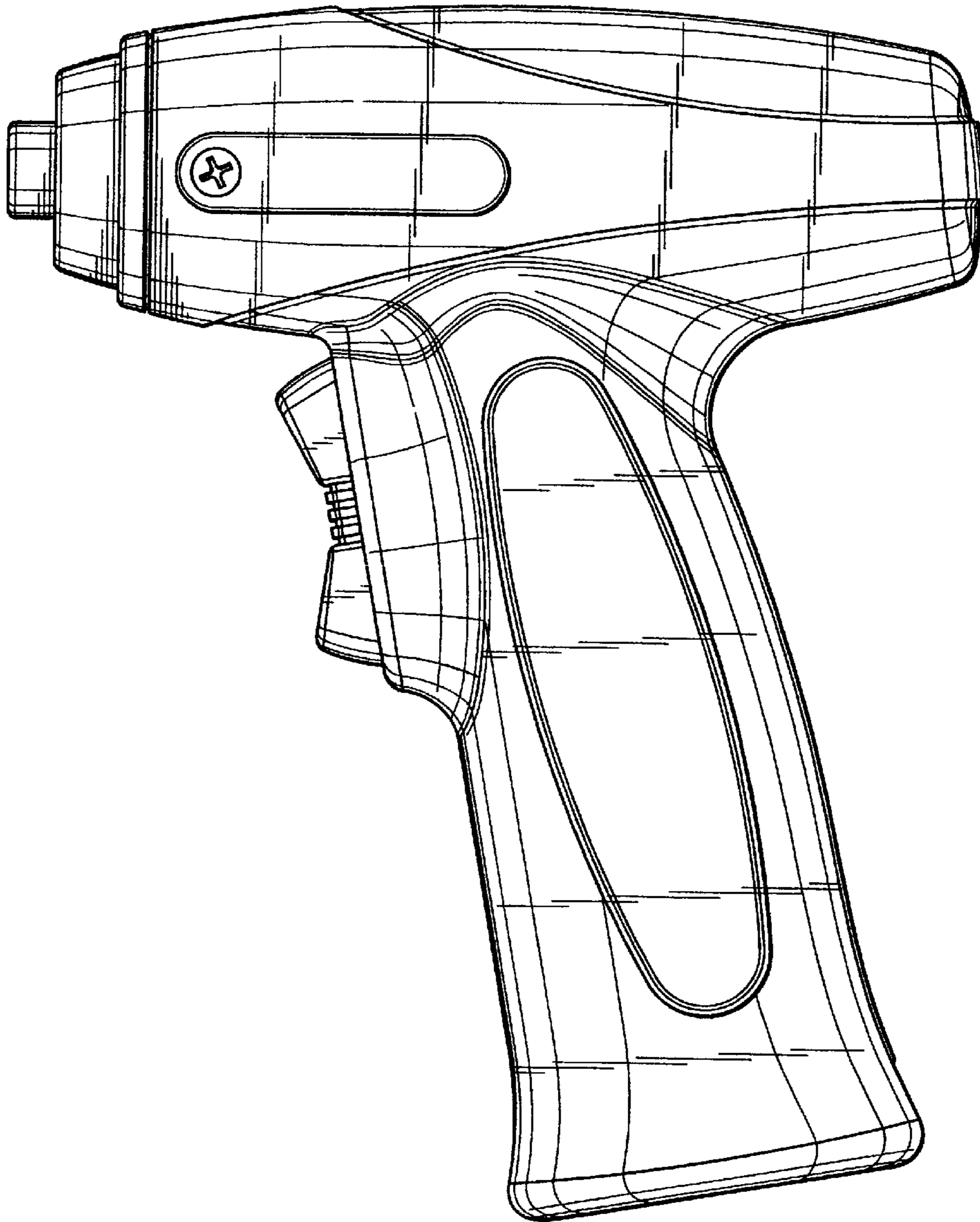

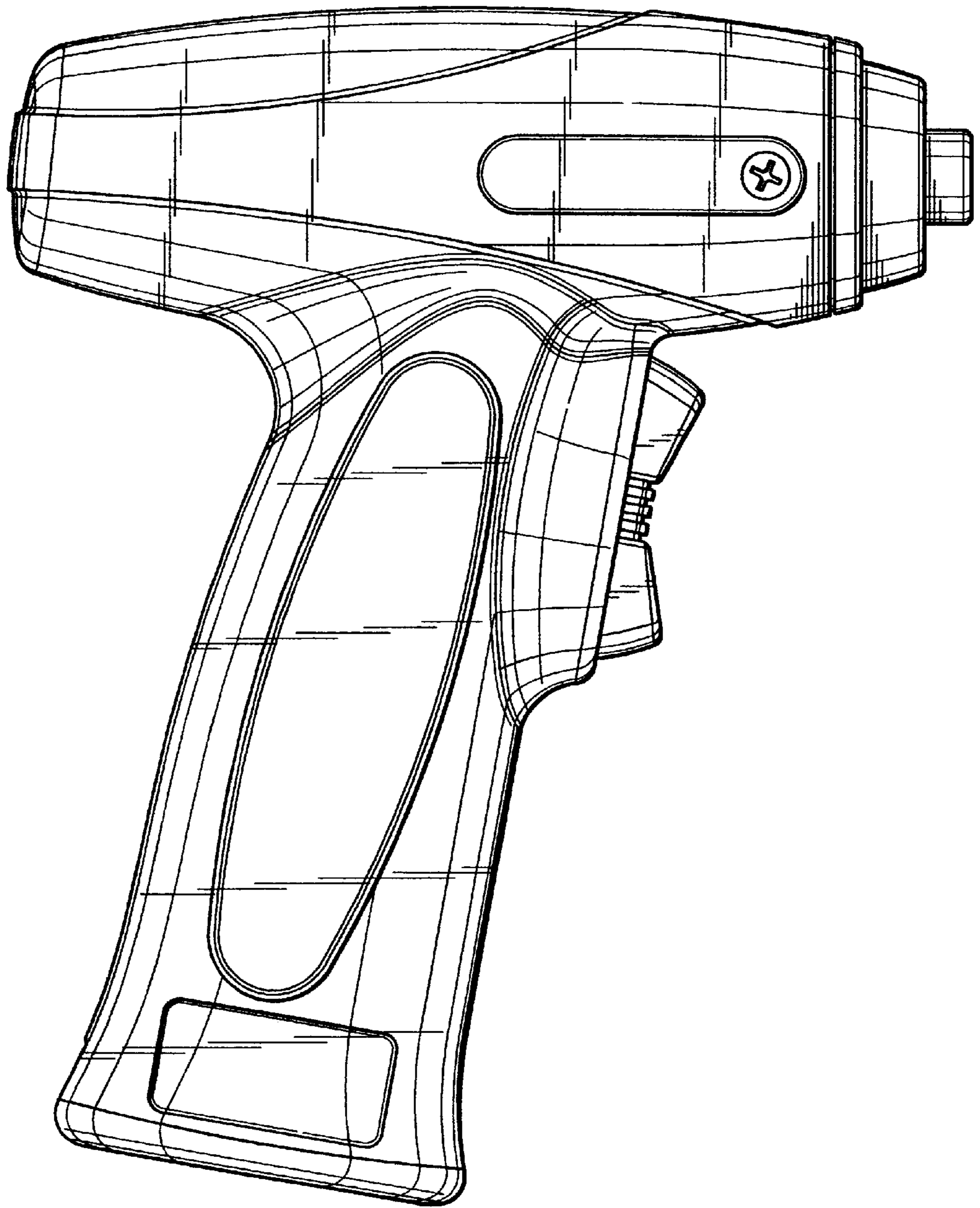

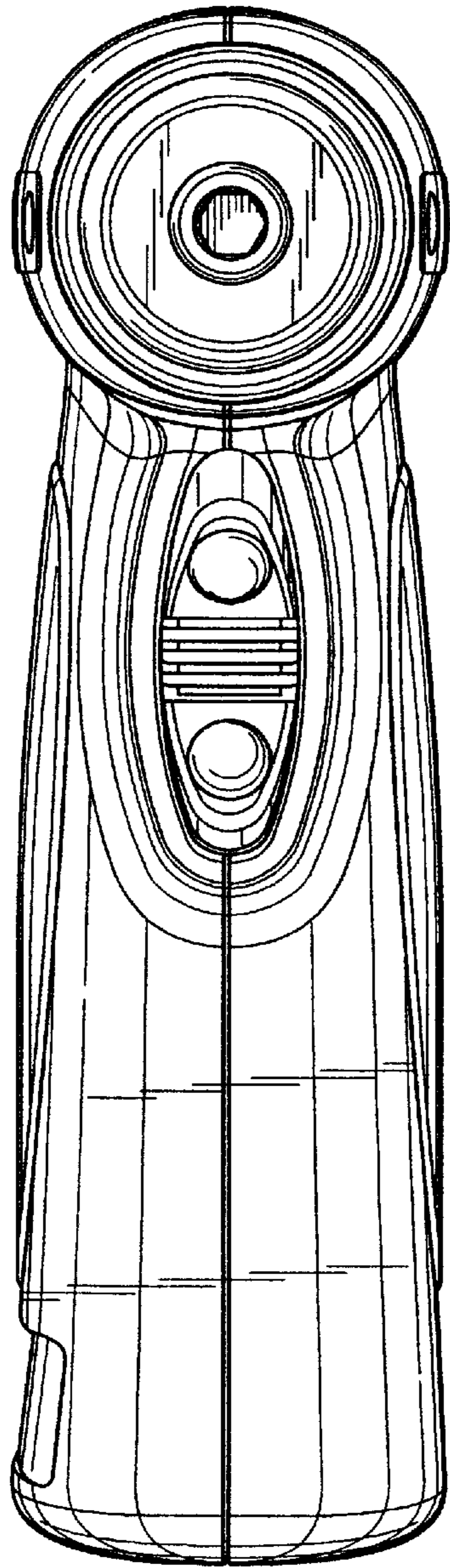

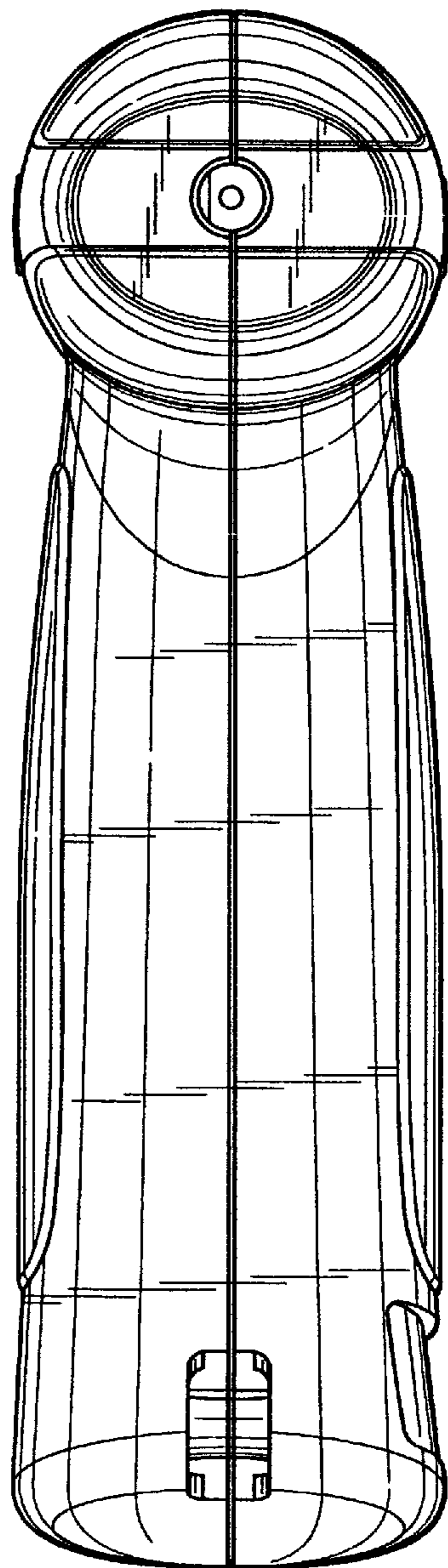

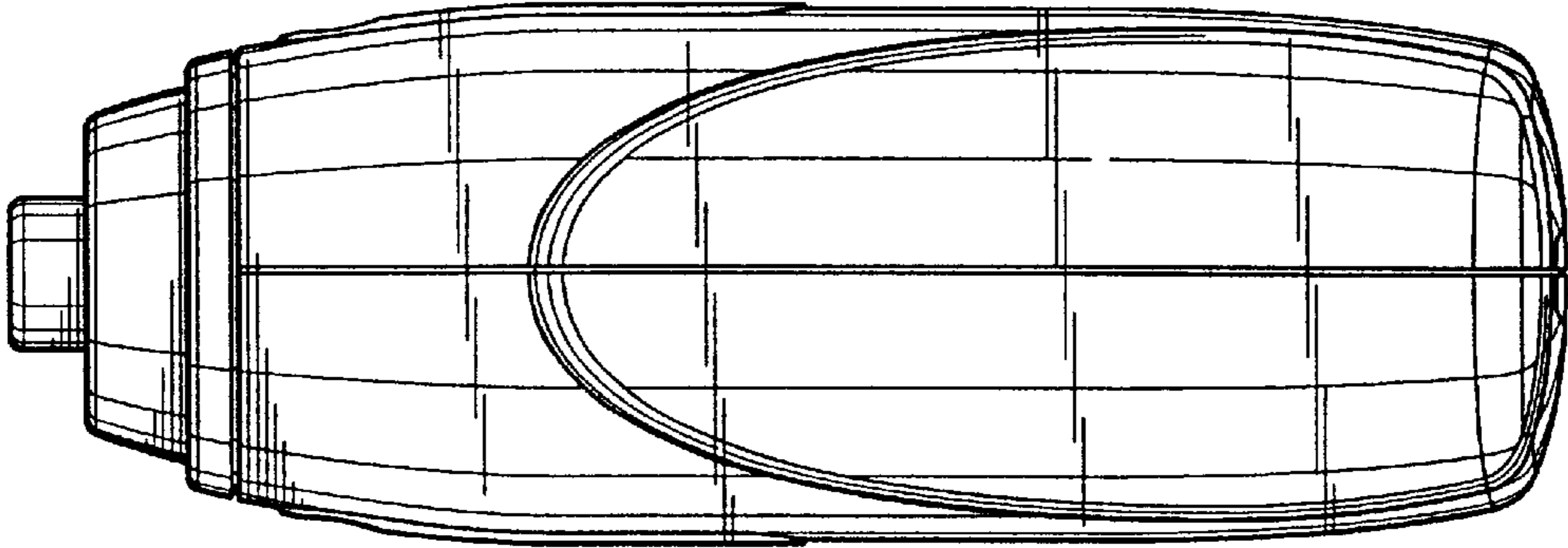

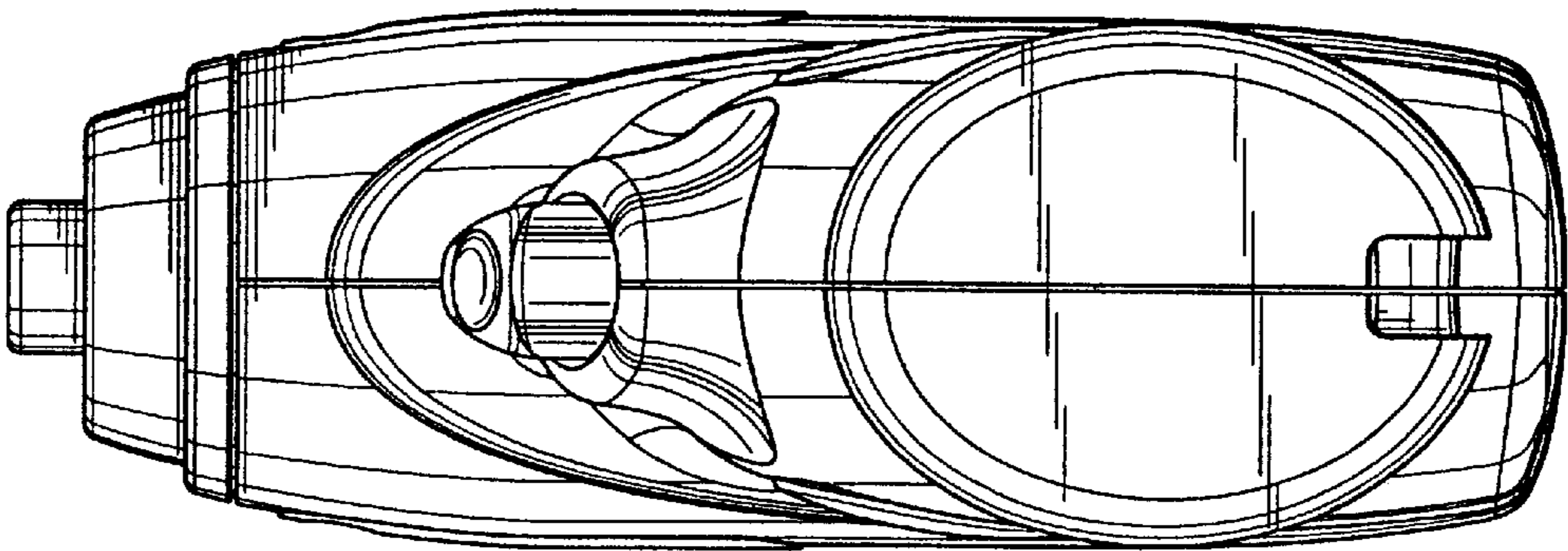
