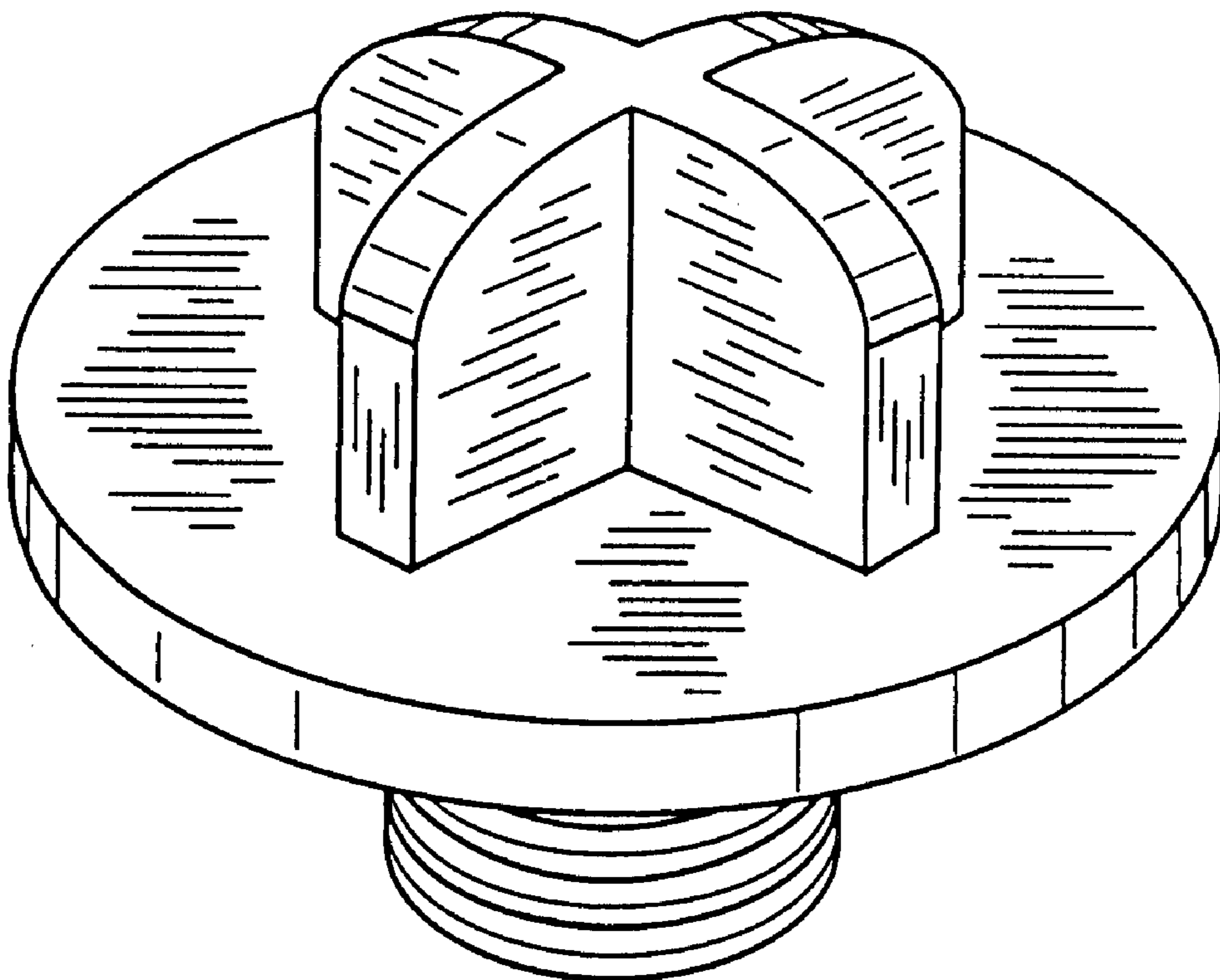
(57) **CLAIM**

The ornamental design for a oil or fuel filter cap with handle,
as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the oil or fuel filter cap with
handle showing the new design with a cross-shaped handle;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof; and,
FIG. 4 is a front side elevation view thereof, the back, left
and right side elevation views thereof being each a mirror
image of this view.

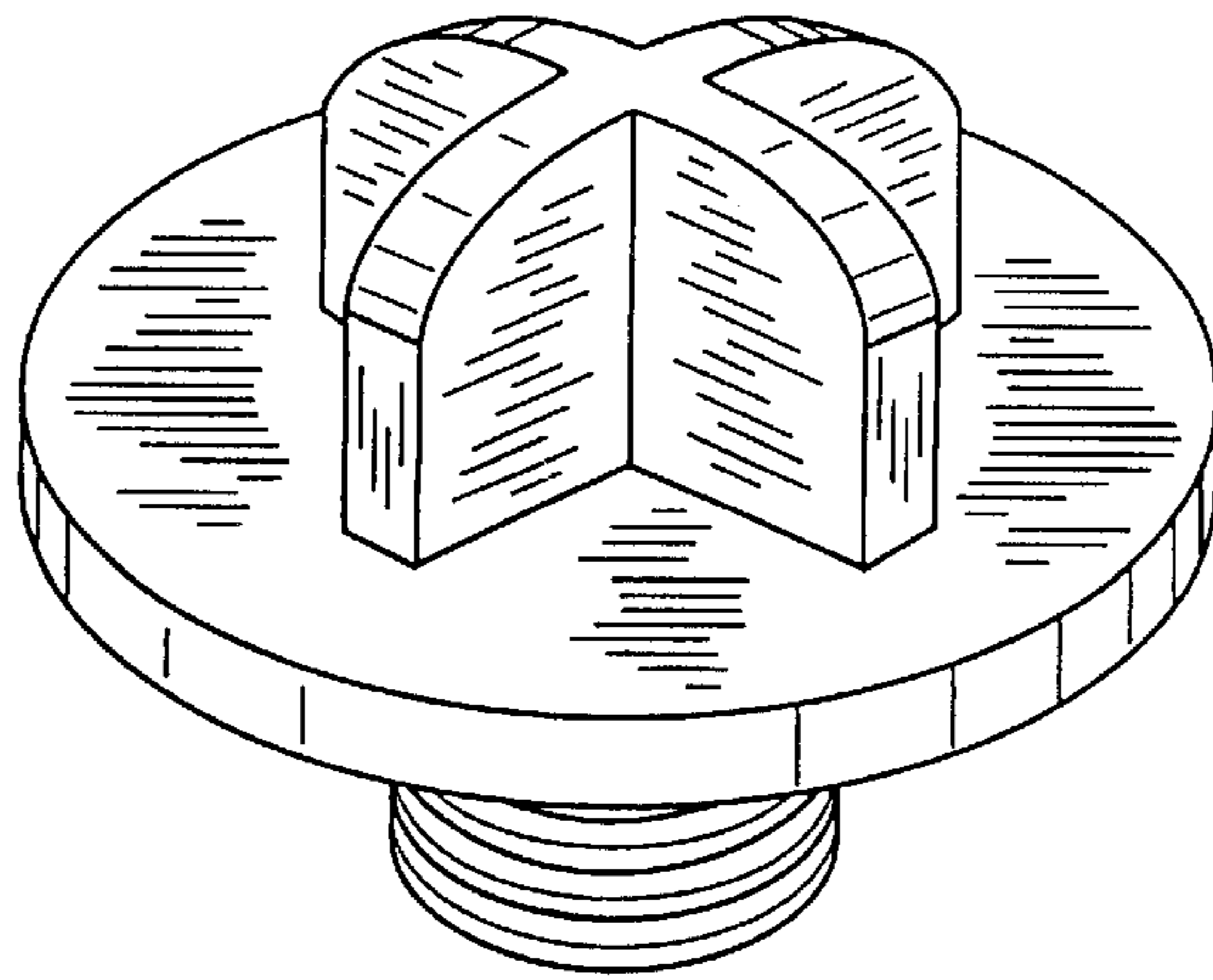

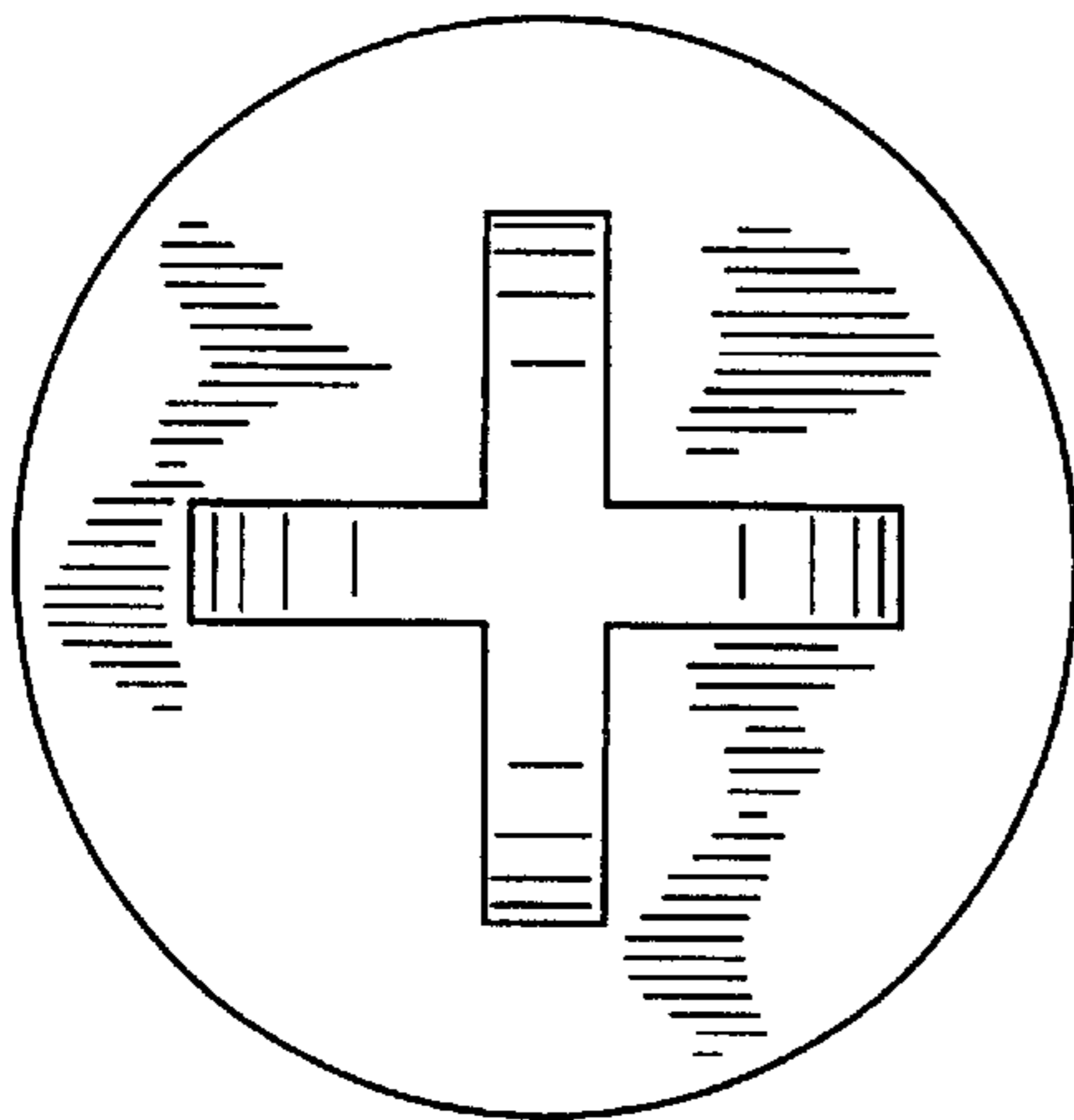

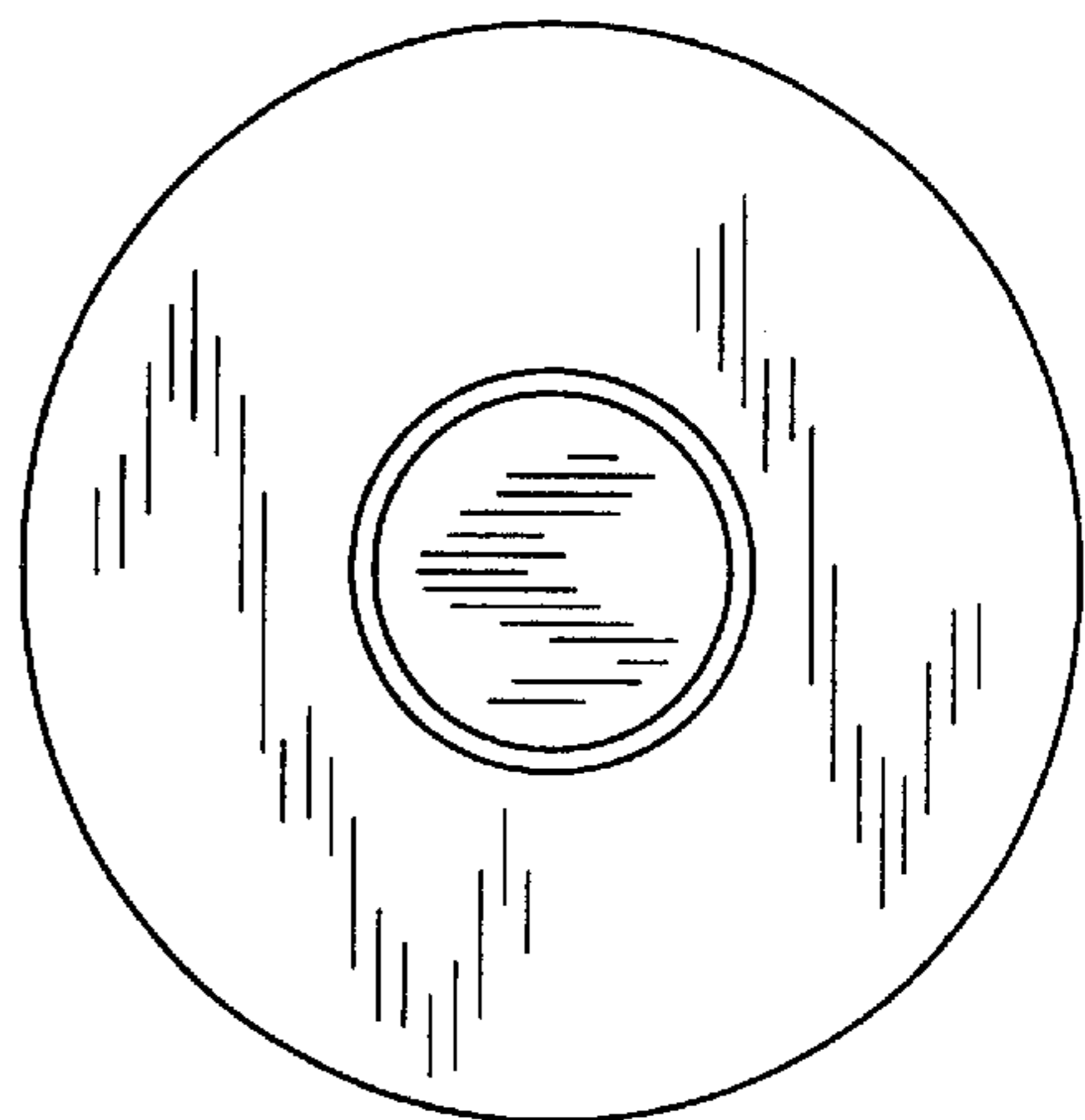

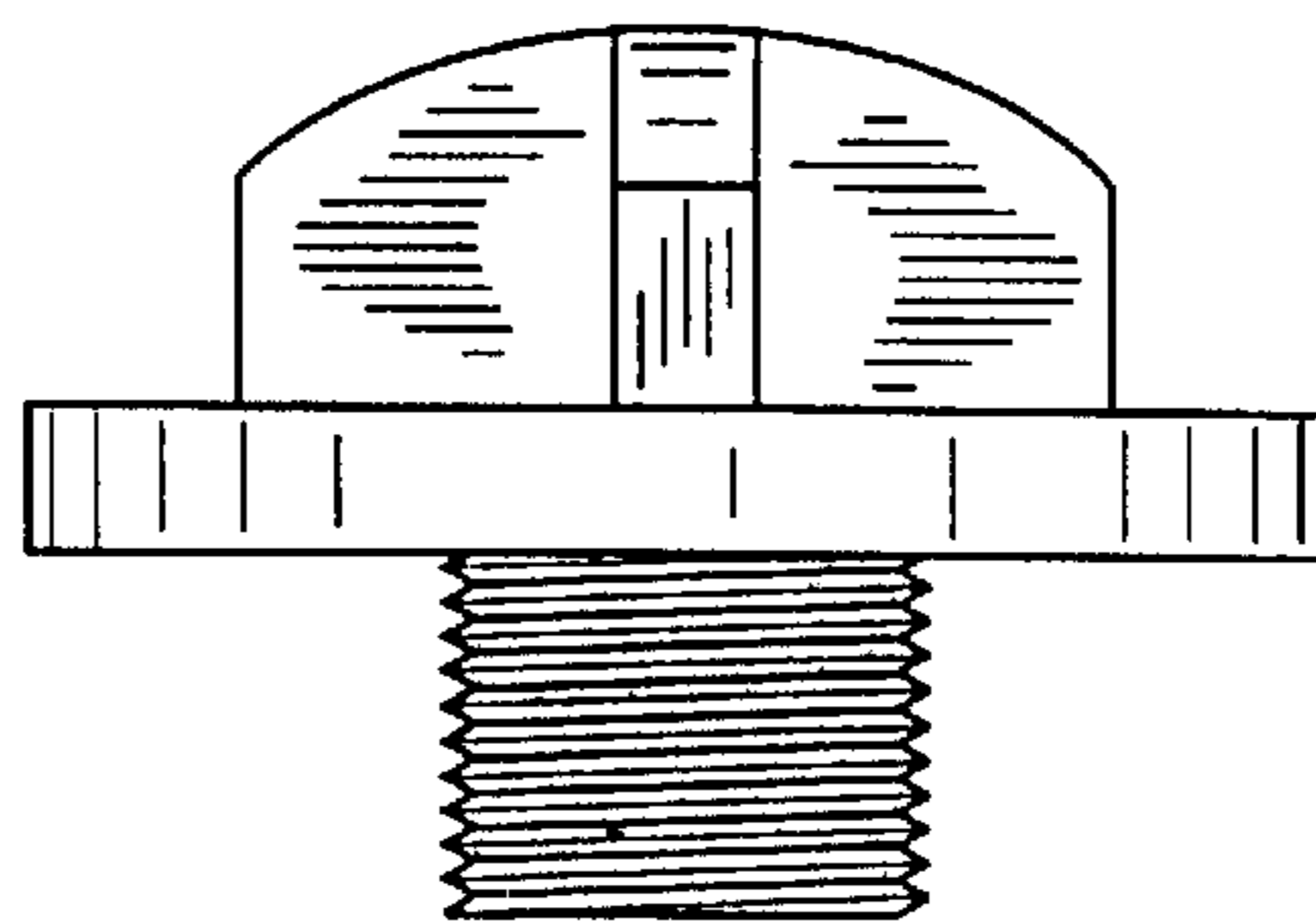
