DESCRIPTION

FIG. 8 is a left side view of the second embodiment;

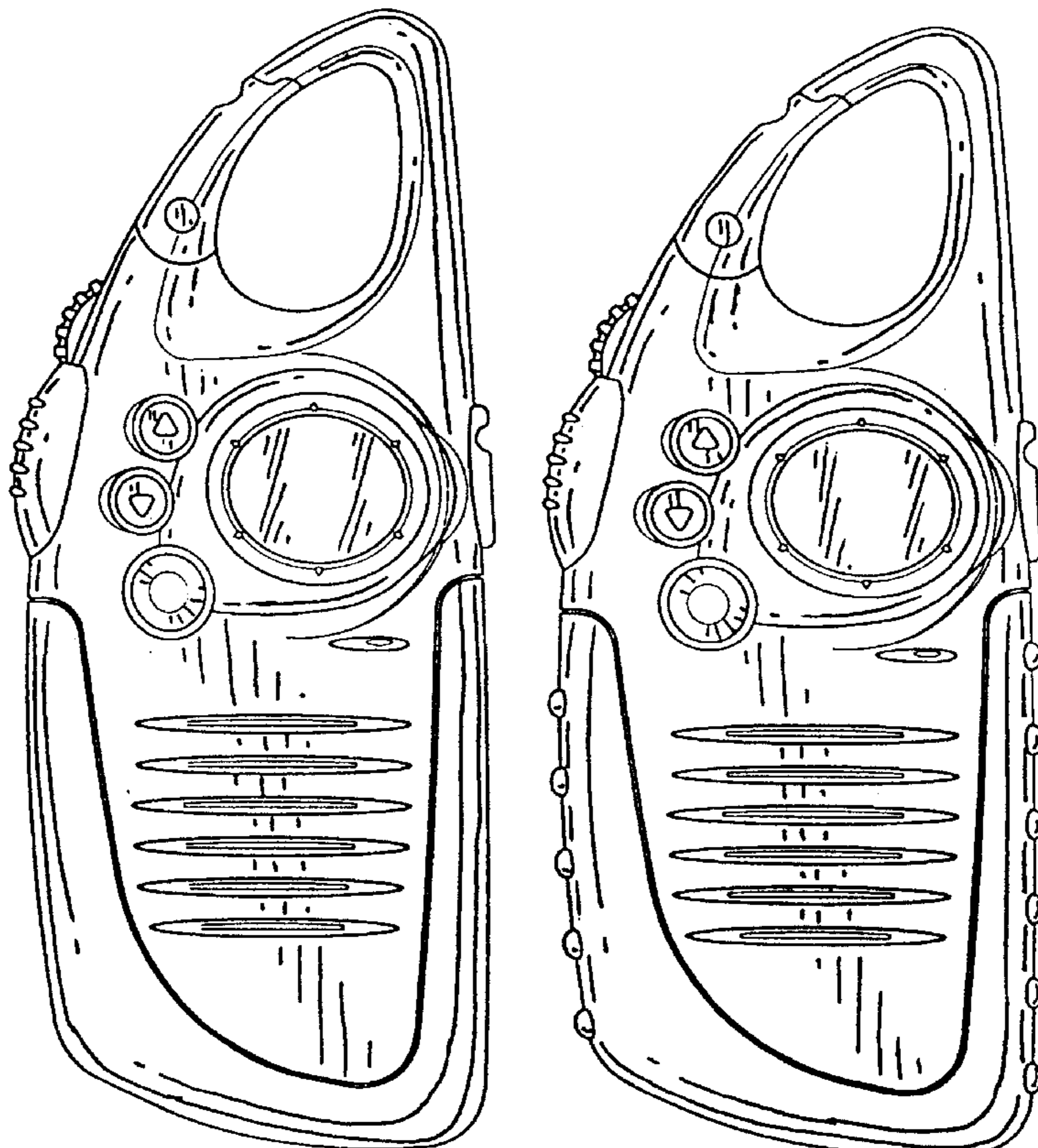
FIG. 9 is a back side view of the second embodiment;

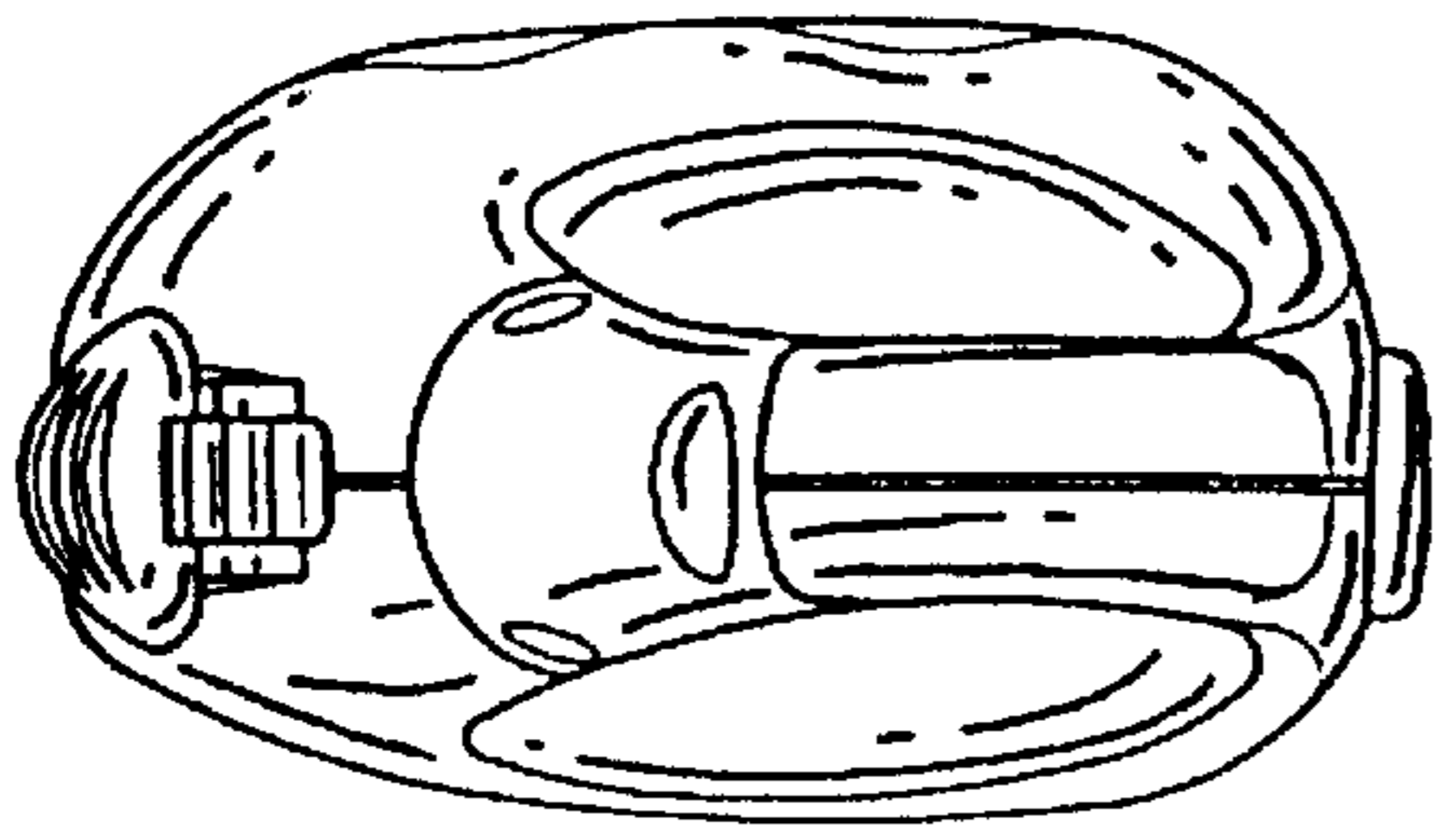

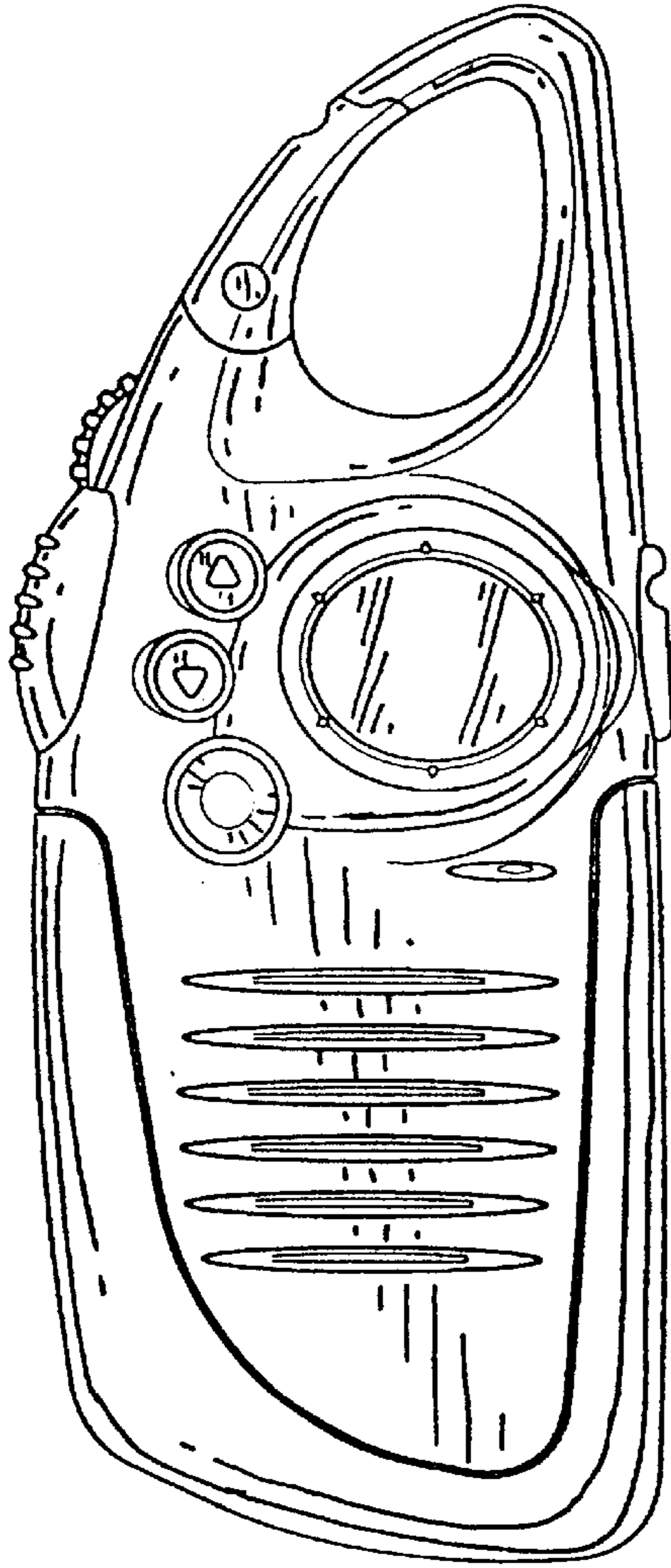

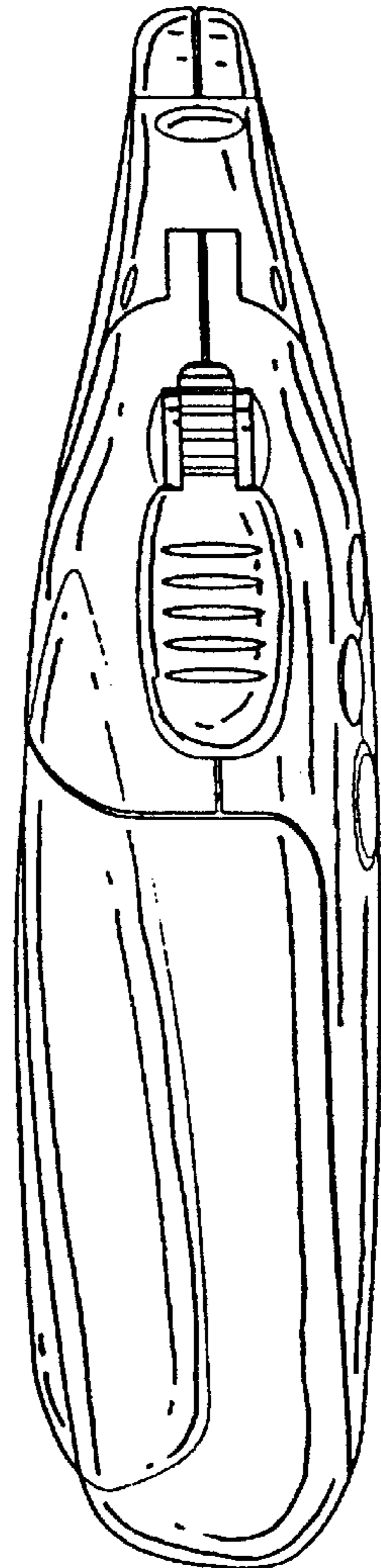

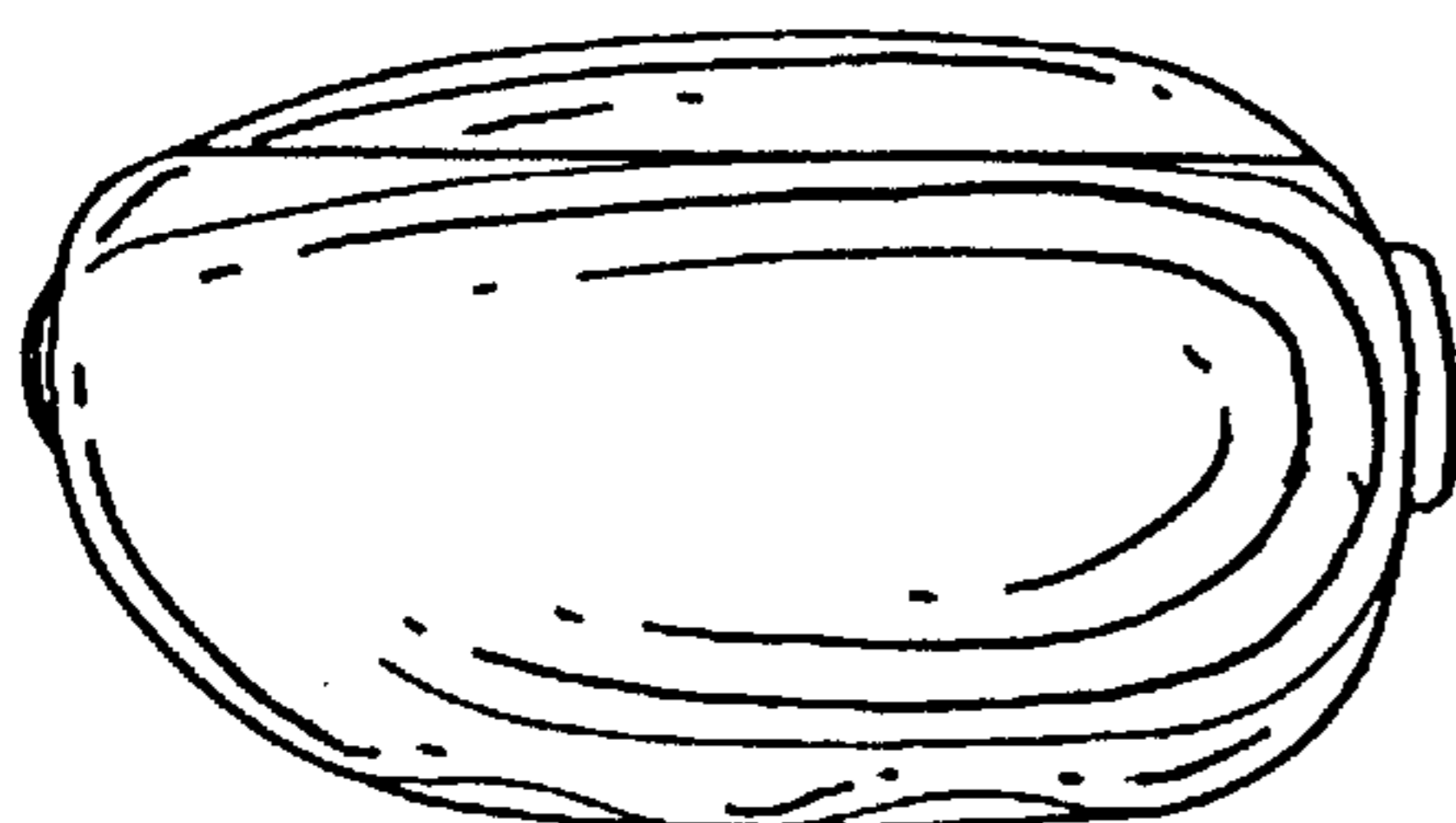

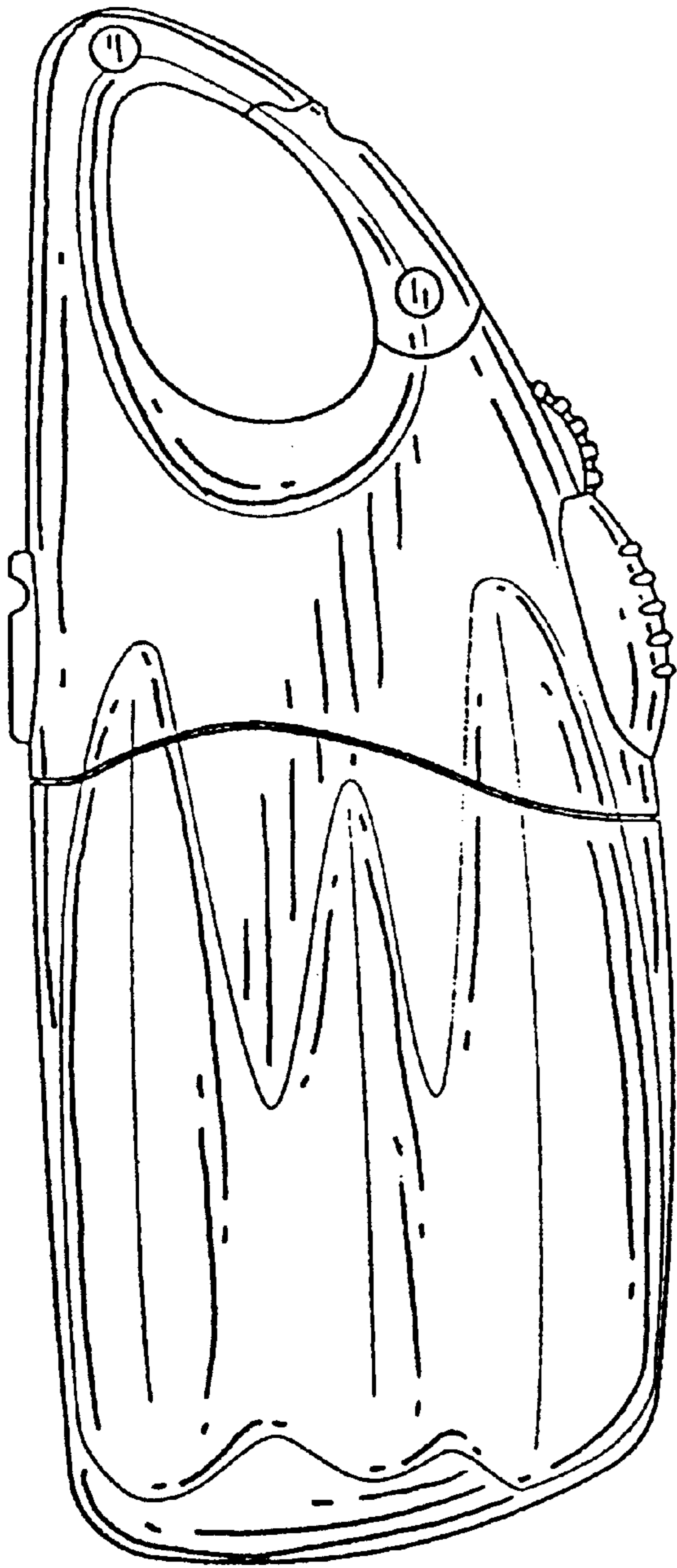

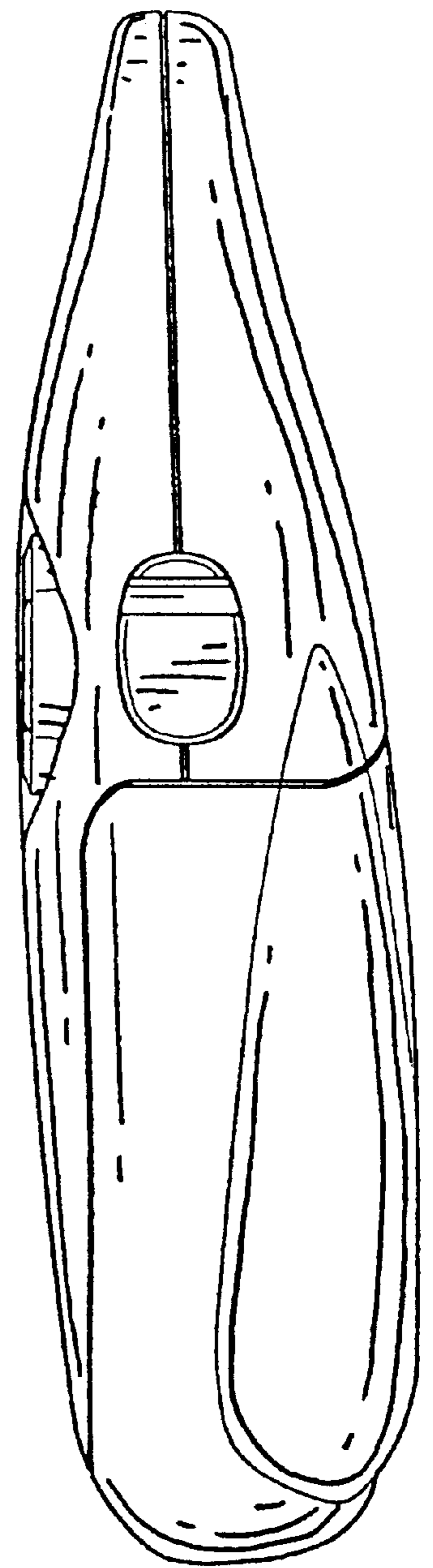

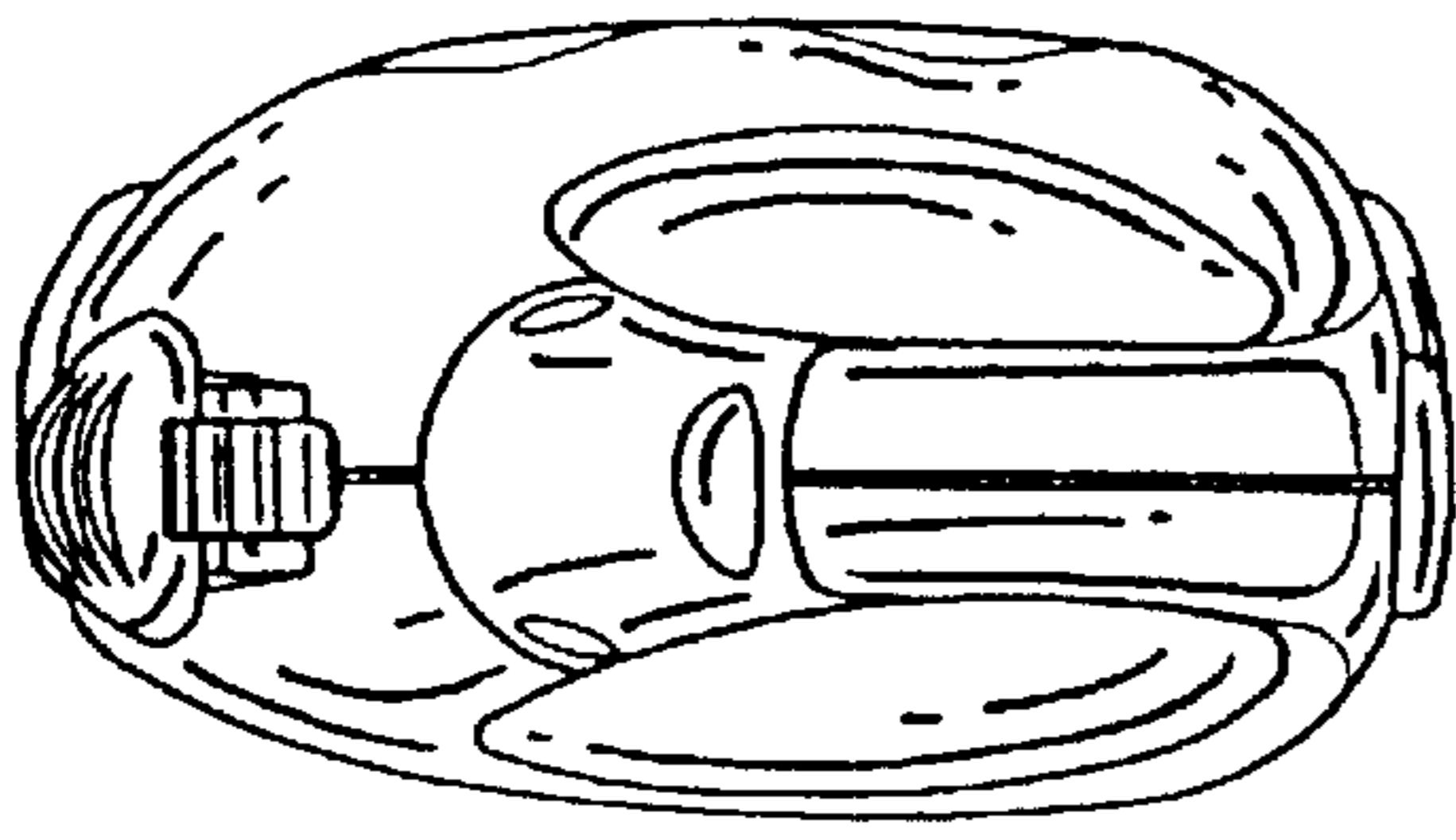

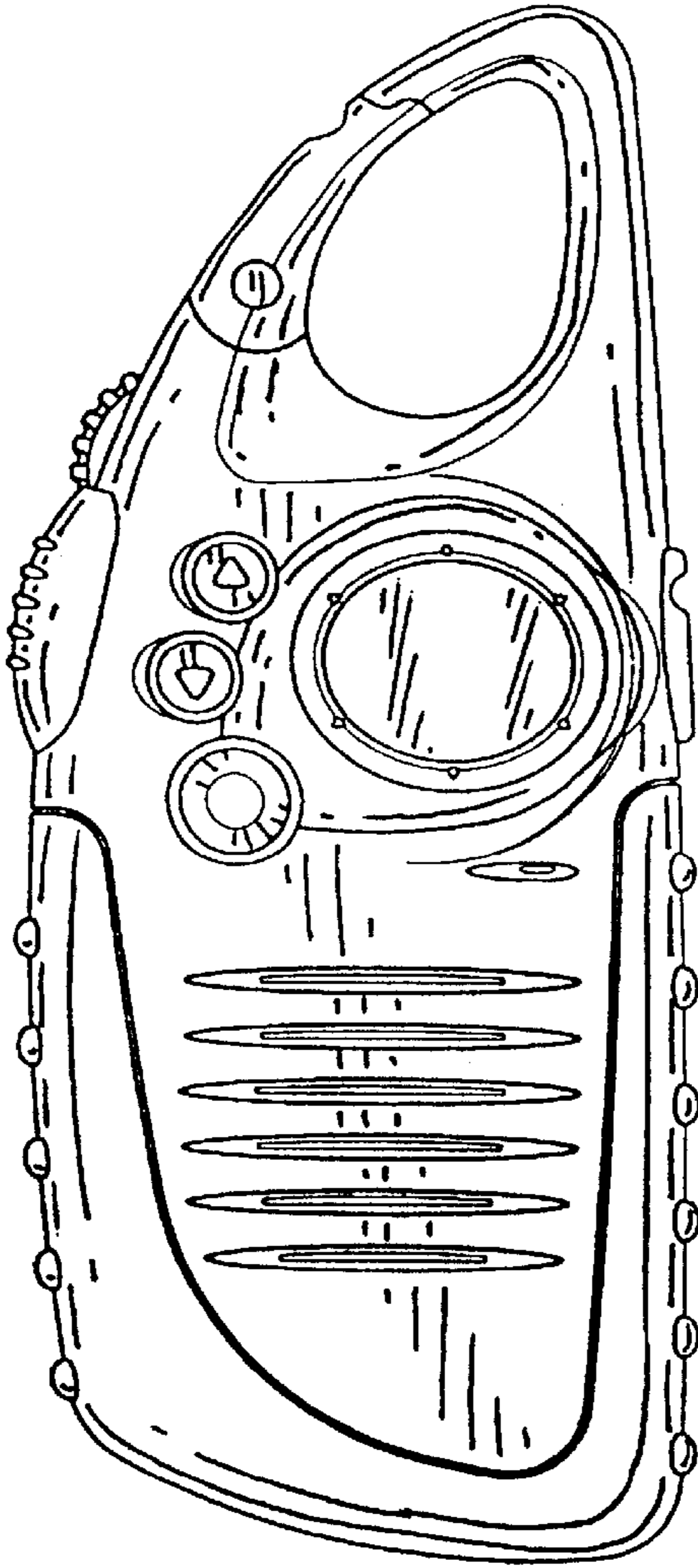

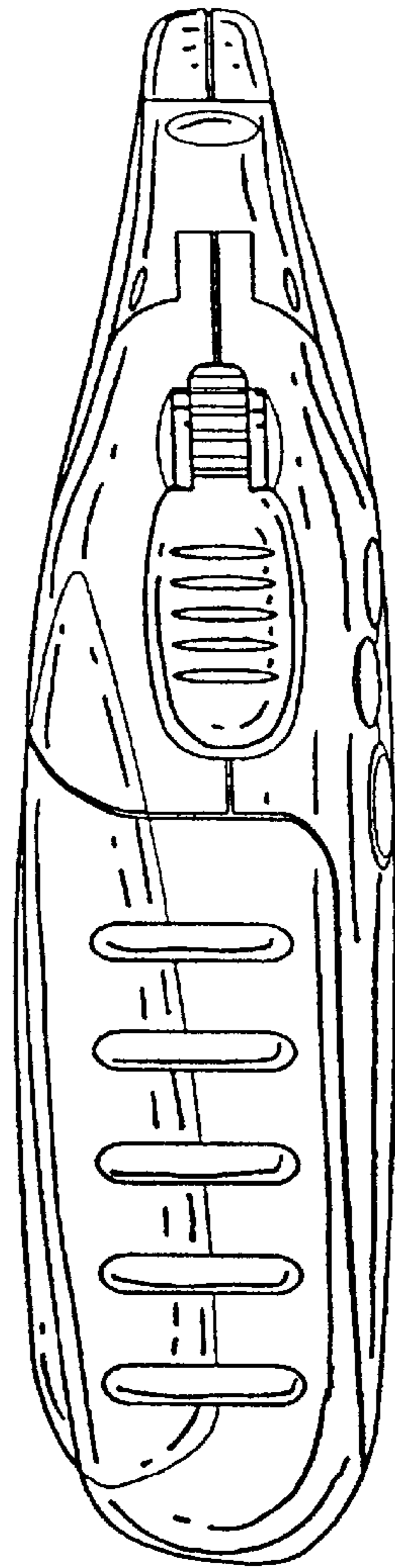

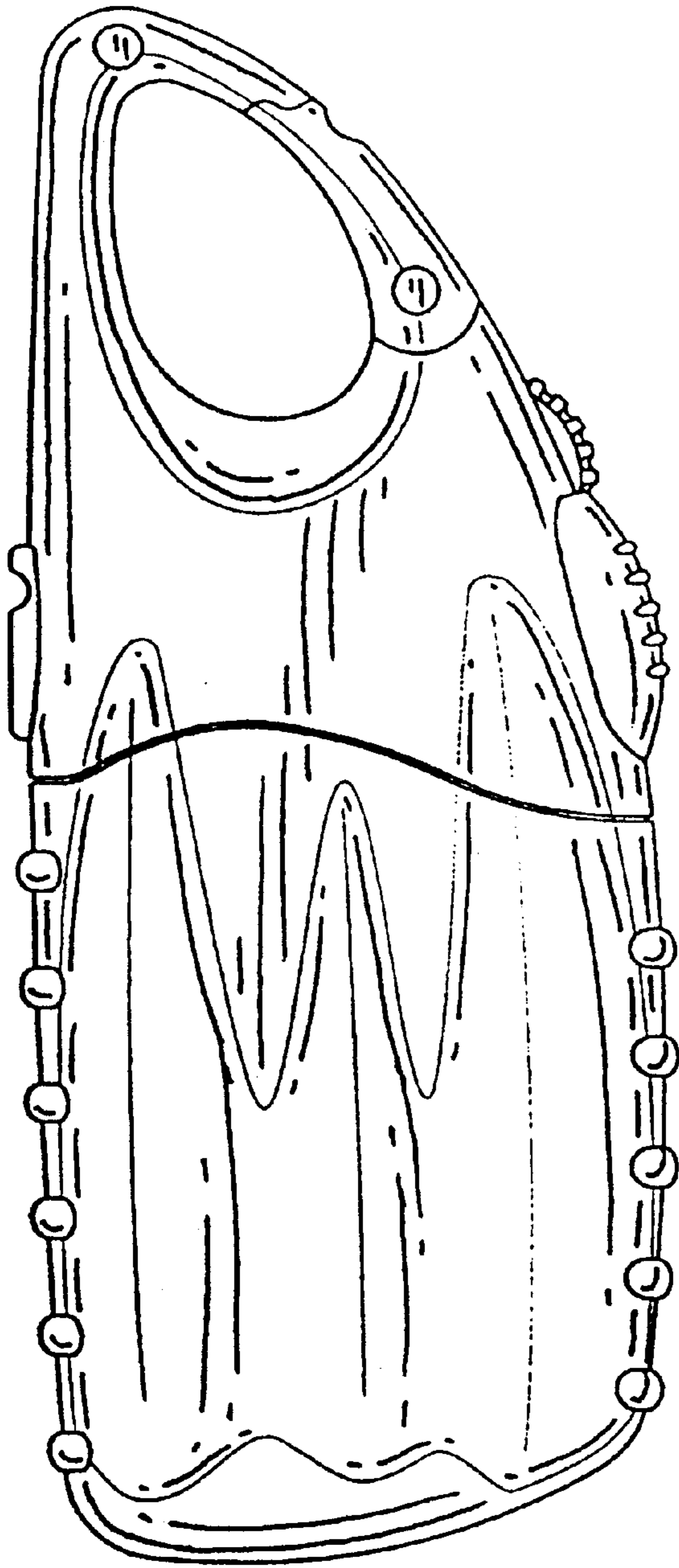

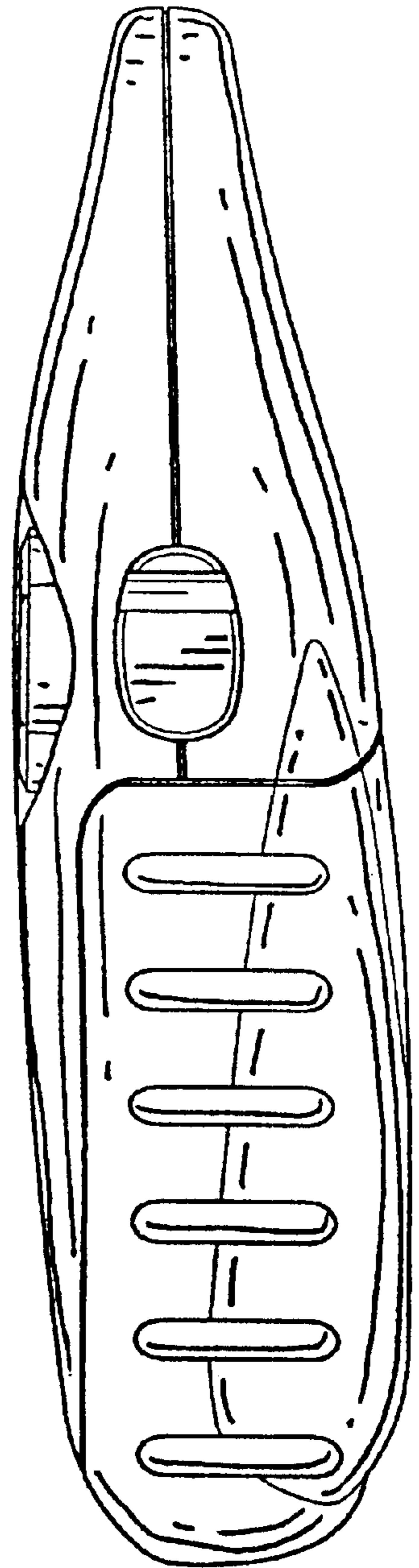
