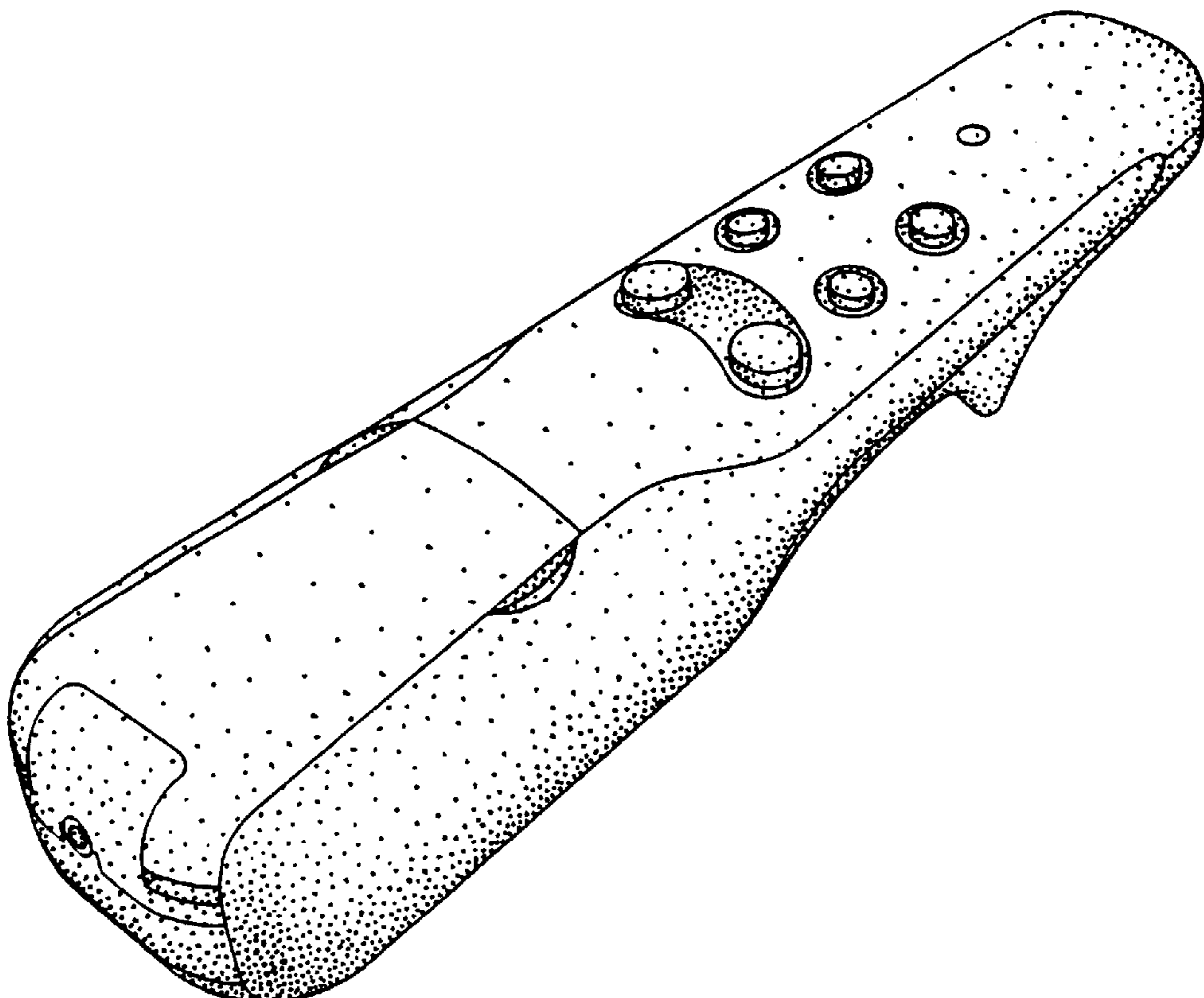
(57) **CLAIM**

The ornamental design for a remote controller for video projector, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom and right side perspective view of a remote controller for a video projector according to our design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a bottom plan view thereof; and,
 FIG. 6 is a right side elevational view thereof, the left side elevational view being a mirror image thereof.

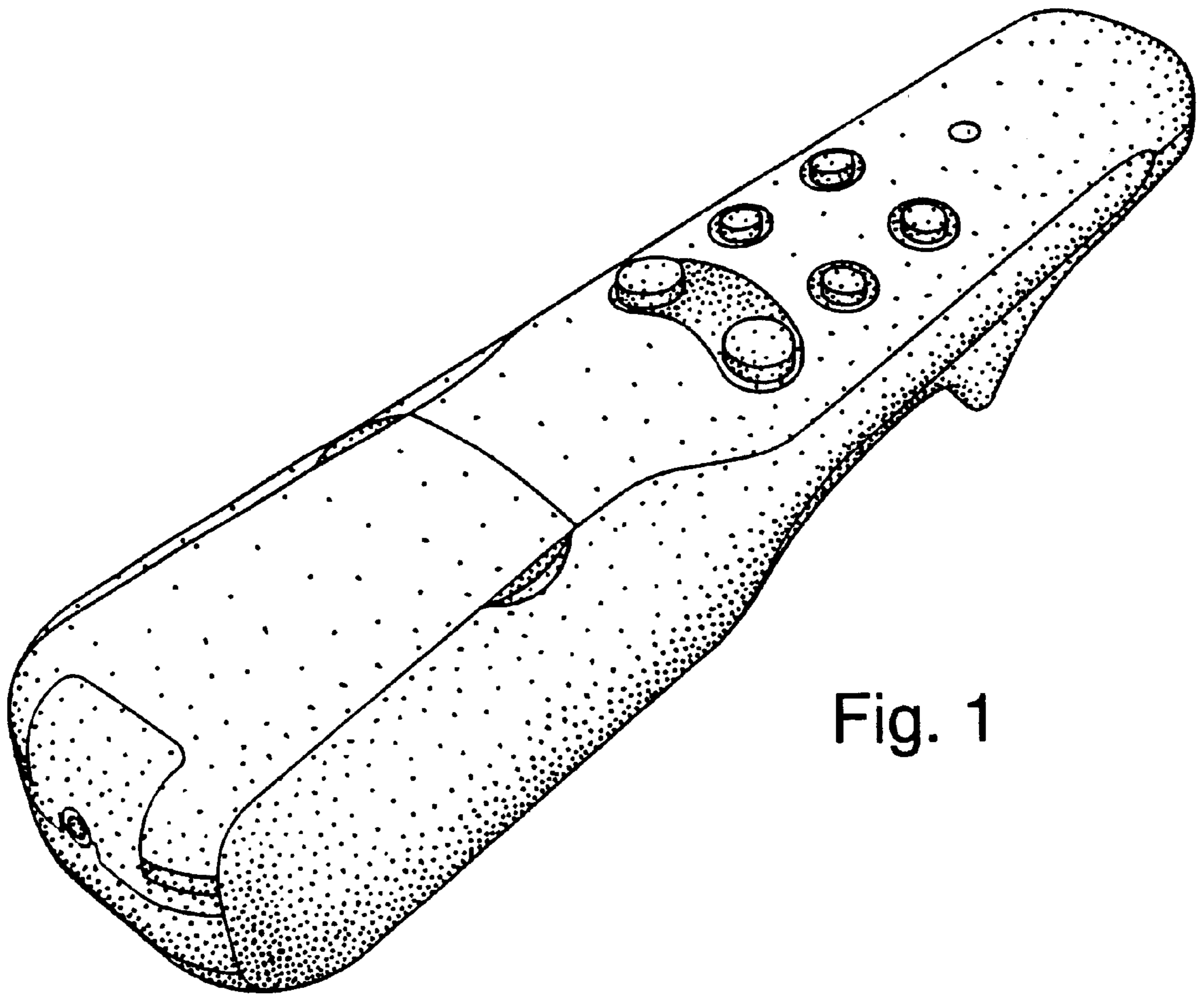

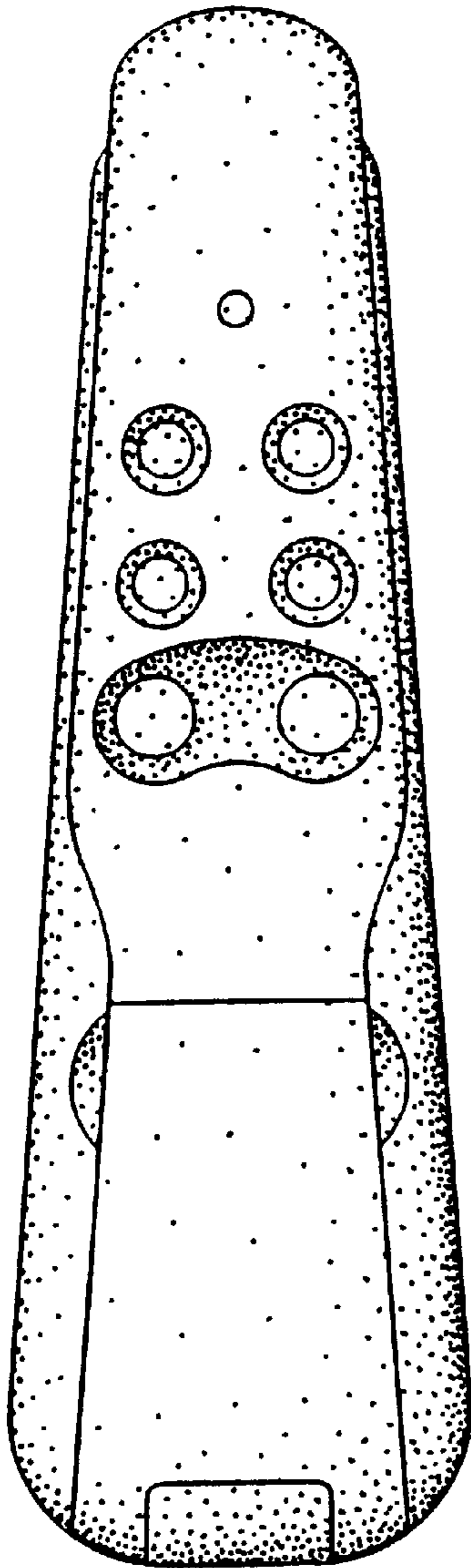

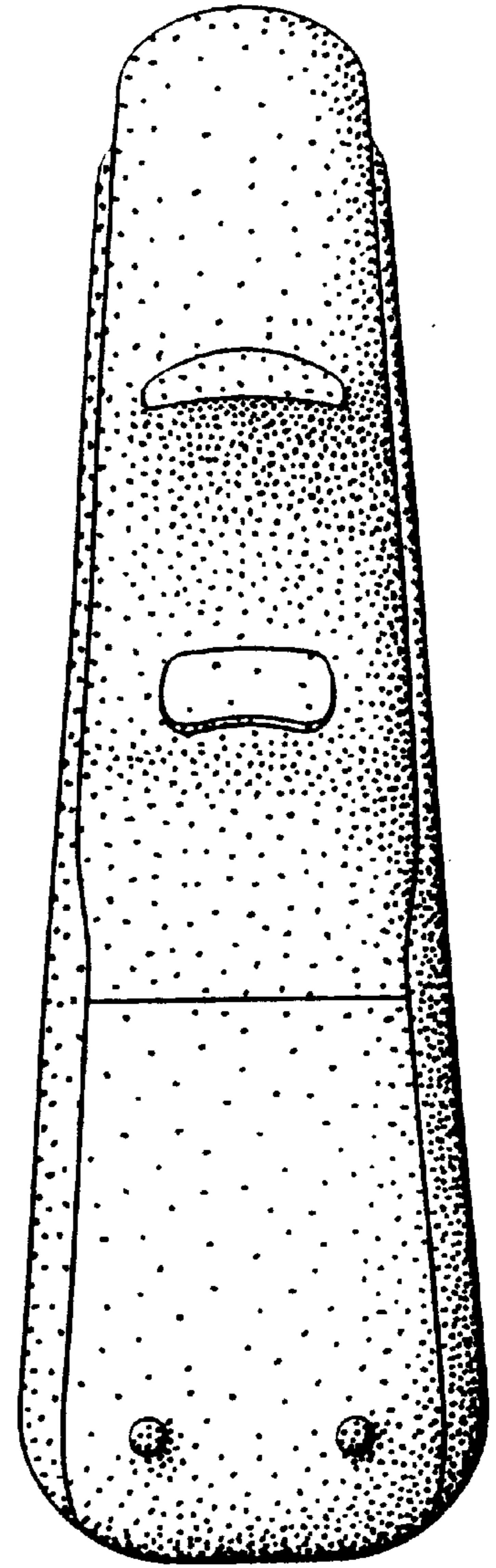

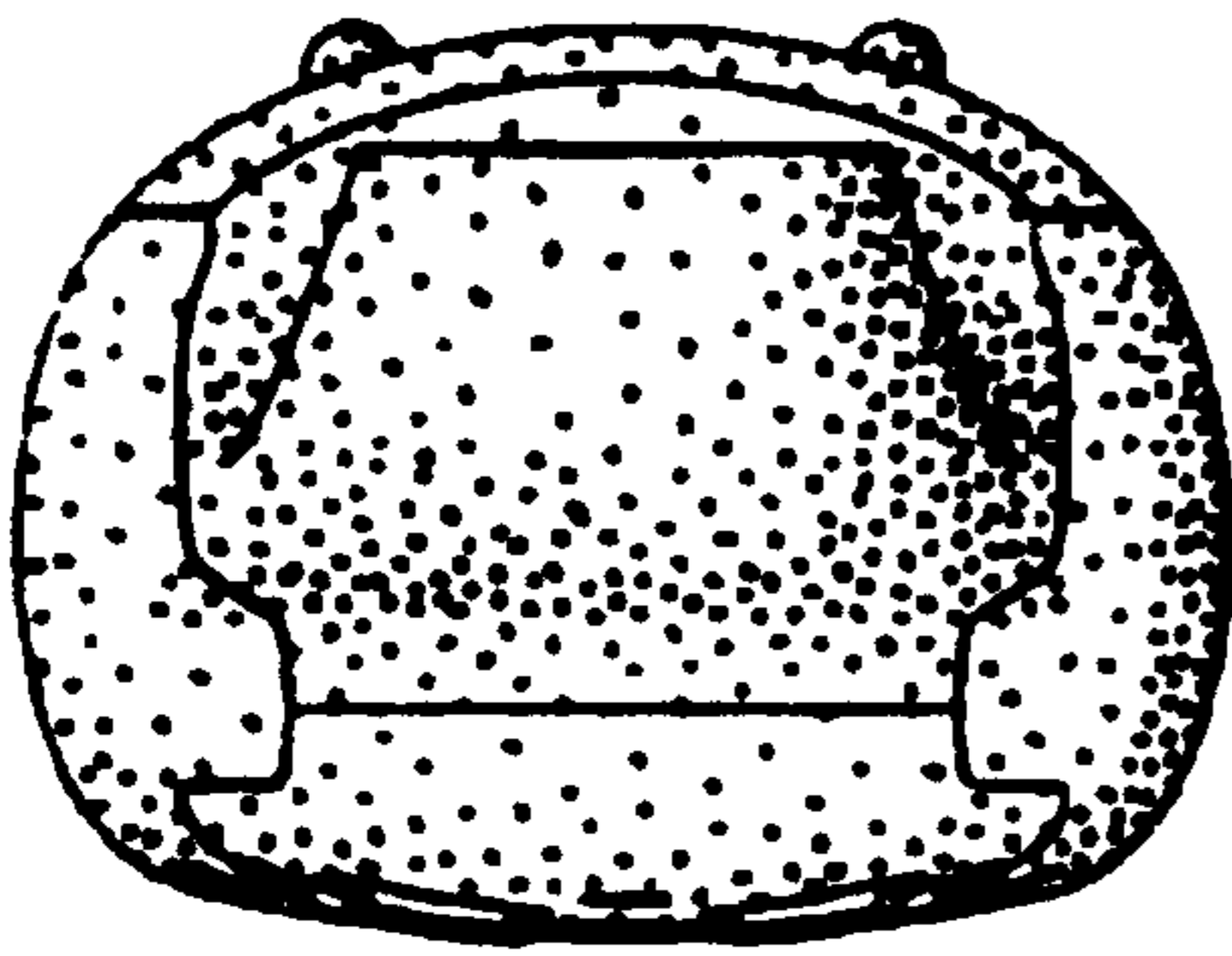

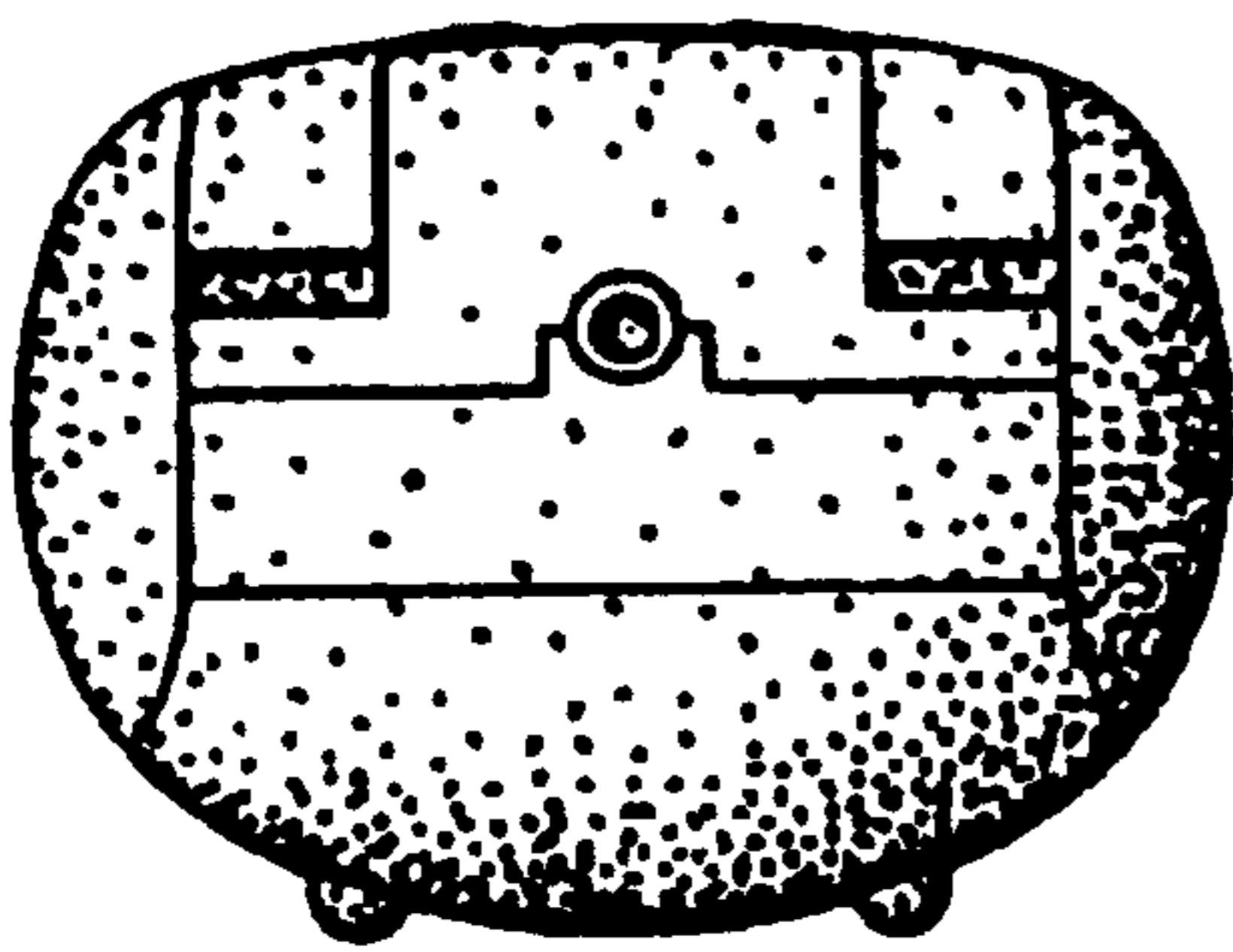

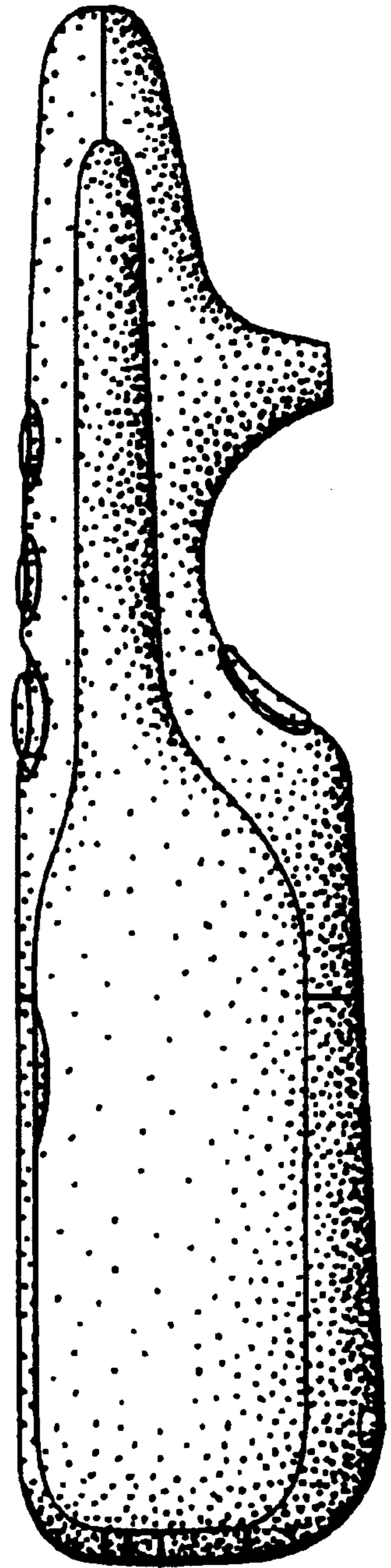
