(57) **CLAIM**

I claim the ornamental design for a jacket cover for a cellular phone, as shown.

DESCRIPTION

FIG. 1 is a front view of the jacket cover for a cellular phone.
 FIG. 2 is a back view of the jacket cover for a cellular phone.
 FIG. 3 is a side view of the left side of the jacket cover for a cellular phone.
 FIG. 4 is a side view of the right side of the jacket cover for a cellular phone.
 FIG. 5 is a bottom view of the jacket cover for a cellular phone.
 FIG. 6 is a top view of the jacket cover for a cellular phone; and,
 FIG. 7 is a perspective view of the jacket cover for a cellular phone.

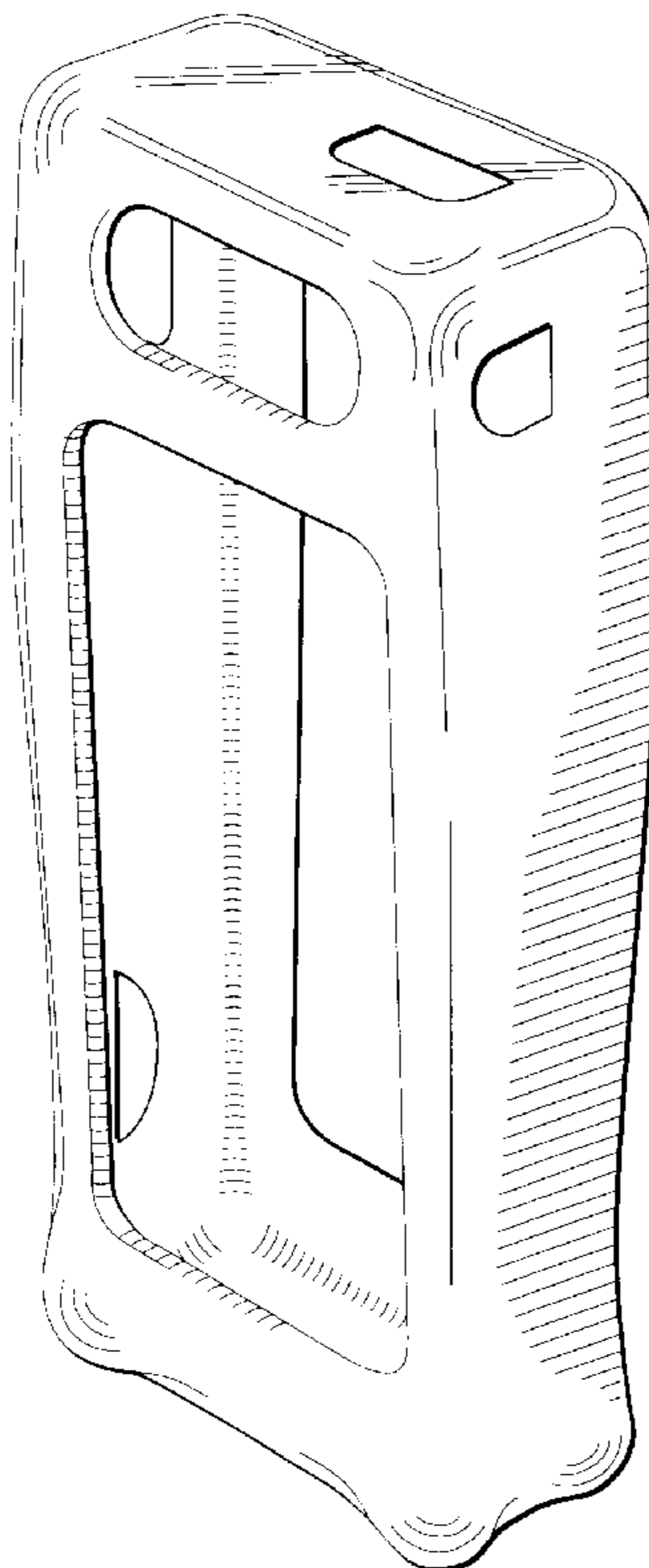

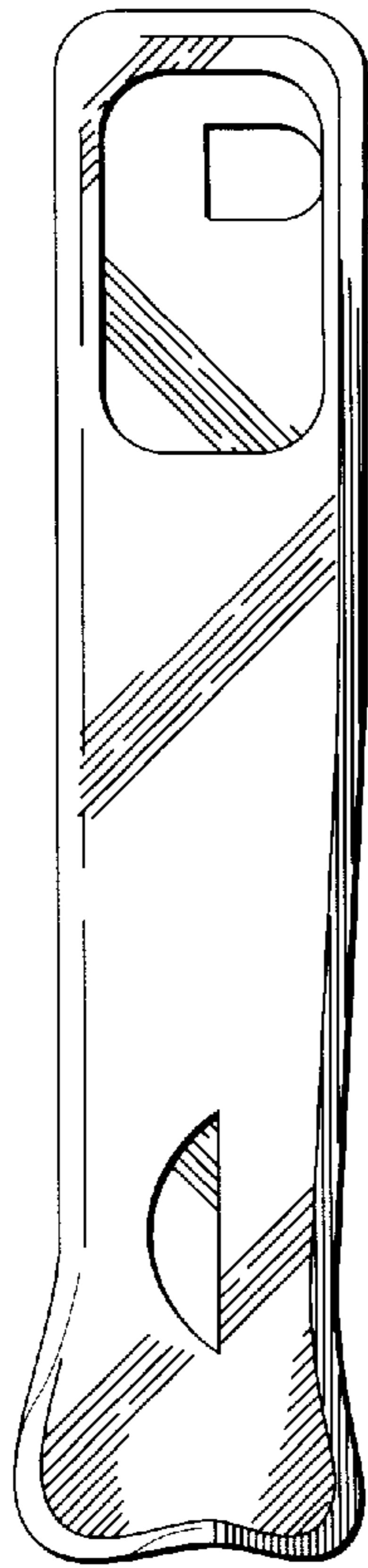

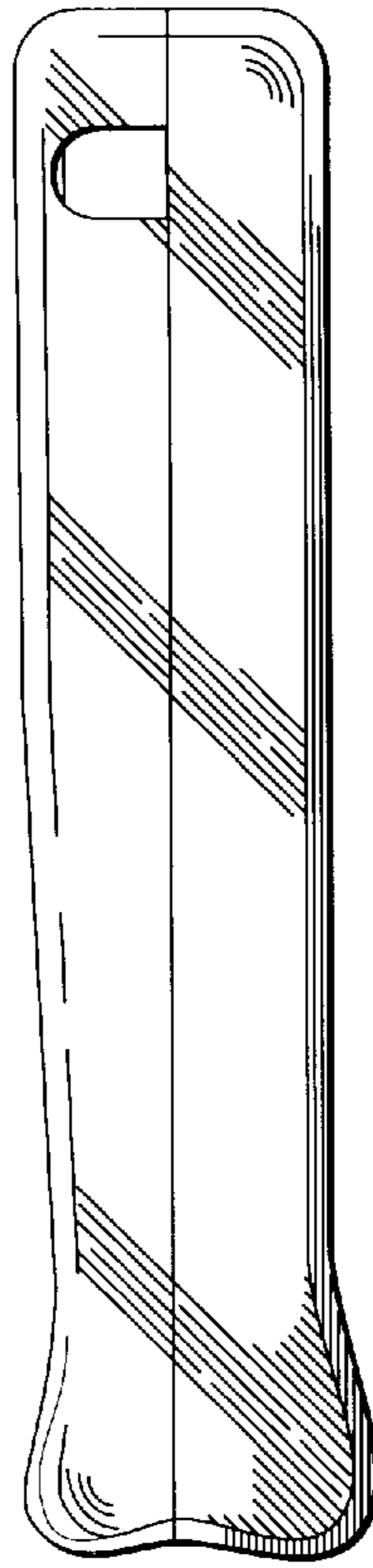

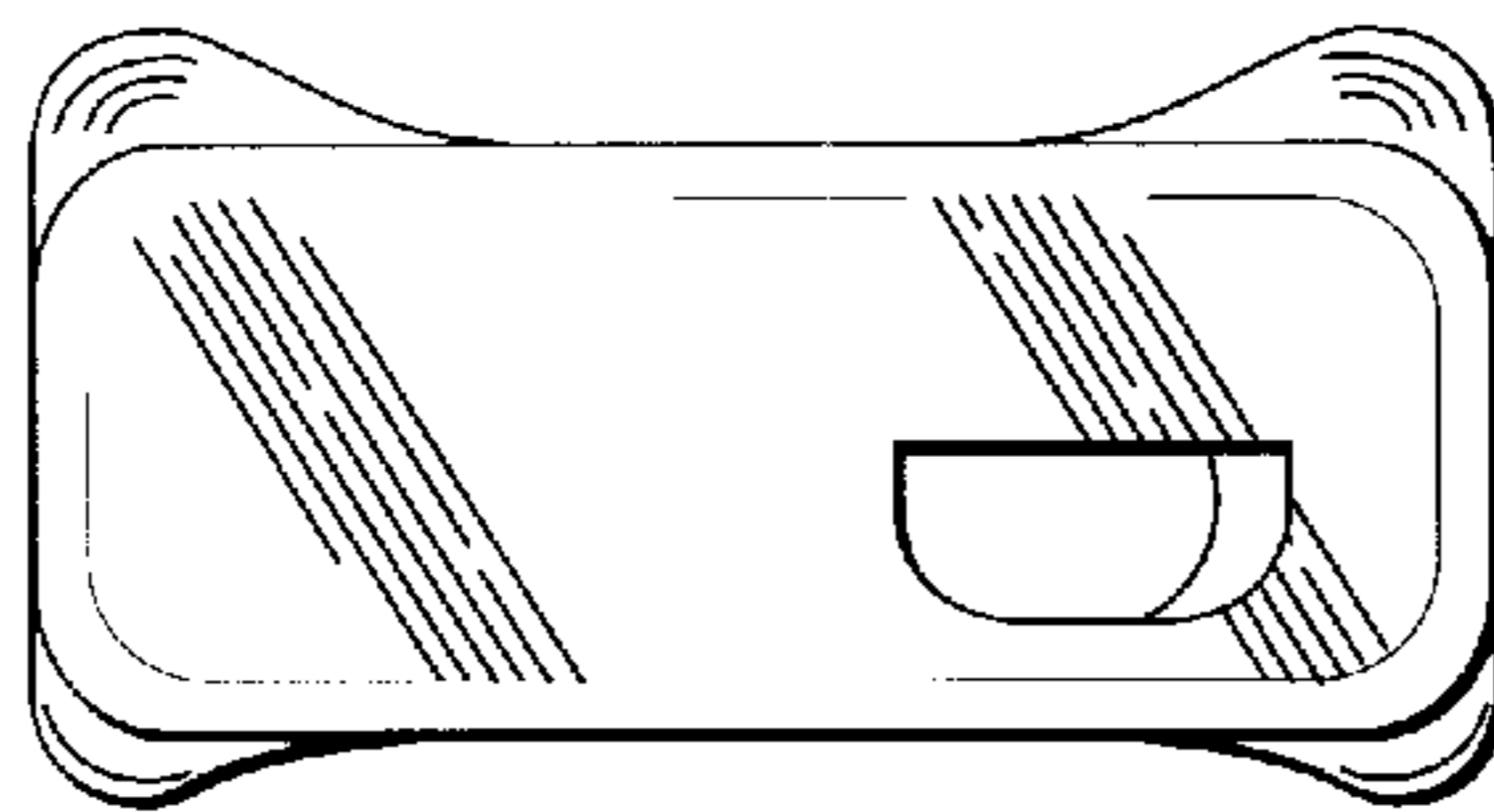

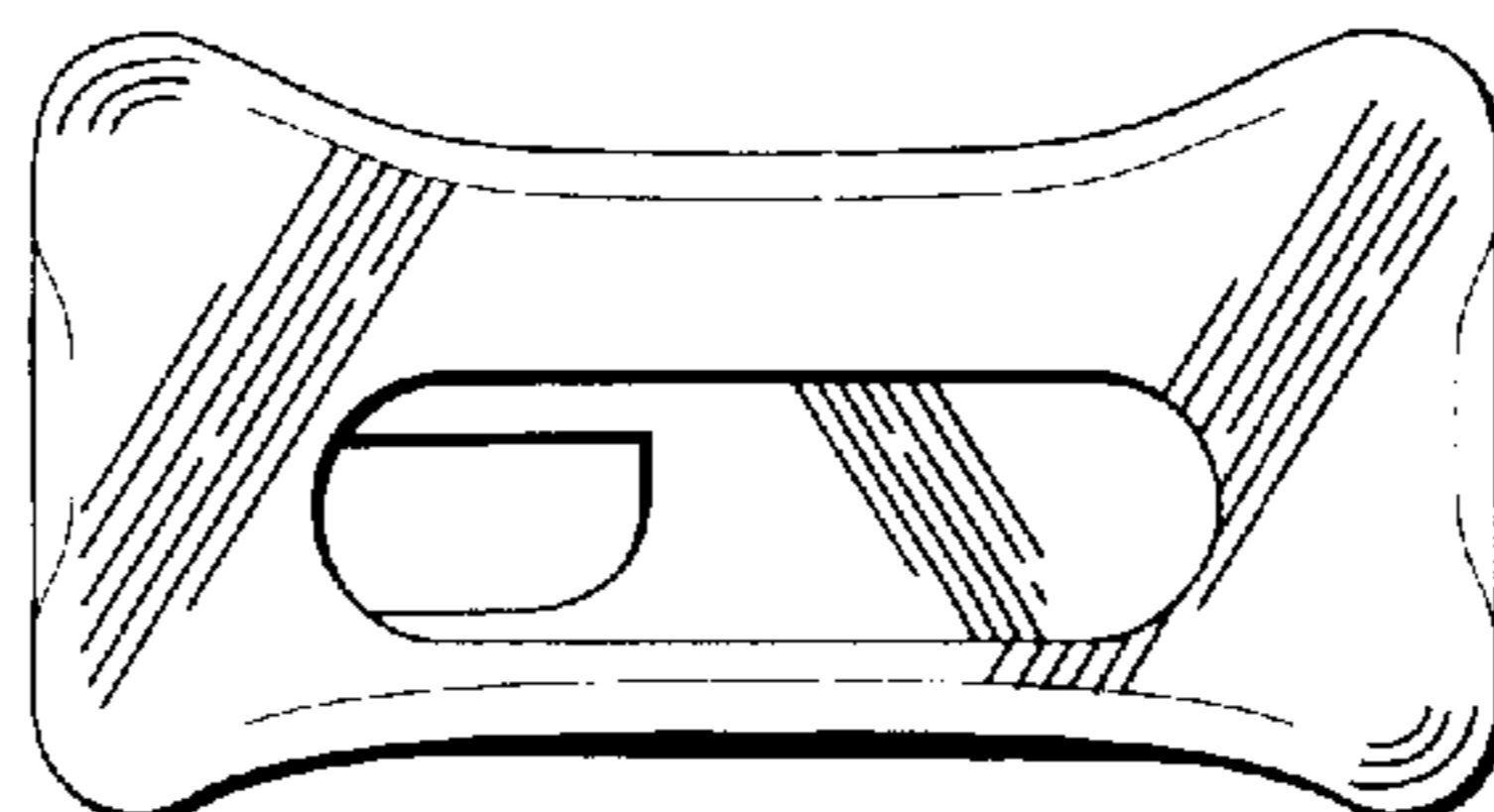

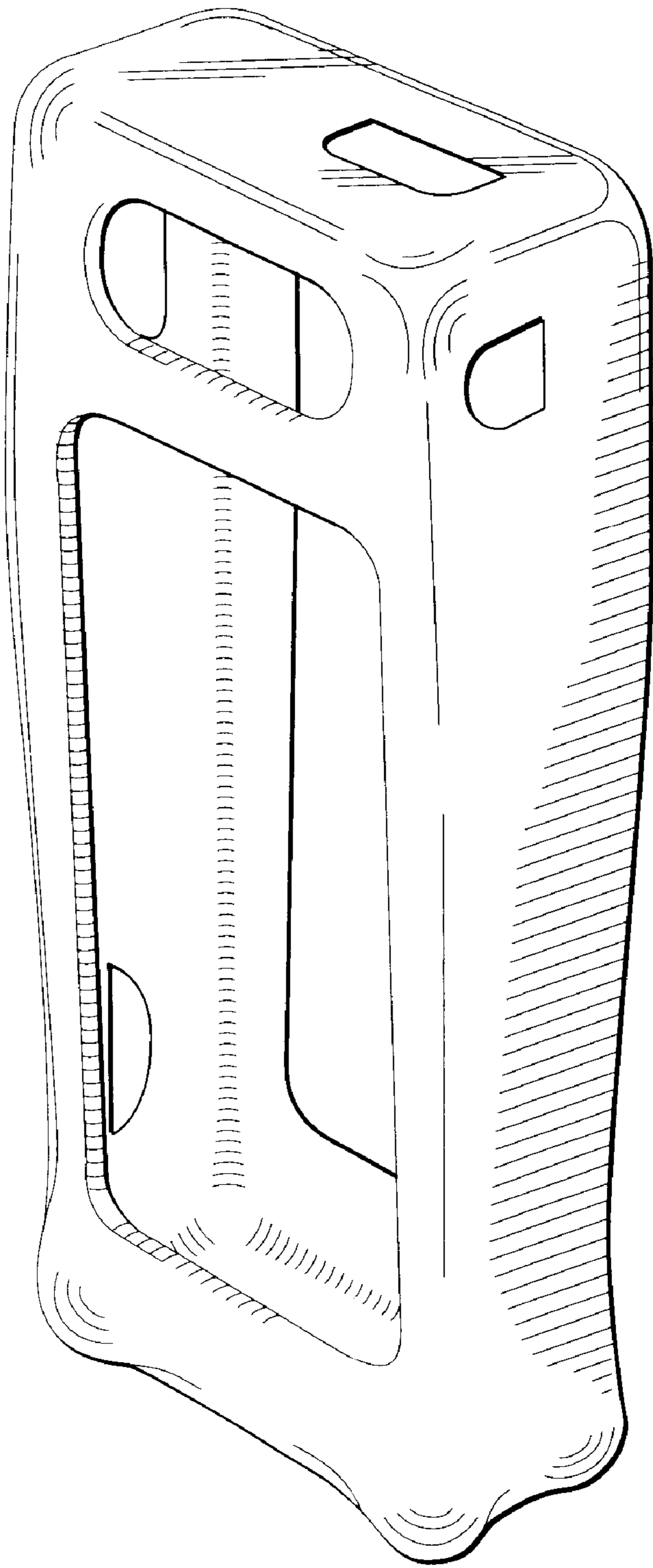
