(57) **CLAIM**

The ornamental design for a self opening calculator clock, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a self opening calculator clock in an open position showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof, the undisclosed right side elevational view being a mirror image thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a perspective view of the self opening calculator clock in a closed position thereof; FIG. 8 is a front elevational view of FIG. 7 thereof; FIG. 9 is a right side elevational view thereof, the undisclosed left side elevational view being a mirror image thereof; FIG. 10 is a rear elevational view thereof; FIG. 11 is a top plan view thereof; and, FIG. 12 is a bottom plan view thereof.

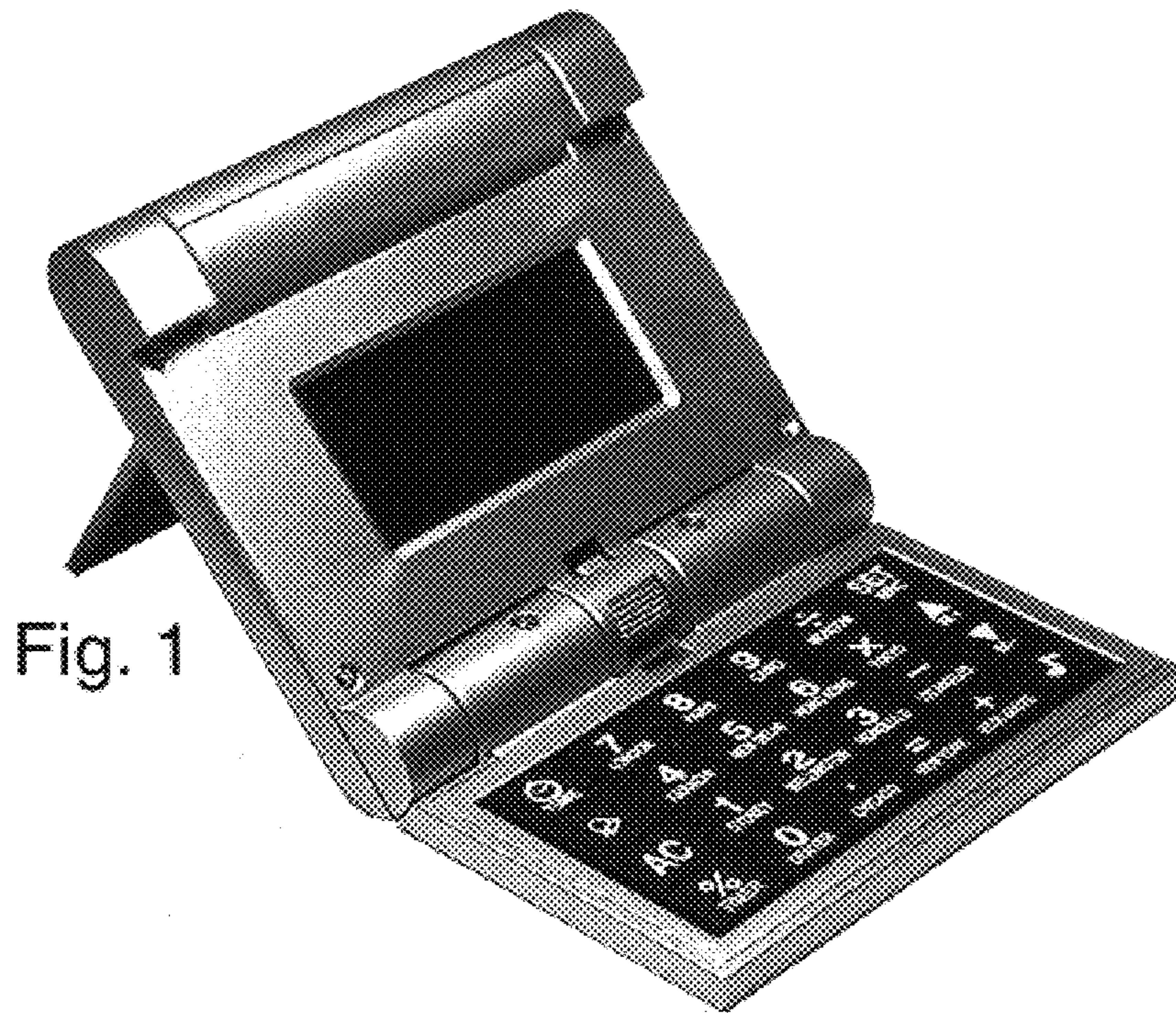

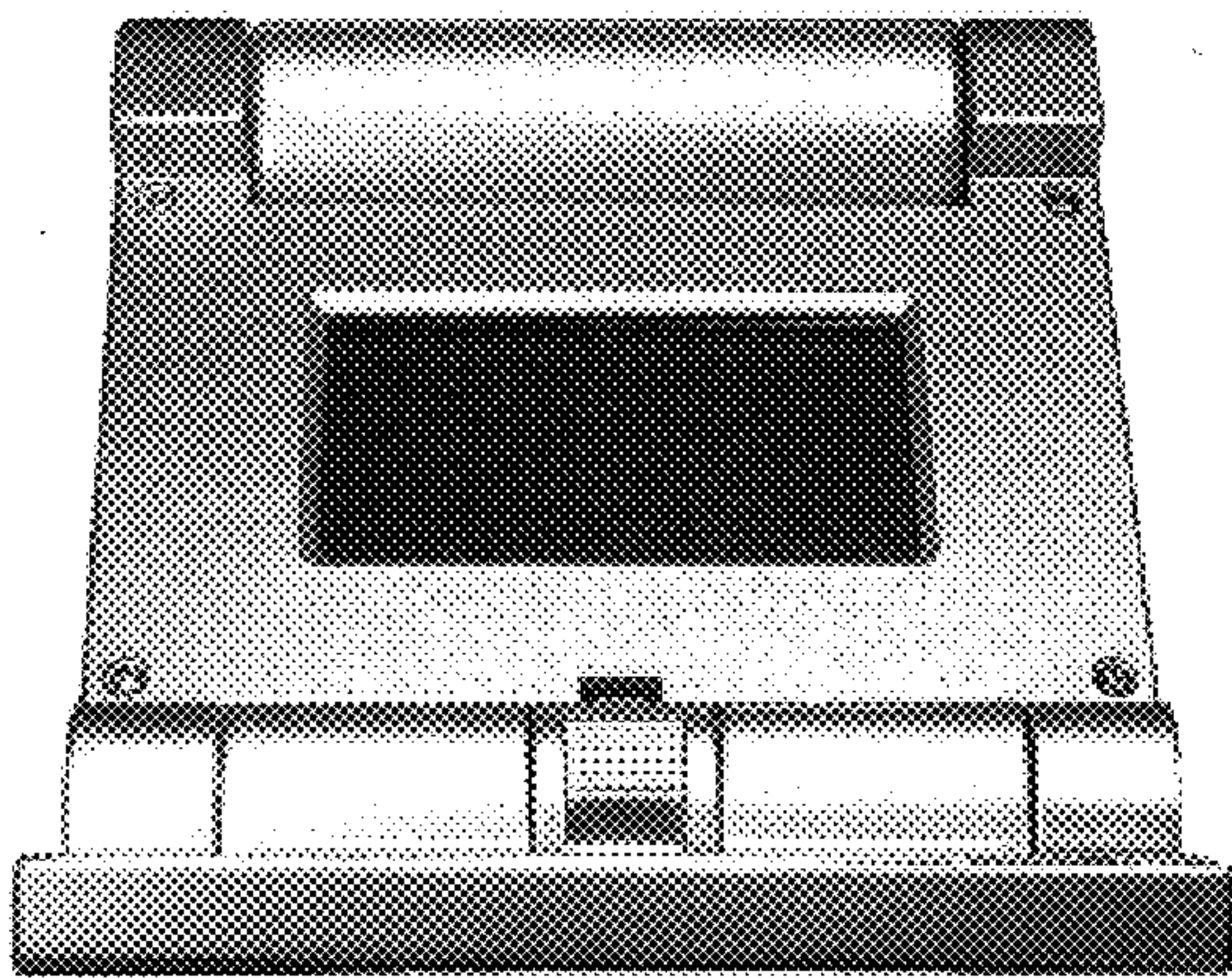

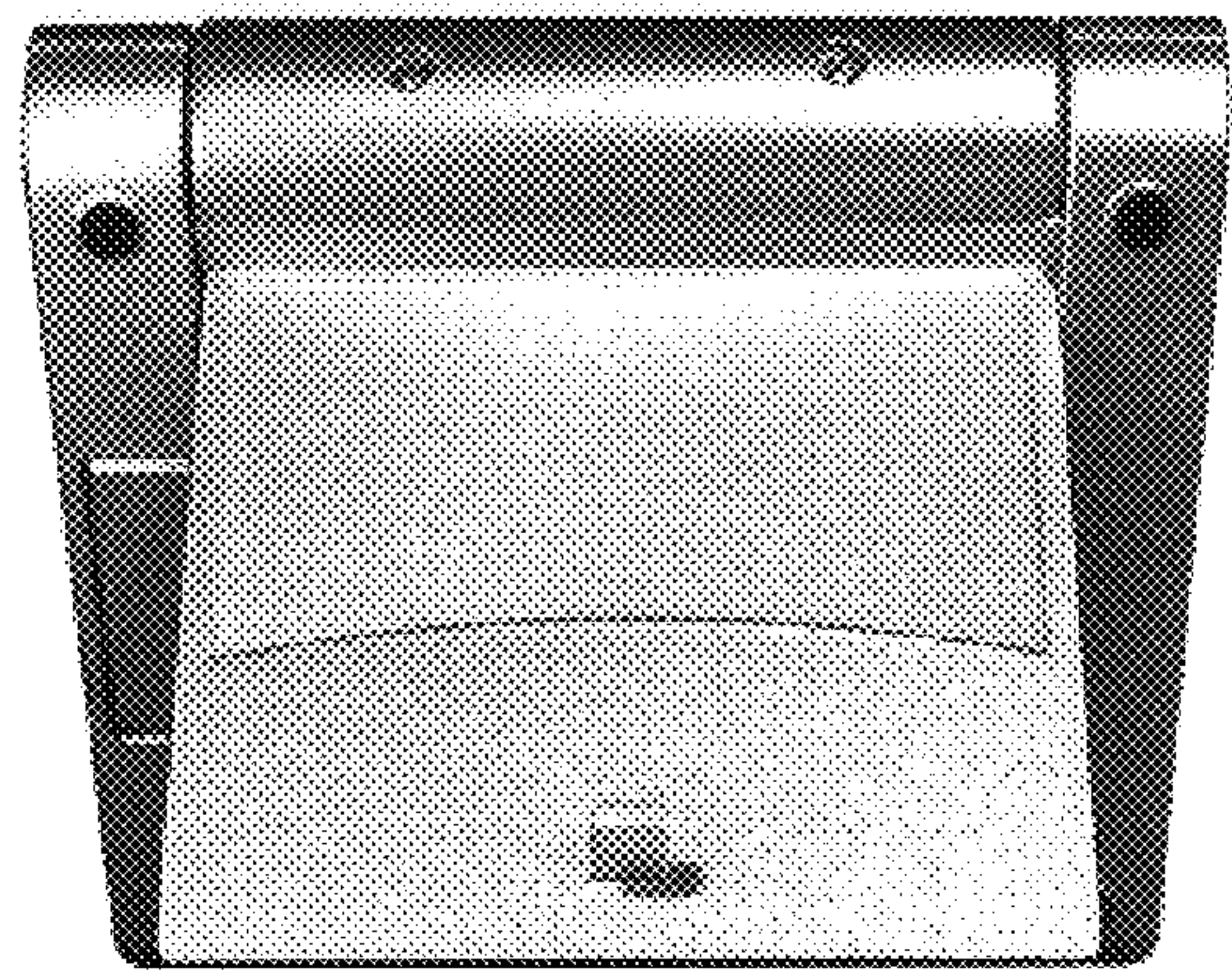

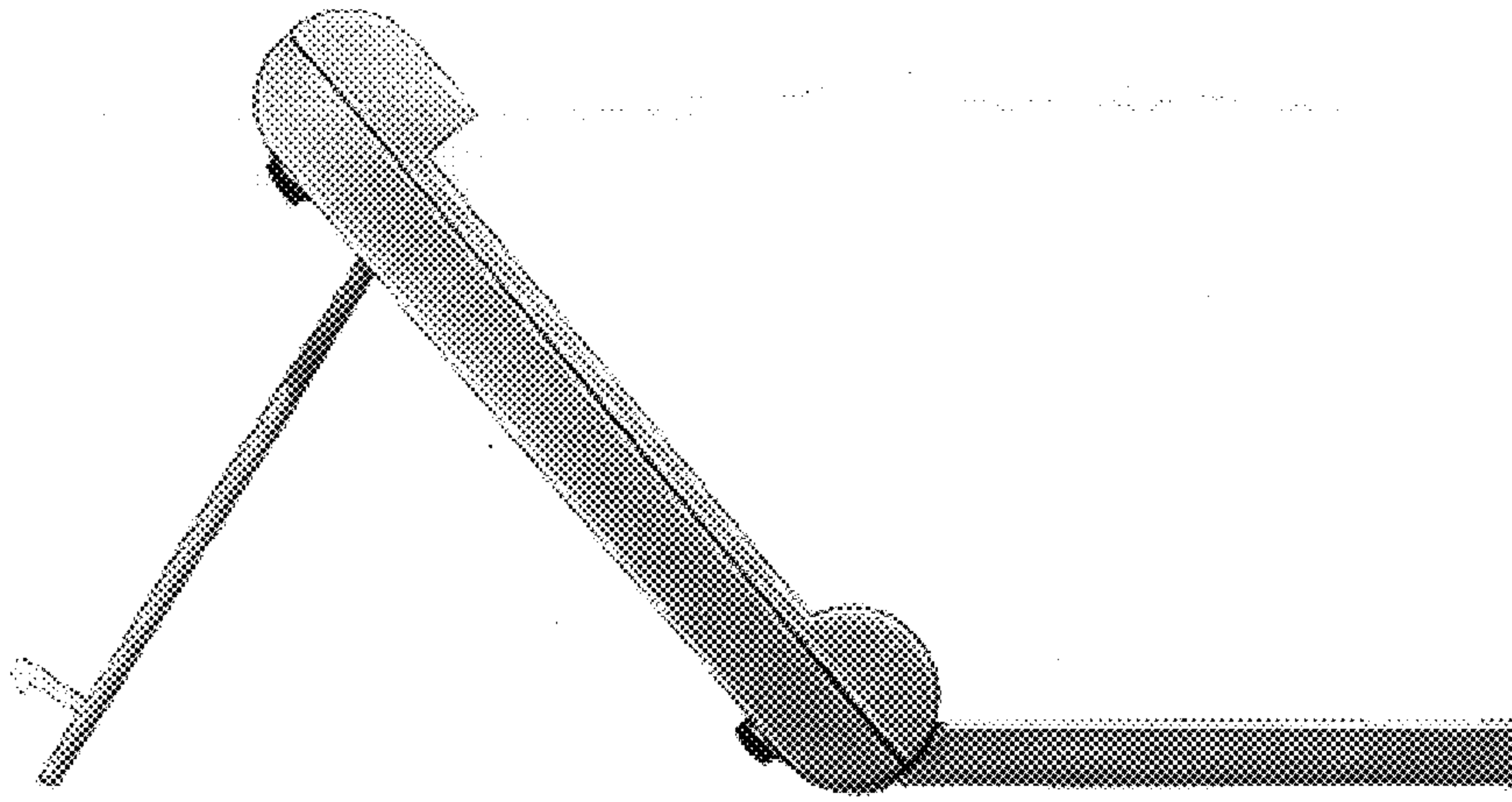

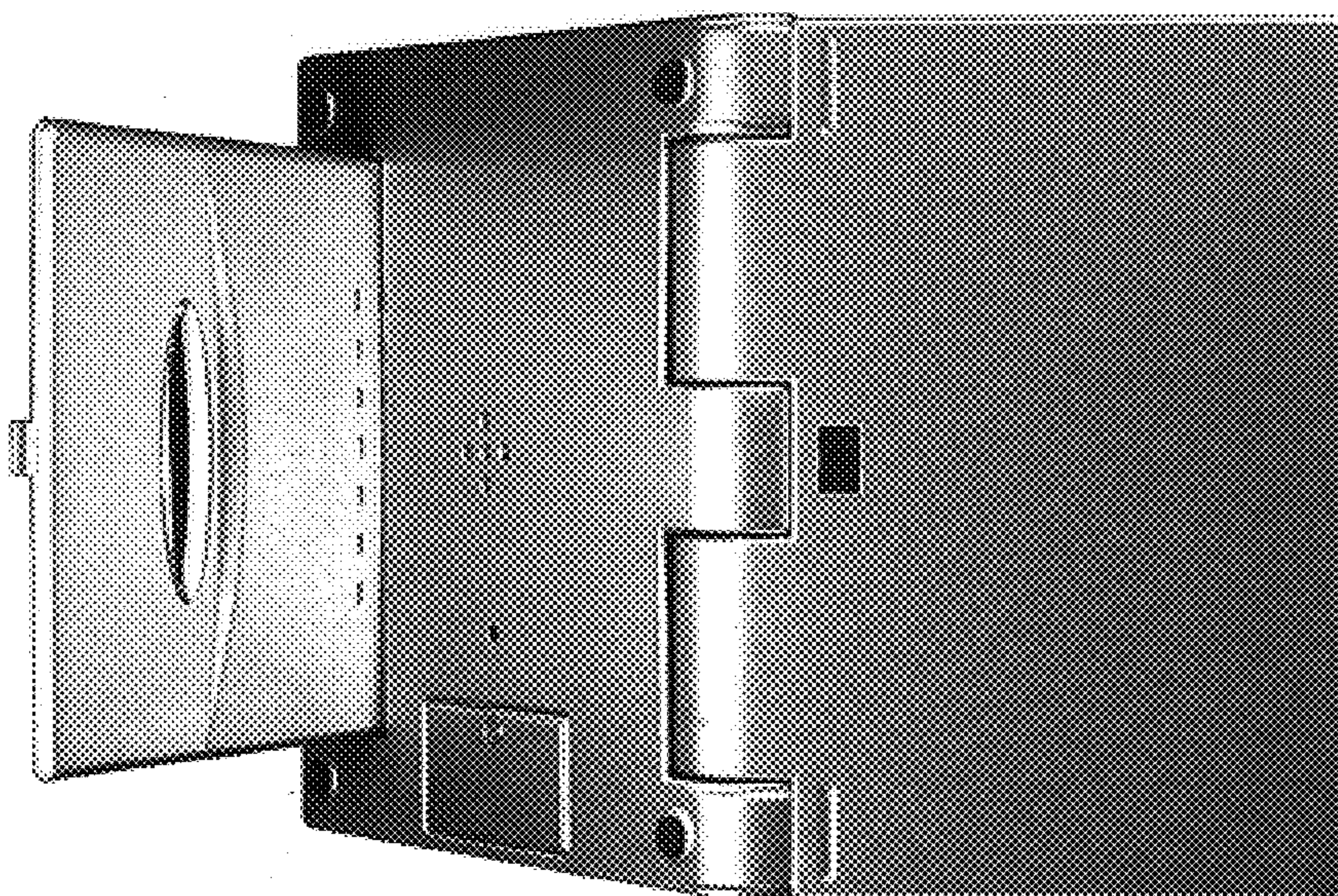

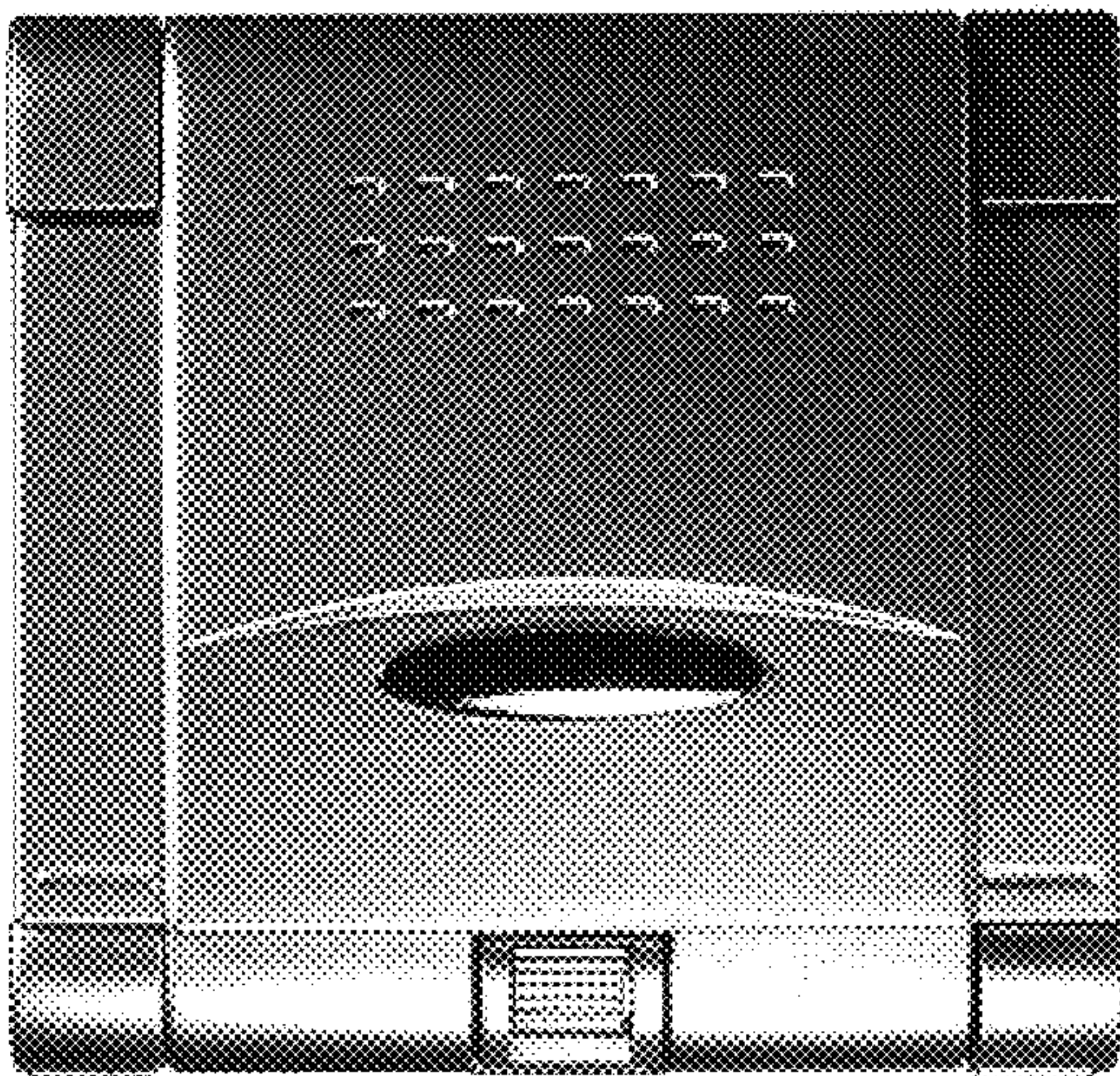

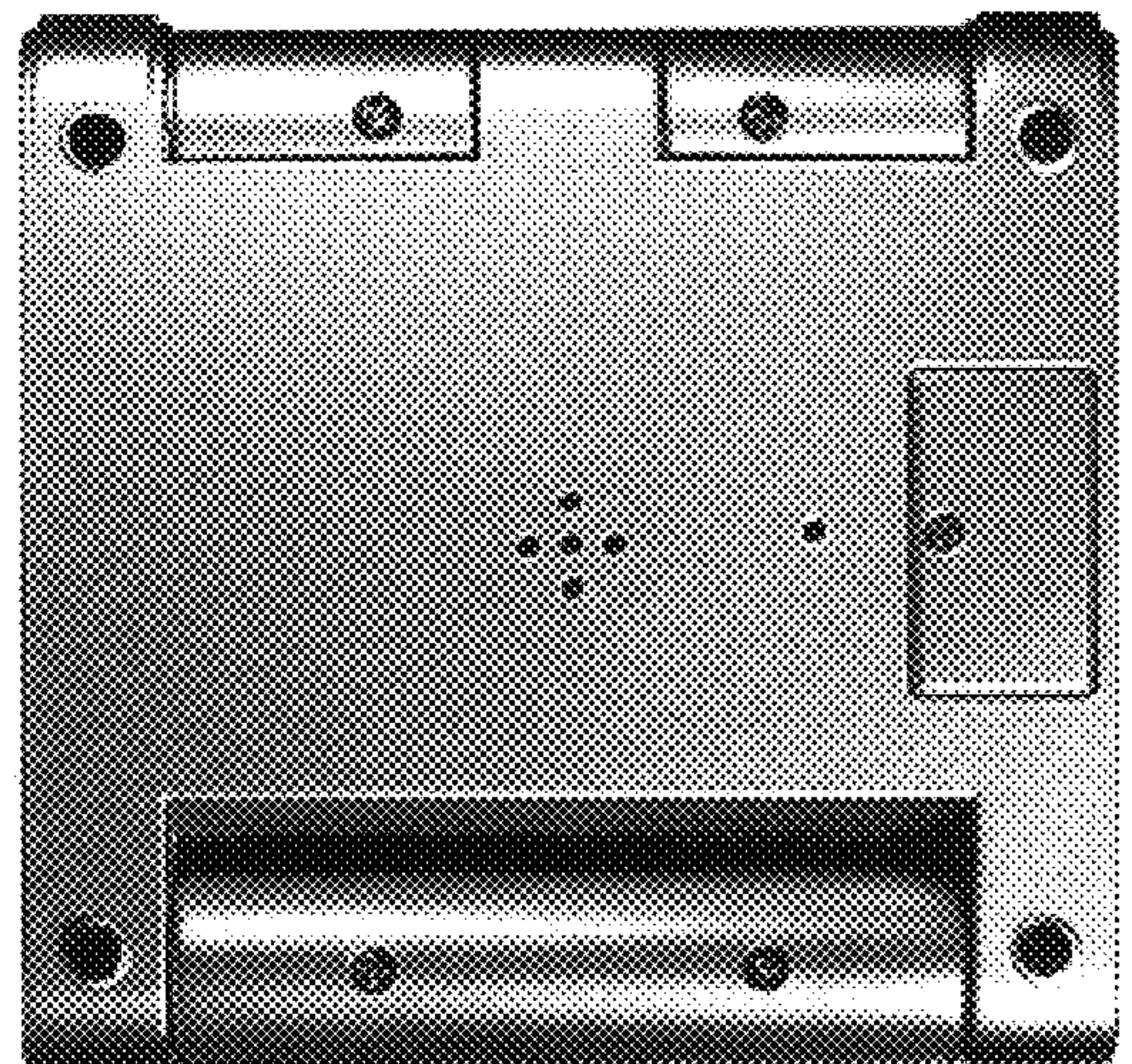

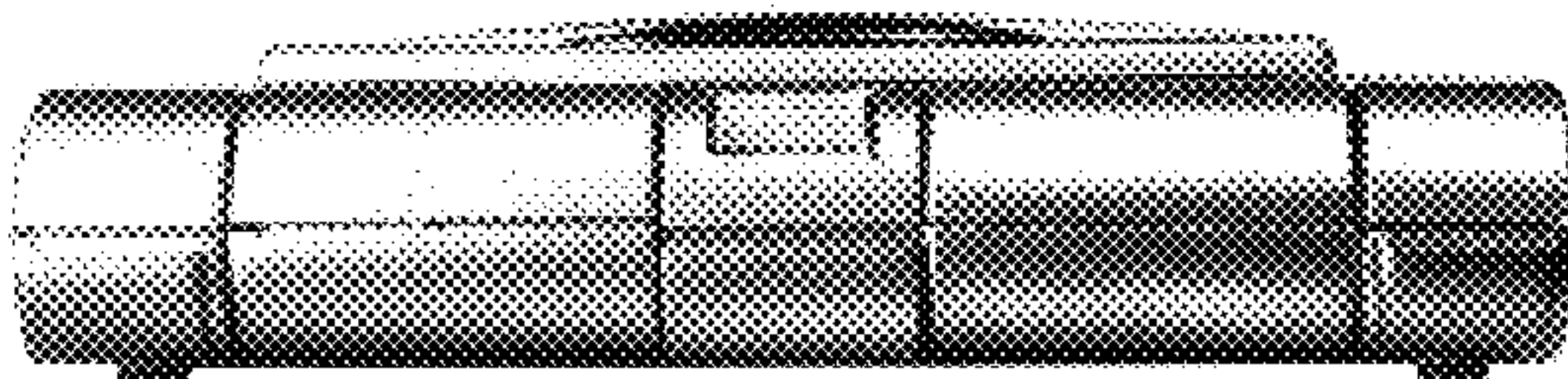

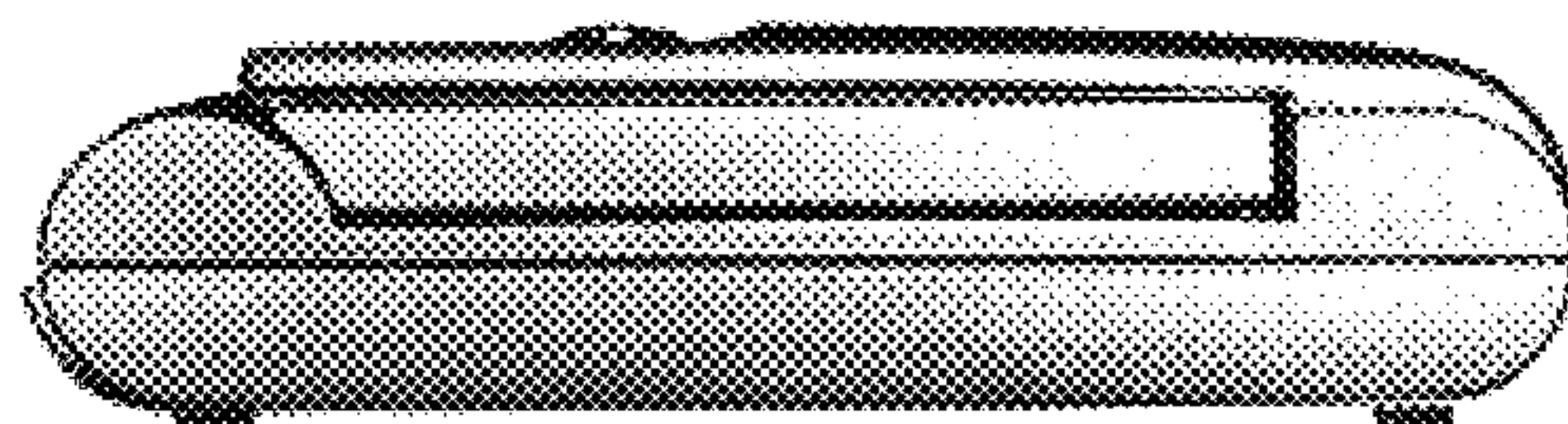
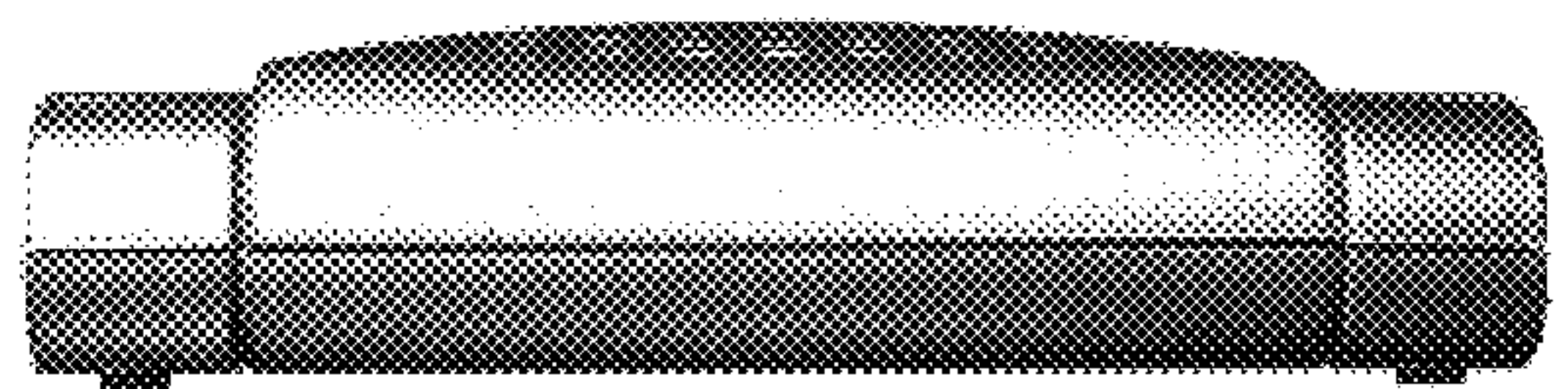
