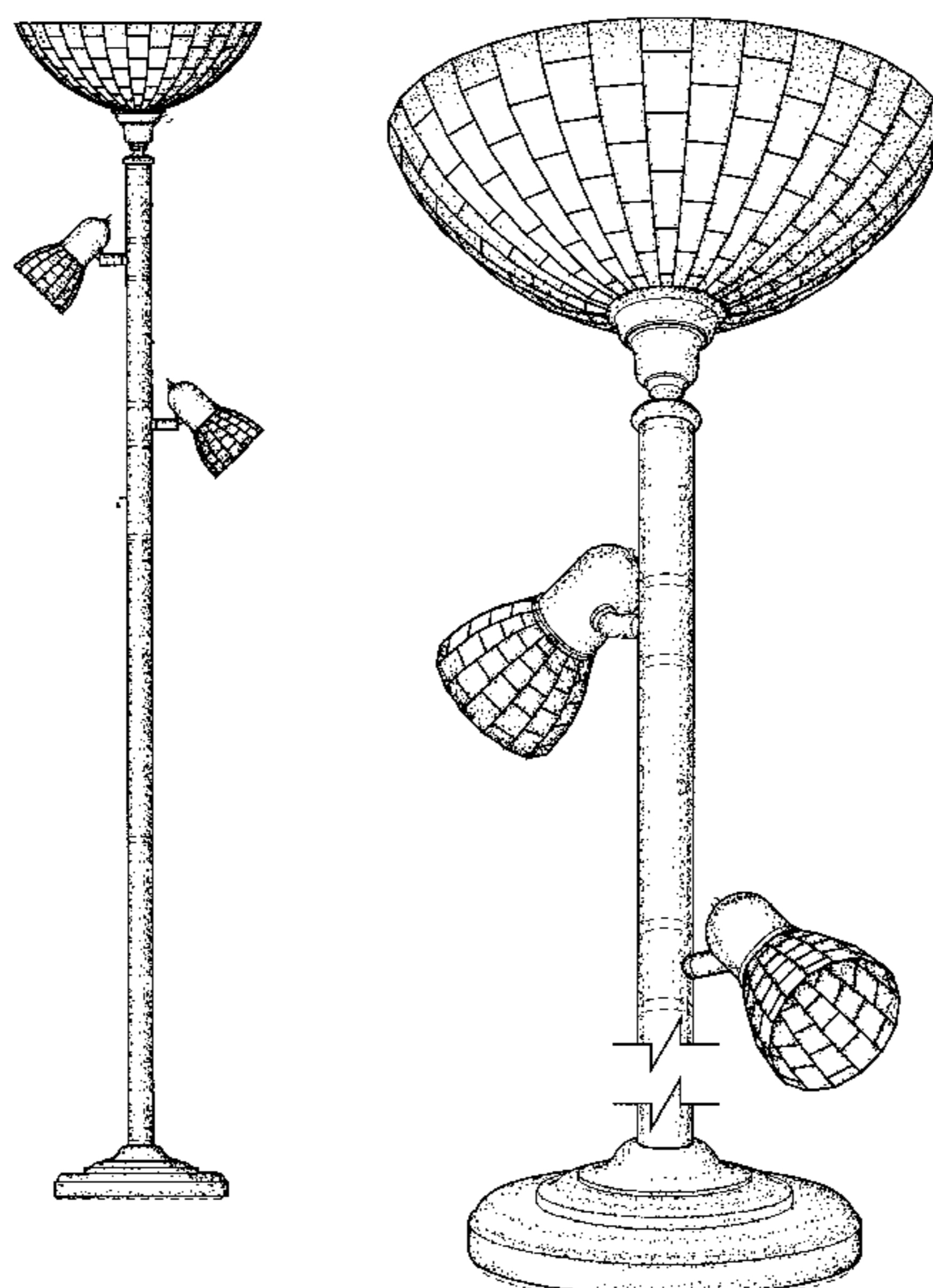
(57) **CLAIM**

The ornamental design for a combined torchiere lamp and adjustable accent lights, as shown and described.

DESCRIPTION

FIG. 1 is a full front elevational view thereof;
 FIG. 2 is an enlarged fragmentary perspective view, for clarity of illustration;
 FIG. 3 is a front elevational view of FIG. 2;
 FIG. 4 is a right side view of FIG. 2;
 FIG. 5 is a left side view of FIG. 2;
 FIG. 6 is a top plan view of FIG. 2; and,
 FIG. 7 is a bottom plan view of FIG. 2.

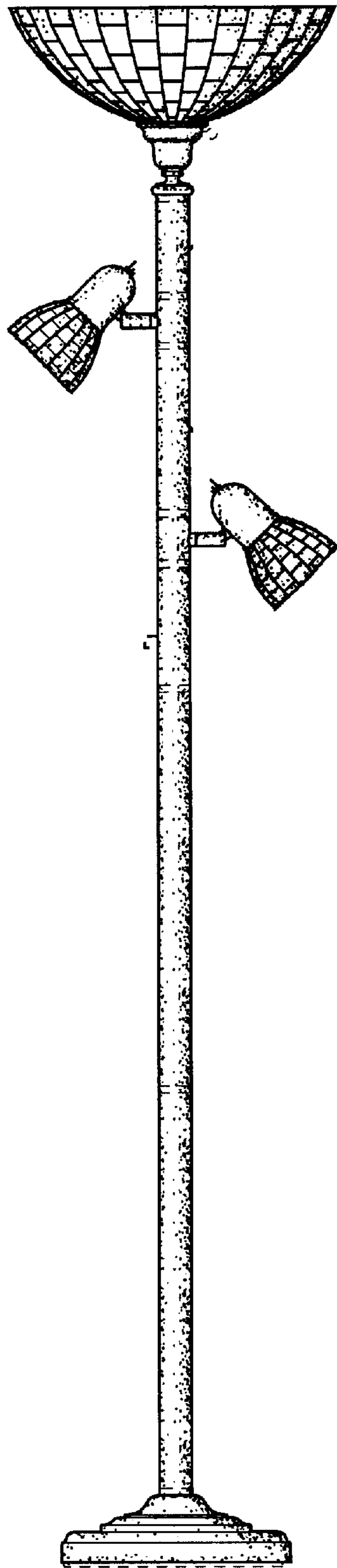

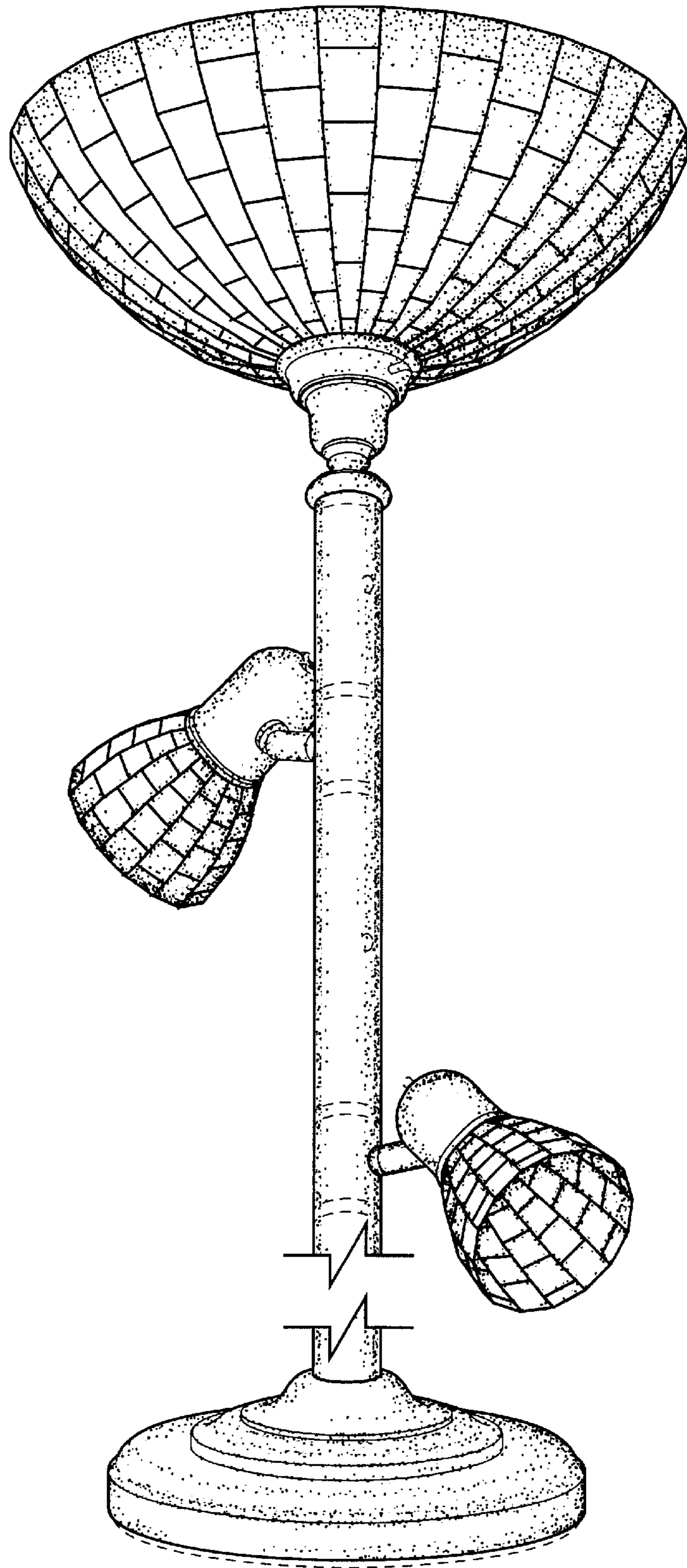

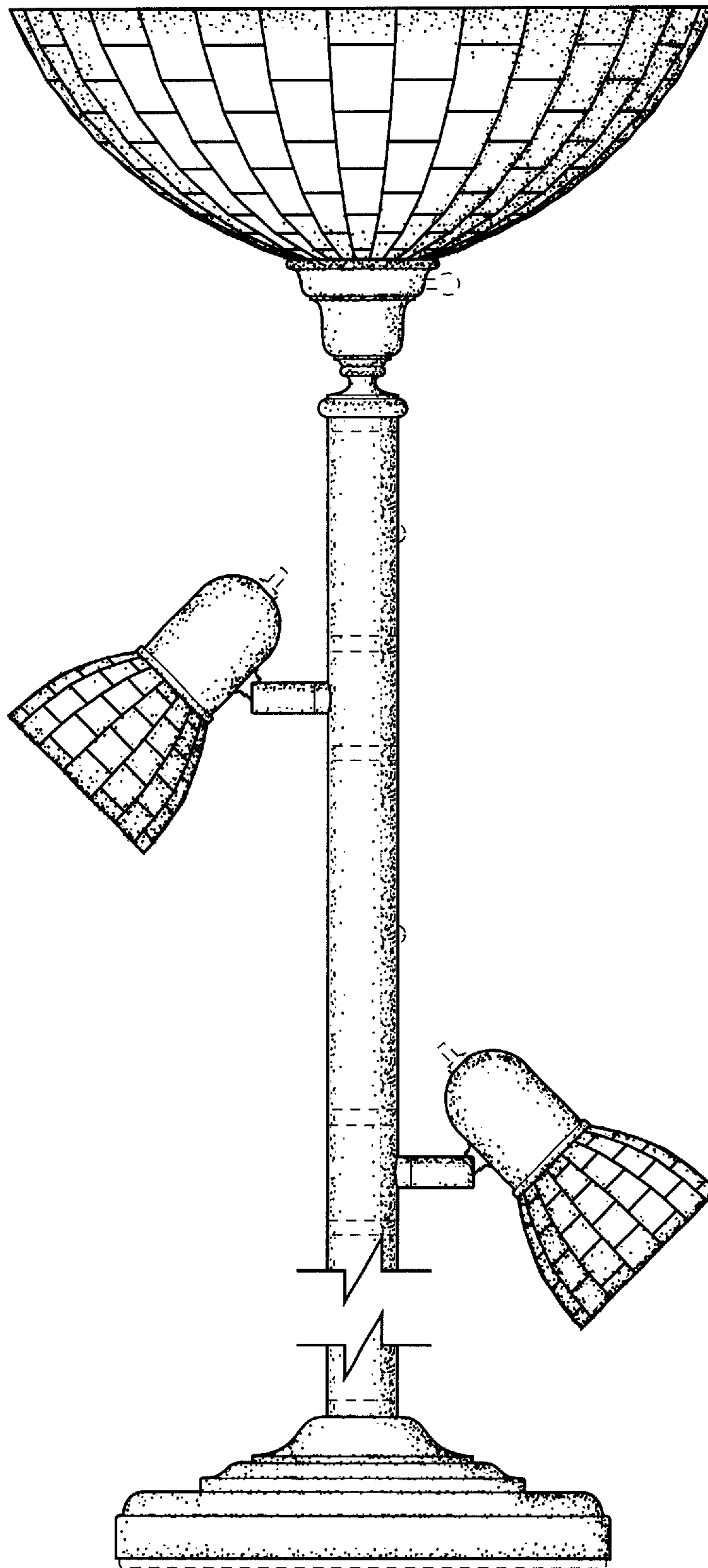

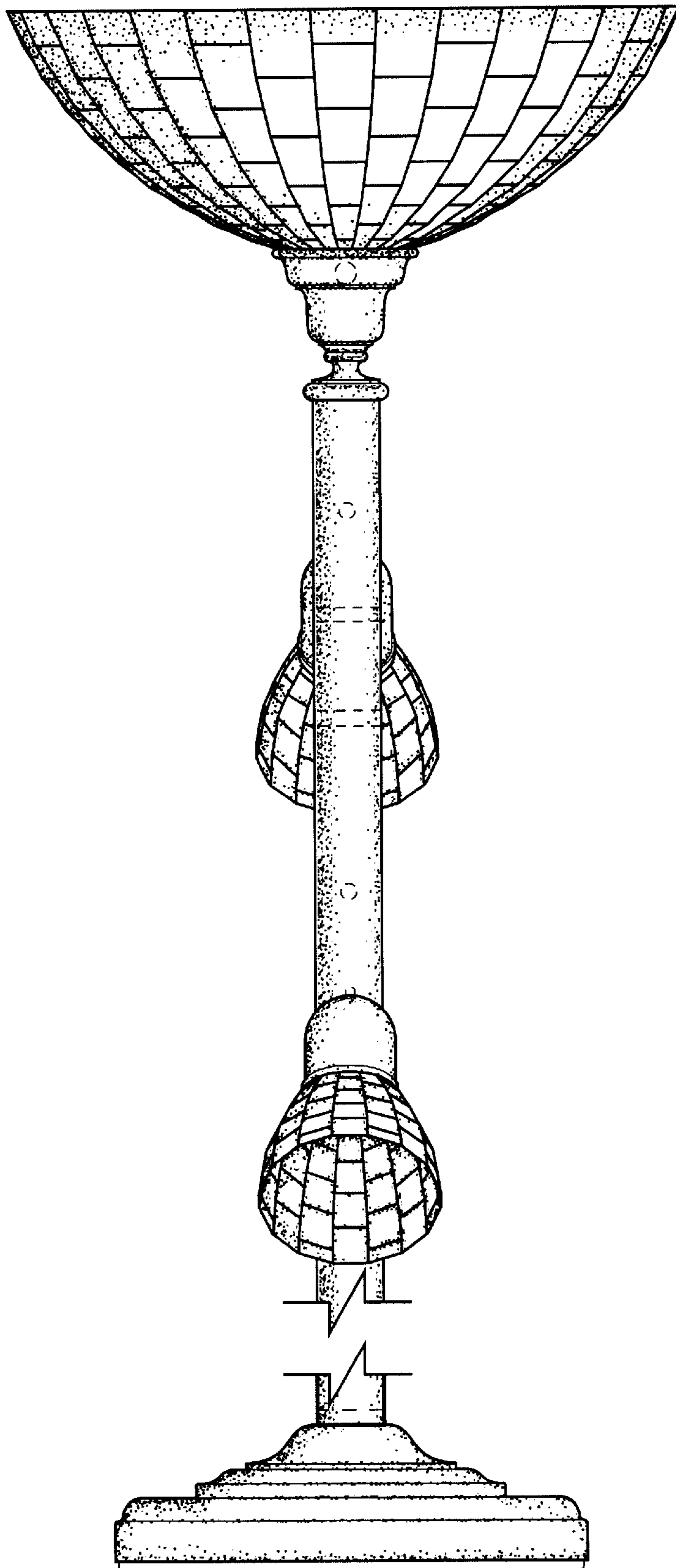

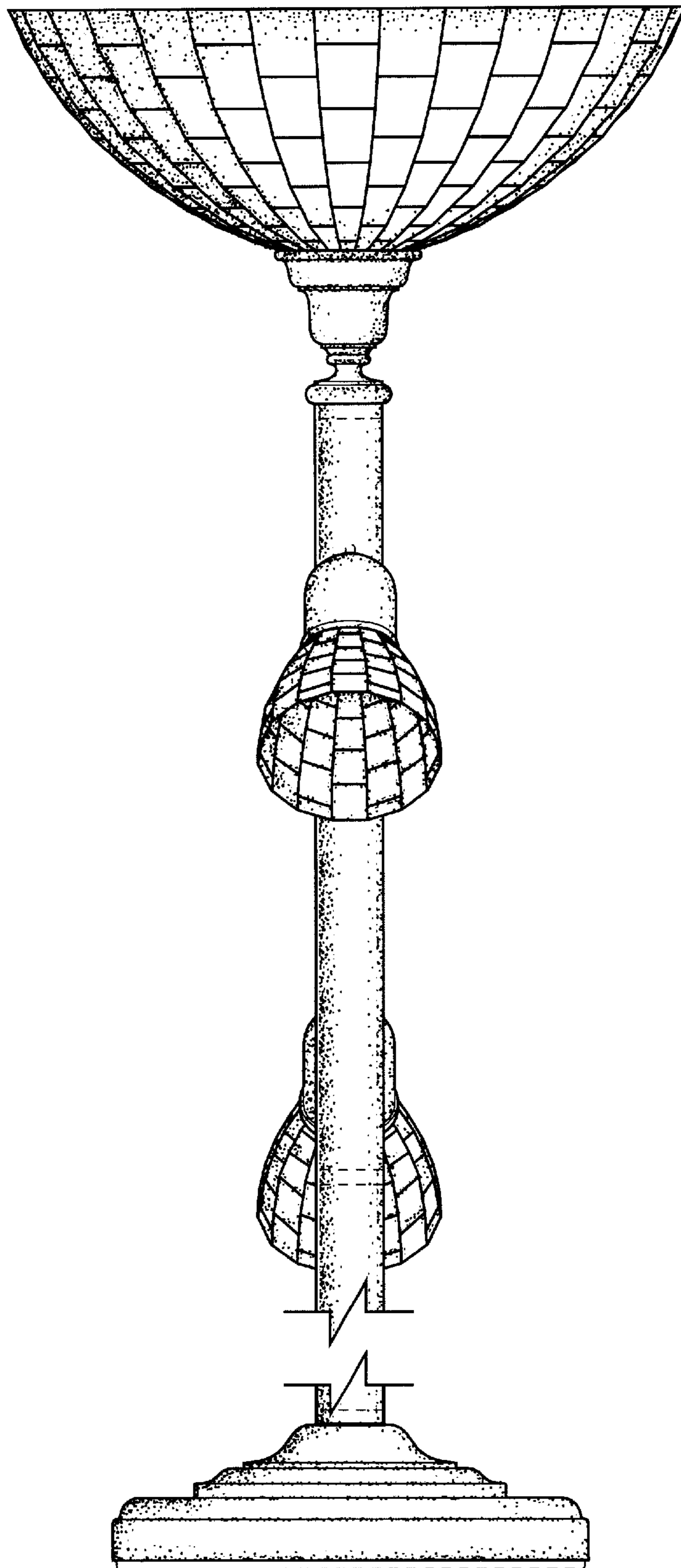

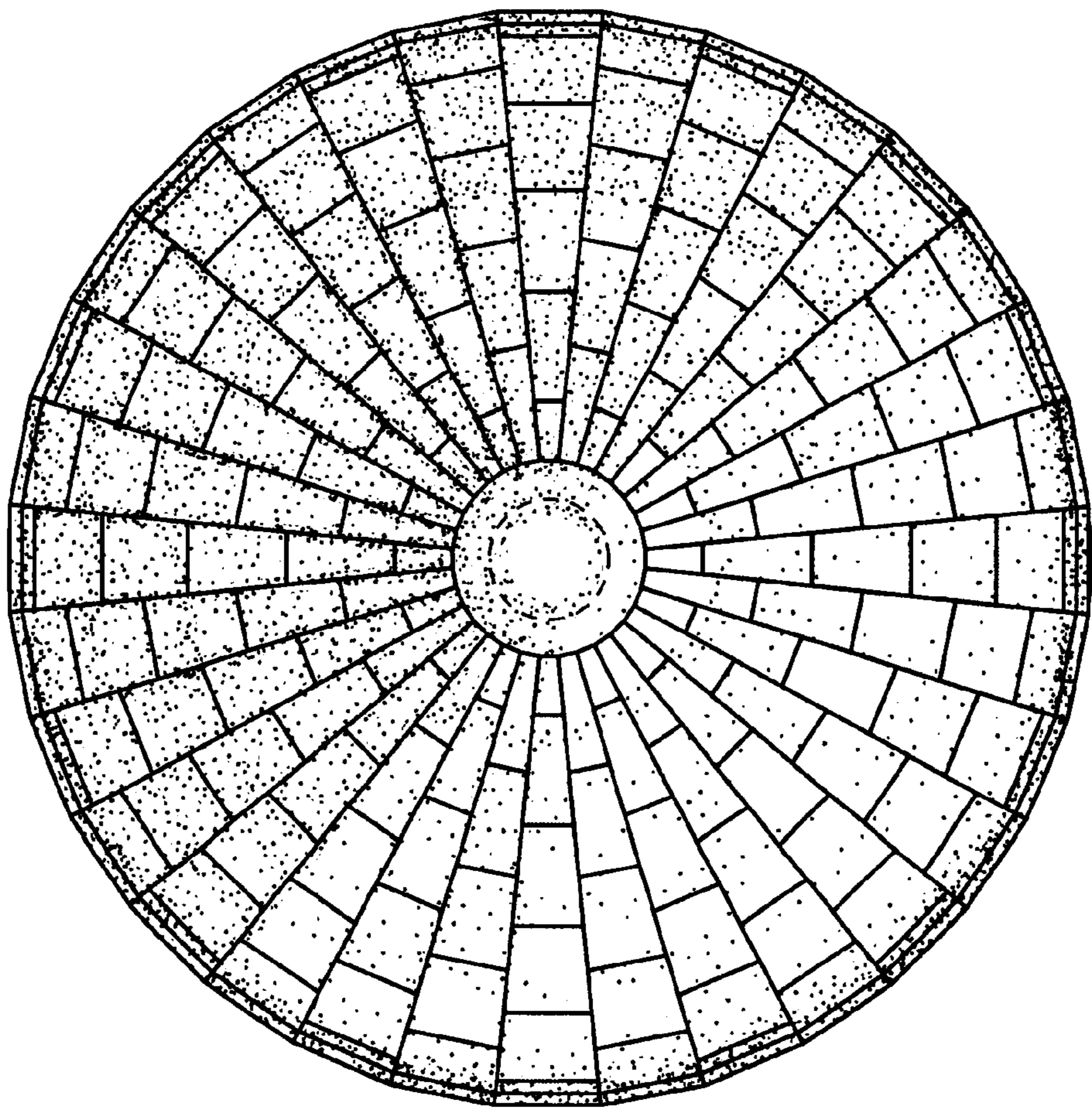

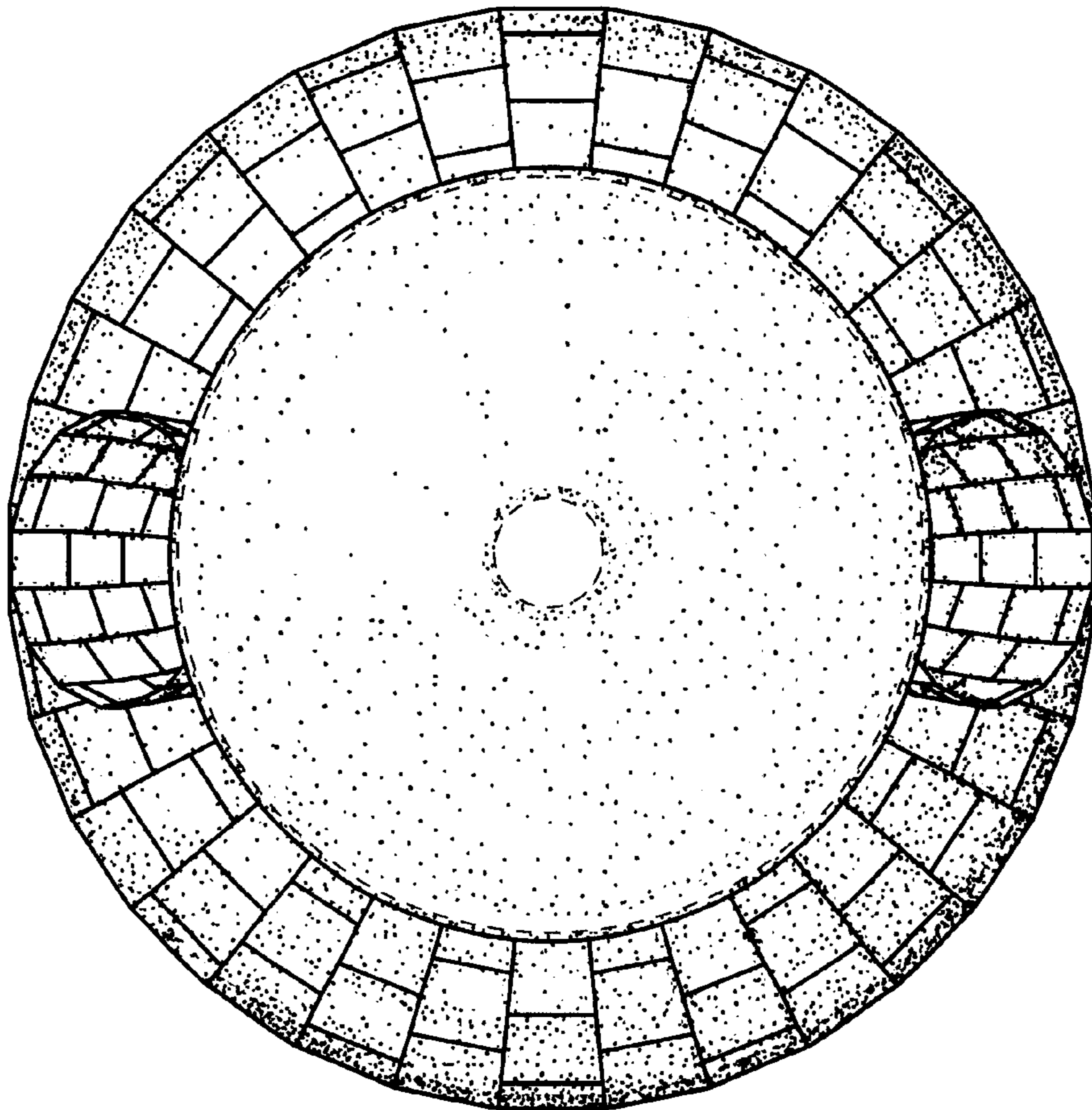
