(57) **CLAIM**

The ornamental design for a transfer sheet for nail decoration, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the transfer sheet for nail decoration;
FIG. 2 is a right side view of the transfer sheet for nail decoration;
FIG. 3 is a left side view of the transfer sheet for nail decoration;
FIG. 4 is an overhead plan view of the transfer sheet for nail decoration; and,
FIG. 5 is a rear view of the transfer sheet for nail decoration.

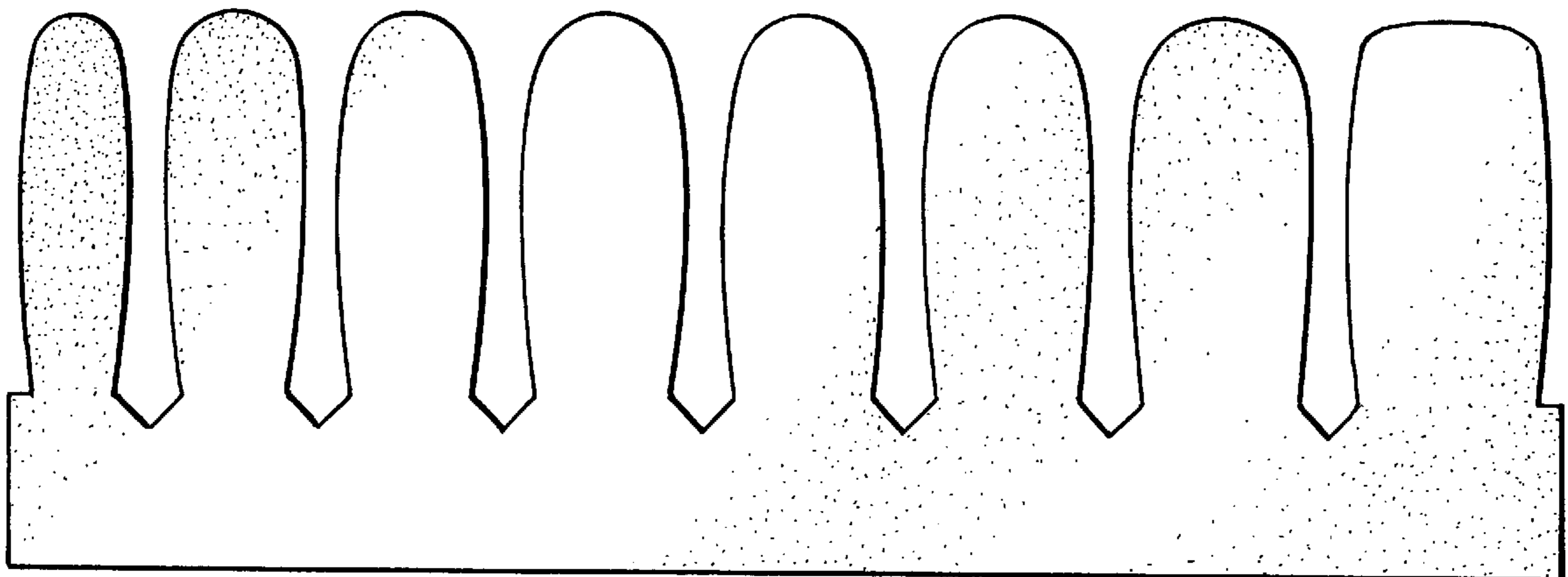

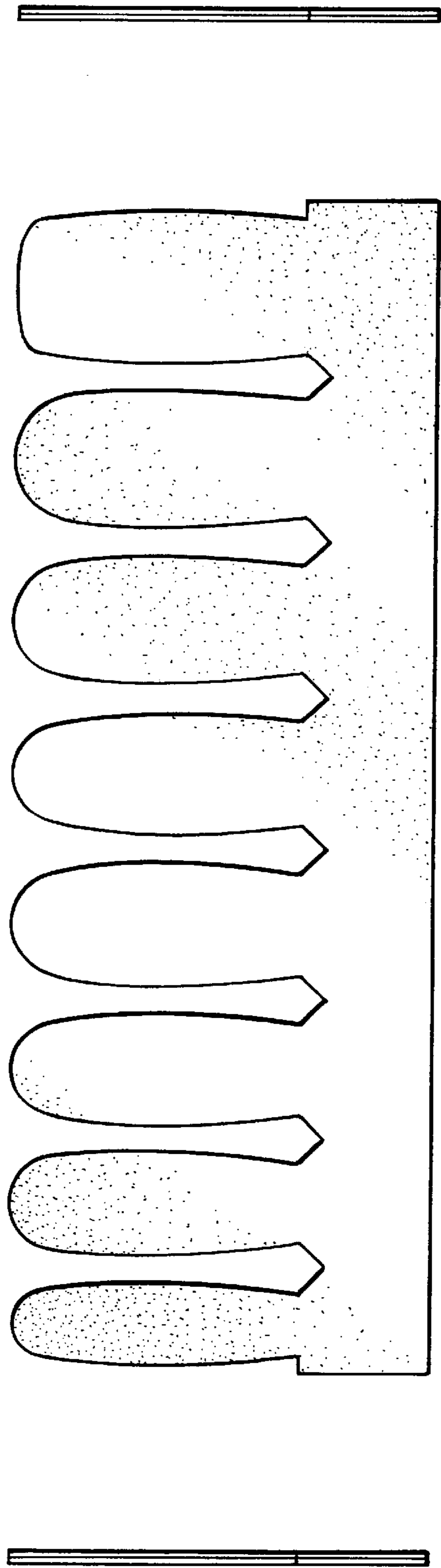
