I claim the ornamental design for an ornamental mounting stand, as shown and described.

DESCRIPTION

FIG. 1 is an oblique elevational view as seen from the left front edge of a mounting stand showing my new design.

FIG. 2 is a front elevational view thereof.

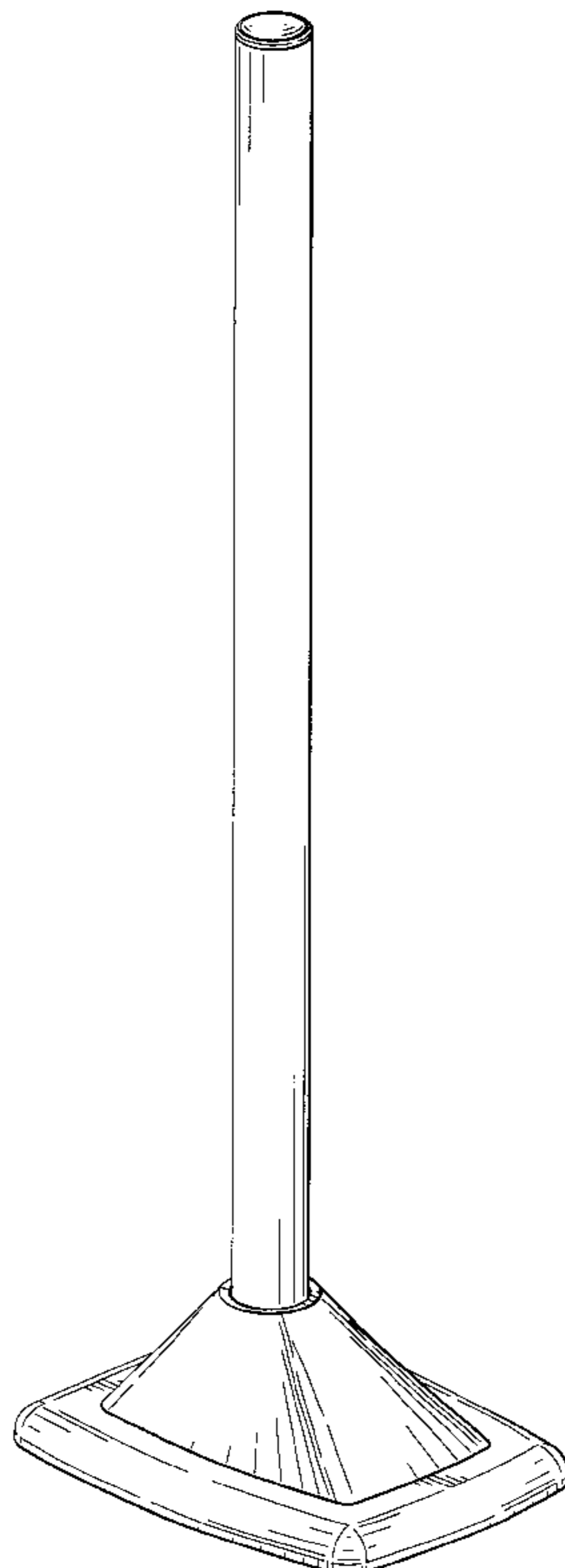
FIG. 3 is a left side elevational view thereof, the right side being a mirror image.

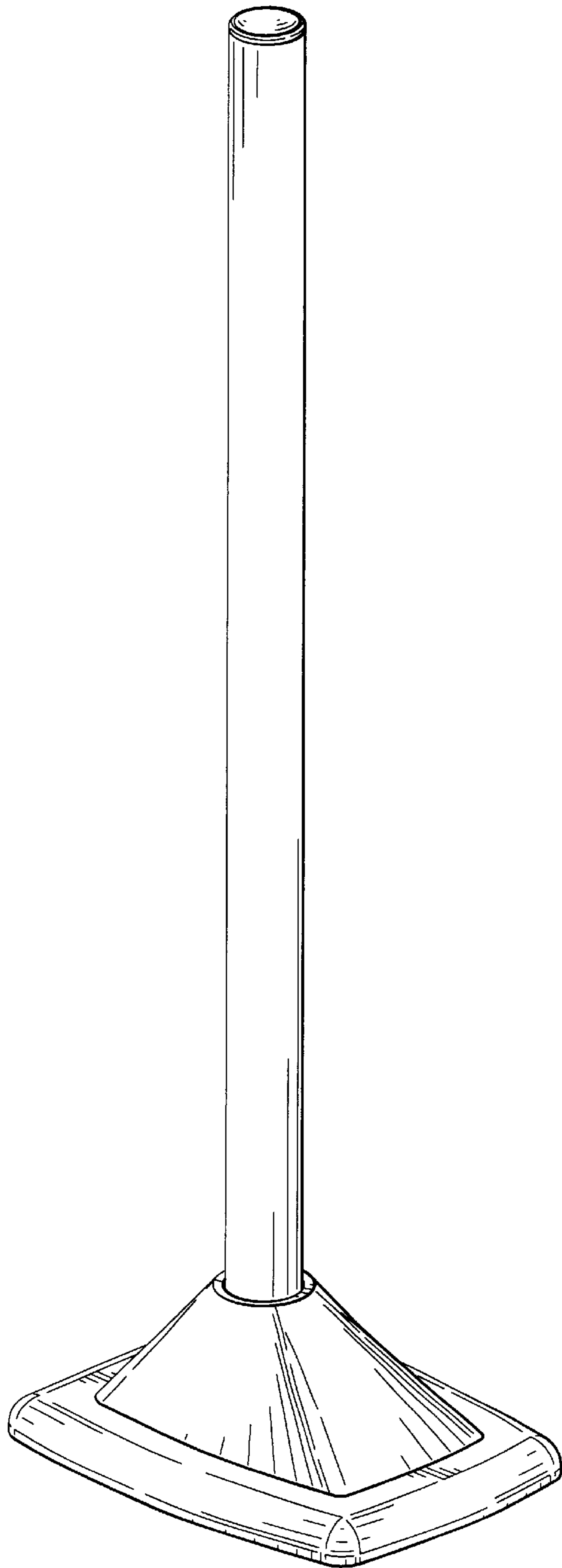

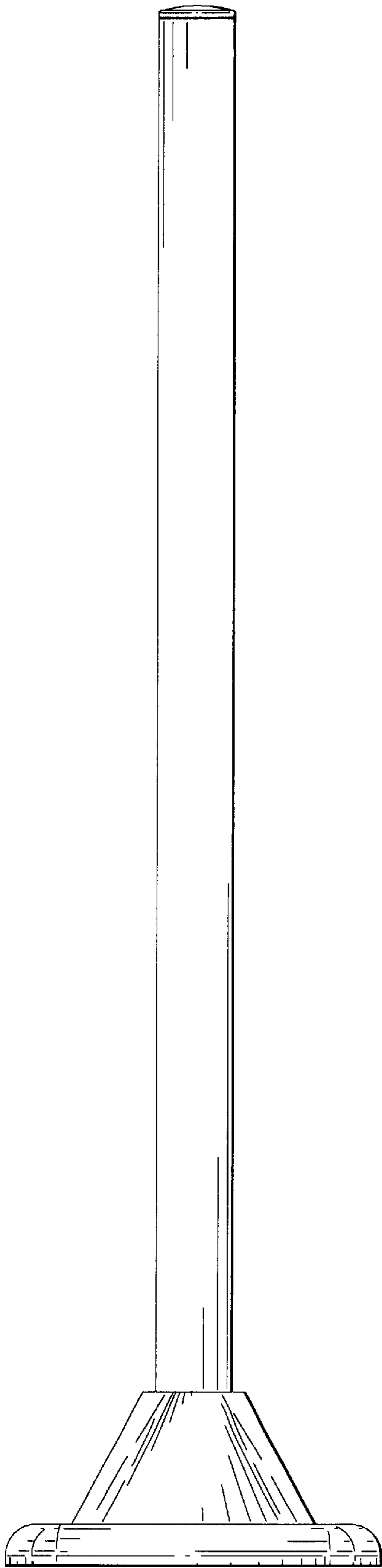

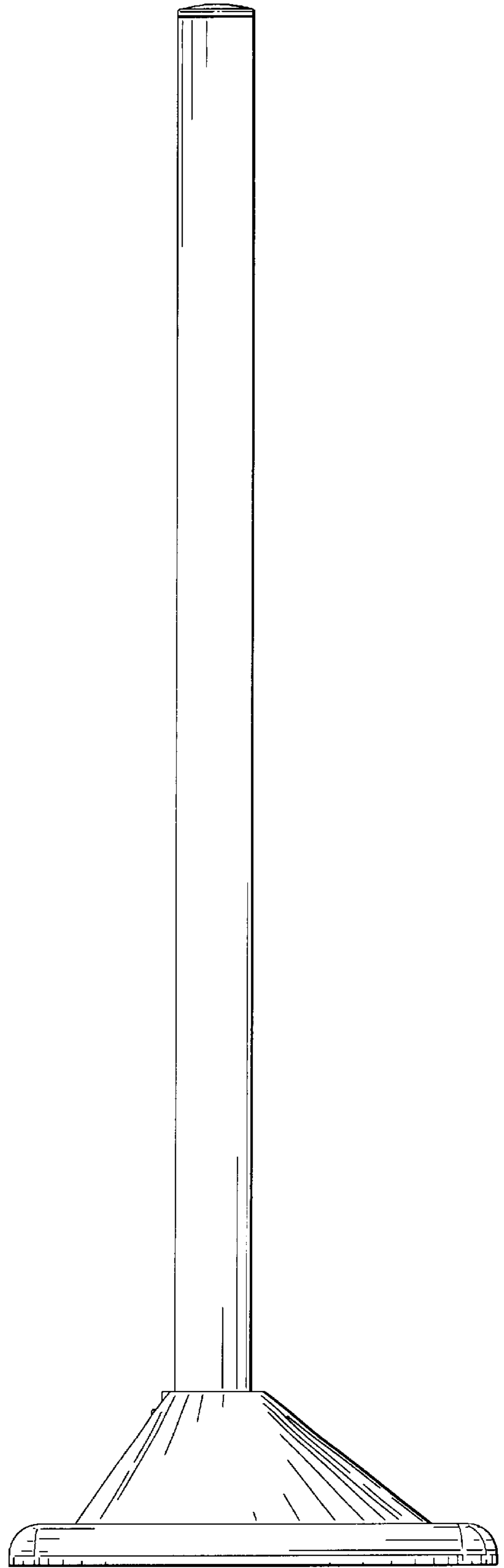

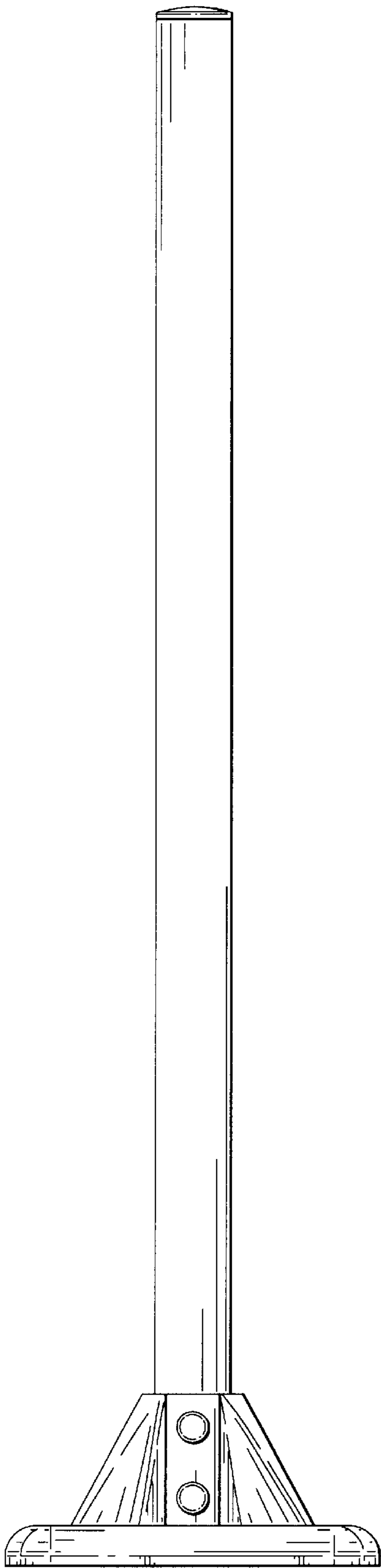

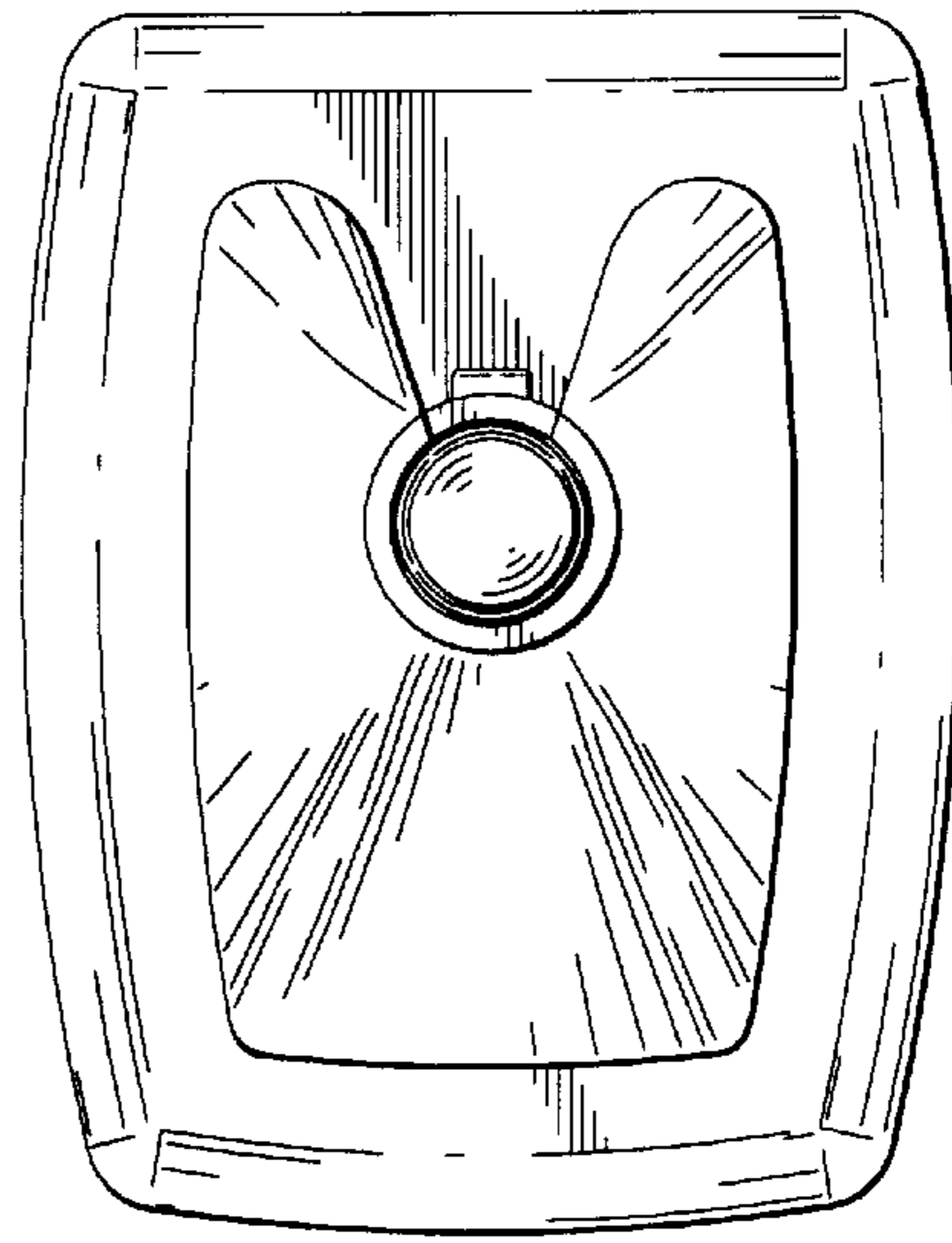

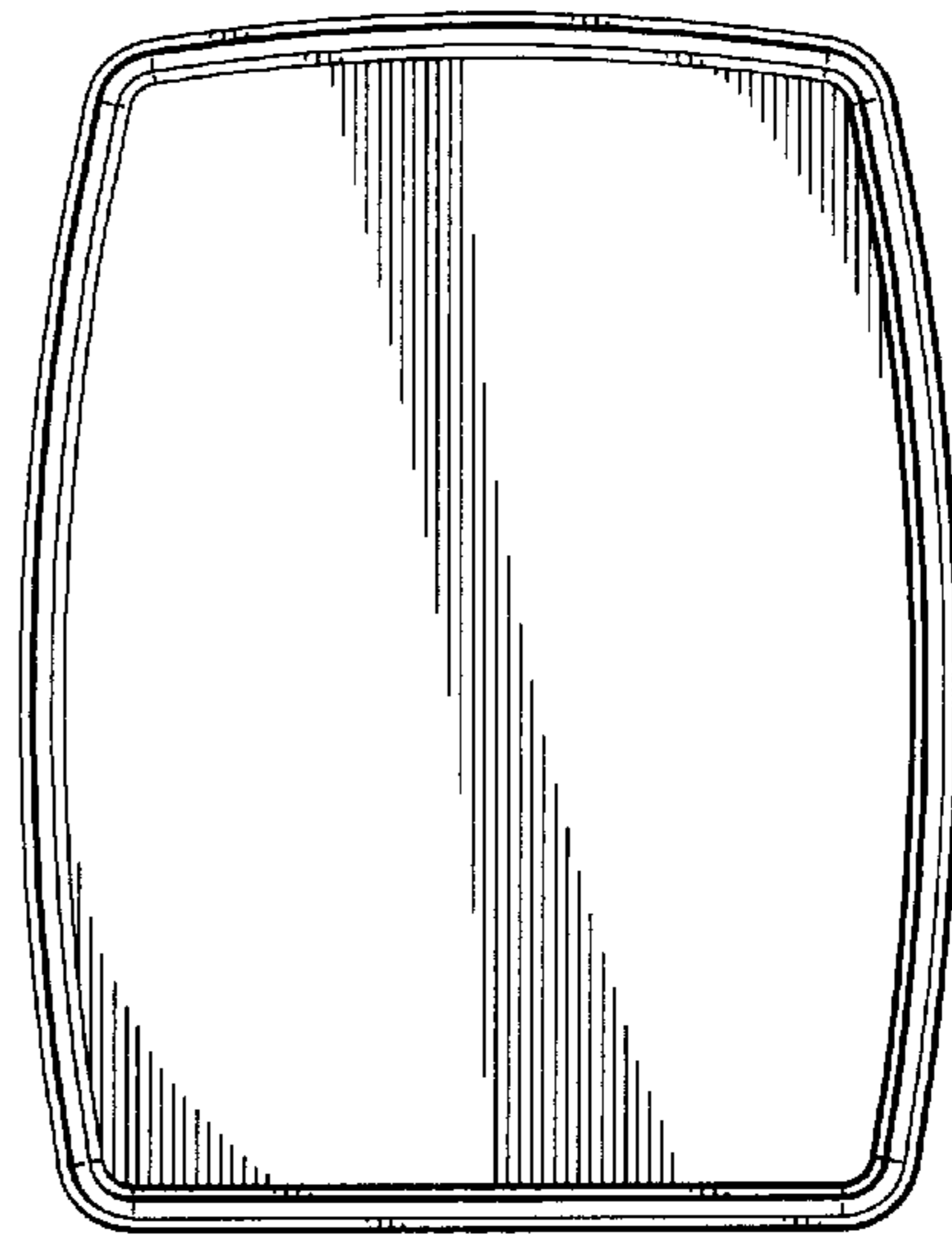
