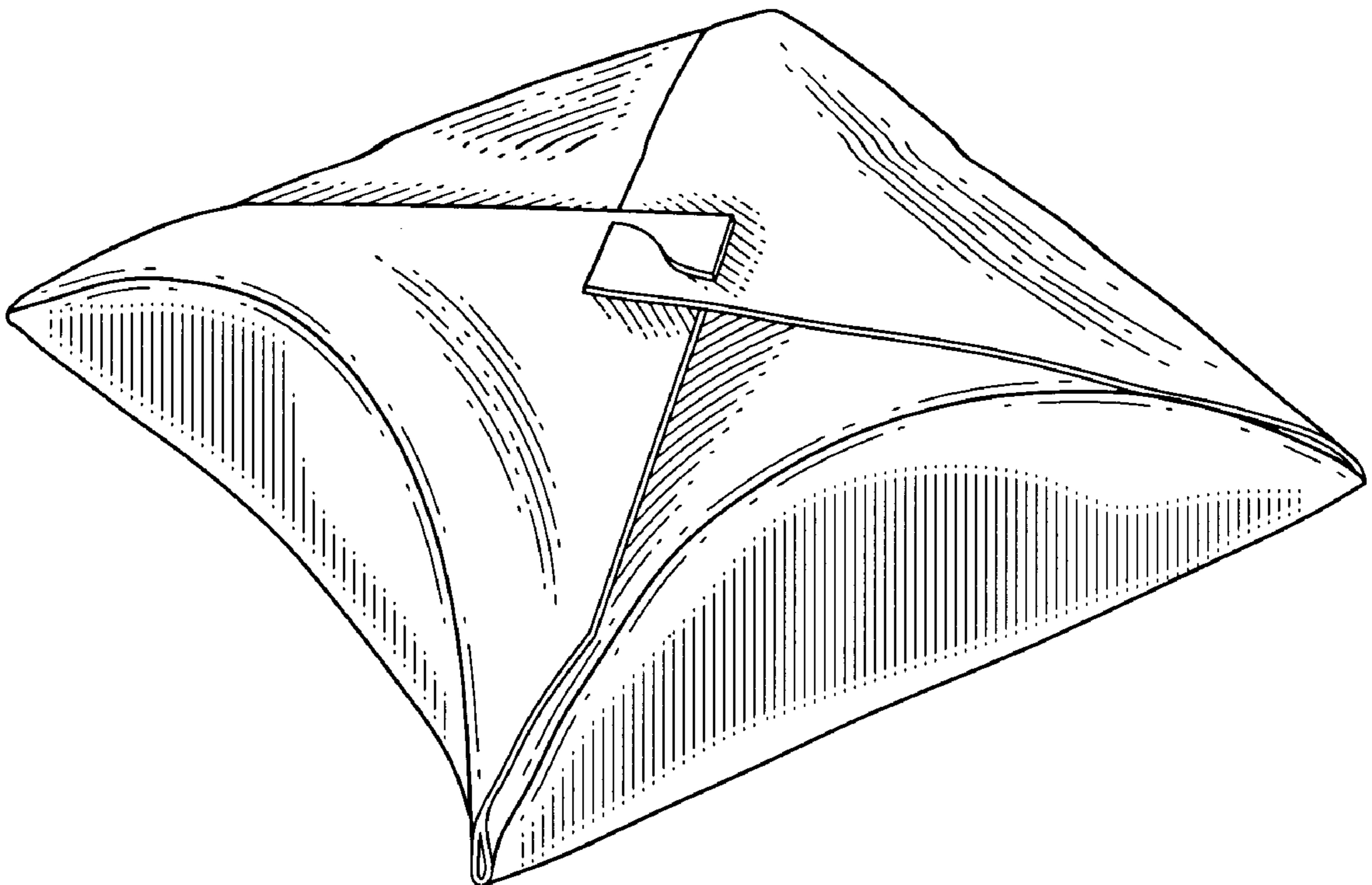

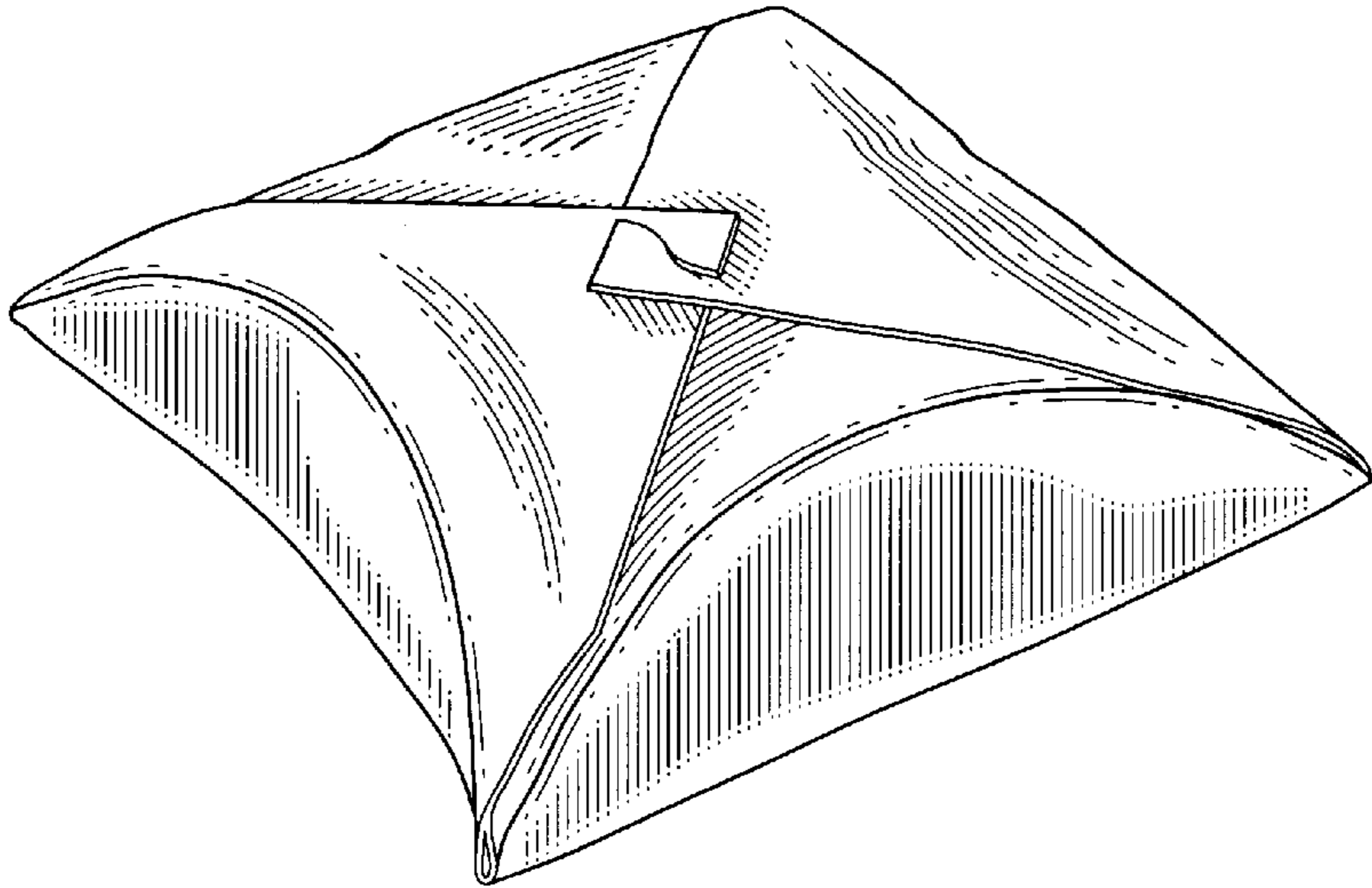
The ornamental design for box for holding one or more articles, as shown and described.

**DESCRIPTION**

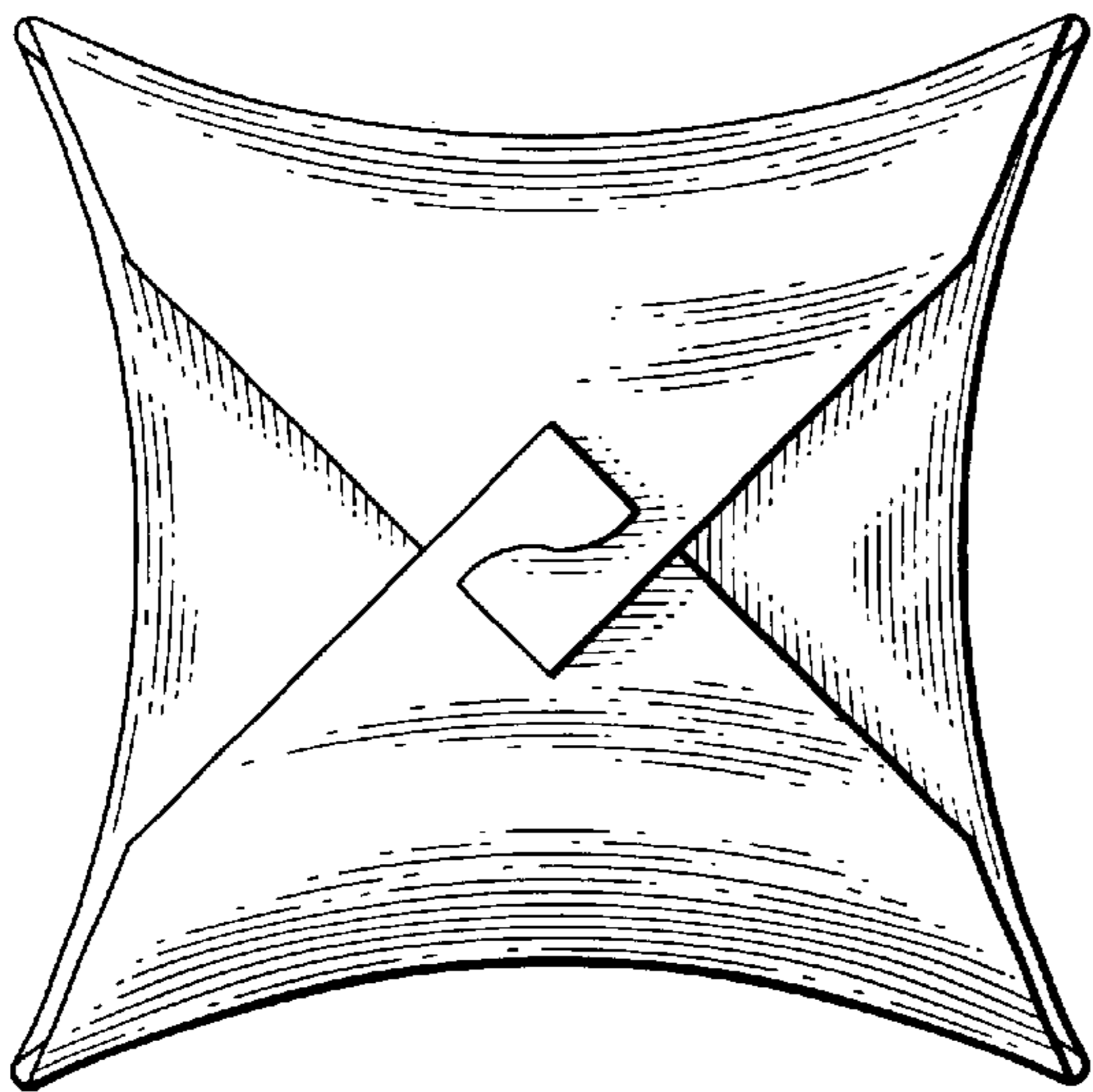
FIG. 1 is a perspective view of a box for holding one or more articles showing my design;

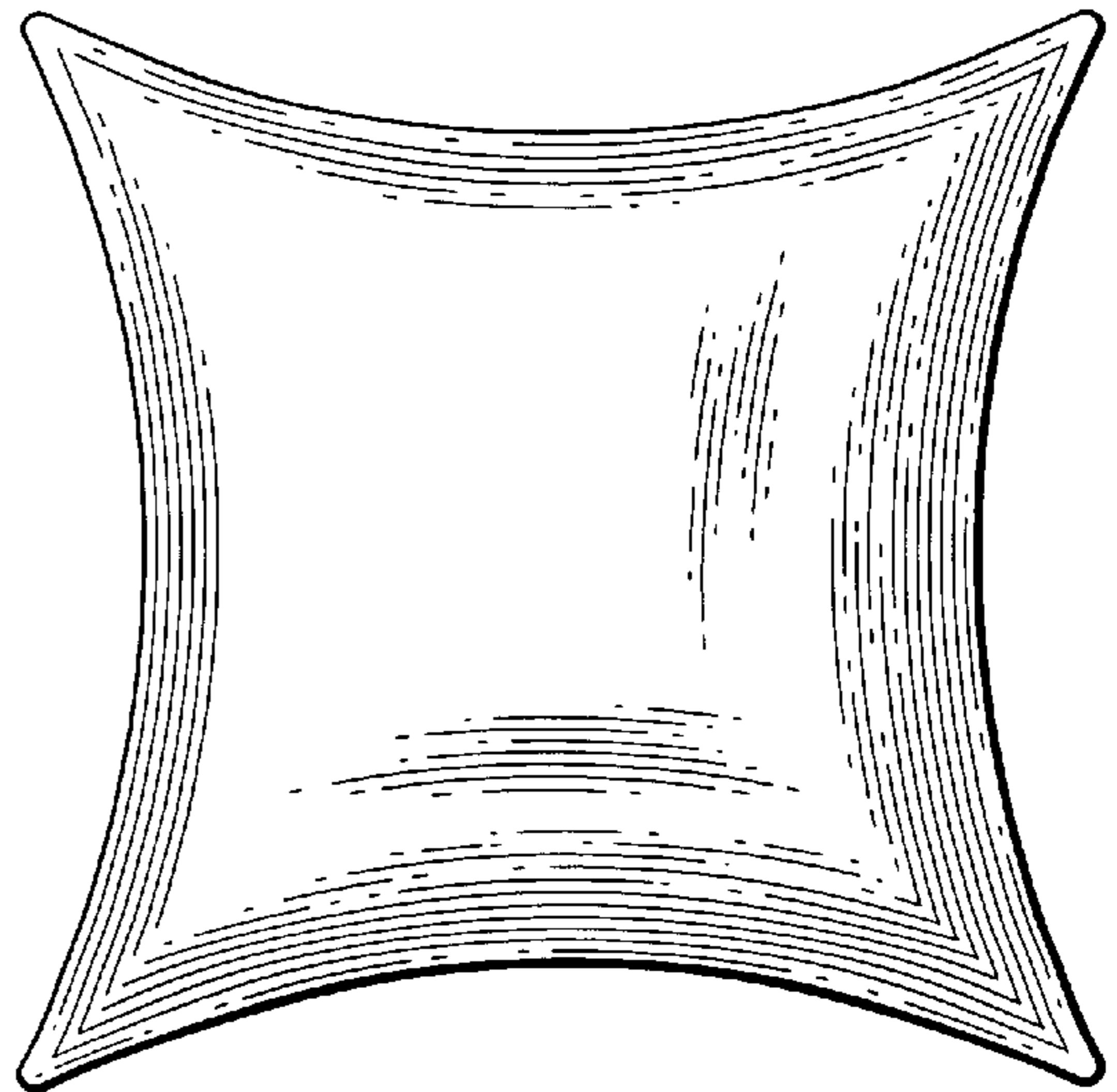




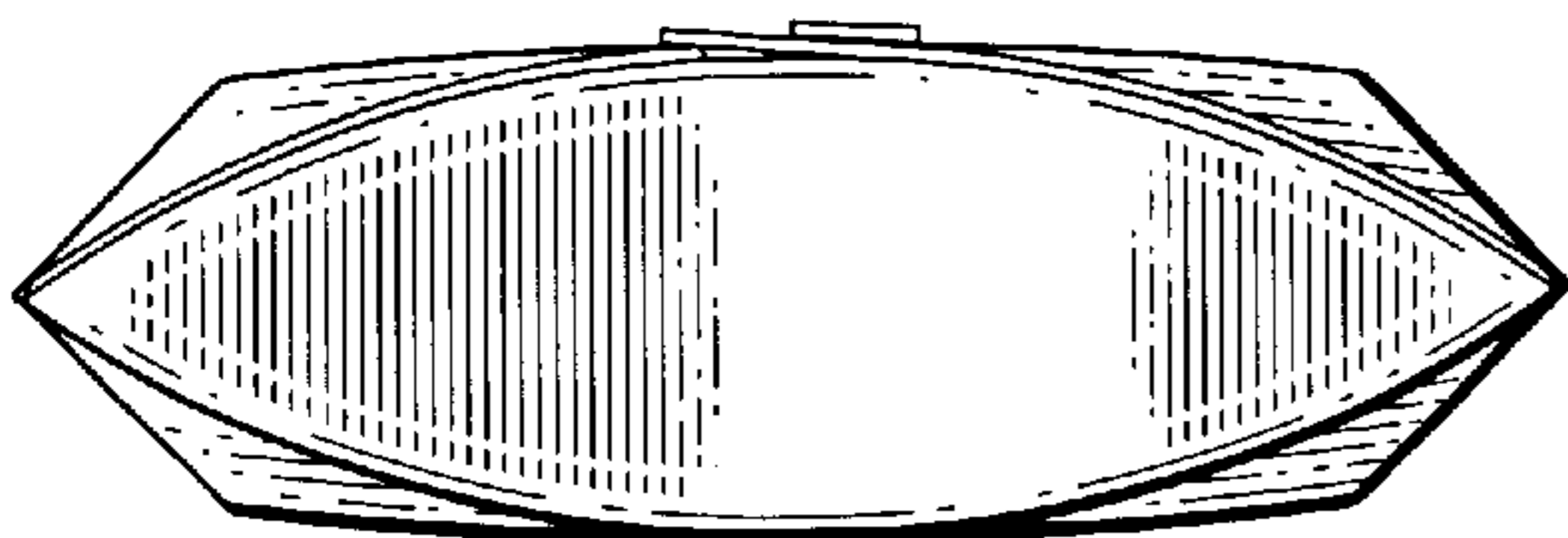

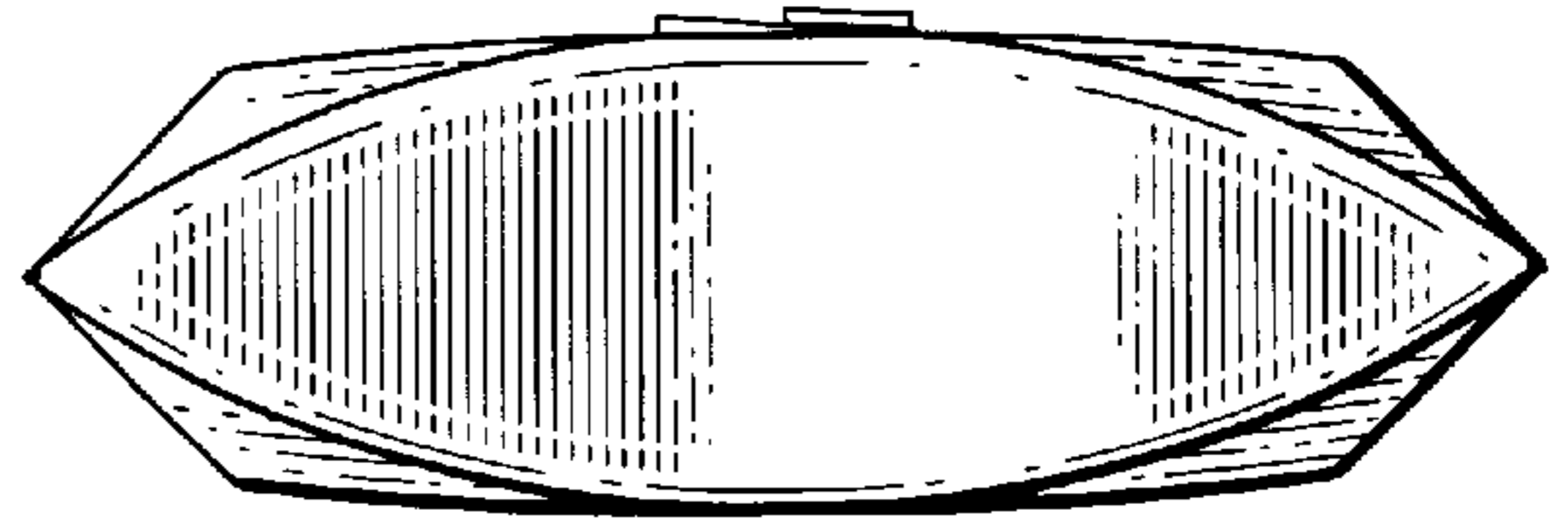
