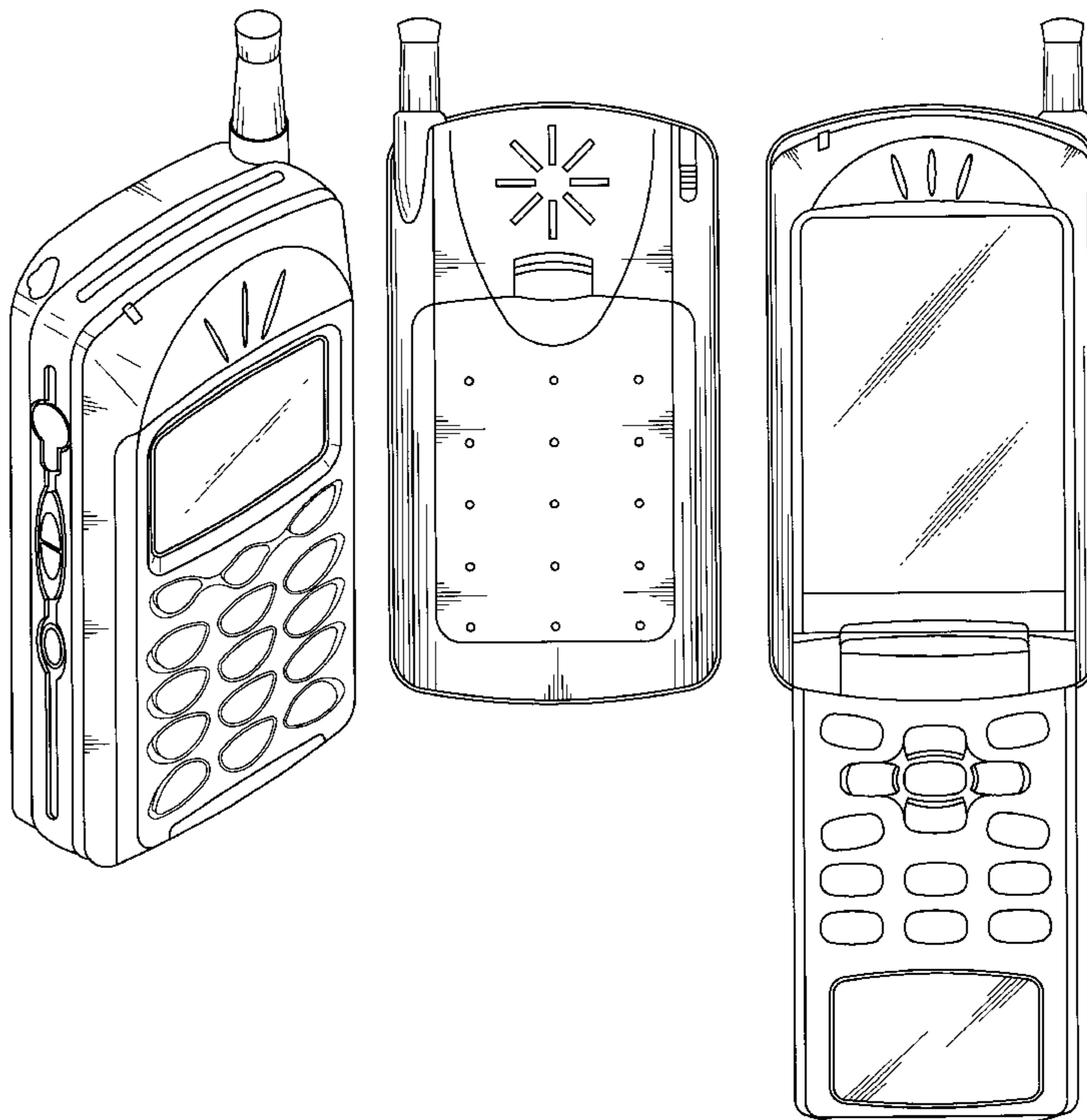
(57) **CLAIM**

I claim the ornamental design of a cellular phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cellular phone showing the new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is an enlarged top plan view thereof;  
FIG. 7 is an enlarged bottom plan view thereof; and,  
FIG. 8 is a perspective view thereof in an alternate position for use.

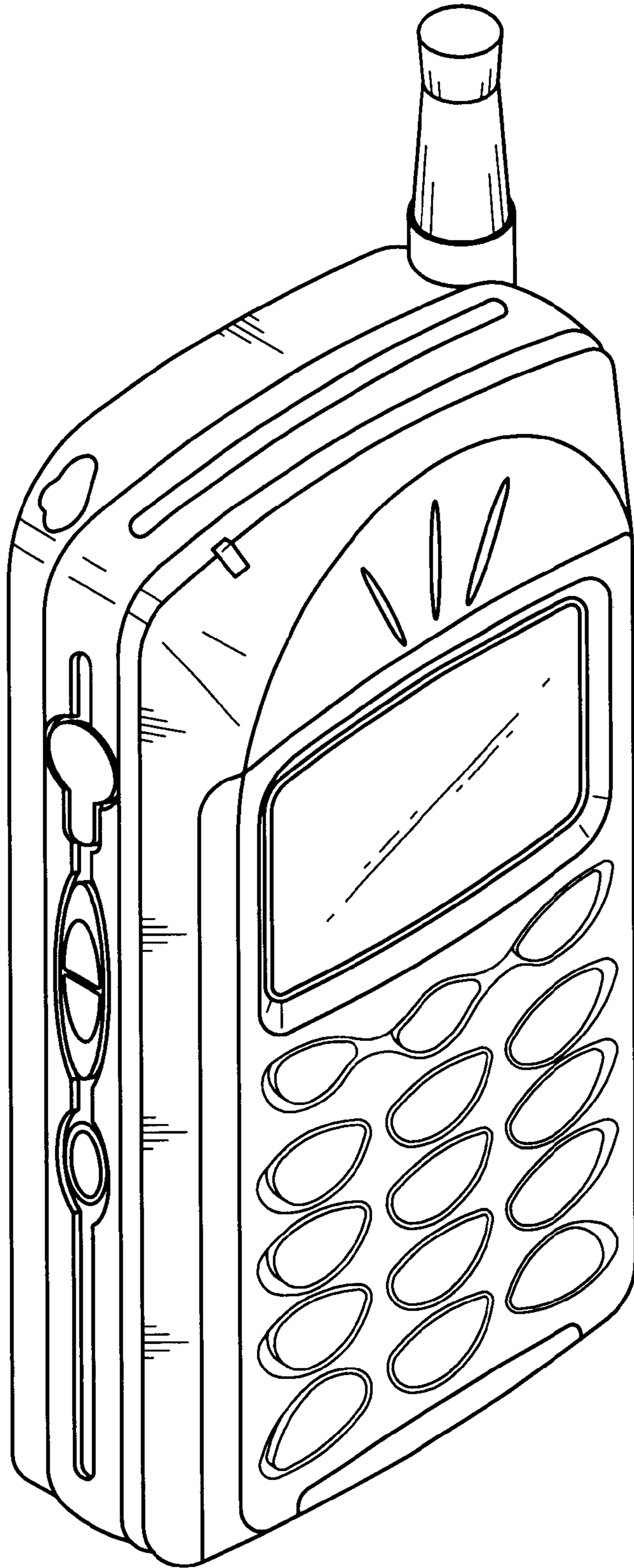

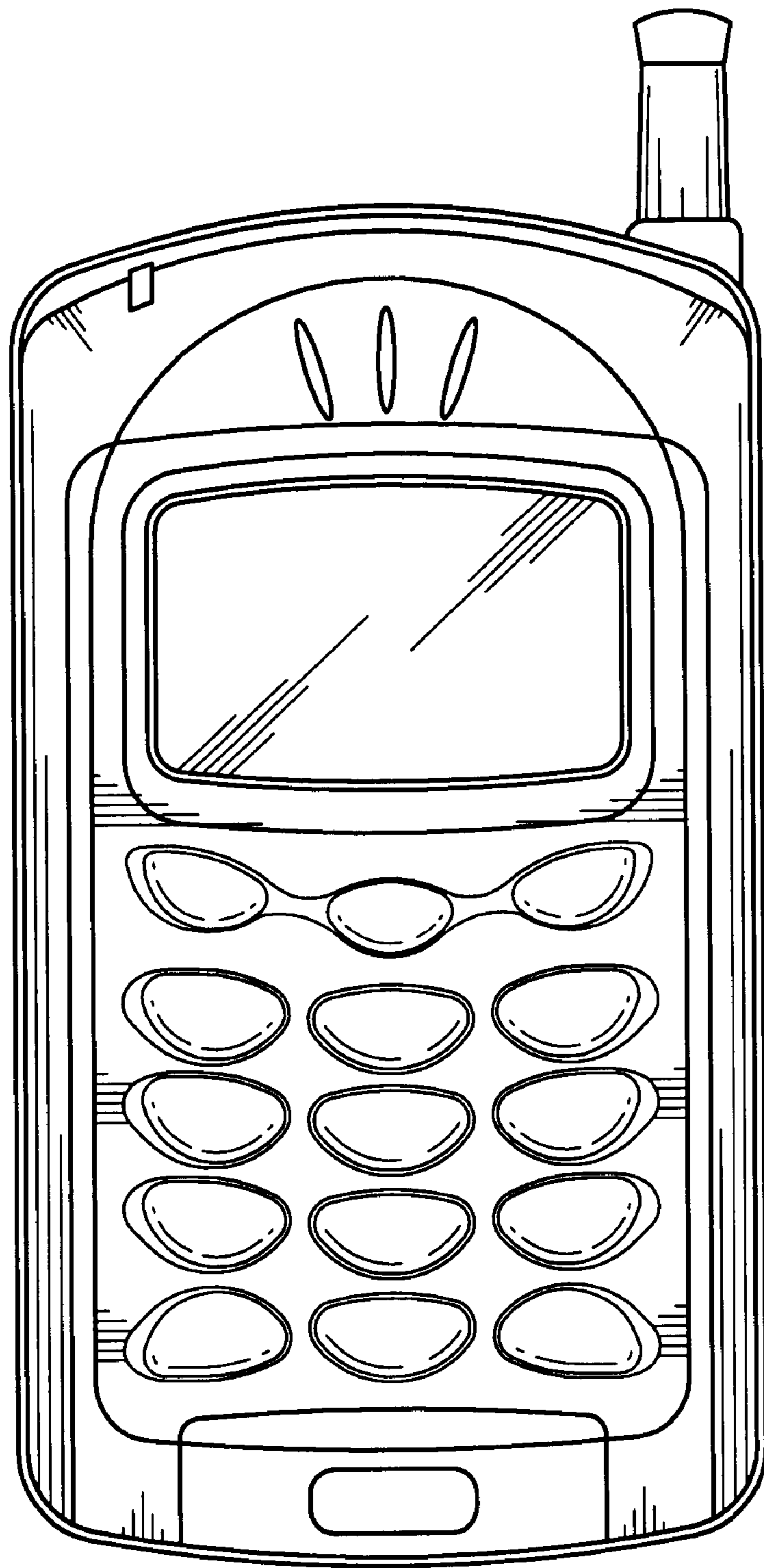

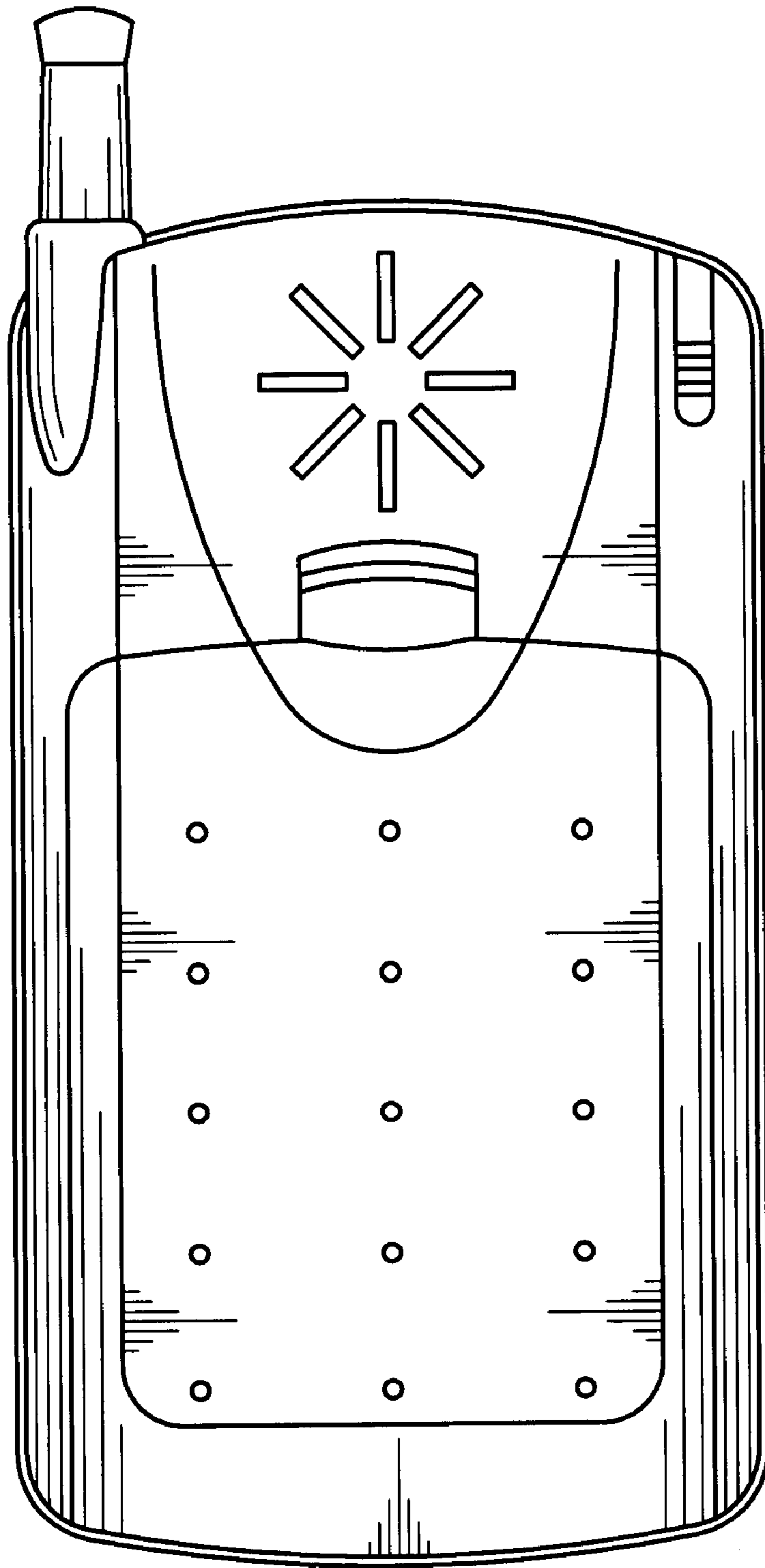

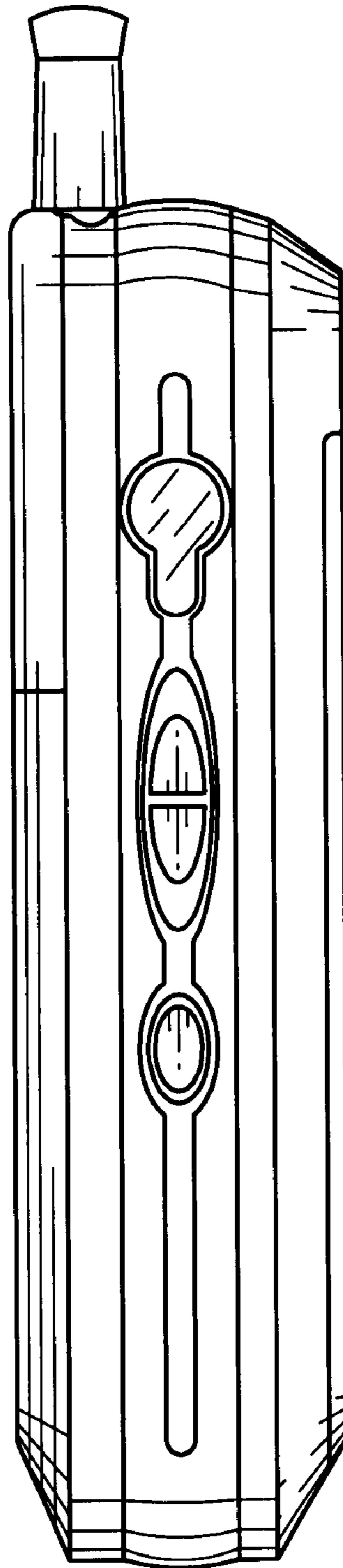

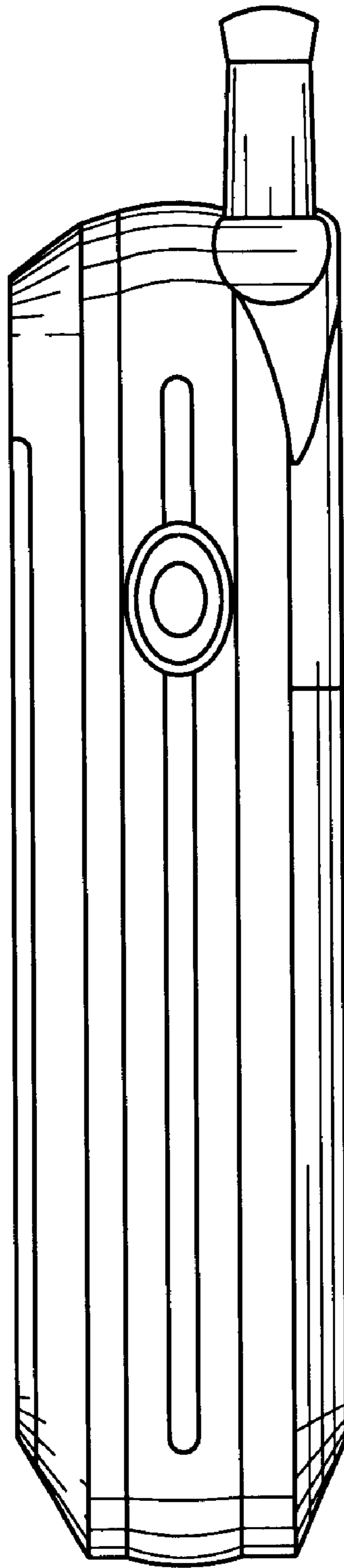

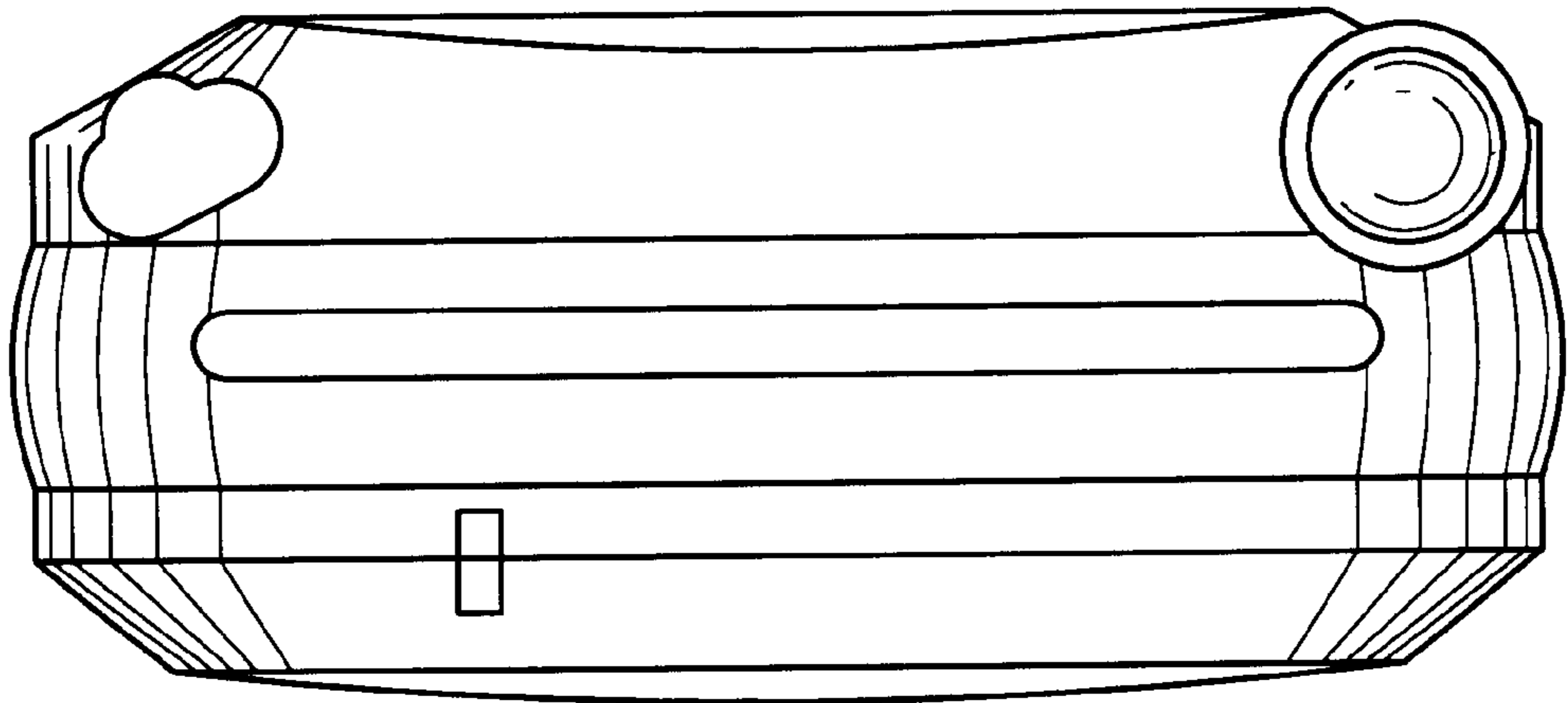

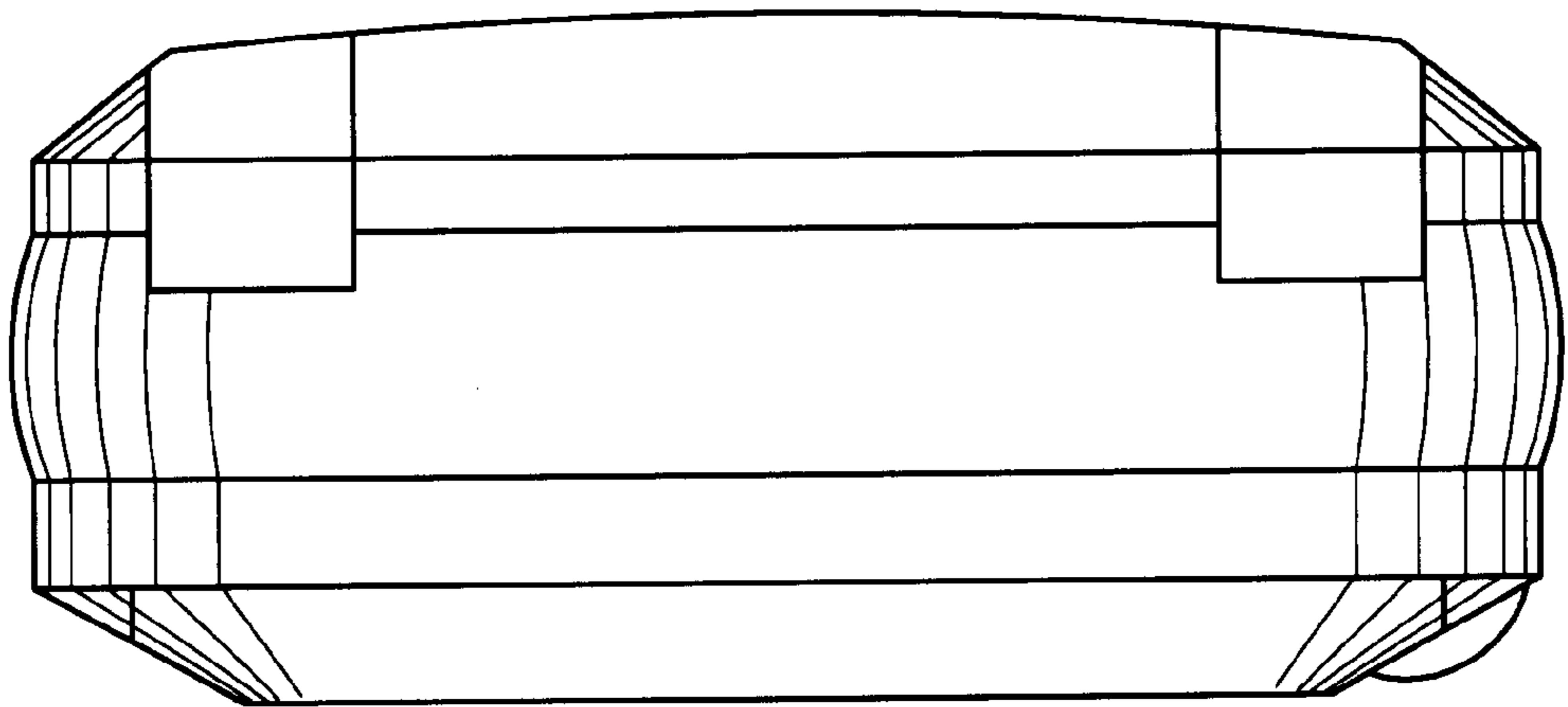

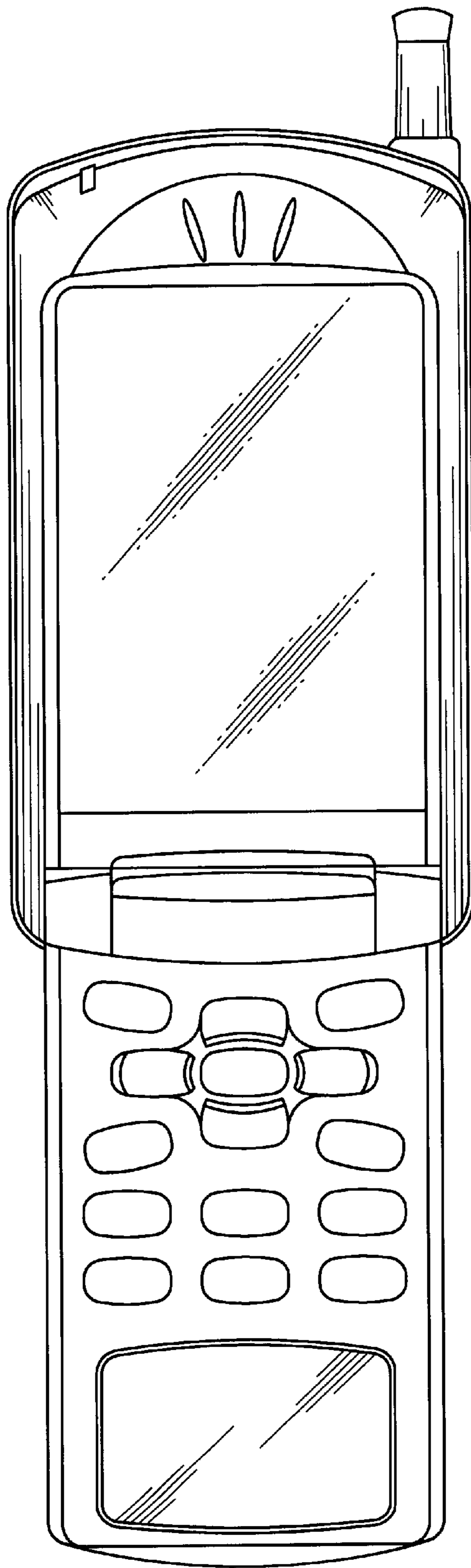
