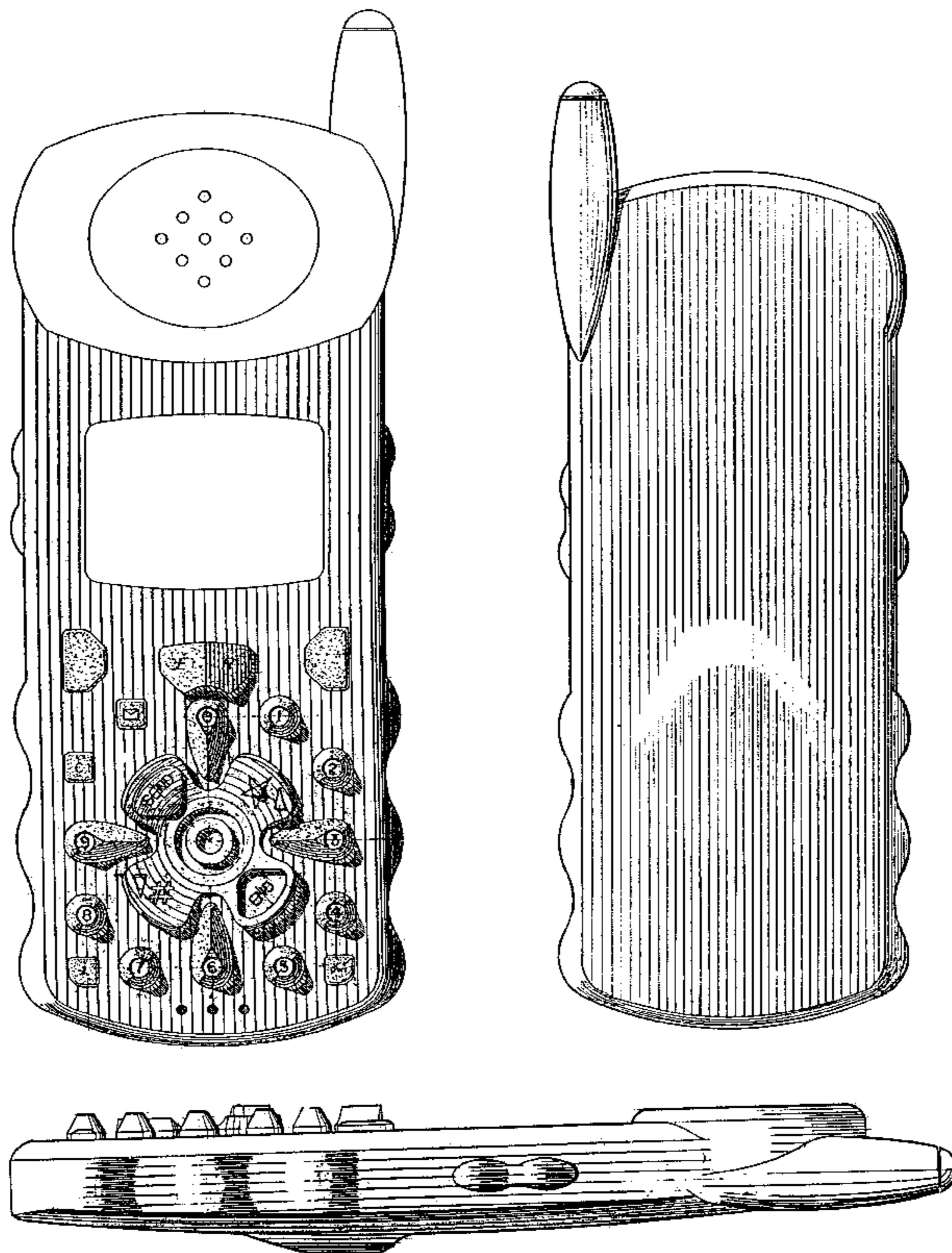
(57) **CLAIM**

The ornamental design for a cell phone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cell phone;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top elevational view thereof;
FIG. 6 is a bottom elevational view thereof;
FIG. 7 is a front elevational view of the cell phone design in its intended environment, the hand is shown in broken lines for illustrative purposes only and forms no part of the claimed design; and,
FIG. 8 is a left side elevational view thereof.

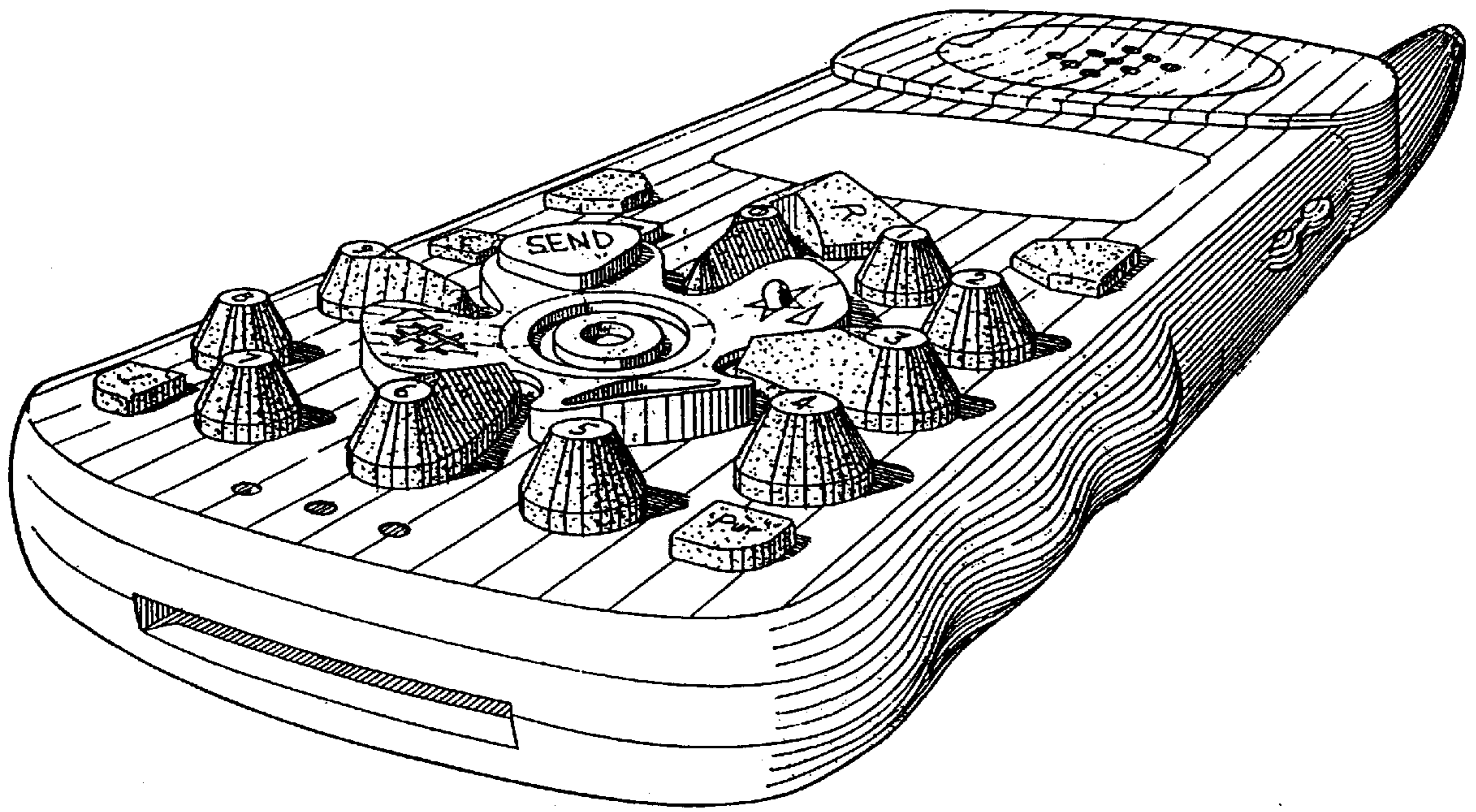

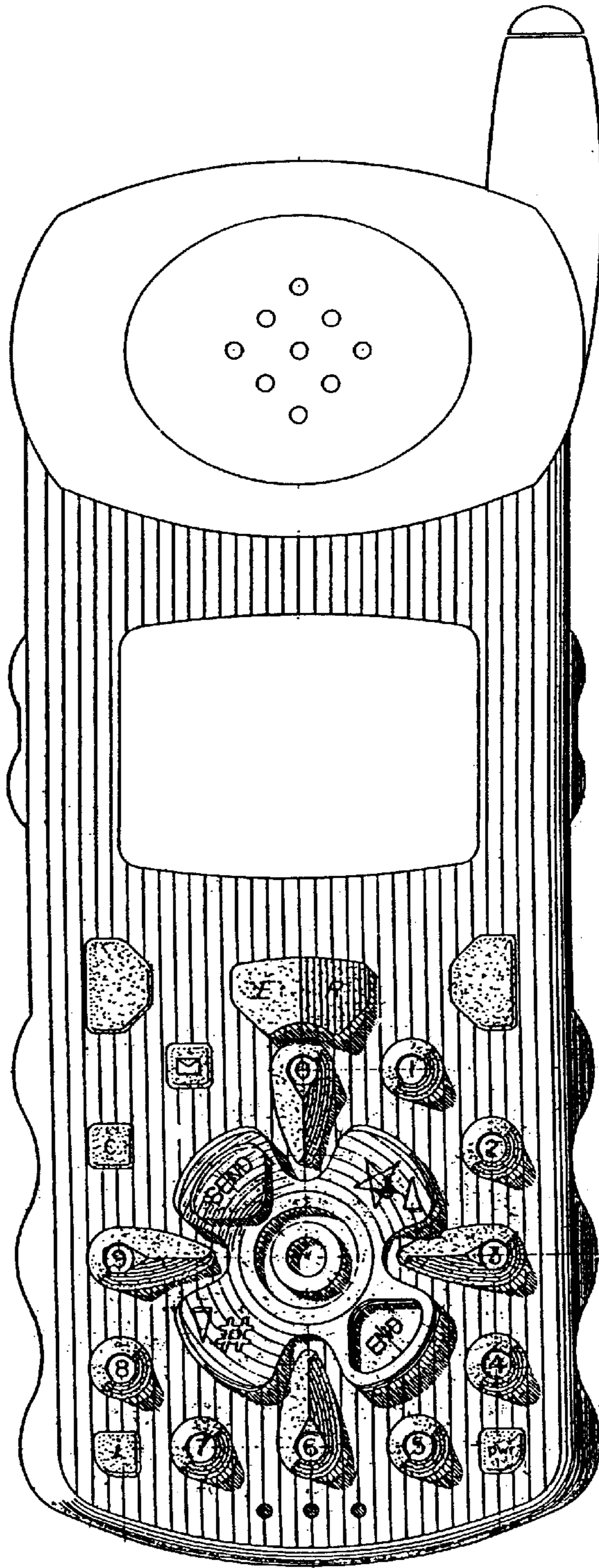

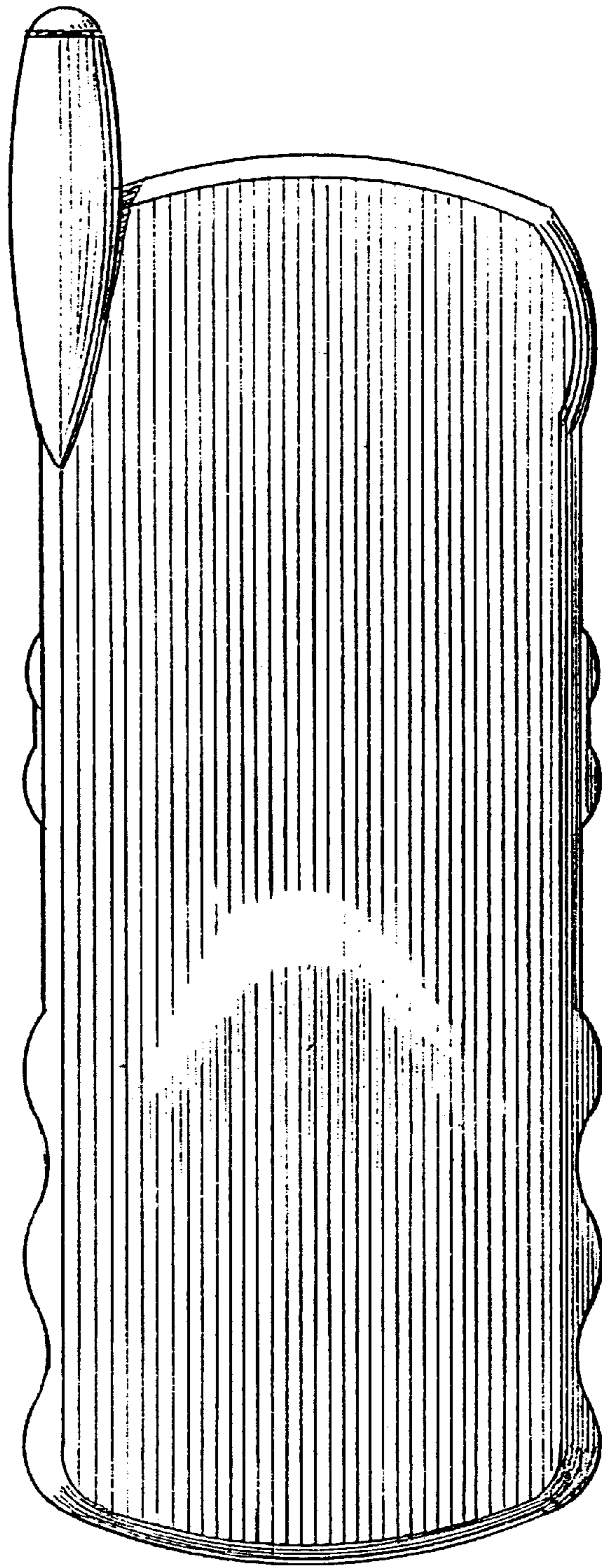

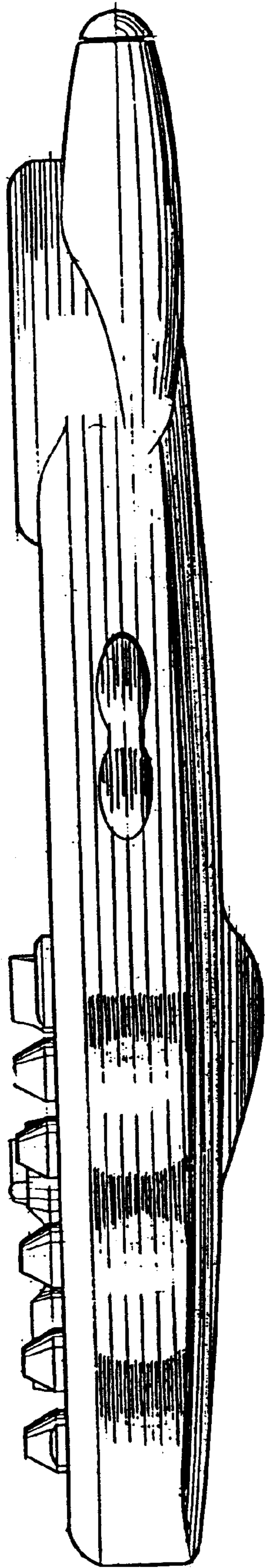

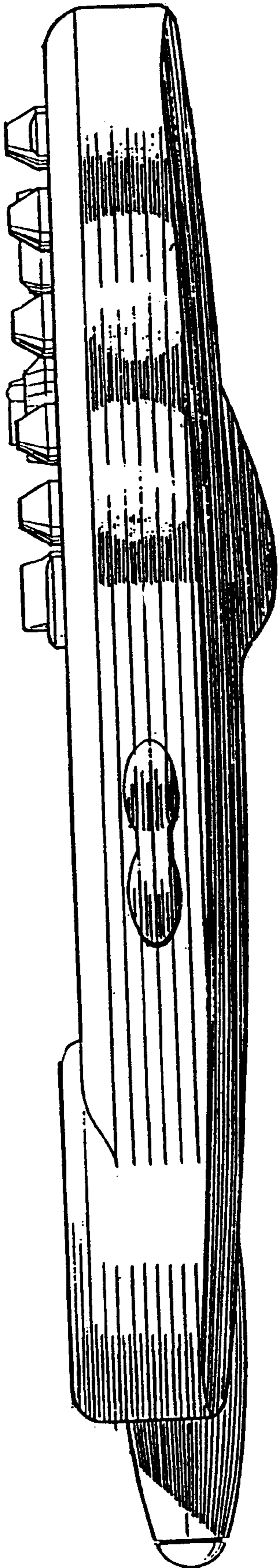

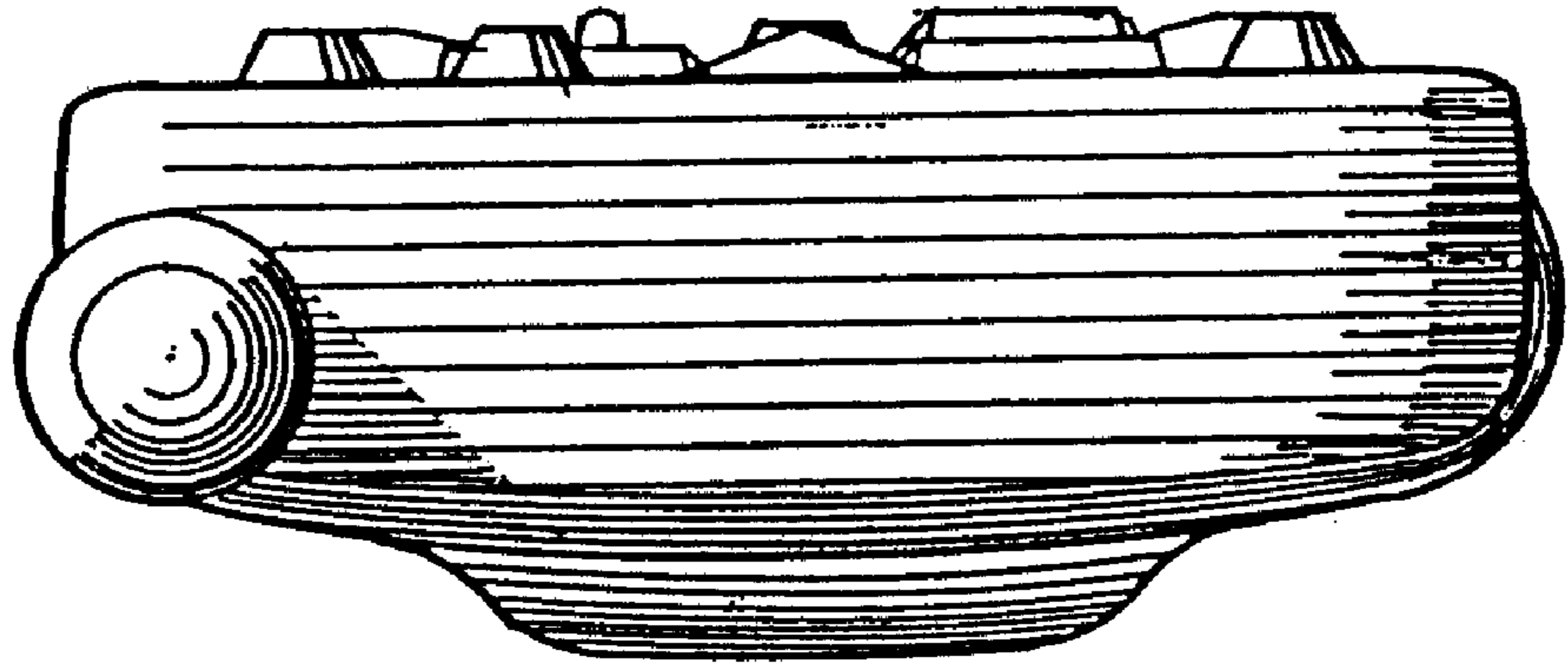

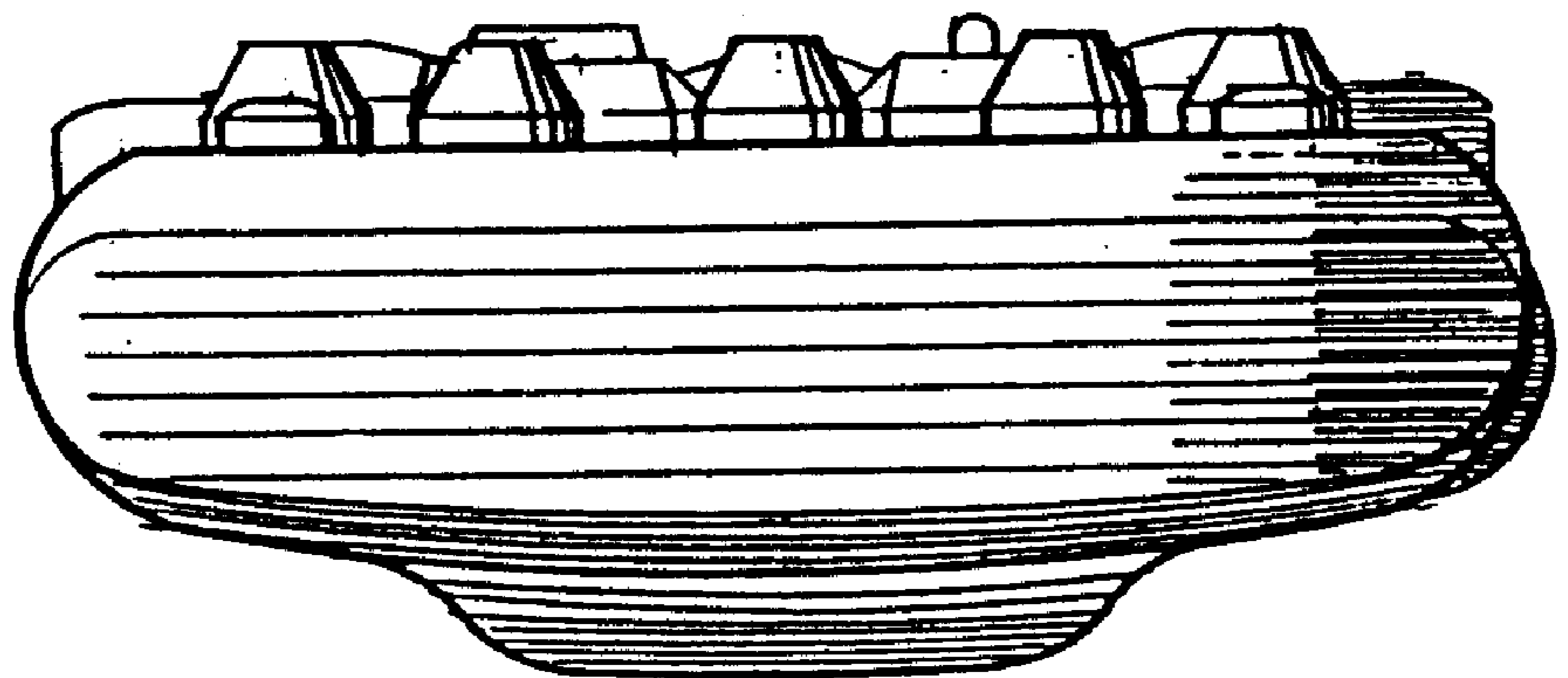

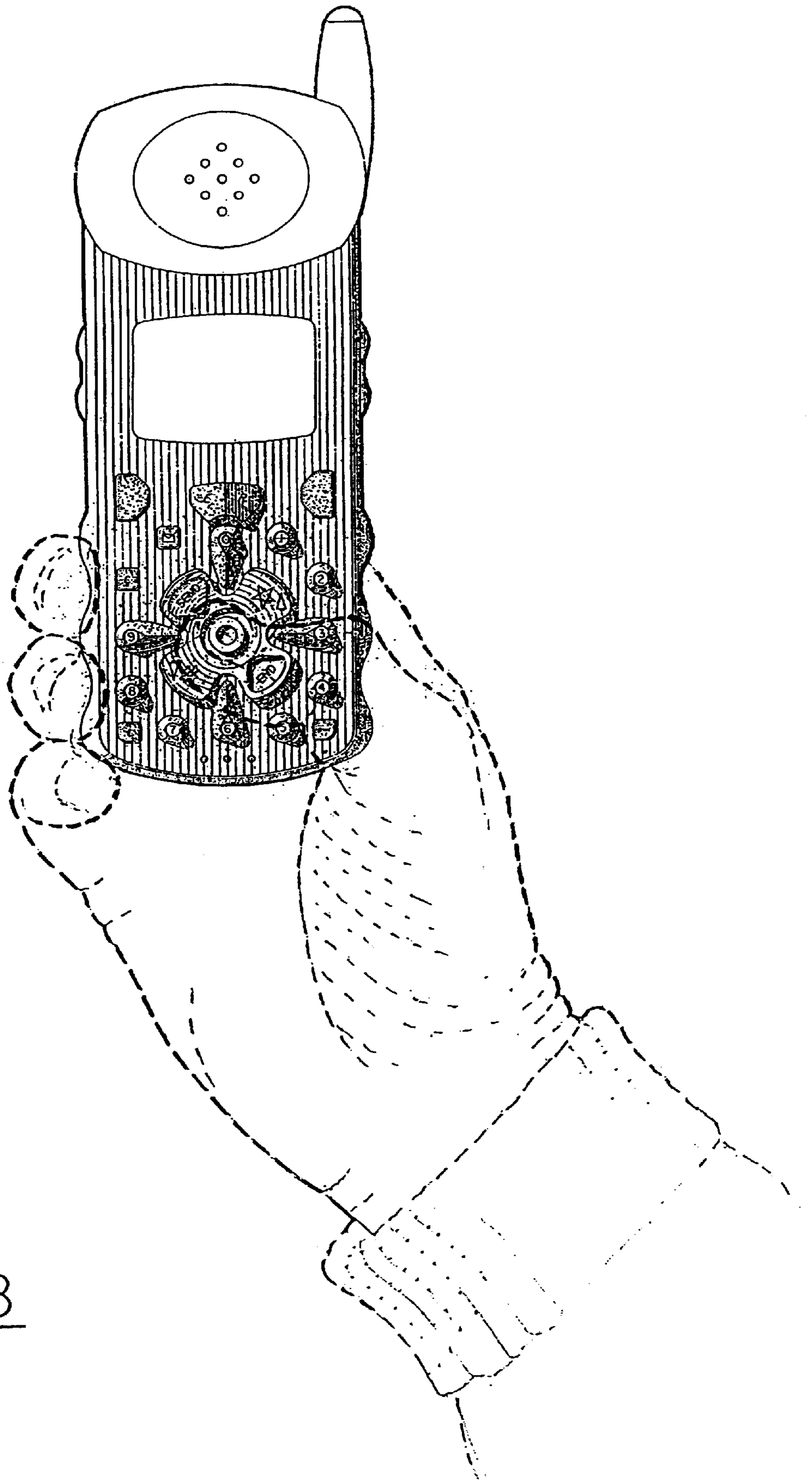
