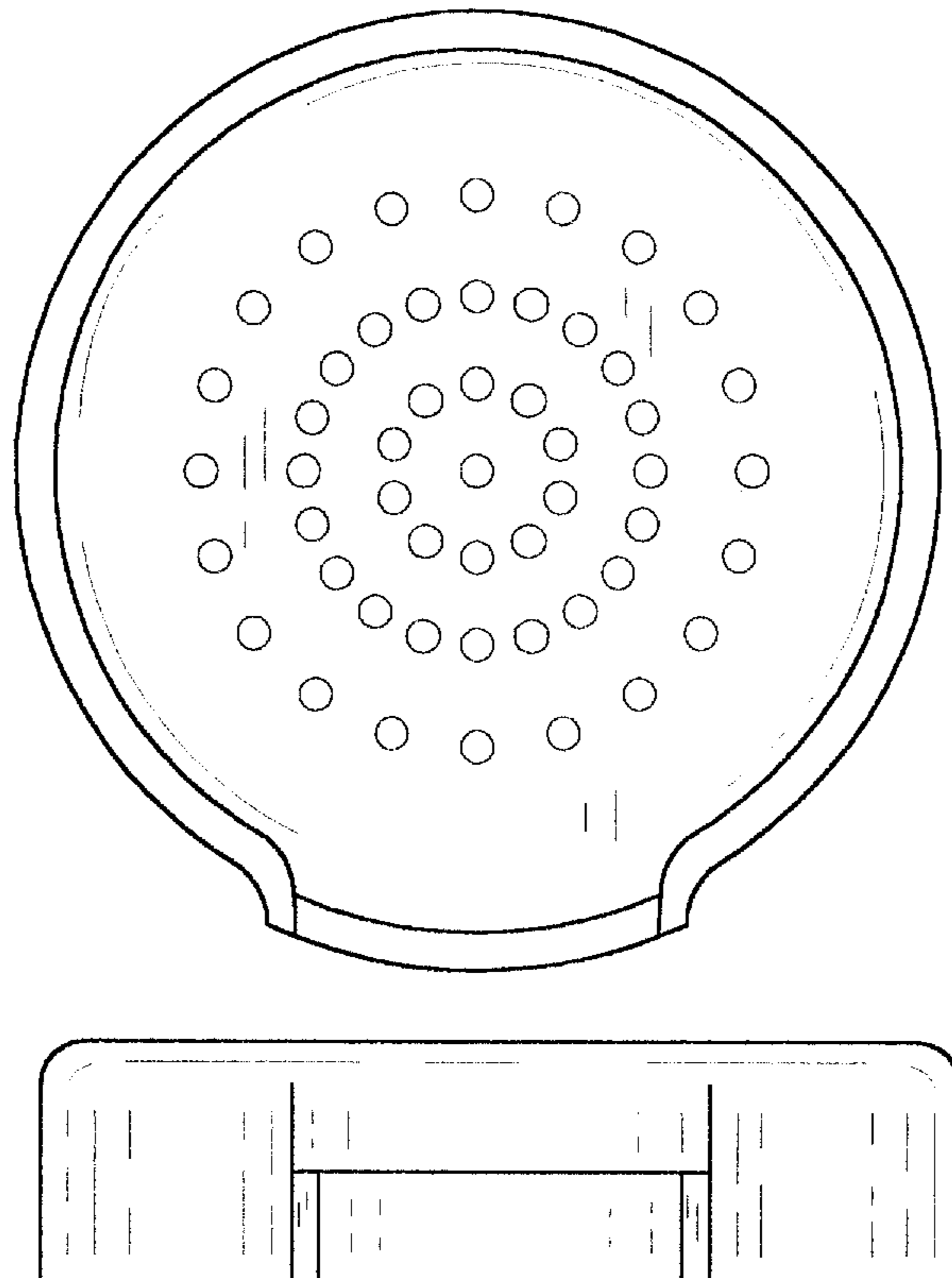
(57) **CLAIM**

The ornamental design for a phone end cover, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the phone end cover of the present invention;
 FIG. 2 is a rear elevational view of the phone end cover of FIG. 1;
 FIG. 3 is a left side elevational view of the phone end cover of FIG. 1; the right side view being a mirror image thereof;
 FIG. 4 is a top plan view of the phone end cover of FIG. 1;
 FIG. 5 is a bottom plan view of the phone end cover of FIG. 1; and,
 FIG. 6 is an enlarged cross-sectional view of FIG. 1 taken along line 6—6.

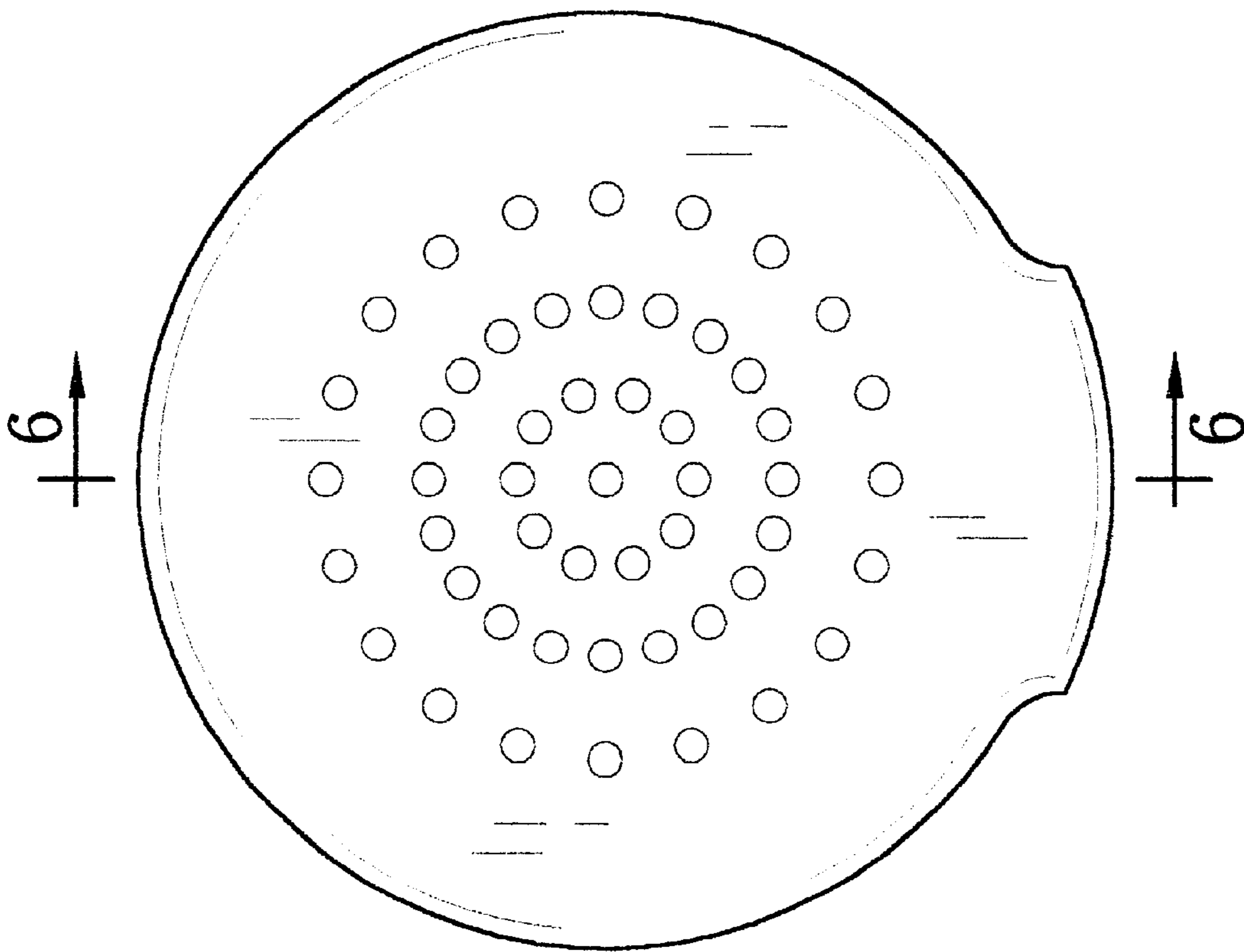

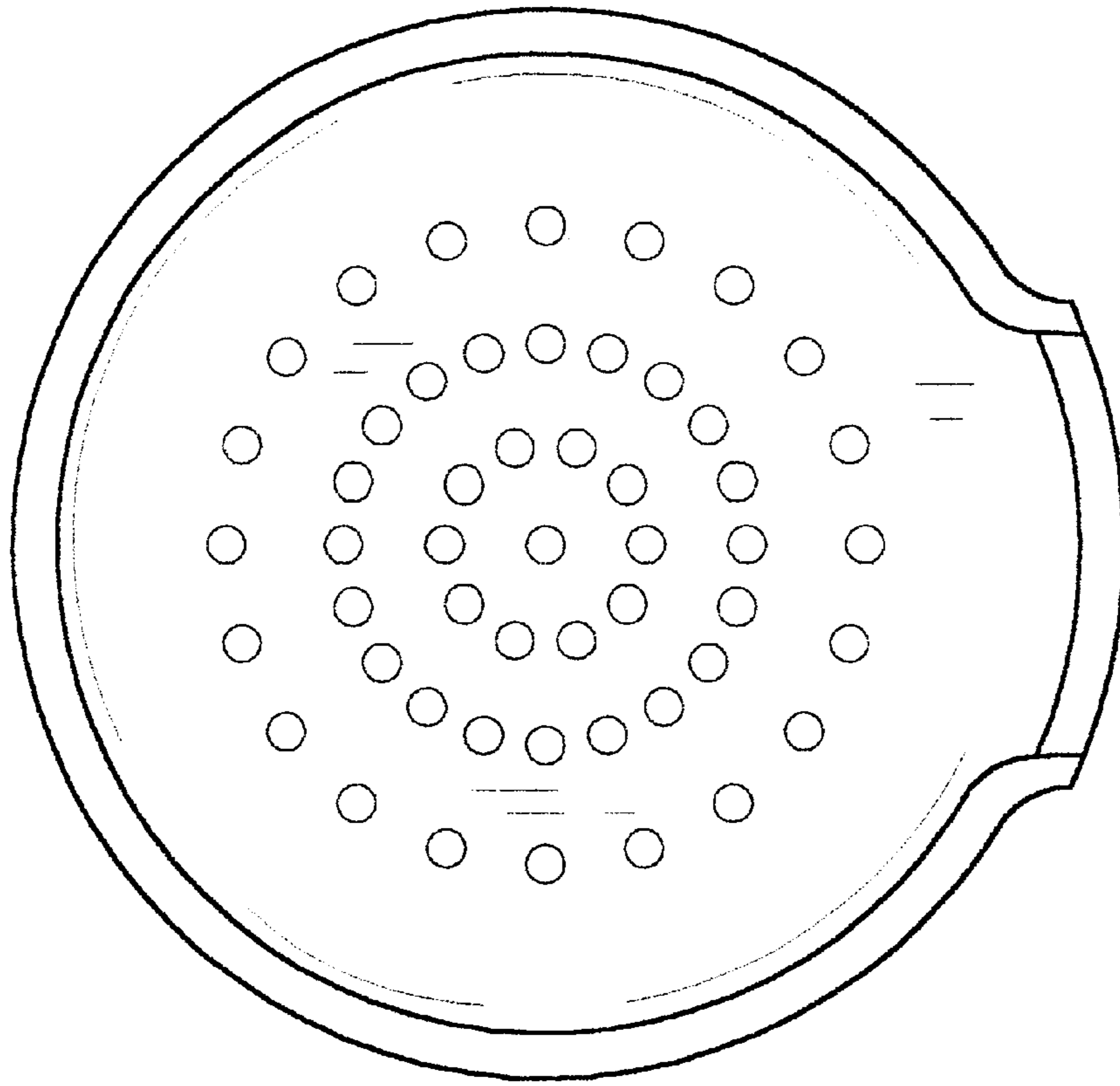

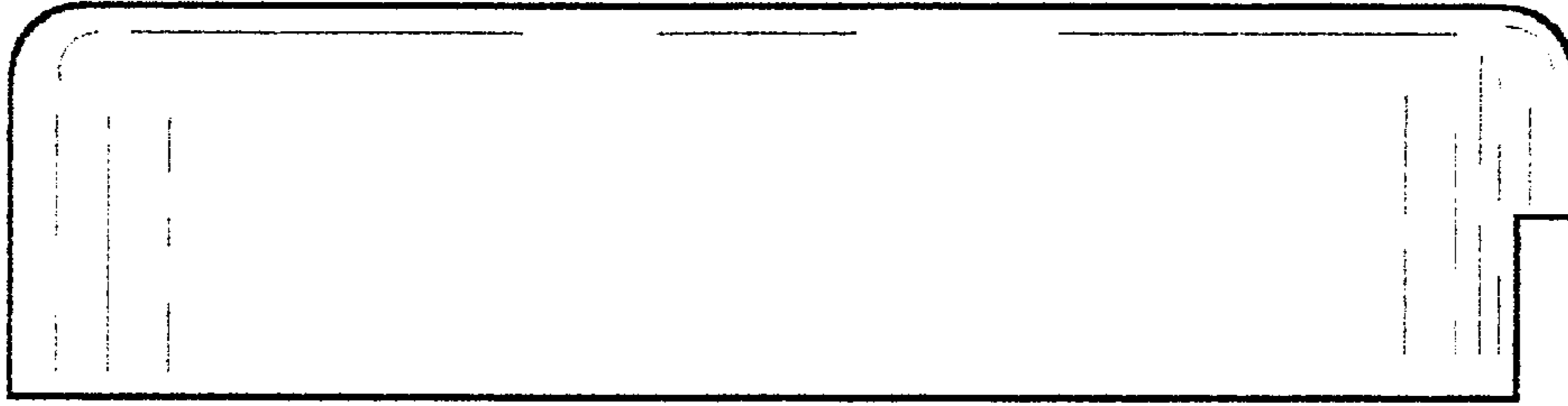

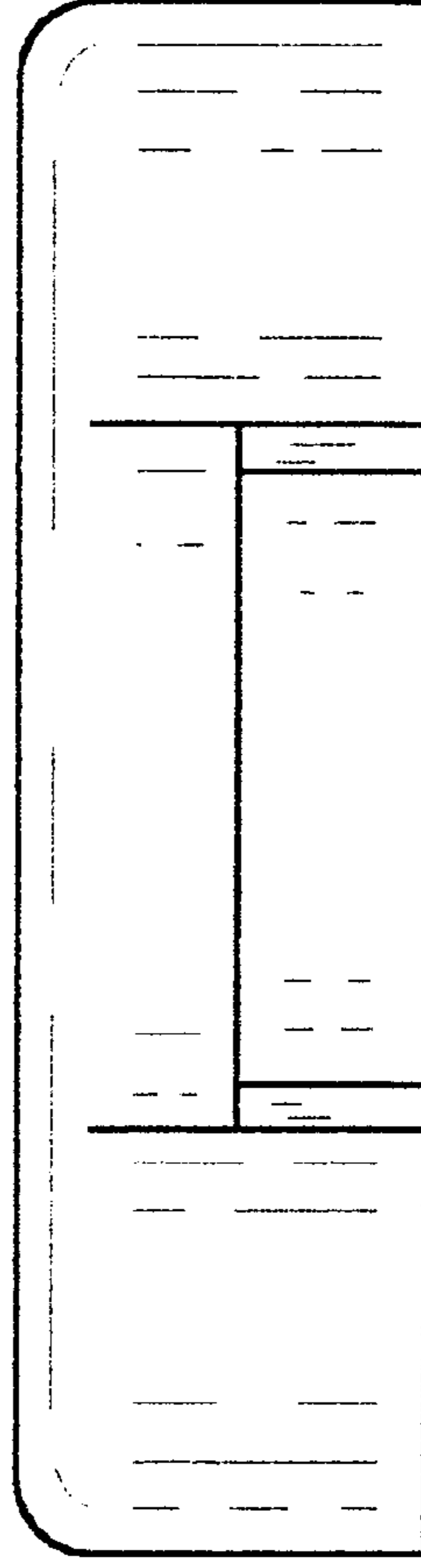
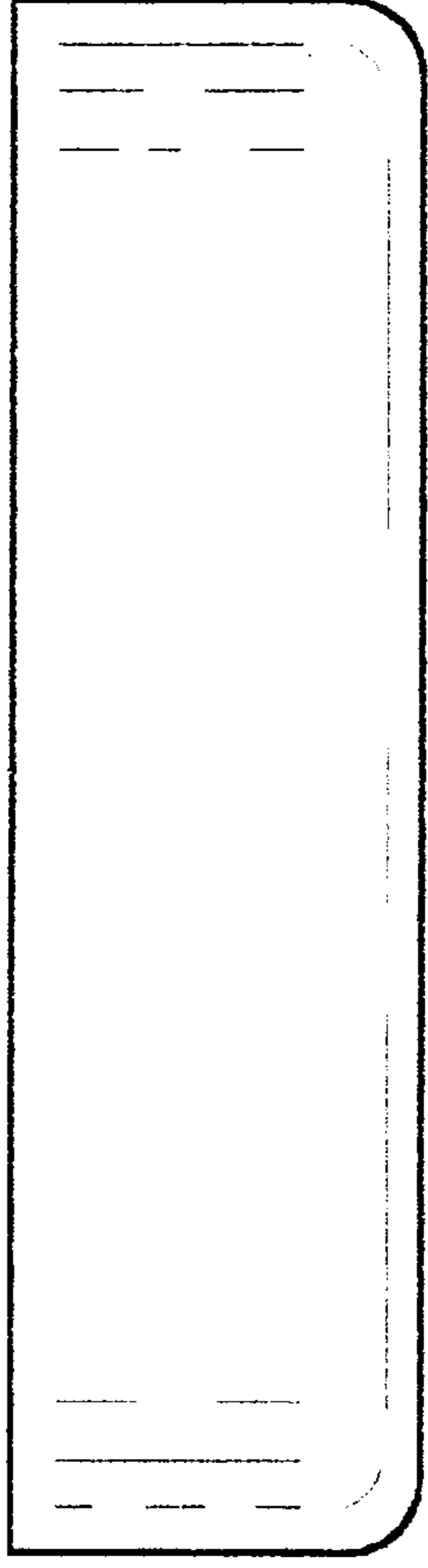

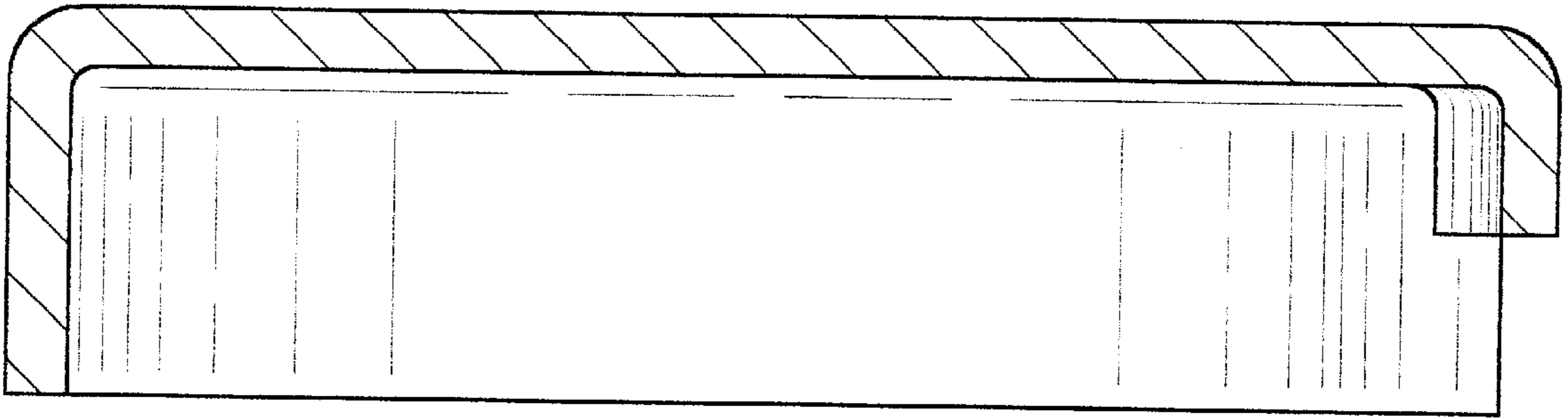
