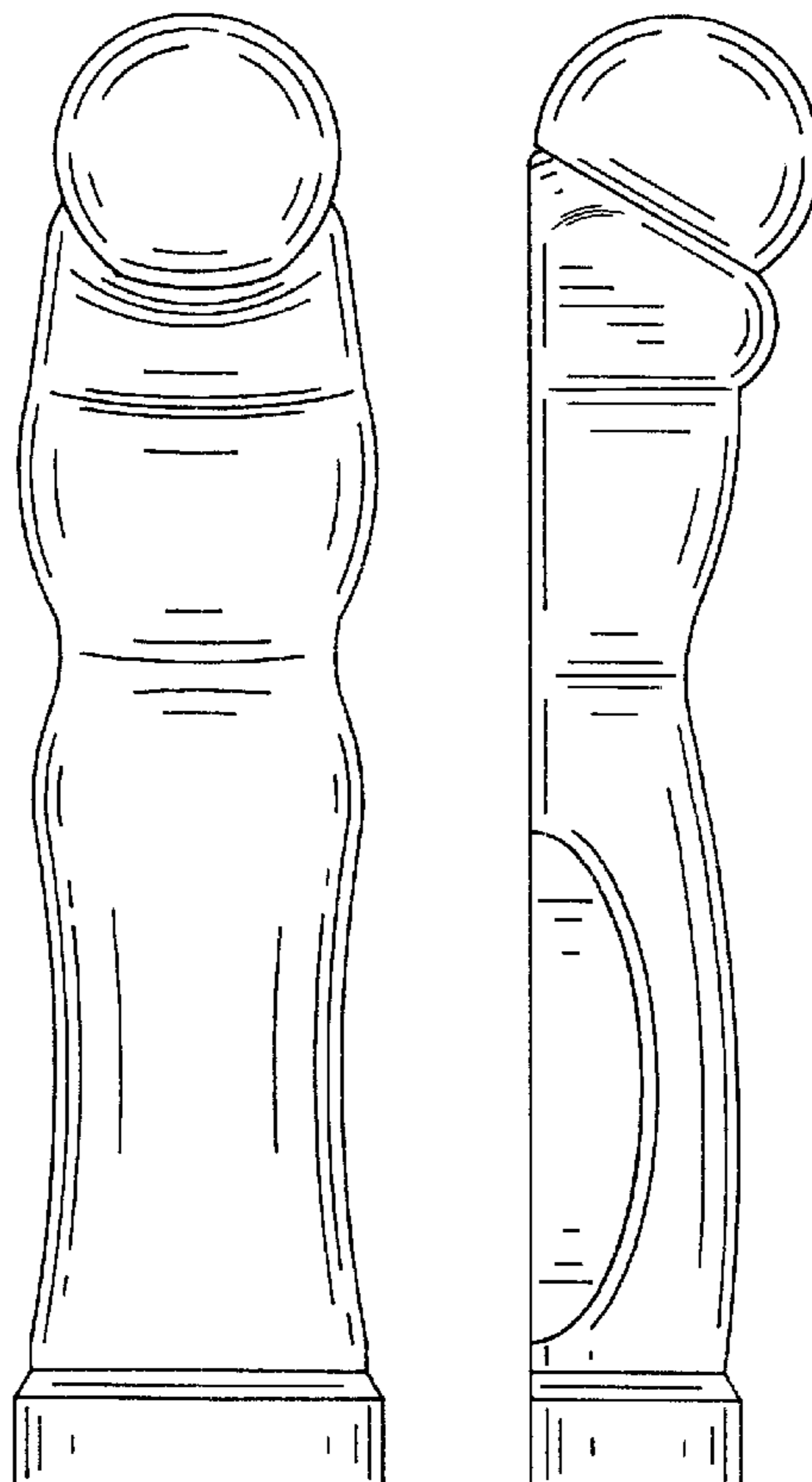
(57) **CLAIM**

The ornamental design for a marker bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a marker bottle, showing our new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a side elevational view thereof;
 FIG. 4 is an opposite elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a front elevational view of the embodiment of FIG. 1 with the cap removed;
 FIG. 8 is a rear elevational view of the embodiment of FIG. 7;
 FIG. 9 is a side elevational view of FIG. 7;
 FIG. 10 is an opposite side elevational view of FIG. 9;

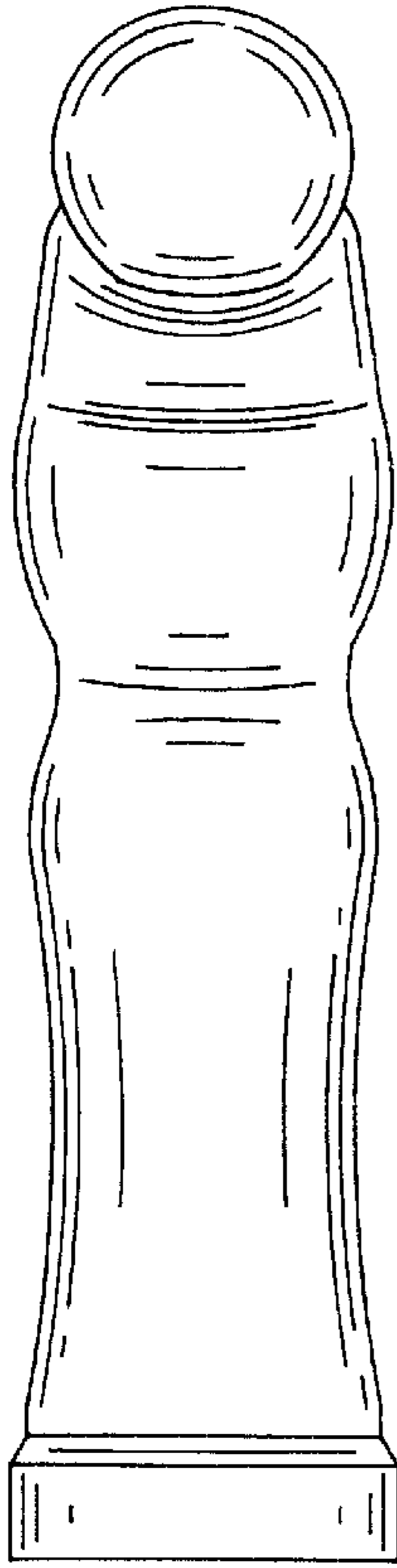

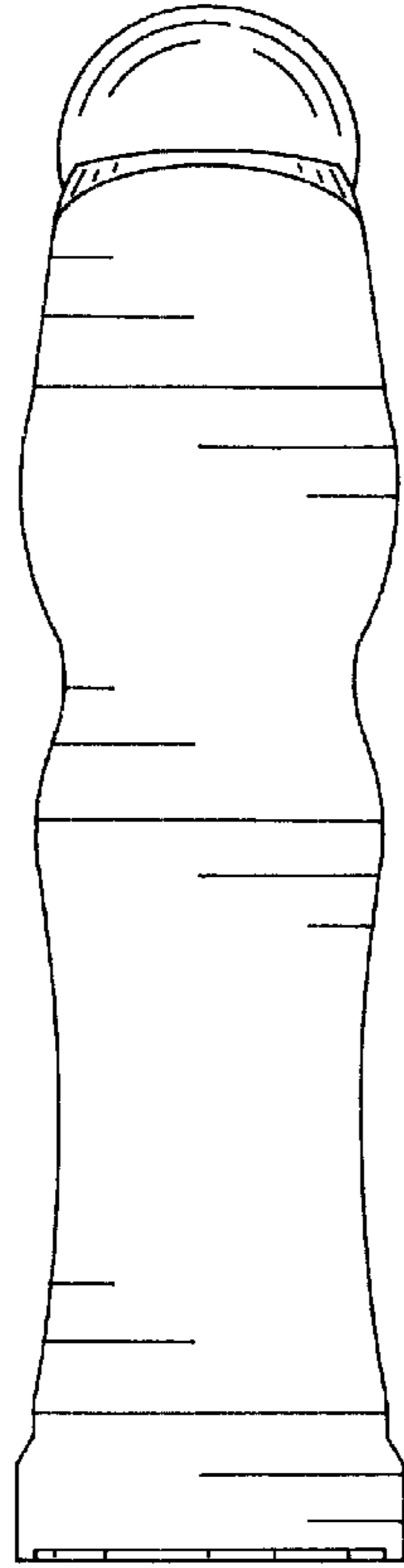

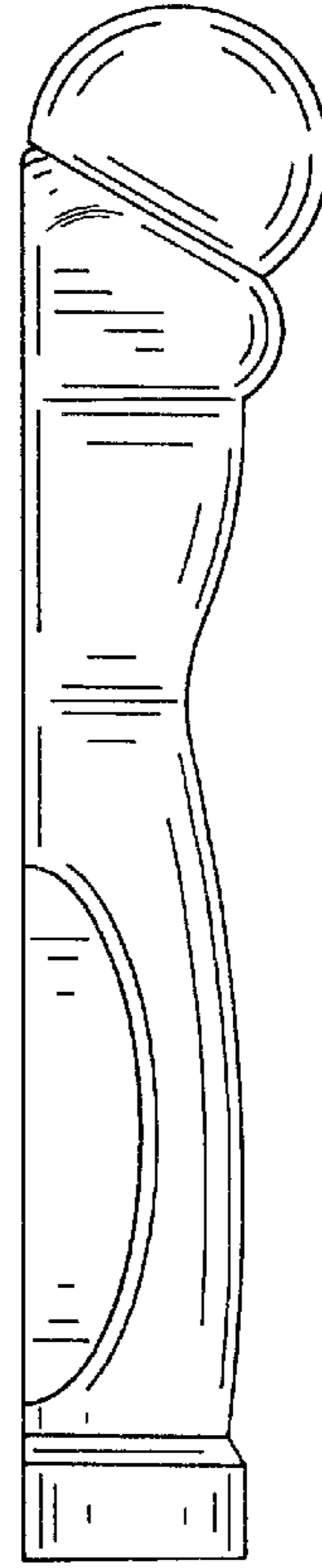

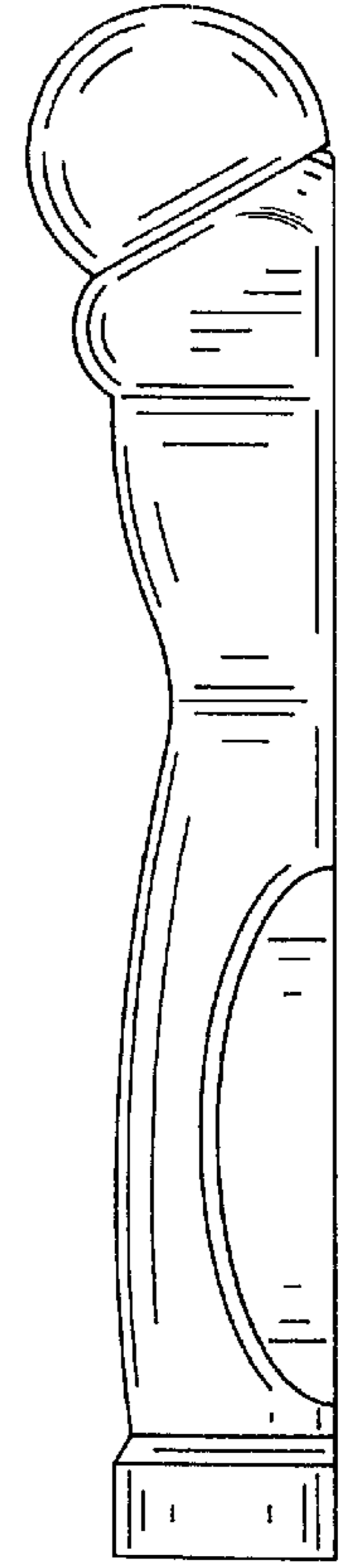

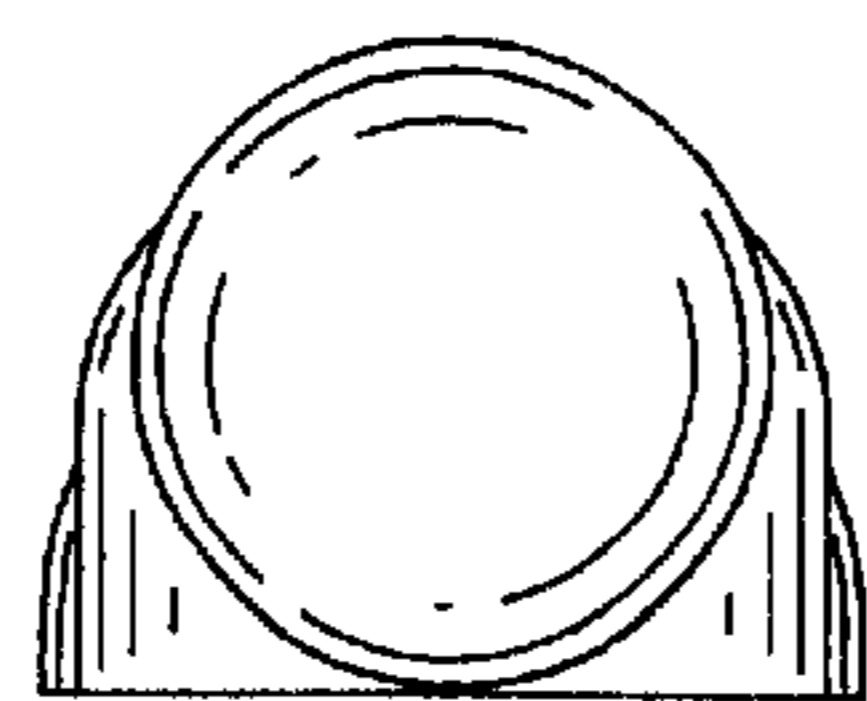

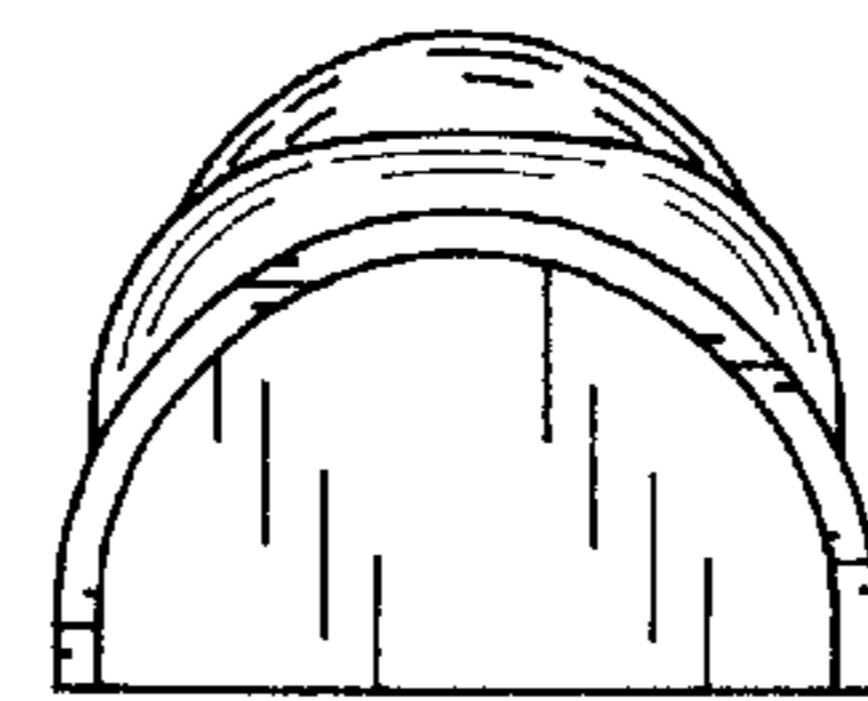

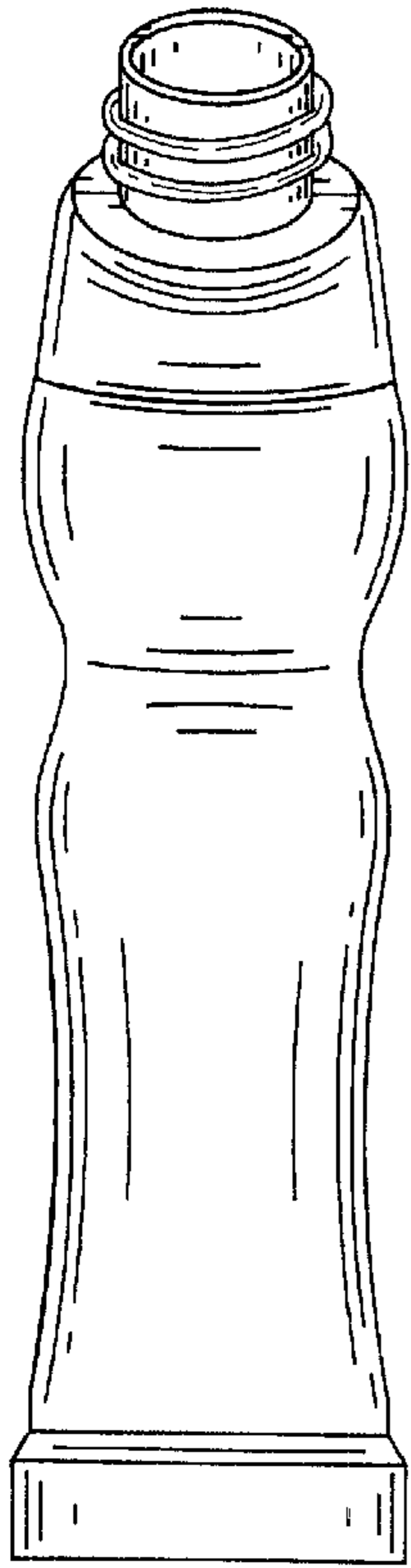

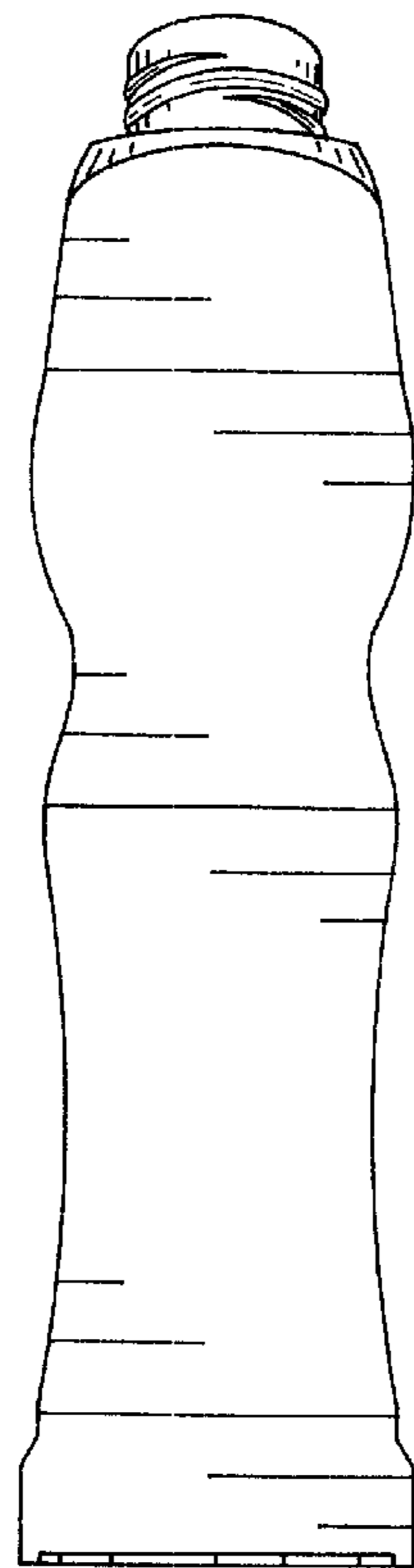

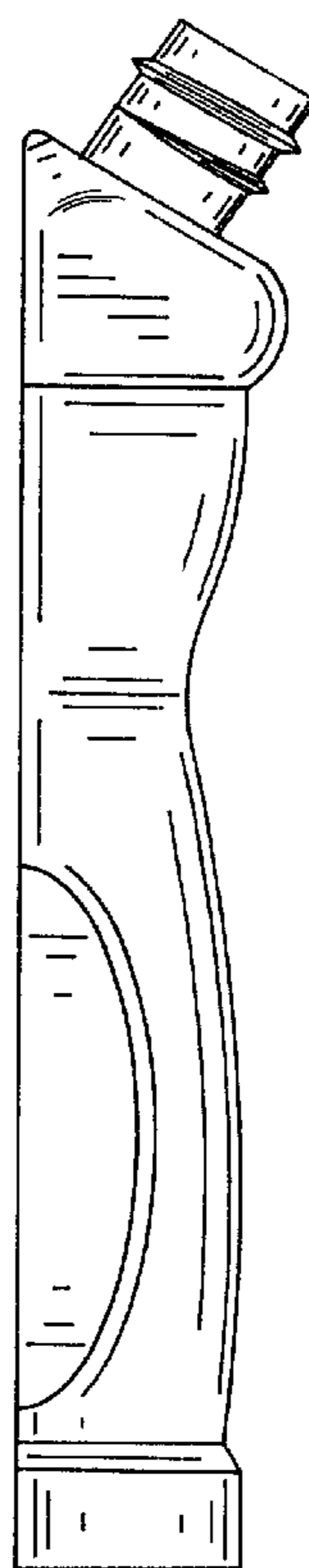

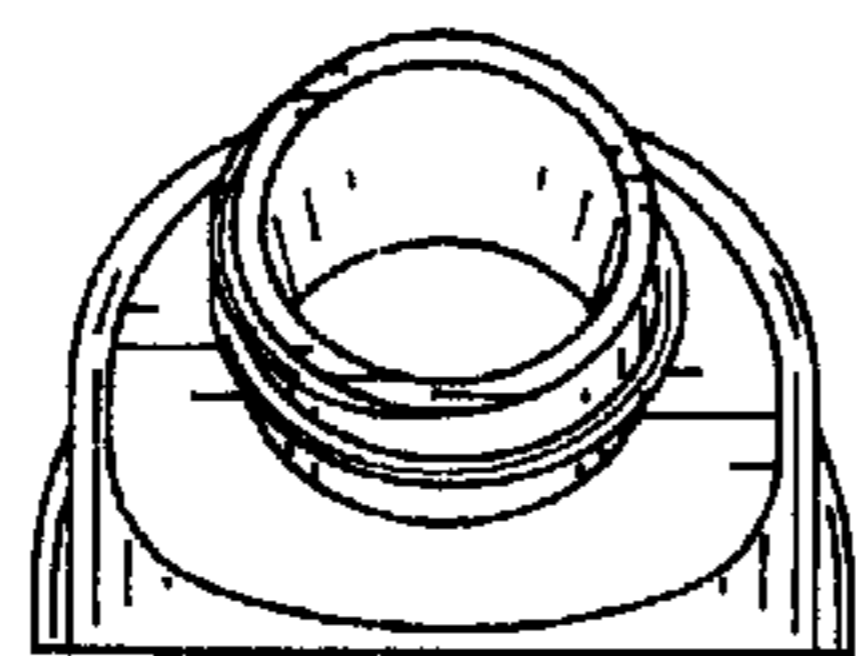

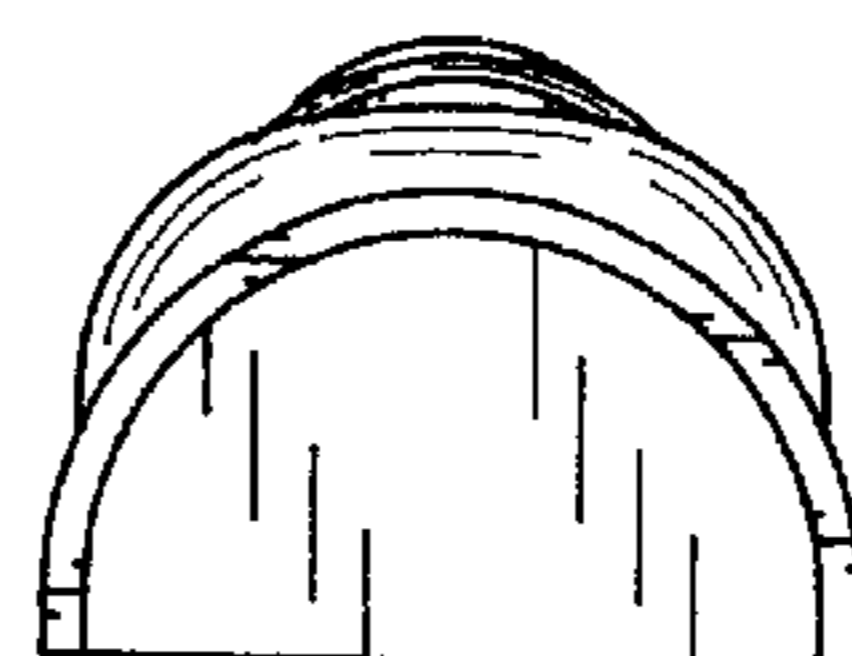
