(57) **CLAIM**

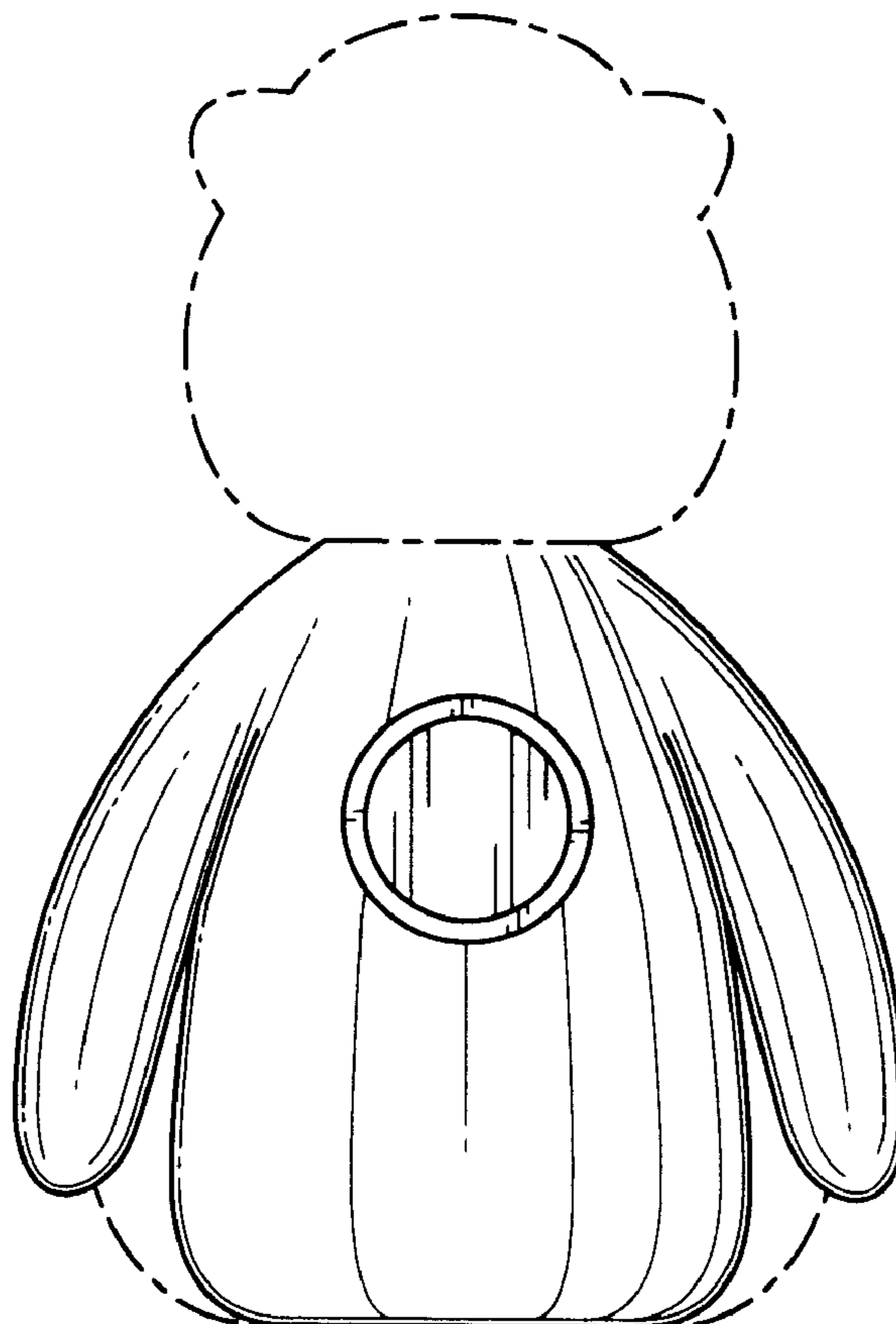
The ornamental design for a plush toy with back article, as shown as described above.

**DESCRIPTION**

FIG. 1 is a front view of a plush toy with back article embodying my invention;  
FIG. 2 is a back view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a top view thereof; and,  
FIG. 6 is a bottom view thereof.

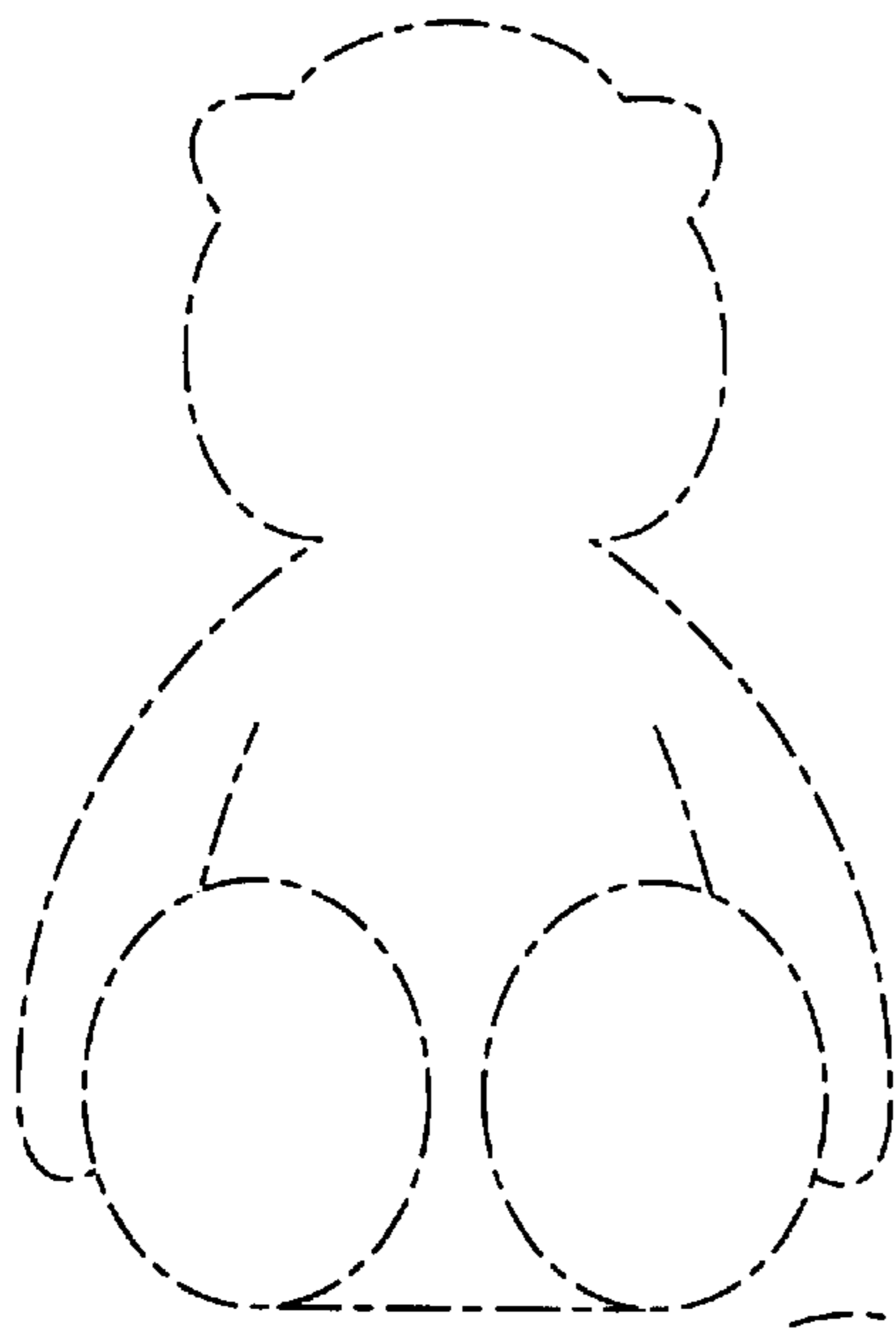

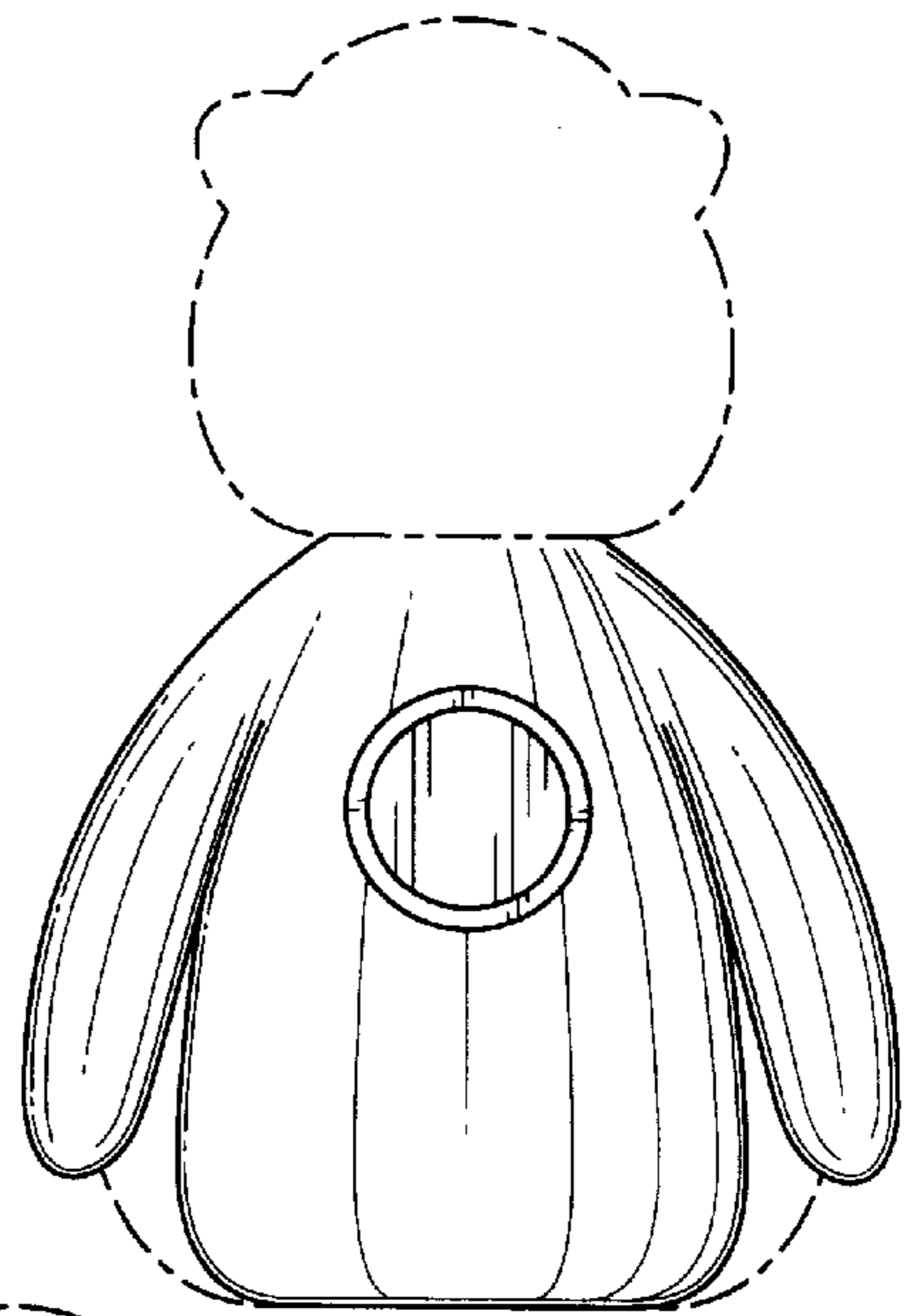

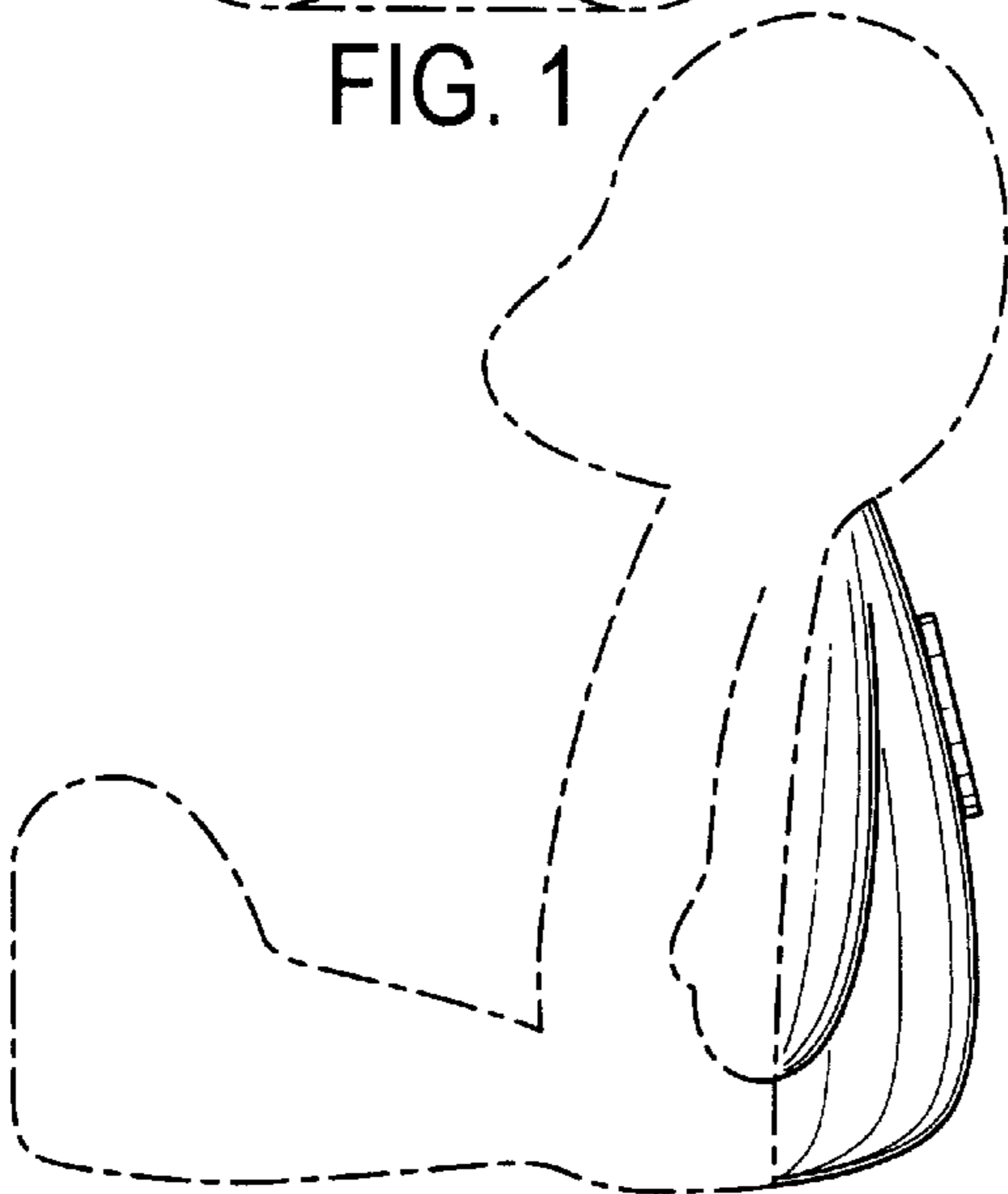

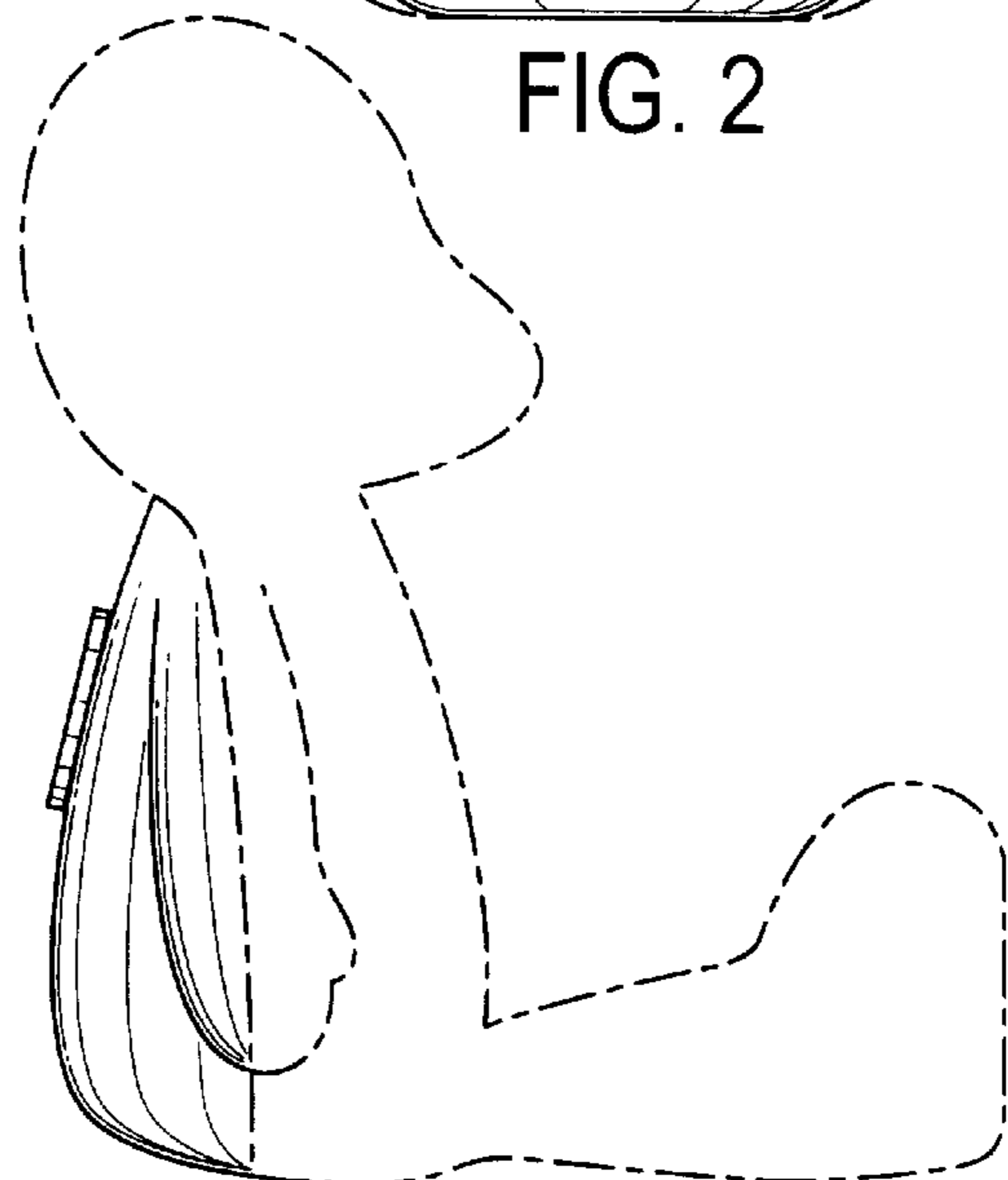

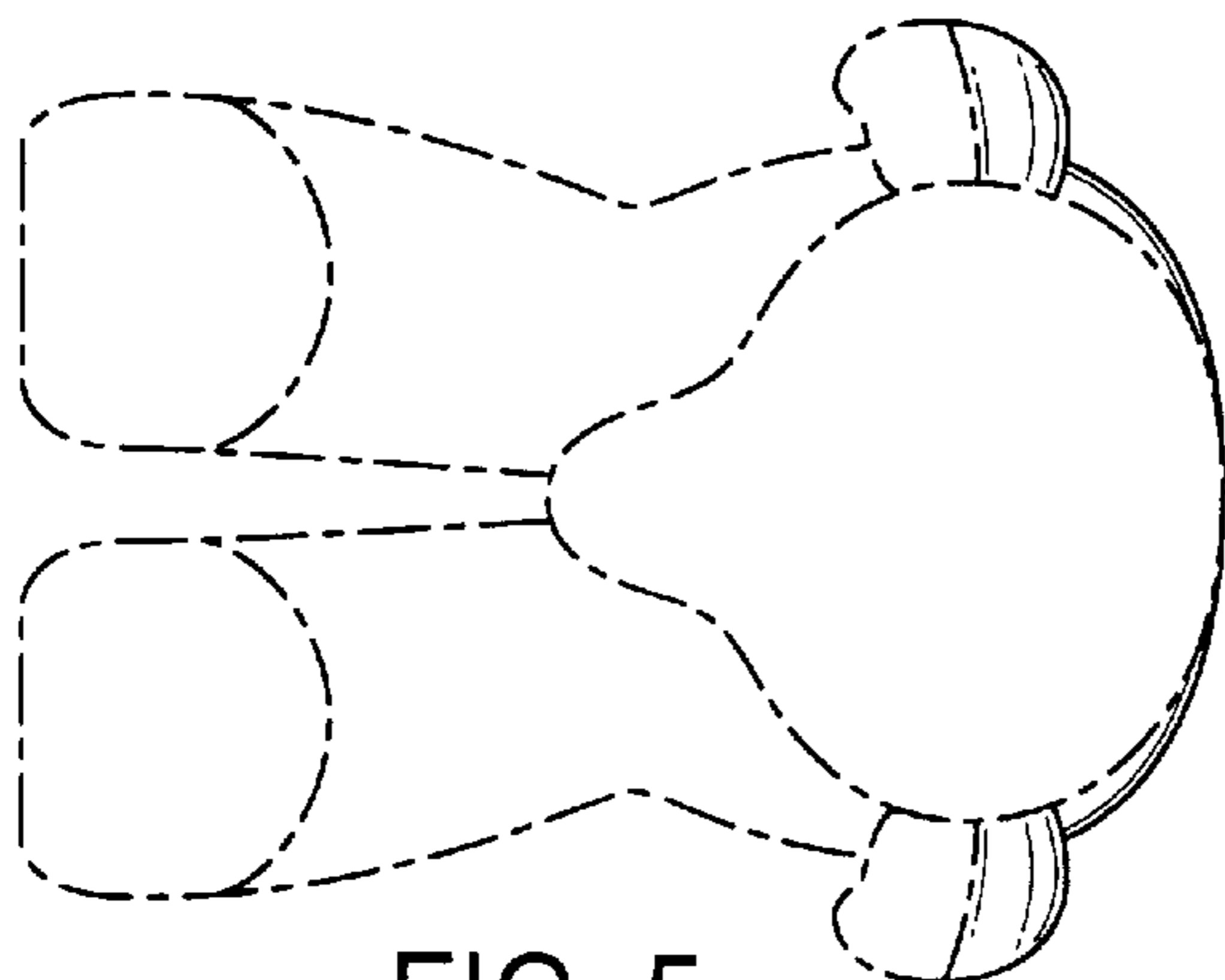

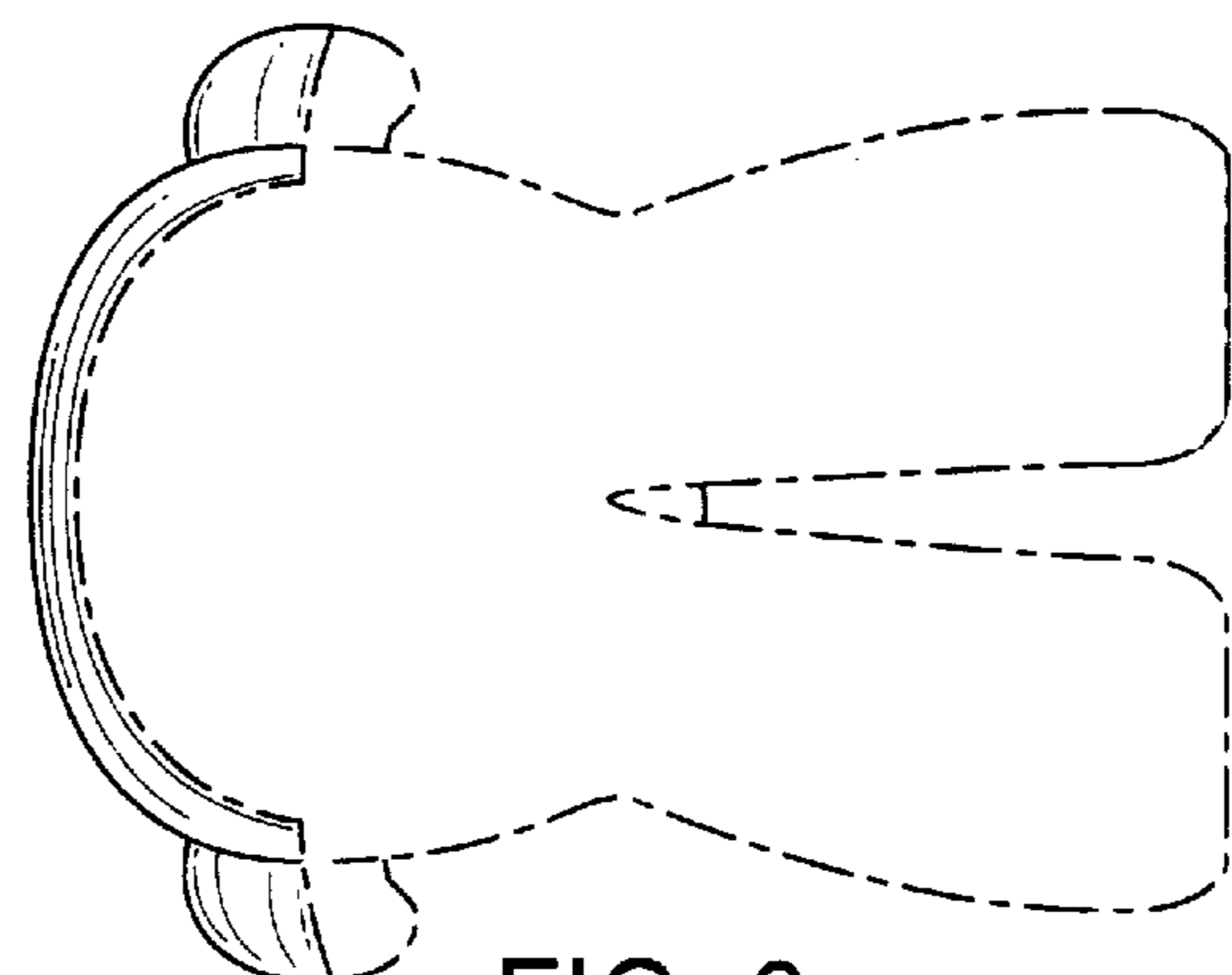
