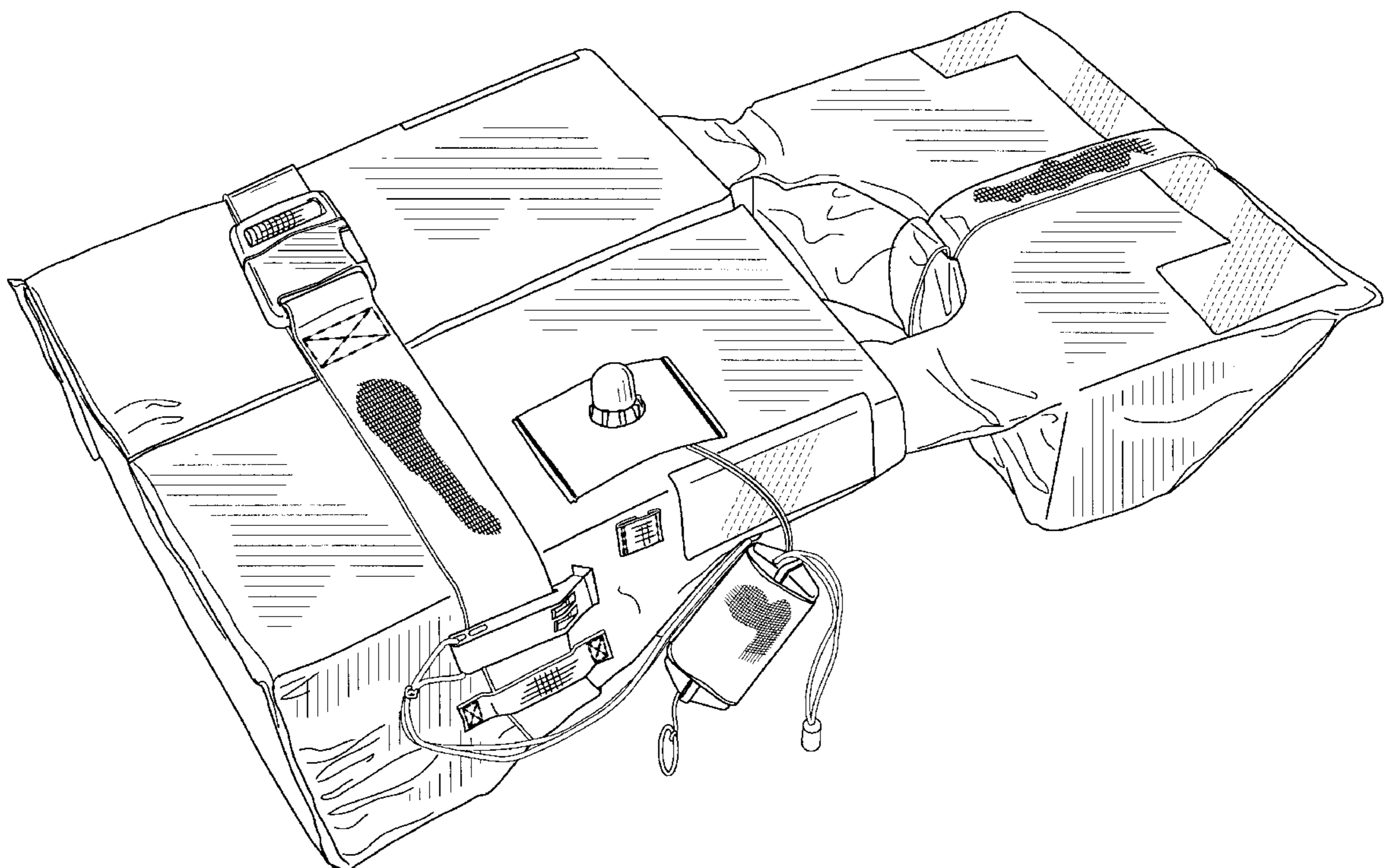
FIG. 1 is a perspective view of a life jacket showing my new design in a first configuration;

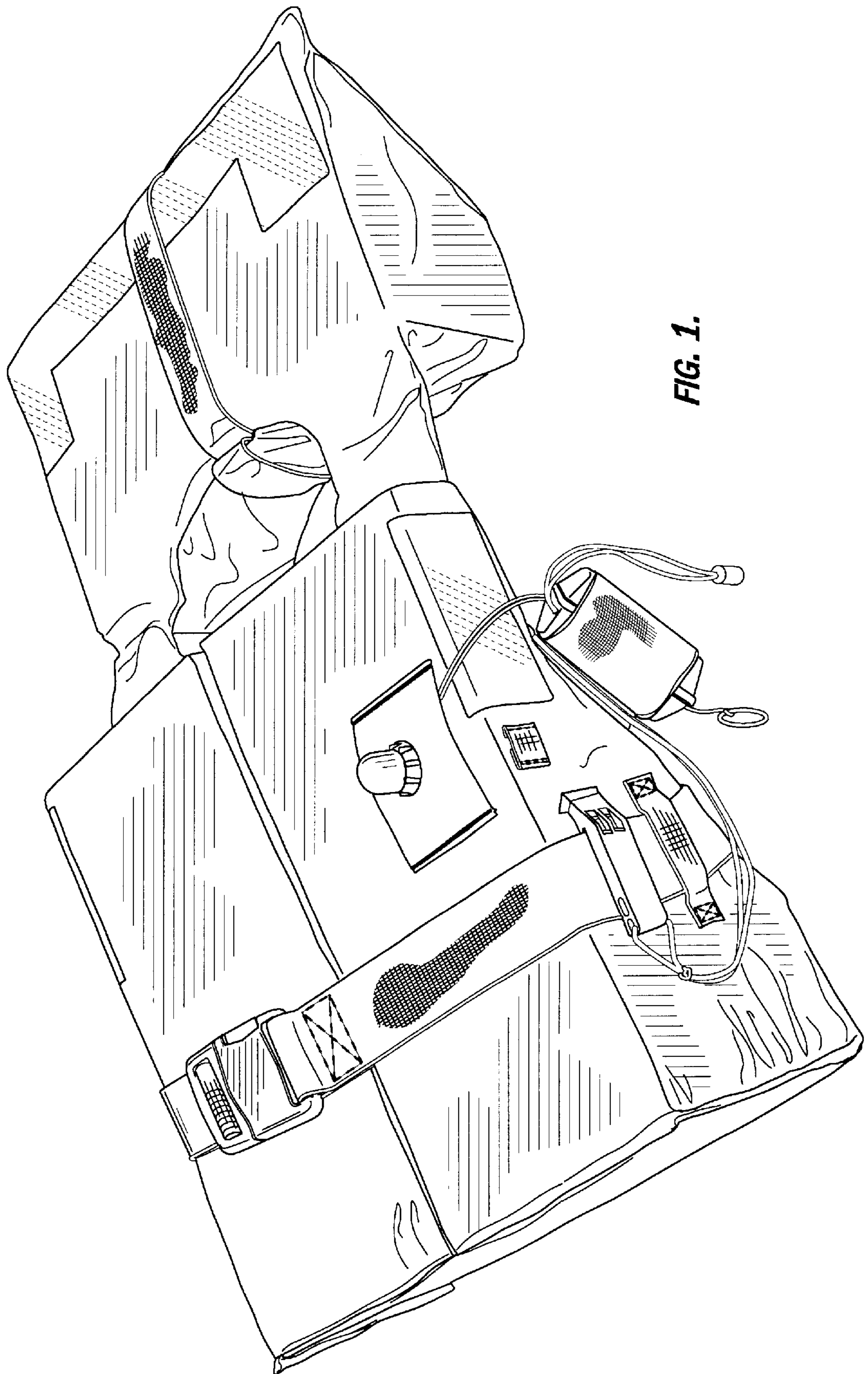

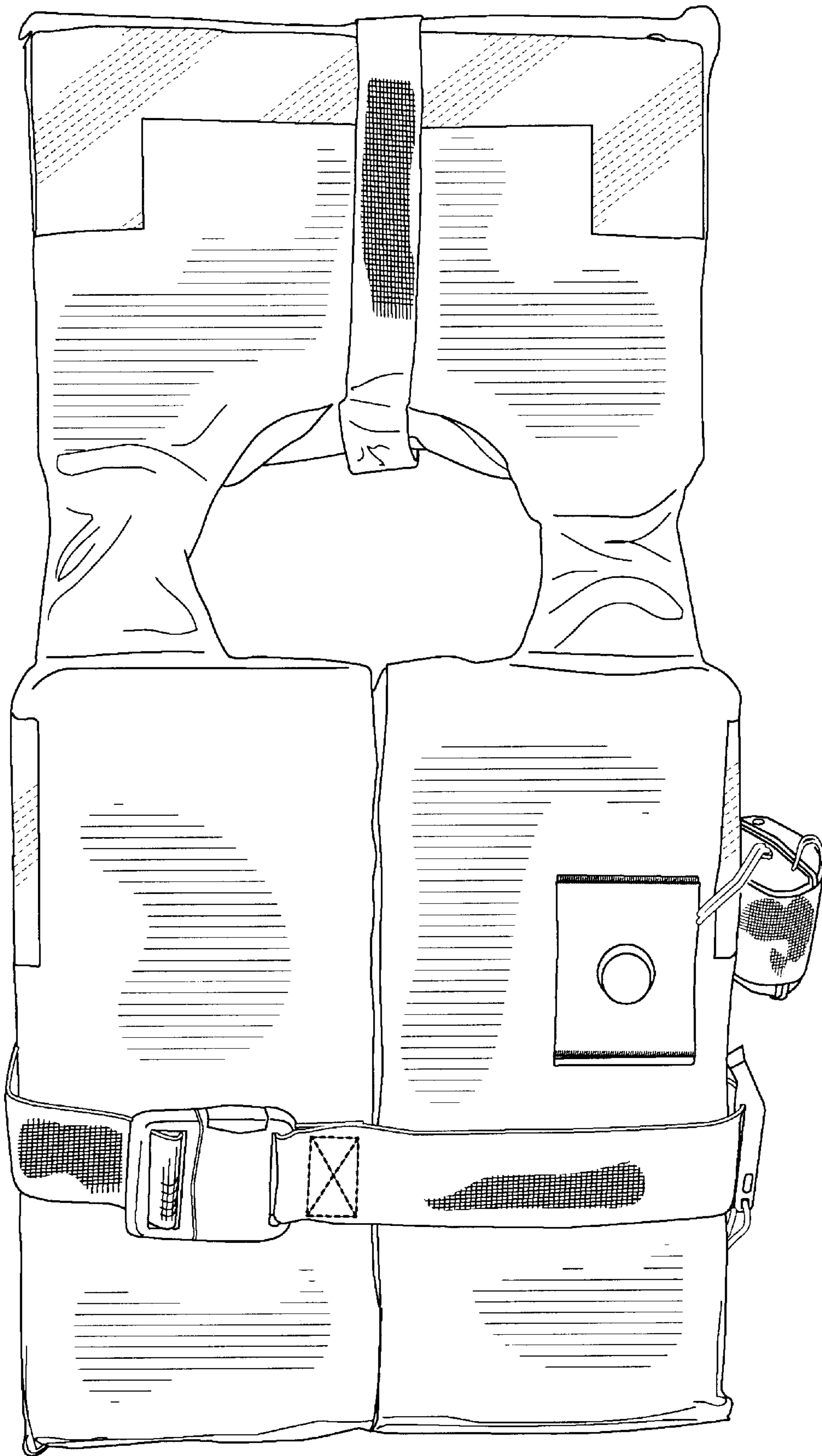

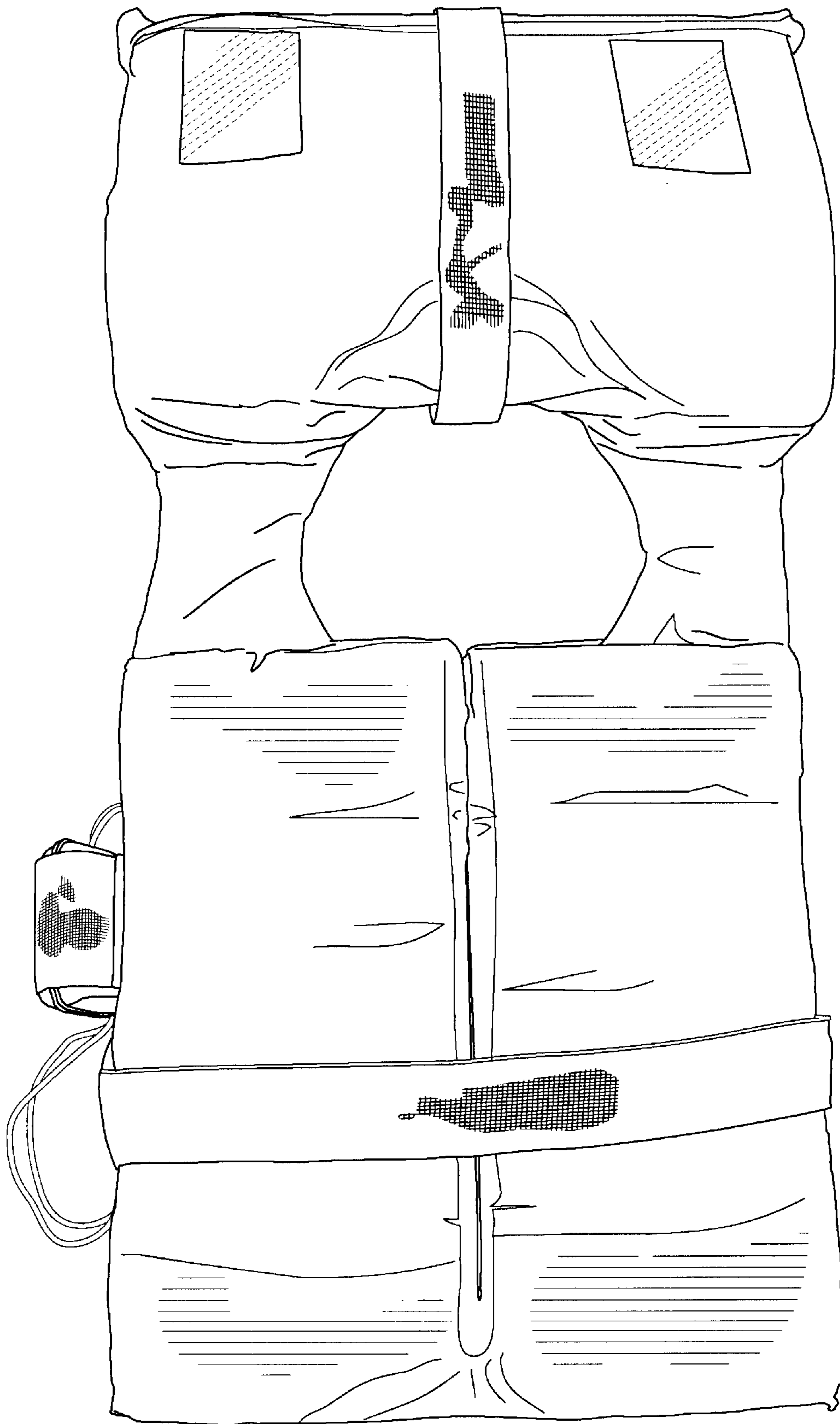

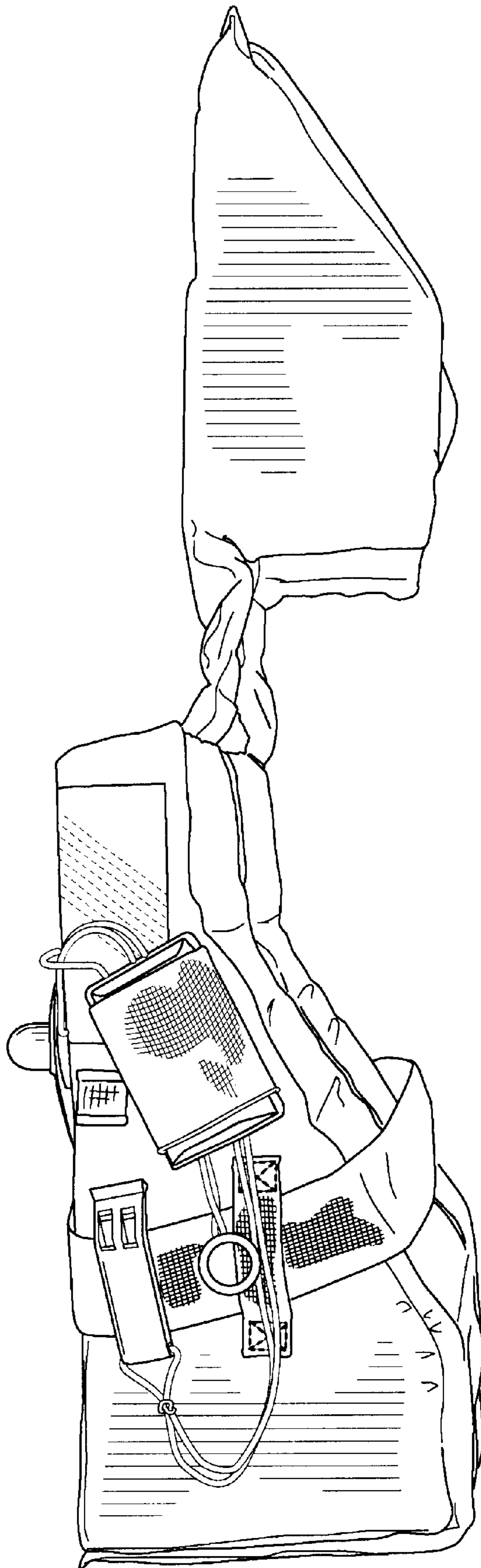

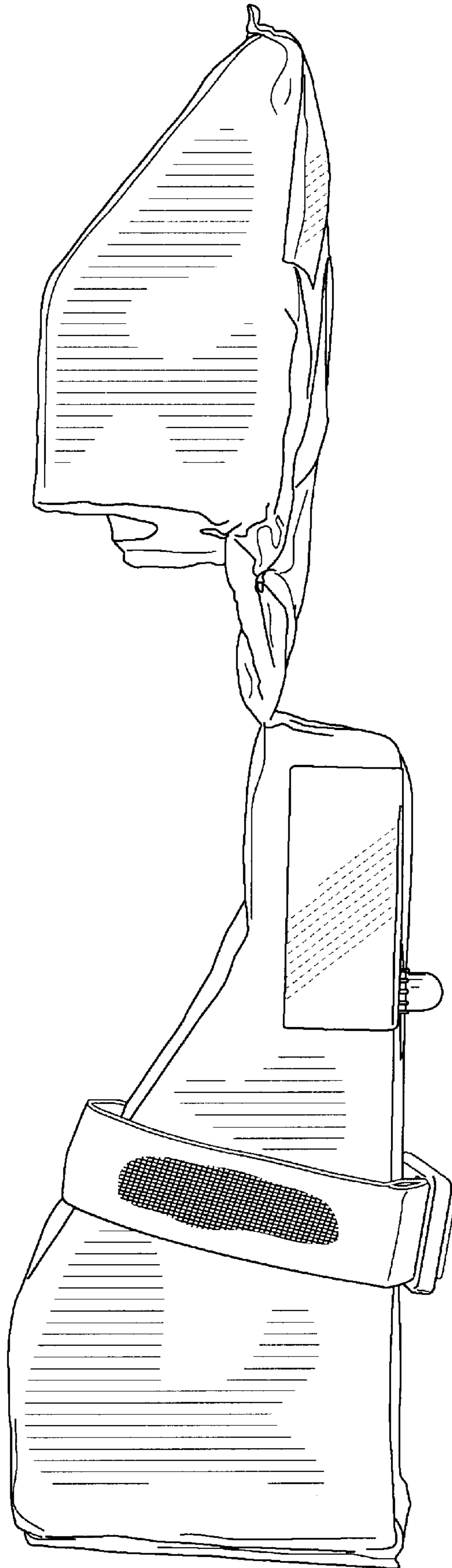

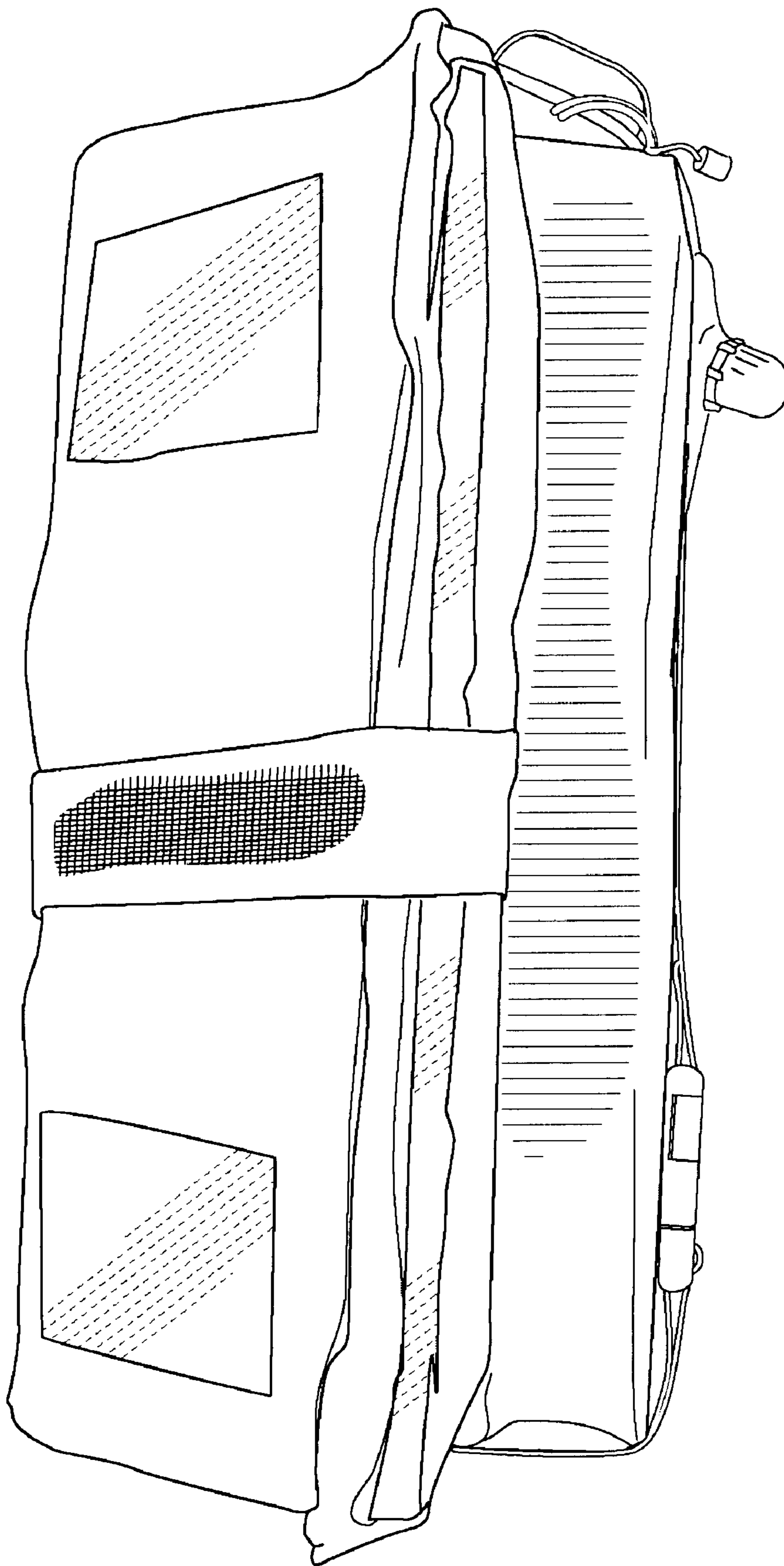

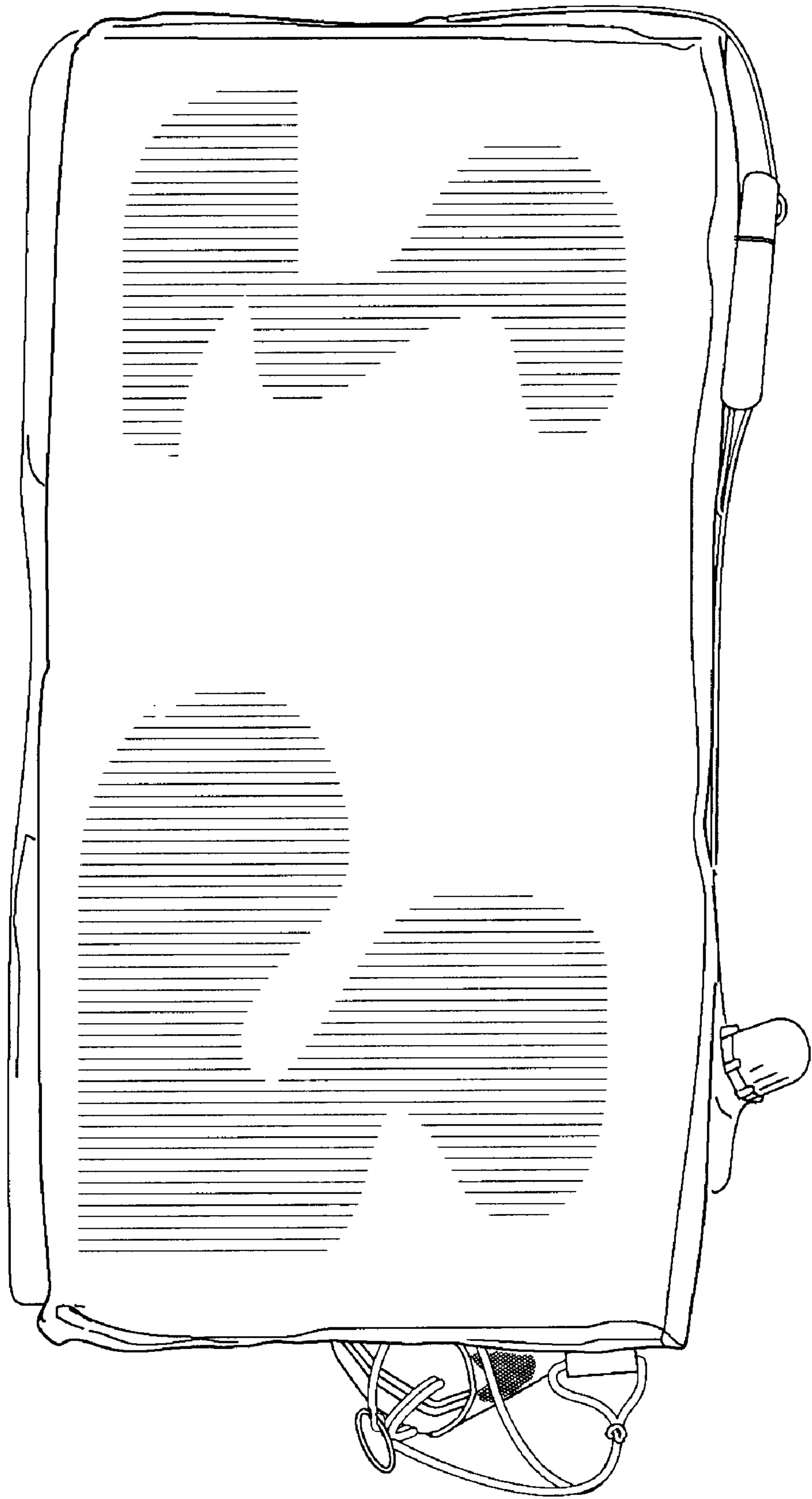

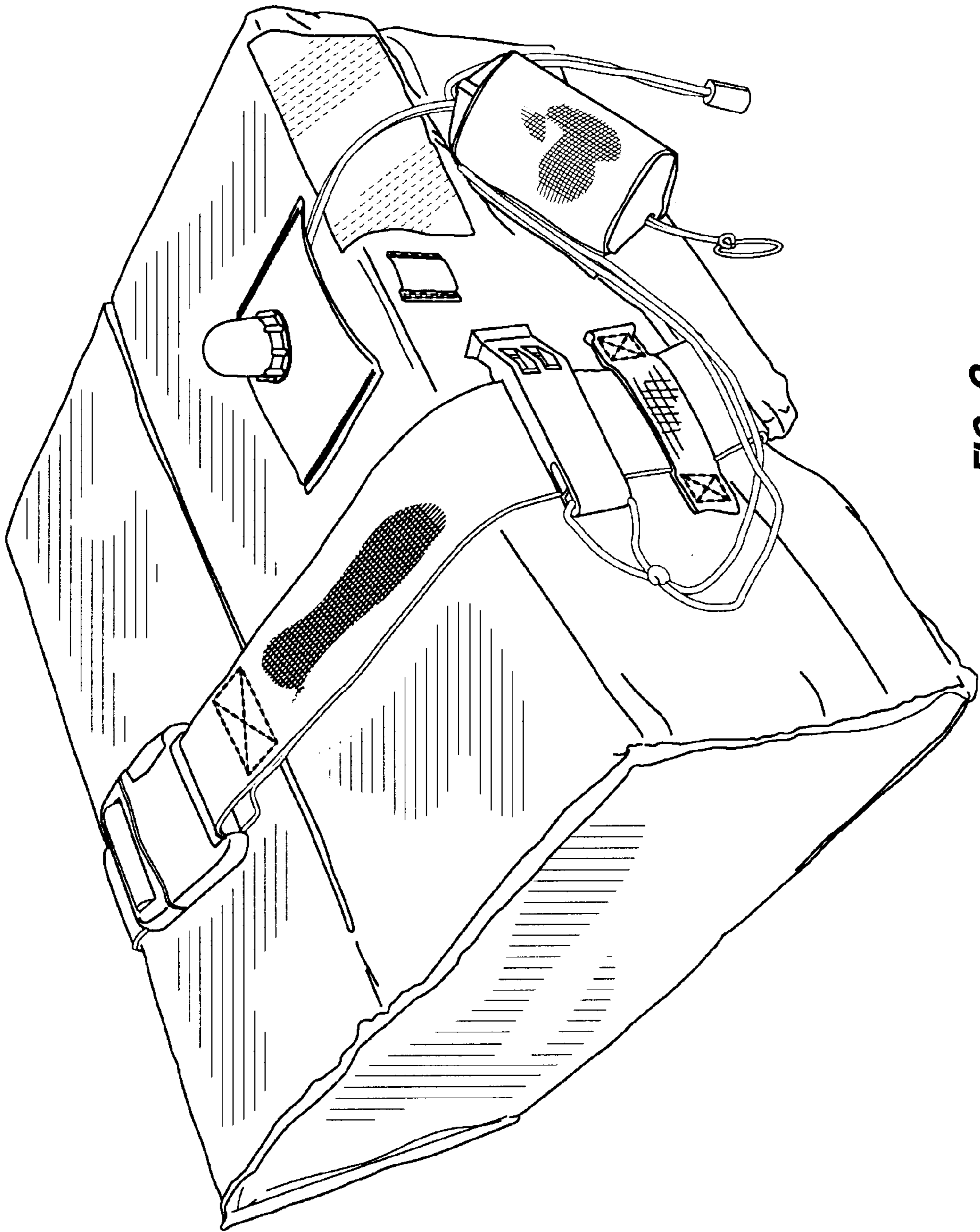

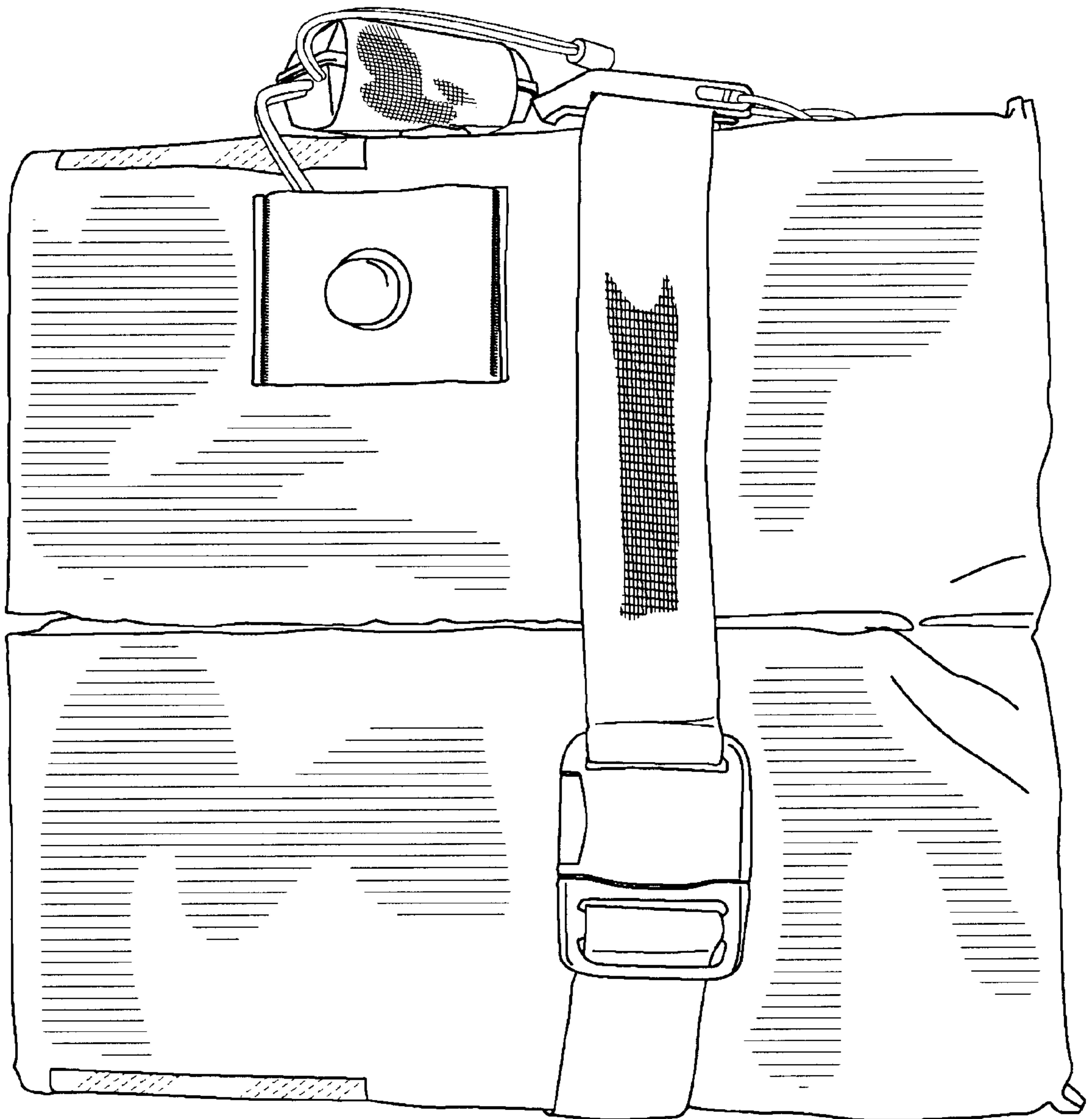

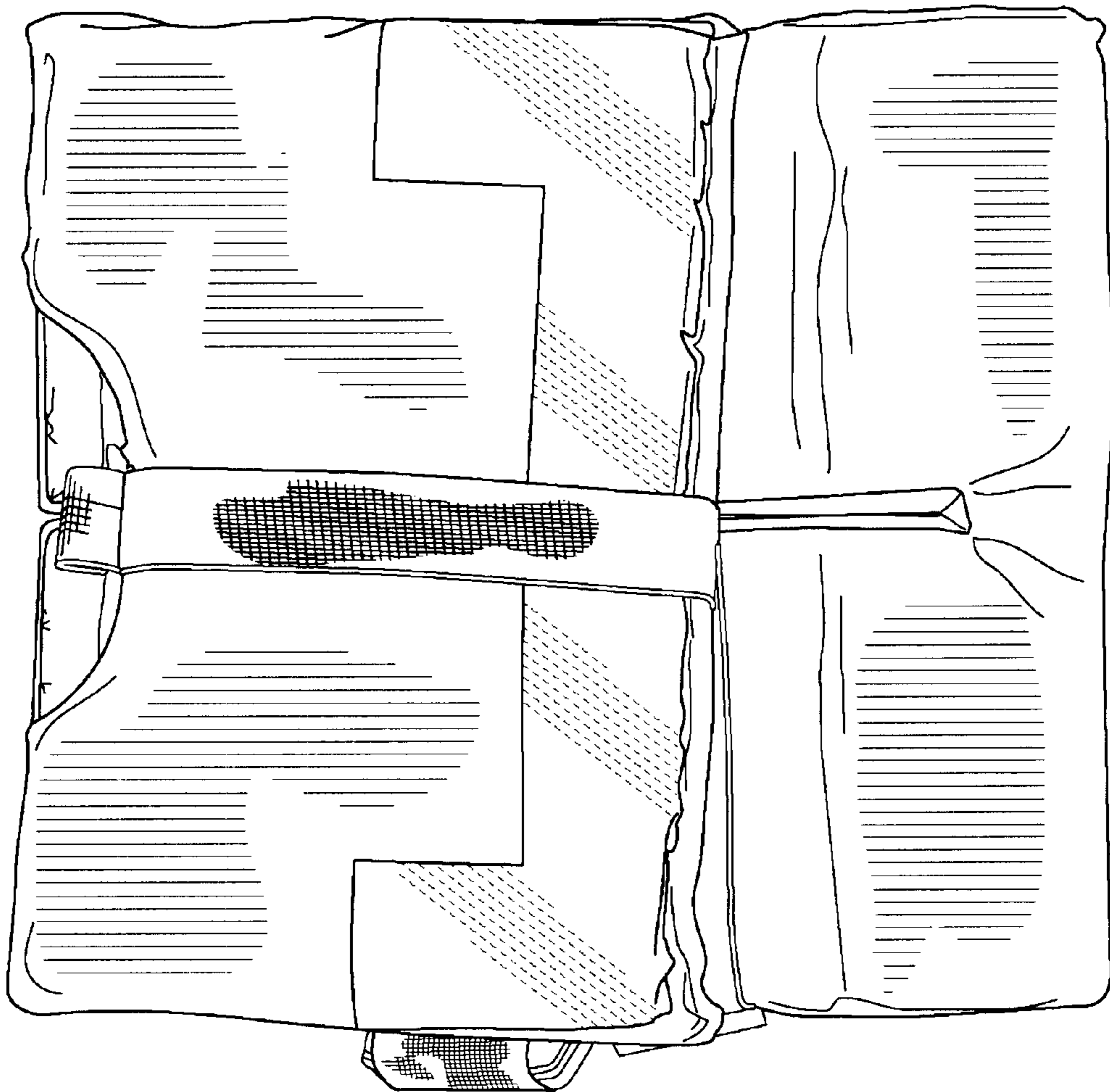

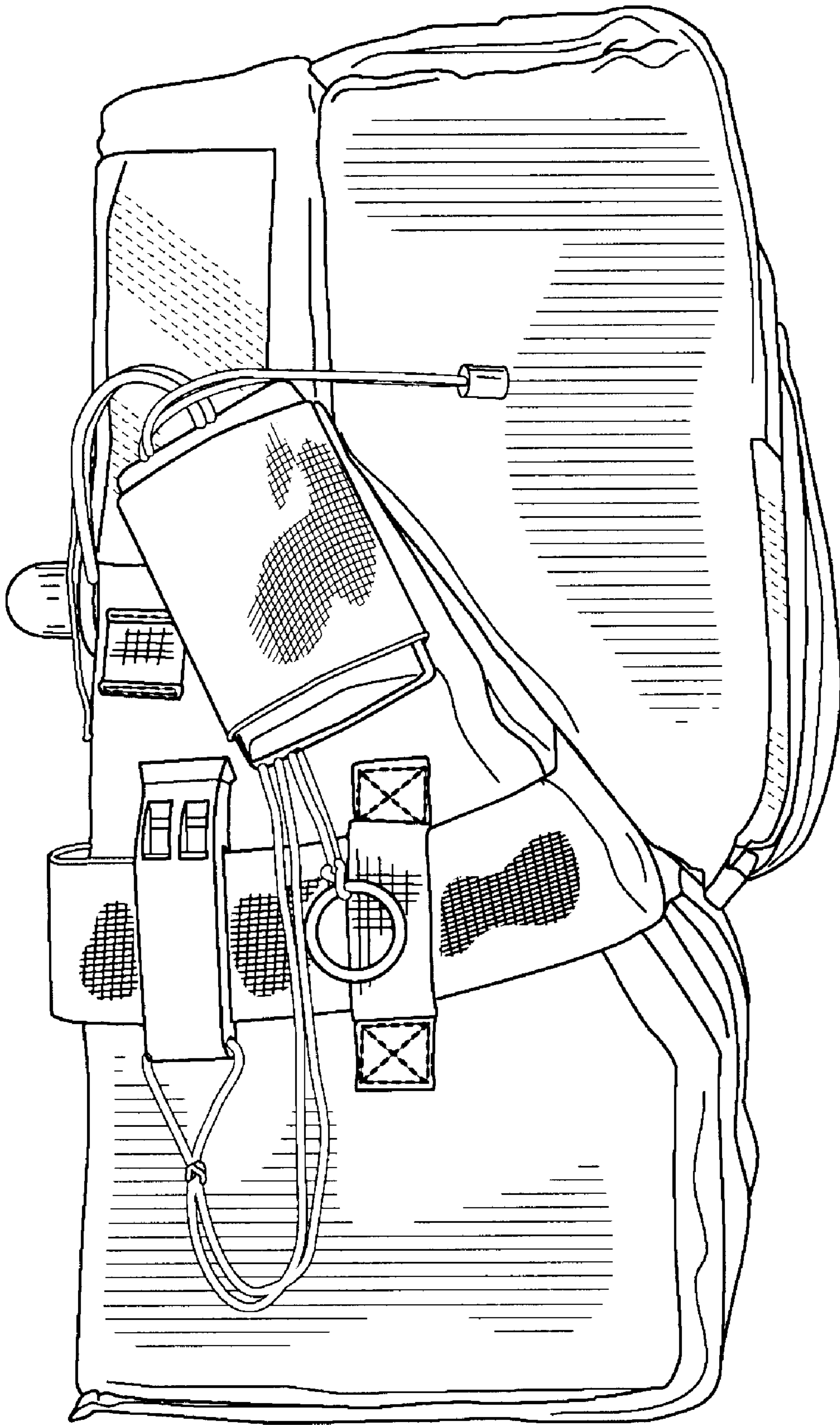

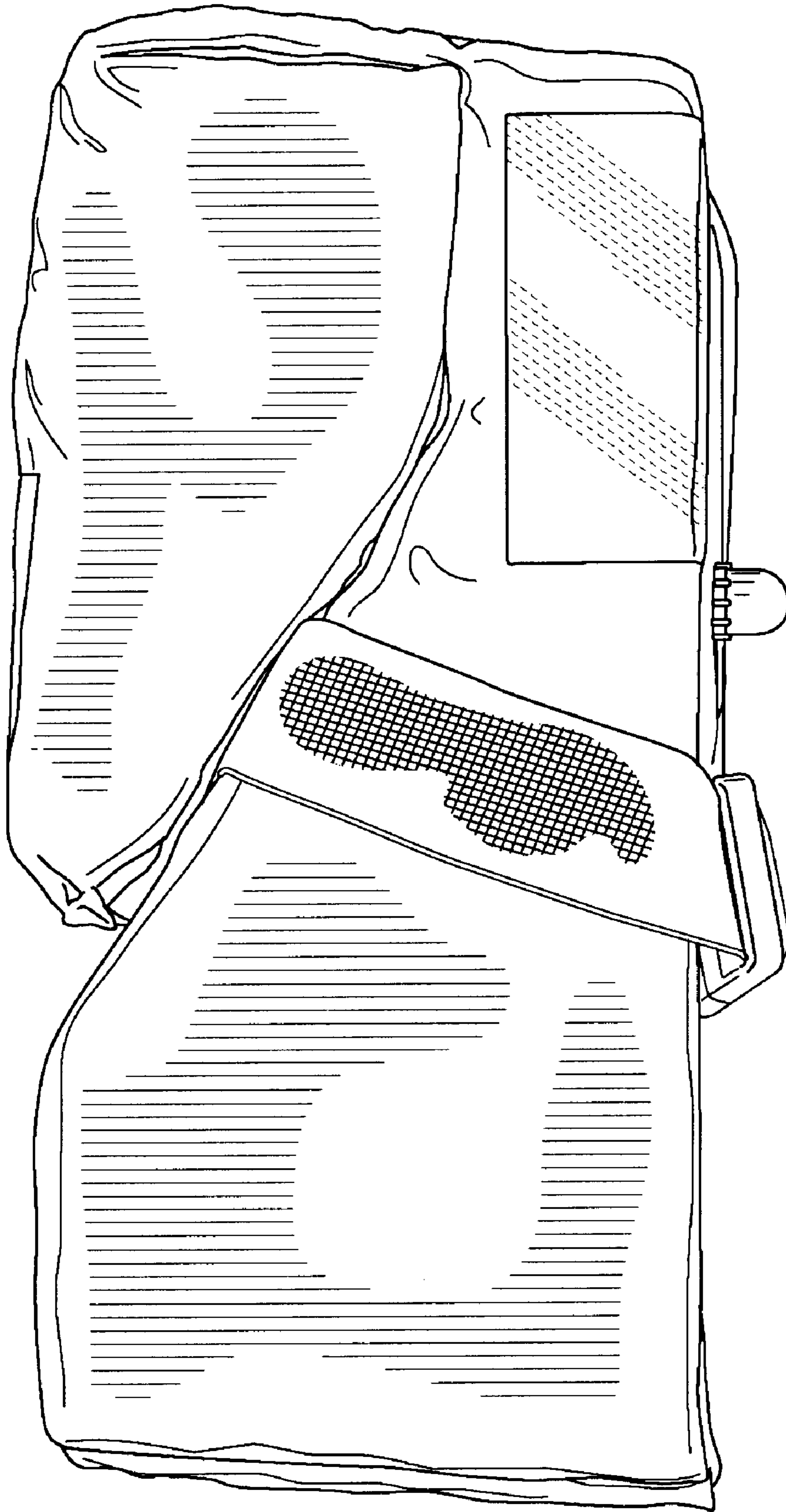

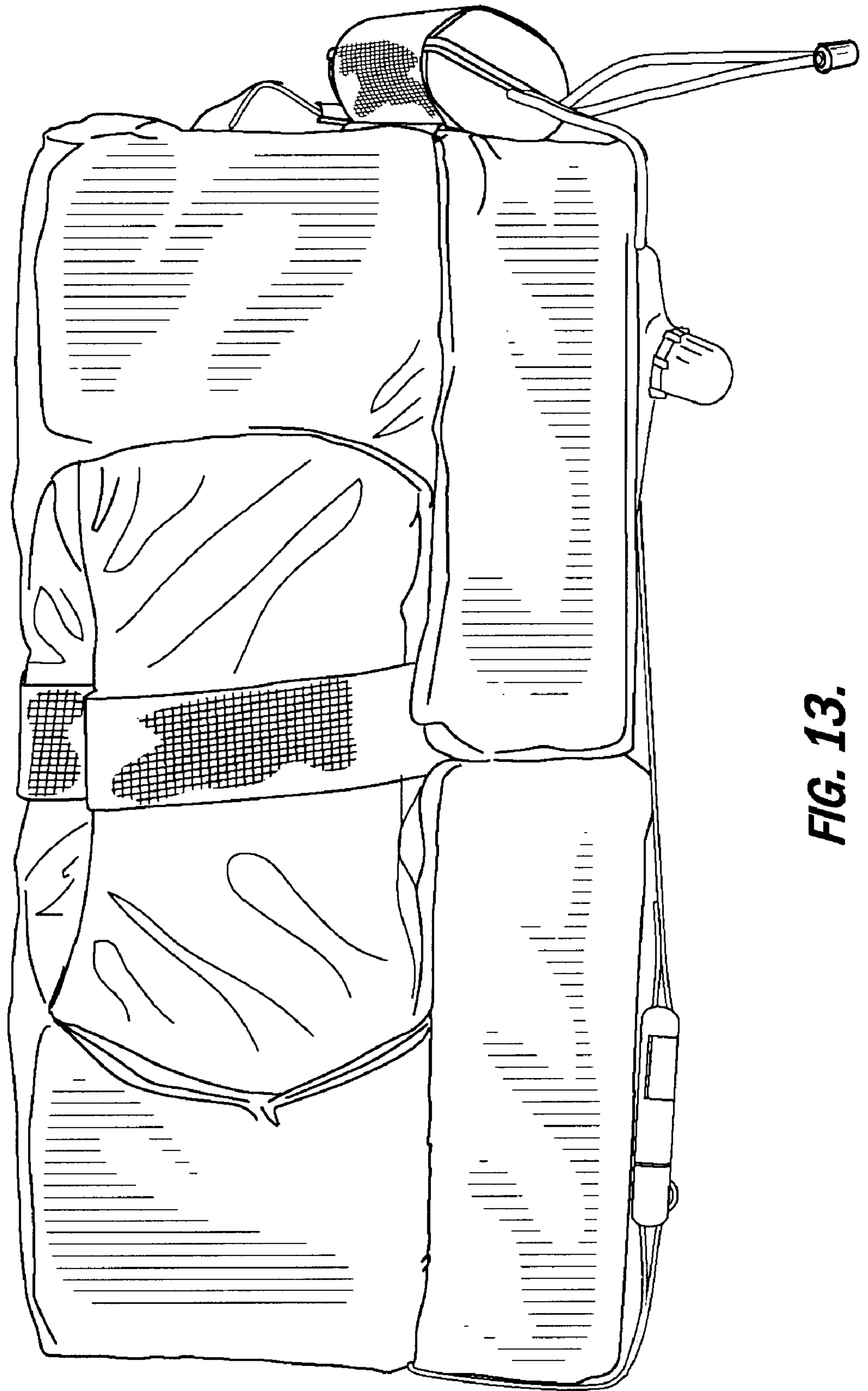
