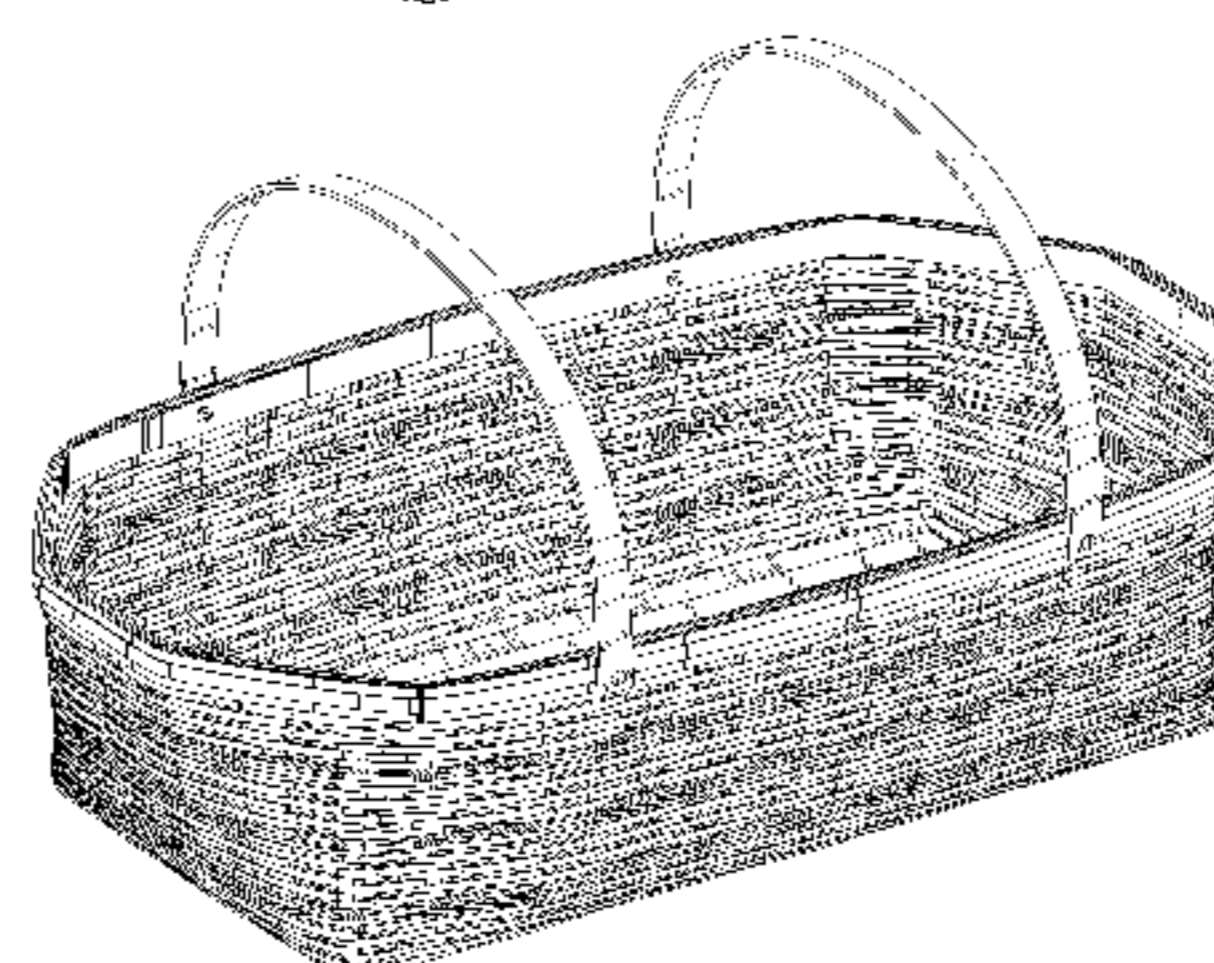
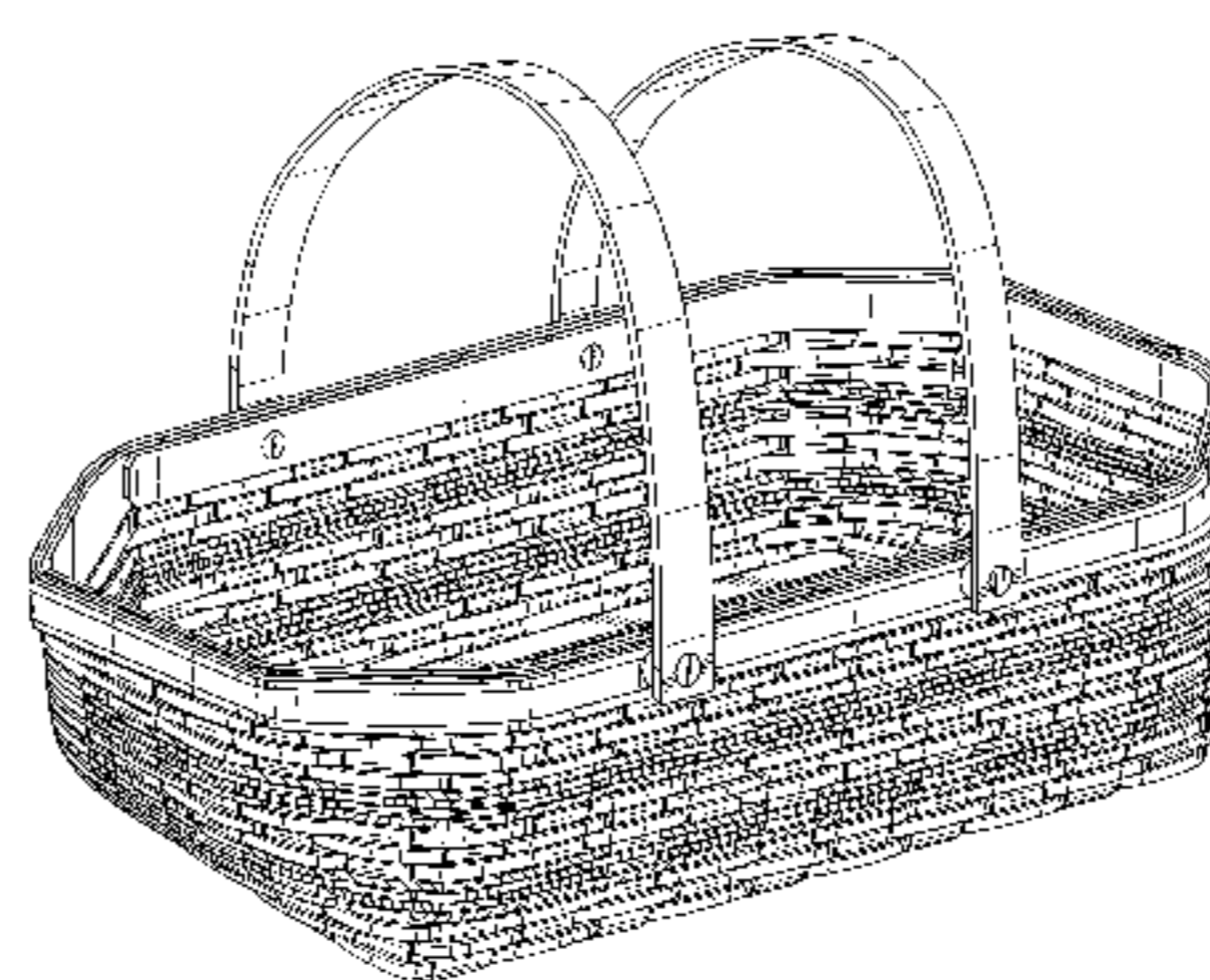


FIG. 15 is a perspective view of another embodiment of our design, having an appearance identical to that of FIG. 8 except for the presence of color contrast;

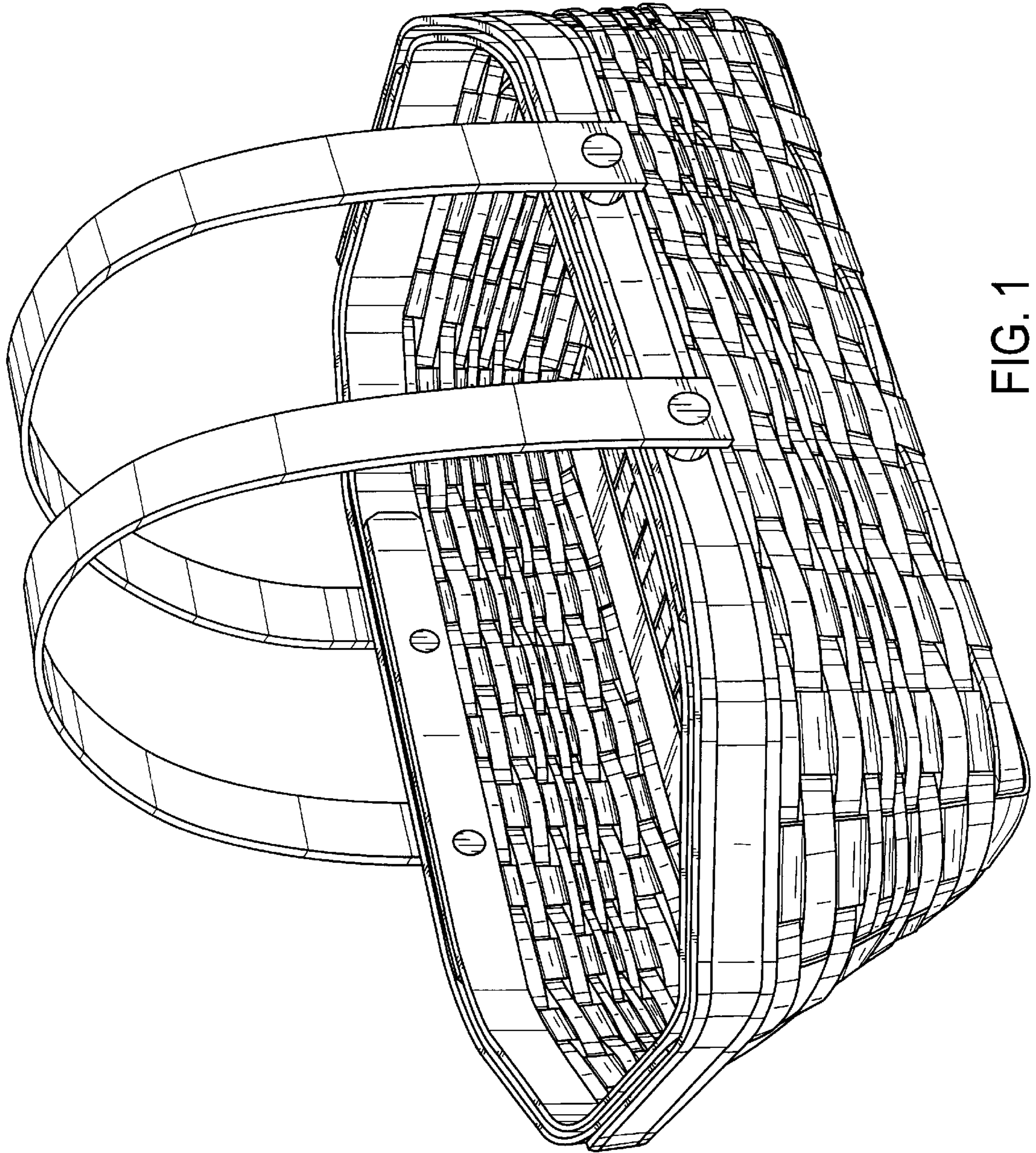

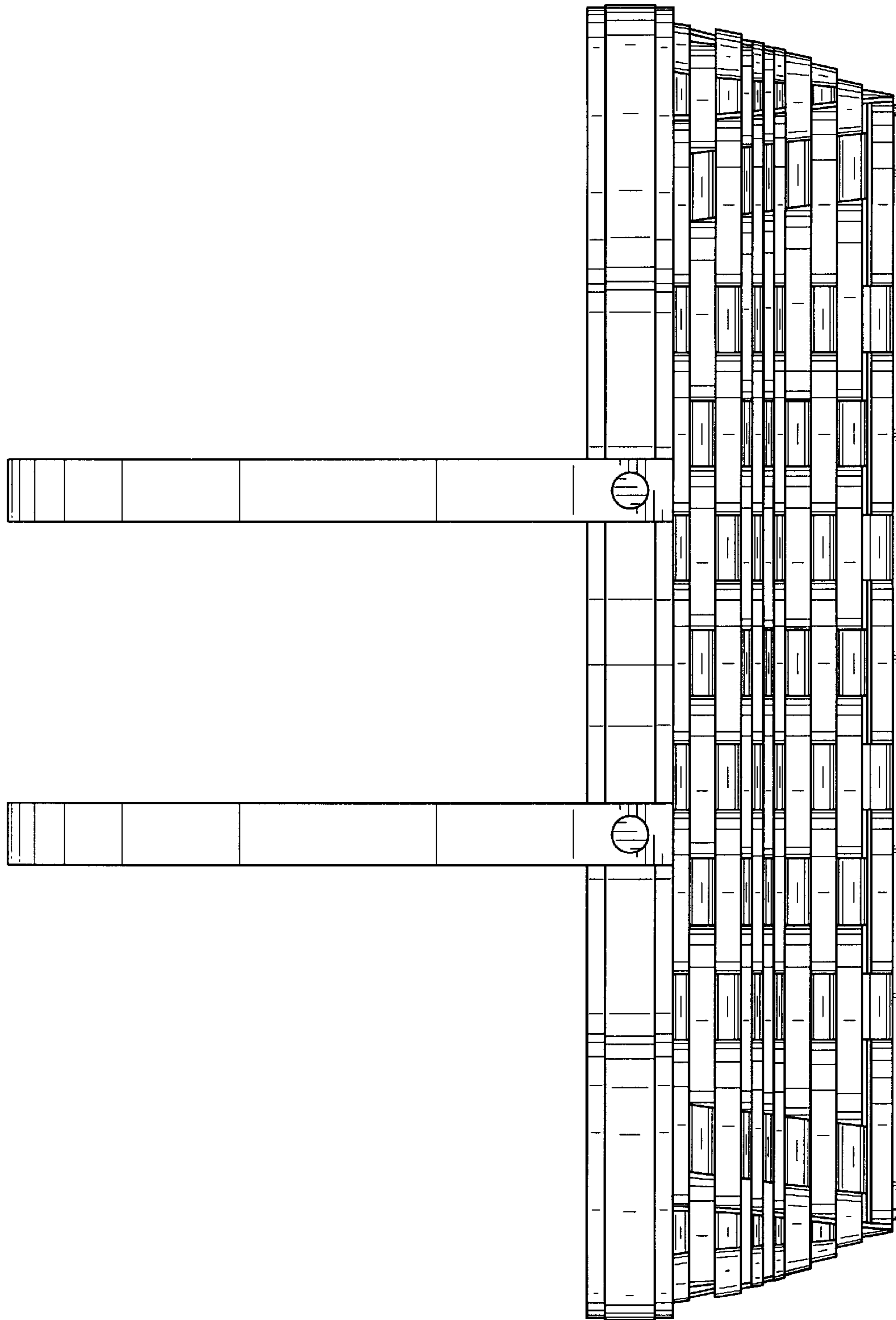

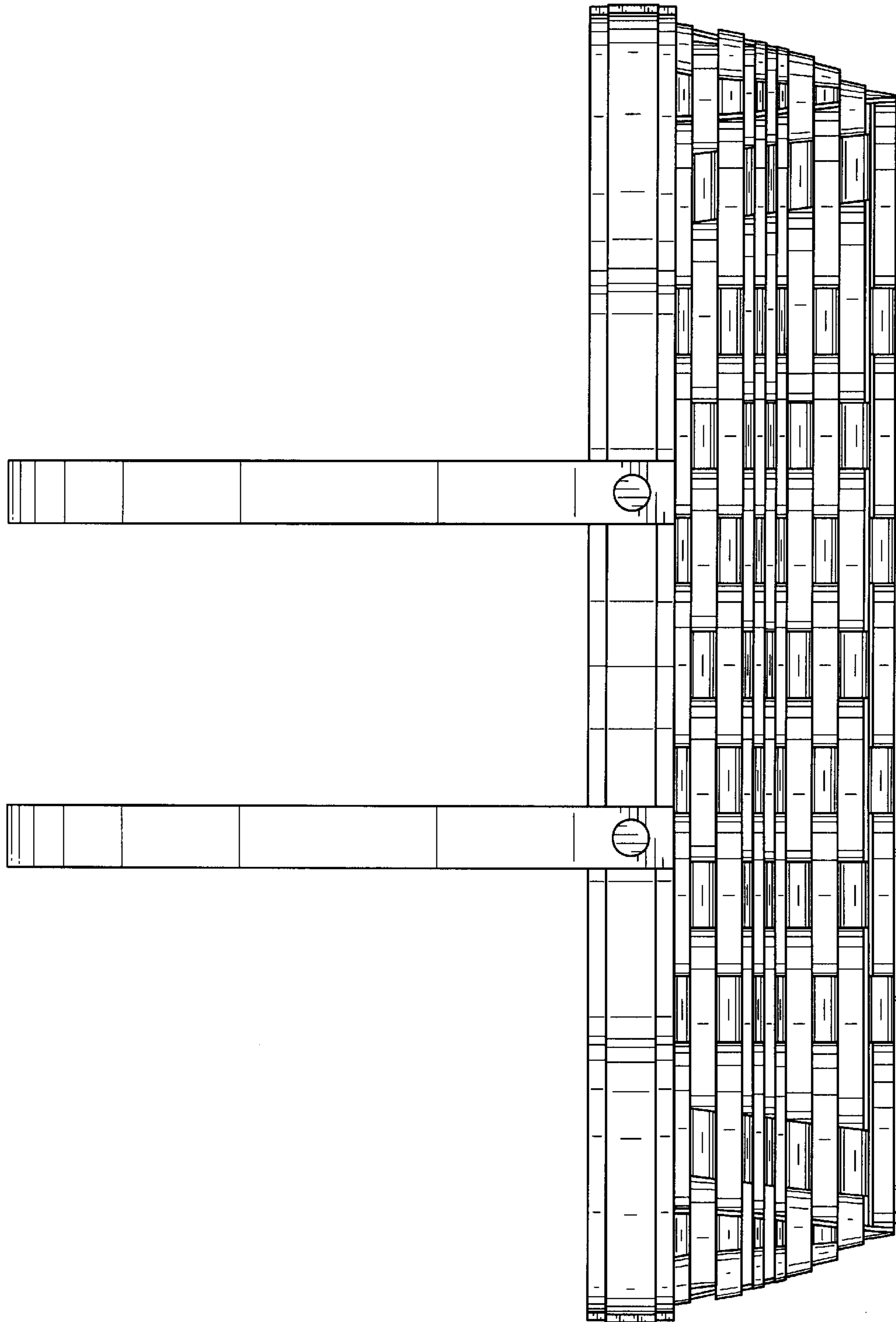

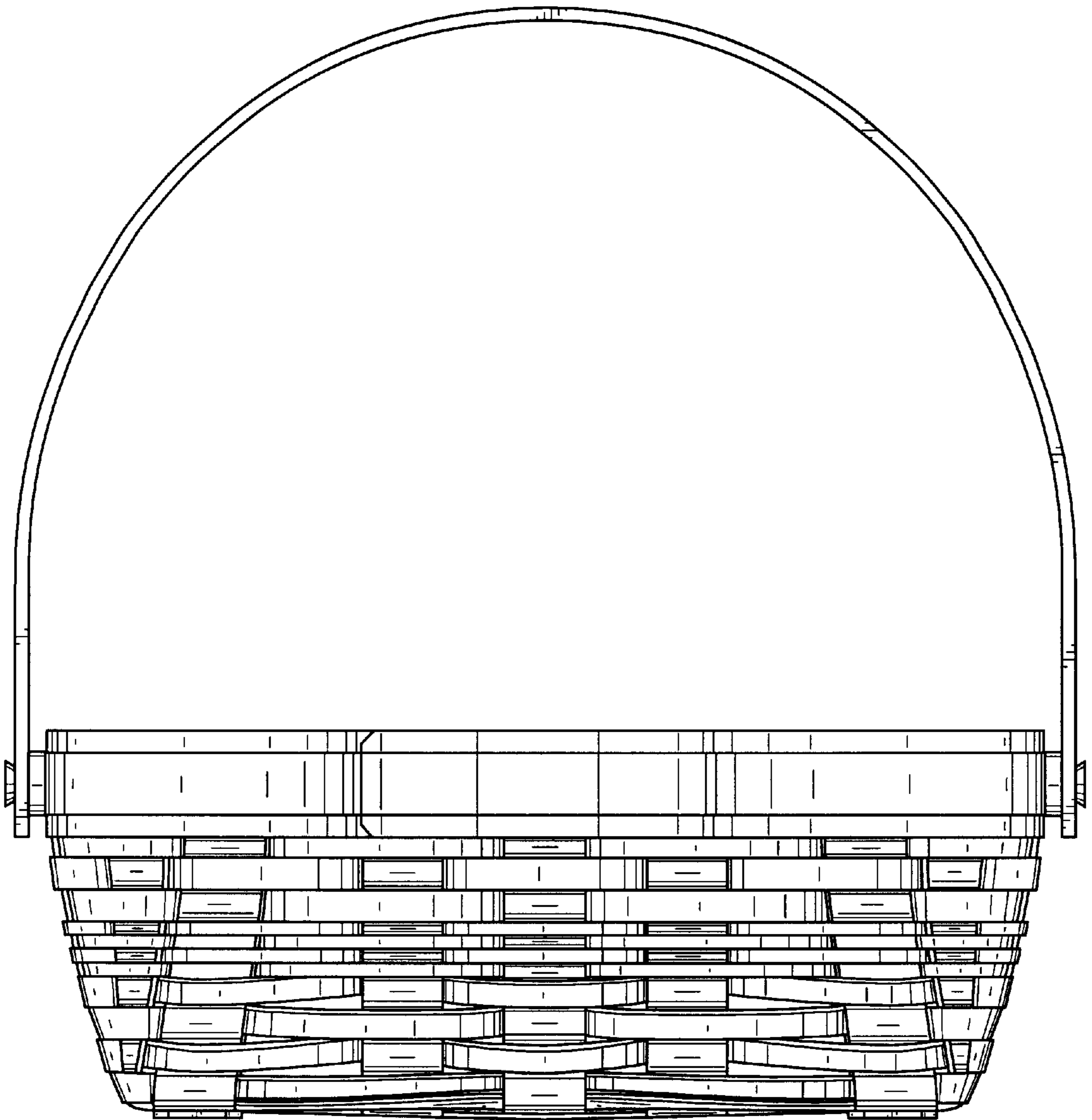

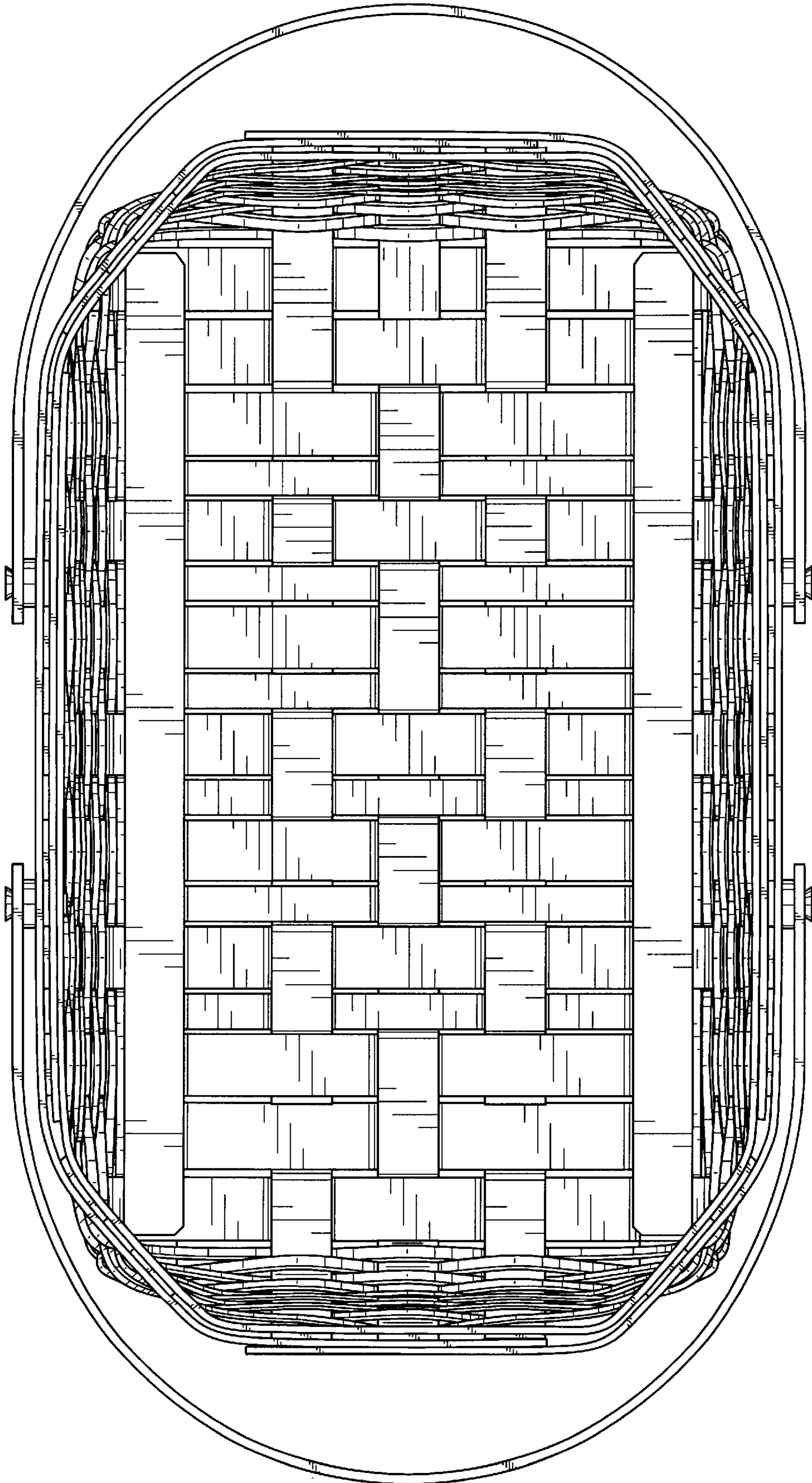

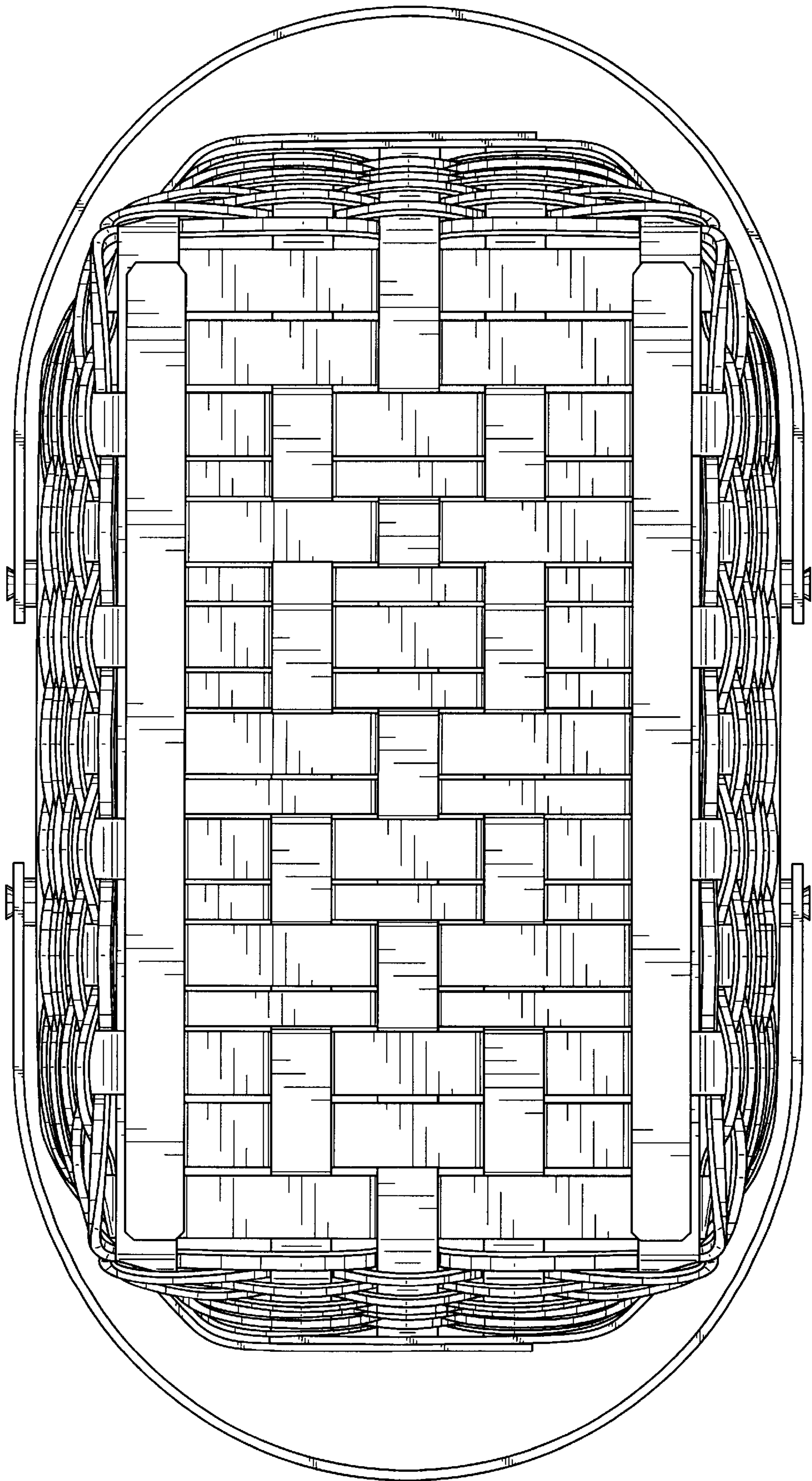

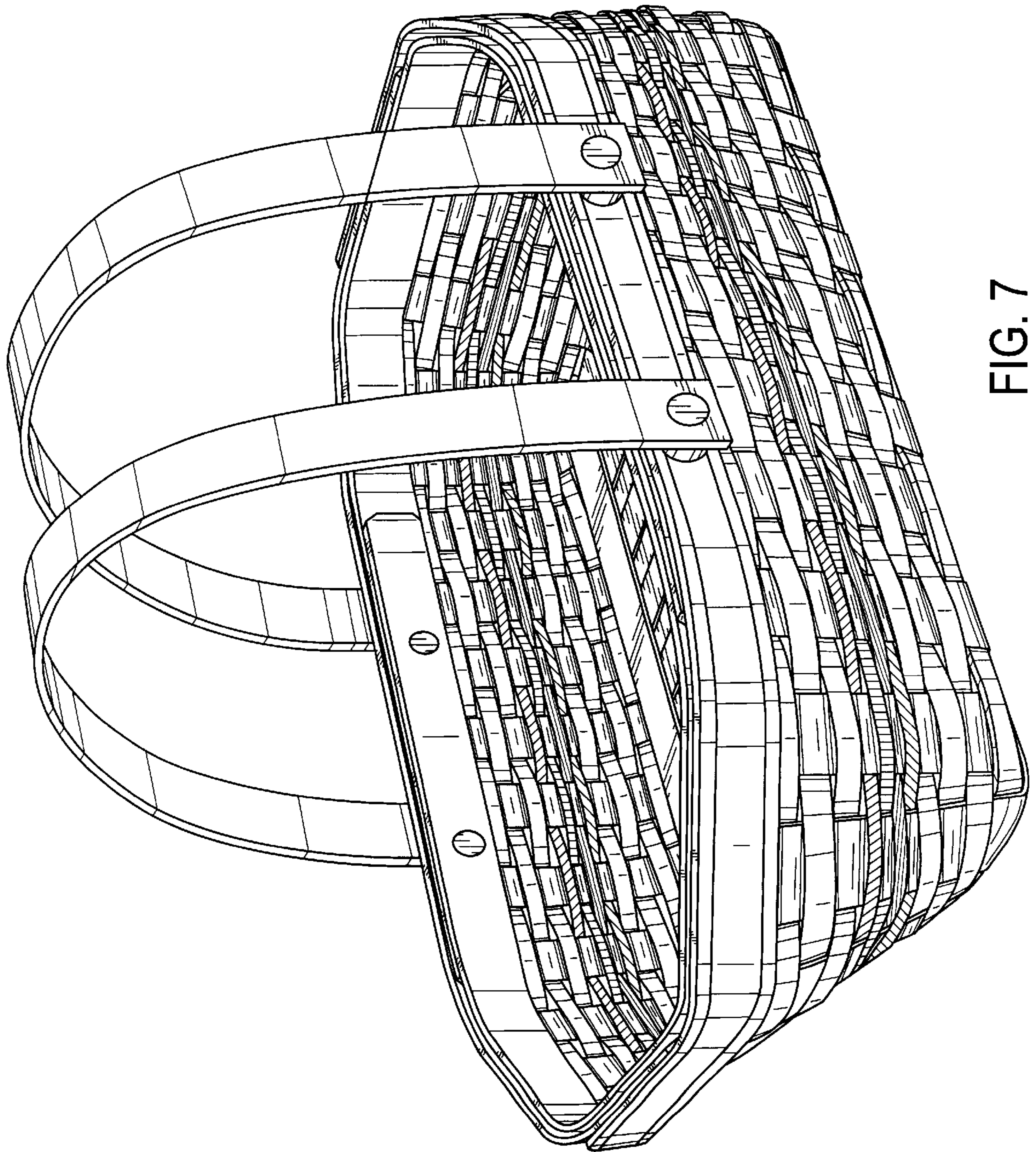

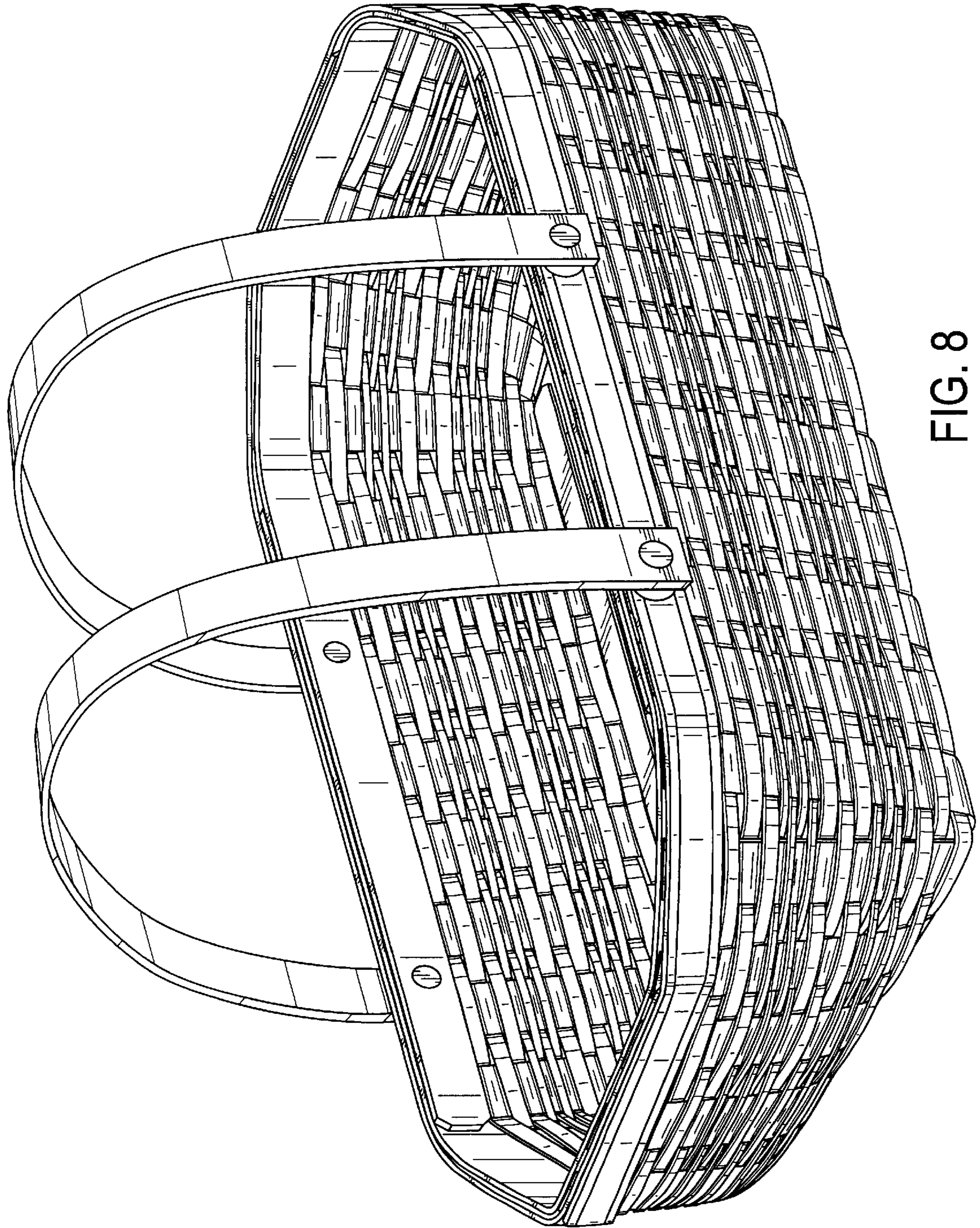

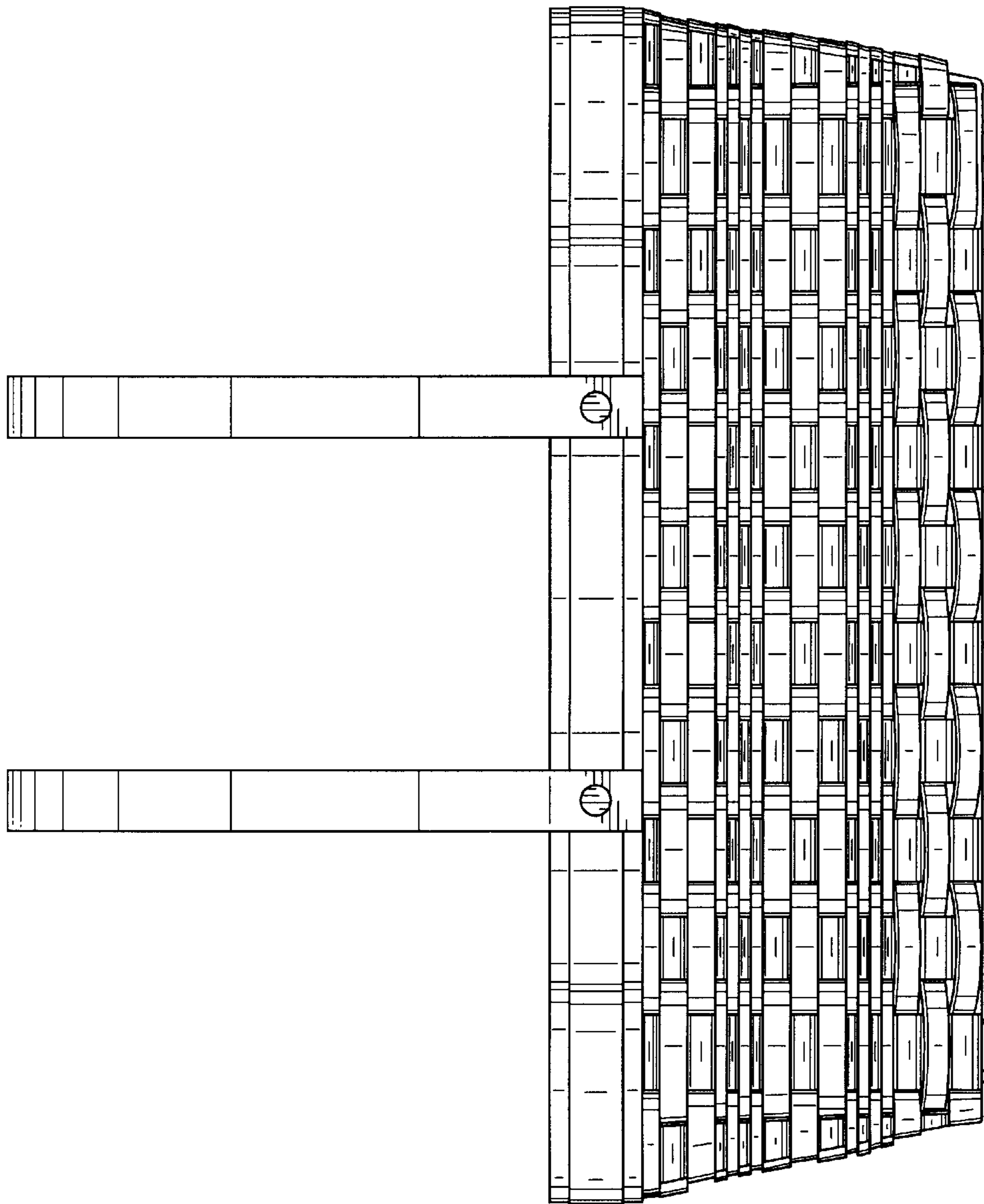

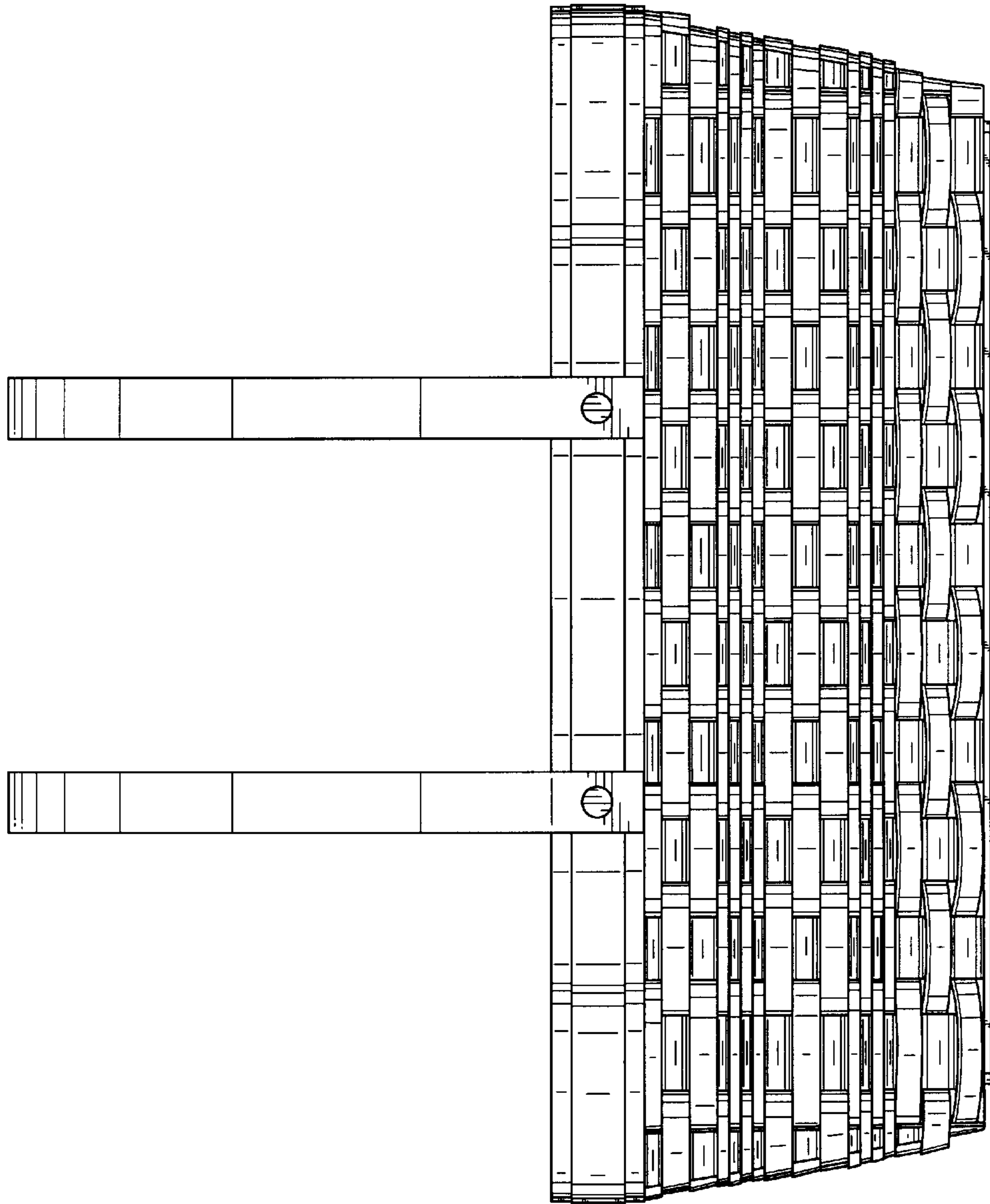

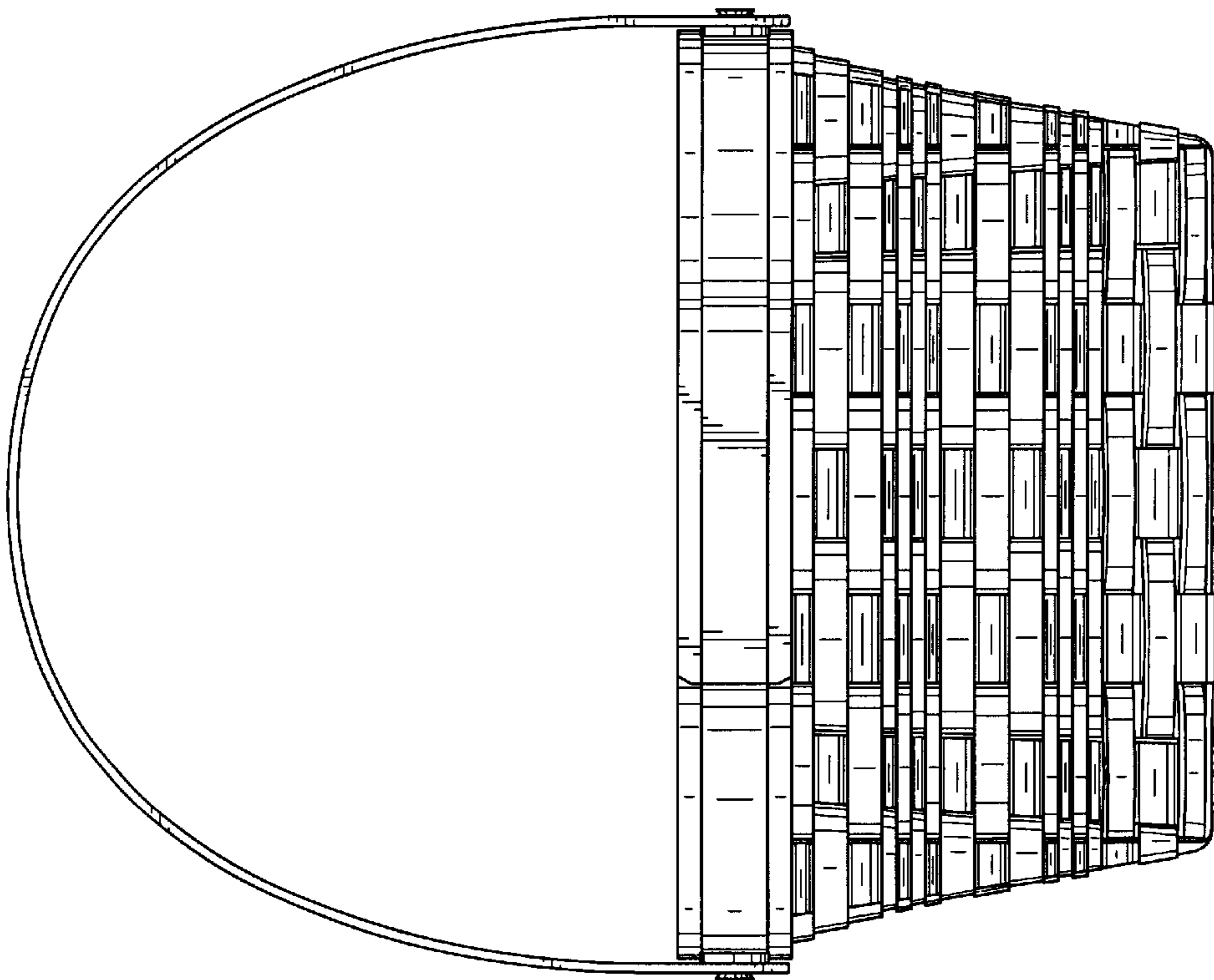

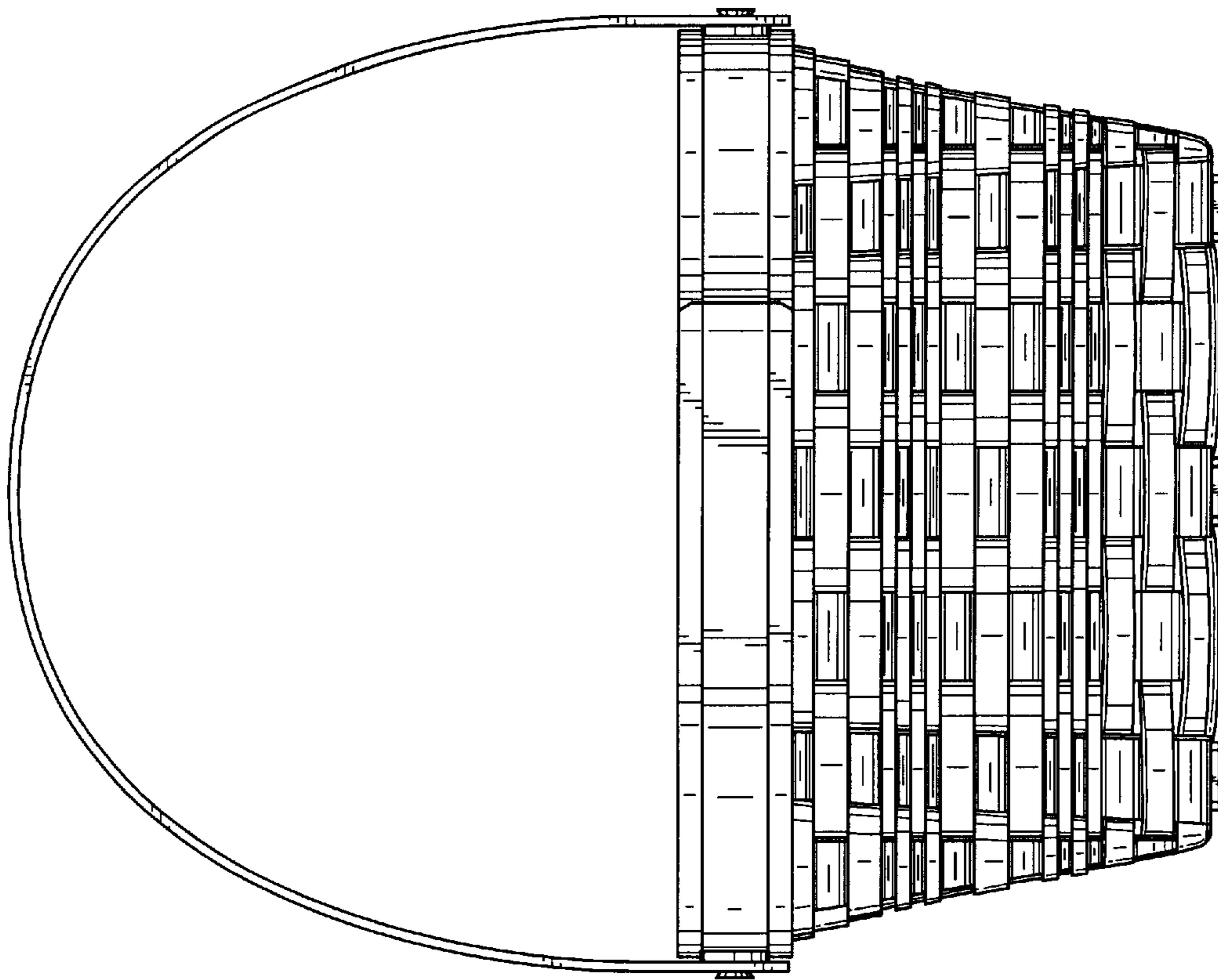

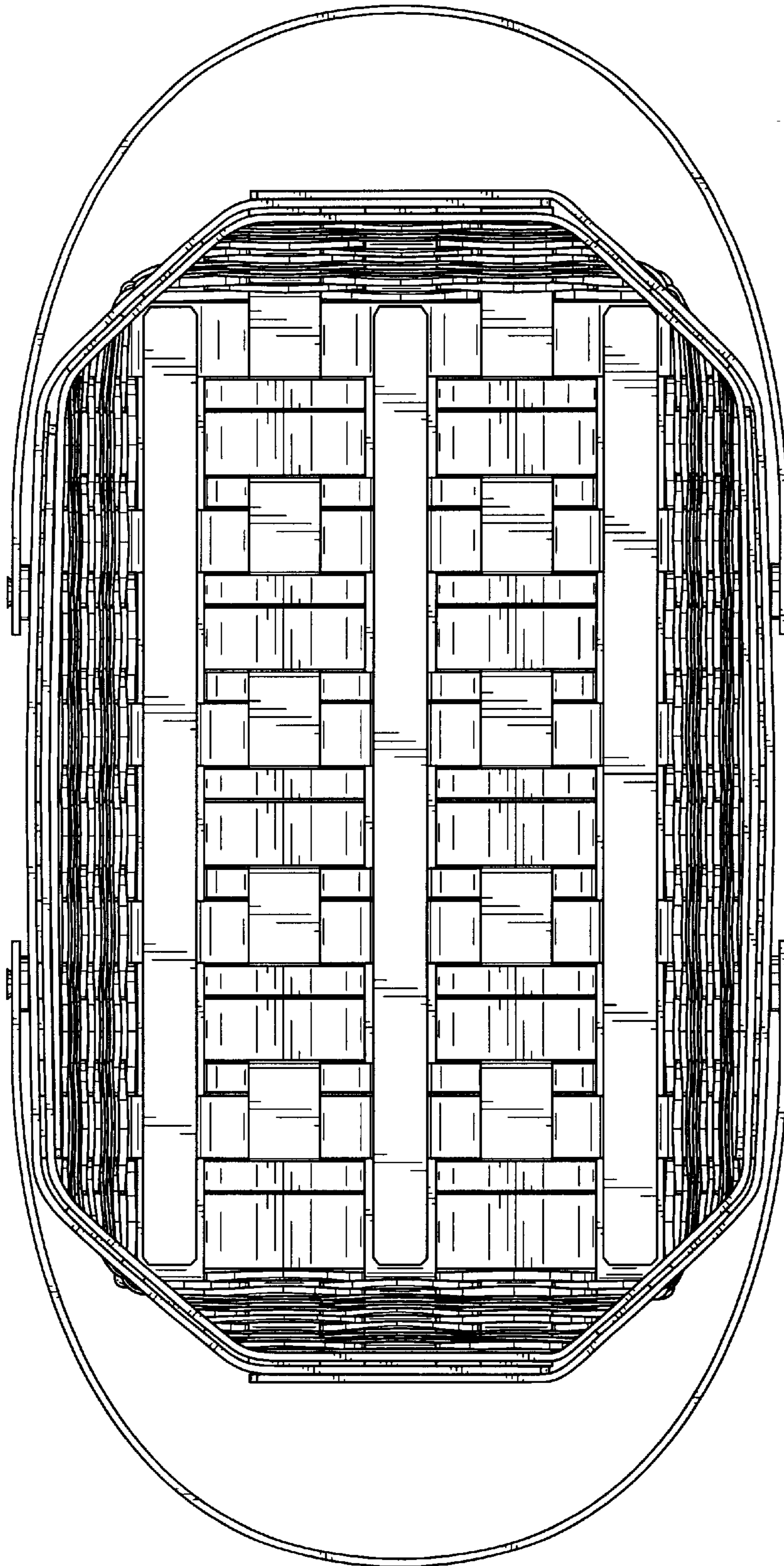

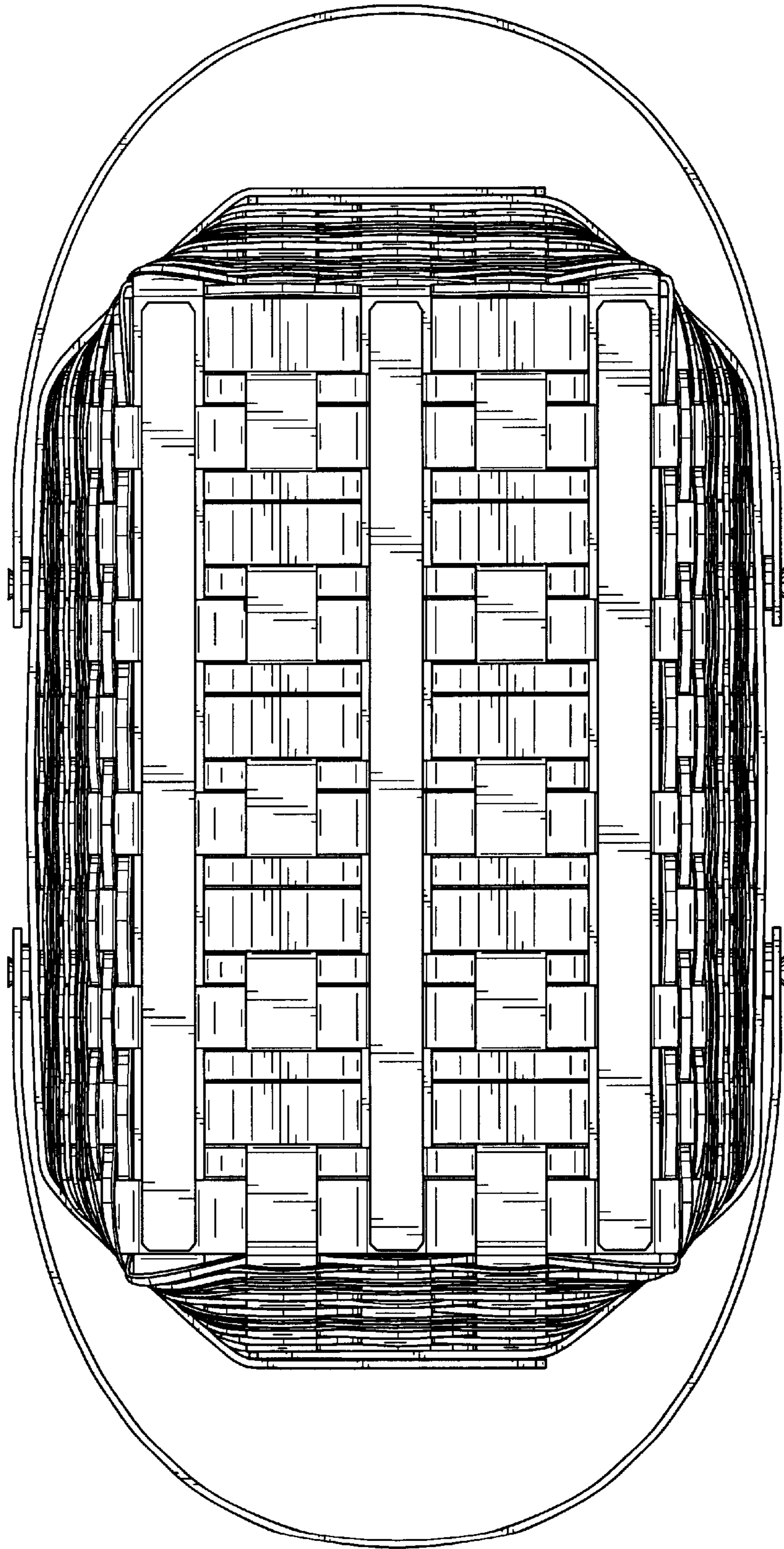

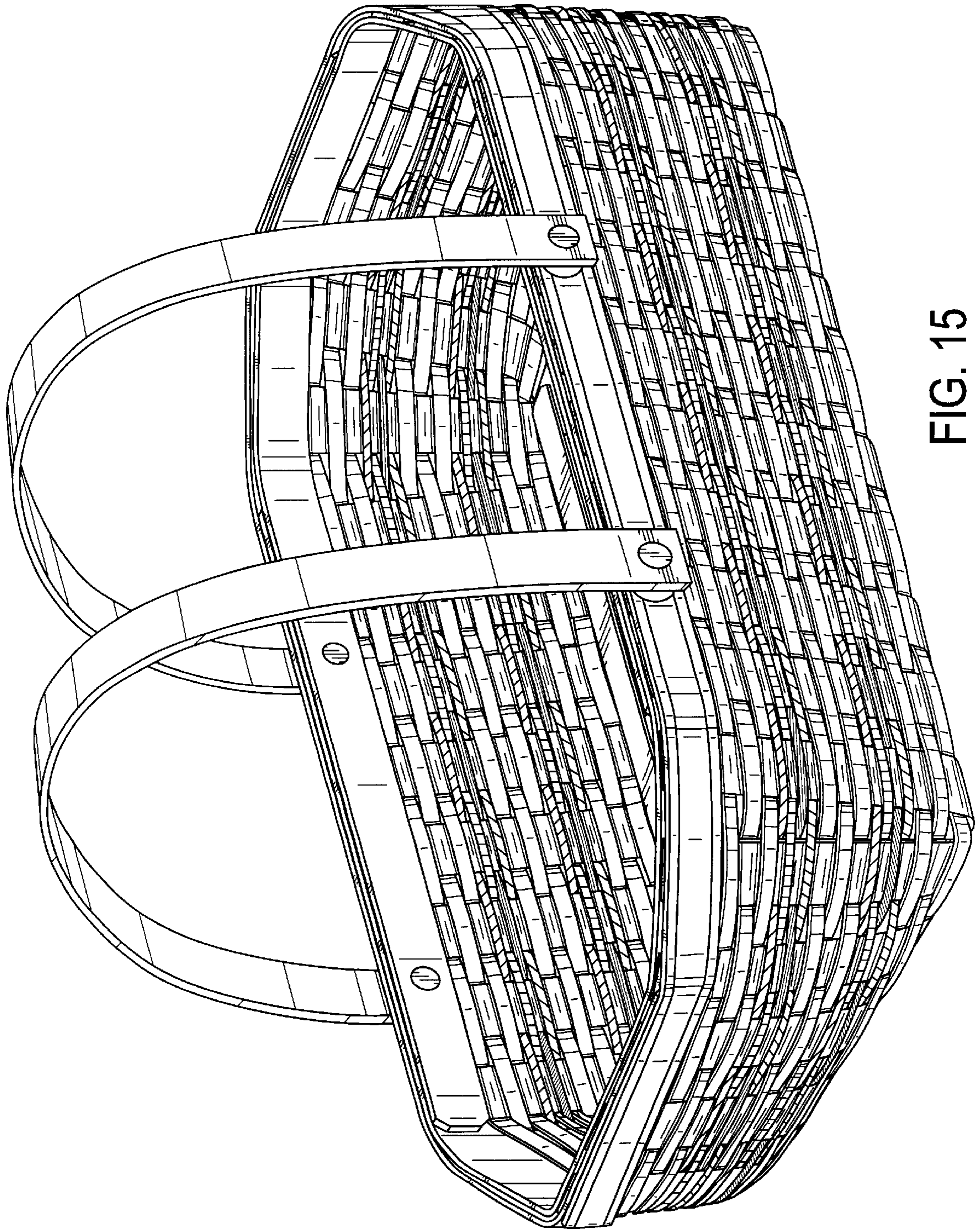

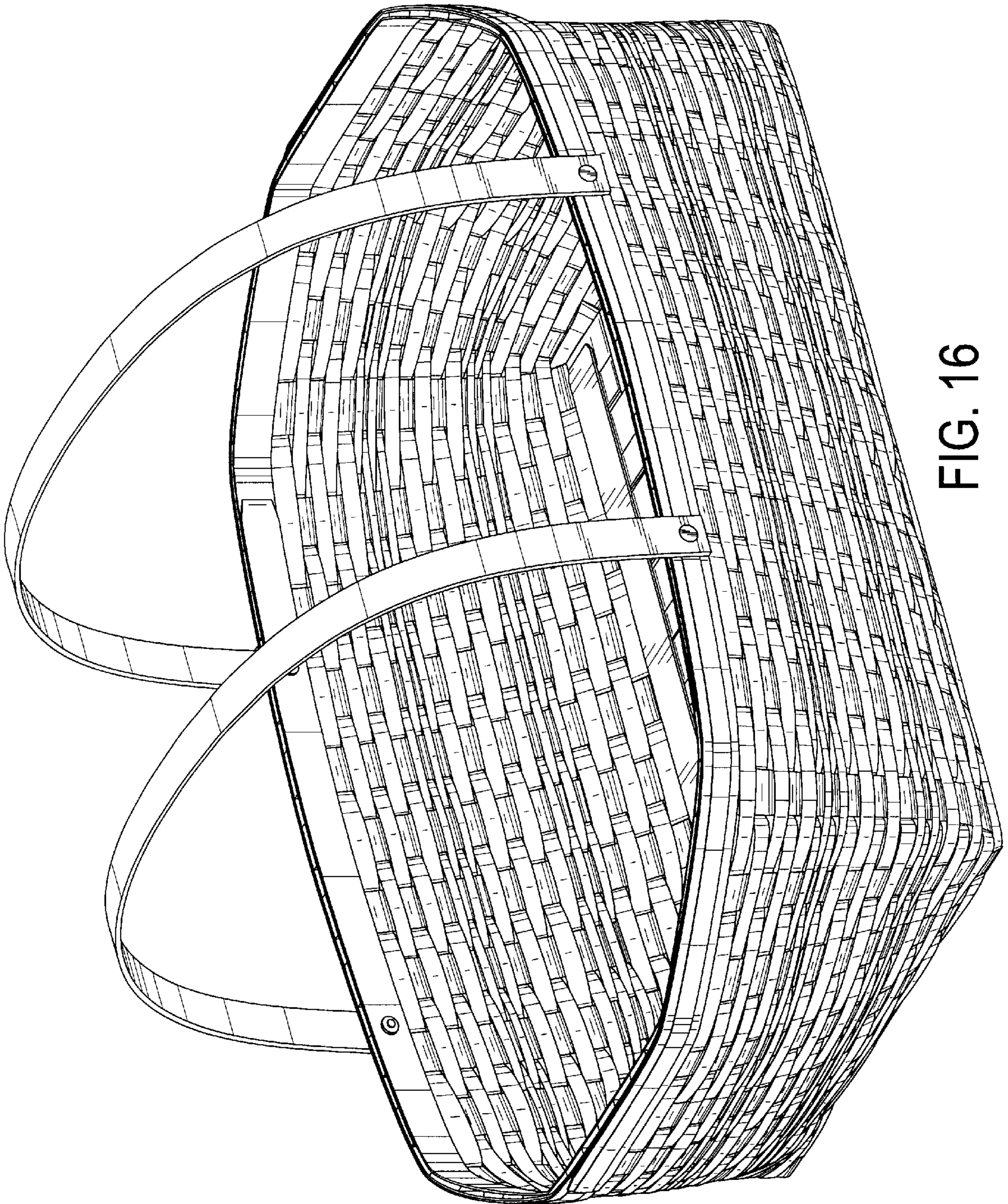

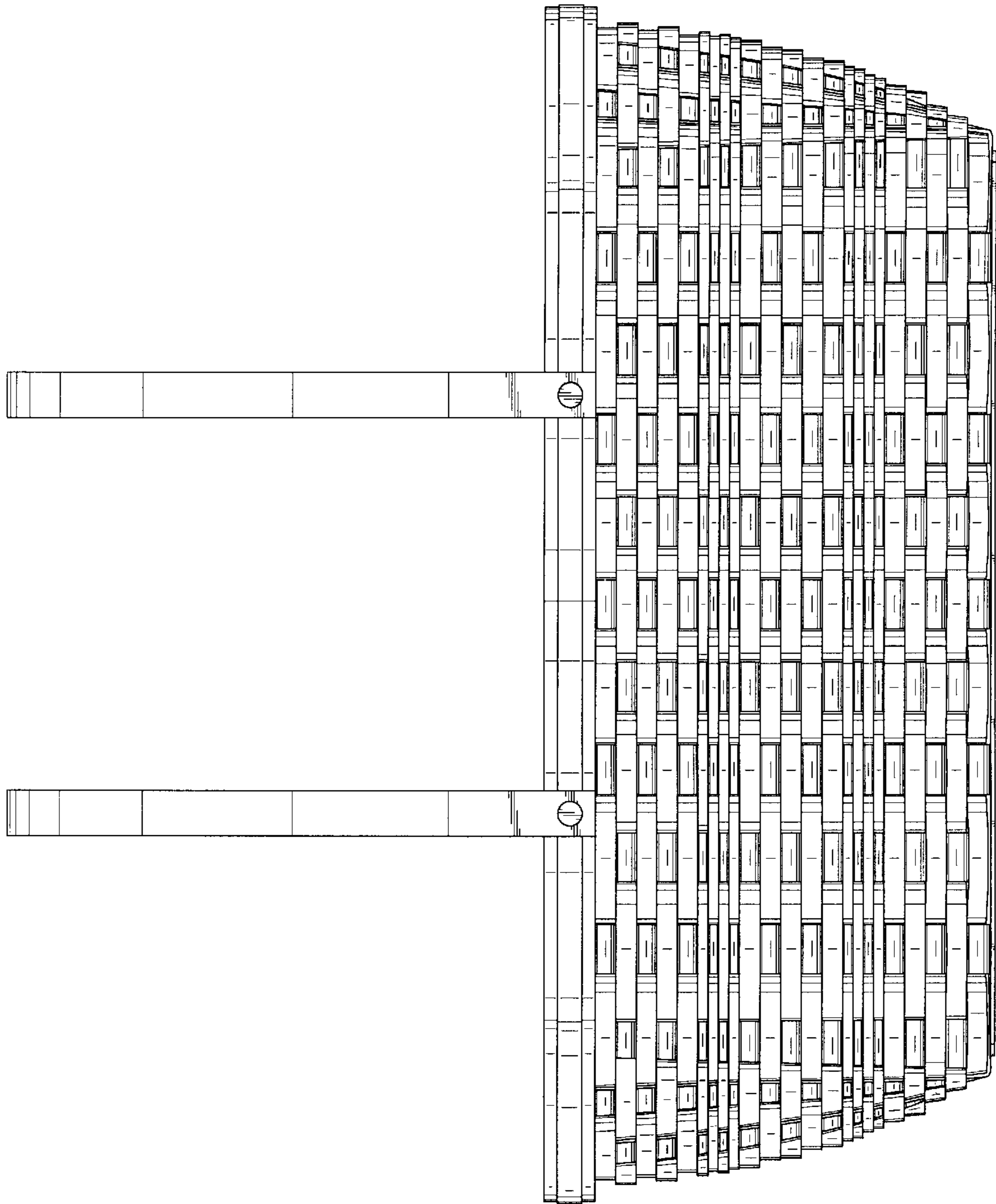

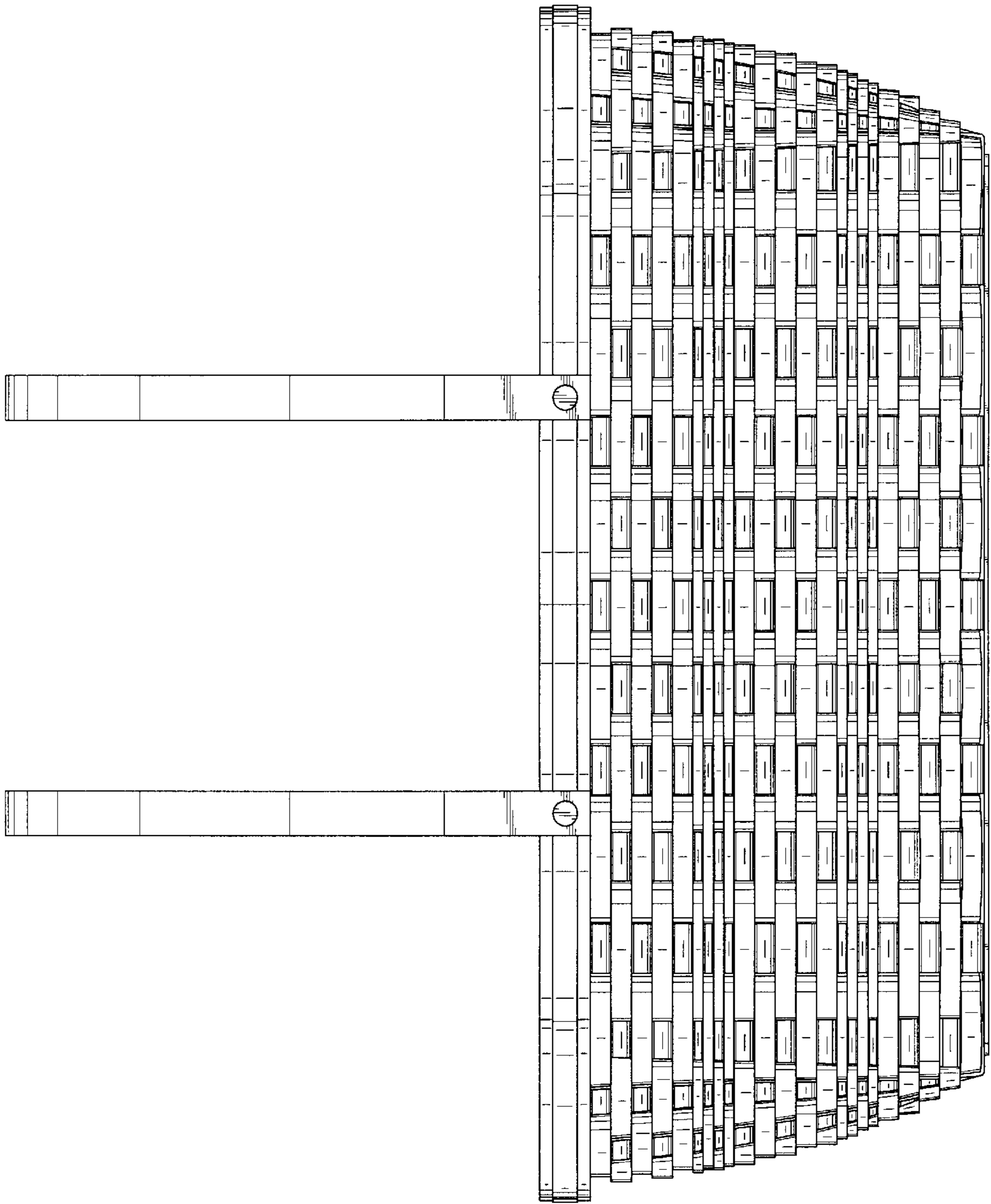

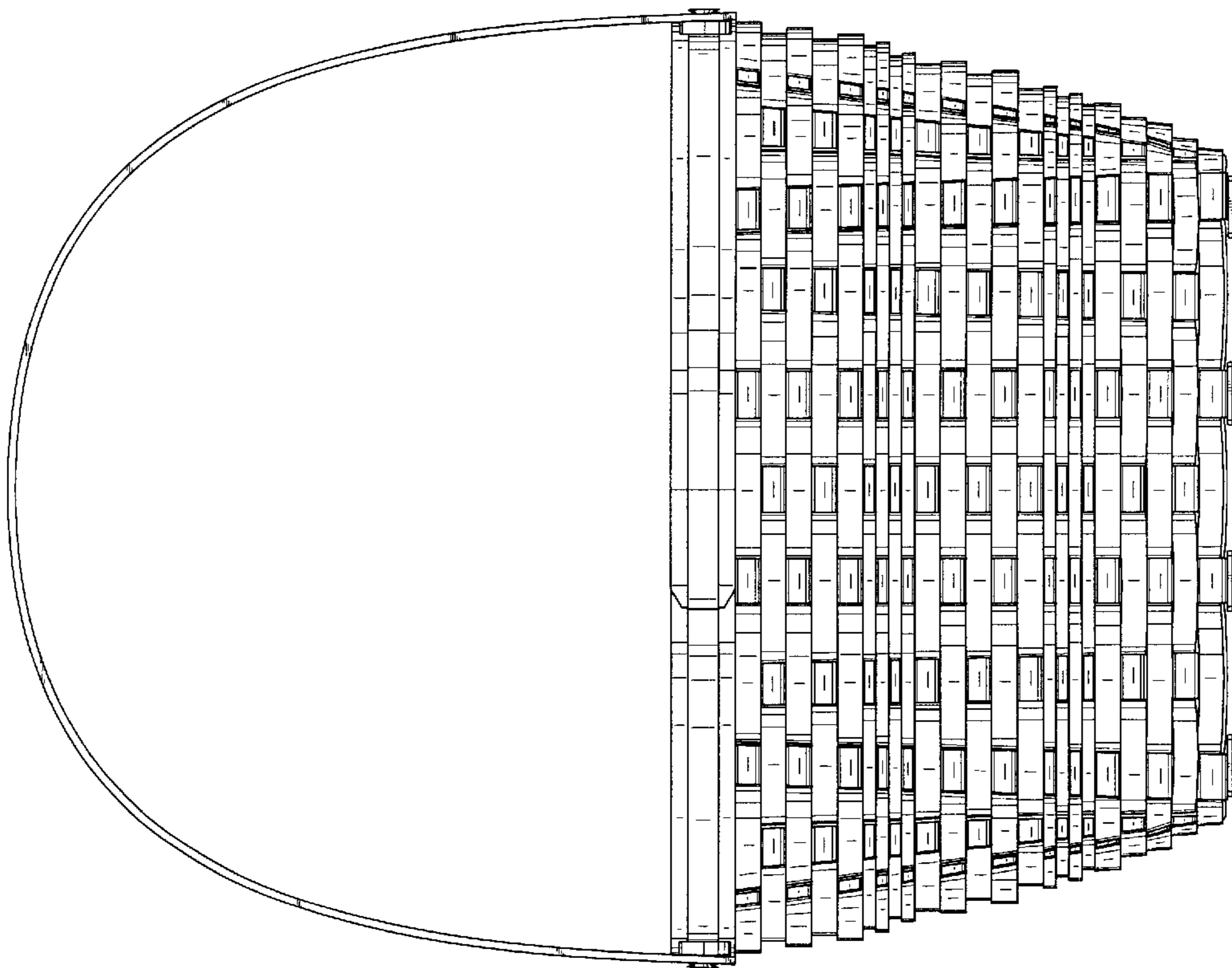

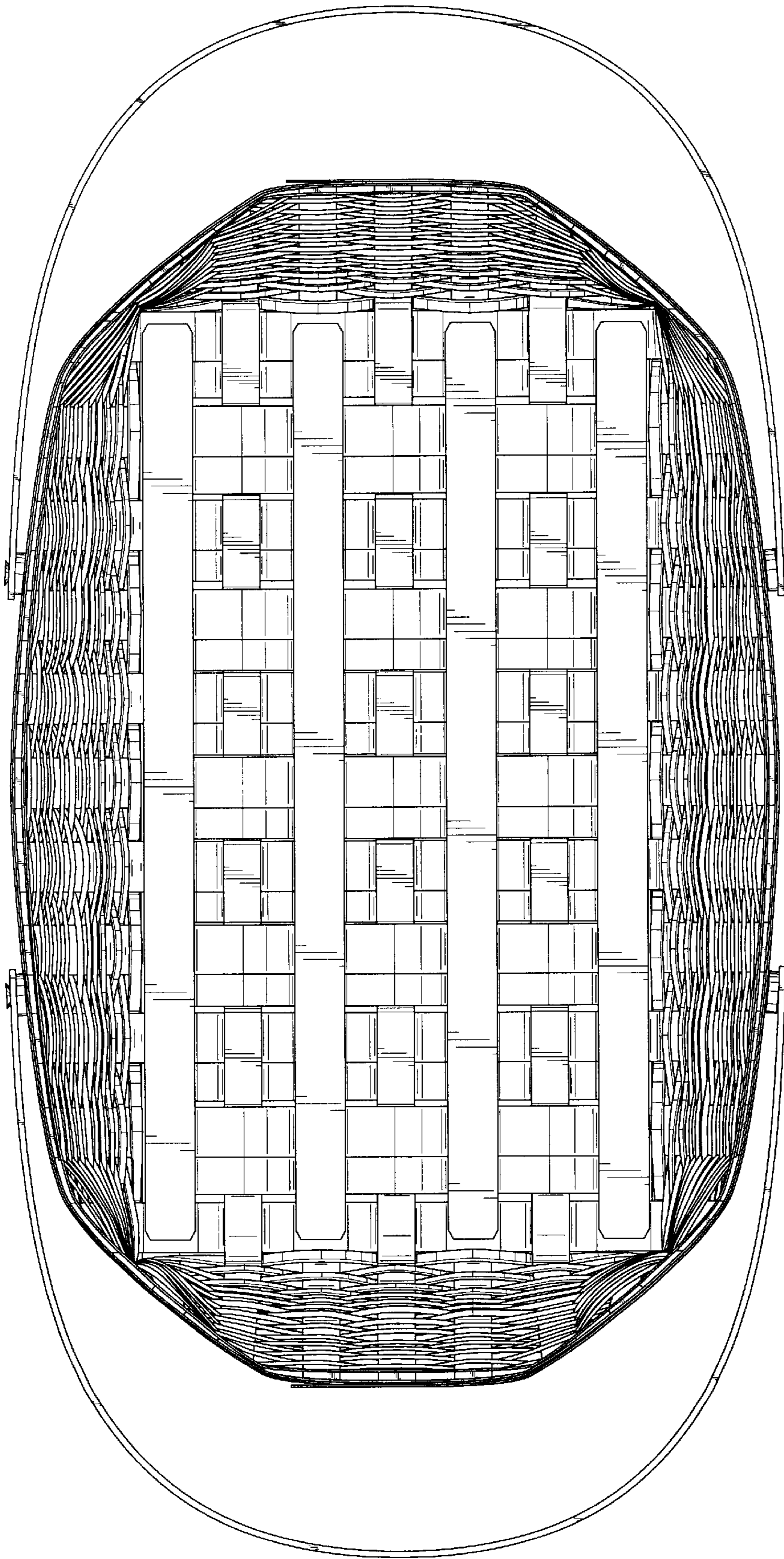

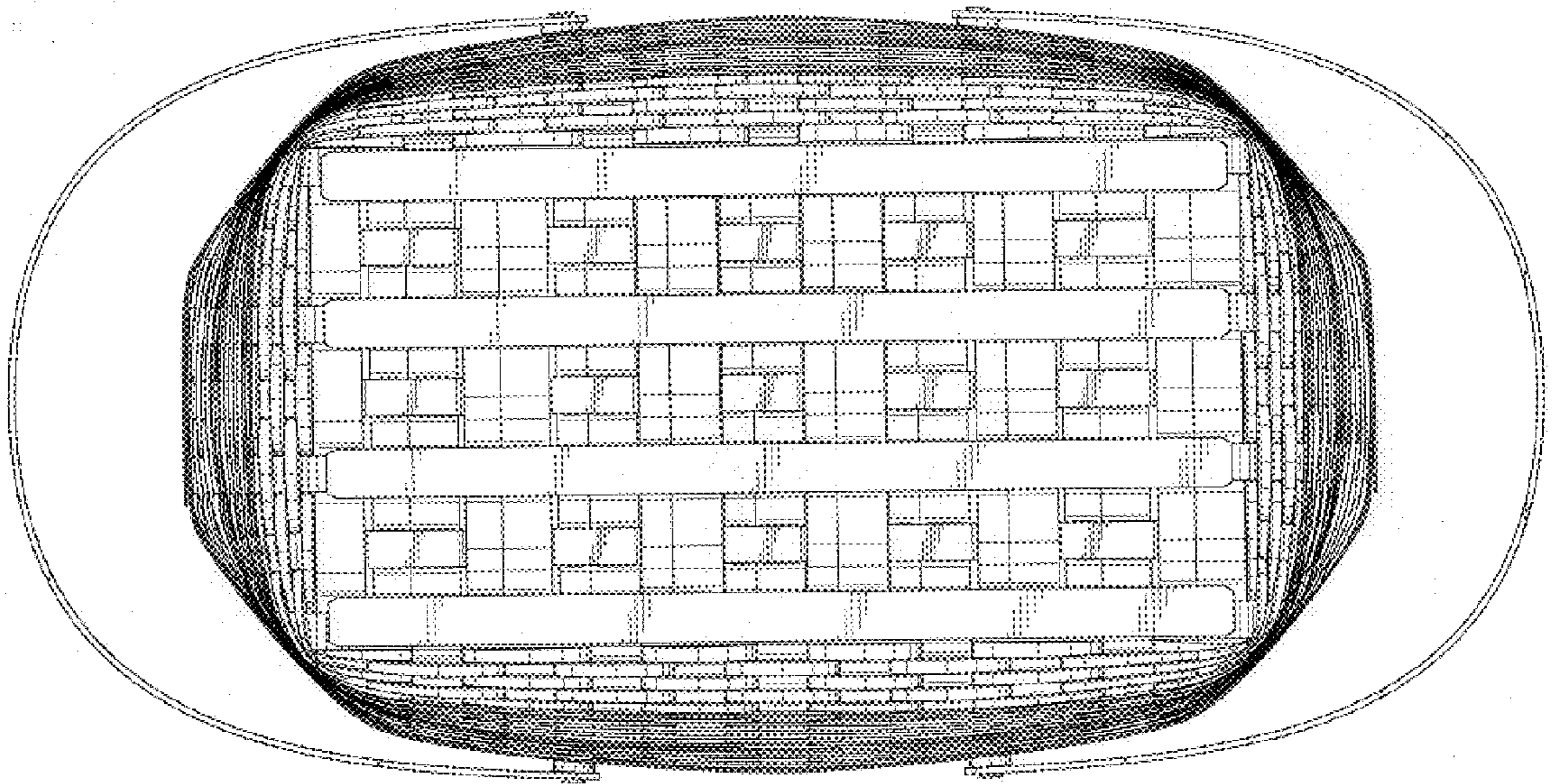

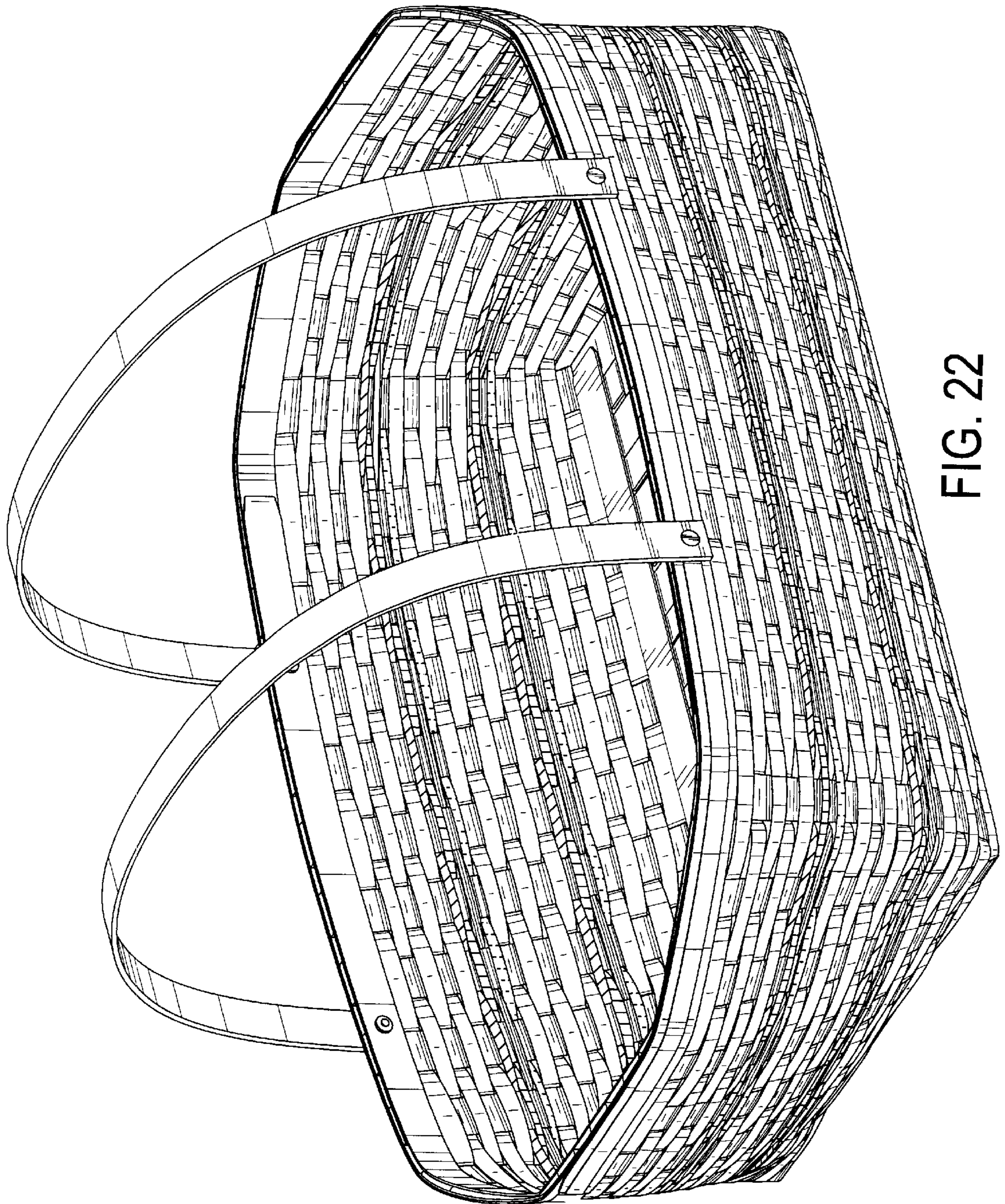

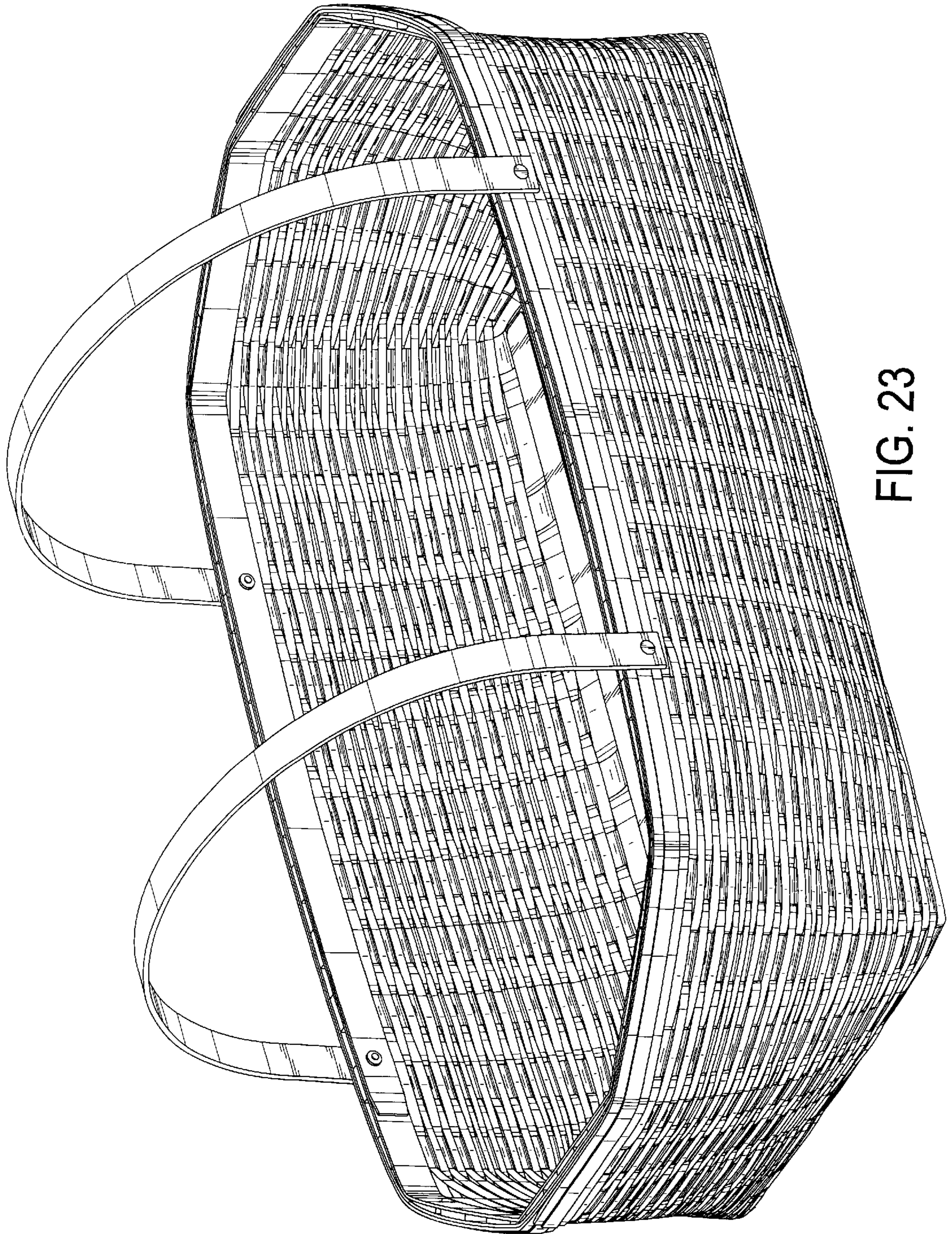

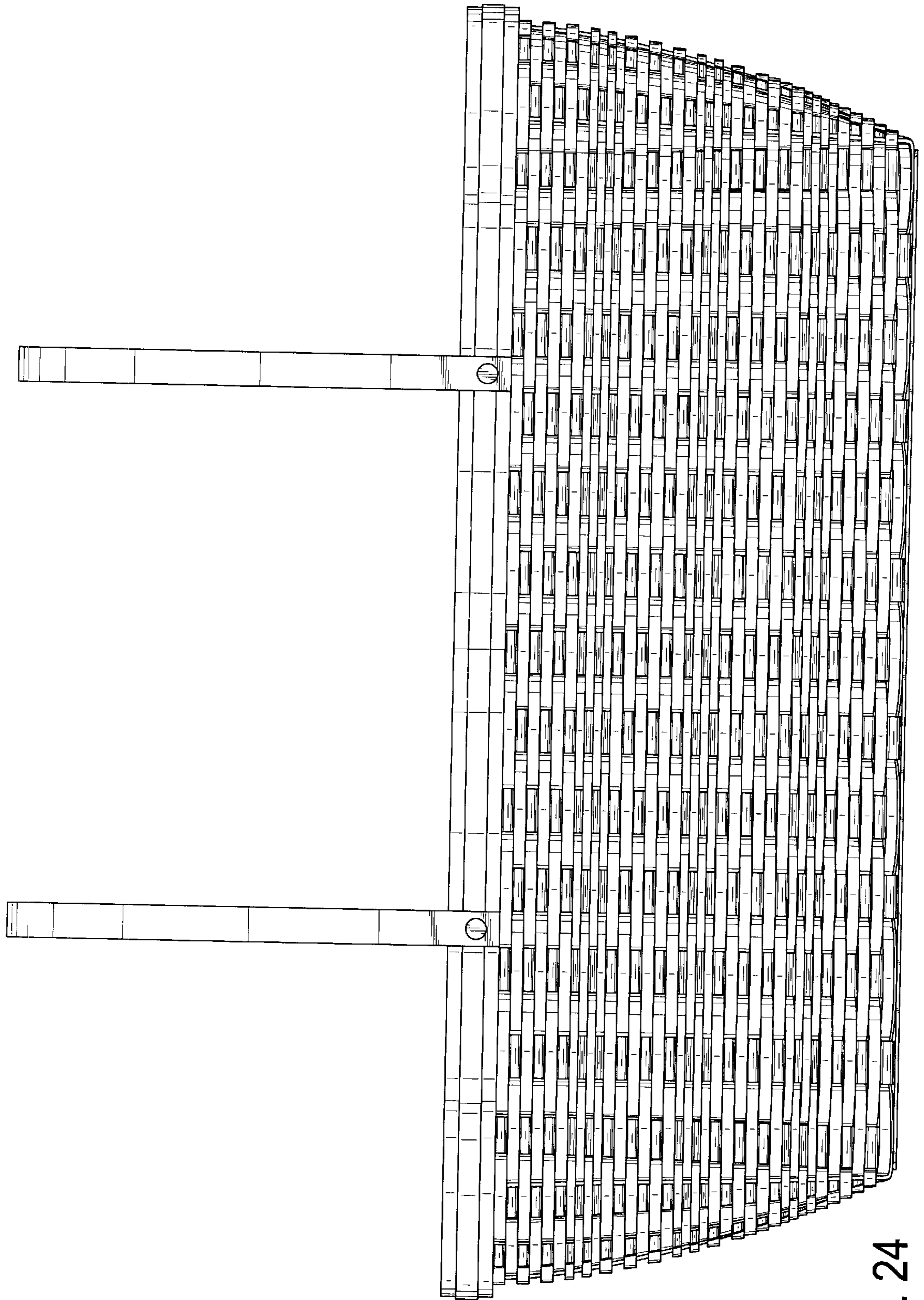

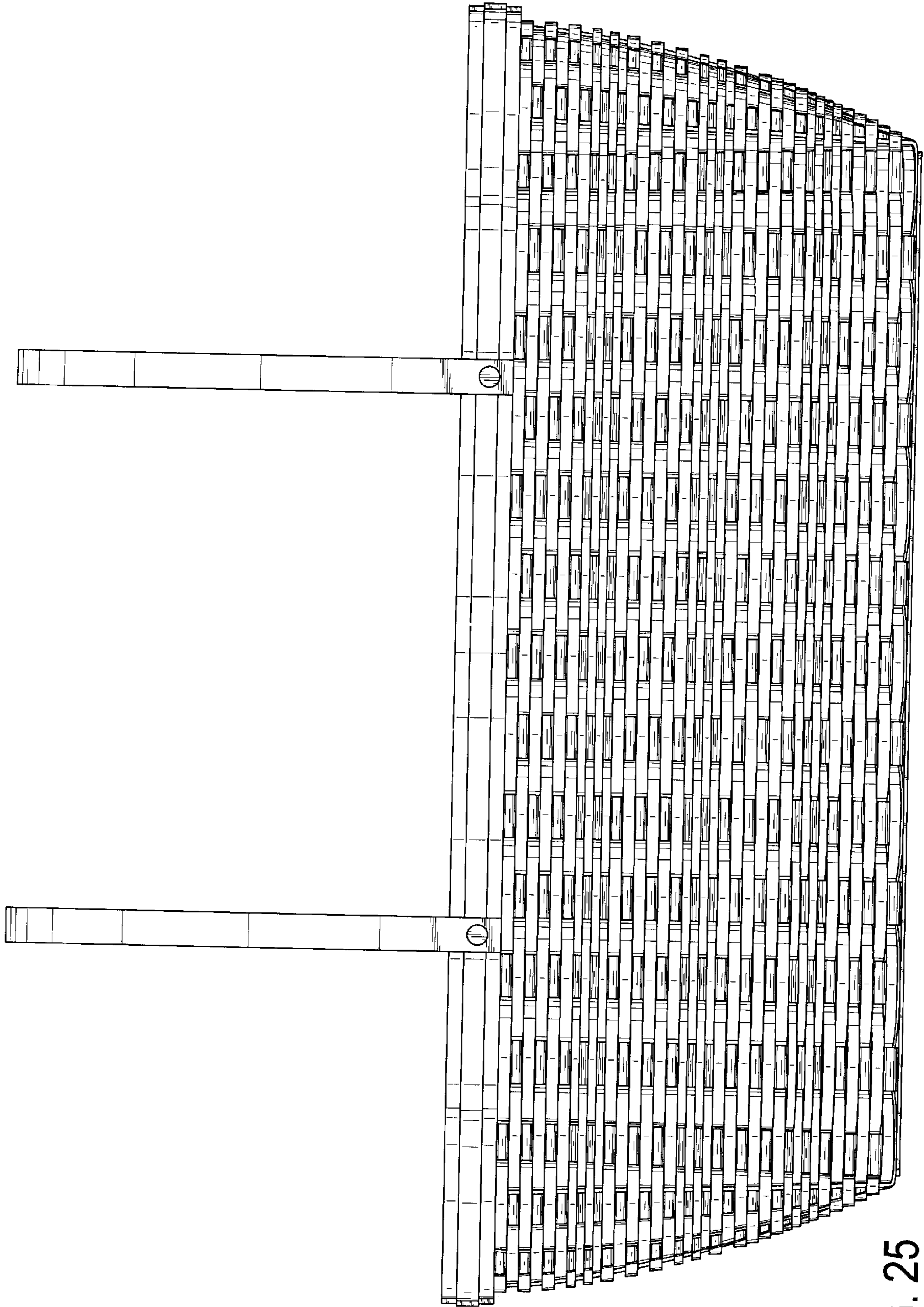

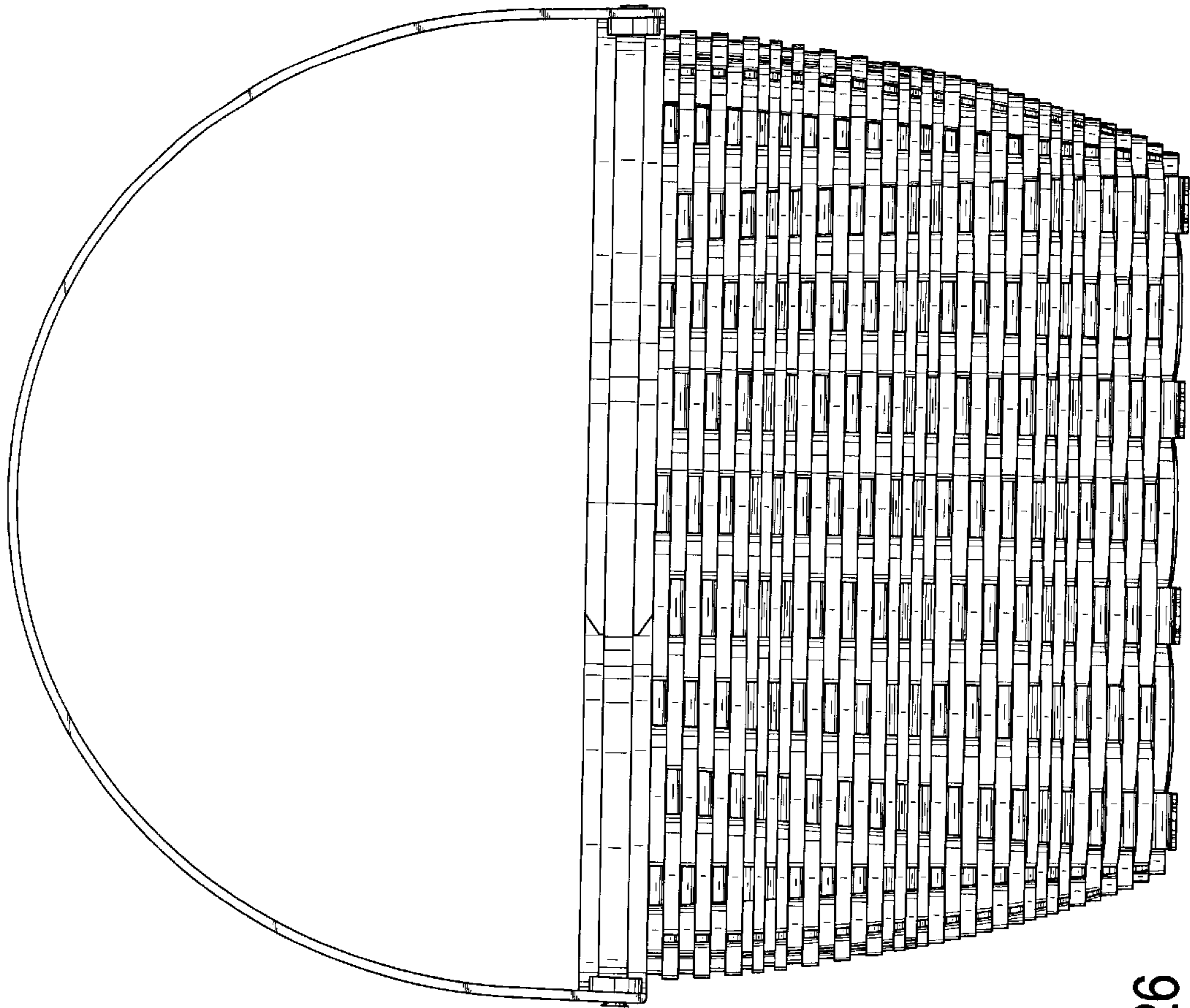

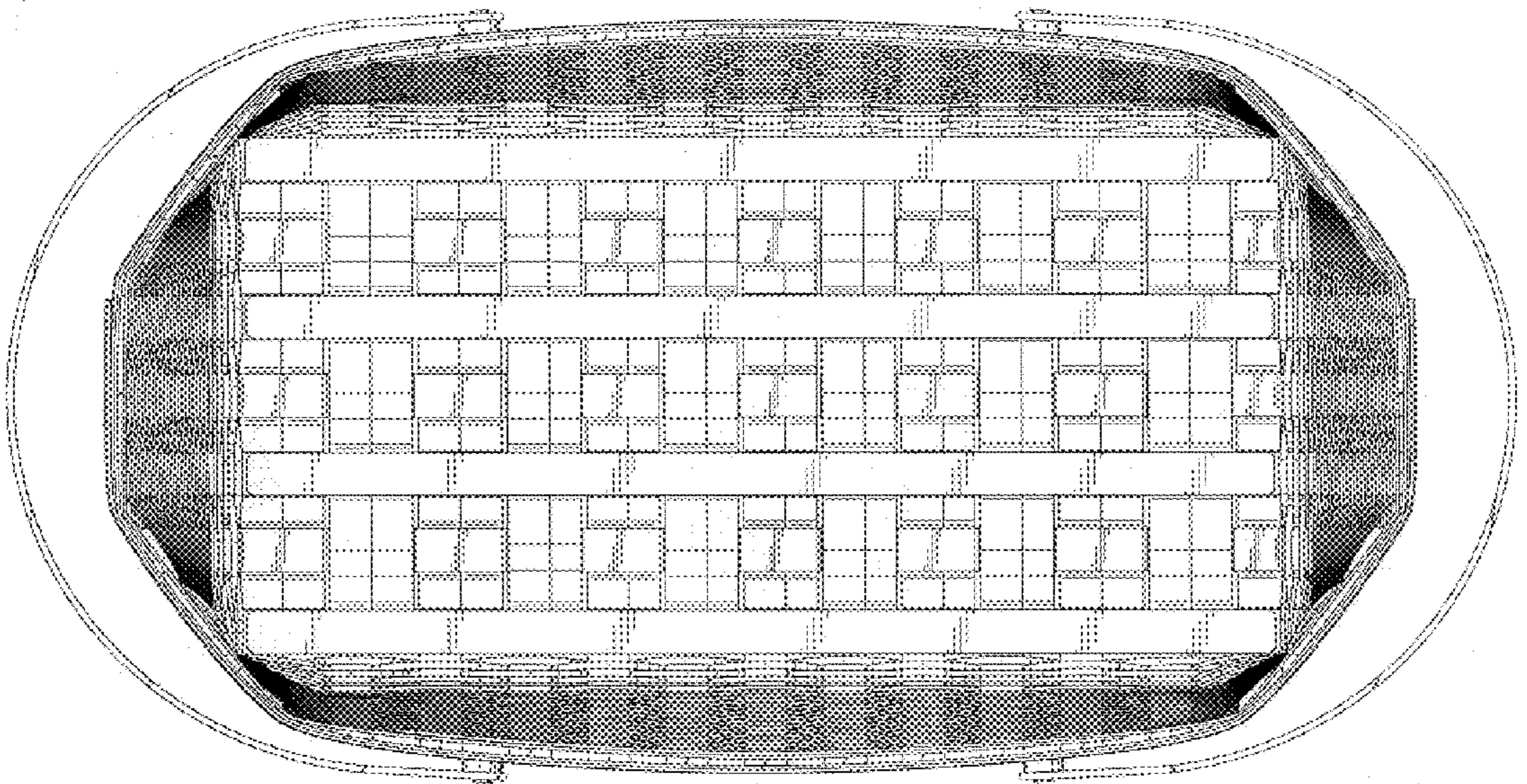

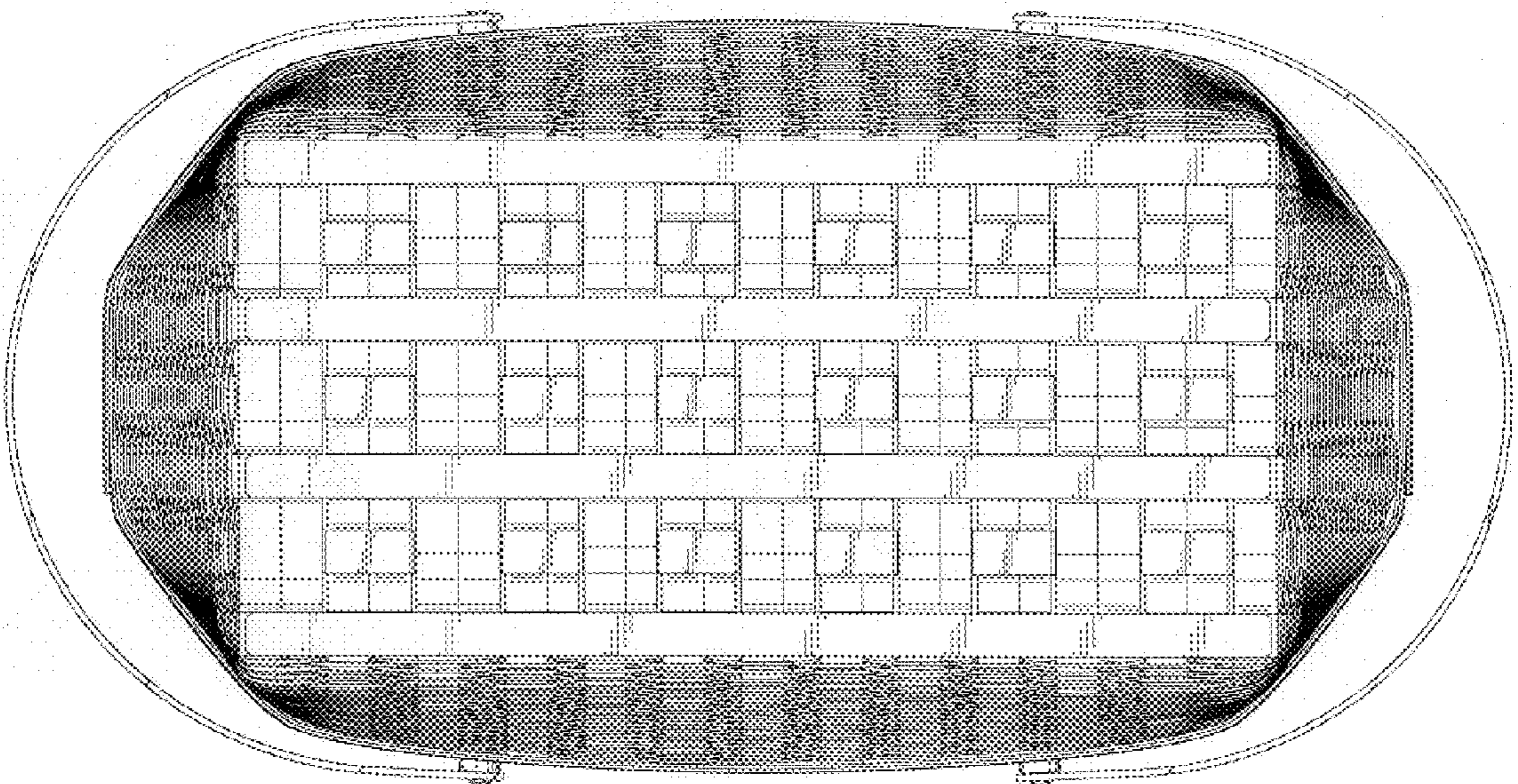

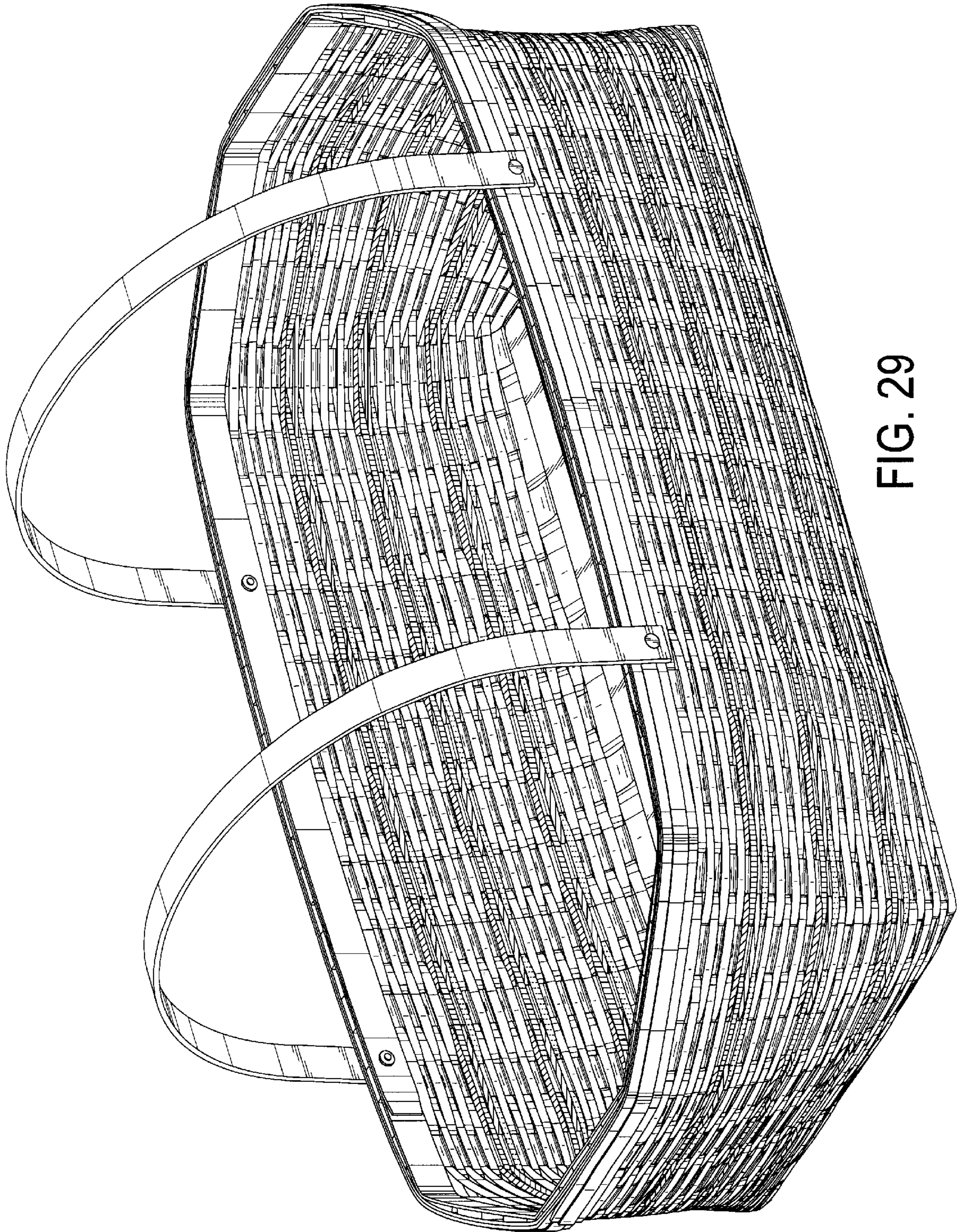
