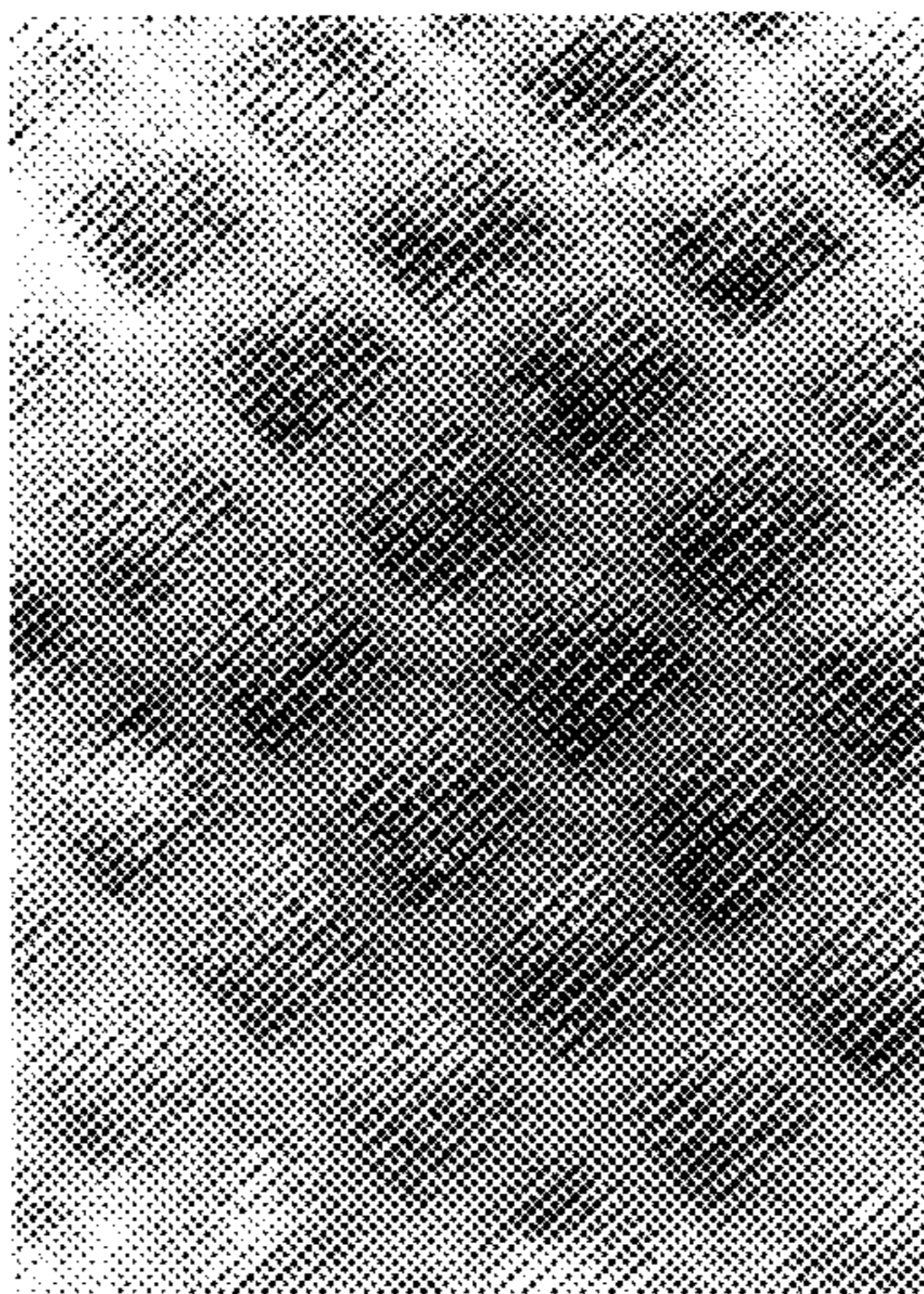
(57) **CLAIM**

We claim the ornamental design for a paper towel, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a paper towel showing our new design; and,  
FIG. 2 is an enlarged fragmentary top plan view thereof.  
Surfaces of the article other than the top surface are not considered to be part of the claimed design.

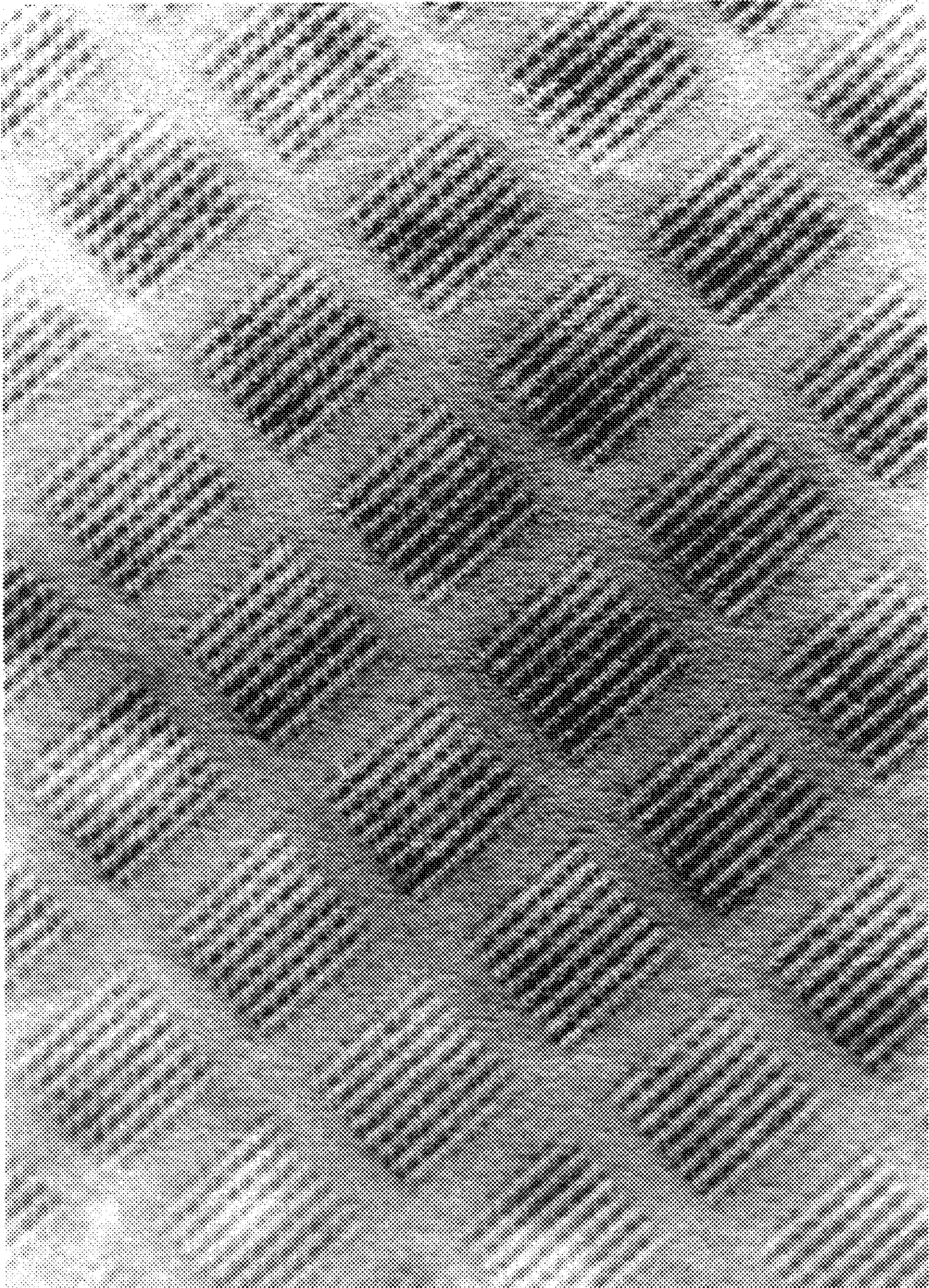

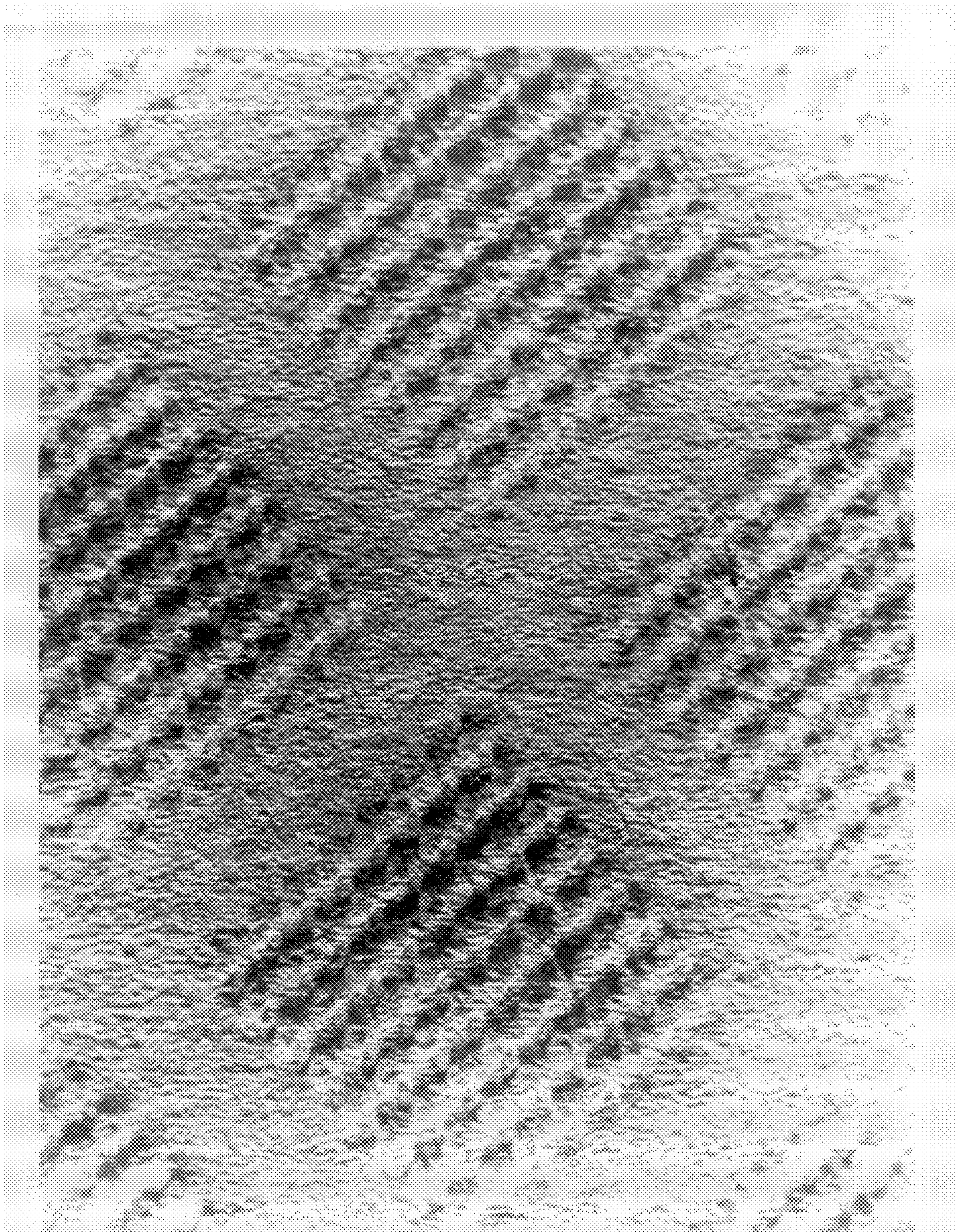
