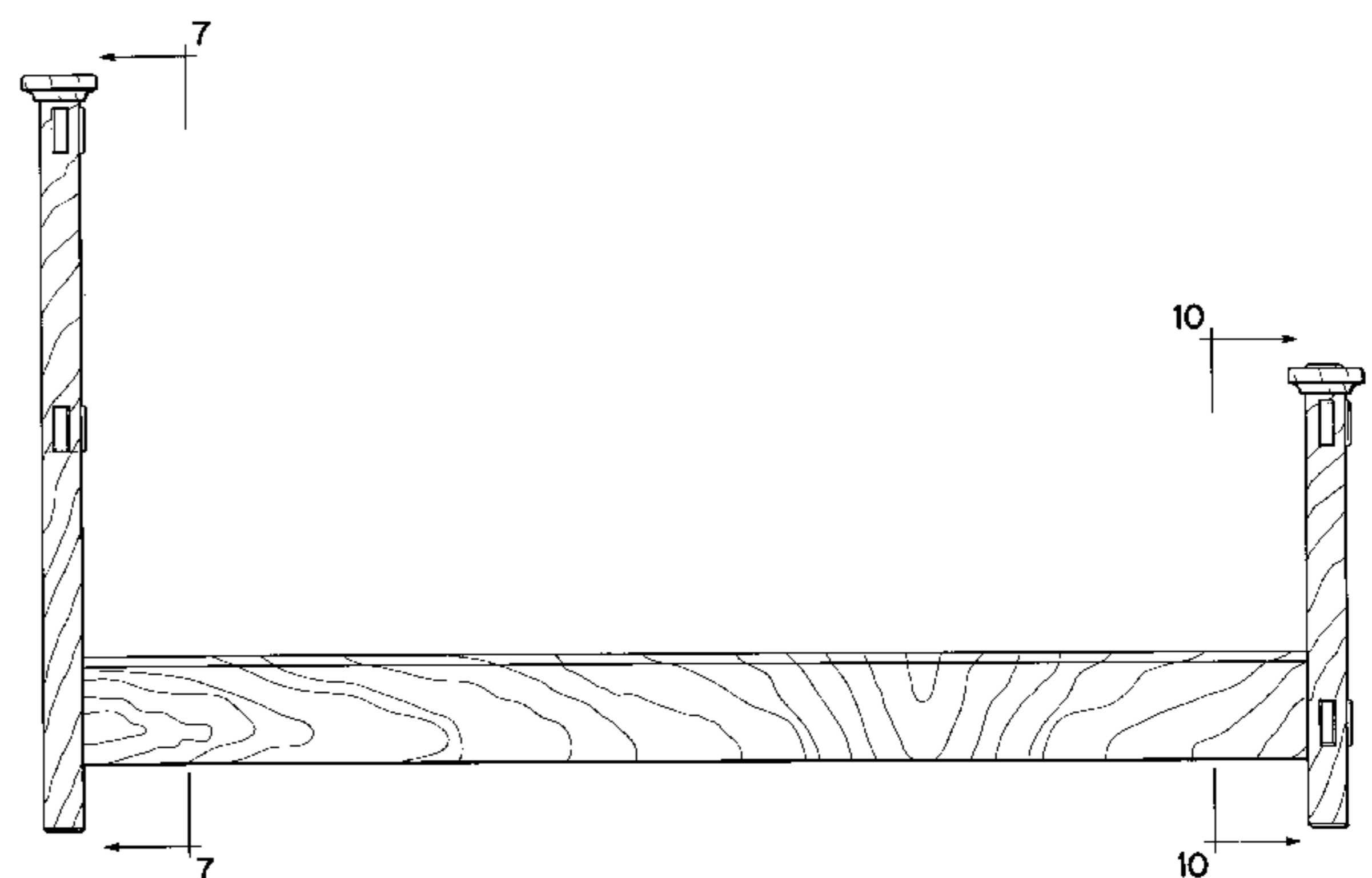
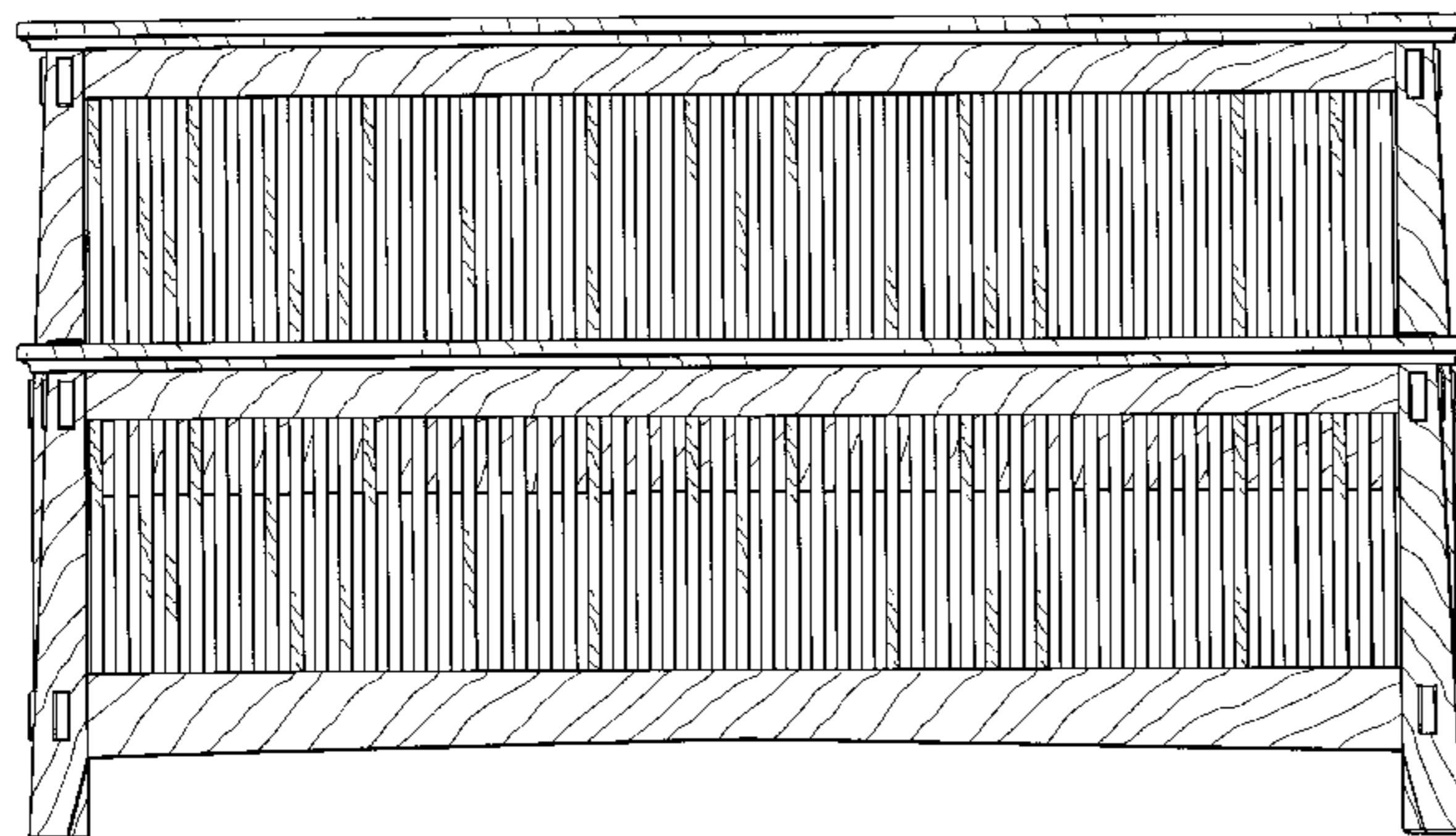
(57) **CLAIM**

The ornamental design for the bed frame, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the bed frame incorporating the design of my new invention;  
 FIG. 2 is a left side elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a vertical cross-sectional view taken along line 7—7 of FIG. 2, depicting the entire front of the headboard;  
 FIG. 8 is a horizontal cross-sectional view taken along line 8—8 of FIG. 7, depicting details of the vertical-oriented, horizontally spaced spindles incorporated in the headboard;  
 FIG. 9 is an enlarged view of the upper left corner of the headboard, depicting details of the tenon extending from the headboard side post, the tenon configuration being the same for the other tenons extending from the headboard and footboard side posts;  
 FIG. 10 is a vertical cross-sectional view along line 10—10 of FIG. 2, depicting the rear of the footboard; and,  
 FIG. 11 is a horizontal cross-sectional view along line 11—11 of FIG. 10, depicting details of the vertically-oriented, horizontally spaced spindle incorporated in the footboard.

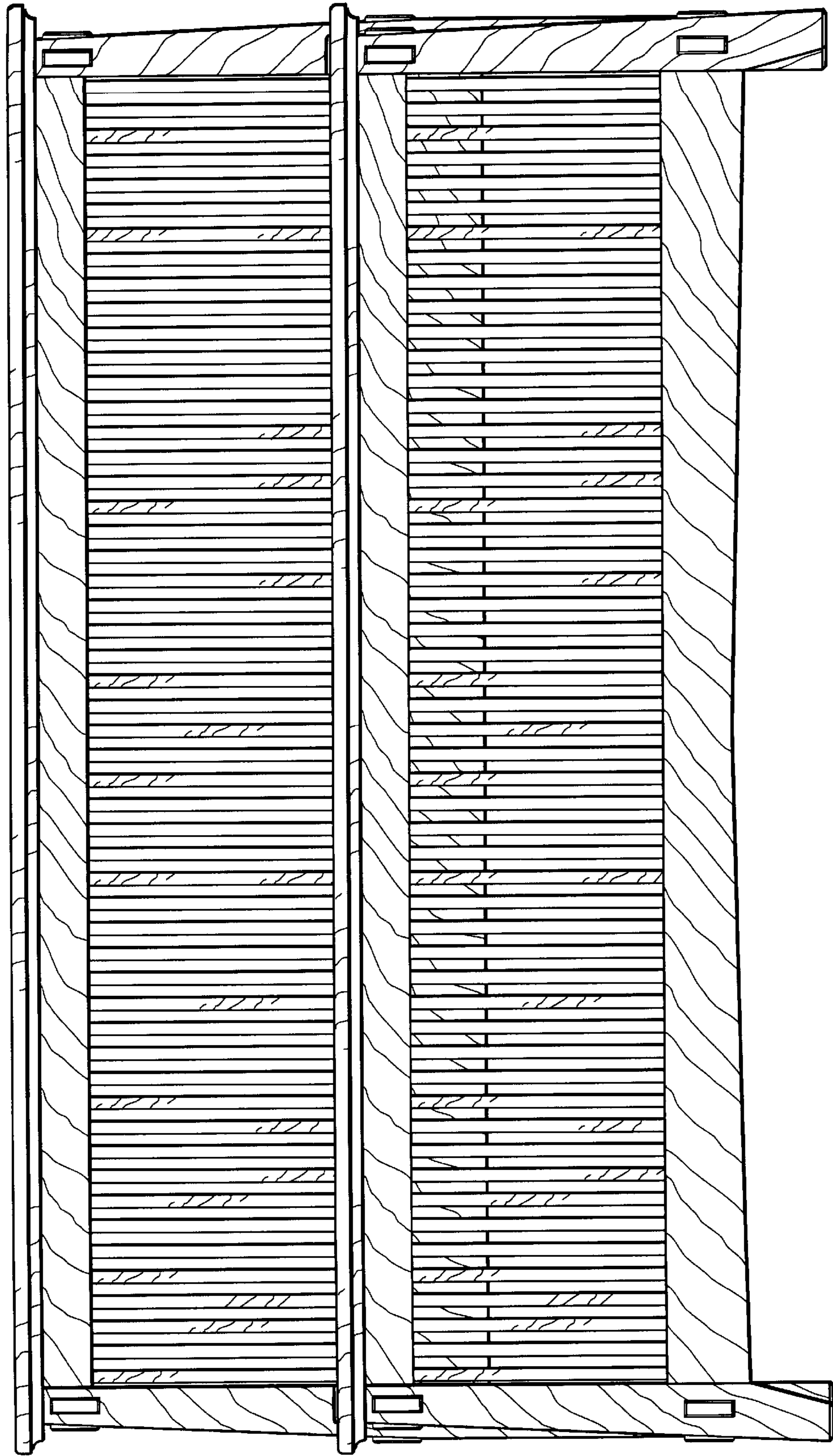

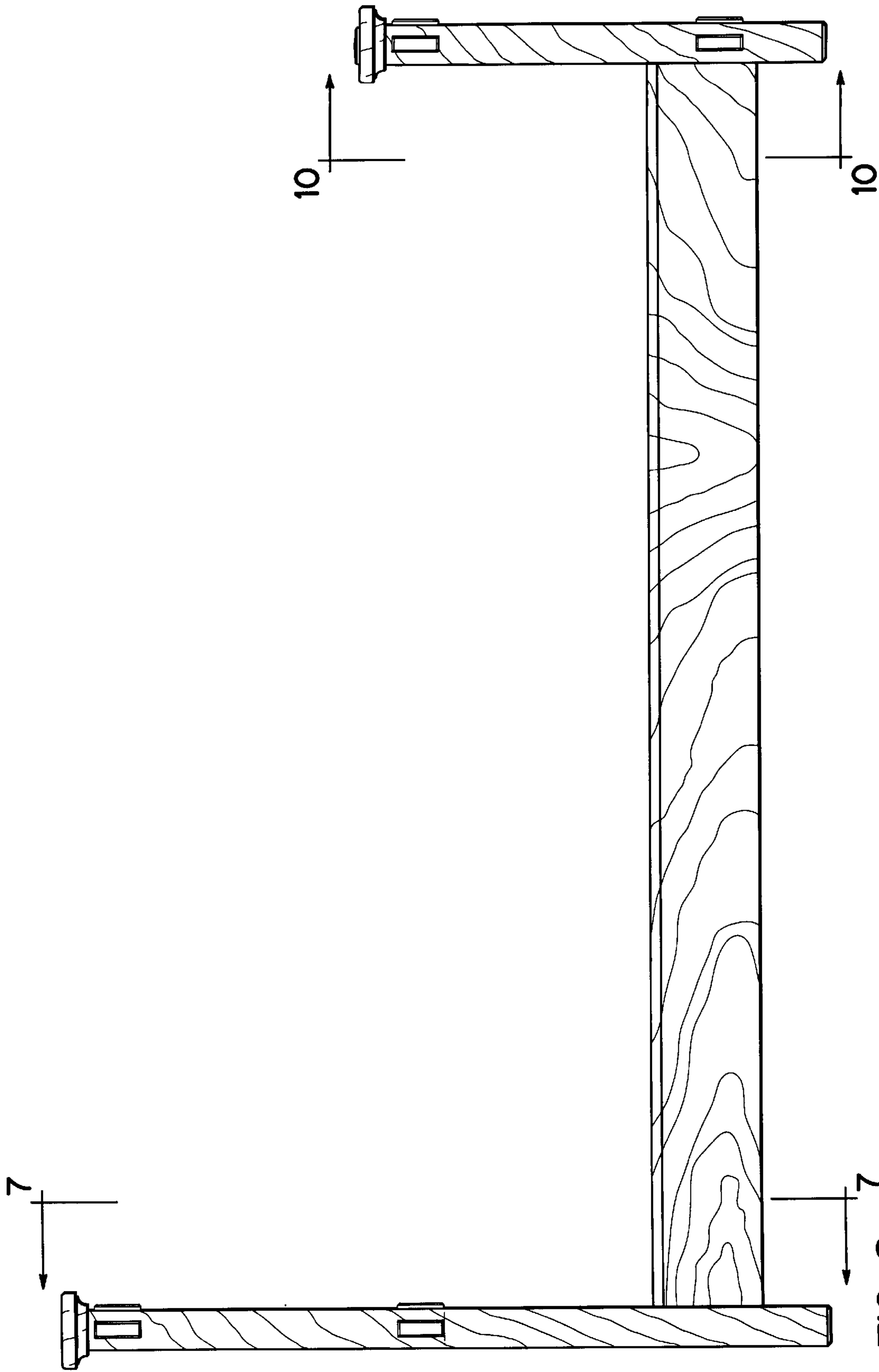

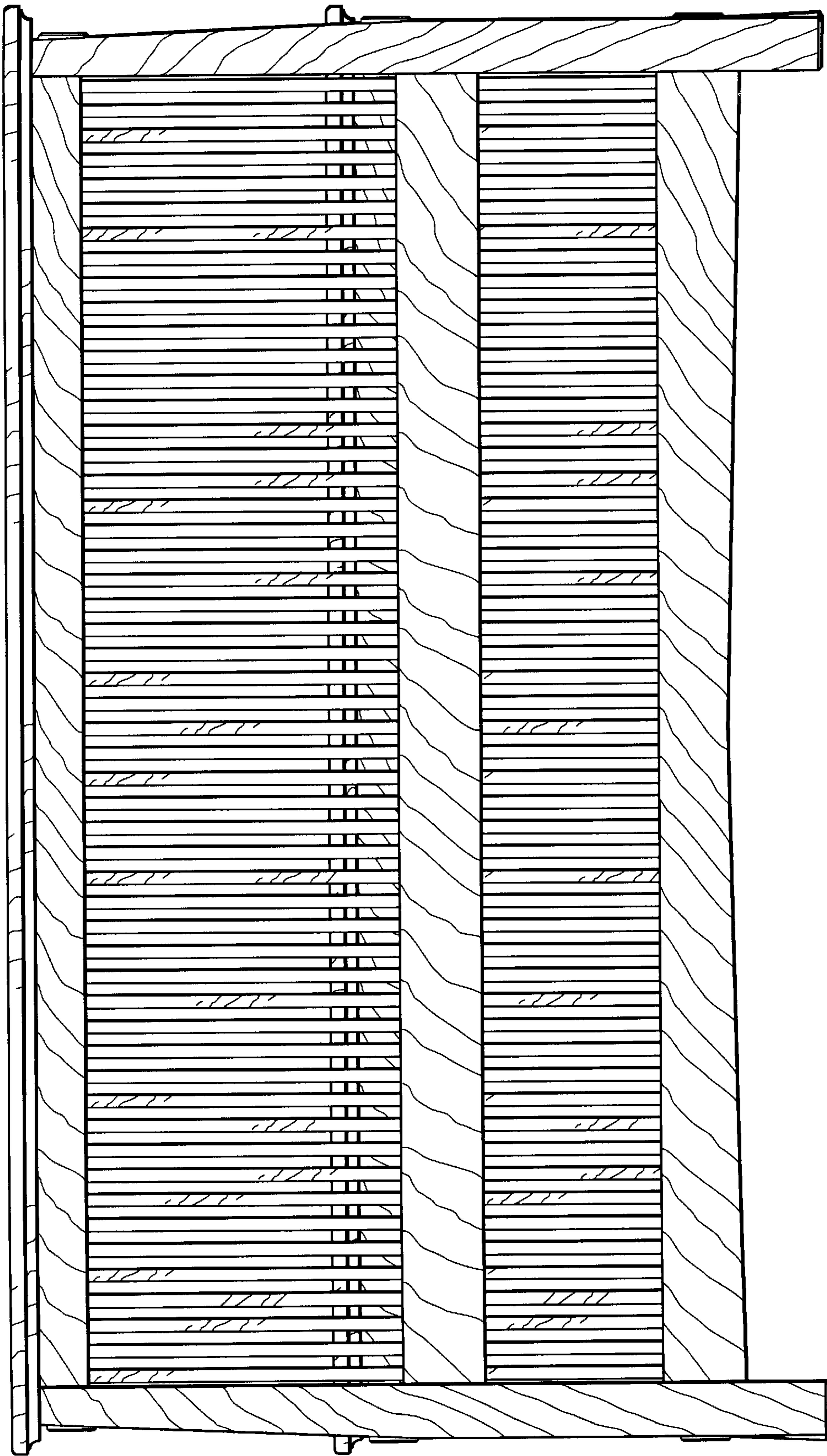

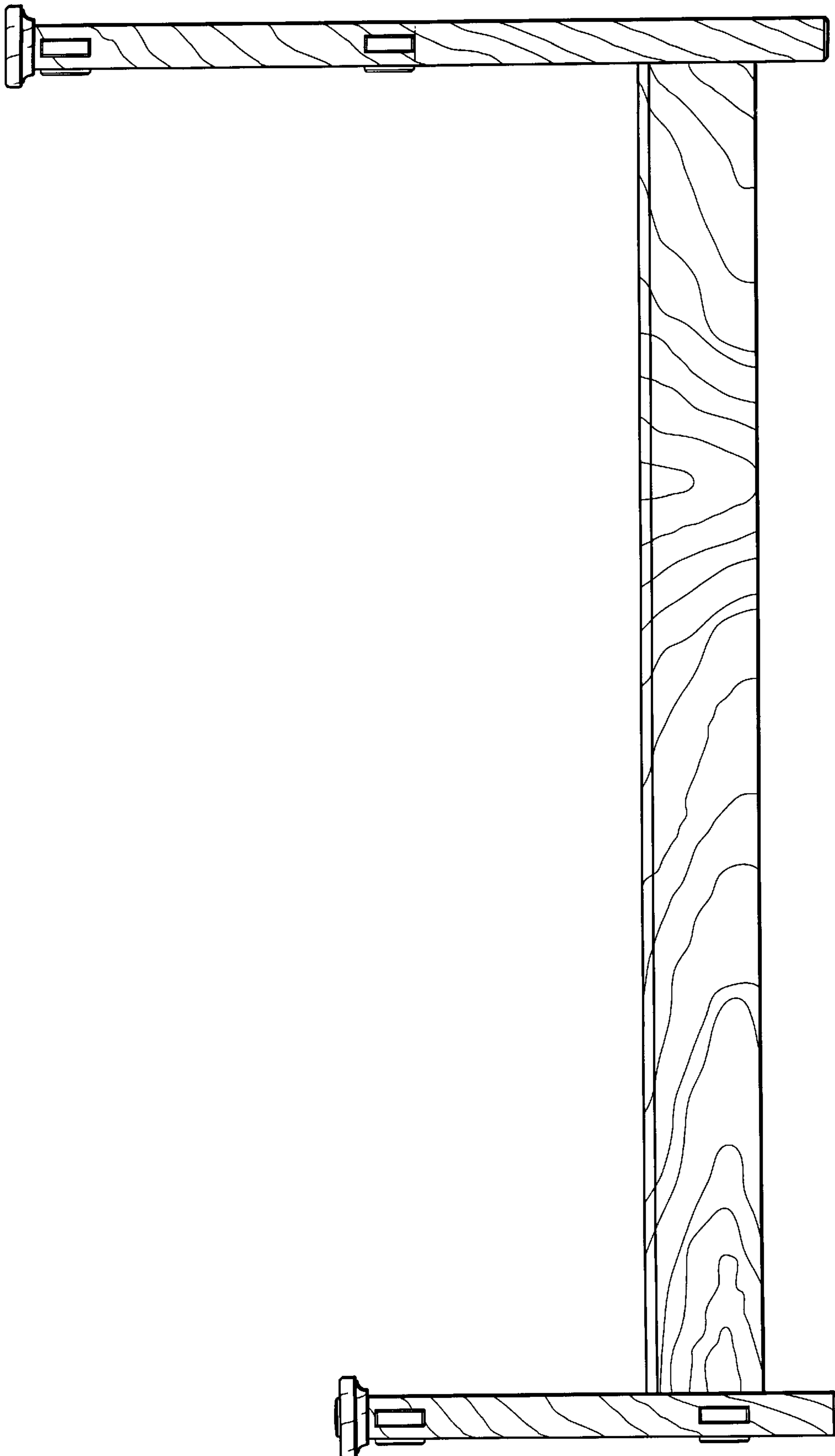

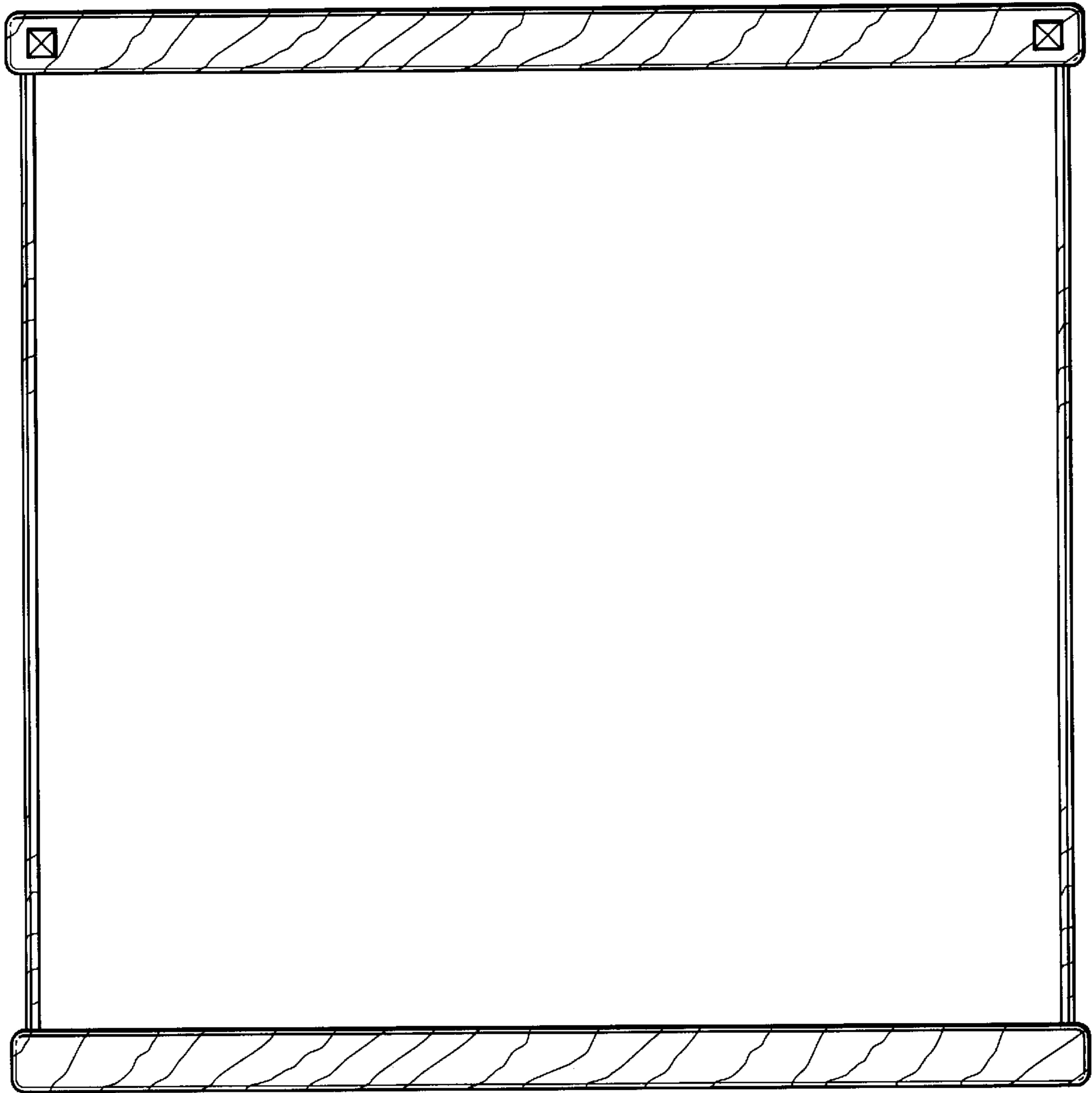

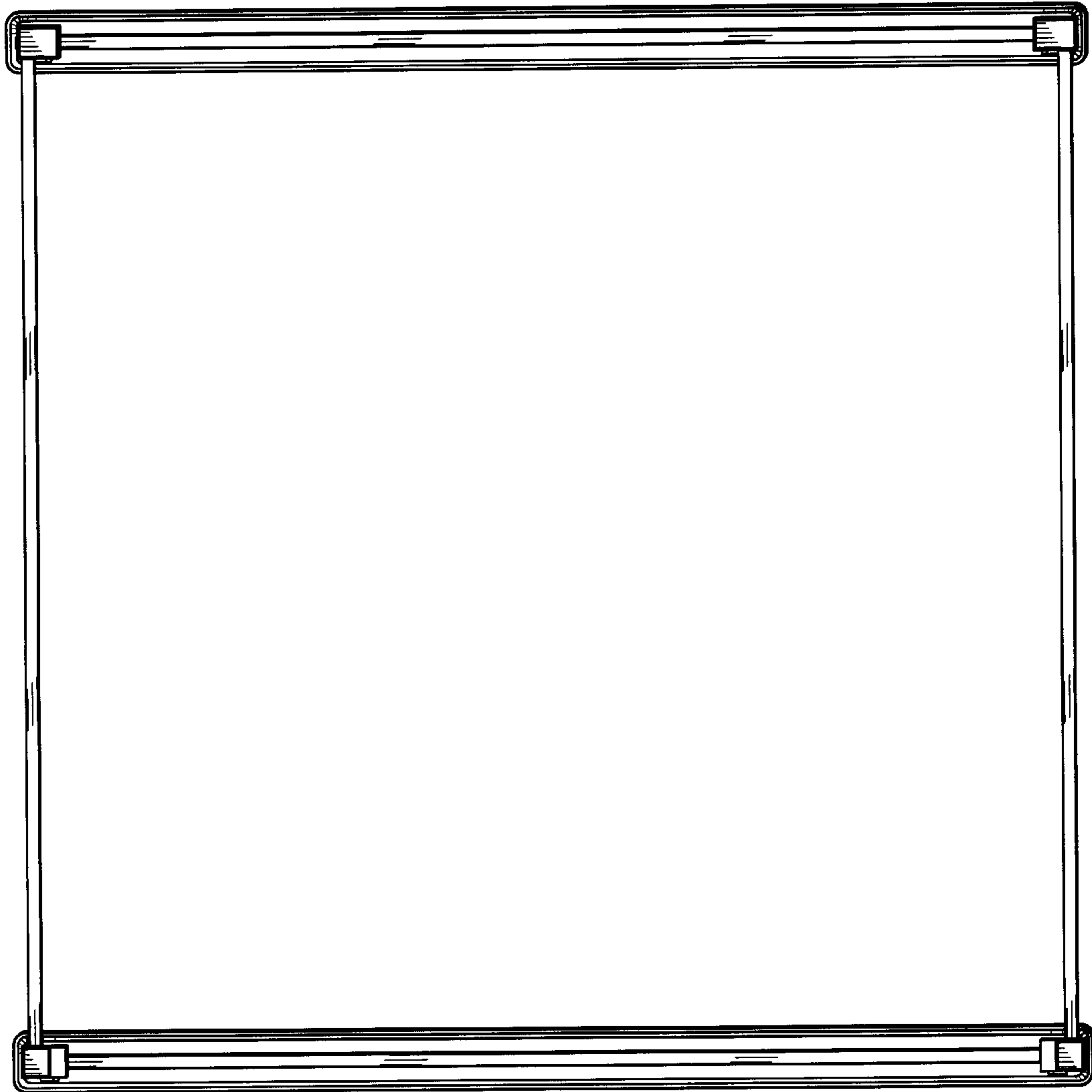

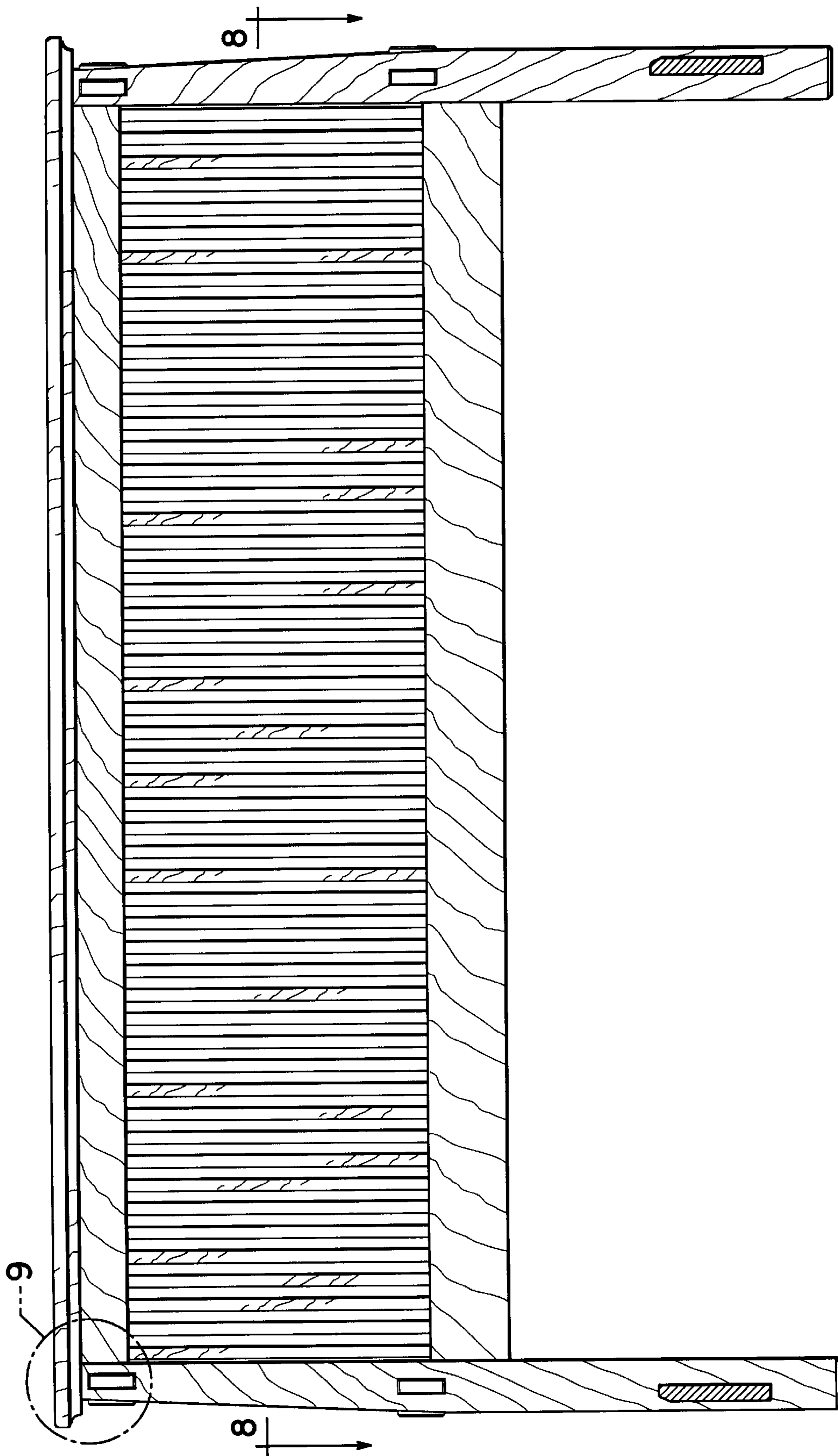

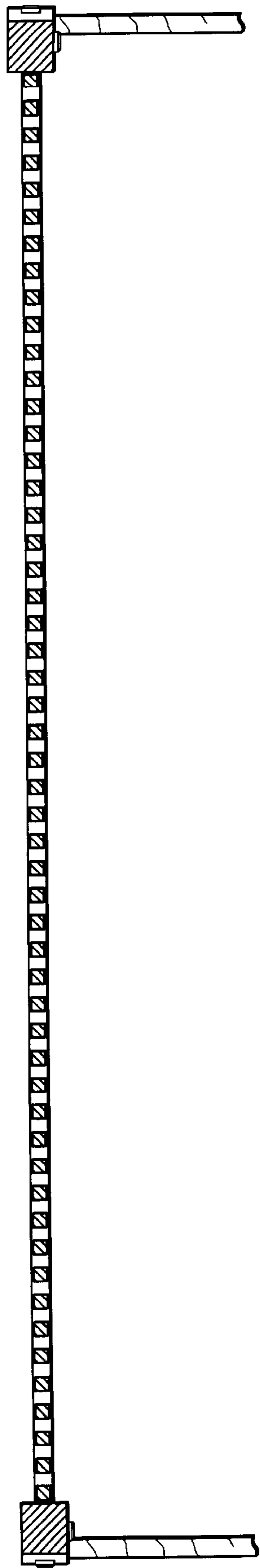

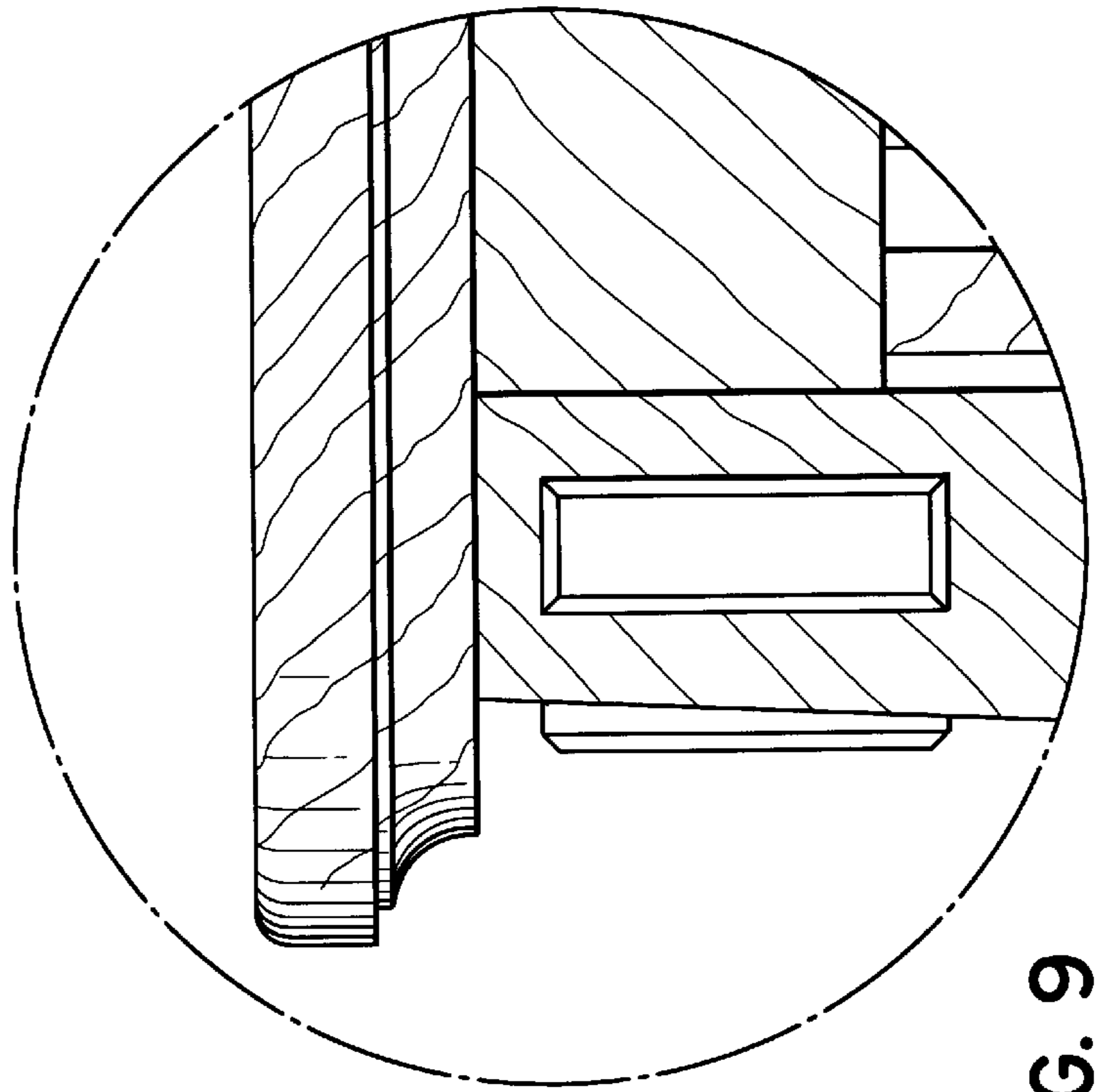

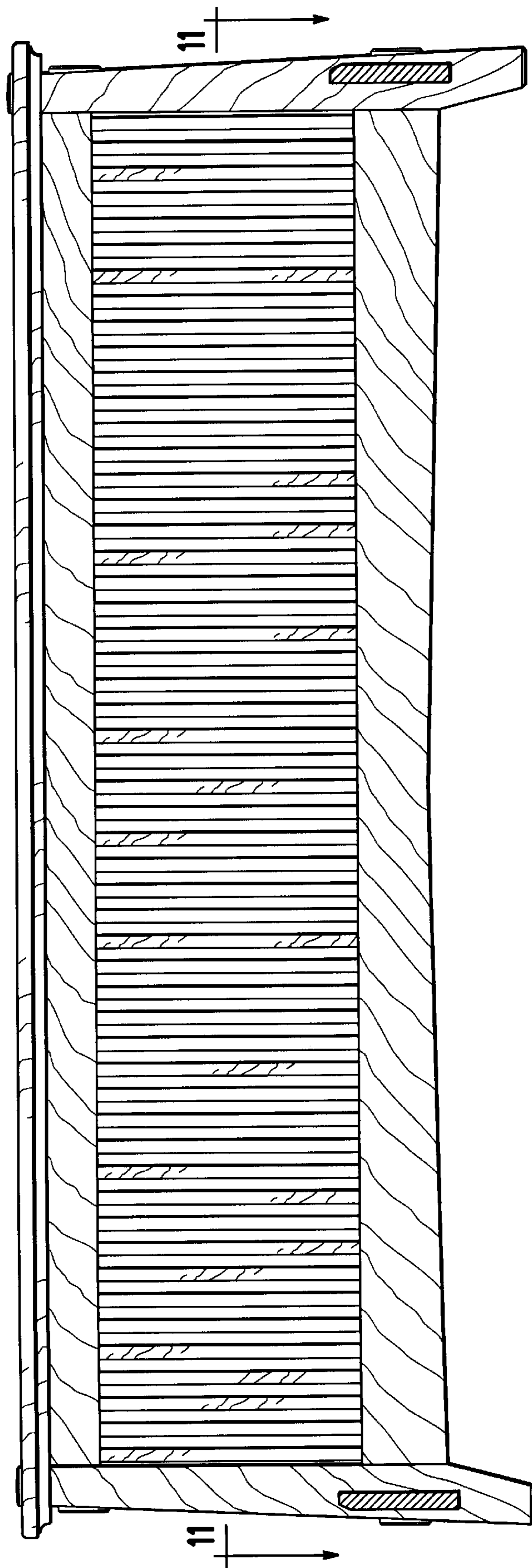

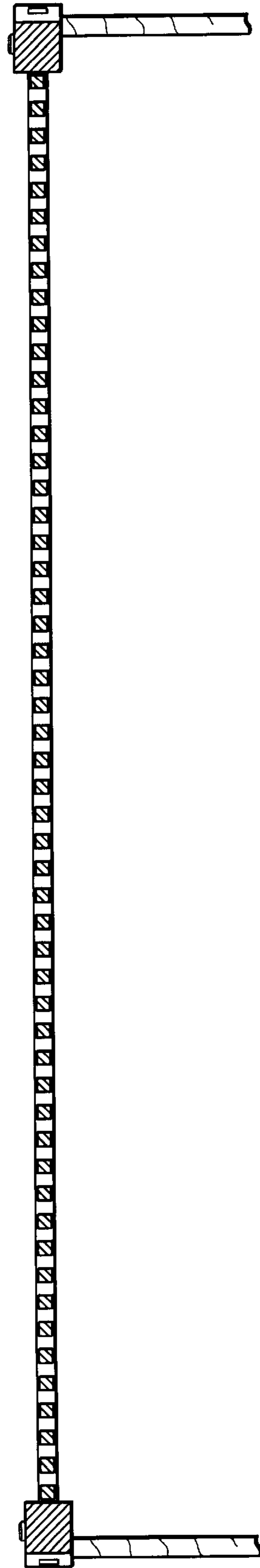
