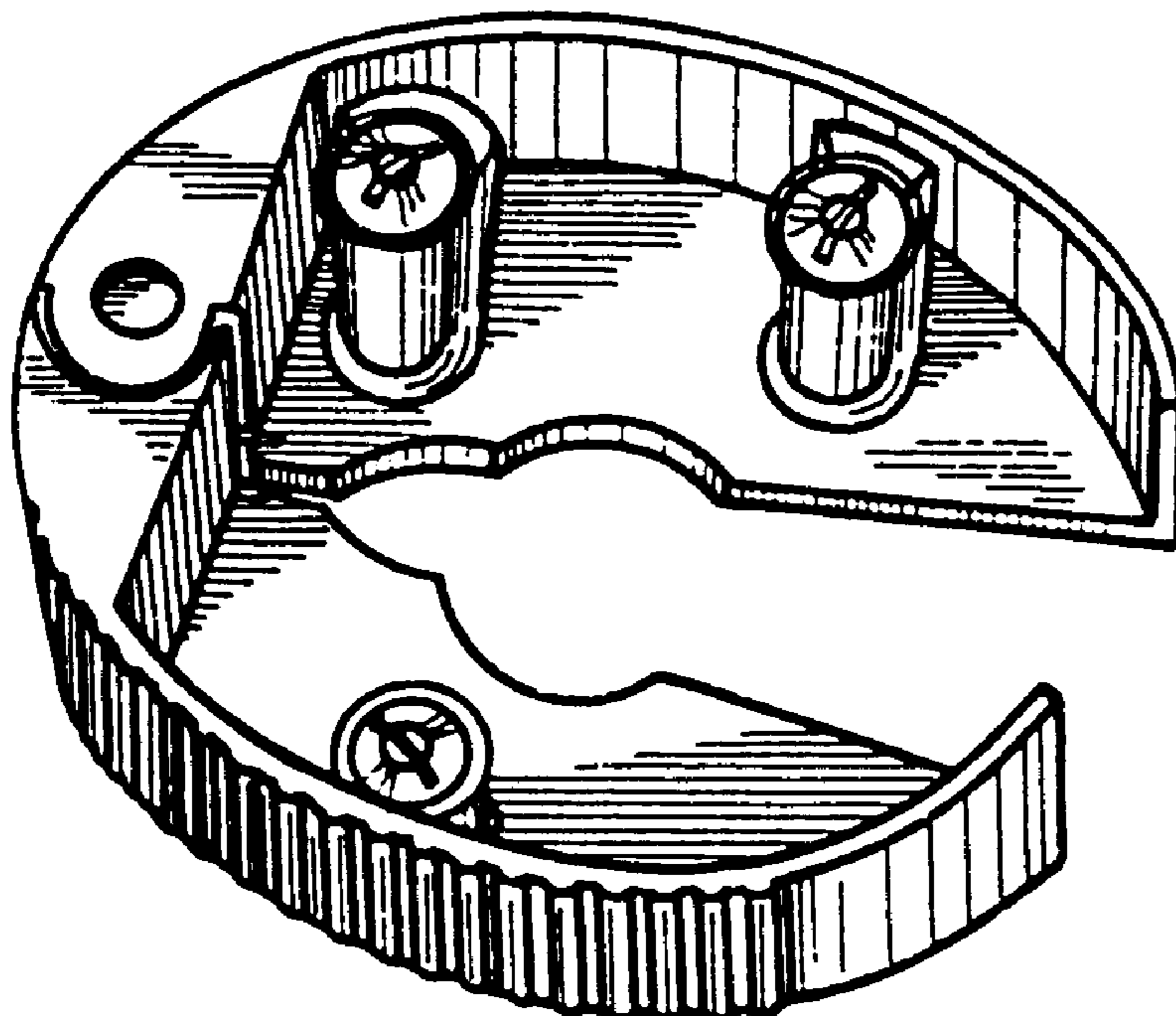
(57) **CLAIM**

The ornamental design for a foil cutter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a foil cutter showing my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof; and,
FIG. 6 is a right side elevational view thereof, with the left side elevational view being the same.

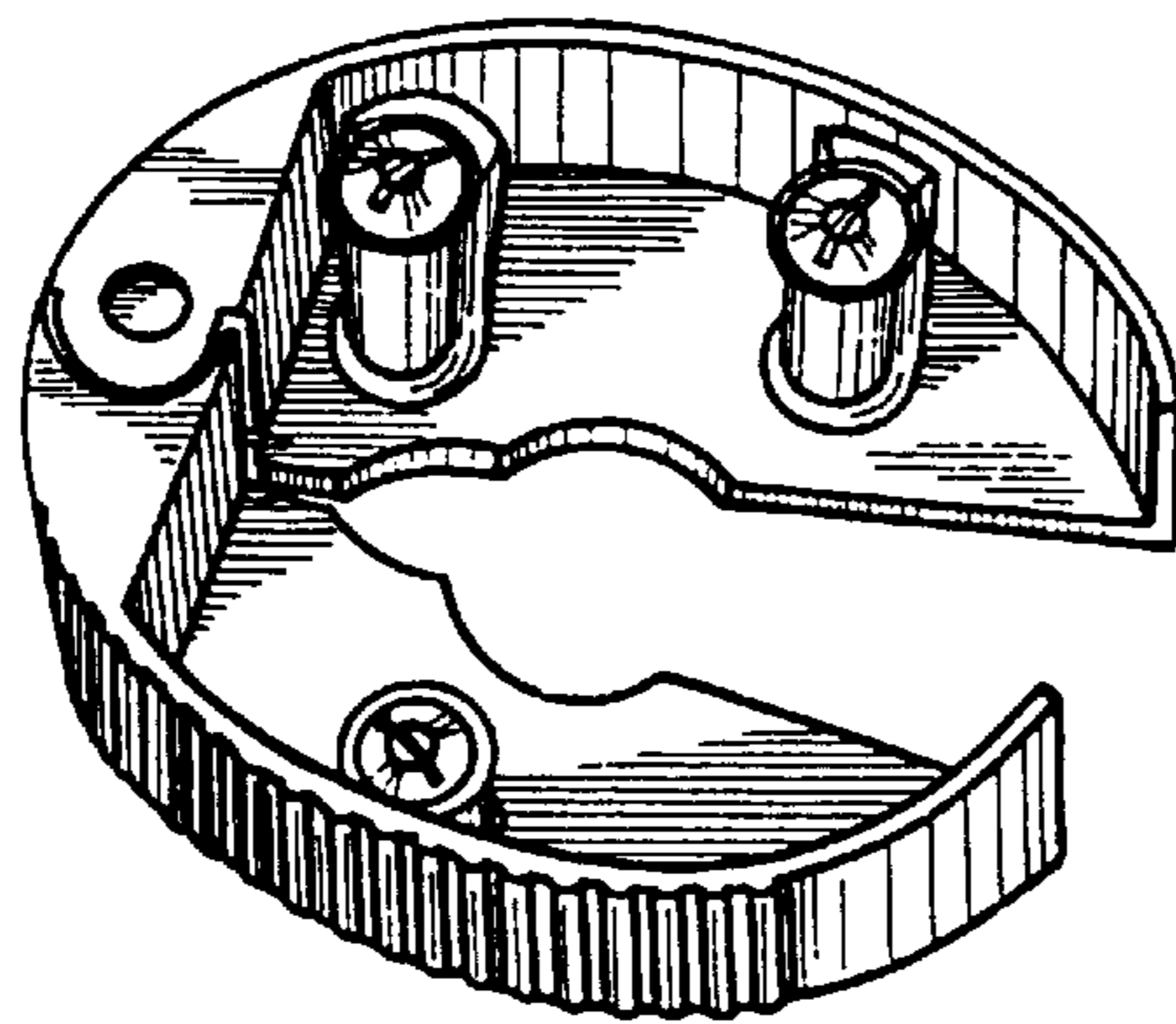

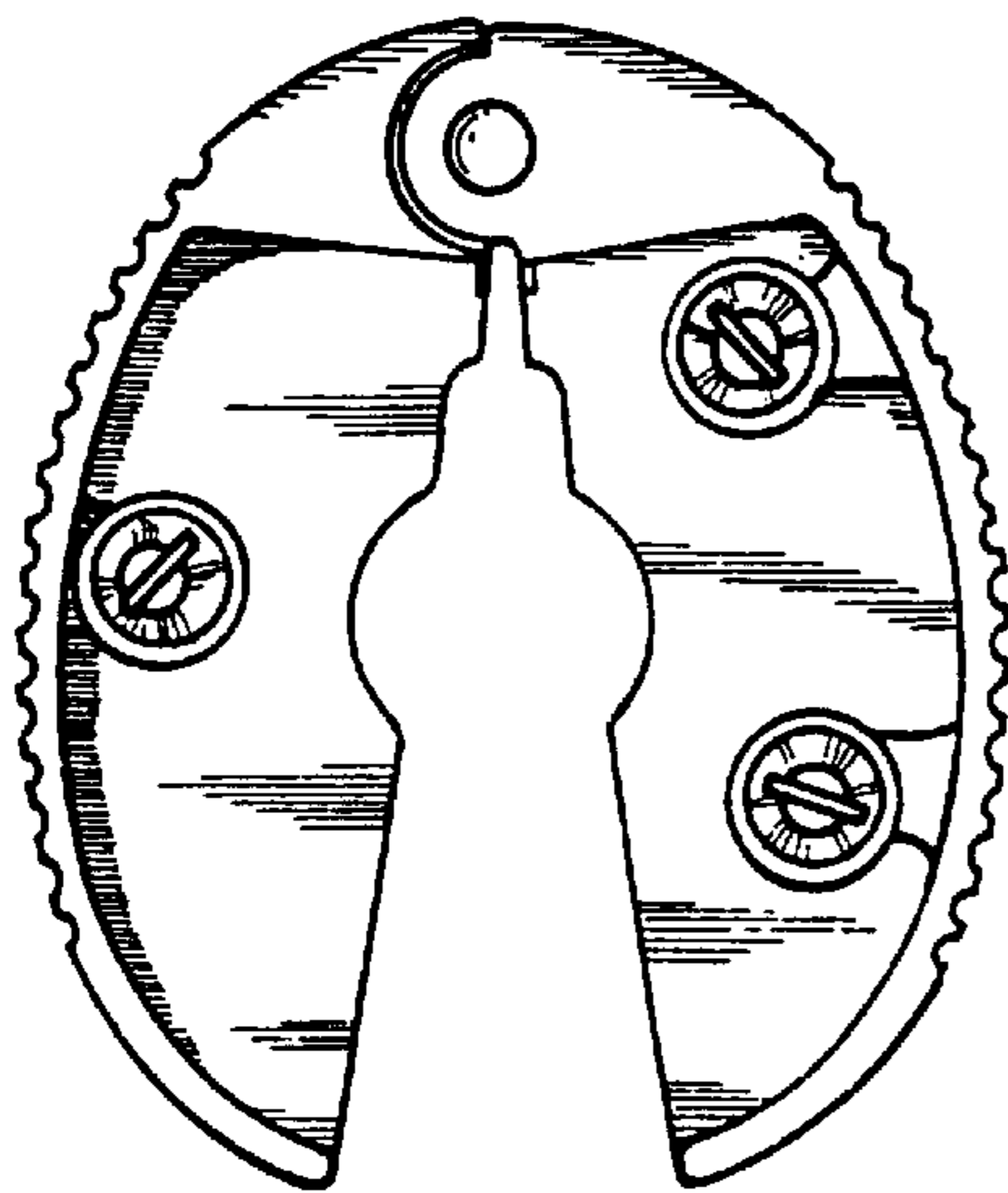

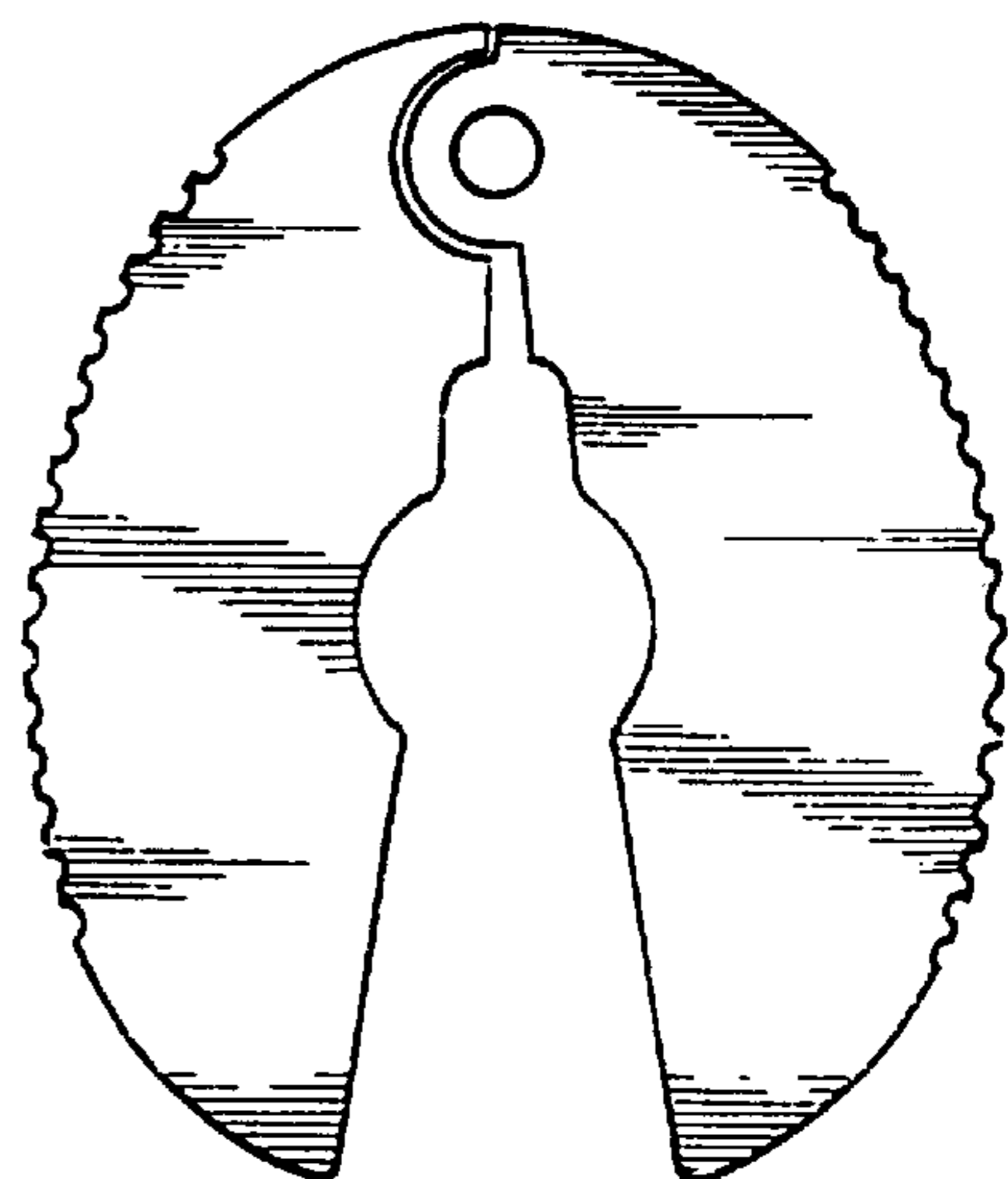

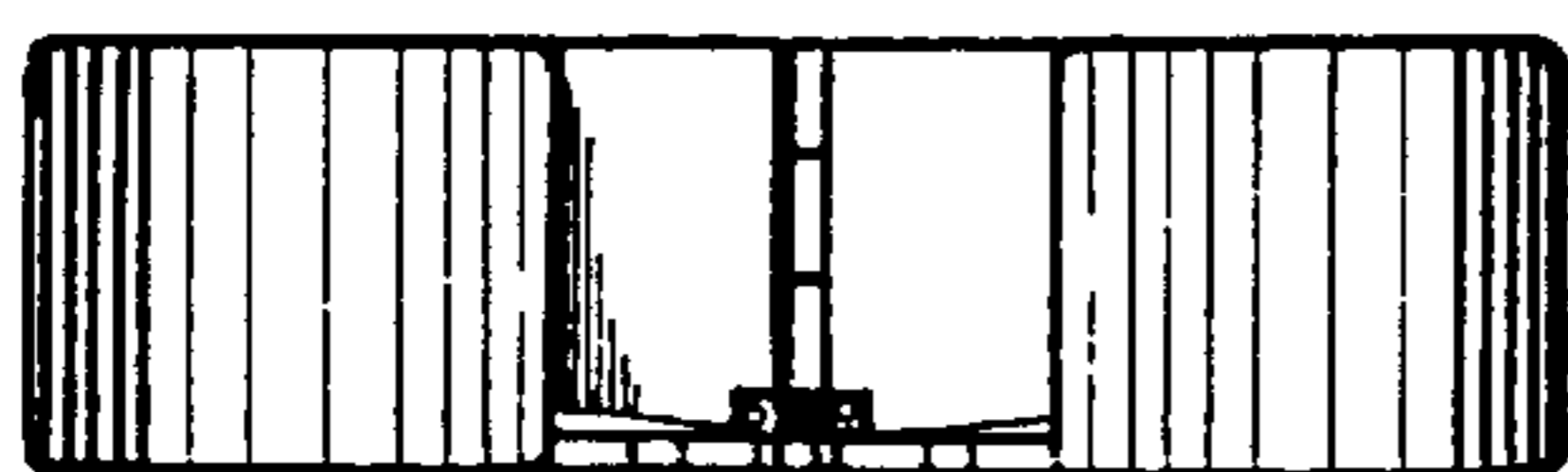

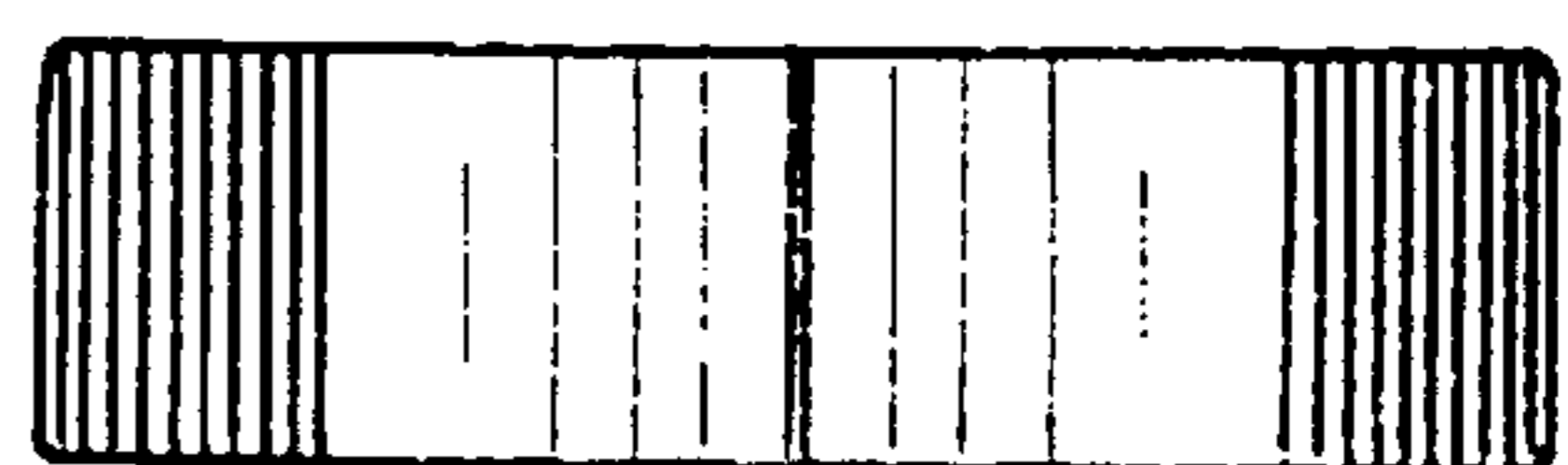
